

CITY OF RANCHO PALOS VERDES WEEKLY CRIME REPORT

CRIMES BY REPORT DATE:

Other Burglary, 12/09/07-12/10/07, 0001-0700 hours, 29300 Block Palos Verdes Dr East (School)
Method of entry- drilled through lock mechanism of vending machine; Loss- money & soft drinks

Vehicle Burglary, 12/09/07-12/10/07, 2030-0730 hours, 32600 Block Nantasket Drive
Method of entry- window smashed; Loss- keys to victim's other vehicle. This incident is related to carjacking incident below.

Robbery (carjacking), 12/11/07, 2123 hours, 32600 Block Nantasket Drive
Loss: Vehicle- 02 Toyota Camry (recovered)
The incident started as a vehicle theft. The victim saw the suspects stealing his vehicle & tried to stop them. The victim was struck by his car as he tried to stop suspect 1 from stealing it. **The suspects were located & arrested.** One of the suspects admitted to being involved in recent vehicle burglaries & other thefts in the area. This incident is related to vehicle burglary above.

Vehicle Burglary, 12/11/07-12/12/07, 1900-0830 hours, 30200 Block Via Borica
Method of entry- no forced entry; Loss- hat, Ipod charger/FM transmitter, vehicle registration & insurance cards

Residence Burglary, 12/06/07-12/13/07, 1200 Block Mount Rainier Drive
Method of entry- kitchen window smashed; Loss- 7 cell phones, Bluetooth, 3 pens, blank checks, jewelry. A female was arrested on 12/06/07 in the city of Torrance who was in possession of 3 of the stolen checks.

Residence Burglary, 12/12/07, 1230-1330 hours, 5900 Block Flambeau Road
Method of entry- no forced entry; Loss- safe, jewelry, money
The victim was approached by 3 people at Hawthorne Blvd & Shorewood Rd. Suspect 1 offered the victim a ride home & he accepted. Suspect 1 gave the victim a business card & told him that her company, "Meza Tree Service" could trim the trees at the location. The victim believes that suspects 1 & 2 distracted him in the backyard while suspect 3 entered the location & stole the listed items.
Note: There have been several similar incidents in the area recently. Palos Verdes Estates & Torrance have also had similar reports.

Petty Theft, 12/13/07, 2000-2020 hours, 29200 Block Bayend Drive
Unknown person(s) attempted to steal the Christmas lights from the victim's front lawn.
