Method of entry- unlocked vehicle; Loss- purse

Method of entry- unlocked vehicle; Loss- 2 iPods, money, 8 packs of cigarettes

Method of entry- rear sliding door, screen was cut; Loss- 2 tv's, laptop computer

Loss- catalytic converter (from '91 Toyota Tacoma)

Method of entry- entry door was forced open; Loss- laptop computer

Method of entry- open rear sliding door, screen door was forced open; Loss- laptop computer
