

RESOLUTION NO. 2015-58

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RANCHO PALOS VERDES AMENDING RESOLUTION NO. 2010-77 TO MODIFY THE DAILY USE FEES CHARGED FOR THE USE OF CITY-OWNED PROPERTIES AND RIGHTS-OF-WAY FOR COMMERCIAL FILMING ACTIVITY.

THE CITY COUNCIL OF THE CITY OF RANCHO PALOS VERDES DOES RESOLVE AS FOLLOWS:

WHEREAS, the City of Rancho Palos Verdes ("City") currently has established daily use fees for commercial filming activity on City-owned properties and rights-of-way, as set forth in Resolution No. 2010-77 of the Rancho Palos Verdes Master Schedule of fees and charges for City services; and,

WHEREAS, the City Council desires to modify the daily use fees for commercial filming activity on City-owned properties and rights-of-way as follows:

WHEREAS, on July 7, 2015, the City Council conducted a duly-noticed public hearing concerning the proposed revision of the daily use fees for commercial filming activity on City-owned properties and rights-of-way; and,

WHEREAS, the adoption of this Resolution approving the revision to the daily use fees for commercial filming activity on City-owned properties and rights-of-way is exempt from the California Environmental Quality Act (Public Resources Code Sections 21080 *et seq.*), pursuant to Public Resources Code Section 21080(b)(8)(A); and,

WHEREAS, all requirements of California Government Code Section 6062a are hereby found to have been satisfied.

NOW, THEREFORE, the City Council of the City of Rancho Palos Verdes does hereby resolve as follows:


Section 1: The facts set forth in the recitals of this Resolution are true and correct and are hereby incorporated herein by reference as though set forth in full.

Section 2: The City Council hereby approves and adopts the revisions to the daily use fees for commercial filming activity on City-owned properties and rights-of-way, as set forth above, and hereby amends the relevant provisions of Resolution No. 2010-77 to incorporate the revised daily use fees.

Section 3: The modified daily use fees specified in this Resolution shall become effective on September 5, 2015.

Section 4: The City Clerk shall certify to the passage, approval, and adoption of this Resolution, and shall cause this Resolution and her certification to be entered in the Book of Resolutions of the City Council of the City.
