### **CITY MANAGER**

**CalWater Pipeline Project Consultation with Rolling Hills Estates:** On May 22<sup>nd</sup>, Staff from the Community Development and Public Works departments met with Staff from Rolling Hills Estates and their environmental consultant to discuss the CEQA process for this project. The direct impacts of the project will be limited to the public right-of-way of Crenshaw Boulevard between Silver Spur Road and Crest Road. Indirect impacts are expected in terms of construction effects (e.g., noise, air quality, traffic, etc.) upon neighborhoods adjacent to the route of the pipeline, as well as upon Peninsula motorists in general. There was mutual agreement for a presentation of the project's CEQA review to the City Council either just before or during the 30-day public review period for the project, which is expected to occur early this summer. Staff will continue to monitor this project in future Border Issues Status Reports.

**Start Work Notice Issued for Ladera Linda Fields Soil Investigations:** As reported in last week's Weekly Administrative Report, the Department of Toxic Substances Control (DTSC) has issued the attached Start Work Notice Fact Sheet for the field work that will begin at the Ladera Linda Fields on Tuesday, May 30<sup>th</sup>. Field work will be conducted between 7:00 AM and 6:00 PM on weekdays, and should be complete by June 9<sup>th</sup>. The notice will be mailed to residents within a 1-mile radius of the Ladera Linda Fields, and will also include a survey of respondents' awareness, concerns and interest in the matter.

**Tree Trimming Schedule, In-Progress Projects, and an Interactive Public Services Map on the City Website:** Head over to the City website at RPVCA.GOV to view several GIS integrated maps with public service schedules and other topical information. Click on the "City Services" banner and "GIS Services" or click this link <http://www.rpvca.gov/869/GIS-Services> to be taken right to the page.

**Hesse and Ryan Park Facilities Fiber Optic Connectivity:** Public Works and IT have now completed the work required to connect Hesse and Ryan Parks to the City's computer network with fiber optic cabling. Residents should notice improvements in the video quality of the City Council and Planning Commission meetings broadcast live on RPVtv (Cox 33 and FIOS 38). This connection also allowed the City to integrate park site telephones into the City's network, improving workflow and eliminating the cost of several analog telephone lines. Additionally, Ryan Park visitors will see the addition of free Wi-Fi in the next couple of months. The City has already terminated two data circuits previously used as backup circuits at City Hall and Hesse Park resulting in an annual savings of almost \$28,000 per year, \$3,000 more than the original \$25,000 estimate.

**Peninsula Regional Law Enforcement Crime Statistics:** Attached are pertinent excerpts from the statistics presented at the Peninsula Regional Law Enforcement Committee meeting held on May 11, 2017. The data is for the first quarter of 2017 (January through March ) and includes Part 1 Crimes (violent), Part 2 Crimes (non-violent), traffic enforcement statistics, Sheriff's response time, and ambulance response time performance.

Additionally, Captain Beringer noted that residential burglary has slightly increased in Rancho Palos Verdes. The Lomita Sheriff's Station has responded to this uptick by working with multiple law enforcement agencies, such as Palos Verdes Estates Police Department and Los Angeles Police Department gang unit, to apprehend and arrest suspects. City Staff will continue to work with the Lomita Sheriff's Station to explore and implement solutions to reduce the number of residential burglaries.

**Public Safety & Ring.Com Security Products:** As part of the City's updated Public Safety Strategic Plan, one of the solutions the City continues to work toward is utilizing technology to make neighborhoods safer. The City and Sheriff's Department have negotiated a subsidy with Ring.com to provide RPV residents with a discount. Ring will provide a \$50 subsidy on the Ring video doorbell (original version) and Stick Up Cam and a \$175 subsidy on the Ring video doorbell pro version. The device limit for Ring's discount is three units per household. In addition to Ring's discount, the City will provide one \$50 incentive on the Ring video doorbell or the Stick up Cam. The City incentive is limited as the City Council allocated \$100,000 for the program and based on a first come, first served basis. The discount and incentive provide a significant savings as the products are regularly the following prices: Ring Video doorbell (original version) and Stick Up Cam are regularly \$179 each and the Ring Video Doorbell Pro is regularly \$249.

## **FINANCE**

**Governmental Accounting Tutorial Series (Capital Assets):** Capital assets include land, construction in progress, building and improvements, vehicles, computer equipment, furniture, fixtures and equipment, and infrastructure assets (street systems, storm drains, sewer systems, etc.). To be viewed as a capital asset, the initial individual cost needs to be at least \$5,000. Improvements and infrastructure assets need to exceed \$100,000. Such assets are recorded at historical (original) cost or estimated historical cost if purchased or constructed.

## **PUBLIC WORKS**

**Several Construction Bid Openings:** Public Works opened two bids Tuesday 5-16-2017. Eight Contractor's submitted their bid for the construction of the Lower Hesse Park Improvements Project and nine Contractor's submitted their bid for the Eastview Park Improvements and Dog Park Construction Projects. On Tuesday May 18, five bids were received for the Storm Drain Improvements Project. On Tuesday May 23, four bids were

received for the Miraleste Drive Arterial Rehabilitation Project. These bids are currently being reviewed to determine the lowest responsive and responsible bidders. The City will seek to enter into a contract with each of the lowest responsible and responsive bidders for each of these projects at the next City Council meeting, June 6, 2017.



Two additional projects are currently seeking proposals from Contractors - those proposal will be opened as follows: 1) June 1, ADA Access Improvements Fred Hesse Park, and 2) June 6, Bus Stop ADA Access Improvements Project

Maintenance: The Maintenance Division completed backflow prevention device inspections for 2017. Five devices failed inspection and are being repaired. Last week maintenance personnel and vendors completed the re-installation of the Ginsburg dolphin statue in Marilyn Ryan Sunset Point Park. The statue was damaged in late December by vandals and required significant repairs before it could be re-installed on its plinth.



Maintenance vendors completed weed abatement and installed mulch to improve weed control and the appearance of the landscaping along approximately 1 mile of Palos Verdes Drive West. This work was primarily focused on the parkway, trail and sidewalk on the

ocean side of the roadway. It also included trimming of overgrown vegetation in the median.

**Citywide Brush Clearing Completed:** EDCO collected a total of 38.2 tons of excess brush and green waste from homes during the Spring season brush clearing event. This quantity which is the most brush collected during the Spring season events in the past five years can be attributed to the heavy rains leading to overgrown weeds, brush, and trees.

**EDCO's Paper Shredding Event Tonnage Information:** At the April 22<sup>nd</sup> event, a total of 22,500 lbs. or 11.25 tons of paper was shredded on-site by certified shredding trucks, 5,490 lbs. of electronic waste (e-waste) collected and 36,500 lbs. of mulch given away to residents. Public Works thanks EDCO for their continuous support and cooperation.

**City Council Solid Waste Subcommittee:** The Solid Waste Subcommittee comprised of Councilmembers Brooks and Misetich met on Monday May 15<sup>th</sup> and reviewed EDCO's performance audit and their FY 17/18 rate adjustment request and recommended approval of both items to the full Council. The items will be presented to the City Council on June 6<sup>th</sup>.

**IMAC Memo to City Council:** The Infrastructure Management Advisory Committee prepared a memo, which was included as late correspondence to the 5/16/17 City Council agenda in support of the draft FY 17/18 CIP projects.

**Residential Street Rehabilitation Project for Area 7:** The design will include roadway rehabilitation for Area 7 based on the Pavement Management Program suggestions. Final design is underway. Construction is anticipated to begin in late summer 2017.

**Residential Street Rehabilitation Project for Area 8:** The design will include roadway rehabilitation for Area 8 based on the Pavement Management Program suggestions. Design and site assessments have started. Construction is anticipated to begin in late summer 2018.

**Storm Drain Deficiency Improvement Program FY 16-17:** The design phase is completed for the first year of the 10-year program outlined in the Master Plan of Drainage (MPD). Construction bidding has been completed and the lowest responsive bidder is under review. Chosen company will be presented to council in early June.

## **COMMUNITY DEVELOPMENT**

**Marilyn Ryan Sunset Park:** Last week, the existing benches and picnic tables were removed in preparation for the new park furniture. This week, the foundations have been poured and most of the furniture have been installed. The concrete pads for the picnic areas are scheduled to be poured and the remaining furniture will be installed for completion by Friday. The construction area will remain taped off from the public until the work is complete.

Unpermitted Dumping in Portuguese Bend: On May 18, 2017, Code Enforcement received several phone calls that the property owner at 1 Roseapple Road was importing dirt on his vacant lot. Code Enforcement verified the unpermitted dumping and issued a Stop Work Notice to the truck driver as a Haul Route Permit from the Public Works Department was not obtained and the property owner accepting the dirt did not obtain a permit from the City. Staff determined that the dirt was coming from a construction site in San Pedro (City of Los Angeles). As unpermitted dumping has been an ongoing issue with this property, Staff is working with the City Attorney's office to obtain an Inspection Warrant to obtain access to the property to determine the extent of the unpermitted dumping so that a course of action against this property owner can be determined. Staff will continue to update the Council on this issue. Staff also received a phone call that unpermitted dumping was occurring on a property on Limetree Road, which is separate and unrelated to the Roseapple property. Staff is also working with the Limetree property owner to address the matter.

SCAG Local Profiles: On May 4, 2017, The Southern California Association of Governments (SCAG) released the 2017 Local Profiles for each SCAG member jurisdiction, including the City of Rancho Palos Verdes. The Local Profiles are intended to provide jurisdictions with updated population, housing, education and employment data within their respective areas and as compared to Los Angeles County as a whole. Unpermitted Leasing Sign at The Terraces: The Retail Opportunity Investment Corporation (ROIC) recently acquired the Terraces Shopping Center at 28901 Western Avenue. As part of their new acquisition, ROIC installed a new "leasing" signage throughout the center and along Western Ave, some of which did not meet code requirements. ROIC has removed the non-conforming signs, while City Staff and their sign manufacturer work together to potentially allow signs that meet the Code requirements.

LAX Roundtable Meeting: At the May 10<sup>th</sup> LAX Roundtable meeting, the Los Angeles World Airports (LAWA) staff distributed six (6) months of statistical data for jet flights over the Palos Verdes Peninsula (see attachment). The number of jet departures from LAX increased since October 2016 from 282 to 406. While there has been an overall increase in southbound jets since 2012, the number of southbound jet flights over the Peninsula has decreased by 1% (2,759 to 2,527). LAWA also distributed data for jet overflight altitudes over the Peninsula between January and March 2017 (see attachment). The next LAX Roundtable meeting is scheduled on Wednesday, July 12, 2017 at 7 p.m. at LAX. These are open meetings and the public is welcome to attend (see attached directions).

The California Department of Toxic Substances Control (DTSC) is providing this Work Notice to notify the community of upcoming investigation activities at an area of stockpiled soil adjacent to and north of Upper Ladera Field, located at 32201 Forrestal Drive, Rancho Palos Verdes, California (Site). The Site is owned by Palos Verdes Peninsula Unified School District (PVPUSD) and leased by Palos Verdes American Youth Soccer Organization (PV AYSO).

Investigation activities are part of a Preliminary Endangerment Assessment (PEA) required by DTSC under the Consent Agreement for the Site. On October 14, 2016, DTSC entered into a Consent Agreement (Docket No. HSA-FY 16/17-037) with PVPUSD and PV AYSO based on information that asbestos was found in three (3) of fifteen (15) pieces of construction debris collected from the stockpile surface in November 2015.

The environmental investigation includes trenching and soil sampling to determine if asbestos-containing material is distributed within the imported stockpiled soil (estimated to be the top 15 inches of stockpile), if asbestos has been released to imported stockpiled soil, and if asbestos has impacted the underlying stockpiled material that originated from nearby Ocean Field. Investigation activities will be conducted by PV AYSO's consultant, Avocet Environmental, Inc., with oversight from a registered civil engineer from Avocet and a Certified Asbestos Consultant from Pacific EH&S Services, Inc. Activities are expected to take up to one (1) week to complete. During that time you may see a backhoe, support vehicles, and personnel entering and exiting the work site.

**Work will begin May 30, 2017 and is expected to continue through June 9, 2017. All work will be done on weekdays between 7:00 a.m. and 6:00 p.m.**

**Community Protection Measures:** Work will be done according to a site-specific health and safety plan. A site supervisor and a health and safety officer will be present to oversee the work and ensure compliance with the health and safety plan. To ensure public safety and minimize dust, the following actions will be taken during this process:

- ✓ The stockpile is currently covered and fenced pursuant to an “Order to Fence and Post” issued by DTSC to PVPUSD on August 1, 2016.
- ✓ Windscreens will be added to existing fencing for security and dust control.
- ✓ Portions of plastic sheeting will be temporarily pulled back to allow trenching and sampling.
- ✓ Material from trenches will be temporarily placed in piles along each trench and returned to the trench after visual observation and sampling.
- ✓ Work areas will be sprayed with clean water to control dust.
- ✓ Perimeter air monitoring will be conducted by a Certified Asbestos Consultant to verify the effectiveness of dust control measures.
- ✓ Equipment leaving the Site will have their tires brushed.

The results of investigation activities will be compiled into a PEA Report and submitted to DTSC for review. Based upon review of the report, DTSC will either request modification or concur with it, as written. Upon DTSC concurrence, the PEA Report will be made available to the public for review and comment for a period of 30 days. DTSC will consider public comments received on the PEA Report and request revisions to the document, as necessary. Subsequently, DTSC will issue a final determination of “no further action” or “further action required” for the Site.






# Jet Altitudes over PV Peninsula





## DIRECTIONS TO VISITOR'S PARKING LOT



### Westbound Century Boulevard (for origins east of the airport)

As you approach the airport, get into the far left lane on the lower level (Arrivals). As you cross the bridge over Sepulveda Blvd., you will see a small sign on the left-hand side for "Department of Airports Administration Building Visitors' Parking" directing you to veer to the left. Take the next turn off to the left to a stop sign. Veer to the right and drive to the Visitors' Parking Lot. At the wooden gate arm to the parking lot, push the button on the two-way intercom to request permission to park.

### Southbound Sepulveda Boulevard (for origins north of the airport)

Head south on Sepulveda Blvd. and turn right into the airport by following the directional signs and remain on the lower level. Merge onto the main roadway and get into the far left lane. Immediately after passing the first parking structure on your left, Parking Structure 1, turn left at the first turnoff (Eastway). Make the next left and get in the number 2 lane (second from left). Continue heading east as if you were exiting the airport. After passing the Administration Building, turn left at the signal, where signs direct you to "Airport Return." Get into the right lane and proceed to the stop sign. Proceed through the stop sign to the Visitors' Parking Lot and stop at the gate. At the wooden gate arm to the parking lot, push the button on the two-way intercom to request permission to park.

### Northbound Sepulveda Boulevard (for origins south of the airport)

Head north on Sepulveda Blvd. and get into the right-hand lane as you enter the Sepulveda Tunnel. Immediately upon exiting the tunnel, veer onto the LAX entrance ramp and follow the signs for the Arrivals Level (lower level). As you cross the bridge over Sepulveda Blvd., you will see a small sign on the left-hand side for "Department of Airports Administration Building Visitors' Parking" directing you to veer sharply to the left. Take that first road to a stop sign. Drive to the Visitors' Parking Lot. At the wooden gate arm to the parking lot, push the button on the two-way intercom to request permission to park.
