CITY MANAGER

RPV Council of Homeowners Meeting: The Council of Homeowners (CHOA) is hosting a meeting on Wednesday, January 23, 2019 at 7 p.m. The meeting will be held at Hesse Park which is located at 29301 Hawthorne Blvd. Attendees will hear from Cal Water regarding the Palos Verdes Peninsula Water Reliability Project, receive an update on the economics of the local real estate market and RPV Mayor Pro-tem Cruikshank will be present to answer questions. Unfilled sandbags are located at the City Hall info desk. Fill sand is located at City Hall in a designated area for residents to use. Please bring your shovels and tools as they are not provided.

There is a limit of 10 sandbags per household with valid ID or proof of residency. If you need additional bags, they can be purchased at local hardware stores.

Peninsula-Wide Safe Routes to School (SRTS) Plan: Staff is soliciting Statements of Qualifications to procure a Consulting Firm to assist the City in the development of a SRTS Plan. The plan shall evaluate eighteen (18) public elementary, middle, and high schools located within the Palos Verdes Peninsula Unified School District (PVPUSD) and the Los Angeles Unified School District (LAUSD). This project is mainly funded by a State grant of \$221,325 with a matching City fund of \$28,675 for a total amount of \$250,000. The deadline to submit a Statement of Qualifications is February 14, 2019. For more information visit the City's website at: <http://www.rpvca.gov/bids.aspx>.

Hesse Athletic Field Improvements: This project consists of installing a new athletic field at Hesse Park. Existing turf and underlying rock will be removed, the irrigation system will be improved, new soil will be imported and new turf will be installed. Staff had a design kickoff meeting with a consulting design team on January 14th to discuss the project goals and milestones.

February IMAC Meeting: The regular February 18, 2019 IMAC meeting is cancelled. Due to Committee vacancies a lack of quorum was anticipated. The new February meeting will be on Wednesday, February 6, 2019.

Maintenance Activities: This week PW Maintenance remained in storm response mode. PW on-call staff responded to a drainage issue in the Portuguese Bend area. Runoff water caused drainage issues and PW staff went out to reassemble. PW also continues to clear catch basins to prevent flooding. A washout of Palos Verdes Drive East and Miraleste Drive was near because of major debris build up in a nearby drainage basin. PW cleared and cleaned out the stoppage and prevented flooding on this busy road. PW also removed several boulders that posed traffic hazards on Silver Spur Road and Crest Road. Lastly, PW repaired a section of the bluff section that overlooks the ocean at Vanderlip Park. The fence looked like it had been vandalized and it posed a public safety concern. PW quickly secured the fence and made repairs.

COMMUNITY DEVELOPMENT

Landscape Plan Approved for Lot D of the Trump National Golf Club Property: Pursuant to the City Council-adopted Conditions of Approval, the Trump Organization is required to submit, for the Director's approval, a landscape plan for the vacant lot along the west boundary line, better known as Lot D. This lot is required to be vegetated with drought tolerant native plant species listed on a plant palette in the Council-approved Habitat Conservation Plan (HCP) for the project. On January 14th, City Staff met with the representatives of the abutting Portuguese Bend Club Association (PBCA), Trump Organization, Coastal Commission Staff, the L.A County Fire Department, and the L.A. County Agricultural Weights and Measures to address the fire hazard and maintenance concerns raised by the PBCA. At this meeting, the PBCA's concerns were addressed and the Landscape Plan (attached) was subsequently approved by the Director. The Trump Organization anticipates installing the Director-approved landscaping in 2020 after all above- and below-ground improvements and infrastructure are completed.

Disability Access Requirements for Business and Commercial Operations: Effective January 1, 2019, AB 3002 requires local jurisdictions issuing building permits for commercial construction or business licenses, to make available a notice containing specific information regarding disability access. View Restoration Trimming at Point Vicente Interpretive Center (PVIC): On or about Tuesday, January 23rd, the City's contract trimming service (WCA Inc.) is scheduled to trim

and remove view impairing Acacia foliage located at PVIC. The bulk of the trimming work effort is focused on Acacia trees with some removal of trees along Palos Verdes Drive West (PVDW). The pending tree trimming/removal is an ecologically-friendly, Staff-initiated view restoration project that will restore the east/west bound view corridor of PVDW (see attached Memorandum). The tree service is expected to be performed over a 4 to 5 day period. Public handouts describing the pending work are available at City Hall and the PVIC.

January 9th LAX/Community Noise Roundtable Meeting Summary: At the January 9th Roundtable meeting, the Los Angeles World Airport (LAWA) Staff distributed passenger jet Peninsula overflight and altitude data, which showed a continued uptick in flights over the Peninsula, consisting of 341 overflights in November and 382 overflights in December (see attachment). The FAA Staff was not in attendance at the Roundtable meeting because of the federal government shutdown. LAWA distributed the Aviation Noise News dated January 9, 2019, which summarized Culver City's response to the Federal Court denying their lawsuit against the FAA (see attachment). As previously reported in the December 12, 2018 Administrative Weekly Report, the U.S Court of Appeals rejected all of Culver City's environmental challenges to the FAA SolCal Metroplex Project. At the January 9th meeting, the Roundtable received a report from the LAX Metroplex/Wide Area Ad Hoc Committee on the north downwind arrivals, a briefing on low frequency noise, and a status update on sound insulation programs. SUBJECT: VIEW ASSESSMENT OF PVIC PARK FOLIAGE

RECOMMENDATION

Based on view assessments conducted from the eastbound and westbound lanes of Palos Verdes Drive West (PVDW), View Restoration Staff recommends that the Public Works Department removes an estimated 66 Acacia trees, 2 Palm trees, 1 Pittosporum tree and trims an estimated 39 Acacia trees located within Point Vicente Interpretive Center (PVIC) Park, as they are creating significant view impairments from the view corridor of PVDW. No mature Aleppo Pines or mature Canary Island Palm trees located within PVIC Park were assessed as part of this assessment because this assessment is focused on those trees that are nearest the view corridor of PVDW.

BACKGROUND

According to the City's General Plan, View Corridors are major circulation roads, such as Palos Drive West, within the City that afford views of visual resources. It is along these routes that a majority of the residents and nonresidents view the City. The subject City-owned trees are located within the established view corridor of Palos Verdes Drive West, as identified in the City's General Plan and in the City's Local Coastal Plan. It is unknown whether the City's tree service has trimmed the subject trees within PVIC Park. By all appearances, PVIC Park the subject trees have grown unmanaged for over a 15 year length of time and as such, the trees have grown to impair the view corridor views. This assessment and recommendation follows that the City is committed to the protection and preservation of the City's established view corridors, particularly when City-owned trees impair such views.

DISCUSSION

View Restoration Staff determined that over 100 City-owned Acacia trees, 2 Canary Island Palm trees and one Pittosporum tree along a ±1,000 foot segment of Palos Verdes Drive West significantly impair the Ocean, Catalina Island, Pt. Vicente Lighthouse and Santa Monica Mountain views from westbound and eastbound PVDW

vehicle lanes. Below is a detailed description of the trees' view impact from these view corridors.

Eastbound lane of Palos Verdes Drive West




Figure 1b View impairment from eastbound PV Drive West view corridor

The greatest view impact caused by the City owned trees, particularly the Acacia trees, which are located within Point Vicente Interpretive Center (PVIC) Park, are from the eastbound lanes of Palos Verdes Drive West starting approximately 950 feet east of the southeast corner of Palos Verdes Drive West and Hawthorne Boulevard and ending at the ingress of PVIC. From this vehicle corridor segment, the subject trees significantly impair the views of the Ocean, Catalina Island, and the Pt. Vicente Lighthouse (see attached Figure 1a-d). Most of the PVIC Park trees which cause significant view impairments are located within 25 feet from the public trail that abuts PVIC Park. View Restoration Staff has labeled this group of trees to be within Area 1 (see attached Map). There are also groupings of trees beyond 25 feet of the adjacent public trail (Area 2) and within the landscaped triangle-shaped area, located between the Parks and Recreation Department storage containers and the ingress/egress to PVIC (Area 3) that cause view impairments. With exception to the Pittosporum tree and the two Canary Island Palm trees, the Acacia trees within Areas 2 and 3 can be trimmed instead of removed.

Tree Removal vs Tree Trimming

The Acacia tree canopies within Area 1 significantly impair the views as observed from vehicle heights along the view corridor. In order to eliminate the significant view impairment the foliage causes, most of the tree canopies will need to be trimmed to a height that doesn't exceed a 3 foot visual plane as measured from the grade of the adjacent public trail (See Figure 4 measurement photo). Unfortunately, trimming to the trees to aforementioned height will effectively remove the trees' canopies, leaving unsightly bare tree trunks exposed to public viewing. As such, View Restoration Staff recommends that the Acacia trees within Area 1 be removed because such severe crown reduction would cause an unsightly, unacceptable appearance to the public.

There are an estimated 39 trees within Areas 2 and 3 that need trimming at various height levels (2 feet to 10 feet of crown reduction). In general terms, the Acacia trees located within Area 2 and 3, which are at lower grade levels, can be crown reduced without leaving unsightly trimmed trees. At this time, due to the density of the trees within Area 1, Staff cannot accurately identify individual trees within Area 3, but it appears that there are up to 15 Acacia trees that need to be trimmed to protect the eastbound and westbound PVDW views of the Ocean, Catalina Island, Pt. Vicente Lighthouse and the Santa Monica Mountains.

Westbound lane of Palos Verdes Drive West

From the westbound lane of Palos Verdes Drive West, the some, but not all of the trees within Areas 1 and 3 impair the Ocean and Santa Monica Mountain views. Based on a westbound view corridor assessment, View Restoration Staff has determined that trimming and removal of the Acacia trees that impair the view from the eastbound lanes of PVDW will eliminate or mostly eliminate the view impairment from the westbound lanes.

PVIC Park View Restoration Project Phasing

Phase 1: Before commencing the recommended removal work in Area 1, View Restoration Staff will mark the trees that are slated for removal. After marking the trees, the trees will be identifiable onsite to the City's tree service crew so that they know precisely which trees are to be removed. Staff will also mark the trees that require trimming so that the City's tree service could identify the tree or groupings of the trees and trim the trees as instructed in Figure 2.

Phase 2: After all trees are trimmed and removed, per the instructions provided in Figure 2, View Restoration Staff will perform another view corridor assessment to ensure that no additional trees remain to significantly impair the views. If any additional trees remain that significantly impair the views, then View Restoration Staff shall notify the Public Works Department and the Recreation and Parks Department with a recommendation to either remove or trim the foliage.

Replacement vegetation

Should the Public Works Department and/or the Recreation and Parks Department, determine that the removed Acacia trees be replanted with new vegetation, View Restoration Staff recommends that the new vegetation be planted below the grade of the top of the slope and be planted with low growing shrubs or bushes which will not grow to impede public trail or view corridor views at mature heights in the future.

Trimming Maintenance

For those trees that are trimmed within Area 2 and 3, the Acacia trees will need periodic maintenance so that the trees' canopies remain out of the view. View Restoration Staff recommends that the trees be monitored by the Community Development Department for future view impairments and be trimmed, as recommended from the Community Development Department, by the Public Works Department at least on an annual basis.

CONCLUSION

At this time, View Restoration Staff is presenting PVIC Park tree trimming and removal recommendations to the Public Works Department and the Recreation and Parks Department for its consideration and implementation.




Figure 1c View impairment from westbound PV Drive West view corridor

FIGURE 3 PVIC Park Tree Location Overview





Figure 4 Measurement height photo






Palos Verdes Peninsula – Jet Overflights




The graphs below show the total number of jets turning south upon departure from LAX and the number of those departures that fly over the Palos Verdes Peninsula.

Federal Court Denies Culver City Lawsuit Against FAA

On November 30, 2018, the United States Court of Appeals for the District of Columbia Circuit denied the City of Culver City's Petition for relief from the impacts from implementation of the Southern California Metroplex.

The City filed its Petition in October 2016 and was joined by the City of Los Angeles, which filed an amicus curiae brief in support of Culver City's Petition.

The City of Culver City's bulletin states, "Culver City explained to the Court the environmental conditions and impacts created by the Metroplex Project, and argued there was an absence of required environmental review in the FAA's Environmental Assessment ("EA") for the Metroplex Project. The Court found that the FAA's analysis of noise and air quality impacts was defensible and reasonable."

The City's bulletin concludes, "The City Council of Culver City still strongly believes that the Metroplex Project has ongoing negative effects on the quality of life in the City. Therefore, the City will continue to coordinate with neighboring cities, as well as state and federal elected officials, to find regional solutions to these issues."

LA City Council Resolution on Hollywood Burbank Airport Flight Track Changes

On November 20, 2018, the LA City Council passed a resolution asking the City Attorney to prepare a strategy related to potential flight track changes at the Hollywood Burbank Airport and to "continue to engage with the Federal Aviation Administration to ensure that all appropriate state and federal laws are followed in the implementation of changes to air traffic control procedures."

The City Council's action is a result of months of hearing community concerns regarding increased aircraft noise from Hollywood Burbank Airport aircraft operations in Sherman Oaks, Studio City and several other San Fernando Valley communities.

FAA spokesperson Ian McGregor had no comment on the City's resolution, but noted, "the environmental process is very important to us and we follow all the applicable environmental laws as we develop new routes." He added, "Our preliminary environmental study of the proposed changes indicated that they may reduce noise in those neighborhoods by tightening up that initial turn."

The City's resolution authorizes the City Attorney to "develop litigation to protect the interests of the city and its residents and to ensure that the FAA is held accountable, if necessary." The City also requested an extension of the public comment period on the FAA's proposed Categorical Exclusion for the proposed flight procedures.

Alaska Airlines Plans West Coast Expansion

On November 27, 2018, Alaska Airlines Chief Commercial Officer, Andrew Harrison, announced the airline's plans to expand its facilities at four West Coast airports including Los Angeles International Airport (LAX).

"California's a huge success story thanks to Virgin America," he said. "We used to talk about where are our gates, how do we hang on to our gates – today we talk about our terminals."

Alaska operates out of Terminal 6 at LAX, where it has preferential use of 10 of the 14 gates in the terminal. Los Angeles World Airports (LAWA) and Alaska are working on

a long-term lease for those gates and, possibly more, as well as a new consolidated security checkpoint. The final lease agreement is expected during the first quarter of 2019.

The article notes, "Gates and facilities at LAX, the second busiest airport in the USA after Atlanta, are among the most sought after by the country's airlines."

British Airways Last 767

On November 25, 2018, British Airways (BA) retired its last Boeing 767 from its fleet. The airline began operating 767s in February 1990 and has since completed over 425,000 flights with that aircraft type.

BA is replacing its 767s with Boeing 787 Dreamliners, which now total 30 aircraft in the BA fleet. The 787 is 40 percent quieter and uses 20 percent less fuel than other similarly sized aircraft, which reduces carbon dioxide and nitrogen oxide air emissions. BA is also adding the new Airbus A350 to its fleet over the next five years.
