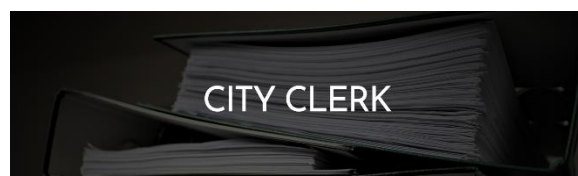
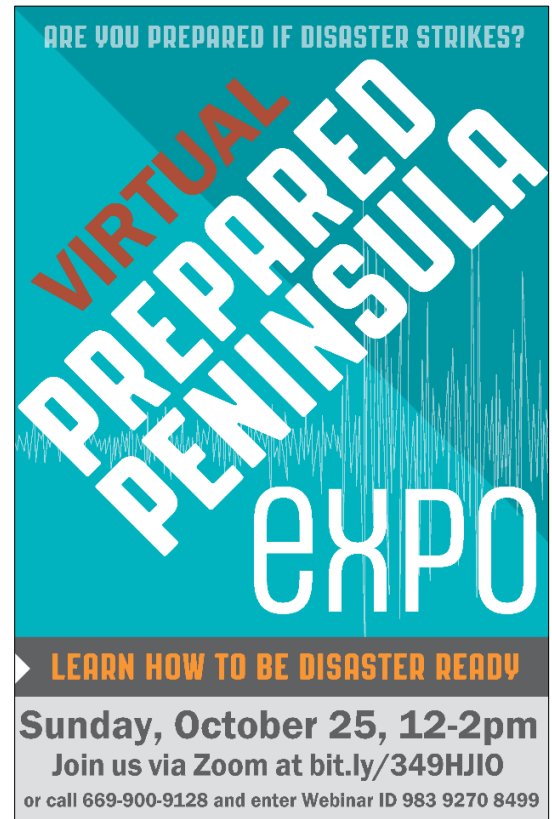

PV Transit Offers Free New Election Day Service

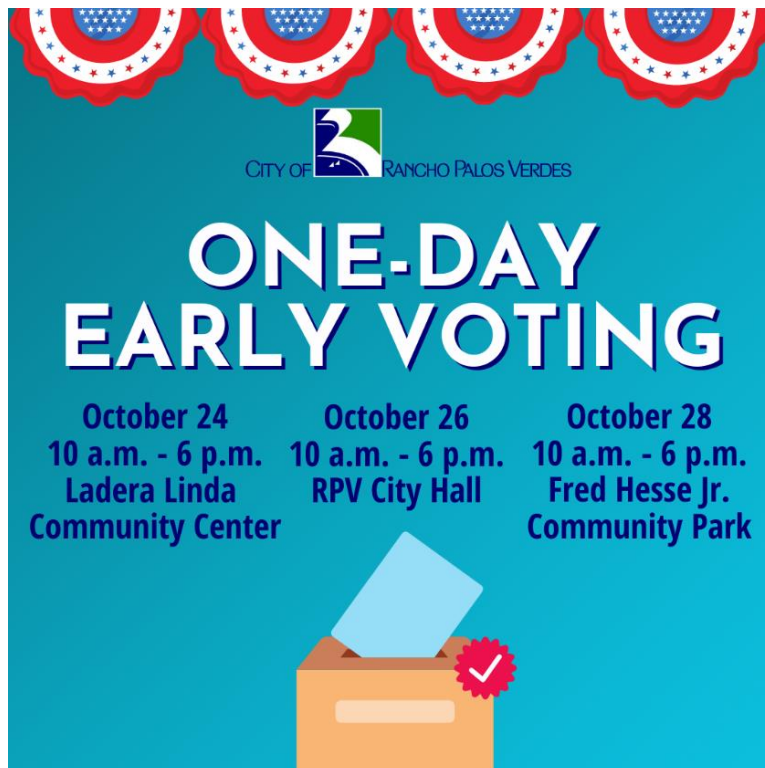
Palos Verdes Peninsula Transit Authority will offer **FREE dial-a-ride service to voting sites on Tuesday, November 3**, to seniors age 62 and older and persons with disabilities who reside in Rolling Hills Estates, Palos Verdes Estates and Rancho Palos Verdes.

This on-demand, door-to-door service will be provided on Election Day from 7 a.m. to 8 p.m. Advanced one-way and roundtrip reservations may be made from 9 a.m. to 2 p.m. beginning Tuesday, October 20, by calling 310-544-3710. Same-day reservations can also be made starting at 6 a.m. on November 3. The last pick-up at polling locations will be at 9 p.m.

After entering your personal information, your unique check-in code (barcode) will appear under your registration information. Show your code to the Election Worker when at the Vote Center to instantly check in. Your Quick Check-in Code is also printed on your mailed Sample Ballot and Vote Center postcard. You may take either of those hard copies to the Vote Center as well.

Update on Tax-Defaulted Properties

Last week, Staff learned that a tax-defaulted vacant lot in the 3100 block of Crownview Drive that the City had sought to acquire for a future trail segment was redeemed by the current owner and is no longer available. The City still has a pending Chapter 8 Agreement sale with the Los Angeles County Treasurer and Tax Collector's Office (TTC)

for a tax-defaulted vacant lot abutting the Agua Amarga Reserve. The estimated purchase price is \$15,007 and the purpose of the acquisition is to preserve open space and expand the Palos Verdes Nature Preserve. If the property is not redeemed by November 9, the agreement will become effective and the TTC will send the City a demand for payment. Staff will continue to monitor the status of this pending acquisition.

COVID-19 Cases

As of October 20, there are 290,009 confirmed cases of COVID-19 across Los Angeles County (population 10.17 million), including the South Bay, so the public should not think one location is safer than another, and everyone should be aware and practice physical distancing. The total includes 327 cases in Rancho Palos Verdes (population 41,731), 106 in Palos Verdes Estates (population 13,190), 45 in Rolling Hills Estates

(population 8,066), 12 in Rolling Hills (population 1,874), and 11 in the unincorporated areas of the Peninsula. Countywide, 6,912 people have died.

According to the Department of Public Health, 13 deaths have been reported in Rancho Palos Verdes. The City extends its deepest condolences to the families of these residents.

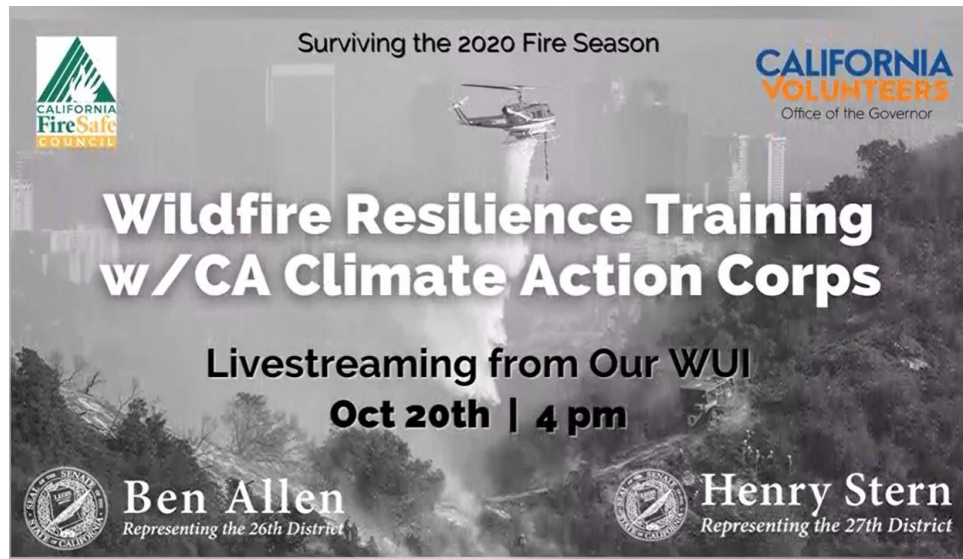


Virtual Investigatory Hearing on Homeowners Insurance Availability and Affordability

On Oct. 19, City Staff attended a Virtual Homeowners Insurance Investigatory Hearing, hosted by California Insurance Commissioner Ricardo Lara. During this investigatory hearing homeowners, industry experts, and insurance providers, among others, provided their input into regulations that would offset rising premiums with discounts for mitigating wildfire risks. Following the public input, as well as concerns, Commissioner Lara stated he will take the following actions which include but not limited to the following:

- Developing of home-hardening standards that are consistent, based on fire science, and apply to all insurance companies;
- Giving transparency to consumers about their wildfire risk score and what they can do to reduce it.
- Creating insurance incentives recognizing home hardening, mitigation of properties, and community mitigation actions, and
- Requiring that insurance companies seek adequate and justifiable rates to protect the solvency of the market.

City Staff will continue to coordinate with the California's Insurance Commissioner and local insurance underwriters to understand how residents can avoid premium hikes and reduced insurance availability. Virtual Town Hall on Safeguarding Homes During Fire Season

On October 20, City Staff attended a Virtual Town Hall on Safeguarding Homes During Fire Season jointly hosted by Senators Ben Allen and Henry Stern. During this Virtual Town Hall, representatives from the California Fire Safe Council provided information on wildfire home hardening and the importance of regularly clearing your home's roof, gutters, decks, and the base of walls to avoid the accumulation of fallen leaves, needles and other flammable materials that can be ignited by embers.

Additionally, Community Members from the Chatsworth Lake Manor neighborhood discussed the steps they are taking to create their own local Fire Safe Council. Furthermore, representatives from California Volunteers discussed opportunities for students and residents to get involved with California Volunteers, newly created state-level [Climate Service Corps](#), which was recently established to empower all Californians to take meaningful action to safeguard the climate.

City Staff will continue to attend informational webinars on Safeguarding Homes from wildfires and disseminate information to the community. With an uptick in recent brush fires across the Los Angeles County region, Peninsula residents are reminded to be on heightened alert and to be prepared for wildfire.

- If you see something, say something. Report any sign of smoke or fire immediately to your local fire department by dialing 9-1-1. If you dial 9-1-1 from your cellphone, be sure to know your location.
- Have your Ready! Set! Go! Wildfire Action Plan in place. It is critical for residents to be familiar with the Ready! Set! Go! program that provides important pre-planning and evacuation information.
- Download the Ready! Set! Go! Wildfire Action Plan and view informational how-to videos, visit fire.lacounty.gov/rsg



Sign up for Alert SouthBay

Alert SouthBay is a multi-jurisdictional emergency notification system used by 13 South Bay cities – including Rancho Palos Verdes -- to keep our communities informed about disasters and emergencies with uniform, expeditious alerts.

Alert SouthBay is an opt-in system using the Everbridge software application. Similar to Nixle alerts, Everbridge sends notifications via email, text message, cellular, and landline phones. Users can subscribe to receive alerts from multiple South Bay cities. If you live in Rancho Palos Verdes, for example, but work in Torrance, you can subscribe to alerts from both cities.

Everbridge is the City's primary vehicle for emergency communication. Users can sign up by:

- Texting "alertsb" to 888-777, which returns a link to register for Everbridge (for COVID-19-related alerts, text the keyword "cv19rpv")
- Registering online at alertsouthbay.com
- Downloading the free [Everbridge app](#) on an iOS or Android device from the [App Store](#) or [Google Play](#)

Wildfire Home Hardening

Flying embers from a wildfire can destroy homes up to a mile away. Taking the necessary measures to harden (prepare) your home can help increase its chance of survival when wildfire strikes.

The following are ways you can harden your home and make it more fire-resistant:

Roof

- The roof is the most vulnerable part of your home. Homes with wood or shingle roofs are at high risk of being destroyed during a wildfire.
- Build your roof or re-roof with materials such as composition, metal or tile. Block any spaces between roof decking and covering to prevent embers from catching.

Vents

- Vents on homes create openings for flying embers.
 - Cover all vent openings with 1/16-inch to 1/8-inch metal mesh. Do not use fiberglass or plastic mesh because they can melt and burn.
 - Use Ember and flame resistant vents

Eaves

- Eaves should be protected with ignition-resistant or non-combustible materials.

Windows

- Heat from a wildfire can cause windows to break even before the home is on fire. This allows burning embers to enter and start fires inside. Single-paned and large windows are particularly vulnerable.
 - Install dual-paned windows with one pane of tempered glass to reduce the chance of breakage in a fire.
 - Consider limiting the size and number of windows that face large areas of vegetation.

Walls

- Wood products, such as boards, panels or shingles, are common siding materials. However, they are flammable and not good choices for fire-prone areas.
 - Build or remodel your walls with ignition resistant building materials, such as stucco, fiber cement wall siding, fire retardant, treated wood, or other approved materials.
 - Be sure to extend materials from the foundation to the roof.

Decks

- Surfaces within 10 feet of the building should be built with ignition-resistant, non-combustible, or other approved materials.
 - Ensure that all combustible items are removed from underneath your deck.

Rain Gutters

- Keep rain gutters clear or enclose rain gutters to prevent accumulation of plant debris.

Patio Cover

- Use the same ignition-resistant materials for patio coverings as a roof.

Chimney

- Cover your chimney and stovepipe outlets with a non-flammable screen. Use metal screen material with openings no smaller than 3/8-inch and no larger than 1/2-inch to prevent embers from escaping and igniting a fire.

Garage

- Have a fire extinguisher and tools such as a shovel, rake, bucket, and hose available for fire emergencies.
- Install weather stripping around and under the garage door to prevent embers from blowing in.
- Store all combustible and flammable liquids away from ignition sources.

Fences

- Consider using ignition-resistant or non-combustible fence materials to protect your home during a wildfire.

Driveways and Access Roads

- Driveways should be built and maintained in accordance with state and local codes to allow fire and emergency vehicles to reach your home. Consider maintaining access roads with a minimum of 10 feet of clearance on either side, allowing for two-way traffic.
- Ensure that all gates open inward and are wide enough to accommodate emergency equipment.
- Trim trees and shrubs overhanging the road to allow emergency vehicles to pass.

Address

- Make sure your address is visible from the road.

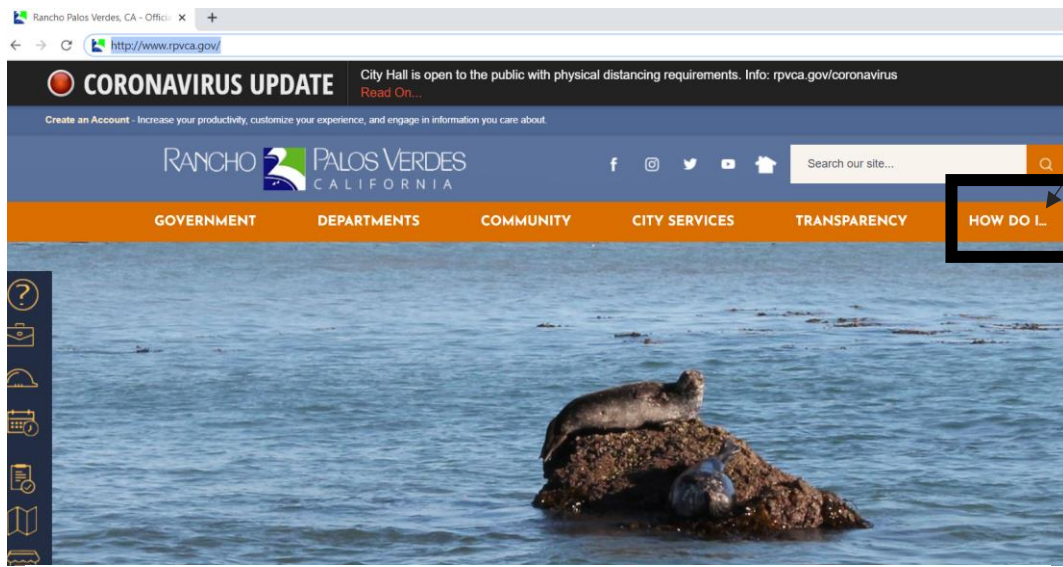


Options to Pay Online

In August 2020, the Finance Department introduced a new option for residents and businesses to pay for fees and permits through the City's website. The online payment option offers a more convenient, secure, and quick ways to pay online as an alternative to making payments at City Hall, over the phone, or mailing a check to the City. Additionally, online payments are cost-effective, and more convenient than traditional paper checks. Since August, the new option received positive feedback from customers and received 264 transactions, including payments for permits, accounts receivable invoices, and taxes.

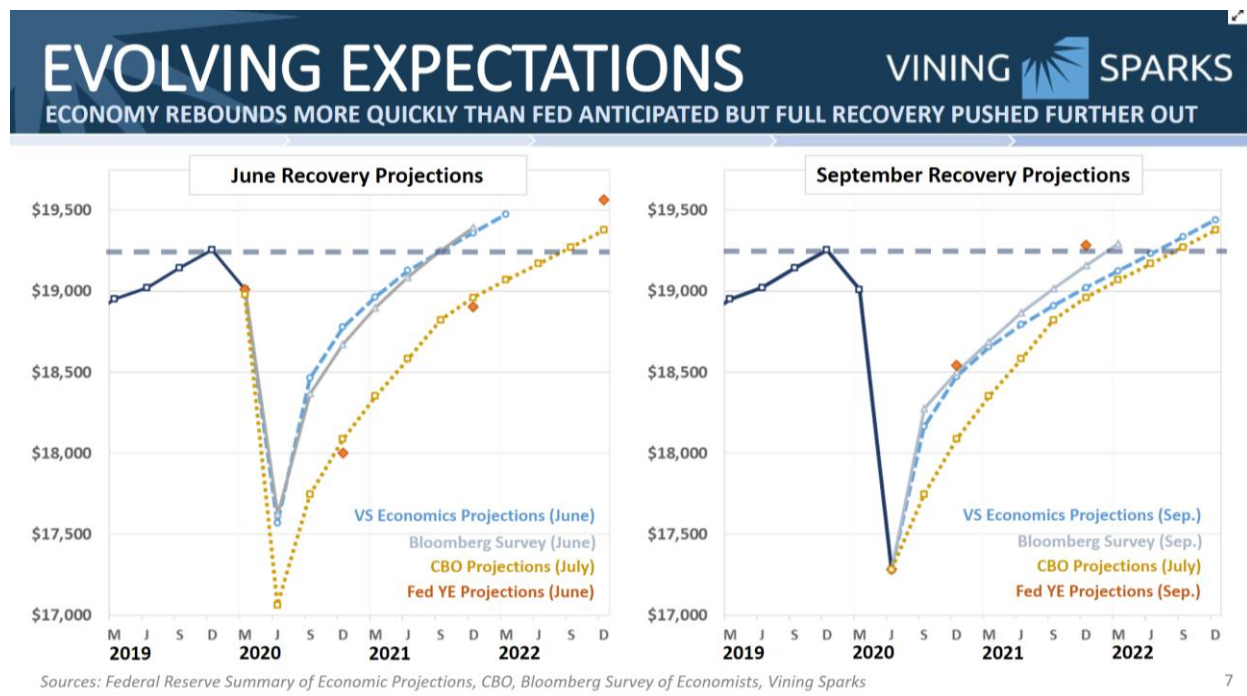

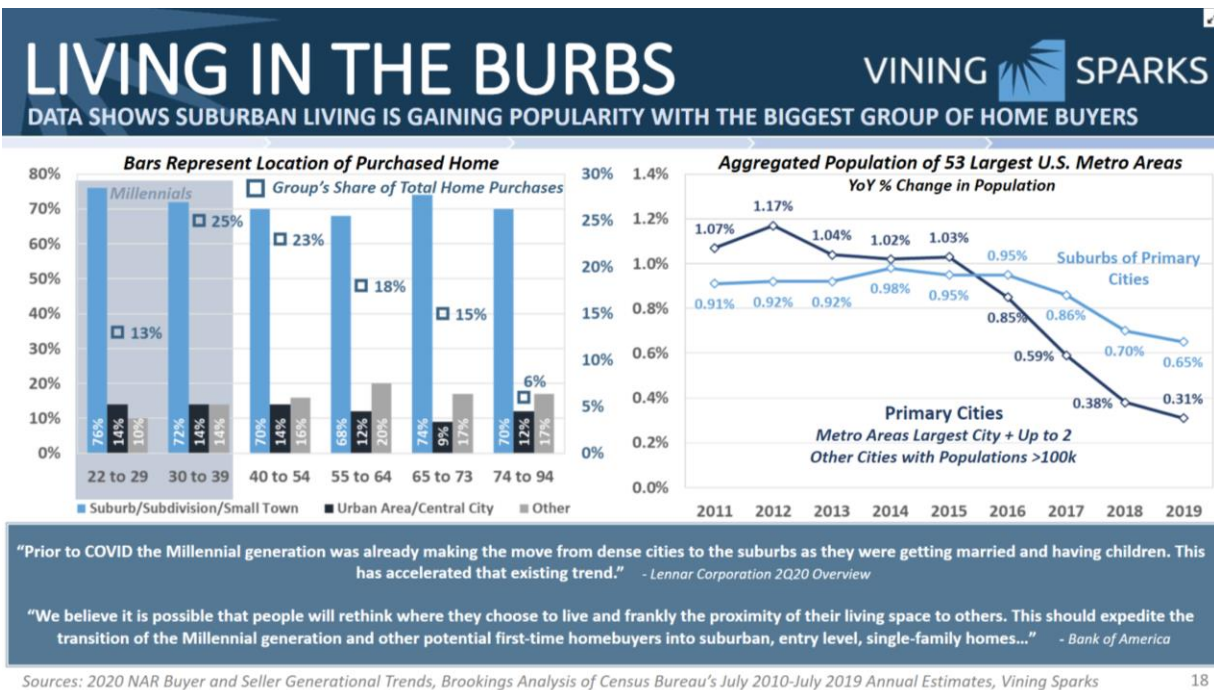
Economic Update

Earlier this month, Vining Sparks held a 4th quarter economic outlook webinar. In their presentation, they noted that the 3rd quarter experienced a stronger than expected recovery. In June, a slower bounce back of the economy was anticipated. However, despite this positive news, the timeline for full recovery has been pushed out.

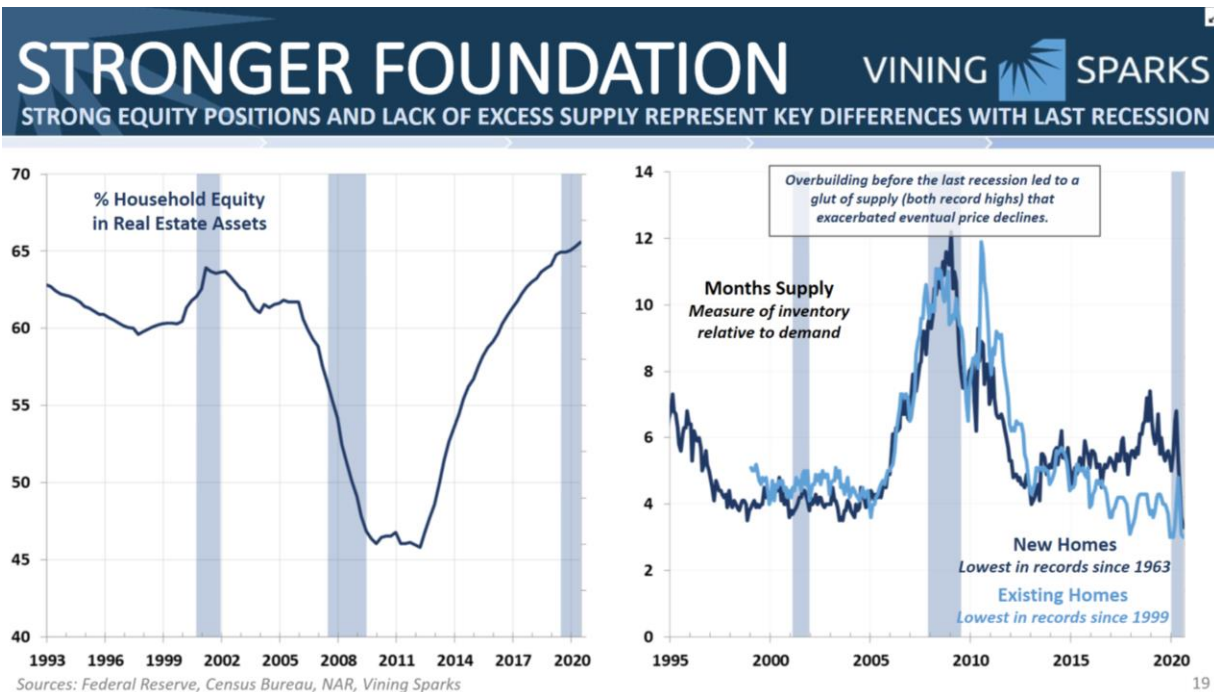


The difficulty in determining when the economy will recover is the unpredictability of the virus and the cycle of surging cases throughout the country. Big questions still loom for the country, such as when a vaccine will be available in large numbers to the population and if the economy will return to normal.

The housing market has performed surprisingly well. Part of the reason for this could be that the pandemic has had a disproportionate impact on renters compared to home owners. There has also been a trend of households leaving large urban areas for suburban life instead.



The major difference between the housing market during this downturn and the great recession that began in 2008 is the strong equity position of homeowners and the absence of overbuilding, that led to an excess of real estate.



Small Business Financial Assistance Plan Update

On April 8, 2020, the City of Rancho Palos Verdes implemented the Small Business Financial Assistance Plan to provide relief and promote the general welfare of the City's small business community experiencing negative financial impacts stemming from the COVID-19 pandemic. The Small Business Financial Assistance Plan provides a one-time refund of the 2020 business license.

On June 2, 2020, the City Council received a status report on the Small Business Financial Assistance Plan. As a result of the low response, the City Council expressed a desire to increase the number of eligible small businesses by removing the limitation that a small business must have a "brick-and-mortar" location to be eligible to receive a refund.

Since the implementation on April 8th:

- the City has received 22 requests for business license tax refunds
- 14 refunds totaling \$4,939 have been issued to date

Portuguese Bend Landslide Mitigation Project – Environmental Document

The Initial Study (IS), the first part of the environmental study for this project, has been prepared and submitted by the Consultant, and Staff have completed their review. The Consultant is now addressing the City's comments and finalizing the report for public review. The IS will determine whether the project will require the preparation of a Mitigated Negative Declaration or an Environmental Impact Report. In summary, upon completing the environmental document and the public review process, the design will be finalized and presented to the City Council for final approval along with the certification of the environmental document. Concurrently, funding sources will be identified for the project. Once funding is identified by the City Council, the construction phasing can be established and solicitation for contractors' proposals for construction may begin.

The goal of the proposed Portuguese Bend Landslide Mitigation Project is to stabilize the existing landslide area through a series of recommended mitigation measures which follow a phased construction approach. The anticipated construction phases are as follows: (i) surface fracture infilling; (ii) surface water improvements (improvements include the refurbishment of existing swales and pipes, and construction of a reduced flow area, which essentially serves as a detention basin near the bottom of the hill landward of Palos Verdes Drive South (PVDS); (iii) and groundwater mitigation improvements (designed to alleviate artesian water pressure underground in the landslide area). Long-term maintenance and landslide monitoring will continue post-construction.

Safe, Clean Water Program

The Safe, Clean Water (SCW) Program, created by Measure W in 2018, is intended to improve water quality to benefit the health and well-being of Los Angeles County communities. Revenues derived from the tax may be used for municipal projects relating to protecting and improving water quality. An SCW Application to help fund the Portuguese Bend Landslide Complex Mitigation Project was submitted on October 15. A review committee will assess the application for funding eligibility and consideration. The anticipated approval for Fiscal Year 2021-2022 Stormwater Investment Plan by the Los Angeles County Board of Supervisors is August 2021.

Highway Safety Improvement Program

Earlier this week, the City's application for a Highway Safety Improvement Program (HSIP) grant for the Palos Verdes Drive East Traffic Safety Project was submitted to Caltrans. The City Council authorized Staff to pursue this grant opportunity in July 2020. The City is seeking \$999,000 for improvements to approximately 4,700 feet of guardrails along Palos Verdes Drive East. Between 2008 and 2019, there have been over 20 accidents, including two fatalities and several severe injuries. Caltrans is expected to decide on HSIP grant awards in November or December 2020. Staff will continue to monitor the status of this application and provide updates.

Paper Shredding Event Successful

The City's Fall Season paper shredding day was held on Saturday, October 17. The event was popular as ever and drew over 795 residents. Although the event started at 8:00 a.m., people were eager to participate; cars were in line at City Hall as early as 6:30 a.m. Public Works Maintenance Staff set up a special event traffic control on Hawthorne Boulevard and at the entrance of City Hall, through the overflow parking lot. Over 15 contracted workers arranged for further traffic controls around the shredding trucks and helped direct attendees. Extra COVID-19 related safety precautions were taken, including the wearing of face coverings, car windows always rolled-up, and instructions to have all desired shredded material placed in the trunk. This allowed minimal contact during the removal of materials to better follow social distancing protocols. The event was modified and did not offer mulch or electronic waste collection. Residents were informed of these changes through social media, newspaper, breaking news, and Nextdoor announcements. Additionally, residents were notified of how to request electronic waste collection services by calling EDCO at 310-540-2977.

Staff thanks the contractor, EDCO, for their diligent work throughout this popular event. All the material was shredded on-site by certified shredding trucks. The weight of the shredded material will be provided in next week's update.



2019 Annual Report for Solid Waste and Recycling Activities Submitted to CalRecycle

The **California Department of Resources Recycling and Recovery** (CalRecycle) is a branch of the California Environmental Protection Agency that oversees the state's waste management, recycling, and waste reduction programs. Annually each jurisdiction in California is legally required to submit an electronic annual report (EAR) to CalRecycle. The EAR, due August 1 of each year, is an annual self-evaluation of solid waste diversion performance. However, this year due to COVID-19, many recycling and processing facilities were temporarily closed. This created a delay in providing disposal and recycling tonnage information to complete the EAR. As a result, the due date for the 2019 EAR was extended to October 13, 2020. The City is a member of the Los Angeles Regional Agency (LARA), which is comprised of 18 cities and submits one annual report which provides activities of every member city. Staff is pleased to report that LARA submitted the 2019 annual report on October 8, 2020. Maintenance Activities

This week, Public Works continued its regularly scheduled maintenance, trash pickup, irrigation repairs, and general repairs at all City parks and facilities. Public Works continues to sanitize its parks' and facilities' restrooms daily to help reduce COVID-19 spread. The right-of-way landscape maintenance team continued working along Palos Verdes Drive West, clearing the weeds along the median and sidewalk.

This week in roadway and right-of-way maintenance, Public Works Maintenance continued making repairs to sidewalks with deviations. Streets that received a grind repair to any deviations larger than ½ inch included Calle Aventura and Elmbank Road. Several signs were also repaired along Springcreek Road, Calle Entradero, and at City Hall.

This week, the Los Angeles Public Works Sewer Division continues its maintenance inspections of the sewer system in RPV. Los Angeles County Sewer Division, responsible for maintaining the City's sewer system, is concentrating work in the northwest portion of the City this fiscal year. Attached is a map of the current schedule. The map shows what has been completed in pink and what is scheduled to be completed through the end of October 26, 2020, in green. The Public Works Department will also commence road repairs on Eddinghill Drive this week. This work will consist of large bump repairs at several locations along the 6660-6700 block of Eddinghill Drive. Work is scheduled for October 20 through October 22. Please expect small delays and reduced parking availability during this time. Work hours are from 7:30 am-5:00 pm. Thank you to the residents for your cooperation.

The Public Works Department responded to the following urgent/emergency requests:

- 11 graffiti removals cases were addressed during this week.
- Responded to a large amount of debris on Palos Verdes Drive West.
- A Landscape truck dropped tree and branch debris on the roadway; Public Works responded and removed the debris quickly.
- Responded to and helped remove a stalled-out vehicle on Hawthorne and Palos Verdes Drive South which created a traffic back-up.



- Responded to and removed a large pepper tree branch in the roadway on PVDE.

Proposed Green Hills Memorial Park Grading Permit

On October 20, 2020, a representative from the Green Hills Memorial Park submitted a Major Grading Permit application to the City's Planning Division. The project proposes to conduct approximately 2,200 cubic yards (1,100 cubic yards of cut and 1,100 cubic yards of fill) of grading within Area 2 (Alta Vista Gardens) of the site. The grading is proposed to accommodate the installation of lawn crypts. Staff is currently in the process of reviewing the application materials and a public notice to property will be issued, pursuant to the Council-adopted Conditions of Approval, once the application is deemed complete for process. Palos Verdes Nature Preserve Parking and Access Issues

The City Council addressed Palos Verdes Nature Preserve (Preserve) parking and access issues at its October 20, 2020 meeting. The item was focused primarily on the Del Cerro area, but also addressed overall Preserve issues. These actions followed meetings on August 18, 2020, and September 1, 2020, where Council issued a number of directives, including a temporary parking moratorium on a 390-foot section of Crenshaw Boulevard, south of Crest Road with the addition of a drop-off area, creation of a holistic Preserve parking analysis, directed Staff to provide an update on the installation of entry gates at the Burma Road and Rattlesnake trailheads, research on parking enforcement alternatives and a parking reservation system in the Del Cerro area.

These directives were undertaken due to the ongoing traffic, noise and safety concerns that have been raised in the Del Cerro area for years. Balancing quality-of-life concerns for neighbors living near the Preserve with public access has been an ongoing challenge.

There was extensive public outreach leading up to the October 20 meeting, including a well-attended Preserve Public Forum on October 13, letters sent to all Homeowner Associations (HOA) adjacent to the Preserve, listserv messages, and meetings with multiple affected HOAs. Robust late correspondence on this issue was received prior to the Council meeting and over 30 individuals spoke or sent in recorded messages.

Below is a list of Council actions taken on October 20.

1. Received and filed a status update on the City's continued social media campaign to direct visitors to appropriate designated parking areas.
2. Directed Staff to return to the City Council with a holistic parking analysis focused on short, medium, and long-term goals, for the entire Preserve, including parking alternatives and recommendations by December 15, 2020.
3. Received and filed a status update on the installation of the entry gates at the Burma Road and Rattlesnake Trailheads and included change order language;

4. Directed Staff to open the Burma Road and Rattlesnake Trailhead gates at 7 a.m and close them at a set time on a quarterly basis based on the latest sunset time during that period.
5. Directed Staff to initiate the process to hire part-time parking enforcement and report back to Council by December 15, 2020.
6. Directed Staff to proceed with a request for proposals (RFP) to establish a parking app system for the Del Cerro area along Crenshaw Boulevard, and other areas; as deemed appropriate by the City and return to Council on December 15, 2020.
7. Deferred entering into an agreement with the Palos Verdes Peninsula Unified School District to use the parking lot at the Rancho Del Mar School for Preserve parking.
8. Directed Staff to extend the parking prohibition along Crenshaw Boulevard south of Crest Road until December 15, 2020, at which time the City Council will consider whether to extend the temporary parking prohibition. Staff was directed to extend the existing passenger loading zone.
9. Directed Staff to analyze parking and citation fees by December 15, 2020.
10. Directed Staff to work with Palos Verdes Peninsula Land Conservancy (PVPLC) on potential trailhead and adjacent park beautification at the Alta Vicente Reserve.
11. Directed Staff to work with PVPLC on an analysis of capacity levels in the Preserve.

Staff will bring back the indicated items for the Council review on December 15, 2020. Staff will also work with a traffic engineer to study ways to address parking and traffic safety concerns on Crenshaw north of Crest Road, and other areas adjacent to the Preserve. Staff will continue to provide weekly updates.

NCCP/HCP Implementing Agreement

The City has received the Implementing Agreement (IA) from the US Fish and Wildlife Service for signing. Signing the IA is part of obtaining permits associated with the City Council-adopted NCCP/HCP. Specifically, the IA is a joint document between the applicant (City and PVPLC) and the Wildlife Agencies that clarifies the provisions of a habitat conservation plan and specifies how those provisions will be carried out. The City anticipates final review and signing (by the Mayor) over the next two weeks.

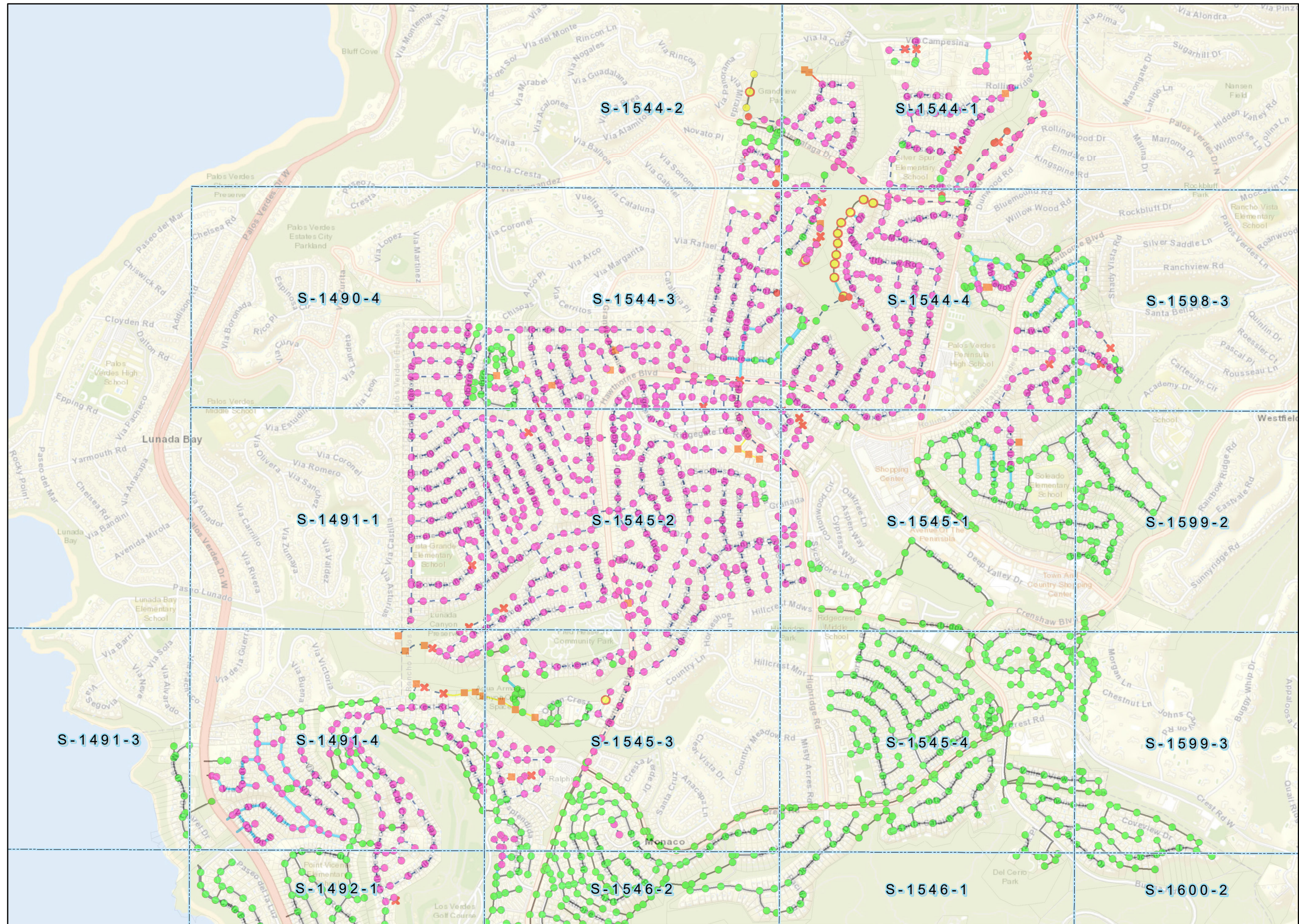

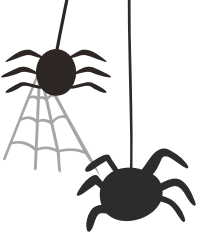
