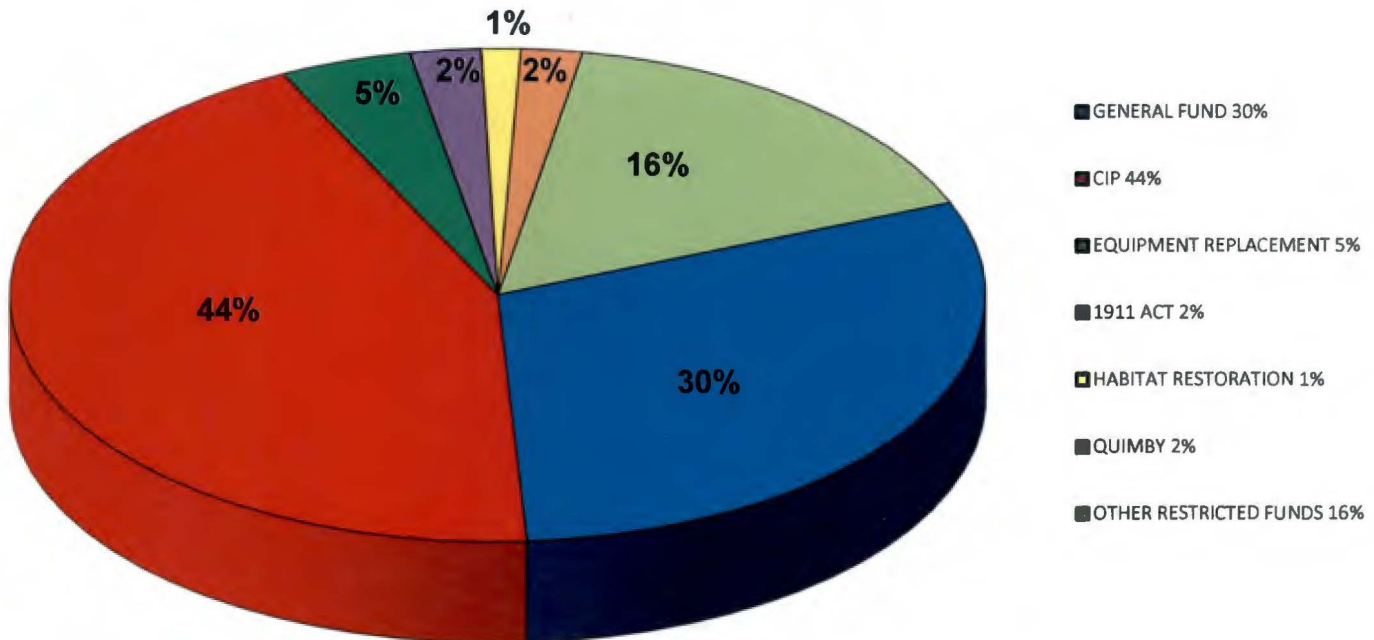

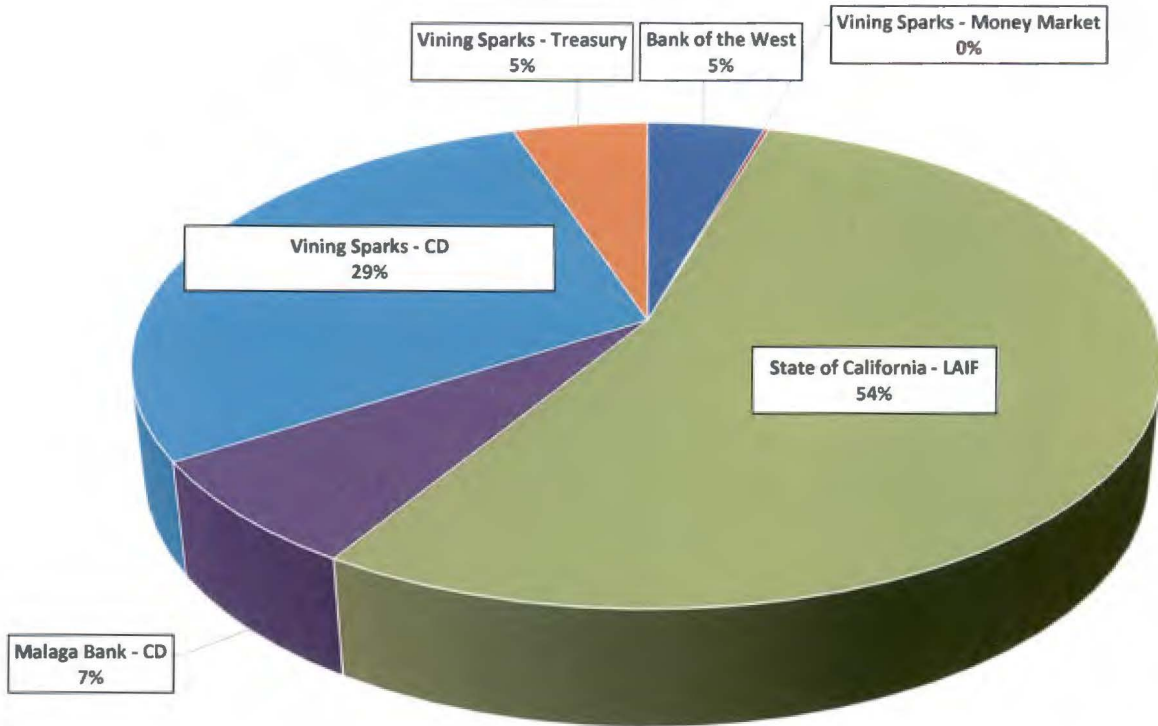

OCTOBER 2020

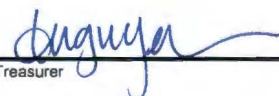
