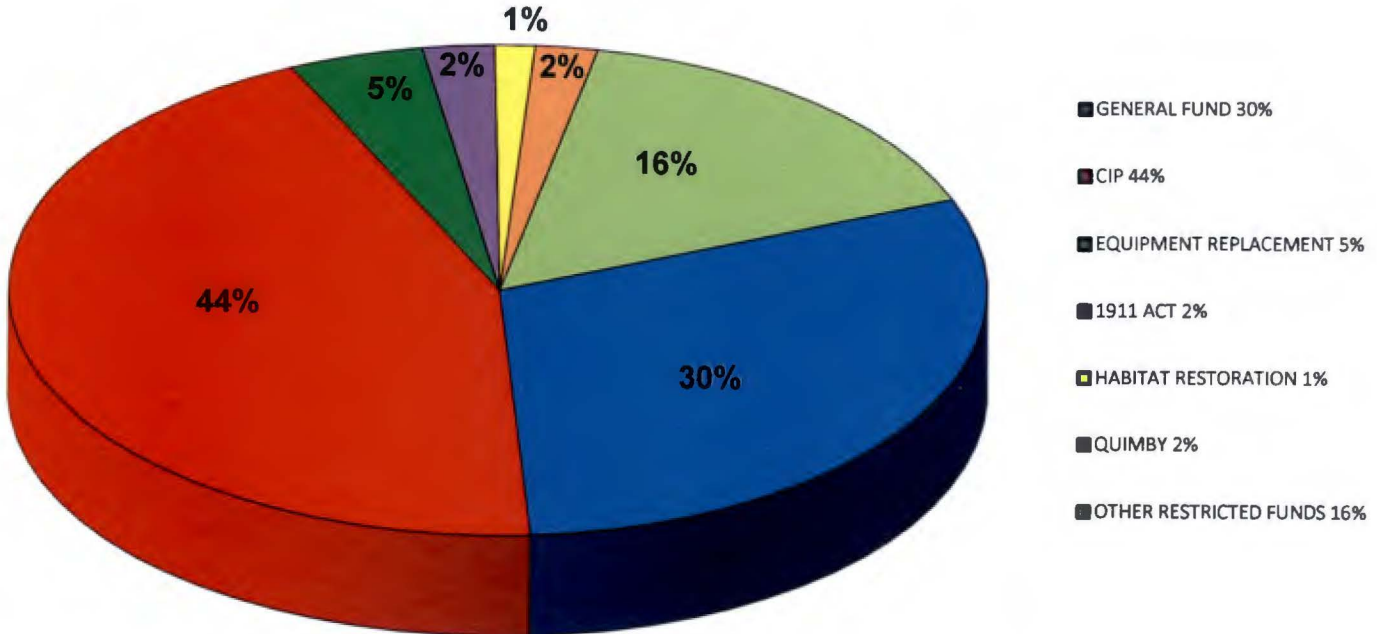

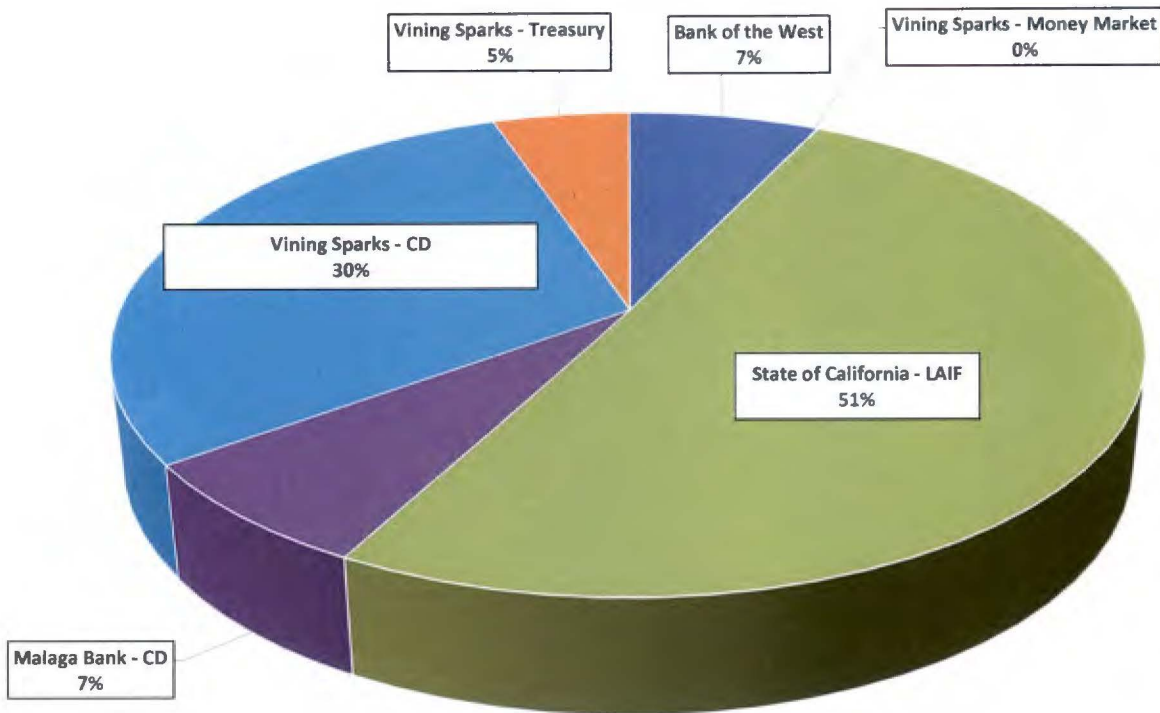

NOVEMBER 2020



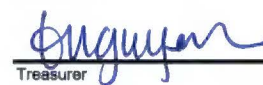
