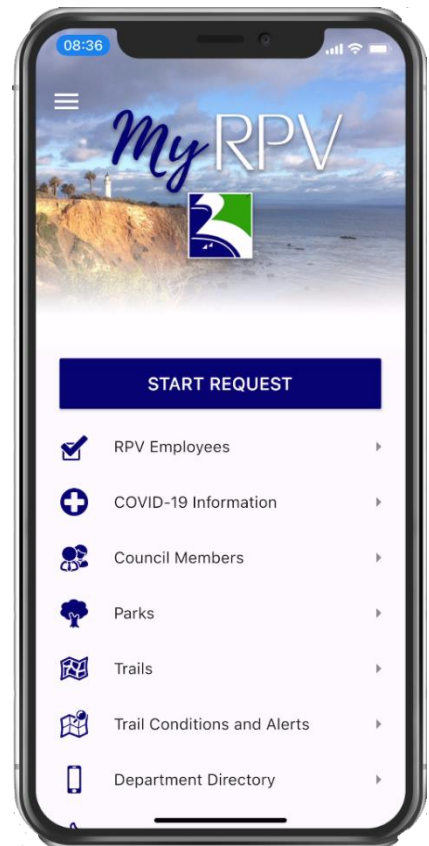

The City is excited to announce the launch of the MyRPV app!

MyRPV provides Rancho Palos Verdes residents, businesses, and visitors access to City Hall 24 hours a day, 7 days a week, from anywhere, via their smartphone or tablet. Submitting service requests has never been easier! Simply open the app, select an issue, take a picture, and tap submit — the app knows the exact location and sends the issue directly to City staff. You can also track the status of your request or send a message to City staff.

MyRPV offers quick access to relevant City information, from City Council meeting agendas and videos, to information on how to get in touch with City departments, visiting parks, trails, and more. You can also get push alerts in real-time from the City by allowing the app to send you notifications.



The free MyRPV app is now available to download for your iOS or Android device from the [App Store](#) or [Google Play](#) by searching “MyRPV.”

Please note that until the City’s previous app used for graffiti reporting cannot be integrated into the new MyRPV app, so graffiti should still be reported using the previous app, which has been renamed “RPV Clean.”

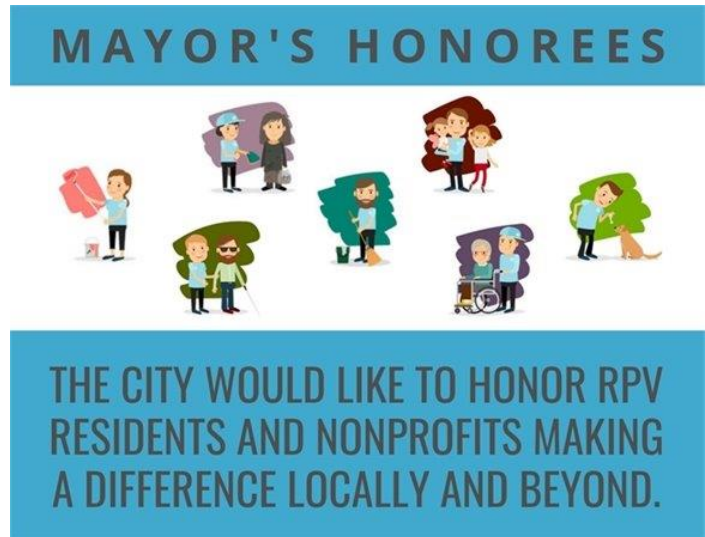

Outdoor dining allowable with physical distancing and new infection control protocols in place

- **Employees that may come in contact with customers must wear both a face covering and a face shield at all times when interacting with customers and when in customer service areas.**
- **Outdoor dining table seating must be limited to no more than 6 people per table, all of whom must be from the same household.**
- **Outdoor tables must be repositioned or removed so that all tables are at least 8 feet apart.**
- **Televisions or other screens that broadcast programming must remain off.**

Outdoor Dining Service Returns with New Mandatory Safety Measures

Last week, the L.A. County Department of Public Health modified the Health Officer Order to closely align with the sector reopenings permitted in the state's Blueprint for a Safer Economy most restrictive purple tier. Outdoor dining at restaurants, wineries, and breweries may reopen with additional safety measures in place to mitigate the increased risk since customers are permitted to spend time unmasked at these businesses. Indoor dining is not permitted. All employees that can come in contact with customers must wear **both** a face covering and a face shield at all times. Persons from different households are not allowed to share a table. All establishments must post signage to this effect and verbally inform customers that everyone sharing a table must be from the same household. Tables must be positioned at least 8 feet apart and televisions or other screens must be turned off. The order also removed operating hour restrictions for non-essential businesses.

Letter on Establishing Vaccination PODs on the Peninsula

On January 29, a letter on behalf of the city managers of the four Peninsula cities was sent to the Los Angeles County Board of Supervisors and Department of Public Health Director Dr. Barbara Ferrer seeking to establish local COVID-19 vaccination PODs on the Peninsula (see attachments). Specifically, the letter proposed establishing vaccination sites at either Ernie Howlett Park in Rolling Hills Estates, and City Hall, Hesse Park, the Point Vicente Interpretive Center, and the Point Vicente Lighthouse in Rancho Palos Verdes. The city managers requested guidance on the next steps necessary to set up local PODs as quickly and efficiently as possible. Staff will continue to monitor this issue.

City Hall to Remain Temporarily Closed to the Public through February 12; Outdoor Recreation Classes to Resume February 8

Although COVID-19 cases are trending down in L.A. County, because transmission remains relatively high and to limit public contact to protect the health and well-being of residents and City staff, **City Hall will remain temporarily closed to the public through February 12.** The City remains open for business, however, by telephone, email, online, and limited curbside services. Some employees are working on rotation and maybe working remotely.

As a reminder, all City park buildings are closed. Following Monday's revised Health Officer Order, **outdoor recreational programming will resume on February 8.** Classes include yoga, dance, fitness, lacrosse, art, enrichment, and more. To limit the risk of exposure to and transmission of the virus, all classes are held outdoors, class sizes are

limited, and participants and instructors are required to wear face coverings except during heavy physical exertion.

COVID-19 Cases

As of February 2, there are 1,124,558 confirmed cases of COVID-19 across Los Angeles County (population 10.17 million). The total includes 1,129 cases in Rancho Palos Verdes (population 42,747), 336 in Palos Verdes Estates (population 13,522), 220 in Rolling Hills Estates (population 8,113), 40 in Rolling Hills (population 1,940), and 47 in the

unincorporated areas of the Peninsula (population 1,921). Countywide, 17,057 people have died.

According to the Department of Public Health, 36 deaths have been reported in Rancho Palos Verdes. The City extends its deepest condolences to the families of these residents.

Letter From the CA Insurance Commissioner Ricardo Lara and the Department of Insurance

On January 28, the City received a letter from California Insurance Commissioner Ricardo Lara regarding available resources that the CA Department of Insurance (CDI) offers for residents. (see attachments). Commissioner Lara noted that the Department of Insurance's Outreach Team is available to meet on an individual basis with local leaders or to make presentations on a community-wide basis at town halls, briefings, roundtables, exhibits, or other events.

City Staff will continue to coordinate with California's Insurance Commissioner and local insurance underwriters to glean a better understanding of how the City can avoid premium hikes and reduced insurance availability for residents and neighborhoods interested in fire hardening homes.

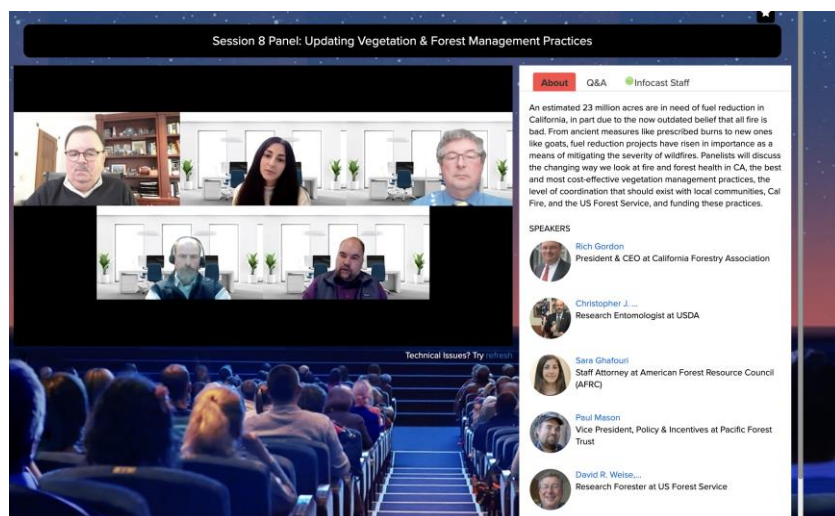

Today, Staff will be attending the second day of the virtual conference on wildfire preparedness hosted by Infocast. The second day of the virtual conference session will be focused on the theme of Meeting Immediate Community Needs in Mitigation & Emergency Preparedness.

This conference provides city staff with helpful information on successful approaches to mitigate and respond to wildfires and how City staff can be prepared to lead their communities through emergencies. City staff will be presenting key findings on approaches to wildfire risk mitigation from this conference to the City's Emergency Preparedness Committee during their March 18, 2020, regular meeting.



Regional Law Enforcement and Emergency Preparedness Committee

The Regional Law Enforcement Committee (RELC) and the Regional Emergency Preparedness Committee (REPC) will be convening for their quarterly meeting on Thursday, February 11, in an online meeting format. The Regional Emergency Preparedness Committee Meeting will begin at 7:30 a.m., and the Regional Law Enforcement Committee Meeting will commence after its conclusion.

The Regional Law Enforcement Committee (RELC) consists of two Council Members from the Cities of Rancho Palos Verdes, Rolling Hills, and Rolling Hills Estates, who share municipal law enforcement services provided by the Los Angeles County Sheriff's Department. The RELC meets on a quarterly basis to review the Sheriff's performance, make policy recommendations regarding the joint contract, review statistics for the preceding quarter concerning crime incidents, traffic enforcement, response times, false alarm rates, and the distribution of the Sheriff's patrol time throughout the region. The RELC also discusses the collaboration on the automatic license plate reader (ALPR) program.

The Regional Emergency Preparedness Committee (REPC) consists of two Council Members from all four Peninsula Cities of Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, and Palos Verdes Estates. The REPC meets quarterly on the same day as the RELC to discuss collaborative efforts on ensuring Peninsula-wide emergency preparedness. The objective of the REPC is to enhance emergency preparedness on the Peninsula by addressing joint preparedness efforts and response to widespread disasters affecting the greater Peninsula.

Power Outage Safety

Communities depend on electricity for heating and air conditioning and food, drinking water, medical care, communication, and other needs. Power outages can be dangerous

during extreme cold temperatures or extreme heat. Power outages can also be dangerous for those who rely on electricity for medical devices.

A power outage may:

- Disrupt communications, water, and transportation.
- Close retail businesses, grocery stores, gas stations, ATMs, banks, and other services.
- Cause food spoilage and water contamination.
- Prevent use of medical devices.

PREPARING BEFORE A POWER OUTAGE:

Preparing for power outages can help minimize the impact and keep you and your family safe. The following are steps you can take to minimize impacts from a power outage and to keep all members of your household as comfortable as possible.

- **Create a support network.** Identify people who can help you stay at home or evacuate during an extended power outage. Keep a paper copy of your contact list.
- **Stay connected and alert.** Sign up for alert systems and apps for text alerts. Have communication devices that work without home power, including a crank or battery radio, a non-cordless home phone, chargers/batteries for your cell phones and your computers.
- **Know and plan for your personal and medical electrical needs.** Talk to your medical provider about a power outage plan for medical devices powered by electricity and refrigerated medicines. Find out how long medication can be stored at higher temperatures and get specific guidance for any medications that are critical for life.
- **Take an inventory of your electrical needs.** Consider both back up and non-power alternatives for lighting, communication, medical devices and refrigerated medicine, cooking, garage doors, locks, and elevators.
- **Stock food and water.** Store non-perishable food and water supplies for at least two weeks. Plan to use coolers and ice to extend food refrigeration and keep a thermometer in the fridge, freezer or cooler to monitor the food temperature.

DURING A POWER OUTAGE:

- **Monitor alerts.** Check local weather reports and any notifications by phone, television, or radio. Utility officials may come to your door to alert you of a planned power outage.
- **Keep food cold, and when in doubt, throw it out.** Eat your fresh, perishable foods first. Avoid opening your refrigerator and freezer to preserve cool temperatures.

An unopened refrigerator will keep foods cold for about 4 hours. A full freezer will keep the temperature for about 48 hours (24 hours if it is half full) if the door remains closed. Measure the food temperature in your refrigerator and freezer with a thermometer. Throw out food that has been warmer than 40 degrees F.

- **Prevent power overloads and fire hazards.** Turn off or disconnect appliances, equipment, or electronics. Power may return with momentary surges or spikes that can cause damage.
- **Use flashlights, not candles.** Turn off the utilities only if you suspect damage or if local officials instruct you to do so.
- **Prevent carbon monoxide poisoning.** Don't use a gas stove to heat your home and do not use outdoor stoves indoors for heating or cooking. If using a generator, keep it outside in a well-ventilated area away from windows.

AFTER A POWER OUTAGE:

- **When in doubt, throw it out!** Throw away any food that has been exposed to temperatures 40 degrees or higher for two hours or more, or that has an unusual odor, color or texture.
 - If the power is out for more than a day, discard any medication that should be refrigerated, unless the drug's label says otherwise. Consult your doctor or pharmacist immediately for a new supply.
- **Keep away from power lines.** Stay at least 35 feet away from fallen power lines and anything they are touching. Call 911 and let them know.
- **Restock your emergency kit** so the supplies will be there when needed again.

Tips to Prevent Vehicle Burglaries

Take steps today to prevent thefts from your vehicle. Residents are strongly encouraged to use “Lock It or Lose It” prevention tips every day. It only takes a matter of seconds for a thief to break into your car and grab your valuable items.



Look through the windows of your vehicle. What do you see? A bag on the passenger seat? A charging cord? A garage door opener? Change in a cup holder? Take it with you or remove it from plain view and be sure to close all windows and lock doors.

Follow these tips to help prevent vehicle burglaries:

1. Remove all valuable items from your car including purses and electronics.
2. If you must leave valuables behind, put them in your trunk before you reach your destination. Avoid doing so while in plain view.
3. Set your alarm or anti-theft device.
4. Park in a locked garage or in well-lit areas.

If you see suspicious activity report it immediately to the Lomita Sheriff's Station at 310-539-1661. In case of emergency call 9-1-1.

Tips for Calling 9-1-1

Call 9-1-1 in an emergency, where Sheriff, Fire, or EMS presence is immediately required. Call the Lomita Sheriff Station at (310) 539-1661 for non-emergency

situations, such as reports of power outages or missing pets, general inquiries toward the Sheriff's office, noise complaints, reports of a crime that occurred in the past, or to report a suspicious person.



When calling 9-1-1, be prepared to answer the dispatcher's questions, such as:

- the location of the emergency, including the street address and room/apartment number, if applicable.
- the phone number you are calling from.
- the nature of the emergency.
- details about the emergency, such as a physical description of a person who may have committed a crime, a description of any fire that may be burning, or a description of injuries or symptoms experienced by a person having a medical emergency.

Avoid disconnecting a 9-1-1 call before the dispatcher has a chance to collect all of the necessary information. If you dial 9-1-1 by mistake, do not hang up – explain to the dispatcher what happened and disconnect only when instructed to do so.

Remember, the dispatcher's questions are important to get the right kind of help to you as quickly as possible. Be prepared to follow any instructions the dispatcher gives you.

FY 2021-22 Recognized Obligation Payment Schedule Submitted

On January 28, 2021, the Finance Department submitted the FY 2021-22 Recognized Obligation Payment Schedule (ROPS) to the Department of Finance for the Successor Agency, formerly the Redevelopment Agency (RDA). This is an annual process for the City to report operating details and submit a request for funds to pay for the Successor Agency's expenses. The majority of the funding request is to satisfy the repayment obligations such as the county bond and loans made by the City to the RDA. The funding is from the Los Angeles County property tax revenues allocated for Successor Agency's expenses.

4th Quarter Home Sale Value Trends Comparison

Detached single-family residential median sales price rose for the second quarter in a row with an increase of 4.39% for the City of Rancho Palos Verdes. During the 4th quarter, the average price of a detached single-family residential home fell to \$1.56 million; however, the median price increased to \$1.46 million from \$1.4 million during the previous quarter. Median home price is more indicative of actual value growth as it is not as strongly influenced by single large value home sales that are outliers.

Despite of fears at the start of 2020 that property values may fall as a result of the pandemic, home values in Rancho Palos Verdes have increased in 3 of the four quarters during 2020, and median home prices are up \$218,000 when compared to the 4th quarter of 2019.

- Public Works maintains approximately 1,100 catch basins throughout the City. They are cleaned of debris regularly before and during the rainy season- this work is currently ongoing.



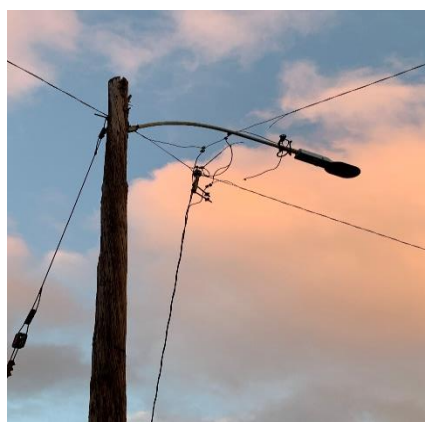
Graffiti Removal

Woof! Dogs Off-Leash Rules

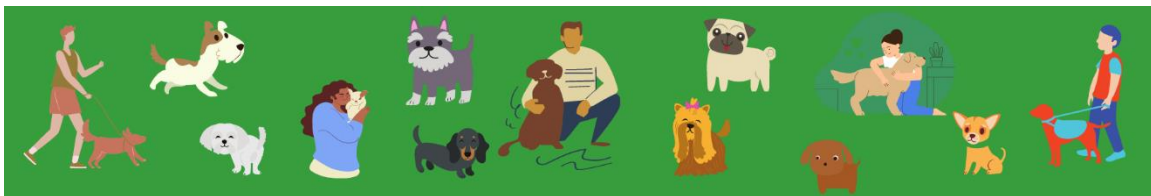
Pet adoptions and foster care has increased significantly during the COVID-19 pandemic. These furry friends have helped offer healthy companionship during these unprecedented times. Along with companionship comes care, including walking your dog or training a new exercise buddy. Here are some reminders while taking your pooch on a stroll on the trails, on a hike, or at a park:

- Animals are **not** allowed on any beach in the City of Rancho Palos Verdes. Violators will be cited.
- Dogs are allowed on the trails if they are **on a leash** no longer than 6 feet in length. Violators will be cited.



Another option to interact with your four-legged friend is to visit the City of Rancho Palos Verdes Dog Parks. Locations are:

- Rancho Caninos Dog Park (30940 Hawthorne Blvd)
- Eastview Dog Park (1700 Westmont Dr)



Follow all posted signs and park rules. Report any concerns directly to park staff or Park Rangers via Preserve Information and Reporting Hotline at **310-491-5775**. Before visiting, review the Dog Park Rules:

- Members of the public entering the dog park are using it at their own risk. The city is not responsible for injuries to people and dogs or illnesses dogs may contract from other dogs.
- Dog park hours are 1 hour before sunrise to 1 hour after sunset.
- Dog owners are limited to a maximum of 2 dogs inside the dog park area.
- Dog owners must clean up after their dog(s).
- All dogs must wear a current license and vaccination tags.
- Dogs are only allowed in the area that is designated for their size.
- Dogs must never be left unattended.
- Aggressive dogs and female dogs in heat are not allowed.
- Dogs must remain on leash at all times coming to and from the enclosed dog park area.
- Leashed dogs are not permitted within the dog park.
- Adults must accompany children under the age of 14.
- Owners must stop their dog(s) from digging. Any holes created must be filled by the owner of the dog(s).
- Unauthorized pieces of equipment, obstacles or apparatus are not allowed in the dog park.
- No food or glass containers are allowed in the dog park.
- The city reserves the right to eject anyone from the dog park at any time for failing to comply with these rules or any other applicable rules pertaining to the use of city parks.

Pets are just like us! When walking our four-legged friends, remember that they also need plenty of water to stay cool and hydrated. Pets, like us, can succumb to heat exhaustion. Please bring water and a bowl for pets while enjoying outdoor activities. Make sure your dog had something to eat before your hike or bring some snacks for them. Exercise common sense and make sure to rest in shady spots along the way. Also, don't forget your doggy bags! Please pick up after your pooch.

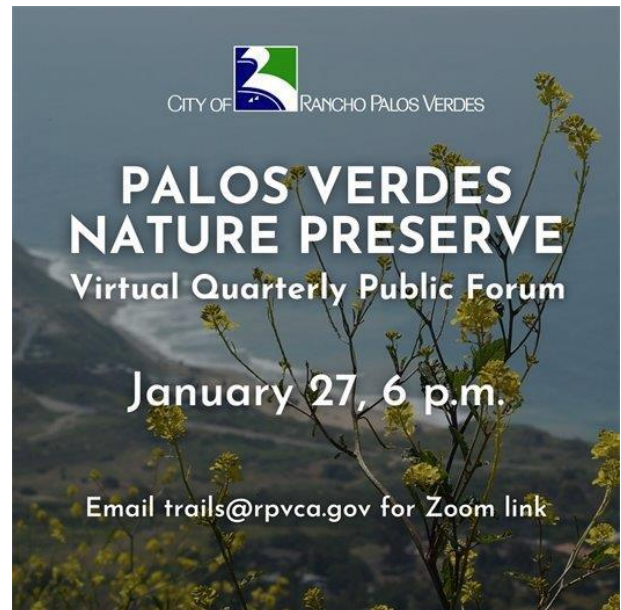

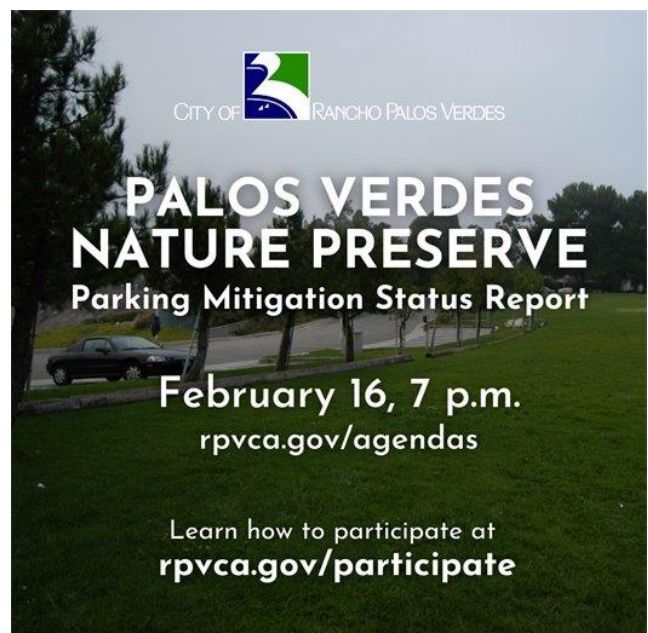

Preserve Parking and Access City Council Meeting February 16

Private Group Gatherings Permitted

In accordance with the L.A. County Health Officer Order, private outdoor gatherings outdoors of up to 3 households and a total of 15 people are permitted. All attendees must wear a face covering and maintain physical distancing from those not in their household. To lower the risk of exposure to COVID-19, remember to keep gatherings short (no more than two hours), practice good hand hygiene, use single-serve disposable containers, and refrain from activities that may increase the risk of COVID-19 transmission such as singing, chanting, shouting, or physical exertion.

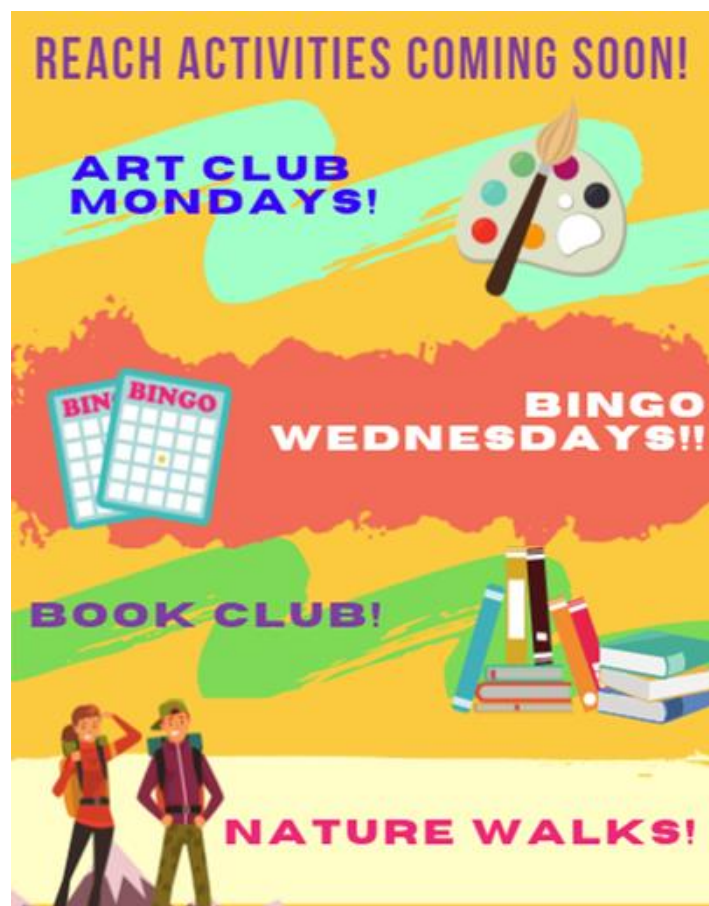

Preserve and Beach Weekend Activity:

Saturday, January 30, and Sunday, January 31, 2021



The Preserve was closed over the weekend due to rain and reopened on Sunday afternoon. OSM staff notified the public of trail closures via signage at key trailheads, the Preserve listserv group, the Trail Alerts webpage (www.rpvca.gov/1007/Trail-Conditions-Alerts), and through a message recorded on the Preserve Information and Reporting Hotline (310-491-5775). Staff also monitored access points and educated visitors about safety concerns and the trail and habitat damage caused by using wet trails.

Ocean Trails Reserve:

Rangers continue to receive reports of increased dog use at Rancho Palos Verdes Beach. Animals are not allowed on any beach in the City of Rancho Palos Verdes. Dogs are allowed on the trails if they are on a leash no longer than 6 feet in length. The City is working with Trump National Staff to improve compliance.

Portuguese Bend Reserve:

The Public Works Department's project to construct erosion control improvements on Burma Road Trail and Water Tank Trail was completed on January 21, 2021. The repairs included adding a drainage swale and drainage dips at numerous locations along Burma Road and Water Tank Trails. The project will improve trail sustainability and reduce trail erosion that regularly occurs after heavy rains. OSM staff monitors these dips after recent rains, making modifications, and adding temporary fencing to caution trail users of changes in slope as a result of the improvements.

"Residential Quiet Zone" signs along Burma Rd. have been repeatedly vandalized. City staff continues to monitor signs, remove graffiti, repair bent signs, and install new posts.

SoCal Edison conducted maintenance work on power lines located on Ishibashi Farm Trail on February 1st. No trail closures took place. A Listserv was sent out to the Palos Verdes Nature Preserve listserv group to notify the public of the activity.

OSM staff received concerns from a resident of the Portuguese Bend Community of hikers trespassing into the private community. Staff will work to improve wayfinding signs in the area to help the public differentiate public trails from private property. On February 3, staff met with a representative of the Rolling Hills Community Association to discuss improved signs at the Reserve's border with Rolling Hills.

SUBJECT: Establishing Vaccination PODs on the Palos Verdes Peninsula

Dear Supervisors, Dr. Ferrer, and Ms. Bagwell:

The cities of Palos Verdes Estates, Rancho Palos Verdes, Rolling Hills and Rolling Hills Estates thank you for your continued efforts to make the COVID-19 vaccine available to as many of our frontline health care workers and seniors as possible.

Seniors 65 and over make up one quarter of the population of the Palos Verdes Peninsula. Like many cities, in the past week, the four cities of the Peninsula have been inundated with phone calls from now vaccine-eligible residents eager to learn how they can get an appointment. Many have expressed frustration with the great distance between the Palos Verdes Peninsula and PODs in Los Angeles. The nearest county-run POD is 15 miles and two freeways away at the Forum in Inglewood. Wait times associated with mass distribution sites are also dissuading those otherwise ready to get vaccinated.

We appreciate the enormous logistical undertaking of distributing the vaccine to eligible residents across Los Angeles County, especially given the extremely limited supply of available vaccine.

We are eager to assist in any way possible to establish local PODs on the Peninsula to ensure our seniors have access to this desperately-needed vaccine. Similar to other cities in the county, the Peninsula cities have seen COVID-19 case rates skyrocket during the winter surge. Since the start of December 2020, new COVID-19 cases

reported in the Peninsula cities increased by 148%. Devastatingly, COVID-19 deaths reported in the Peninsula cities rose by 159%.

We have carefully reviewed the requirements necessary to accommodate a POD and have determined the following locations across the Peninsula to be suitable:

- Ernie Howlett Park, 25851 Hawthorne Blvd. in Rolling Hills Estates
- Fred Hesse Jr. Community Park, 29301 Hawthorne Blvd. in Rancho Palos Verdes
- Point Vicente Interpretive Center, 31501 Palos Verdes Dr. West in Rancho Palos Verdes
- Point Vicente Lighthouse, 31550 Palos Verdes Dr. West in Rancho Palos Verdes
- Rancho Palos Verdes City Hall, 30940 Hawthorne Blvd. in Rancho Palos Verdes

We request that the Department of Public Health please advise us of the next steps necessary to set up local PODS as quickly and efficiently as possible.

Thank you again for your efforts and we are eager to partner with you in this endeavor.



PRESERVE VISITOR CONTACTS SUMMARY

- October 1st 2020 – December 31st 2020
 - 4 Rangers* patrolled the Preserve during this period
- *Approximately 130 hours per week.

This reporting period continued to be atypical as operations continued to be strongly influenced by public health mandates from the State and L.A. County regarding the COVID-19 Pandemic and increased use of the Preserve, including more new visitors less familiar with outdoor and hiking safety and trail etiquette.

Welcome Park Ranger Acero!



In October 2020, The Recreation and Parks Department welcomed our 4th Park Ranger, Rosario Acero, to the Open Space Management (OSM) team. Ranger Acero has enforcement and public safety background from her employment with the Torrance Police Department and the City of Commerce lifeguard program. She also has a passion for public service and natural resource management, and we are excited about the talents she brings to the City's Open Space Management team!

Operations under COVID-19 LA County Health Department Regulations

Due to COVID-19 restrictions, group size in the Preserve was limited to no more than 10. Rangers educated patrons about social distancing, facial coverings, and other restrictions as mandated by the L.A. County Department of Public Health. During routine patrols, Rangers saw approximately 70% compliance with mask and social distancing mandates. Reports for compliance from the public were significantly lower than those observed by Rangers.

Trainings and Coordination:

The Open Space Management Division participates in the L.A. County-wide Trails Task Force, which is a group of open space managers throughout L.A. County that coordinate management best practices, including implementation and enforcement of Pandemic-related County Health Orders. Staff attended the October meeting at which the Task Force discussed topics including visitation levels, additional trail re-openings, and public communication and messaging enhancements.

The Open Space Management Division collaborates with the Los Angeles Marine Protected Areas Collaborative Team as well as the Department of Fish and Wildlife Game Wardens to educate visitors about Abalone Cove and Point Vicente State Marine Conservation Area. Staff collects data daily and submits this data on a weekly basis to our partners. Training has been postponed due to COVID-19.

Rattlesnake Safety Workshop: Staff received rattlesnake safety training from Dr. Emily Taylor of Central Coast Snake Services in October. Staff learned about snake identification, mating behaviors, and received hands-on training to be able to safely relocate rattlesnakes. The City will be offering additional information on rattlesnake safety for the public online and exploring options for community trainings in early 2021.

Water Rescue and Cave Training: On October 27th, Rancho Palos Verdes Park Rangers and L.A. County Fire Department firefighters and lifeguards met for training at Abalone Cove. The training included rock entries/exits, and personnel swam inside the sea caves simulating actual gorge rescues. Multi-agency efforts were made so that land-based resources and water-based resources can better coordinate their efforts while reducing risk for personnel.



In case of an emergency, the public should call 911 and know their specific location to share with dispatchers.

Project Coordination

OSM staff help coordinate multiple projects within the Preserve to ensure Natural Communities Conservation Plan/Habitat Conservation Plan (NCCP/HCP) compliance with PVPLC, to implement trail closures and public safety measures, and to provide public notification. On Sunday, November 15, a patron reported finding human remains on Abalone Cove Beach. Los Angeles County Sheriff's Deputies were called and after close examination, confirmed they were not human, but were marine mammal.

A patron called the Los Angeles County Sheriff's Department regarding a possible suicidal person on Portuguese Point Loop Trail. Deputies responded and escorted the individual out.

On weekends, holidays, and during low-tide events, staff continued to observe high traffic in the City's two State Marine Conservation Areas, primarily, at Abalone Cove SMCA. Staff continued to educate patrons about Marine Protected Areas (MPA), and shared proper tide pool etiquette for safely viewing but not disturbing marine organisms. During this reporting period, a total of 62 violations were observed, and 111 individuals were contacted and educated by staff, resulting in the return of 92 marine organisms, and an additional 21 violations prevented by providing information and alternative locations where individuals can legally take outside of the MPA zone with a fishing license.

Collection of animals in containers (as seen on the right) even with the intent to return is not allowed in the MPA zones. Containers, including buckets, tubs, and plastic bottles of water are frequently used to collect water and wildlife to observe closely. They are confiscated by staff, and all animals are returned safely to their respective habitats.



Additionally, staff continues to collaborate, and communicate with local agencies, including California Department of Fish and Wildlife, Los Angeles Waterkeeper, and Los Angeles Marine Protected Areas Collaborative Team.

Rangers received multiple past reports of an aggressive dog on the trails. One reporting party indicated their dog was bit and wounded. The party was advised to notify Animal Control and consult with their local veterinarian to report and assess the dogs' injuries. Rangers continue to monitor the area and have been unable to locate the dog or owner.

Rangers received several reports of a potential homeless man in the area verbally threatening hikers in the Alta Vicente Reserve trails. Rangers were unable to locate the man, or any evidence of an illegal encampment. Rangers continue to monitor the area.

Staff has also observed increased use at Alta Vicente Reserve and Upper Point Vicente Park/Civic Center. Violations of dogs off-leash and off-trail use are being observed and addressed. Rangers have additionally received reports of increased dog waste on trails.

Rangers have received calls of increased dog use at Rancho Palos Verdes Beach. Animals are not allowed on any beach in the City of Rancho Palos Verdes. Animal fecal matter and urine can cause health risks for humans and affect water quality. Dogs are allowed on the trails, as long as they are on a leash no longer than 6 feet in length. The City is working with Trump National Staff to ensure adequate signage is in place to educate and enforce the City's Municipal Code.



Staff continued to receive reports of individuals in closed areas. Some of these individuals are hiking off trail, and some are individuals illegally paragliding, including launching from and land on City property. When possible, staff educated and informed individuals of habitat loss, compaction, and damage to sensitive species, including the island green dudleya that are found in the area. The City reinforced signage, barricades, and increased patrols to inform, and deter off-trail use.

Staff approached a patron with an off-leash cat in the Reserve. The man was hiking with his cat and indicated that the cat was startled due to high traffic on Burma Road trail, causing the cat to hide behind nearby brush.

On Thursday, October 8th, Cal Water alerted residents in the Portuguese Bend Community about a main break. Vanderlip trail remained closed throughout the weekend. Rangers closed off Vanderlip, Kubota, and a section of Gary's Gulch Trail while crews worked to bring in dirt, and repair damages. Rangers received several reports of patrons accessing these trails during the closure increasing safety concerns for the public.

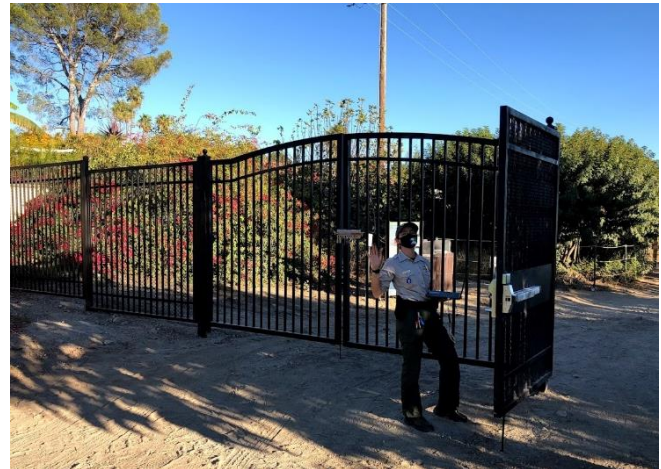


On Monday, November 9th, construction began for the installation of the new entry gate at the Burma Rd. trailhead. The trails remained open, however, OSM staff were present to provide information to the public and recommend alternatives to access the Portuguese Bend Reserve during construction. The gate is programmed to lock at sunset, and unlock at 7:00 a.m. every day. When trail closures are in effect, the gate will remain locked. Rangers have increased patrols during the night to ensure the gate is in working condition and patrons are informed of the Preserve hours.

“Residential Quiet Zone” signs located at the top of Burma Road trail were vandalized and spray painted with gray colored paint, bent, or removed from their post on several occasions. OSM repaired and replaced signs on a weekly basis, with over 8 counts of vandalism on each sign (24 total). No information is known about the individual(s).

Staff has reported at least 2 counts of the City of Rancho Palos Verdes locks cut on both the bottom and top of Wanderer Trail. Rangers continue to monitor activity in the Reserve, including unauthorized vehicle access, and replace locks as needed.

On November 25, Rangers made contact with a male who was harvesting cacti fruit from the native Prickly Pear cacti growing along Palos Verdes Drive East within Reserve boundaries. The individuals returned the fruit to Rangers.

The illegal structure reported to Rangers during in September was dismantled. The structure included several repurposed logs, pipes, and plywood held together by nails, and rope. With the support of OSM, staff was able to haul out all material from the area.

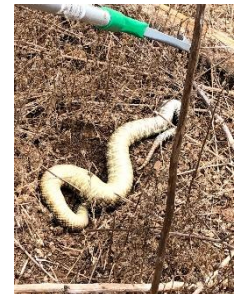

Residents reported hearing and seeing increased coyote activity at dusk along the lower trails. One such incident included a sighting of a coyote pack within 20 feet of a hiker. Coyotes do reside in the Palos Verdes Nature Preserve. Any coyote sightings should be reported to the City's Code Enforcement Division online from your mobile device or desktop.

Additionally, Rangers received a report of a deceased snake adjacent to Three Sisters Trail. It was unclear how the snake had died, but the reporting party indicated it may have died from blunt force trauma inflicted by a group of hikers that they had encountered on the trail. The rattlesnake was found with its head buried 4 inches into the ground and had no other injuries.

The Bluff Top Fence Replacement Project began in August 2020, and continued through the fourth quarter. The project included temporary closure of trails, and one-way

trails when paths were not wide enough to allow for two-way traffic. As a result of this project, temporary chain link fence was placed, and several concrete shortages stalled the work of the project. Staff saw a decreased in the amount of unauthorized trail use. Upon completion of the fence, staff installed “Do Not Climb Over the Fence” signs to educate and remind visitors of safety hazards/environmental sensitivity on the cliff edge. Staff also stenciled numbers to mark the locations of posts along the Seascapes and Golden Cove trail. These numbers can be used to report maintenance issues and or emergencies with greater precision for location.



On November 7, 2020, staff reported damage to the City’s monument sign located at Terrace Trailhead. It is unknown when or what caused the damage.
