

Members of the public who attend City Council meetings in person must follow physical distancing guidelines and wear a face covering of the nose and mouth at all times during the course of the meeting unless and until invited to speak. The City Council will limit

DDT Dumping Update

On March 30, Staff received correspondence from Dr. Deborah Jordan, Acting Regional Administrator of the U.S. EPA Region 9, in response to the City's letter calling for an assessment of the extent of DDT dumping off the coast of the Palos Verdes Peninsula (see attachments).

Dr. Jordan stated that the EPA will convene a meeting with federal and state agencies later in the spring that will include discussion informed by the recent seafloor mapping mission by the Scripps Institution of Oceanography and NOAA to identify the locations of the barrels. Regarding the Palos Verdes Shelf Superfund site just off the coast of Rancho Palos Verdes, Dr. Jordan noted that the EPA is finalizing a contract to update the human health and ecological risk assessments for the site and will then evaluate the available cleanup technologies and select a final remedy for cleaning up contamination. Dr. Jordan also offered to meet with Mayor Alegria and Staff to provide an update on the status and success of the remediation effort. Staff is following up to arrange the meeting and will continue to monitor this issue.



Emergency Preparedness Committee Recruitment

Want to get more involved in local government? The City is accepting applications to fill two vacancies on the **Emergency Preparedness Committee**. These are volunteer, non-paying positions with terms of office ending in June 2024.

The seven-member Emergency Preparedness Committee is charged with making recommendations to the City Council to help ensure that the City of Rancho Palos Verdes develops and maintains a high state of readiness to respond to emergencies and disasters. Committee members advise the City Council on ways to develop and improve programs to communicate with and educate residents about the importance of emergency preparedness. Committee members are called upon to participate in community outreach events to encourage residents to become prepared and to participate in local volunteer disaster response organizations. Committee members are also encouraged to become trained and registered as Disaster Service Workers, and/or receive other disaster-related training and certifications.

The committee meets on a monthly basis, typically the third Thursday of the month, at 7 p.m. in the Community Room at City Hall. However, due to current COVID-19 restrictions, the committee has been meeting virtually using the Zoom platform.

L.A. County Qualifies for Orange Tier Threshold, Additional Reopenings with Safety Measures Set for April 5

L.A. County has met the threshold for the less restrictive orange tier in the state's Blueprint for a Safer Economy.

A revised Health Officer Order will go into effect on Monday, April 5 at 12:01 a.m. to reflect newly permitted activities. This allows the county to follow the state guidelines and wait until three weeks are completed in the red tier to be sure that case numbers do not rise this third week since the county's earlier reopenings. The Health Officer Order and modified directives for businesses will be posted on April 2, with an effective date of April 5. Assuming county case numbers do not increase, the following changes will be made to the Health Officer Order:

- **Bars that do not provide meals** will be allowed to open outdoors with distancing, masking and infection control safety measures. Indoor operations are not permitted. Masks are required except when people are eating or drinking. There can be no counter seating and people can eat or drink only when they are seated. Tables must be 8 feet apart, with a maximum of 6 people from up to 3 different households. There can be no live entertainment, television is permitted, and hours of operations are from 11:30 a.m. until 10:00 p.m.
- **Breweries, Wineries, Distilleries that do not serve meals** can remain open outdoors and can also open indoors at 25% capacity or 100 people, whichever is fewer. These establishments will follow the same public health directives as bars for their outdoor areas, however, there are additional requirements for indoor spaces: reservations are required for indoor seating, there is a maximum of 6 people per table and they must be from the same household, and there is no live entertainment or television viewing indoors.
- **Restaurants** can increase capacity for indoor dining to 50% capacity or 200 people, whichever is less with continued safety modifications.
- **Cardrooms** can operate indoors at 25% capacity. There must be 8-feet of distancing between tables and masks are always required. Food and beverages remain banned from card tables.
- **Places of Worship** can hold services indoors at 50% capacity.
- **Fitness Centers** can operate indoors at 25% capacity and indoor pools can now re-open. Masks are always required unless swimming.
- **Movie Theatres** can increase capacity to 50% or 200 people, whichever is less. Seats must be reserved, and each group must have 6 feet of distance from other

groups in all directions. Eating is allowed in only designated areas or in your reserved seat.

- **Family Entertainment Centers** can open indoors at 25% capacity for distanced activities, such as bowling or escape rooms. Masks remain required.
- **Grocery and Retail Stores** can increase capacity to 75%, although Public Health strongly recommends grocery stores remain at 50% capacity until April 15 to allow as many grocery store workers as possible get vaccinated.
- **Hair Salons, Barbershops and Personal Care Services** can increase capacity to 75% with masks required, except for services where customers need to remove their masks. For services where customers must remove their face coverings, staff must wear a fitted N95 or a mask with a face shield.
- **Museums, Zoos and Aquariums** can be open indoors at 50% capacity.
- **Youth and Adult Recreational Sports** can apply to Public Health for approval for athletic events, tournaments or competitions that involve more than two teams or multiple individuals.

COVID-19 Vaccine Eligibility to Expand

With the supply of vaccines expected to significantly increase in the coming weeks, the state is expanding vaccine eligibility to more Californians. Starting April 1, individuals aged 50+ will be eligible to make an appointment, and individuals 16+ will be eligible to make an appointment to be vaccinated starting on April 15.

Even with expanded vaccine supplies, it is expected to take several months for willing Californians to be vaccinated. Based on public information shared by vaccine manufacturers and the federal government, California expects to receive several million vaccine doses per week starting sometime in April.

COVID-19 Cases

As of March 30, there are 1,218,958 confirmed cases of COVID-19 across Los Angeles County (population 10.17 million). The total includes 1,451 cases in Rancho Palos Verdes (population 42,747), 426 in Palos Verdes Estates (population 13,522), 269 in Rolling Hills Estates (population 8,113), 54 in Rolling Hills (population 1,940), and 63 in the

unincorporated areas of the Peninsula (population 1,921). Countywide, 23,110 people have died.

According to the L.A. County Department of Public Health, 54 deaths have been reported in Rancho Palos Verdes. The City extends its deepest condolences to the families of these residents.



LASD Parking Enforcement Resumes April 1, 2021

Beginning on April 1, 2021, the Sheriff's Department will resume enforcement of all parking violations and reinstate the issuance of expired registration citations and resume towing vehicles that have been warned to be in violation of the parking laws.

The Sheriff's Department had been directed to limit parking citations due to the COVID-19 pandemic and parking citation cases were assessed on a case-by-case basis. Starting April 1, all parking violations will be enforced. For additional information, visit [LASD's Nixle Advisory Message](#).

Security Camera Grant Program Extended

With continued efforts to enhance public safety, the City is extending the grant program to allow HOAs and neighborhoods to purchase Flock Safety license-plate reading cameras for the purpose of monitoring neighborhood entrances.

Catalytic Converter Theft Prevention Event

The Lomita Sheriff's Station is hosting a catalytic converter etching event to help prevent theft on Saturday, April 24 from 9am-1pm at Lomita City Hall at no charge.

Catalytic converters are stolen for their previous metals. In Los Angeles County alone, the Sheriff's Department reported a 400% increase in catalytic converter thefts from 2019 to 2020.

At etching events, vehicle identification numbers (VIN) are engraved into the metal. This may help recover a stolen catalytic converter.

Safe Drug Drop Off Locations

The public is urged to safely drop off unused prescription drugs at Public Disposal Locations. To locate local pharmacies participating in this program, visit the DEA's Public Disposal Locations [Search Utility](#). Before disposing of any medications, be sure to remove or scratch out all personal information on labels or packaging.

Residents can safely and anonymously drop off expired or unused prescriptions and over-the-counter medications. Saving unused or expired medications can lead to improper and illegal use if they fall into the wrong hands. A safer solution is to bring your old medications to designated drug drop off boxes.

If you are unable to go to a drop-off site, you can take the following steps to dispose of medications at home.

1. Check if your medication is on the FDA's [flush list](#). If it is, remove the medicine from all packaging and flush it down the sink or toilet.
2. If your medication is not on the flush list, mix the medication with an undesirable substance like dirt or cat litter in a sealable plastic bag and throw it away in your household trash.
3. Remove all personal information from labels or packaging and discard all outer packaging.


Join Your Neighborhood Watch

The Rancho Palos Verdes Neighborhood Watch program is a community-based, resident-run organization that exists to make neighborhoods safer through crime reduction and improving the quality of life for individuals living in the same area. The RPV Neighborhood Watch runs separately from the City government and uses its network to address issues related to crime, public safety, and quality of life.

Make Safety a Habit

Every night at 9:00PM, the community is encouraged to lock up property, turn on lights, and bring in valuables to reduce the likelihood of falling victim to property crimes.



Lock all doors and windows, including garage doors, turn on lights or set them on a timer if you plan to be away, and avoid leaving valuables in visible areas. These actions help deter burglars and may help prevent residential burglaries.

Emergency Preparedness

Postponement of Prenotice Public Discussions on Mitigation in Rating Plans and Wildfire Risk Models

The California Department of Insurance has [postponed pre-notice public discussions](#) regarding contemplated additions to the California Code of Regulations dealing with mitigation in rating plans and wildfire risk models, previously scheduled for March 30, 2021. The new date for the pre-notice public discussions will be announced in the near future.

The proposed regulation seeks to prohibit an insurer from using a rating plan or wildfire risk model that does not consider community and property level mitigation efforts undertaken when establishing insurance rates.

The proposed regulation that will be open to public comment touches upon all of the following:

- Incentivizing individual and community mitigation efforts by requiring consideration of property- and community-level mitigation against wildfire risk;
- Reducing the risk of loss posed by wildfires;
- Improving accuracy in the classification of wildfire risk and the resulting rates and premiums;
- Increasing transparency in, and consumer awareness of, insurers' rating and/or scoring of wildfire risk;
- Enhancing consumer protection by establishing a consumer appeals process; and
- Reducing unfair discrimination by enhancing consistency in insurers' wildfire rating practices and/or risk scoring practices; and,
- Potentially improving availability and affordability of property-casualty insurance for communities and properties where wildfire mitigation measures have been implemented.

Upcoming Southern California Edison Local/Tribal Government Resiliency Workshop

On April 6, Southern California Edison will host a resiliency workshop to assist local and tribal governments to make informed decisions on resiliency planning efforts as well as provide feedback on implemented preparedness measures. Community Choice Aggregation (CCA) providers and community organizations that represent and support vulnerable and disadvantaged communities have also been invited to participate.

During this workshop, representatives from Southern California Edison will share information on a variety of subjects, including the notification process for Public Safety Power Shutoffs(PSPS), weather forecasting, microgrids, electric grid operations, grid infrastructure plans, and reliability. City staff will participate in this virtual workshop to gain a better understanding of how the City can further collaborate with Southern California Edison to improve emergency planning and resiliency efforts for the City.

Extreme Heat Safety Tips

Extreme heat is a period of high heat and humidity with temperatures above 90 degrees for at least two to three days. In extreme heat, your body works extra hard to maintain

a normal temperature, which can lead to death. In fact, extreme heat is responsible for the highest number of annual deaths among all weather-related hazards.

When experiencing hot temperatures, it's important to remember to: Stay cool, Stay hydrated and Stay informed.

STAY COOL:

- **Wear Appropriate Clothing:** Choose lightweight, light-colored, loose-fitting clothing.
- **Stay Cool Indoors:** Stay in an air-conditioned place as much as possible. If your home does not have air conditioning, go to a shopping mall or public library—even a few hours spent in air conditioning can help your body stay cooler when you go back into the heat.
- **Schedule Outdoor Activities Carefully:** Try to limit your outdoor activity to when it's coolest, like morning and evening hours. Rest often in shady areas so that your body has a chance to recover.
- **Pace Yourself:** Cut down on exercise during the heat. If you're not accustomed to working or exercising in a hot environment, start slowly and pick up the pace gradually. If exertion in the heat makes your heart pound and leaves you gasping for breath, STOP all activity. Get into a cool area or into the shade, and rest, especially if you become lightheaded, confused, weak, or faint.
- **Do Not Leave Children in Cars:** Cars can quickly heat up to dangerous temperatures, even with a window cracked open. While anyone left in a parked car is at risk, children are especially at risk of getting a heat stroke or dying. When traveling with children, remember to do the following:
 - Never leave infants, children or pets in a parked car, even if the windows are cracked open.
 - To remind yourself that a child is in the car, keep a stuffed animal in the car seat. When the child is buckled in, place the stuffed animal in the front with the driver.
 - When leaving your car, check to be sure everyone is out of the car. Do not overlook any children who have fallen asleep in the car.

STAY HYDRATED:

- **Drink Plenty of Fluids:** Drink more fluids, regardless of how active you are. Don't wait until you're thirsty to drink.
- **Stay away from very sugary or alcoholic drinks**—these actually cause you to lose more body fluid. Also avoid very cold drinks, because they can cause stomach cramps.

- **Replace Salt and Minerals:** Heavy sweating removes salt and minerals from the body that need to be replaced. A sports drink can replace the salt and minerals you lose in sweat.
- **Keep Your Pets Hydrated:** Provide plenty of fresh water for your pets, and leave the water in a shady area.

STAY INFORMED:

- **Check for Updates:** Check your local news for extreme heat alerts and safety tips and to learn about any cooling shelters in your area.
- **Know the Signs:** Learn the signs and symptoms of heat-related illnesses and how to treat them.
 - **HEAT CRAMPS**
 - **Signs:** Muscle pains or spasms in the stomach, arms or legs
 - **Actions:** Go to a cooler location. Remove excess clothing. Take sips of cool sports drinks with salt and sugar. Get medical help if cramps last more than an hour.
 - **HEAT EXHAUSTION**
 - **Signs:** Heavy sweating, paleness, muscle cramps, tiredness, weakness, dizziness, headache, fainting, nausea, vomiting, Fainting.
 - **Actions:** stop physical activity, move to an air-conditioned place, and lie down. Loosen or remove clothing. Take a cool bath. Take sips of cool sports drinks with salt and sugar. Get medical help if symptoms get worse or last more than an hour.
 - **HEAT STROKE**
 - **Signs:** Extremely high body temperature (above 103 degrees) taken orally, Red, hot and dry skin with no sweat, Rapid, strong pulse, dizziness, confusion or unconsciousness
 - **Actions:** Call 9-1-1 or get the person to a hospital immediately. Cool down with whatever methods are available until medical help arrives.
- **Monitor Those at High Risk:** Although anyone at any time can suffer from heat-related illness, some people are at greater risk than others:
 - Infants and young children
 - People 65 years of age or older
 - People who are overweight

- People who overexert during work or exercise
- People who are physically ill, especially with heart disease or high blood pressure, or who take certain medications, such as for depression, insomnia, or poor circulation.

February 2021 Financial Reports

The City's February 2021 Revenue and Expenditure Financial Reports are now available to view and/or download on the City's website <http://www.rpvca.gov/1066/Monthly-Financial-Reports>. A snapshot of the General Fund categories is provided below.



February's financials are also available via the new interactive Monthly Finance Report. Staff worked to create a report that would be both interactive and easy to use while providing important insight into the City's finances. OpenGov, an existing service currently in use by the City, was used to create this interactive report. You can view our new February financial report at <https://stories.opengov.com/rpv/published/7YtXzF8pq>.

General Fund Revenues

At the end of February, the City received a total of **\$16,785,000 or 57.5%** (including transfers) of the FY 2020-21 Revenue Budget of \$29.2 million. As summarized in Table 1, compared to the prior year, General Fund Revenues are **\$1.3 million or 7.2% less** than FY 2019-20 revenue for the same period.

General Fund Revenue Updates

As mentioned previously, the year-to-date revenues through February are just over \$1.3 million less than was received at this same point last year. The largest contributing factor to this variance continues to be the reduction in Transient Occupancy Tax (TOT) revenue which is a result of the reduced demand for travel due to the pandemic. The City has received just over \$1.5 million in TOT revenue, \$1.86 million less than at this same point last fiscal year.

Business License Tax (BLT) revenue has also been impacted by the effects of the pandemic. Businesses with \$1.5 million or more in gross receipts pay an additional \$1 for every \$1,000 in gross receipts in excess of \$50,000. As larger businesses such as Terranea Resort experience a decrease in revenue, the BLT rate they pay also decreases. Through January the City has received \$569,000 in revenue compared to \$827,000 last fiscal year.

Sales Tax is down roughly \$447,000 due in part to reduced demand for retail and leisure travel and the timing of revenue received. TOT and Sales Tax were the revenue sources that were projected to be impacted the most by the economic slowdown. Roughly \$906,000 or 40.5% of budgeted Sales Tax revenue has been received so far during FY 2020-21. As a reminder, sales Tax revenue typically lags by at least two months.

Parking lot fee revenue continues to outperform budget. Revenue has reached \$290,000 or 210% of budgeted revenue. Charges for Services remain higher than usual for this time of year with \$411,000 or 110% of budget revenue. This level of revenue is due to the recording of revenue received from Los Angeles County in July rather than in June, as was done in the previous fiscal year. This money is for the repayment of loans made by the City to the Redevelopment Agency (RDA) for the Portuguese Bend and Abalone Cove Landslide areas. The payment is received each fiscal year.

Golf Tax revenue continues to outpace expectations due to continued high demand. The City has already received \$316,000 or 105% of the projected revenue, \$58,000 more than received at the same period in FY 2019-20.

General Fund Expenditure Updates

At the end of February, the City's expenditures, including encumbrances, totaled **\$20,590,000 or 69.6%** of the FY 2020-21 Expenditure Revised Budget of \$29.6 million.

Additionally, the Department encumbers any commitment for a specific expenditure with a specific vendor during the first quarter of the year.

Compared to the same period last year, the General Fund Expenditures, including encumbrances, have decreased by \$2.2 million or 9.8%. The results are aligned with the City's reduced budget and current activities. The majority of the decreased activities are a combination of savings from salaries and benefits from deferred/unfilled positions, park closures, a reduction in transfers out of the General Fund, and reimbursements from the Coronavirus Relief Fund Grant.

Undergrounding Along Palos Verdes Drive South

A preconstruction meeting for this project to underground, overhead utilities along Palos Verdes Drive South (from La Rotonda Drive to the eastern City limit) was hosted by Southern California Edison's (SCE) contractor last week. Work is expected to begin next Monday, April 5 and conclude in May. This project is being managed by SCE and paid for with ratepayer funds collected through tariffs regulated by the California Public Utilities Commission's Tariff Rule 20. Traffic delays should be expected when traveling through this area so proceed with caution. This project will have an overall and long-lasting positive impact on our community especially along the coastal view corridor of the City.



Traffic Signal at Hawthorne Boulevard and Via Rivera

This week, construction continues as the contractor will bore under Hawthorne Boulevard to connect the new signal to the City's existing communications cable. Additionally, the City is coordinating with the Gas Company to relocate a previously unknown section of a gas line to allow for the proper installation of one of the signal poles. That relocation work is expected to be completed this week, and foundation installation for the new signal poles and other equipment is scheduled to begin next week.



Rattlesnake Trailhead Gate Update

The City continues discussions with the Island View Homeowners Association to obtain an easement that will allow construction to continue the Rattlesnake Trailhead fence and gate.





The City Attorney is continuing discussions with the Island View HOA to secure the easement so that construction can proceed. Updates will continue to be provided.

ParkMobile Parking App Project Update

Attorneys and staff from the City and ParkMobile attorneys met this week to address final contract details for the app-based online parking system to be installed in the Del Cerro area. City Council approved this program on January 19, 2021, to help alleviate parking issues. The target date for going live has been moved from March to the end of May. Staff understands the importance of this project for Del Cerro residents and is focused on finalizing the contract and beginning the installation process to meet the end of May target date.

Private Group Gatherings Permitted





The City is part of the Los Angeles Marine Protected Areas Collaborative Network and has received support from them including pamphlets, stickers, educational training (limited due to COVID-19) and signage. Tracking our observations goes a long way to obtaining resources and identifying areas we can improve upon.

Staff inspected trails and conducted water control measures along Portuguese Point Loop Trail and Olmstead Trail to divert some of the water flow and reduce the emergence of ruts and muddy conditions. Frequent inspections followed by minor and routine trail work help keep our trails in good shape!

On Wednesday, March 24, OSM staff, LA County Fire Department, and LA County Lifeguards met for training at Abalone Cove. Staff was able to swim inside the sea caves simulating actual gorge rescues and water conditions. Additionally, staff learned how to use rescue lines from land to pull swimmers to safety.



In case of an emergency, call 9-1-1. Knowing your location is key to ensuring the timely arrival of first responders. Always monitor water conditions, and abide by all posted signage.

Portuguese Bend Reserve:

Staff has seen an increased use of motorized e-bikes on trails that can reach a maximum speed of 31 MPH. These bikes are considered motor vehicles and are prohibited in the Nature Preserve and will be cited by the rangers.

Thank you for your letter dated March 10, 2021 concerning the deep-water ocean disposal of DDT and progress at the Palos Verdes Shelf portion of the Montrose Chemical Corporation Superfund Site. I understand this issue is of high interest to your community, and I share your concern about the potential impacts to human health and the environment presented by legacy contamination. The U.S. Environmental Protection Agency (EPA) continues to prioritize protecting the public from the most imminent threats from DDT contamination on the Palos Verdes Shelf, and we would be happy to provide an update on the status and success of this remediation effort to you and your staff at a time of your convenience. As a separate matter from Palos Verdes Shelf, we are also planning a federal and state level multi-agency meeting to discuss deep-water ocean disposal sites.

The EPA Superfund Program's work to clean up the undersea Palos Verdes Shelf portion of the Montrose Chemical Corporation Site and to protect the community from seafood potentially contaminated by DDT is ongoing. EPA is finalizing a contract to update the human health and ecological risk assessments for the Palos Verdes Shelf, which became contaminated through chemical runoff into the Pacific via sewers. Drawing upon the assessments, EPA will then evaluate the available cleanup technologies and select a final remedy for cleaning up the contamination. Throughout the cleanup process, we will continue to engage in education and outreach to protect public health in partnership with community-based organizations, and local, state, and federal agencies. This effort includes multilingual public signage and fish market inspection programs along with proactive educational work to address risks presented by DDT contamination of seafood.

Regarding the historic deep-ocean disposal sites, this situation constitutes a complex and large-scale challenge. In addition to the disposal site off Catalina recently explored by the University of California at Santa Barbara, there are thirteen other documented ocean disposal sites involving DDT and other chemicals. The National Oceanic and Atmospheric Administration and the Department of the Interior, as federal natural resource trustees, have important roles to play in characterizing and understanding the effects on the marine environment from this disposal. The EPA will convene a meeting with these federal partners and state agencies later in the spring. This multi-agency discussion will be informed by the results of a NOAA-sponsored Scripps Institution of Oceanography survey to map a portion of the area where the disposal occurred.

We understand the long history of impacts on your community stemming from contamination of the offshore marine environment. The EPA takes seriously our commitment to science and transparency, and to providing clear communication regarding next steps. Again, we are happy to schedule a meeting at your convenience to discuss the Palos Verdes Shelf issue in further detail.
