

Have You Noticed an Increase in Your Water Bill?

In response to inquiries from residents, a representative from Cal Water will give a presentation at the April 20 City Council meeting regarding the utility's recent rate increase due to the Palos Verdes Peninsula Water Reliability Project.

On April 22 at 7 p.m., the Palos Verdes Peninsula Land Conservancy will partner with the Palos Verdes Library District, Friends of the Library, and the California Native Plant Society for a live Zoom event in celebration of Earth Day. Letter in Support of Palos Verdes Shelf Superfund Site Special Study

Last week, Staff sent a letter to the Los Angeles Regional Water Quality Control Board in support of a proposed special study to monitor the status and trends of DDT and PCB contamination levels in the sediment, water column, and fish tissue in the Palos Verdes Shelf Superfund Site (see attachments). The letter was transmitted in advance of the Water Board’s May 13, 2021 public hearing where the Special Study resolution will be considered. If approved by the Board, the study will be conducted in late 2021. Staff will continue to monitor this issue.

Letter in Support of PVPUSD’s Tobacco Grant Program Proposal

This week, Staff sent a letter in support of the Palos Verdes Unified School District’s (PVPUSD) Tobacco Grant Program proposal to enhance enforcement of the illegal sale and marketing of tobacco products to minors and youth through the employment of School Resource Officers (SROs) (see attachments). SROs are full-time law enforcement officers with sworn law enforcement authority trained in school-based policing and

crisis response. The SROs have worked with the administration teams to educate students about the dangers of tobacco use and vaping and other risky behaviors through conversations with students and parents while on campus. They have and will continue to work towards campuses that are free of tobacco, alcohol, and drugs.

COVID-19 Cases

As of April 13, there are 1,226,596 confirmed cases of COVID-19 across Los Angeles County (population 10.17 million). The total includes 1,479 cases in Rancho Palos Verdes (population 42,747), 450 in Palos Verdes Estates (population 13,522), 274 in Rolling Hills Estates (population 8,113), 54 in Rolling Hills (population 1,940), and 64 in the unincorporated areas of the Peninsula (population 1,921). Countywide, 23,498 people have died.

According to the L.A. County Department of Public Health, 53 deaths have been reported in Rancho Palos Verdes. The City extends its deepest condolences to the families of these residents.

Vaccine Eligibility to Expand to Ages 16+

Starting tomorrow, April 15, all persons who live or work in L.A. County and are 16 years and older will be eligible for a COVID-19 vaccine. For those 16 and 17, it will be important to be aware that you can only be vaccinated at this time with the Pfizer vaccine. Therefore, if given the option while registering on VaccinateLACounty.com, please be sure to select the Pfizer when it's your turn to be vaccinated.

As we move into a new tier that no longer requires you to identify your eligibility based on your occupation, it is important that you still provide documentation that you live or work within L.A. County and provide some sort of photo ID that doesn't necessarily have to be government-issued. Insurance and Immigration status is not required, and the vaccine is free. You will not have to pay anything out-of-pocket for the vaccine, and none of your information is shared with immigration officials.

L.A. County Pauses Use of Johnson & Johnson Vaccine Following FDA and CDC Recommendation

Out of an abundance of caution, L.A. County is following the recommendation of the Food and Drug Administration (FDA) and the Centers for Disease Control and Prevention (CDC) to pause the use of Johnson & Johnson vaccine after reports that six women between the ages of 18 and 48 developed unusual types of blood clots 6 to 13 days after receiving the vaccine. This pause will last until the FDA and CDC complete their review, which is expected to take several days.

Vaccine providers in L.A. County will contact patients about rescheduling or providing a new appointment for the Pfizer or Moderna vaccine.

These reactions are extremely rare, as nearly 7,000,000 people have received the Johnson & Johnson vaccine in the United States to date. People who received the vaccine in the last three weeks should look for any symptoms of these unusual clots, including severe headaches, abdominal or leg pain, and shortness of breath, and contact

their medical provider if symptoms develop. People who don't have a medical provider can call 2-1-1 to connect with a healthcare provider. For more information, read a list of [frequently asked questions](#).

The L.A. County Department of Public Health is grateful to the researchers and scientists working to ensure that all medications or vaccines, including the COVID-19 vaccines, have the highest safety standards.

L.A. County to Update Health Officer Order with Guidance for Indoor Live Events, Performances, and Private Events

On April 12, the L.A. County Department of Public Health announced several changes to the Health Officer Order that will take effect tomorrow, April 15. These changes align with the state changes to the Blueprint for a Safer Economy regarding indoor live events and performances, private events such as conferences, receptions and meetings, and private informal gatherings.

Starting April 15, **indoor live events and performances** will be permitted in L.A. County with the following safety measures:

- Indoor live events and performances are able to open for in-state visitors only, who must pre-purchase tickets.
- Eating or drinking is not permitted anywhere except pre-designated eating areas.
- Masks must be worn at all times except when in designated eating areas.
- There must be 6-feet of distance between different households unless people are fully vaccinated.
- As with outdoor live events, employers must offer a weekly worker testing program.

For venues that hold up to 1,500 people, there is a maximum capacity limit of 15% or 200 people, whichever is fewer. However, the capacity limit can increase to 35% if all guests are tested or vaccinated. For venues holding more than 1,500 people, there is a capacity limit of 10% or 2,000 people, whichever is fewer, although the capacity limit can increase to 25% if all guests are tested or vaccinated.

Private meetings such as **conferences, receptions and meetings** will be permitted starting on April 15 with the following safety measures:

- There must be a defined guest list or tickets must be purchased.

- Masks must be worn at all times unless attendees are eating or drinking.
- There must be 6-feet of distance between tables and chairs for guests not vaccinated.
- There must be assigned seating or a seating chart with a max of 6 people per table for guests not vaccinated.
- And there can be no intermingling of multiple private events.

For **outdoor private events**, a maximum of 100 people is allowed, but that limit can increase to 300 people if all guests are tested or vaccinated. Tables are also limited to 6 people from a maximum of 3 households unless everyone at the table is vaccinated. Indoor private events are only allowed if all guests are tested or vaccinated with a limit of 150 guests.

Public Health is also modifying the protocols for **private social or informal gatherings**. Outdoor gatherings can have up to a maximum of 50 people. Masks will be required at all times unless people are eating or drinking. There must be 6-feet of distance between tables and chairs. Seating at tables is restricted to 6 people from up to three households. If everyone is vaccinated, the capacity limit at tables are not necessary.

Indoor private gatherings are permitted, but strongly discouraged. If you choose to hold an indoor private gathering, the following are required safety modifications:

- A max of 25 people or a 25% capacity limit where capacity limits exist.
- Masks must be worn at all times, unless everyone is full vaccinated.
- And there can be no eating or drinking unless everyone attending is fully vaccinated or everyone attending is fully vaccinated except for members of 1 household that does not have any high-risk individuals.

West Basin Hosts Firescaping Workshop for the Palos Verdes Peninsula

West Basin Municipal Water District is hosting a free online firescaping workshop on Wednesday, April 21, 2021, at 6:00 P.M. to teach residents how to use landscaping techniques to help safeguard their properties from the threat of wildfires. The West Basin workshop will focus on its Division I service area, which includes the cities of Palos Verdes Estates, Rancho Palos Verdes, Rolling Hills and Rolling Hills Estates. However, all interested service area residents are welcome to participate given that California has dry, windy, and often hot weather conditions spanning from spring through fall.

Douglas Kent, MS, MLA, will present at the Districts April 21st workshop. Kent is a subject-matter expert and for nearly three decades, has helped to create fire-protected communities. He will provide useful tips and insights tailored for Peninsula residents and business owners. Information will include landscaping techniques, native plant selection, and smart irrigation systems to help the community protect structures, use less water, and ultimately save money on their water bills.

Wildfire Insurance Coordination Meeting with the California Department of Insurance.

On Wednesday, April 7, City Staff and Members of the Emergency Preparedness Committee's (EPC) Subcommittee on wildfire insurance met with representatives from the California Department of Insurance (CDI) to discuss available resources for residents experiencing premium hikes and reduced homeowner insurance availability.

At this meeting, City Staff and Committee Members shared the City's concern regarding insurance providers refusing to renew home insurance policies and increasing premiums as a result of the City's status as a Very High Fire Hazard Severity Zone. Representatives from the Department of Insurance were receptive to the City's concerns and pledged to continue collaborating with City Staff to provide residents with resources and services available through the California Department of Insurance. Furthermore, representatives from the Department of Insurance offered the opportunity for the Insurance Commissioner Ricardo Lara to host a virtual townhall meeting to discuss Homeowners insurance rate reductions and loss of coverage for residents at a future date.



Run. Hide. Fight. - Surviving an Active Shooter Event

Active shooter incidents are often unpredictable and evolve quickly. Active shooters typically use firearms and have no pattern to their selection of victims. In the midst of the chaos, anyone can play an integral role in mitigating the impacts of an active shooter incident.

The following describes what to do in an active shooter event. Remember, during an active shooting event to RUN. HIDE. FIGHT.

BE INFORMED:

- If you see something, say something to authorities right away.
- Be aware of your environment and any possible dangers.
- Make a plan with your family and make sure everyone knows what to do if confronted with an active shooter.
- Wherever you go, look for the two nearest exits, have an escape path in mind, and identify places you could hide if necessary.
- Know what information to provide to 911 operators during an active shooter event. (Location and number of shooters, physical description of shooters, type of weapons the shooter has, and number and location of potential victims).

SURVIVE DURING:

RUN and escape if possible.

- Getting away from the shooter(s) is the top priority.
- Leave your belongings behind and getaway.
- Help others escape, if possible, but evacuate regardless of whether others agree to follow.
- Warn and prevent individuals from entering an area where the active shooter may be.
- Call 9-1-1 when you are safe and describe the shooter, location, and weapons.

HIDE if escape is not possible.

- Get out of the shooter's view and stay very quiet.
- Silence all electronic devices and make sure they won't vibrate.
- Lock and block doors, close blinds, and turn off lights.
- Don't hide in groups. Spread out along walls or hide separately to make it more difficult for the shooter.
- Try to communicate with the police silently. Use text message or social media to tag your location or put a sign in a window.
- Stay in place until law enforcement gives you the all-clear.
- Your hiding place should be out of the shooter's view and provide protection if shots are fired in your direction.

FIGHT as an absolute last resort.

- Commit to your actions and act as aggressively as possible against the shooter.
- Recruit others to ambush the shooter with makeshift weapons like chairs, fire extinguishers, scissors, books, etc.
- Be prepared to cause severe or lethal injury to the shooter.
- Throw items and improvise weapons to distract and disarm the shooter.

BE SAFE AFTER:

When Law Enforcement Arrives:

- remain calm and follow instructions.
- Make sure to keep hands visible and empty.
- Know that law enforcement's first task is to end the incident and they may have to pass injured along the way.
- Officers may be armed with rifles, shotguns or handguns and may use pepper spray or tear gas to control the situation.
- Officers will shout commands and may push individuals to the ground for their safety.

- Follow law enforcement instructions and evacuate in the direction they come from unless otherwise instructed.

Take care of yourself first, and then you may be able to help the wounded before first responders arrive.

- If the injured are in immediate danger, help get them to safety. While you wait for first responders to arrive, provide first aid. Apply direct pressure to wounded areas and use tourniquets if you have been trained to do so.
- Turn wounded people onto their sides if they are unconscious and keep them warm.
- Consider seeking professional help for you and your family to cope with the long-term effects of the trauma.

National Drug Take Back Day is April 24

With opioid overdose deaths increasing during the pandemic, the Drug Enforcement Administration (DEA) announced its 20th Take Back Day is scheduled for April 24th. Over the 10-year span of Take Back Day, DEA has brought in more than 6,800 tons of prescription drugs. With studies indicating a majority of abused prescription drugs come from family and friends, including from home medicine cabinets, clearing out unused medicine is essential.



The public can drop off potentially dangerous prescription medications at collection sites which will adhere to local COVID-19 guidelines and regulations in order to maintain the safety of all participants and local law enforcement.

DEA and its partners will collect tablets, capsules, patches, and other solid forms of prescription drugs. Liquids (including intravenous solutions), syringes and other sharps, and illegal drugs will not be accepted. DEA will continue to accept vaping devices and cartridges at its drop-off locations provided lithium batteries are removed.

Residents can drop off unwanted prescription medications on Saturday, April 24, 2021 from 10:00 a.m. to 2:00 p.m. For additional information on National Drug Take Back Day and to locate collection sites, visit DEATakeBack.com.

Tips to Recognize and Avoid a Scam

The number and types of scams are numerous and constantly changing. Always investigate fully before giving your money to a stranger or even someone claiming to be a family relative.

Scammers may pretend to be from an organization you know, like the IRS or Medicare. They may be able to change the phone number that appears on your caller ID so it looks real, or they may use a real-looking logo or branding in an email.

Always verify you are speaking to a legitimate organization.

- Legitimate organizations won't call, email or text to ask for your personal information like your Social Security, bank account, or credit card numbers.
- Even if you get an email or a text message you think is real, avoid clicking on any links. Instead, contact them using a website you know is trustworthy.
- Do not call a number they give you in a voicemail or the number from your caller ID.

Scammers say there is a problem or a prize. They may say you're in trouble with a government agency or you owe money or that someone in your family had an emergency and they need you to verify some information. They may say you have won money in a lottery or sweepstakes, but you have to pay a fee to get it. They will likely

pressure you to act immediately. They may threaten to arrest you, sue you, take away your driver's license, or say your computer is about to be corrupted.

Resist the pressure to act immediately.

- Legitimate businesses will give you time to make a decision.
- Anyone who pressures you to pay or give them your personal information is a scammer.
- Ask for a supervisor's name and call back number, chances are a scammer won't want to provide you with that information. If they can't give you a local number or address, hang up.

Scammers tell you to pay in a specific way. They may insist that you pay by sending money through a money transfer company or by putting money on a gift card and then giving them the number on the back.

Never pay someone who insists you pay with a gift card or by using a money transfer service. Never deposit a check and send money back to someone.

Stop and talk to someone you trust.

- Before you do anything else, tell someone – a friend, a family member, a neighbor – what happened. Talking about it could help you realize it's a scam.

Portuguese Bend Landslide Grant Application

Public Works Staff, in partnership with the City's grant consultant (Blaise and Associates), submitted a Letter of Intent to apply for a National Fish and Wildlife Foundation – National Coastal Resilience Fund grant to fund final design and construction document preparation for the Portuguese Bend Landslide Mitigation project. Based on the grant agency's feedback on the Letter of Intent, the matching fund requirement, and grant conditions; Staff may ask the City Council to approve a full grant application. The purpose of the Portuguese Bend Landslide Remediation project is to slow movement in the landslide complex and reduce potential impacts to the natural and built environment.



Palos Verdes Drive East Guardrail Replacement Project

On July 21, 2020, City Council authorized Staff to apply for a federal Highway Safety Improvement Program (HSIP) grant to fund guard rail repairs and/or replacement on Palos Verdes Drive East. Staff recently learned that the project was approved for HSIP funding in the amount of \$990,900 (with no requirement for City matching funds). Staff have started working on the funding agreement documents and will soon add this project to the City's Capital Improvement Program.

Undergrounding Along Palos Verdes Drive South

Southern California Edison's (SCE) contractor continues to work to underground existing overhead utilities along Palos Verdes Drive South (from La Rotonda Drive to the eastern City limit). Traffic delays should be expected when traveling in this area so proceed with caution, and work is expected to conclude in May.



Fuel Modification



Starting this week, the goats are coming back to Rancho Palos Verdes as part of the City's Fuel Modification plan for 2021. Unfortunately, out of an abundance of caution and Covid-19 protocols, the City's "Meet the Goats" event has been canceled for a second year, although we expect it to return in 2022. Although we understand the popularity of the goats and the

excitement seeing them generates, especially for children, we ask that you do not attempt to see them or get close to where they are working. The fencing that is put up to contain them to designated areas is electrified, and we want to avoid anyone getting shocked. For this reason, we will not advertise or promote the dates when they are scheduled for designated areas to the general public. We appreciate your understanding and ask for your cooperation and respect for the safety of all, including the goats.

Laborer crews are also used for designated areas as part of the City's Fuel Modification plan, and they will also be working in designated areas in the coming weeks. Although far less of an attraction than the goats, we ask that you avoid approaching crews as they work as well.

Fuel Modification is the act of removing or reducing vegetation to create or maintain "defensible space" around homes and structures. Defined by Los Angeles County as 200 feet around structures within Very High Fire Hazard Severity Zones, which covers over 90% of property within the City of Rancho Palos Verdes, "defensible space" allows the fire

department to place firefighters between your home and approaching flames if there is a fire that might threaten your home. For resources to help you with fuel modification on your property, please visit <http://www.rpvca.gov/1321/Wildfire-Preparedness>

Fuel Modification season typically starts April 1st each year based on the typical start of significant weed growth. The City's plan is to have fuel modification work completed for more than 200 acres of defensible space on city properties and public right-of-way areas, most of which is in the Palos Verdes Nature Preserve, by the end of June. Due to the amount of work required, we ask for patience from residents adjacent to these areas as we try to get to everyone as soon as is feasible.

This work is coordinated with the Palos Verdes Peninsula Land Conservancy (PVPLC), as Fuel Modification season coincides with birds nesting season. This means that the City hires PVPLC to perform bird surveys in areas before fuel modification work is performed to identify and mark any areas where active bird nests exist so that such sub-areas are avoided until such nests are no longer active (i.e. baby birds have left the nest). These areas are then addressed after bird nesting season has ended, which is in August.

The City's contractor is expected to begin pouring concrete this week for the foundations for the new traffic signal poles and equipment. After a seven-day period for the concrete to cure, residents should expect to see a crane on-site to install new traffic signal poles next week.




Recycling Events are a GO!





Landscape Plans Approved for 580 Silver Spur Road

On April 12, the City's Landscape Architect approved landscape plans for the remodel and renovation of the commercial property located at 580 Silver Spur Road. The approval includes a compliance review to ensure the project's compliance with the City's Water Efficient Landscape Ordinance or WELO. The project involves new planting materials and irrigation improvements throughout the site. Staff previously issued an approval for the remodel of the building façade and ancillary site features associated with the commercial renovation.



Coastal Sage Scrub Protection Code Amendment Update

On May 4, the City Council will consider adopting an ordinance amending Subsection 17.70.025 (Natural Communities Conservation Plan/ Habitat Conservation Plan) of Chapter 17.70 (Site Plan Review) of Title 17 (Zoning) of the Rancho Palos Verde Municipal Code in order to update provisions for the protection of Coastal Sage Scrub as required by Sections 6.3.1 and 6.3.2 of the City Council-adopted Natural Communities Conservation Plan/Habitat Conservation Plan (NCCP/HCP). On March 9, the Planning Commission recommended that the City Council

adopt the ordinance ([Planning Commission Staff Report](#)). A public notice (Attached) announcing the proposed code amendment and City Council meeting details will be issued on April 15th. Drainage Swale Maintenance Reminder

Drainage swales tend to become filled with leaves, overgrown vegetation, and debris over the course of the year. As a reminder, property owners are responsible for maintaining swales located on their property to ensure that the swales function properly. Improperly maintained swales interfere with proper drainage flows resulting in property damage caused by slope failure, erosion, or excess storm-water runoff.

As an additional reminder, the City's Municipal Code does not permit the construction of any structure within or above a drainage swale or on a slope on or equal to 35% or greater. This includes decks, stairs, or structures of any kind.



Living with Coyotes



Coyotes are found throughout California, from desert and mountain habitats to urban areas, including the Peninsula. Problems occur when people begin feeding coyotes, either deliberately or inadvertently. Coyotes will quickly lose their natural fear of people and become bold, even aggressive. It is important that residents are aware of what they can also do to keep coyotes in the wild and away from our neighborhoods.

Safeguard your family and property through hazing and removing attractants:

HAZING:

- Basic hazing consists of standing your ground, never ignoring, or turning your back to a coyote(s), yelling, and making unpleasant and frightening noises until they choose to leave.
- Sometimes, coyotes do not respond to basic hazing and aggressive hazing is needed. This consists of approaching an animal quickly and aggressively throwing projectiles like rocks or tennis balls toward the animal, spraying with a hose, water gun containing water, or white vinegar.
- Create fear of contact so the animal leaves the situation; use a whistle, horn, bell, bang pots/pans, stomp your feet.
- KEEP hazing until the coyote is out of site.
- NEVER RUN AWAY FROM A COYOTE

REMOVE ATTRACTANTS:

- Chaperone your pets when they are outside. Do not leave them outside overnight.
- Keep pets on a leash when outdoors.
- Do not feed coyotes or any other wildlife.
- Keep pet food inside.
- Provide secure enclosures for rabbits, chickens, etc.
- Keep garbage in tightly closed containers that cannot be tipped over.
- Remove sources of water, especially in dry climates.
- Put away bird feeders at night to avoid attracting rodents and other coyote prey.
- Pick up fallen fruit and cover compost piles.
- Learn proper, effective hazing techniques.

Code Enforcement Staff continues to work with Los Angeles County Dept. of Agricultural Commissioner/Weights & Measures (ACWM) regarding residents' concerns with coyote sightings in their neighborhood. Additionally, staff continues to work collectively with ACWM to canvass the neighborhood for coyote attractants and potential warranty trapping in designated areas. 

- Estimated number of animals prevented from being poached: none.
- Individuals deterred from poaching: three (3) fishermen.

Staff found an unauthorized encampment within a closed area in the Reserve. The encampment was uninhabited upon discovery, and staff will be attempting to make contact with the individual(s) to remove their belongings.

Alta Vicente Reserve

In response to increased occurrences of dogs off-leash and the habitat, Rangers have increased patrols in the Reserve to monitor activity, educate patrons, and deter activity. Additional signs have been installed by staff to remind visitors that dogs must be on a leash at all times.

March – August is the breeding and nesting season for the endangered California gnatcatcher and the threatened Cactus Wren. Cactus Wren's specifically build their nests in cactus (especially cholla) as well as prickly pear, which is abundant at Alta Trails Reserve. Off-trail use and encroachment into native habitat can disturb these sensitive and threatened species.

Vicente Bluffs Reserve

On Friday, April 9, a Los Angeles County Fire Department cliffside rescue took place. The individual had climbed over the fence and onto the cliff when they lost their footing and fell 20 feet over the edge. The individual fell on a ledge where they could remain safely while Fire personnel attempted to make contact. A helicopter unit was instrumental in the safe retrieval of the individual.

On Monday, April 12, Rangers were notified of an abandoned panga boat that had landed at the bottom of Tovemoore Trail in the Pelican Cove area at an unknown time. Rangers assisted alongside personnel from the Los Angeles County Fire Department, the Department of Homeland Security, and agencies in clean-up efforts. Multiple life vest jackets were discarded along the shore, trail, and parking lot area.

The public is encouraged to report suspicious activity to the Port of Long Beach. *See Something, Say Something* signs, provided by the Port of Long Beach, are posted along several coastal locations in RPV.





Portuguese Bend Landslide Monitoring Survey Activity



The City Attorney continues discussions with the Island View HOA to secure the easements and an agreement so that construction can proceed. Updates will continue to be provided.


ParkMobile Parking App Project Update

A revised ParkMobile contract for reservation-based, online parking services in the Del Cerro area is on the April 20 City Council agenda. The revised contract includes changes to indemnification policies, intellectual property clauses, the number of sensors, and other changes that have been discussed recently by City and ParkMobile attorneys. Following approval, ParkMobile estimates that the system will be fully installed and operational by the end of June. While there have been some delays in proceeding with this project, once installed the system should alleviate long-standing parking and traffic pattern concerns.



Preserve Public Forum

The Preserve Public Forum is scheduled quarterly to provide an opportunity for the public to learn about past, current, and upcoming projects related to the management of the Nature Preserve. City representatives from the Recreation and Parks Department, Public Works Department, and Palos Verdes Peninsula Land Conservancy staff attend to report information and help answer any questions and concerns from the public. This meeting is an invaluable tool for the City and Palos Verdes Land Conservancy to gain public feedback and involvement in Preserve operations. The next meeting will be held virtually on Wednesday, April 14 at 6pm.

The City of Rancho Palos Verdes supports the proposed special study for Palos Verdes Shelf Superfund Site Remediation: Second Monitored Natural Recovery (MNR) Sampling.

The City is concerned about the extent of environmental damage caused by offshore DDT dumping by the Montrose Chemical Corporation. This issue is of high importance to our community. A recent survey of Rancho Palos Verdes residents found that the impacts of chemical dumping in our coastal waters was the second most concerning local environmental issue among respondents, after ocean and beach pollution.

While the City is pleased that the proposed efforts will provide information on the status and trends of DDT and PCB contamination levels in the sediment, water column, and fish tissue, this is only the first step in addressing the untold harm done to our ecosystem by this long-hidden hazard.

Thank you for your continued efforts to study the effect of contaminants on the Palos Verdes Shelf. Engaging in the proposed special study will help guide interim, and ultimately final actions to mitigate the superfund site and ensure the Palos Verdes Shelf is safe for all. For these reasons, the City of Rancho Palos Verdes supports the Special Study for the Palos Verdes Shelf Superfund Site.
