Green Hills Memorial Day Fireworks May 30

Please be advised that on Sunday, May 30, around 8:30 p.m., as part of its Memorial Day Observance, Green Hills Memorial Park will put on a 15-minute fireworks show to commemorate its display of The Moving Wall, a half-size traveling replica of the Vietnam Veterans Memorial. **This event is invite-only.** Please view the fireworks from your home or watch a livestream of the evening's activities starting at 7 p.m. at greenhillsmemorial.com. The City also reminds residents to take extra precautions to keep their pets safe during the fireworks show and as Fourth of July approaches:

- Make sure your pet has a collar and tags with your personal information. Include a phone number where you can be reached.
- Get your pet microchipped, and please verify the information for that microchip is correct.
- Keep your pets indoors in a cool, comfortable place with some "white noise" distraction.
- Your pets may want to hide; allow them access to a room away from windows.
- If your dog is outside, make sure all gates are closed and locked and fencing is secure. Your dog may try to escape if it becomes startled.

Loud Exhaust Strictly Enforced

The City of Rancho Palos Verdes contracts with the Los Angeles County Sheriff's Department and is served by the Lomita Sheriff's Station. The Sheriff's Department strictly enforces loud vehicle exhaust. Additional deputies will be deployed this summer, starting Memorial Day Weekend, looking for vehicles with loud or modified exhausts that are not in compliance with California Vehicle Code (CVC) regulations.



How Loud is Too Loud? CVC 27151 states that a vehicle weighing 6,000 pounds or less, or anything smaller than a light truck or van, shall have a sound level of 95 decibels or less, which is the same as an average gas-powered lawn mower.

The State of California requires that vehicles have an adequately working muffler, which means you cannot remove or make adjustments to your muffler that intentionally increase the noise of the vehicle.

Reporting Violators: While the Sheriff's Department will be conducting additional patrols, you can help too! If you notice a pattern with certain locations at certain times of the day or week with loud exhaust violators, report it to the Sheriff's Station at 310-539-1661.

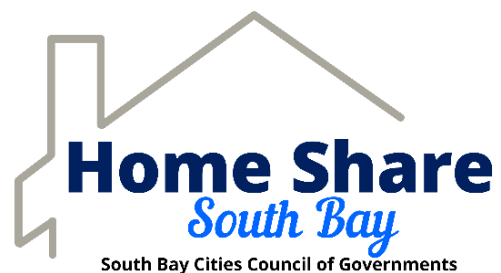
Congratulations to our 2021 Graduates!

SB 210 Not Moving Forward in Legislative Process

The City Council opposed SB 210, which would have required that data collected by an ALPR system be deleted after 24 hours unless it is on a hot list. The Peninsula cities sent a joint letter of opposition on May 5, 2021. The bill failed to pass out of the Senate Appropriations Committee and will not be moving forward in the legislative process.

Letter Regarding SB 946 (Sidewalk Vendors)

Following direction provided by the City Council, last week, the City sent a letter to Senate President Pro Tem Atkins, Speaker Rendon, Senator Allen, and Assemblymember Muratsuchi, requesting the Legislature review its consideration of how bills such as SB 946 (Chapter 459, Statutes of 2018), related to sidewalk vendors, may elicit undesirable and unintended consequences for cities (see attachments). SB 946 sought to decriminalize sidewalk vending and in doing so, placed the burden on cities to regulate for every health and safety concern, rather than allowing broader prohibitions on sidewalk vending.

Cal Water Notice of Availability of Cost of Capital Application

The California Public Utilities Commission (CPUC) requires that utility companies prepare a rate case for CPUC approval every three years. Cal Water submitted a notice of availability of cost of capital application for authority to establish general increases in rates for the period January 1, 2022-December 31, 2024 (see attachments).

At its June 1 meeting, the City Council will consider participating as a formal party in this proceeding in order for the City to advocate for residents during the CPUC process, to ensure that residents are being provided with reliable, cost-effective service.

COVID-19 Cases

As of May 25, there are 1,239,093 confirmed cases of COVID-19 across Los Angeles County (population 10.17 million). The total includes 1,527 cases in Rancho Palos Verdes (population 42,747), 471 in Palos Verdes Estates (population 13,522), 286 in Rolling Hills Estates (population 8,113), 57 in Rolling Hills (population 1,940), and 65 in the unincorporated areas of the Peninsula (population 1,921). Countywide, 24,184 people have died.

According to the L.A. County Department of Public Health, 56 deaths have been reported in Rancho Palos Verdes. The City extends its deepest condolences to the families of these residents.

Emergency Preparedness

Peppertree Trail Regional Wildfire Brush Drill - TODAY

On May 26, 2021, Battalion 14 of the Los Angeles County Fire Department, which services the Palos Verdes Peninsula, conducted the first in a series of regional wildfire brush drills located in the vicinity of the lower portion of the Portuguese Bend Reserve.

During today's exercise, personnel from the Los Angeles County Fire Department, in coordination with the City of Torrance's and Redondo Beach's Fire Departments, simulated a wildfire scenario beginning at the Peppertree Trailhead located in the Reserve.



City staff and Park Rangers participated in today's drill to learn best practices in communicating between LA County Fire and the City in the event of an emergency. The drill aims to work with other local fire departments and the City to discuss and apply wildland fire response tactics, such as communications, familiarization of different equipment used on an incident, etc.

The drill will continue to take place on May 27 and 28 in the vicinity of the lower Portuguese Bend Reserve between 9:00am and 1:00pm each day. No live fire will be used. There may also be periodic landings and take-offs from the helipad at Point Vicente Park/Civic Center in the City of Rancho Palos Verdes.

Cal OES – FEMA's Hazard Mitigation Grant Program (HMGP) – Best Practices for a Successful Wildfire Subapplication

FEMA's Hazard Mitigation Grant Program (HMGP) provides funding to state, local, tribal and territorial governments so they can reduce or mitigate future disaster losses in their communities. HMGP funding becomes available after an area experiences a qualifying disaster to mitigate against such a disaster recurring in the same area. In California, these funds are managed by the California Office of Emergency Services (Cal OES) Hazard Mitigation Grant Program HMGP Unit.



On May 7, 2021, the City submitted two Notice of Interests (NOI) to the Hazard Mitigation Grant Program towards the securing of funds for the undergrounding of overhead powerlines located in the Portuguese Bend Nature Reserve to reduce the risk of a downed powerline igniting a wildfire, as well as for the City's continued use of grazing goats to consume hazardous vegetation, thereby reducing the amount of fuel available for burning in a wildfire. A Submission of a Notice of Interest is required prior to submitting a sub-application for the Hazard Mitigation Grant Program (HMGP).

On Monday, May 24, Cal OES notified the City that the proposed powerlines undergrounding project to reduce the risk of a wildfire is an **eligible** HMGP activity and has formally invited the City to submit a full sub-application for consideration of funding. Additionally, Cal OES has recently reviewed and determined that the proposed Goat Vegetation Management Project is an eligible HMGP activity. Staff is currently compiling data for the DR-4558 applications, which are due on June 18, 2021.

As a result of California's record-breaking 2020 wildfire season, Cal OES received an increase in funding available under the Federally declared disaster "DR-4558". The HMGP DR-4558 (DR-4558) is a competitive grant that resulted from FEMA's Disaster Declaration in response to the devastating wildfires that began on August 14, 2020, in California.



Wildfire Preparedness

With an uptick in recent brush fires across the Los Angeles County region, Peninsula residents are reminded to be on heightened alert and to be prepared for wildfire.

- If you see something, say something. Report any sign of smoke or fire immediately to your local fire department by dialing 9-1-1. If you dial 9-1-1 from your cellphone, be sure to know your location.
- Have your Ready! Set! Go! Wildfire Action Plan in place. It is critical for residents to be familiar with the Ready! Set! Go! program that provides important pre-planning and evacuation information.
- Download the Ready! Set! Go! Wildfire Action Plan and view informational how- to videos, visit fire.lacounty.gov/rsg

Power Outage Safety

A communities' comfort and security rests upon the electrical power grid providing power to essential everyday services. A power outage is when the electrical power goes out unexpectedly. Planned or unexpected, an extended power outage has the ability to impact the whole community and the economy. Power outages that last for days or longer can impact needs such as lighting, heating, cooling, communication, food and medicine refrigeration, cooking, and medical equipment.

The following are steps you can take to minimize impacts from a power outage and keep all household members as comfortable as possible.

Staying Safe: BEFORE a Power Outage:



BE PREPARED FOR A POWER OUTAGE

Extended power outages may impact the whole community and the economy.

A power outage is when the electrical power goes out unexpectedly.

- May disrupt communications, water, transportation
- May close retail businesses, grocery stores, gas stations, ATMs, banks, and other services
- Can cause food spoilage, water contamination
- Can prevent use of medical devices

PROTECT YOURSELF DURING A POWER OUTAGE

- Keep freezers and refrigerators closed.
- Only use generators outdoors and away from windows.
- Do not use a gas stove to heat your home.
- Disconnect appliances and electronics to avoid damage from electrical surges.
- Use alternate plans for refrigerating medicines or power-dependent medical devices.
- If safe, go to an alternate location for heat or cooling.
- Check on neighbors.

- **Identify** which items you may need that rely on electrical power. Then, **plan for extra batteries and other ways** to meet your needs when the power goes out.
- **Talk to your medical provider** about a power outage plan for medical devices powered by electricity and refrigerated medications. Find out how long medications can be stored at higher temperatures and get specific guidance for any medications that are critical for life.
- **Check your local weather forecast** regularly by visiting the [National Weather Service](#).
- **Determine whether your home telephone will work** in a power outage and how long battery backup will last.
- Take stock of your disaster supplies that are available in case of a power outage. **Have flashlights with extra batteries** for every household member. Have enough nonperishable food and water, as well as medications.
- Use a **thermometer in the refrigerator and freezer** so that you can know the temperature when the power is restored. Throw out food if the temperature is 40 degrees or higher.
- Keep **mobile phones**, recharging devices and other equipment fully charged.

Staying Safe: DURING a Power Outage:

- **Monitor alerts.** Check local weather reports and any notifications by phone, television, or radio. Utility officials may come to your door to alert you of a planned power outage.
- **Keep food cold, and when in doubt, throw it out.** Eat your fresh, perishable foods first. Avoid opening your refrigerator and freezer to preserve cool temperatures.
 - An unopened refrigerator will keep foods cold for about 4 hours.
 - A full freezer will keep the temperature for about 48 hours (24 hours if it is half full) if the door remains closed.
 - Measure the food temperature in your refrigerator and freezer with a thermometer. Throw out food that has been warmer than 40 degrees F.
- **Prevent power overloads and fire hazards.** Turn off or disconnect appliances, equipment, or electronics. Power may return with momentary surges or spikes that can cause damage.
- **Use flashlights, not candles.** Turn off utilities only if you suspect damage or if local officials instruct you to do so.
- **Prevent carbon monoxide poisoning.** Do not use a gas stove to heat your home and do not use outdoor stoves indoors for heating or cooking. If using a generator, keep it outside in a well-ventilated area away from windows.

Staying Safe: AFTER a Power Outage:

- **When in doubt, throw it out!** Throw away any food that has been exposed to temperatures 40 degrees or higher for two hours or more, or that has an unusual odor, color or texture. If the power is out for more than a day, discard any medication that should be refrigerated, unless the drug's label says otherwise. Consult your doctor or pharmacist immediately for a new supply.
- **Keep away from power lines.** Stay at least 35 feet away from fallen power lines and anything they are touching. Call 911 and let them know.
- **Restock your emergency kit** so the supplies will be there when needed again.

- Agree on a rendezvous point with members of your party in the event you get separated.

On June 1, the City Council will conduct the FY 2020-21 Budget Hearing , where the preliminary budget will be presented, which has been created based on City Council direction for General Fund, Capital Projects Fund, and all Special Revenue Funds. In addition to the Budget Hearing, staff will be presenting the following items:



- Review of FY 2020-21 Budget Adjustments
- Five-Year Capital Improvement Program
- FY 2021-22 Improvement Authorities
- Update on the American Rescue Plan Act (ARPA)

Statewide Sales Tax Trends

The Finance Department works with several outside consultants and analysts to monitor trends related to the City's revenue sources. HdL provides a quarterly look at sales tax trends by sector. Below you will find insights and projections for two sectors.

Restaurants and Hotels

FY20-21: Projected -13.2% decrease

FY21-22: Projected 23.9% growth

The long road to recovery continues with a small setback from the December/January shelter-in-place order. The recovery in this sector is complicated; it is geographically uneven, with variations across restaurant types. There have been shifts to digital and alternative formats that accommodate social distancing and rising labor costs. These

challenges result in restaurants increasing menu prices. The industry anxiously awaits the boom from pent-up demand and anticipates summer 2021 to deliver multitudes of diners. Hotels are expected to gain more overnight stays; recovery in this sector depends upon vacation destination upticks. Expect a slow recovery to progress over several years. Another glimmer of hope is provided as sporting events, and amusement parks begin to reopen in April.

Food and Drugs

FY20-21: Projected 4.4% growth

FY21-22: Projected 2.5% growth

Overlapping issues with other groups listed herein affected cash registers as taxable receipts at grocery, convenience, and liquor stores climbed throughout 2020. The continued expansion of cannabis also provided fuel to this segment. The outlook for grocery stores is bright and focuses on broadening merchandise, retaining customer loyalty, and deepening online efficiency deployment – approaches aim to keep up with a steady expansion of more companies battling in a highly competitive marketplace. As cannabis outlets multiply, saturation levels may impact expected returns. Overall, growth is moderate as pent-up demand to eat out while spending stimulus checks and savings accounts is redirected to other household preferences.

Landslide Road Repairs

Work on Palos Verdes Drive South, through the landslide, began on Tuesday, May 18, and concluded on May 24. This project was to repair the roadway surface between Peppertree Drive and Narcissa Drive. The surface of the road was lowered in some areas and raised in other areas to help smooth the vertical transitions throughout the landslide. The roadway was limited to one lane in each direction, and traffic control personnel were in place as part of the work zone setup. Additional work will take place in June, with more information to follow as the schedule is finalized.



Grant Application Letters of Interest

Public Works received a response to the letter of interest submitted to the National Fish and Wildlife Foundation (NFWF) proposing to apply for a grant for the Portuguese Bend Landslide Remediation project. Unfortunately, NFWF declined to support the project and supported other projects and more closely matched their grant criteria.

Public Works received a response to the letter of interest submitted to the Ocean Protection Council's Coastal Environmental Justice office (OPC) proposing to apply for a grant for the Portuguese Bend Landslide Remediation project. Unfortunately, OPC declined to invite the City to apply for the grant.

Public Works will continue to seek grant opportunities to fund the projects, where grant conditions are acceptable to the City Council.

Undergrounding Along Palos Verdes Drive South

No work is expected this week on this project, as the final paving of the trenched areas of Palos Verdes Drive South, from La Rotonda Drive to the city limit with San Pedro, has been pushed back by the utility crews to the first week of June. Pavement marking is scheduled for one week after paving is completed. City staff is continuing to work with the utility companies to confirm schedules for them to remove their lines from the poles, which is expected to be completed by the end of June and will be followed by pole removal.

Fuel Modification Update



Please resist the urge to visit places that members of the public may be posting on social media sites identifying where goats have been seen. Although we understand the popularity of the goats and the excitement seeing them generates, especially for children, we ask that you do not attempt to go see them or get close to where they are working.

The fencing that is put up to contain them to designated areas is electrified and we want to avoid anyone getting hurt or even shocked. Additionally, getting close to these areas, especially with pets of your own, can be stressful to the goats and the herd dogs. For these reasons and more, we do not advertise or promote the dates when they are scheduled for designated areas to the general public. We appreciate your understanding and ask for your cooperation and respect for the safety of all – including the goats.

Although far less of an attraction than the goats, humans are also utilized for designated areas as part of the City's Fuel Modification plan, and crews will also be working in

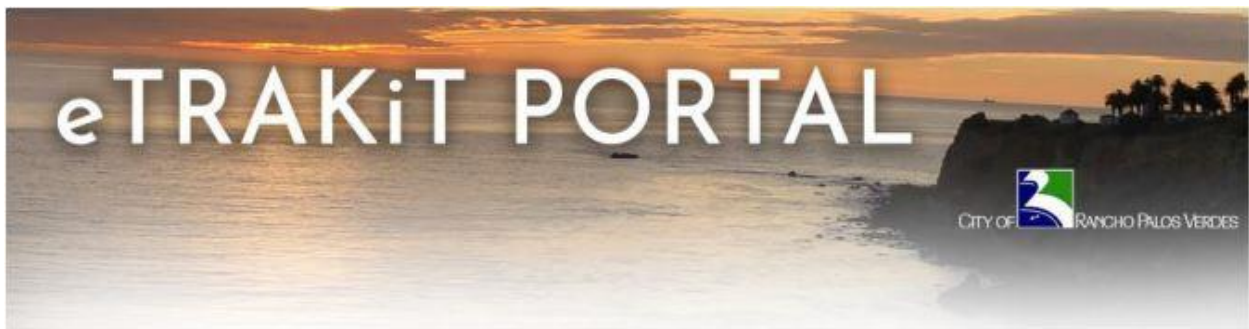
designated areas in the coming weeks. We ask that you avoid approaching crews as they work due to other safety concerns.

Traffic Signal at Hawthorne Boulevard and Via Rivera Update

Southern California Edison established permanent power to the traffic signal this week. Public Works staff is working with the City contractor to schedule the signal programming, testing, and installation of pavement marking and related signs. Staff expects the traffic signal to be fully operational in early June.



eTrakit Online Portal to Apply for Selected Public Works Permits

With eTrakit, a homeowner, developer, or contractor can apply and pay for Dumpster, Haul Route, and Parking Permits online. Business owners or contractors may also apply and pay for an RPV Business License.

Licensed contractors may also log in and view their previous permits using the CA State Licensing Board (CSLB) license number as their login. Passwords for current eTrakit accounts with the City of Rancho Palos Verdes will need to be reset at first log-in.

In addition to regularly scheduled maintenance and repairs, Public Works performed the following:



- Public Works continues daily cleaning and sanitizing parks' facilities and restrooms to reduce the spread of COVID.
- Irrigation repairs took place at Calle Entradero, Hawthorne Boulevard and Vallon Drive, Silver Spur Road median, Forrestal Drive and Palo Verdes Drive South, and at City Hall
- At Rancho Caninos Dog Park, Public Works installed 90 cubic yards of fresh mulch. Public Works also installed more asphalt grindings around the parking area of Rancho Caninos Dog Park to help make a more useable parking area. The Public Works Department used recycled material from the current Public Works' landslide area project. Re-using these materials in a nearby location reduces the environmental impact of the work.



Public Right of Way/Roadway Repairs

- Repaired sidewalks at 2138 Fairhill Drive, 28304 San Nicholas Drive, and 2025 Beecham Drive.
- Inspected and repaired Hesse Park's walking path.
- Repaired or replaced damaged street signs at Hawthorne Boulevard and Granvia Altamira, Palos Verdes Drive South and Dauntless Drive, and Barkentine Road and Palos Verdes Drive South.



Graffiti Removal



- 20 cases of graffiti were reported and removed this week.
- Residents can now download the RPV Graffiti reporting App for Android and Apple devices under the name of "**RPV Clean.**" Residents can help keep RPV look great by using this App.



Emergency Response Items

- The Public Works Department responded to an emergency tree inspection on Avenida Esplendida. Public Works inspected and received the arborist report recommending removal. Public Works is in the process of removing the tree.

Request for Proposal (RFP) Issued for the Subdivision and Residential Development of the Point View Property

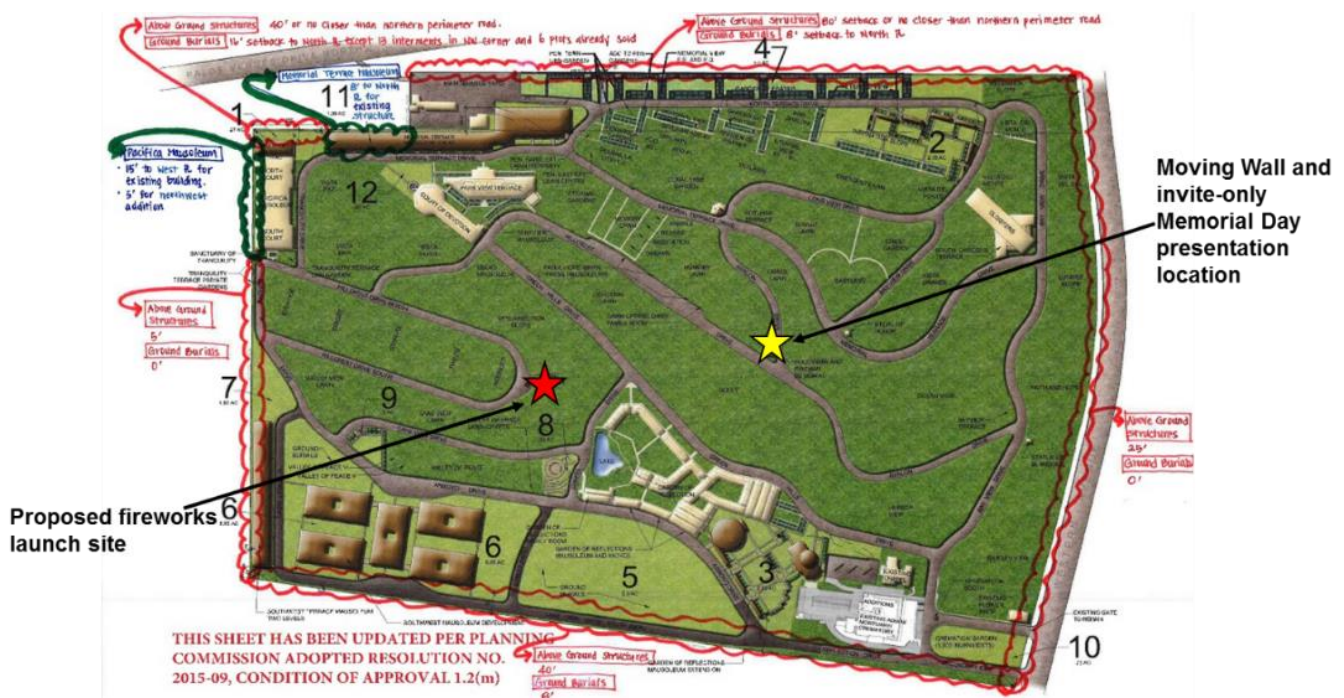


On May 24, the Planning Division issued an RFP to solicit proposals from qualified firms to assist in the environmental assessment of a proposal to subdivide the property at 6001 Palos Verdes Drive South, also known as the Point View Property. The proposed project involves a subdivision of the south and west portion of the project site to create 37 single-family lots, one estate lot, 11 landscape lots, six private street lots, and one lot for a detention basin as outlined in the reference site plan. The project will

require the completion of an environmental impact report to assess all potential project impacts. The project's environmental analysis is part of the development review process and does not signify approval of the project. The environmental review process will include a public scoping meeting and hearings before the City Council and the City's Planning Commission. Green Hills Memorial Park Special Use Permit Update

On May 19, 2021, the Community Development Department issued a Notice of Decision for a conditional approval of a Special Use Permit (SUP) to allow Green Hills Memorial Park to remain open until 9:00 p.m. (two hours past the usual Daylight Savings closing time of 7:00 p.m.) and to conduct a 15-minute fireworks display with amplified/live music on Sunday, May 30, 2021. The fireworks display and live music will be in coordination with an invitation-only Memorial Day presentation to commemorate the display of “The Moving Wall”, a traveling half-size replica of the Vietnam Veterans Memorial. The deadline to appeal the SUP was Monday, May 24. Staff did not receive any appeal notifications; therefore, the Director’s approval of the SUP is final. LAX Community Noise Roundtable Virtual Meeting Summary

A LAX Community Noise Roundtable Virtual Meeting was held on May 19. An action-item summary of the virtual meeting is as follows:

- The Roundtable approved the membership request from the San Gabriel Valley Council of Governments.
- The Roundtable approved updates to the Work Program that included activities over the past year. Examples include the Los Angeles World Airports (LAWA) staff continuing statistical reports on the Extended Downwind Approach, LAWA providing datasets to the 360 at South Bay Community, LAWA chronicling Roundtable letters sent in support of airspace noise reduction, LAWA chronicling technical advances in the aviation industry.
- LAWA staff provided the Roundtable with statistical updates on the passenger jet PV Peninsula overflights and altitude ranges. The attached charts reflect recorded data for March and April 2021.
- The Roundtable approved rescheduling the next meeting to July 14, 2021.

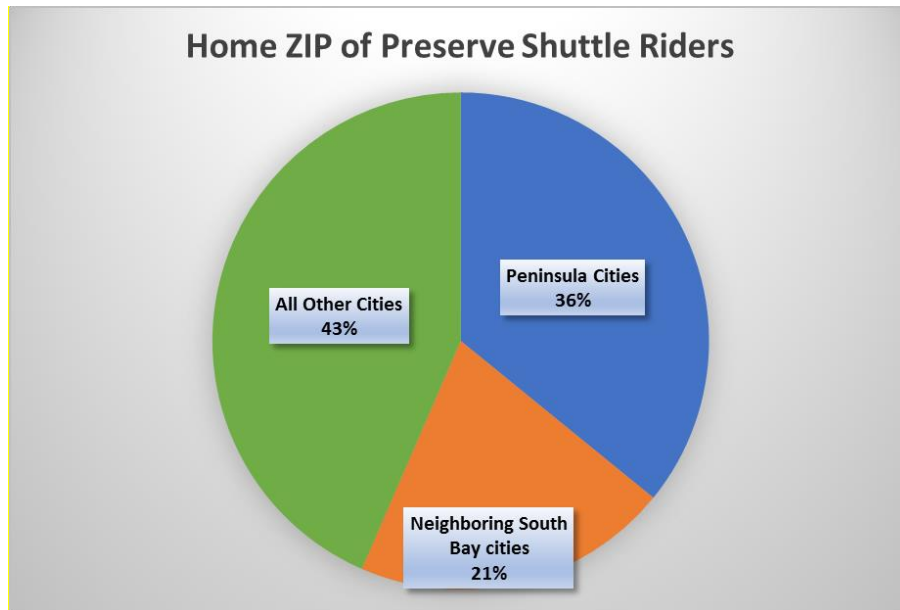
Free Preserve Shuttle Service Pilot Program Completes Seventh Weekend

The City's Palos Verdes Nature Preserve pilot shuttle service program has been operating for seven weekends. The shuttle transports Preserve visitors from the City Hall parking lot to shuttle stops at the Point Vicente Interpretive Center, Abalone Cove, and lower Portuguese Bend Reserve. The City and Palos Verdes Peninsula Transit Authority has moved the Abalone Cove shuttle stop from the bus stop location on Palos Verdes Drive South to the former Annie's Stand area within Abalone Cove Park. It is anticipated that this change will lessen impacts to surrounding neighborhoods.



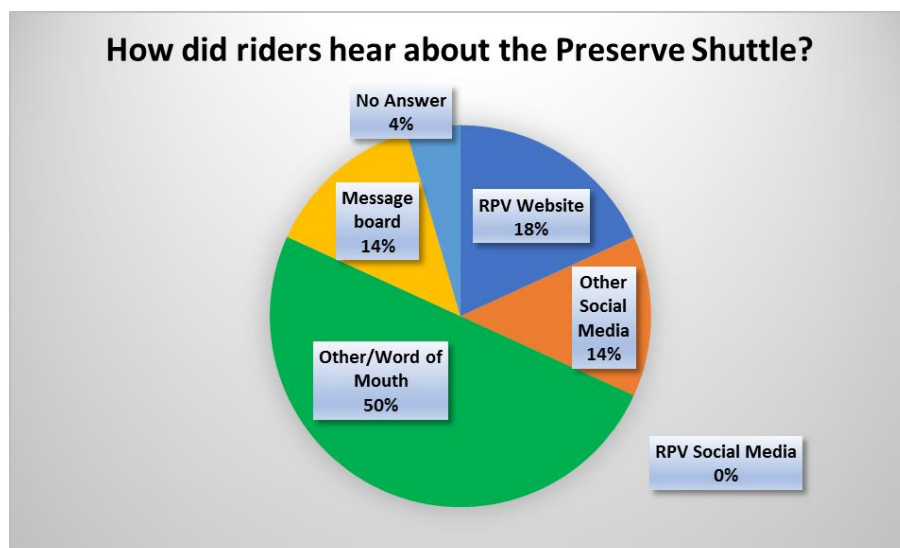
Thirty-two (32) passenger trips were taken on Saturday, May 22, and forty-eight (48) on Sunday, May 23. There was no shuttle service on Friday, May 21, due to a Public Works project. These numbers reflect the number of one-way shuttle trips, so individuals who took a round trip riding the shuttle back to City Hall were counted twice. To date, there have been 440 total passenger trips since the shuttle program started on April 9. There will be no shuttle service this Friday due to Fire training exercises, but there will be an additional day of shuttle service on Monday, May 31 because of the Memorial Day Holiday.

Ninety-three riders completed surveys between April 9 and May 23. Thirty-three respondents were Peninsula residents, and 19 were from neighboring cities (San Pedro, Lomita, Torrance, and Redondo Beach). A total of 40 respondents were from all other ZIP codes.



From the survey responses, the most common parking locations for visitors to the Preserve continue to be City Hall and the Crest & Crenshaw and Del Cerro Park area, followed by Ladera Linda/Forrestal and PVIC. Twenty-three respondents indicated their usual parking location is City Hall, and 18 responded Crest/Crenshaw or Del Cerro. Seven responded Ladera Linda or Forrestal and 6 PVIC.

Beginning on May 21, shuttle riders were asked how they heard about the Preserve Shuttle. Of the 20 riders who completed surveys, four responded that they heard about the shuttle from the RPV website and three from electronic message boards at various locations around the City. Three respondents heard about the shuttle from unspecified other social media, and 11 riders heard by other means, mostly word of mouth or found the shuttle when they parked but did not know about it in advance.



The Preserve Shuttle stops at each location approximately every 30 minutes. The shuttle hours are from 8 a.m. – 5:30 p.m. Friday-Sunday and on holidays. Dogs and mountain bikes welcome!

The City of Rancho Palos Verdes offers this program in partnership with the Palos Verdes Peninsula Transit Authority. The shuttle operates in full compliance with L.A. Meeting with School District and AYSO

On Monday, May 17, staff met with representatives from the Palos Verdes Peninsula Unified School District (PVPUSD) and Palos Verdes American Youth Soccer Organization (AYSO) to discuss the operations and permitted field use of the Ladera Linda School District fields. Over the past few months, there has been an uptick in unpermitted use of the soccer fields. As a result, there has been an increase in after-hours activity, noise, and traffic in the Ladera Linda Community. The City, AYSO, and PVPUSD are working together to increase signage and City Staff, Ranger, and Sheriff presence to eliminate unpermitted use of the fields. City Staff's efforts this past week have been successful in reducing unpermitted use and educating the users on PVPUSD field use requirements.



Last Week for Painting Rocks

Final call for rock art! Throughout May, paint a rock or rocks from your backyard and place them in the Robert E. Ryan Park Rock Garden. Paintings of local points of interest, views, animals, etc., are encouraged but not required. Rock size not to exceed 6"x 6". Patrons can contribute rocks during park hours.



Summer Movies in the Park

This summer, the Recreation and Parks Department will be hosting Movies in the Park at Upper Point Vicente Park/RPV Civic Center. The first movie Onward is scheduled for June 19. A film company will shoot a TV commercial Thursday, May 27, at the Portuguese Bend Beach Club. The crew obtained permission to park their vehicles at Wayfarer's Chapel for the day. This group will film from 7 a.m. to 10 p.m. A second film crew will shoot still photos on Friday, May 28, at Portuguese Bend Beach Club. Their hours will be 7 a.m. to 9 p.m.

Abalone Cove Reserve

From May 17 to May 23, the following Marine Protected Area (MPA) contacts, all from Abalone Cove, were made:

- Ranger/OSM contacts with MPA violators: one (1) collecting with intent to take, eight (8) collecting for observational purposes
- Estimated number of animals prevented from being poached: 0

- Individuals deterred from poaching: 10

During this period, there was lots of coordination between Open Space Management and the Los Angeles Water Keeper, resulting in violators being contacted in both MPAs. Most activity continues to be in Abalone Cove, which received heavy use this weekend.

We want to remind everyone who visits our Marine Protected Areas that in addition to living organisms being protected, non-living resources, such as rocks and shells, are also protected. These resources are important in providing habitat and protection for living organisms. Because of that, take or possession of them is unlawful per Section 632 of the California Code of Regulations.

On Wednesday, May 19, Rangers received a report of a possible transient vandalizing the sidewalk and locking herself into the women's restroom at Abalone Cove Park and Reserve. Rangers were able to make contact. She was last seen walking on Palos Verdes Drive South towards the Fire Station.

Additional signs and cones were placed within Annie's Stand area to guide the Preserve Shuttle into the area and deter unauthorized parking. OSM installed "Authorized Vehicles Only" signs and monitored this area throughout the weekend to assist any and all incoming visitors.



Alta Vicente Reserve

On Sunday, May 23, Rangers received a report of a possible transient sleeping on the trail. Rangers attempted to make contact with the individual to determine whether medical assistance was needed. The individual had been sleeping in 80-degree weather, with no shade, for an unknown period. The female responded aggressively and began to

shout at Rangers. Sheriff Deputies were called to assist and were able to escort the female out of the Reserve.

Forrestal Reserve

After receiving noise concerns from neighbors, Park Rangers and staff have been working to deter unauthorized use of the Palos Verdes Peninsula School District (PVPUSD) owned fields above the Ladera Linda Community Center. The Rangers contacted two individuals with dogs off-leash this weekend; no unauthorized soccer games were observed. The school district approves and authorizes groups on the soccer fields and has posted temporary signs to assist in the enforcement of field use, and is looking into options to deter unauthorized use.



The City is aware of two potential hazards along the coastal side of Klondike Canyon Trail near Barn Owl Trail within the Portuguese Bend Reserve / Forrestal Reserve boundary and began to fill in the hazard with sediment to build a berm.



Ocean Trails Reserve

The bridge located on Catalina Trail near Lakeview Trail has been temporarily closed due to safety concerns related to fissures and land movement (visible on the bottom right of the picture). Visitors can safely walk up Lakeview Trail to Palos Verdes Drive South and access the Eastern trails within the Reserve via East Portal Trail or East Boundary Trail or use Coastal Switch back Trail and Southshore Coastal Trail to walk along the beach. Staff is monitoring the situation with Trump National since they are responsible for maintaining this trail and bridge.



Portuguese Bend Reserve

Fire Station trail was closed on Wednesday, May 19, to allow Stay Green crews to perform fuel modification.



The City has observed increased use of E-bikes within the Palos Verdes Nature Preserve. As a result, new signs were installed at major trailheads to remind visitors that e-bikes are considered motorized vehicles and are not permitted.



On May 24, Rangers assisted Los Angeles County Fire Department in coordinating traffic on Ishibashi Trail as emergency responders located an injured bicyclist. The individual appeared to have a hip injury and was transported out by medical personnel.



Rattlesnake Trailhead Gate Update

The City and the Island View Homeowners Association continue to finalize the details to the agreement install the trailhead fence and gate. At this time, the agreement with the plat map is being reviewed by the Island View Homeowners Association. Construction will begin when the overall easement agreement is finalized and recorded.

ParkMobile Parking App Project Update

The revised timeline for implementing the ParkMobile system is now late June 2021. Parkmobile is in the final stages of system configuration and is setting up training sessions with Staff. During the first month of implementation (July 2021), the City will require a reservation to park but will not charge the \$10 parking fee. This period will allow the City to gain valuable information and data on parking patterns and habits. It will provide the City one month to work directly with ParkMobile on a public education campaign for the new parking system. The City will begin using both the reservation requirement and charging the parking fee in August 2021.



Safety Measures for Outdoor Recreation and Private Gatherings

Beaches, parks, and trails, including the Palos Verdes Nature Preserve, have been open since May 13, with physical distancing, in accordance with guidance from the County of Los Angeles. Please go to www.rpvca.gov for further information.

Parks and Trails Open

Parks, playgrounds, and trails remain open for recreation use, including running, walking, and playing outdoors with members of the same household. All activities where individuals will be or can be in contact with non-household members require an appropriate face-covering unless medically exempt. When participating in a gathering or other activity, all park rules must be followed.

Private Group Gatherings Permitted

In accordance with the L.A. County Health Officer Order, private, informal, outdoor gatherings outdoors of up to 100 people are permitted. Organized meetings and events are not allowed at this time. To lower the risk of exposure to COVID-19, remember to keep gatherings short (no more than two hours), practice good hand hygiene, use single-serve disposable containers and refrain from activities that may increase the risk of COVID-19 transmissions, such as singing, chanting, shouting, or physical exertion.

Attendance at informal gatherings cannot exceed thresholds in the Special Event Permits ordinance.

SUBJECT: Consideration of Impacts from SB 946 (Chapter 459, Statutes of 2018)

Dear President Pro Tem Atkins, Speaker Rendon, Senator Allen, and Assemblymember Muratsuchi:

The City of Rancho Palos Verdes requests that the Legislature renew its consideration of how bills such as SB 946 (Chapter 459, Statutes of 2018), related to sidewalk vendors, may elicit undesirable and unintended consequences for cities. This is another example where a one-size-fits-all approach to legislation infringes upon cities' ability to maintain local security. SB 946 essentially elevates sidewalk vending to a new and prominent status that has the potential to adversely impacts the quality of life for many communities.

The intention of SB 946 was to decriminalize sidewalk vending, and to protect vendors from harassment, criminal prosecution, and deportation. It also allows local authorities to adopt non-criminal laws to protect public health, safety and welfare, such as limiting hours of operation, prohibiting stationary sidewalk vending in residential areas, requiring sanitary conditions, requiring a permit or license, and requiring vendors to comply with the Americans with Disabilities Act.

While the intention of the bill was to protect undocumented immigrants from facing deportation due to criminal charges relating to sidewalk vending, instead SB 946 limits the City's regulatory ability to ensure the safety and welfare of both the seller and passersby to regulating time, place, and manner. One of the unintended consequences of SB 946 has led to physical and verbal altercations between supporters, protestors, and passersby as of result of sidewalk stands across the state that have proliferated in the wake of the 2020 presidential election. The risk of these altercations poses a severe threat to public safety. Furthermore, displays such as banners and large flags risk distracting drivers and causing accidents.

SB 946, in decriminalizing sidewalk vending, also places the burden on cities to consider and regulate for every health and safety concern that may arise, rather than broader prohibitions on sidewalk vending that would ensure that safety is maintained. We are committed to protecting the health and safety of our residents, and all of our business owners and operators, no matter their scope. SB 946 prevents us from successfully doing so.


We encourage the Legislature to recognize that as legislation becomes practice, there may be undesirable and unintended consequences. Therefore, local autonomy and authority must be maintained, and local agencies should be allowed to regulate as they deem necessary to protect the health, safety, and welfare of all residents, workers, and visitors.

The City of Rancho Palos Verdes, like many California cities, has implemented an ordinance regulating sidewalk vending, as allowed by SB 946, and will be assessing its efficacy.

We appreciate the work of the Legislature to represent the people of California, and would request your continued evaluation of protection of local authority, recognizing that local authorities are working to protect the health, safety, and welfare of all residents, workers, and visitors.

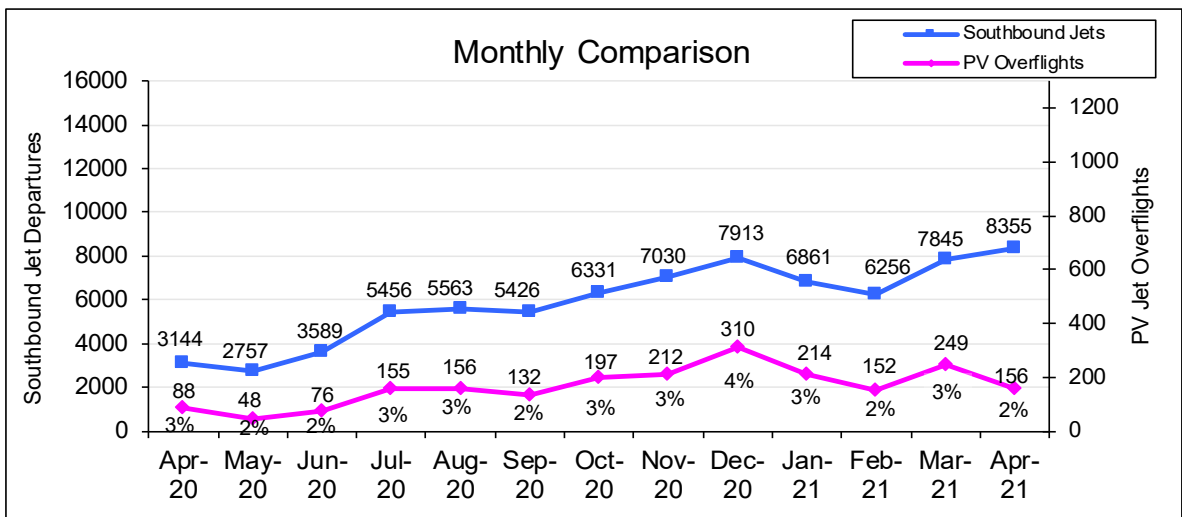
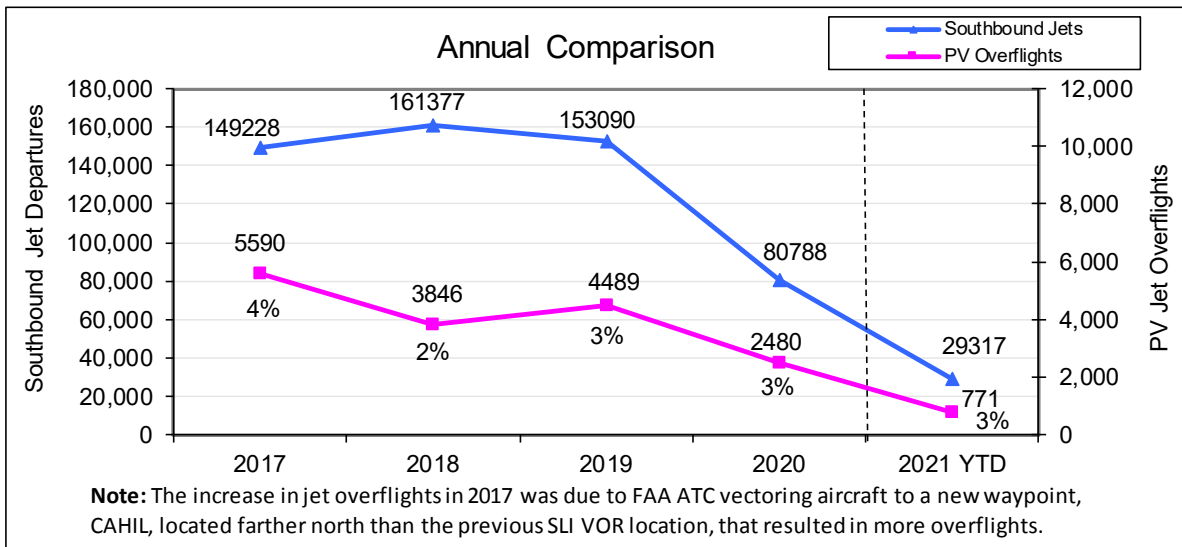
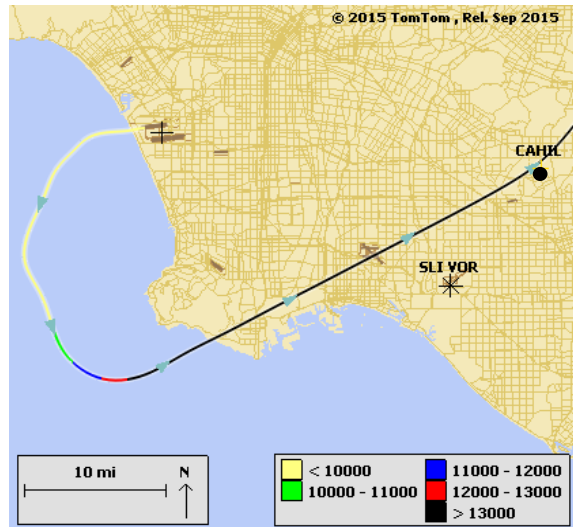
