Proposed Temporary Maritime Tower at Point Vicente

Last week, the California Coastal Commission informed Staff that U.S. Customs and Border Protection (CBP) is seeking to install a relocatable remote surveillance system maritime (RSS-M) tower on federally-owned land near the Point Vicente Lighthouse for six months to one year to detect and track illegal border activities (see attachments). The proposal comes as law enforcement has observed an uptick in panga boat activity off the coast of the Palos Verdes Peninsula in recent months. According to a letter from CBP to the Coastal Commission, the RSS-M tower would comprise a retractable 30- to 80-foot-tall tower with guy wires on a towable trailer and would cause temporary visual impacts. CBP has requested Coastal Commission staff review and concurs with a statement of negative determination (ND) that the proposed tower will not affect the coastal zone and, therefore, does not require a consistency determination. Coastal Commission staff has not made a conclusion and has invited the City to submit comments on the project. Staff will continue to monitor this issue, and intends to submit a comment letter including suggesting alternatives.



Tips for Living with Coyotes

The City has been receiving reports of increased coyote sightings. Coyotes will generally avoid humans but are attracted to free meals in pet food, compost, or trash. A coyote who finds food in one yard may learn to search for food in other yards. Use the following tips to avoid attracting coyotes and to help deter coyotes from your neighborhood:

- Do not feed coyotes: this includes removing access to food from yards, leaving pet food outside overnight, composting outside of an enclosed bin, or having fallen fruit from a fruit tree on the ground.
- Haze any coyote you see this can help maintain a coyote's fear of humans and deter them from neighborhood spaces. The simplest method of hazing involves being loud and large; stand tall, wave your arms and yell at the coyote, approaching it as necessary until it runs away. You may need to use different tactics such as noisemakers, stomping your feet, or spraying the coyote with a hose to get it to leave. In addition, you may want to carry hazing tools with you while you walk your dog. These include a whistle, squirt guns, or sticks or rocks thrown towards the coyote. It is important to continue to haze the coyote until it completely leaves the area.

- Keep your dog on a leash outdoors and away from vegetation where coyotes could hide. Pick up small pets.
- Report sick, injured, or dead coyotes to LA County Animal Control at 310-523-9566. If you see an aggressive or dangerous coyote, contact LA County Agricultural Commissioner, Weights and Measures Division at 626-575-5462.

City of Rancho Palos Verdes' 2021 Rule 20A Allocation Balance Letter.

On May 20, the City received a letter from Southern California Edison (SCE) regarding the City's 2021 Rule 20A allocation (see attachments). Under the Rule 20A program, every year, SCE allocates ratepayer funding to cities to use for qualifying projects to put overhead electric equipment underground. According to SCE, the City's 2021 allocation is \$42,388, and the City's current work credit balance is \$232,965. Staff will bring this to the City Council.

COVID-19 Cases

As of June 1, there are 1,244,161 confirmed cases of COVID-19 across Los Angeles County (population 10.17 million). The total includes 1,544 cases in Rancho Palos Verdes (population 42,747), 482 in Palos Verdes Estates (population 13,522), 289 in Rolling Hills Estates (population 8,113), 59 in Rolling Hills (population 1,940), and 66 in the unincorporated areas of the Peninsula (population 1,921). Countywide, 24,346 people have died.

According to the L.A. County Department of Public Health, 57 deaths have been reported in Rancho Palos Verdes. The City extends its deepest condolences to the families of these residents.

According to the L.A. County Department of Public Health, as of May 23, 70.8% of Rancho Palos Verdes residents age 16 and over received at least one dose of the COVID-19 vaccine.

Water Conservation Tips

Use these conservation tips to help save water – and potentially reduce your water bill!

INDOOR CONSERVATION TIPS:

- Wash only full loads of laundry and dishes and save up to 50 gallons per week
- Fix household leaks promptly and save up to 20 gallons per day
- Spend only 5 minutes in the shower and save up to 8 gallons each time
- Turn off the water while you brush your teeth and save up to 2.5 gallons per minute
- Buy water-saving devices like high-efficiency toilets and clothes washers and save many gallons per day



OUTDOOR CONSERVATION TIPS:

- Water your lawn 1 to 2 days a week and save up to 840 gallons per week
- Check your sprinkler system for leaks, overspray and repair promptly and save up to 500 gallons per month

- Use a broom instead of a hose to clean driveways and sidewalks and save up to 150 gallons each time
- Install a smart sprinkler controller that adjusts for weather, soil type, and plant type and save up to 40 gallons per day
- Water your plants in the early morning or evening to reduce evaporation and save up to 25 gallons each time

PepperTree Trail Regional Wildfire Brush Drill - Concluded

From May 26 to May 28, Battalion 14 of the Los Angeles County Fire Department, which services the Palos Verdes Peninsula, conducted a regional wildfire brush drill in the vicinity of the lower portion of the Portuguese Bend Reserve. During this exercise, personnel from the Los Angeles County Fire Department, in coordination with the City of Torrance's and Redondo Beach's Fire Departments, simulated a wildfire scenario beginning at the Peppertree Trailhead located in the Reserve.

The aim of the drill was for the Los Angeles County Fire Department to exercise and strengthen its ability to work with other local fire departments and the City in responding to a wildfire incident.

As part of the exercise, the Los Angeles County Fire Department provided City staff with an overview of the initial actions that fire department personnel take in responding to a wildfire, shared insights on the decision-making process when responding to a brush fire and best practices in communicating between LA County Fire and the City in the event of an emergency.

The City's Emergency Preparedness Committee is scheduled to receive a presentation on key takeaways from this exercise during their June 17, 2021, regular meeting. City



staff will continue to work closely with the Los Angeles County Fire Department to improve emergency planning and resiliency efforts for the city.

Human-caused hazards are the result of human intent, error, or a result of failed systems. They can be caused by accidents in human-built infrastructures or technologies, or intentional human actions that cause destruction or loss of life. While natural events outside our control cause most disaster type emergencies, there are a number of Human-Caused Disasters that could occur.

Alert SouthBay is a multi-jurisdictional emergency notification system used by 14 South Bay cities – including Rancho Palos Verdes - to keep our communities informed about disasters and emergencies with uniform, and expeditious alerts.

Alert SouthBay is the City’s primary vehicle for emergency communication.

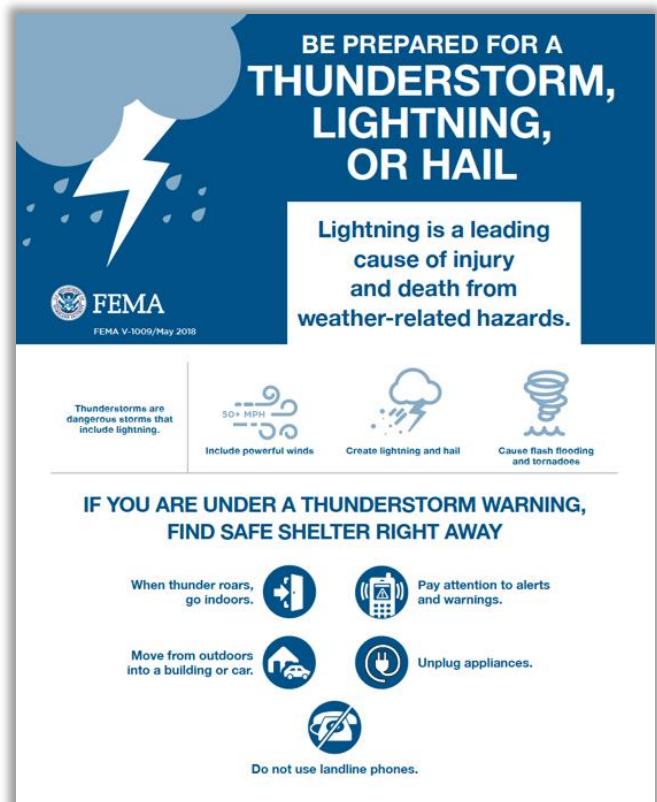
EMERGENCY PREPAREDNESS TIPS

Thunderstorms & Lightning Safety

Thunderstorms last an average of 30 minutes and can cause dangerous lightning, large hail, flash flooding, and strong winds. They often develop quickly, and with little warning, it is important to learn the danger signs and plan ahead. Lightning is a leading cause of injury and death from weather-related hazards.

Thunderstorms are dangerous storms that include lightning and can:

- Include powerful winds over 50 MPH;
- Create hail; and
- Cause [flash flooding](#) and [tornadoes](#).



Understanding Severe Weather Alerts:

Be prepared for severe weather by educating yourself on the differences between a **Severe Thunderstorm Watch** and **Severe Thunderstorm Warning**.

- **Severe Thunderstorm Watch: Be Prepared!** Severe thunderstorms are possible in and near the watch area. Stay informed and be ready to act if a severe thunderstorm warning is issued.
- **Severe Thunderstorm Warning: Take Action!** Severe weather has been reported by spotters or indicated by radar. Warnings indicate imminent danger to life and property. Take shelter in a substantial building. Warnings typically encompass a much smaller area (around the size of a city or small county) that may be impacted by a large hail or damaging wind identified by an NWS forecaster on radar or by a trained spotter/law enforcement who is watching the storm.

Stay Safe BEFORE a Thunderstorm Threatens:

- ☐ **Prepare Now:** In advance of any storm, be sure your property is secure. Make a list of items outside your home you will need to tie down or put away so that they don't blow away or fly through a window.
- ☐ **Be Weather-Ready:** Check the forecast regularly to see if you're at risk for severe weather. Listen to local news or a NOAA Weather Radio to stay informed about severe thunderstorm watches and warnings.
- ☐ **Prepare Your Home:** Keep trees and branches trimmed near your house. If you have time before severe weather hits, secure loose objects, close windows and doors, and move any valuable objects inside or under a sturdy structure.
- ☐ **Make a Kit:** Gather supplies that will last for several days after a disaster for everyone living in your home. Don't forget to consider the unique needs each person or pet may have in case you have to evacuate quickly.
- ☐ **Create a Communications Plan:** Have a family plan that includes an emergency meeting place and related information. Additional information for creating a communications plan is available at: <http://ready.gov/make-a-plan>

Stay Safe DURING a Thunderstorm:

- ☐ **Stay Weather Ready:** Continue to listen to local news or a NOAA Weather Radio to stay updated about severe thunderstorm watches and warnings.
- ☐ **When thunder roars, go indoors:** Immediately go inside a sturdy building when severe thunderstorms are approaching and move to an interior room or basement. Take your pets with you if time allows. Take shelter in your car if you are not near a sturdy building. If possible, drive to a nearby sturdy building. Otherwise, move your car to a location where it is less likely to be hit by falling trees or power lines.
- ☐ **In a vehicle:** Being in a vehicle during severe thunderstorms is safer than being outside; if caught in a vehicle during a severe thunderstorm Safely exit the roadway and park if possible. Stay in the vehicle and turn on the emergency flashers until the heavy rain ends. Avoid touching metal or other surfaces that conduct electricity in and outside the vehicle.
- ☐ **Turn Around. Don't Drown!:** Just six inches of fast-moving water can knock you down, and one foot of moving water can sweep your vehicle away. Each year, more deaths occur due to flooding than from any other thunderstorm related hazard. People underestimate the force and power of water. Many of the deaths occur in cars swept downstream. It is NEVER safe to drive or walk into flood waters.

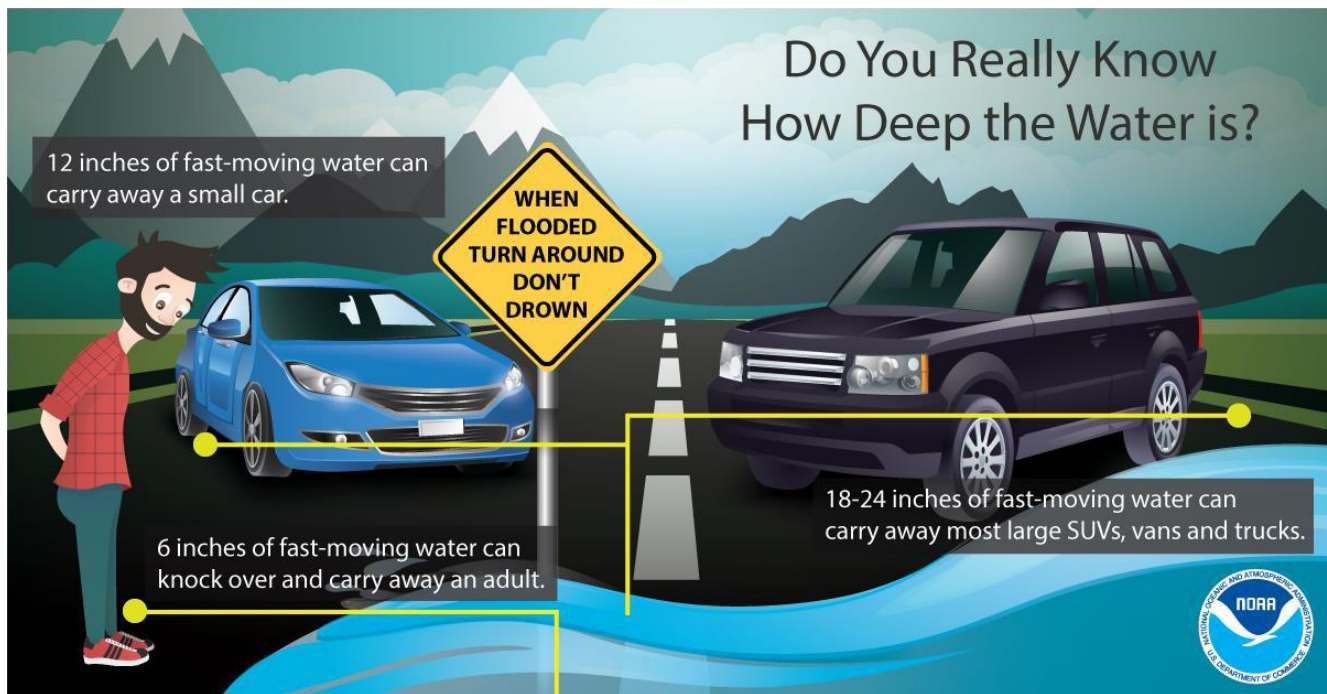
Stay Safe AFTER a Thunderstorm:

- ☐ **Stay Informed:** Continue listening to local news or a NOAA Weather Radio to stay updated about severe thunderstorm watches and warnings. More severe thunderstorms could be headed your way.
- ☐ **Contact Your Family and Loved Ones:** Let your family and close friends know that you're okay so they can help spread the word. Text messages or social media are more reliable forms of communication than phone calls.
- ☐ **Assess the Damage:** After you are sure the severe weather threat has ended, check your property for damages. When walking through storm damage, wear long pants, a long-sleeved shirt and sturdy shoes. Contact local authorities if you see power lines down.

- ❑ **Help Your Neighbor:** If you come across people that are injured and you are properly trained, if needed, provide first aid to victims until emergency response team members arrive.

Protect Your Home

There are simple steps to take to help secure your home and deter residential burglaries:

- When at home or away, keep all doors locked and windows secured with security latches.
- Secure side gates and backyard access with padlocks at all times.
- Request identification from any stranger that comes to your door, including utility workers, and verify before they enter your home.
- Keep valuables out of sight, preferably secured in locked cabinets or safes.
- Use motion-sensor activated lighting to secure the perimeter of your property.
- Utilize home alarms, guard animals, signage, and trimmed landscaping to create sufficient protections for your property.

FINANCE DEPARTMENT

Fiscal Year 2021-22 Budget Adoption

On June 15, the City Council will conduct a second public hearing to adopt the FY 2021-22 Budget. The Citywide FY 2021-22 Budget includes total revenues of approximately \$35.1 million and total expenditures of almost \$35.8 million, excluding transfers and Improvement Authorities. The total General Fund includes revenues of approximately \$30.1 million and expenditures of \$27.4 million, excluding transfers.



In addition to including the details of this public hearing in this weekly report, the notice was also published in the Palos Verdes Peninsula News on May 13 and May 20, 2021.

Statewide Sales Tax Trends

The Finance Department works with several outside consultants and analysts to monitor trends related to the City's revenue sources. HdL provides a quarterly look at sales tax trends by sector. Below you will find insights and projections for two sectors.

Building and Construction

FY20-21: Projected 6.8% growth

FY21-22: Projected 1.7% growth

Issued construction permit values have continued to decline since the end of 2019. However, household projects filled the gap in spending for the construction industry. Through January, traffic at home improvement stores increased as stimulus recipients

spent up to 28% of those payments on renovation products. As the State pulls back restrictions on business openings, consumer spending will shift to other goods and services. Contractors are active, addressing the backlog of projects created by the pandemic slowdown. Lumber prices, up 170% in the last ten months, should push up taxes. The year 2021 is expected to see an extension of growth in warehousing; recent permit activity indicated office space is still in demand. Across California, new home construction is showing no signs of slowing down, supported by the persistent affordability of mortgages. All areas of the state will see at least modest growth in the coming year.

Autos and Transportation

FY20-21: Projected 6.2% growth

FY21-22: Projected 3.0% growth

The autos/transportation sector continues to recover as consumers treat themselves to more expensive vehicles at a time when other spending opportunities have been curtailed by the COVID-19 pandemic. The average price of a new car increased 6% compared to last year as attractive financing rates sustained demand while production stoppages early in the crisis limited supply. Sales are expected to continue to grow as the economy recovers, with automotive executive's hopeful the industry will return closer to normal this year. Recreational vehicle (RV) purchases continue to be a bright spot as many feel they offer a safer way to travel. Receipts for this category were up 27% in the most recent quarter; the RV Industry Association is projecting industry volume may grow by as much as another 20% in 2021, boosted by millennial buyers newly introduced to the lifestyle during lockdowns.

Traffic Signal at Hawthorne Boulevard and Via Rivera Update



The new traffic signal was placed into operation last Thursday, and adjustments were made to the signal programming on Friday afternoon. The signal is designed to remain a green light for traffic along Hawthorne Boulevard, unless vehicles are detected approaching from Via Rivera or the driveway opposite Via Rivera. The City will be monitoring the operation of the new signal and making adjustments as necessary in the days and weeks to come.

Undergrounding Along Palos Verdes Drive South

Final paving of the trenched areas of Palos Verdes Drive South, from La Rotonda Drive to the city limit with San Pedro, is expected to be performed this week, with pavement marking scheduled for a week after the paving is completed. City staff continues to work with the utility companies to confirm schedules for them to remove their lines from the poles, which is expected to be completed by the end of June and will be followed by pole removal.

Fuel Modification Update



Please resist the urge to visit places that members of the public may be posting on social media sites identifying where goats have been seen. Although we understand the popularity of the goats and the excitement seeing them generates, especially for children, we ask that you do not attempt to go see them or get close to where they are working. The fencing that is put up to contain them to

designated areas is electrified and we want to avoid anyone getting hurt or even shocked. Additionally, getting close to these areas, especially with pets of your own, can be stressful to the goats and the herd dogs. For these reasons and more, we do not advertise or promote the dates when they are scheduled for designated areas to the general public. We appreciate your understanding and ask for your cooperation and respect for the safety of all – including the goats.

Although far less of an attraction than the goats, humans are also utilized for designated areas as part of the City's Fuel Modification plan, and crews will also be working in designated areas in the coming weeks. We ask that you avoid approaching crews as they work due to other safety concerns.

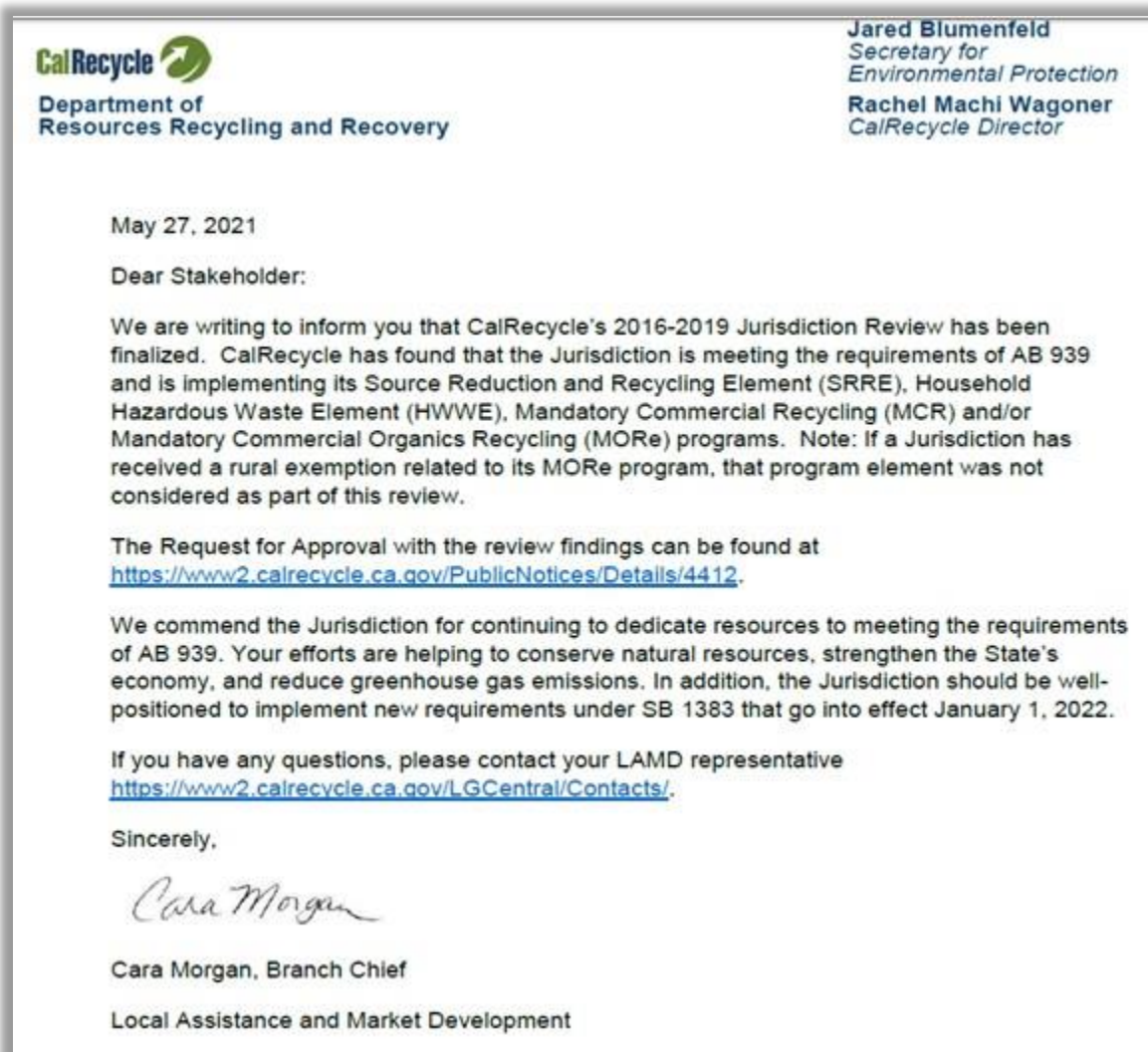

CalRecycle's 2016-2019 AB 939 Jurisdiction Review Completed

On May 27, 2021, Staff was informed that CalRecycle completed its 2016-2019 AB 939 (Solid Waste and Recycling) Jurisdiction Review. Staff is pleased to report that CalRecycle has found that the City meets the requirements of AB 939 and is implementing its Source Reduction and Recycling Element, Household Hazardous Waste Element, Mandatory Commercial Recycling, and/or Mandatory Commercial Organics Recycling programs. The City is a member of the Los Angeles Regional Agency for the

implementation of AB 939 recycling and waste reduction programs and outreach and education efforts. See copy of the letter below.



In addition to regularly scheduled maintenance and repairs, Public Works performed the following:



- Public Works continues daily cleaning and sanitizing parks' facilities and restrooms to reduce the spread of COVID.
- Update: At Rancho Caninos Dog Park, Public Works reinstalled 90 cubic yards of fresh mulch after finding unintended items, such as large pieces of wood, in the originally installed mulch. Public Works' Staff and the vendor worked quickly to replace the mulch with a safer, rounded mini bark before the long weekend for our four-legged friends to enjoy. The mulch was replaced at no cost to the City.
- City Hall Grounds: In the City's efforts to continue beautifying the City Hall grounds, Public Works has installed a new hydro-seed on approximately 35,000 square feet of an open field at City Hall. Hydroseed is a seed and liquid pulp product designed to grow grass in large areas at a fraction of the price of installing pre-grown SOD. It is anticipated that the new greenfield will be ready for enjoyment by residents on the 4th of July.

- Repaired sidewalks at 30571 Rue De Lapierre and 4319 Dauntless Drive.
- Repaired or replaced damaged street signs on Palos Verdes Drive South, Silver Spur Road, and Crest Road.



Graffiti Removal



- Ten cases of graffiti were reported and removed this week.
- The RPV Graffiti reporting App can now be downloaded for Android and Apple devices under the name of "**RPV Clean.**" Residents can help keep RPV look great by using this App.



Emergency Response Items

- Lomita's Sheriff Department reported a potential road hazard on Palos Verdes Drive South and La Rotonda Drive over the holiday weekend. Public Works responded and has since replaced the damaged post and reinstalled the street sign.

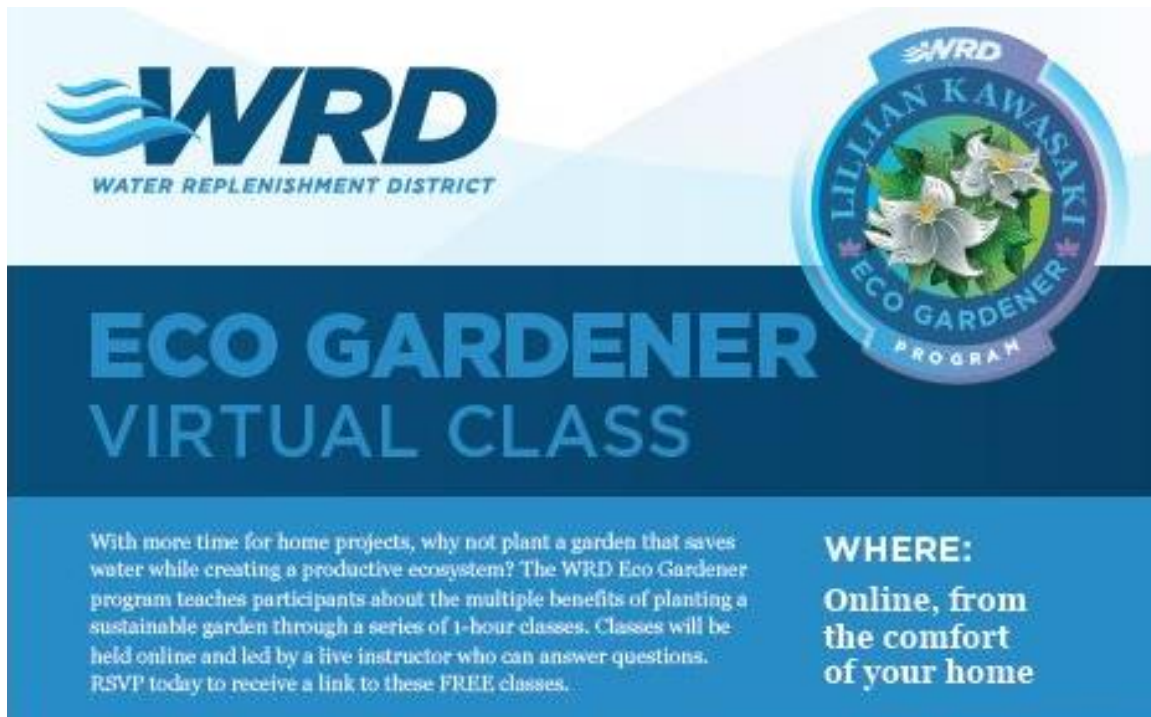


PW Training

Update on Naming City Facility After Councilmember Ken Dyda

On June 1, the City Council provided direction to staff regarding potential sites to be named in honor of Councilmember Ken Dyda for his legacy of over fifty years of service to the City. Among his many accomplishments, Councilmember Dyda helped lead the effort to incorporate the City in the early 1970s and has served for a total of thirteen years on the City Council, including two terms as Mayor. City Council reviewed a list of potential sites including Point Vicente Interpretive Center (PVIC), the Sunset Room at PVIC, Grandview Park, City Hall, and Upper Point Vicente Park/Civic Center. The City Council directed Staff to return with more information on three possible locations: Grandview Park, City Hall/Civic Center, and a new historical museum/lecture hall to be located on the Civic Center grounds.

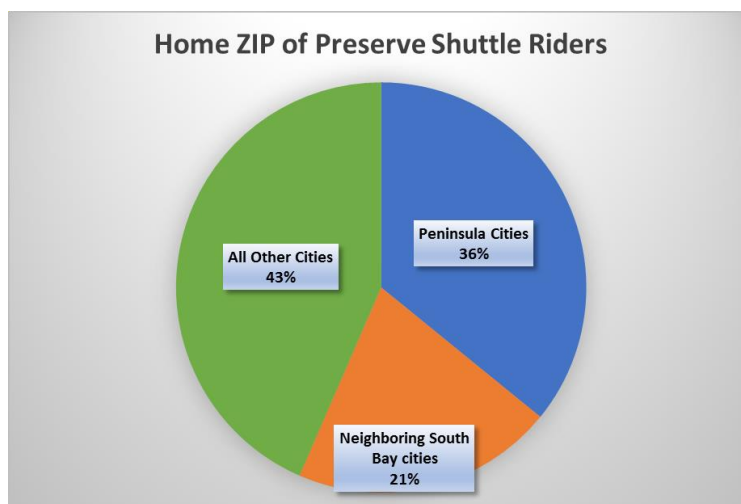
Free Preserve Shuttle Service Pilot Program Keeps on Rolling

The City's Palos Verdes Nature Preserve pilot shuttle service program has been operating for almost two months. The shuttle transports Preserve visitors from the City Hall parking lot to shuttle stops at the Point Vicente Interpretive Center, Abalone Cove, and lower Portuguese Bend Reserve. The City and Palos Verdes Peninsula Transit Authority has moved the Abalone Cove shuttle stop from the bus stop location on Palos



Verdes Drive South to the former Annie's Stand area within Abalone Cove Park. It is anticipated that this change will lessen impacts to surrounding neighborhoods.

Twenty-nine (29) passenger trips were taken on Saturday, May 29, twenty-two (22) on Sunday, May 30, and seventeen (17) on Monday, May 31. There was no shuttle service on Friday, May 28, due to Fire training exercises. These numbers reflect the number of one-way shuttle trips, so individuals who took a round trip riding the shuttle back to City Hall were counted twice. To date, there have been 503 total passenger trips since the shuttle program started on April 9. The chart below shows the home ZIP code of riders through May 24.



The Preserve Shuttle stops at each location approximately every 30 minutes. The shuttle hours are from 8 a.m. – 5:30 p.m. Friday-Sunday and on holidays. Dogs and mountain bikes welcome!

Abalone Cove Reserve

From May 24 to May 30, the following Marine Protected Area (MPA) contacts, all from Abalone Cove, were made:

- Ranger/OSM contacts with MPA violators: 1 collecting with intent to take
- Estimated number of animals prevented from being poached: 0
- Individuals deterred from poaching: 0

During this period, there was lots of coordination between Open Space Management and the Los Angeles Water Keeper, resulting in violators being contacted in both MPAs. Most activity continues to be in Abalone Cove, which received low activity related to MPA violations despite a busy holiday weekend.

Several groups were contacted this weekend regarding permitted tents and camping gear adequate for beach use and activity at Abalone Cove and Sacred Cove Beaches. Closed and covered tents are not permitted. There is no overnight camping permitted within the Palos Verdes Nature Preserve or City Parks, per 12.16.140 RPVMC. However, beach tents are permitted, which allow for protection from the sun.

Staff assisted LA County Lifeguards in educating the public about two highly visible and active rattlesnakes within Abalone Cove Reserve. Rattlesnakes are common in the area, including the beaches, and all patrons are advised to always stay on designated trails, and to always watch where their hands and feet are placed.

Forrestal Reserve

After receiving noise concerns from neighbors, Park Rangers and staff have been working to deter unauthorized use of the Palos Verdes Peninsula School District (PVPUSD)-owned fields above the Ladera Linda Community Center. The Rangers observed no individuals with dogs off-leash this weekend. Five unauthorized soccer games were observed and dispersed. The School District approves and authorizes groups on the soccer fields and has posted temporary signs to assist in the enforcement of field use, and is looking into options to deter unauthorized use.



Rangers responded to a report of an injured and immobile rabbit. The rabbit had two engorged ticks on its neck and was bleeding on its right paw. The rabbit was also seen

experiencing seizures. Wildlife and animal control agencies were called to determine the best course of action.

Ocean Trails Reserve

The bridge located on Catalina Trail near Lakeview Trail has been temporarily closed due to potential safety issued possibly related to fissures and land movement. Visitors can safely walk-up Lakeview Trail to Palos Verdes Drive South and access the Eastern trails within the Reserve via East Portal Trail or East Boundary Trail, or use Coastal Switchback Trail and Southshore Coastal Trail to walk along the beach. Staff continues to monitor the situation with Trump National staff. Trump National staff is responsible for maintaining this trail and bridge and are exploring solutions.



Portuguese Bend Reserve

The Los Angeles County Fire Department conducted a drill in the lower Portuguese Bend area from May 26 – May 28. Rancho Palos Verdes, Open Space Management Division, participated and received training during the drill. The drill simulated a real-time brushfire in the Preserve. Several engines were on scene and worked together to initiate an incident command post, check communication equipment and support resources (such as helicopter units), identify access points, and simulate coordination with the City for traffic control. The drill allowed personnel to assess site topography and site-specific hazards.



Vicente Bluffs Reserve

On Tuesday, June 1, the City was informed of a vacant panga boat at Pelican Cove. Coast Guard, Los Angeles County Lifeguards, and Los Angeles County Sheriff Departments responded.



Sea Dahlia Trail Repairs Project Update

Sea Dahlia Trail remains closed to the public due to loose rocks located near a steep drop-off. On Friday, May 28, the City met with the Palos Verdes Land Conservancy for a site visit to inspect the slope, as well as identify protected species before work can begin. The Conservancy's Volunteer Trail Crew will conduct minor repairs, including removal of rock steps and the addition of wooden steps to be drilled where the current rock steps are. This will ensure the steps cannot be easily removed. They will also add a berm to assist with the stabilization of the cliff.

Rattlesnake Trailhead Gate Update

The City has finalized the easement agreement for installation of the trailhead fence and gate based on the agreed-upon alignment with the Island View Homeowners Association. The Island View Homeowners Association is reviewing the agreement, and construction can begin shortly after the association signs the agreement.

ParkMobile Parking App Project Update

Staff from Recreation and Parks and Public Works met with ParkMobile personnel this week to address a wide range of issues related to the upcoming installation and implementation of the online reservation-based parking program. The current timeline for implementing the ParkMobile system is late June 2021. During the first month of implementation (July 2021), the City will require a reservation to park but will not charge the \$10 parking fee. This period will allow the City to gain valuable information and data on parking patterns and habits, and it will provide the City one month to work directly with ParkMobile on a public education campaign for the new parking system. The City will begin using both the reservation requirement and charging the parking fee in August 2021.



Safety Measures for Outdoor Recreation and Private Gatherings

Beaches, parks, and trails, including the Palos Verdes Nature Preserve, have been open since May 13, with physical distancing, in accordance with guidance from the County of Los Angeles. Please go to www.rpvca.gov for further information.

Parks and Trails Open

Parks, playgrounds, and trails remain open for recreation use, including running, walking, and playing outdoors with members of the same household. All activities where individuals will be or can be in contact with non-household members require an

appropriate face-covering unless medically exempt. When participating in a gathering or other activity, all park rules must be followed.

Private Group Gatherings Permitted

In accordance with the L.A. County Health Officer Order, private, informal, outdoor gatherings outdoors of up to 100 people are permitted. Organized meetings and events are not allowed at this time. To lower the risk of exposure to COVID-19, remember to keep gatherings short (no more than two hours), practice good hand hygiene, use single-serve disposable containers and refrain from activities that may increase the risk of COVID-19 transmissions, such as singing, chanting, shouting, or physical exertion.

Attendance at informal gatherings cannot exceed thresholds in the Special Event Permits ordinance.

SUBJECT: California Coastal Consistency Negative Determination for Deployment of Relocatable Remote Surveillance System Maritime (RSS-M) Tower at Site Named CCS Point Vicente in Rancho Palos Verdes, Los Angeles County.

Dear Mr. Weber:

In accordance with Section 307c(1) of the Federal Coastal Zone Management Act of 1972 as amended, U.S. Customs and Border Protection (CBP) has determined that the deployment of a relocatable remote surveillance system maritime (RSS-M) tower at the proposed site in Los Angeles County will not affect the coastal zone and therefore, does not require a consistency determination. CBP requests California Coastal Commission (CCC) review and concurrence with this statement of negative determination (ND).

The proposed site is located on federally owned land in Rancho Palos Verdes. The proposed CCS Point Vicente site is located at **latitude 33.741709, longitude -118.407839**. The proposed site is located within a disturbed area. It is accessed via an unnamed driveway and Palos Verdes Drive. The site is located on Point Vicente, which includes the Point Vicente Lighthouse. The proposed site is separated from the Point Vicente Lighthouse via a fence and shrubbery.

CBP is proposing the deployment of a RSS-M tower at the U.S. Coast Guard Property at Point Vicente based on operational need. The RSS-Ms are needed to detect and track illegal border activities with the goal of facilitating a CBP response and resolution to border incursions with the ability to relocate based on mission needs. This deployment includes the installation, operation, maintenance, repair, dismantlement, and removal of the system for a period of 6 months to 1 year.

The RSS-M tower is comprised of retractable 30-ft to 80-ft tower with guy wires on a towable trailer with site footprint of 50-ft. x 50-ft. The system is placed on a gravel pad or on suitable soil condition with a circular/square footprint of 100-ft radius from the tower cleared (clearance includes the removal of vegetation and trees as a safety measure for operations) as required for operation and maintenance. However, given site conditions at the proposed site, no vegetation or tree clearance is anticipated.

The installation of the relocatable RSS-M tower would comprise of the system being towed to the site via a heavy-duty pickup truck. Up to 6 personnel will be involved in initial site setup. The proposed site may require two weeks for setup and testing. Once operational, the RSS-M requires

periodic (monthly) and emergency maintenance by up to 3 personnel for 1-2 days/month. Setup and maintenance would only occur during daylight hours. The installation team would connect the system to utilities (solar or grid power if available), mount the sensors on the mast, lift the mast to the operating height, stabilize the tower/outriggers, connect a grounding wire, power on the system, confirm connectivity, ensure the system is operationally stable, and depart the site.

The equipment associated with the relocatable RSS-M includes:

- Solar panels and battery power as the primary power source.
- Grid power will be utilized if available at/or near tower sites.
- Backup propane generators with capacity less than 15 Kw on the towable trailer.
- 8-ft. tall non-ground penetration security fence with access gates.
- Grounding rods inserted into the soil to protect equipment from lightning strikes

The visual area of potential effect (APE) for a 30-ft to 80-ft. tower height is 0.25 mile.

Aesthetics (Visual Quality)

The deployment of the RSS-M tower is within the visual APE of the Point Vicente Lighthouse, Point Vicente Interpretive Center, Alta Vicente Reserve, Pelican Cove Park, and Terranea Bluff Top Park. The deployment of the RSS-M tower would have a temporary impact to the aesthetics of this area during its deployment of 6 months to 1 year. It is a relocatable system, so the visual impacts would be temporary.

Natural Resources

The site is in a previously disturbed, cleared area with an existing access road. No ground disturbance or excavation is necessary for the placement and use of the RSS-M tower.

As the activities will take place within a previously disturbed area, the proposed action would not create additional impacts to wildlife habitat, water, air, or archaeological resources. Standard best management practices will be followed to ensure impacts to wildlife and water resources during installation, operation, and maintenance activities are avoided.

Historic Resources

The site and proposed system deployment were reviewed by the California Department of Parks and Recreation Office of Historic Preservation on April 8, 2021. They did not object to CBP's finding of No Adverse Effect pursuant to 36 CFR 800.5(b).

Coastal Access

The deployment of the RSS-M tower is on federal property that is not accessible to the public. The deployment of this system will not interfere with public access to coastal resources.

Conclusion

CBP has determined that the installation, operation, maintenance, repair, dismantlement, and removal of supporting infrastructure for the RSS-M tower at the proposed CCS Point Vicente Site would not affect aesthetics, natural resources, or public access to the coastal zone in Los Angeles County.

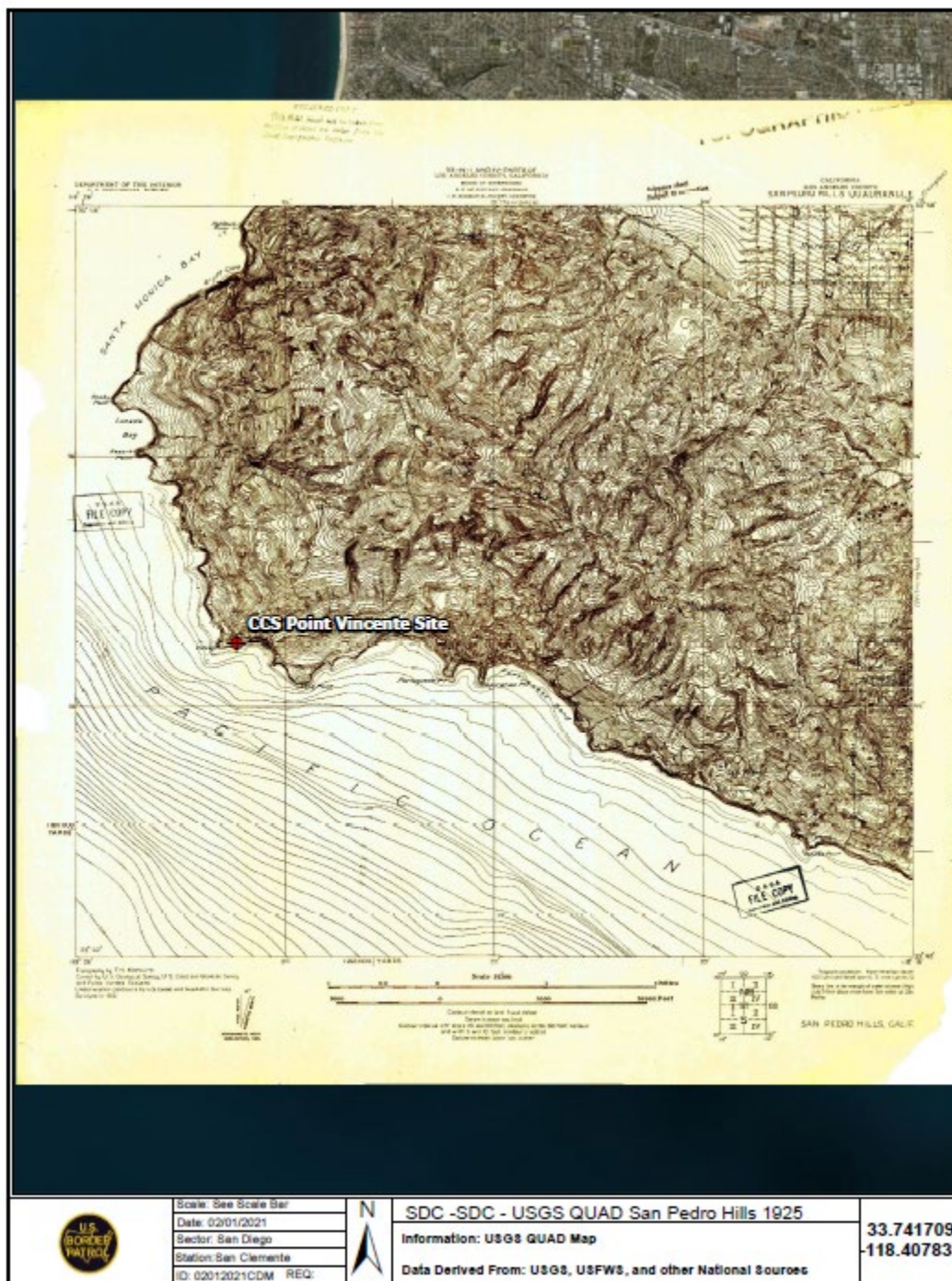
Relocatable RSS-M Tower Photograph

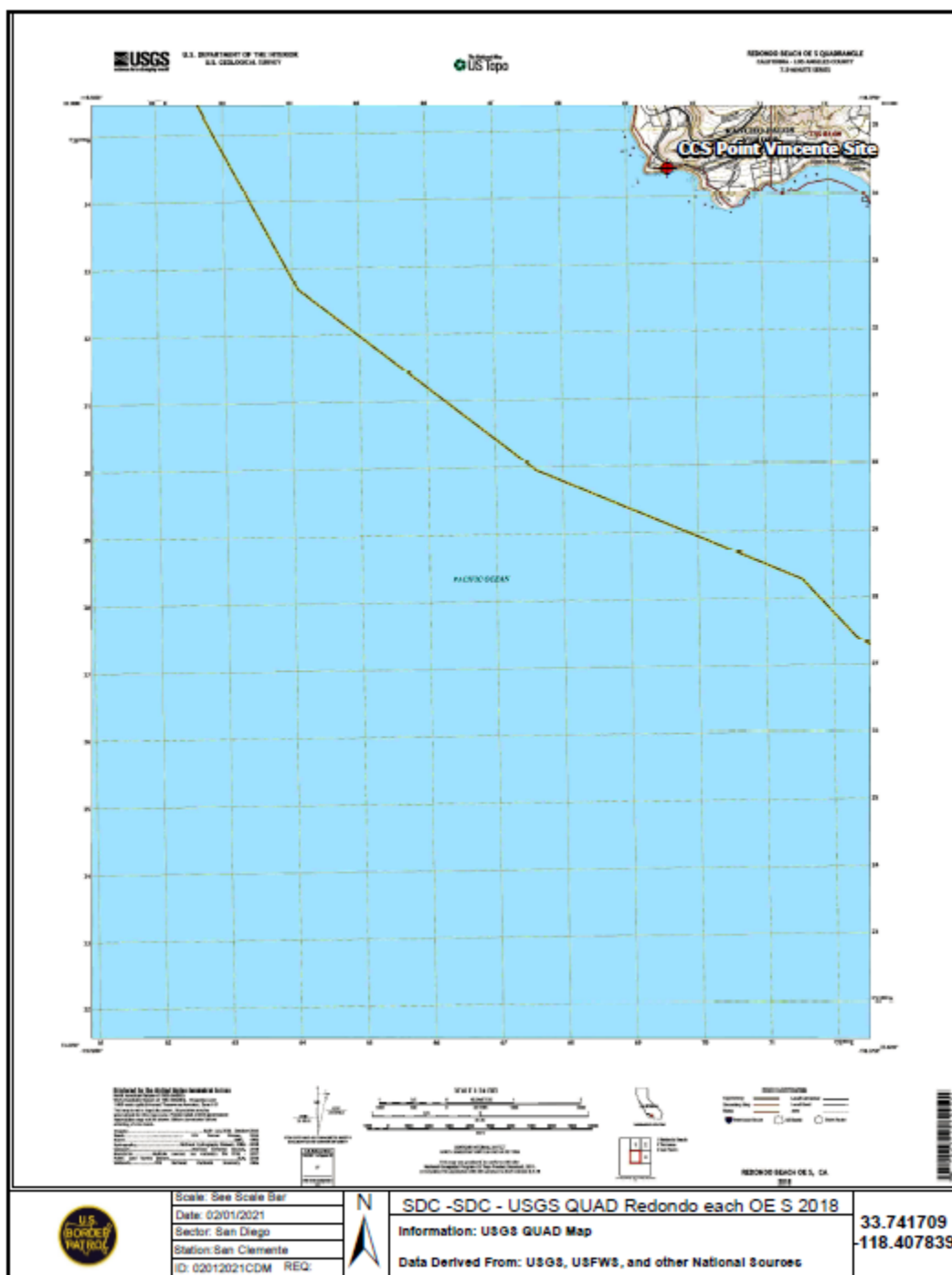




Figure 5. View Impacts of 30-ft Tower Height

Dear Mr. Miharanian:

Southern California Edison (SCE) has filed with the California Public Utilities Commission (CPUC) its annual report of SCE's 2021 budget for capital spending under Tariff Rule 20A, Replacement of Overhead with Underground Electric Facilities. For calendar year 2021, the budget is \$ 12,083,257.

Pursuant to the formula set out in Tariff Rule 20A, the portion of this amount allocated to the City of Rancho Palos Verdes is \$42,388. Under the tariff, allocated work credits not committed to a qualifying project in a given year are carried over to the next year. As of this writing, the City of Rancho Palos Verdes' work credit balance is \$232,965.

In addition to the work credit balance, CPUC Decision 01-12-009 codified the opportunity for local governments to "mortgage" or borrow up to an additional five years of work credits in order to be able to undertake a qualifying Rule 20A project sooner than they otherwise could.

In accordance with the Decision, and when requested by you, SCE will meet with you and community residents at least once every six months when projects are in queue, and at least once every other month once a conversion project is underway. The decision requires local government to give notice of the meetings and provide the venue. Please feel free to call me any time to schedule such a community meeting or, if you have any questions about Rule 20A or any other matters affecting SCE's service to you.
