### ParkMobile Guide for Residential Recreational Parking Permit Holders

Are you an RPV resident with a Residential Recreational Parking Permit and wondering how to reserve parking on Park Place next to Del Cerro Park using the City's new reservation system? For questions specific to current reservations, including reservation changes and refunds, please call ParkMobile Member Services at (866) 330-7275.

Parking reservations are now **required** for Crenshaw Boulevard south of Crest Road and on Park Place (this includes Residential Recreational Parking Permit holders).

Reserve your parking spot using the [ParkMobile website](#) or [mobile app](#) to reserve parking spaces on Crenshaw Boulevard south of Crest Road and on Park Place, near the Rattlesnake and Burma Road Trailheads.

The system is being implemented to manage parking and improve traffic flow in the Del Cerro Park area.



## Parking with ParkMobile

- ParkMobile reservations are **required** for all 60 spaces on Crenshaw Boulevard south of Crest Road and on Park Place.
- Reservations must be made by 11:59 p.m. the night before your visit.
- Visitors cannot park and then reserve their spot.
- Reservations are limited to blocks of 2 hours and 45 minutes from 7:00 a.m. to an hour after sunset (shorter or longer blocks of time are not available at this time).
- Reservations are free of charge until August 2, when parking will be \$10 per reservation block and can be paid using ParkMobile. An additional \$0.35 processing fee will apply.
- Parking is free from 7:00 a.m. to 8:45 a.m. on weekdays.
- Fifteen (15) spaces on Park Place adjacent to Del Cerro Park remain available to those who hold a [Residential Recreational Parking Permit](#). Permit holders must reserve these spaces (in Zone A) using ParkMobile. Two additional ADA spaces on Park Place do not require Residential Recreational Parking Permits but require ParkMobile reservations.
- Street parking on Crenshaw Boulevard north of Crest Road remains free and does not require reservations.

## Civic Center Advisory Committee Recruitment

Do you have a vision for the future of the Rancho Palos Verdes Civic Center site? The City is in the process of developing a master plan to potentially redevelop the Civic Center site on Hawthorne Boulevard, which includes City Hall, Upper Point Vicente Park, and the Rancho Caninos Dog Park.



The City is accepting applications to fill two vacancies on the **Civic Center Advisory Committee**, which serves as a citizen's advisory board to the City Council advising on the

development of the Civic Center Master Plan. The seven committee members play a vital role in the public outreach process, financial analysis, layout/boundary concerns, conceptual design, and other related issues. These are volunteer, non-paying positions with terms of office ending in June 2024.

The committee meets monthly, typically the fourth Thursday of the month, at 6:00 p.m. in the Community Room at City Hall. However, due to the pandemic, the committee has been meeting virtually using the Zoom platform.

### How to Apply

Those interested in applying must submit an application to the City Clerk's Office by 4:30 p.m. on **Friday, July 20**. To be considered for appointment, an applicant must be a resident of the City of Rancho Palos Verdes. To apply, please visit the [Advisory Board Recruitment](#) page on the City website. ### As Drought Conditions Intensify, Governor Newsom Calls on Californians to Take Simple Actions to Conserve Water

Amid intensifying drought and record-breaking temperatures across the Western



United States, Governor Gavin Newsom is calling on Californians to voluntarily reduce their water use by 15 percent with simple measures to protect water reserves if drought conditions continue and to help maintain critical flows for fish and wildlife wherever possible.

The Governor [signed an Executive Order](#) calling on all Californians to voluntarily reduce their water use by 15 percent compared to 2020 levels through simple actions such as reducing landscape irrigation, running dishwashers and washing machines only when full, finding and fixing leaks, installing water-efficient showerheads, and taking shorter showers. These voluntary efforts complement specific local conservation mandates already in place in some communities experiencing acute water shortage conditions this summer.

State officials estimate an additional 15 percent voluntary reduction by urban water users from 2020 levels could save as much as 850,000 acre-feet of water over the next year for future use, or enough to supply more than 1.7 million households for a year.

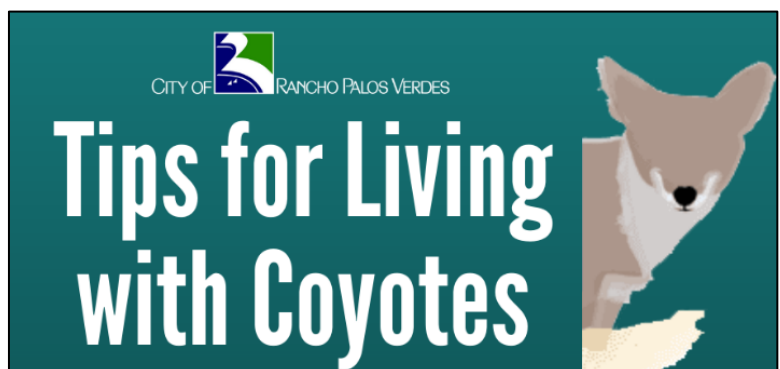
The State Water Resources Control Board and the Department of Water Resources will monitor progress on voluntary conservation, reservoir storage, soil moisture, and other metrics in the coming months to determine whether additional drought response actions are needed.

To help Californians take simple action to reduce water use by 15 percent, state agencies are partnering with local water suppliers to promote conservation tips through the [Save Our Water](#) campaign. The campaign and website were critical resources for Californians during the 2012-2016 drought and remained a trusted information source on using water wisely.

### Tips for Living with Coyotes

The City has been receiving reports of increased coyote sightings. Coyotes will generally avoid humans but are attracted to free meals in the form of pet food, compost, or trash. A coyote who finds food in one yard may learn to





search for food in other yards. Use the following tips to avoid attracting coyotes and to help deter coyotes from your neighborhood:

- Do not feed coyotes: this includes removing access to food from yards, not leaving pet food outside overnight, composting in an enclosed bin only, and picking up fallen fruit from a fruit tree on the ground.
- Haze any coyote you see: this can help maintain a coyote's fear of humans and deter them from neighborhood spaces. The simplest method of hazing involves being loud and large; stand tall, wave your arms and yell at the coyote, approaching it as necessary until it runs away. You may need to use different tactics such as noisemakers, stomping your feet, or spraying the coyote with a hose to get it to leave. In addition, you may want to carry hazing tools with you while you walk your dog. These include a whistle, squirt guns, or sticks or rocks that can be thrown towards the coyote. It is important to continue to haze the coyote until it completely leaves the area.
- Keep your dog on a leash outdoors and away from vegetation where coyotes could hide. Pick up small pets.
- Report sick, injured, or dead coyotes to LA County Animal Control at 310-523-9566. If you see an aggressive or dangerous coyote, contact LA County Agricultural Commissioner, Weights and Measures Division at 626-575-5462.

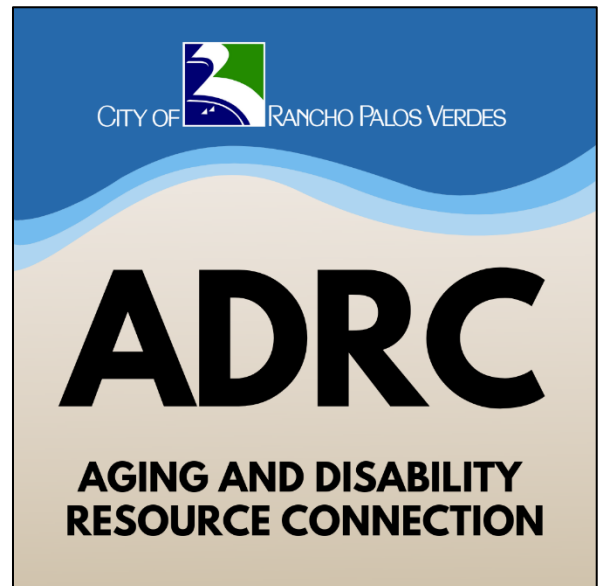

RPV residents 65 and older and individuals with a disability covered under the Americans with Disabilities Act are invited to participate as ADRC members! This is a free service for residents.

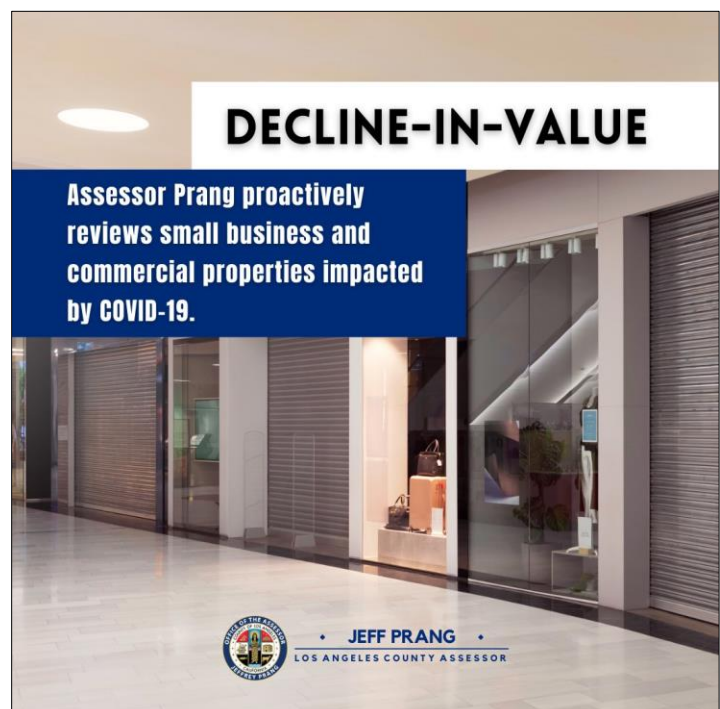

## Decline-in-Value Assessments for Businesses Affected by COVID-19 Pandemic

While home prices have skyrocketed during the pandemic, many small businesses and retail property owners have struggled to hang on despite significant losses. Due to the impacts of the COVID-19 pandemic, the Los Angeles County Assessor's Office is proactively reviewing small businesses and other commercial properties to determine if they are entitled to property tax relief.



If you think your property lost value because of the pandemic-induced recession, you may be eligible for a decline-in-value review of your property's assessment. The filing period to request a review runs through November 30, 2021.

### **L.A. County Sees Increased Spread of COVID-19 and Delta Variant Cases; Fully Vaccinated People Remain Well Protected**

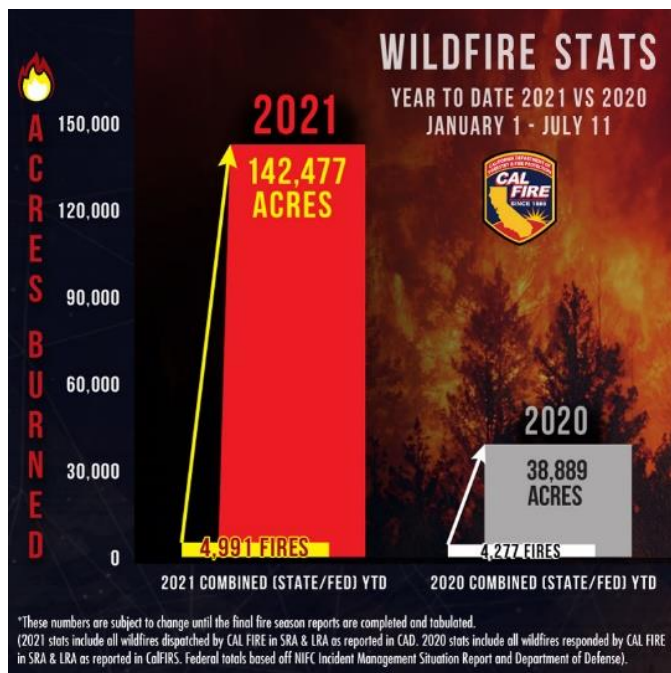
With the recent rise in COVID-19 cases, tracking the proliferation of variants of concern remains a priority to better understand the factors that may be contributing to increased community transmission. The L.A. County Department of Public Health is watching particularly closely for Delta variants which were first detected in India, and are now estimated to comprise about half of U.S. cases.

The Delta variant has been the most commonly sequenced variant in L.A. County since the beginning of June, now accounting for the majority of variants of concern identified by labs. From June 20 and June 26, the number of sequenced Delta variants was 63, 54% of all sequences collected that week. The rising proportion of Delta among sequenced variants of concern is consistent with what other parts of the U.S. are seeing, and for certain represents increased circulation of the variant. Given that slightly under 4 million residents in L.A. County are not yet vaccinated, the risk of increased spread remains high. The data to date suggests fully vaccinated people are well protected from severe infections with the Delta variant.



## Wildfire Preparedness

Hot weather and dry conditions are fueling an increase in wildfire activity throughout California. According to Cal Fire, more than 700 wildfires and over 103,000 acres burned since this time last year. As a result, it is now more important than ever that all Californians are prepared for wildfire. ## Fireworks Roundtable Discussion

Earlier this week, staff attended a League of California Cities Roundtable Discussion centered on the continued use of illegal fireworks beyond the Fourth of July holiday and into the summer. Elected officials and agency representatives from across Southern California participated in this discussion and engaged in an open-forum exchange of



ideas and best practices used by their municipalities to regulate and curb the use of fireworks. **Local officials specifically discussed the following fireworks mitigation practices:**

- Implementation of significant administrative fines for selling or discharging fireworks.
- Issuing non-contact citations, in which residents who are observed lighting fireworks receive a citation in the mail.
- Adoption of Social Host ordinances that hold renters and homeowners accountable when their house guests use fireworks.
- The use of emerging technologies such as drones and mobile apps to assist in the monitoring and regulating of fireworks use.

Roundtable discussion participants further emphasized the importance of increased collaboration between all levels of government, as fireworks are a regional issue, not a local one. The City will explore if and how any of these potential mitigation practices could be implemented in Rancho Palos Verdes, or the Palos Verdes Peninsula.

Fireworks are illegal and strictly prohibited on the Peninsula. Fireworks pose a significant fire danger, cause injuries, scare pets and may trigger a response in those with post-traumatic stress disorder (PTSD). To support the City's efforts in deterring the use of fireworks, you can report problem locations by calling the Lomita Sheriff's Station to report fireworks in the cities of Rancho Palos Verdes, Rolling Hills, and Rolling Hills Estates at 310-539-1661.

## Cyber Incident Response Tabletop/Webinar

On Thursday, July 8, City staff attended a Cyber Incident Response Webinar hosted by the Multi-State Information Sharing and Analysis Center (MS-ISAC), a trusted cybersecurity resource for local governments, that focused on best practices for collaborating with law enforcement during a cyber security incident response. Throughout this webinar, cyber security subject matter experts walked participants through a simulated cyber-attack scenario, demonstrating the variety of nefarious methods cybercriminals use to



infiltrate an organization and the potential devastation that cyber-attacks can cause to an organization's ability to function.

Cyber security experts further briefed participants on the latest phishing attack techniques, dangers posed by ransomware attacks, and on specific steps an organization must take to effectively respond to an incident once detected. This training additionally, stressed the importance of contacting law enforcement as soon as possible to help mitigate the consequences of an attack, and clarified that, while law enforcement can assist with recovery operations, their primary mission is to prosecute the perpetrators.

Additionally, the importance of organizations being prepared to quickly provide technical details to responding law enforcement personnel, comprehend how this information will be used, and the potential unintended consequences displayed during an incident, as well as best practices for navigating financial recovery and insurance claims, were also addressed during this webinar.

## Have You Signed Up For Emergency Alerts From Alert SouthBay?

Alert SouthBay is a multi-jurisdictional emergency notification system used by 14 South Bay cities, including Rancho Palos Verdes, to keep our communities informed of

disasters informed about disasters, and major emergencies via SMS (text), email, phone, landline, as well as other means of communication.

Alert SouthBay is an opt-in system using the Everbridge software application. Users can subscribe to receive alerts from multiple South Bay cities. If you live in Rancho Palos Verdes, for example, but work in Torrance, you can subscribe both cities' alerts. Alert SouthBay will act as the City's primary vehicle for emergency communication.

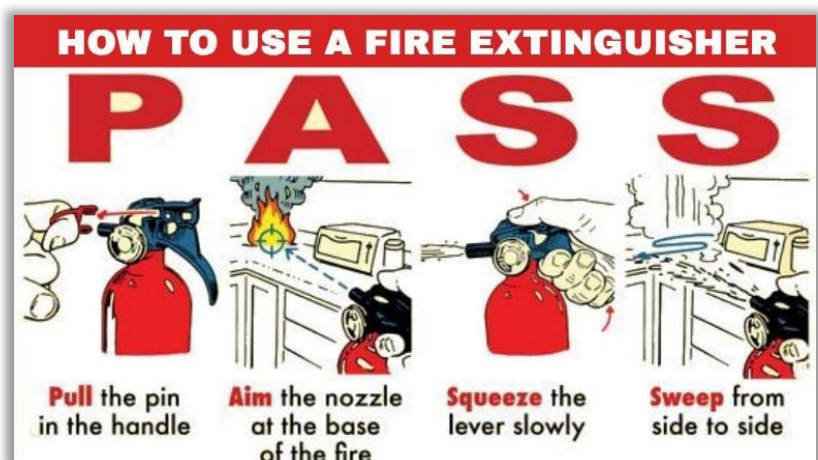

## How to Properly Use a Fire Extinguisher

Fire extinguishers are a necessary safety item that should be in every home and business. Most fires start small. If the fire is contained to a single object, such as a trash can, you may want to try using a fire extinguisher to put out the flames.



Using a fire extinguisher can be intimidating if you have never used one before. Most of us have extinguishers in our homes and workplaces but may not know how to actually use one. It's important to make sure you know how and when to use a fire extinguisher and have the right type on hand to put out common household fires.

The following information is designed to help you determine when to use a fire extinguisher, the proper use, and what type you need.

### TYPES OF FIRE EXTINGUISHER CLASSES:

Not all fire extinguishers are the same; they are classified according to the type of fire that is burning. If you use the wrong type of fire extinguisher on the wrong class of fire, you can make matters worse. All fire extinguishers are labeled to indicate which classes of fire they are designed to combat.



There are four classes of fire extinguishers – A, B, C and D – and each class can put out a different type of fire.

- **Class A extinguishers** will put out fires in ordinary combustibles such as wood and paper.
- **Class B extinguishers** are for use on flammable liquids like grease, gasoline and oil.
- **Class C extinguishers** are suitable for use only on electrically energized fires.
- **Class D extinguishers** are designed for use on flammable metals

Most household fire extinguishers are considered multipurpose and can be used on different types of fires and will be labeled with more than one class, like A-B, B-C, or A-B-C.

#### **HOW TO USE A FIRE EXTINGUISHER:**

There is a simple acronym to remember to operate most fire extinguishers - PASS. PASS stands for Pull, Aim, Squeeze and Sweep.

- **Pull** - Pull the pin at the top of the extinguisher. This unlocks the extinguisher and allows it to be discharged.
- **Aim** - Aim the extinguisher nozzle at the base of the fire.
- **Squeeze** - Squeeze the lever above the handle. This will discharge the extinguishing agent.
- **Sweep** - Sweep the extinguisher nozzle from side to side while aiming at the base of the fire.

#### **WHEN TO USE A FIRE EXTINGUISHER**

Fire extinguishers are meant to handle only small fires. Death or serious injury can occur by tackling a fire that is beyond your capabilities. Only tackle a fire in its early stages and always ensure you put your own and other people's safety first. Before trying to control a fire with a portable extinguisher you should know the general procedures for responding to a small, early-stage fire.

**You should fight a fire with a fire extinguisher only when all the following are true:**

- Everyone has left or is leaving the building.
- The fire department has been called.
- The fire is small and confined to the immediate areas where it started such as in a wastebasket, cushion, small appliance, stove, etc.
- You can fight the fire with your back to a safe escape route.

- Your extinguisher is rated for the type of fire you are fighting and is in good working order.
- You have had training in use of the extinguisher and are confident that you can operate it effectively.

If you cannot put out the fire or if the extinguisher becomes empty, evacuate yourself and everyone in the building immediately, closing all doors behind you as you go and ensure the fire department has been called.

### **FIRE EXTINGUISHER BEST PRACTICES**

Because we do not have regular opportunities to practice fighting fires, it is easy to make simple mistakes when the time comes. The following is a list of best practices for storing, maintaining, and using your fire extinguisher.

- **Ensure Easy access in an emergency:** Be sure nothing is blocking or limiting your ability to reach it.
- **Read the instructions:** Thoroughly read the operating instructions that came with your fire extinguisher.
- **Don't let your extinguisher go bad:** Fire extinguishers come with an expiration date, after which the extinguishing agent is no longer effective. Know the dates on your fire extinguishers and replace them as needed.
- **Care and Maintenance of Your Extinguisher:** Ensure there are no dents, leaks, rust, chemical deposits, and other signs of abuse/wear. Wipe off any corrosive chemicals, oil, gunk, etc., that may have landed on the extinguisher.
- **Know where the exits are at all times:** When you decide where to keep your fire extinguisher, make sure it is in an easily accessible location near exterior doors. Also, consider the most common places where fires occur in a home and place your extinguishers accordingly.

## Prevent Vehicle Burglaries

Take steps today to prevent thefts from your vehicle. Residents are strongly encouraged to use "Lock It or Lose It" prevention tips every day. It only takes a matter of seconds for a thief to break into your car and grab your valuable items.

Look through the windows of your vehicle. What do you see? A bag on the passenger seat? A charging cord? A garage door opener? Change in a cup holder? Take it with you or remove it from plain view and be sure to close all windows and lock doors.



Follow these tips to help prevent vehicle burglaries:

1. Remove all valuable items from your car, including purses and electronics.
2. If you must leave valuables behind, put them in your trunk before you reach your destination. Avoid doing so while in plain view.
3. Close all windows, lock your doors, and set your alarm or anti-theft device.
4. Park in a locked garage or well-lit areas.



If you see suspicious activity report it immediately to the Lomita Sheriff's Station at 310-539-1661. In case of emergency, call 9-1-1.

## Make Safety a Habit

Every night at 9:00PM, the community is encouraged to lock up property, turn on lights, and bring in valuables to reduce the likelihood of falling victim to property crimes.

Lock all doors and windows, including garage doors, turn on lights or set them on a timer if you plan to be away, and avoid leaving valuables in visible areas. These actions help deter burglars and may help prevent residential burglaries.



Be aware, and if you see something suspicious, say something! The City encourages you to call the Lomita Sheriff's Station at 310-539-1661 if you see suspicious persons or activities.

## Vacation Security Tips

While planning and going on a vacation, consider these tips to help enhance your safety, and secure the safety of your property:

- Avoid posting about your vacation on social media – doing so may alert thieves that your home is vacant.
- Have friends or neighbors clear your newspapers and mail if you leave town, or temporarily suspend deliveries.
- Set lights on a timer, so your home looks occupied.
- When on vacation, know the locations of local law enforcement stations and phone numbers.
- Agree on a rendezvous point with members of your party in the event you get separated.
- Share your itinerary with friends and family.

## AMERICAN RESCUE PLAN ACT OF 2021

### American Rescue Plan Act (ARPA)

As previously reported, on June 10, 2021, the City has submitted its request for ARPA's allocations to the Department of Finance (DOF). On July 13, the City received \$4.97 million, 50% of the City's allocation of \$9.9 million. Based on the DOT's "Interim Final Rule" (draft guidelines) below, the City will be compiling and reviewing eligible projects that will be presented to the Finance Advisory Committee and to the City Council in September.

#### Eligible Uses: Four Main Categories

1. Containing/mitigating COVID-19 or negative economic impact.
2. Premium pay for essential workers.
3. For government services to the extent of the loss of revenue. This category is the most pertinent to local agencies and defined as follows:
  - Directly provide services or aid to citizens.
  - Maintenance or pay-go funded building of infrastructure, including roads;
  - Modernization of cybersecurity, including hardware, software, and protection of critical infrastructure;
  - Health services;
  - Environmental remediation;
  - School or educational services; and
  - The provision of police, fire, and other public safety services.
4. Investments in water, sewer, and broadband infrastructure.

#### Ineligible Uses

1. Pension payments.
2. Replenishing of reserves.
3. Payment on any debt instruments.

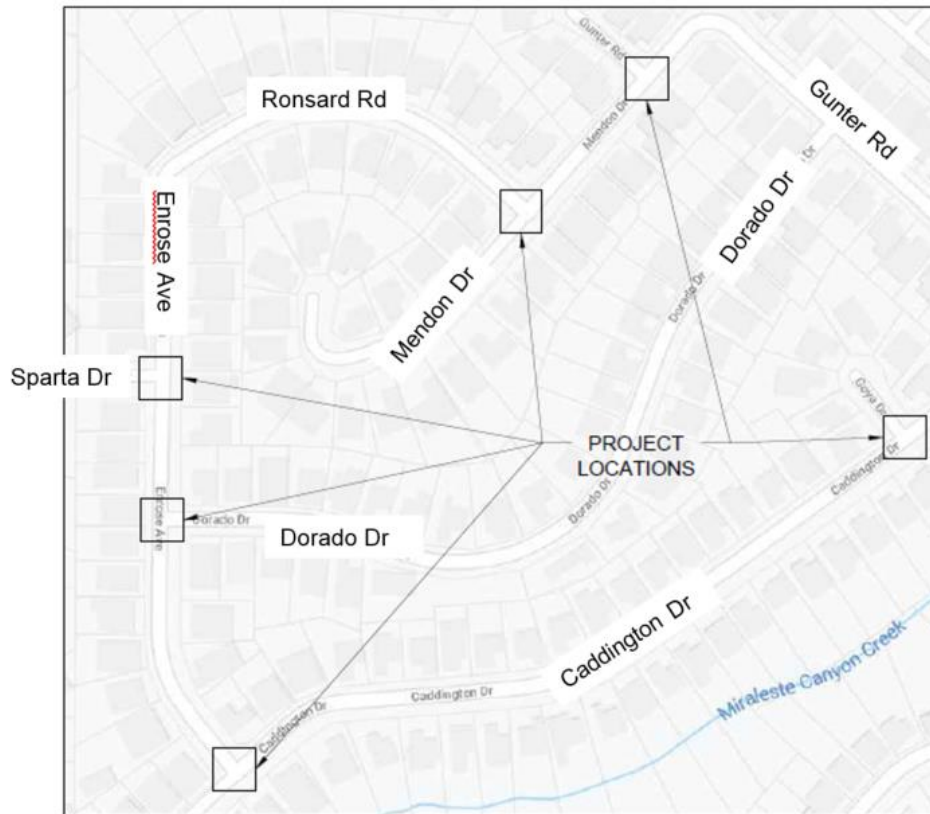


### **Curb Ramp Construction Starts July 19 in Caddington Drive Area**

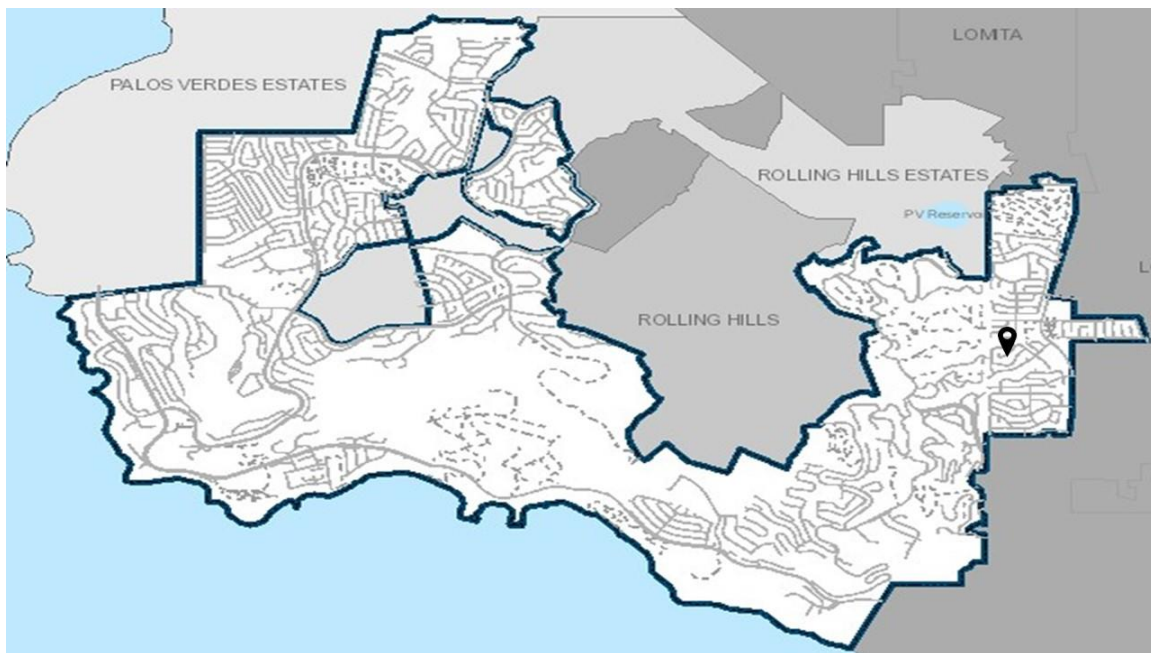

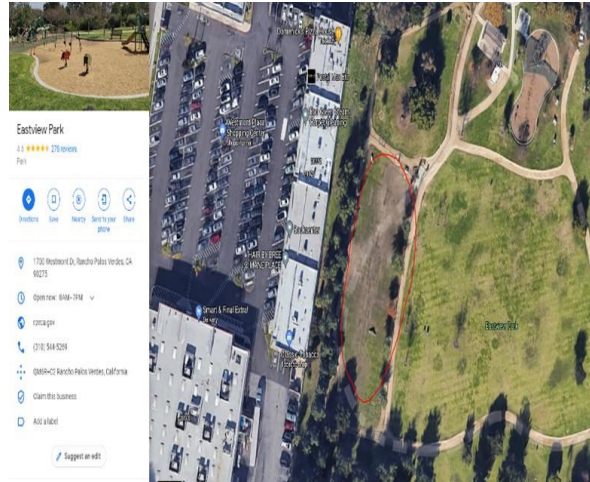


In addition to regularly scheduled maintenance and repairs, Public Works performed the following:



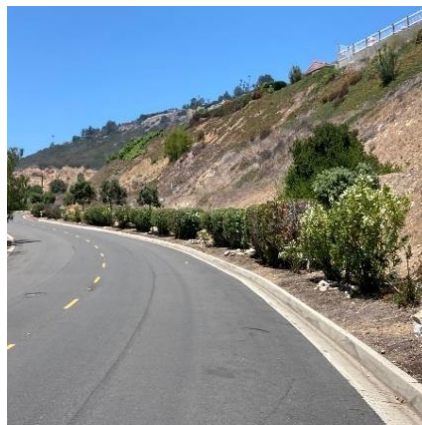
- Public Works continues daily cleaning and sanitizing parks' facilities and restrooms to reduce the spread of COVID.
- At Eastview Dog Park, the Public Works Department will begin hydroseeding the large dog park this week. The dog park will be closed during this process, which is expected to last for approximately eight weeks. An alternative temporary dog park will be created this week to be used while the seed takes growth.





### Street Median and Public Right of Way Landscape Maintenance

- The City completed cleaning and de-weeding the medians and right-of-way along Palos Verdes Drive West from the City limits of Palos Verdes Estates to Hawthorne Boulevard.
- The team also completed de-weeding on Forrestal Drive from Palos Verdes Drive South to Ladera Linda Park.
- The right of way team is continuing its work along the Palos Verdes Drive South median from Forrestal Drive to Schooner Drive.
- The median crew completed work along three secondary arterial medians this week which include, Highridge Road and Whitley Collins Drive from Crest Road to Highridge Road.
- This week, preventative weed spraying continues throughout the City right of ways, including Hawthorne Boulevard, Forrestal Drive, and Palos Verdes Drive South.

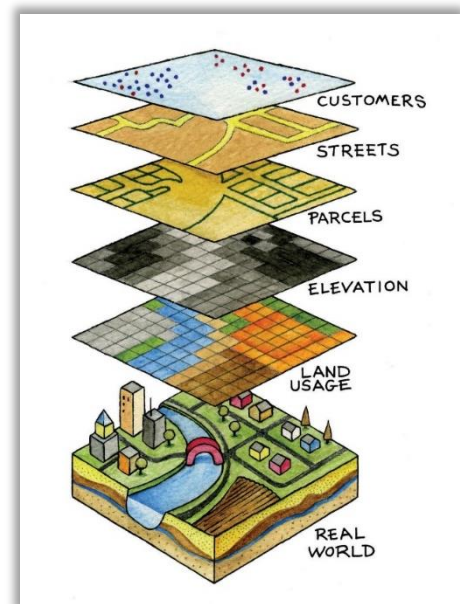

### ParkMobile Parking App Update

On July 6, the City of Rancho Palos Verdes launched an online parking reservation system for Del Cerro Park and the popular Portuguese Bend Reserve. Visitors can now use the ParkMobile website or mobile app to reserve parking spaces on Crenshaw Boulevard south of Crest Road and Park Place, near the Rattlesnake and Burma Road Trailheads. A total of 225 reservations were made July 6-11. Staff will continue to report on total reservations and other data points each week.

The system is being implemented to manage parking and improve traffic flow in the Del Cerro Park area. Staff is working closely with ParkMobile personnel to fine-tune the system and respond to all user concerns and issues.

### Parking with ParkMobile

- ParkMobile reservations are now required for all 60 spaces on Crenshaw Boulevard south of Crest Road and Park Place.
- Reservations must be made by 11:59 p.m. the night before your visit.
- Visitors will not be able to park and then reserve their spot.
- Reservations will be limited to blocks of two hours and 45 minutes from 7:00 a.m. to an hour after sunset (shorter or longer blocks of time will not be available when the system launches).
- Reservations will be free of charge until August 2, when parking will be \$10 per reservation block and can be paid using ParkMobile. After that, an additional \$0.35 processing fee will apply.
- Parking will be free from 7:00 a.m. to 8:45 a.m. on weekdays.
- Fifteen (15) spaces on Park Place adjacent to Del Cerro Park remain available to those who hold a Residential Recreational Parking Permit at this time. Permit holders will need to reserve these spaces (in Zone A) using ParkMobile. Two

additional ADA spaces on Park Place do not require Residential Recreational Parking Permits but will require ParkMobile reservations.

- Street parking on Crenshaw Boulevard north of Crest Road will remain free and will not require reservations.

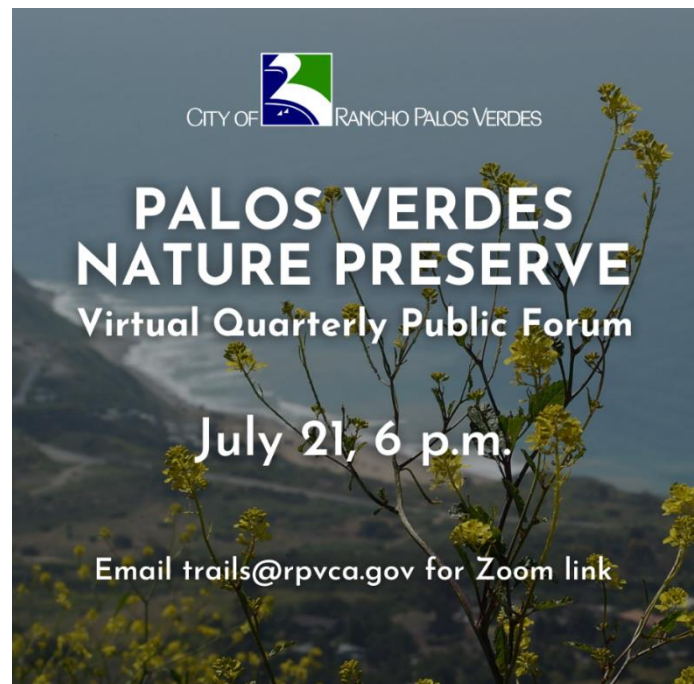

### **Abalone Cove Reserve**

From June 5 to July 11, the following Marine Protected Area (MPA) contacts, all from Abalone Cove, were made:

- Ranger/OSM contacts with MPA violators: 0
- Estimated number of animals prevented from being poached: 0
- Individuals deterred from poaching: 1 fisherman

These numbers reflect when staff is able to make contact with the public while on patrols. Public contact is dependent on tides which contribute to an increase or decrease of activity in the Marine Protected Area.

An irrigation leak occurred on July 12 along Beach School Trail, resulting in run-off water. Staff coordinated with the Palos Verdes Peninsula Land Conservancy to shut off the water main while inspections took place.



On Saturday, July 10, the new class of Junior Lifeguards visited Abalone Cove Reserve for hands-on training and learned about water safety and rescues.

On Tuesday, July 13, “Authorized Vehicles Only” signs were installed throughout the various access points in Abalone Cove.



## **Forrestal Reserve**

On July 5, Rangers spoke with four individuals who were using sparklers at the basketball courts in Ladera Linda Park, adjacent to the Reserve. The group complied when informed they were not allowed.

An “Authorized Vehicles” only sign was installed on Saturday, July 10, at the entrance to Forrestal Drive.

## **Ocean Trails Reserve**

As a result of a landslide within Ocean Trails Reserve, the Coastal Switchback Trail and adjacent beach area are closed and will remain closed for the foreseeable future until the City Geologists determines otherwise. Several switchbacks within the trail are impassable, several posts and cables have fallen, and the trailhead from the beach is no longer visible due to the landslide.





## Portuguese Bend Reserve

On Saturday, July 3, 2021, the Los Angeles County Sheriff Department received a call at 6:20 a.m. that a vehicle had crashed into the gate on Burma Road. Temporary barriers have been secured in place to deter unauthorized vehicle entry. Preserve hours are still enforced. The City is assessing repairs and will continue to provide updates regarding the status and installation of the gate.



Rangers received a report of a transient at Del Cerro Park. Los Angeles County Sheriff Department was notified to check on the welfare of the individual.

During routine patrols, Rangers identified two holes on Burma Road, one measuring approximately two (2) feet deep. OSM staff filled in the hole and will continue to monitor the area.



## San Ramon Reserve

The Volunteer Trail Crew identified and removed several recently installed bike jumps on Switchback Trail. Bike jumps, berms, and other similar structures are not allowed in the Palos Verdes Nature Preserve. Unauthorized jumps, and berms, may pose a safety hazard for all users, not simply bicyclists, and can change the slope, cause erosion, or result in habitat damage. The City is working with the Palos Verdes Land Conservancy in cataloging all such instances in the Preserve.



## Parks and Trails Open


Beaches, parks, and trails, including the Palos Verdes Nature Preserve, are open. In accordance with the L.A. County and State of California Health Officer Orders, private, informal, outdoor gatherings outdoors are permitted. Organized events and indoor gatherings are not permitted at this time. L.A. County continues to urge everyone, especially those who are not or cannot be vaccinated against COVID-19 to exercise caution and good judgment as physical distancing requirements and capacity limitations are lifted. In addition, all individuals must follow the requirements in the Guidance for the Use of Face Coverings issued by the California Department of Public Health.

When participating in gatherings or activities, all park rules must be followed and attendance at informal gatherings cannot exceed thresholds in the Special Event Permits ordinance.
