Legislation Corner: SB 9 and SB 10 Updates

SB 9 (Atkins), which would allow developers to build up to four housing units on a single parcel in residential neighborhoods traditionally zoned for single-family homes, passed the Assembly Appropriations Committee and may be heard on the Assembly Floor as early as Thursday, August 26. The City of Rancho Palos Verdes reissued a letter of opposition ahead of the Assembly vote (see attachments). Additionally, the League of California Cities is preparing a coalition letter of opposition on behalf of every City that has opposed SB 9 – the City of Rancho Palos Verdes has joined this coalition letter, which will be made available once released.



SB 10 (Wiener), which would allow cities to upzone by ordinance for up to 10 units in a transit-rich corridor, passed the Assembly Floor and will be heard on the Senate Floor. The City Council has opposed SB 10.

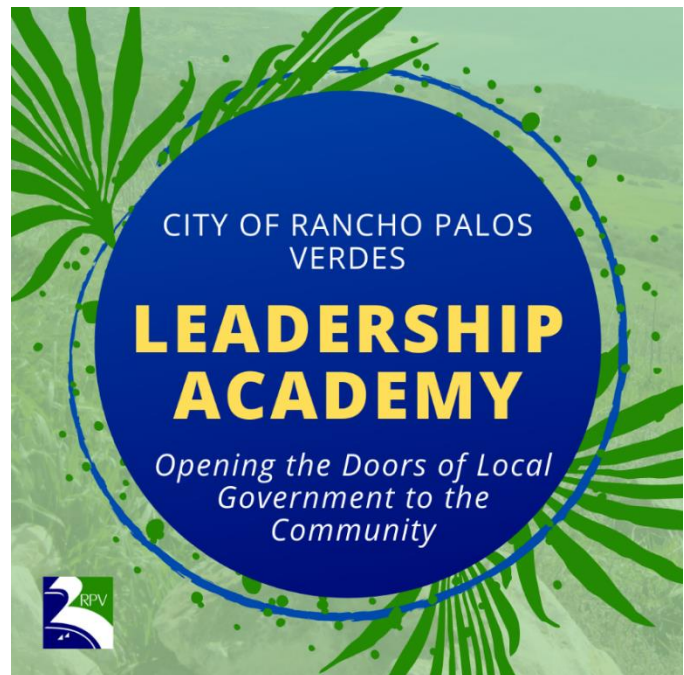

Update on Proposed Temporary Maritime Tower at Point Vicente

Earlier this week, Staff met with representatives from U.S. Customs and Border Protection (CBP) to discuss a proposal to install a relocatable remote surveillance system maritime (RSS-M) tower on federally-owned land near the Point Vicente Lighthouse for six months to one year to detect and track illegal border activities.

The City raised concerns in July with the 30- to 80-foot-tall tower's visual impacts, requested that all opportunities for screening and/or camouflaging be explored, and sought clarity on the height needed for CPB's mission, given the range provided. Staff also requested co-locating the RSS-M tower on the existing Coast Guard towers at the Civic Center property.

Since then, Staff has met with CBP Staff several times regarding the location and use of the temporary tower. CBP has indicated that at the proposed Point Vicente location, the agency would only be interested in erecting the tower at the maximum height of 80 feet. On August 24, Staff and CBP representatives toured alternative locations, including the City maintenance yard at the Civic Center and a 4-acre Coast Guard property overlooking the Point Vicente Lighthouse, which is the site of several communications towers and an abandoned WWII-era artillery bunker.

CBP will next conduct a feasibility analysis to consider these alternative sites, including height ranges. Staff will continue to monitor this issue.

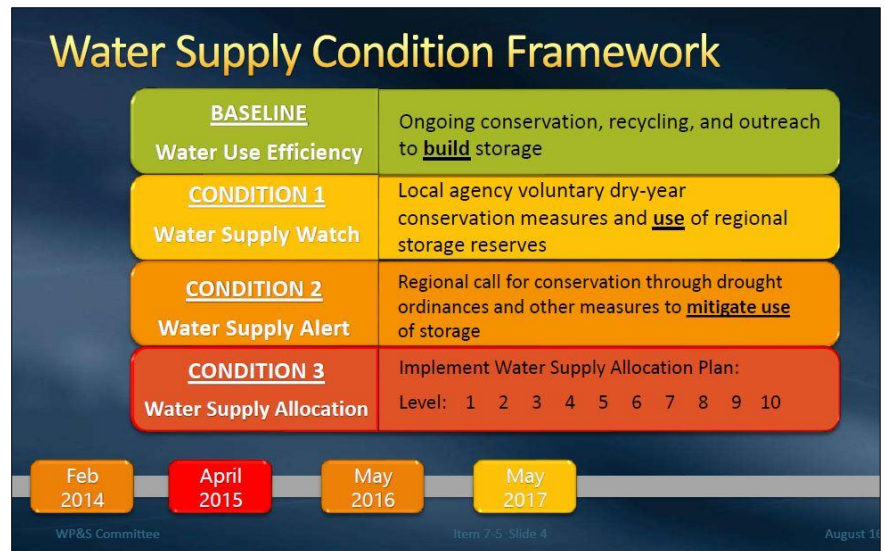

Metropolitan Water District Declares Water Supply Alert in Response to Severe Drought

Last week, in response to the extreme drought conditions impacting Southern California, the Metropolitan Water District's Board of Directors declared a Water Supply Alert, calling for consumers and businesses to voluntarily reduce their water use and help preserve the region's storage reserves.



The board's action urges residents, businesses and agencies in Metropolitan's 5,200 square-mile service area to lower the region's water demand to stave off more severe actions in the future, which could include restricting water supplies to Metropolitan's 26 member agencies. The declaration comes a day after the Bureau of Reclamation declared a first-ever shortage on the Colorado River, typically providing about 25 percent of Southern California's water needs.

A Water Supply Alert is the third of four conditions in Metropolitan's framework indicating the urgency of Southern California's need to save water. The action calls for water agencies to reduce their water demand through public awareness campaigns and adopt measures tailored to their own local conditions.

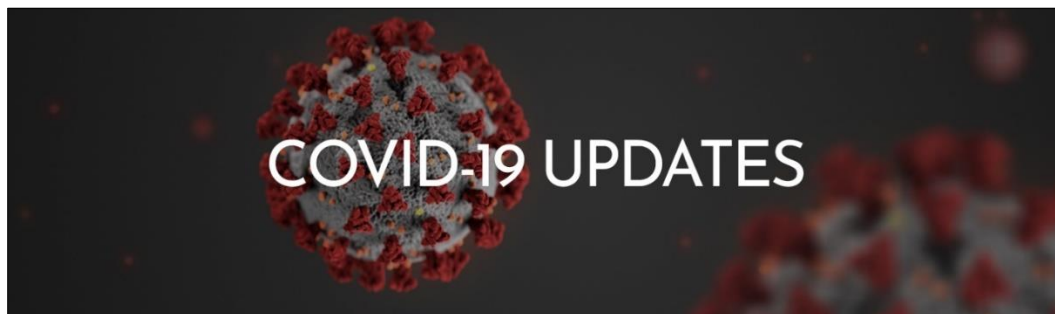

FDA Approves License for Pfizer-BioNTech COVID-19 Vaccine

Earlier this week, the U.S. Food and Drug Administration (FDA) approved the license for the Pfizer-BioNTech COVID-19 vaccine for the prevention of COVID-19 disease in individuals 16 years of age and older. The Pfizer COVID-19 vaccine continues to be available under emergency use authorization (EUA) for those 12 through 15 years old and for the third dose in certain immunocompromised individuals. The licensing approval was made after another thorough evaluation of safety and effectiveness data by a panel of scientific and medical experts. FDA-approved vaccines undergo the agency's standard process for reviewing the quality, safety, and effectiveness of medical products.

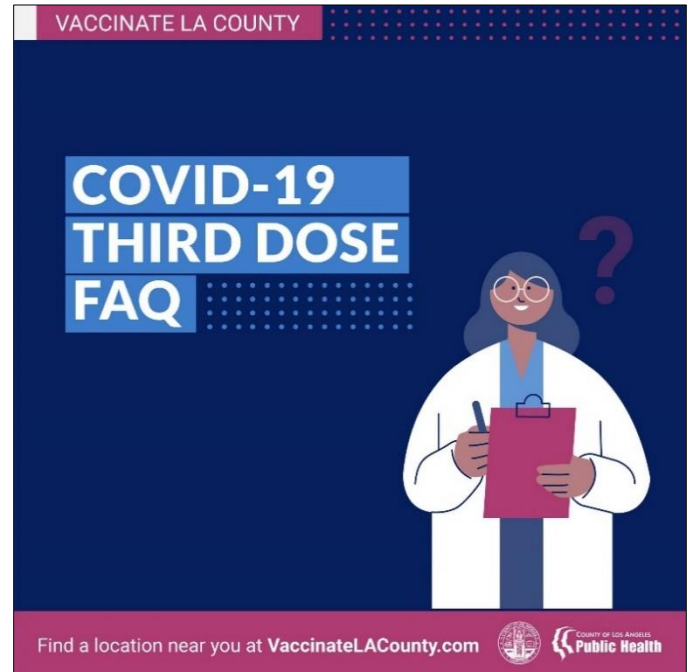
What You Need to Know About Third Doses and Booster Shots

The difference between third doses and booster doses is more than just a language issue. Third doses are meant to elicit an antibody response where there was an inadequate antibody response before, while booster doses are meant to increase antibody levels that have waned after a robust increase in the months after vaccination.

With emerging data indicating that certain populations will need more support to be protected, the CDC's Advisory Committee on Immunization Practices on August 13 recommended a third dose of mRNA vaccines for immunocompromised people, including transplant recipients, people with advanced or untreated HIV infection, people actively receiving cancer treatment, and people taking immunosuppressive medications. Third doses have been available to eligible individuals at vaccination sites across L.A. County since August 14.

Additionally, following last week's announcement by the CDC that booster doses of mRNA vaccines will be offered to all vaccinated people, the county continues to work with staff and residents at skilled nursing facilities to prioritize these most vulnerable residents for booster doses so we are prepared to administer these as soon as the Food and Drug Administration gives their approval.

California to Require Proof of Vaccination for Indoor Events with 1,000+ Attendees

Last week, the California Department of Public Health (CDPH) strengthened requirements already in effect for mega events in the [Beyond the Blueprint Framework](#), announcing that proof of vaccination, or a negative COVID-19 test within 72 hours before an event starts, will be required starting September 20 for indoor gatherings where 1,000 or more participants or spectators are attending. Currently, verification of being vaccinated or a pre-entry negative test is necessary where there are 5,000 or more persons for an indoor event.

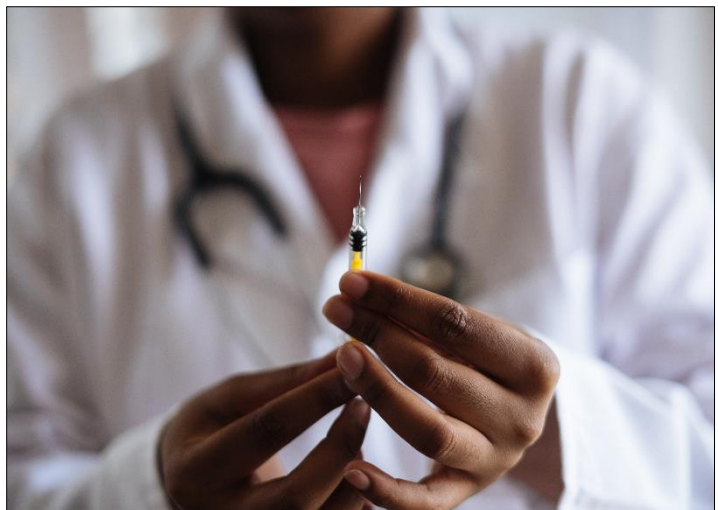


Beyond dropping the requirement from 5,000 to 1,000 individuals, self-attestation to verify a person's vaccination status will no longer be accepted. The aforementioned changes will remain in place until November 1, 2021.

Allocation of Personal Protective Equipment (PPE) Supplies by Area G Disaster Management Area Coordinator (DMAC)

On August 20, 2021, the City received an allocation of personal protective equipment (PPE) purchased with statewide grant funding secured by the Los Angeles Area G Disaster Management Area Coordinator (DMAC) Jeff Robinson. With the assistance of the Area G DMAC and State officials, City staff coordinated the receipt of **1,060 N95 masks, 6,300 KN95 masks, 6,350 surgical masks, and 18 gallons of Gel Hand Sanitizers.**

These supplies will significantly aid the City in replenishing its inventory of personal protective equipment (PPE). The supplied personal protective equipment has been securely stored on City property and will be used solely to prevent the spread of COVID-19. The City is greatly appreciative of the cooperation of local and state officials in ensuring the safety of our employees and the residents they serve.

SCE CONCURRENT EMERGENCY RESPONSE SYSTEM

SCE uses the California Standardized Emergency Management System (SEMS) and the Federal National Incident Management System. Emergency events are managed using the Incident Command System through an Emergency Operations Center (or virtual EOC as required).

Depending on the circumstances, one or multiple Incident Management Teams may be activated. For more complex incidents, including concurrent emergencies, an Incident Support Team may be activated to manage the totality of the incident including prioritization and resource allocation. The IST will direct all aspects of communications and outreach including coordination with external agencies and first responders.



SCE Concurrent Emergency Response System - Virtual Meeting

Southern California Edison (SCE) has recently invited City Staff to participate in a virtual meeting to address the possibility of concurrent emergencies, including fires, arising during PSPS events. For example, during potentially dangerous weather conditions in fire-prone areas, SCE may need to call for a Public Safety Power Shutoff (PSPS) event. SCE will proactively turn off power in high fire risk areas reduce the threat of wildfires. A Concurrent Emergency is when a PSPS de-energization event overlaps with a secondary emergency event such as a wildfire or extreme weather-related events.

SCE currently manages emergencies through their Emergency Operations Center (EOC), which utilizes the California Standardized Emergency Management System (SEMS) and the Federal National Incident Management System (NIMS). Depending on the circumstances surrounding a PSPS Event, SCE may activate one or more Incident Management Teams. For more complex incidents, such as simultaneous emergencies, an Incident Support Team may be activated to manage the incident holistically, including setting priorities and allocating resources.

On August 26 and 27, SCE will host two workshops to discuss these types of situations and preview the upcoming weather conditions and fire season to provide additional information and solicit input from public safety partners. The workshops are intended for emergency response personnel, including first responders, public works directors, and personnel responsible for emergency management. City staff will have the opportunity to ask questions and participate in a feedback session throughout the virtual meeting to gain a better understanding of how the City can collaborate with Southern California Edison to strengthen the City's emergency planning and resiliency efforts.

Public Meeting on Utility Safety Practices

In keeping with their shared commitment to safety and transparency, the California Public Utilities Commission (CPUC) and the Office of Energy Safety Infrastructure (Energy Safety) invited San Diego Gas & Electric (SDG&E) and Southern California Edison (SCE) to present updates on their electric safety efforts during a Public Meeting on Utility Safety Practices which took place this morning August 25, 2021, from 10:00 a.m. to 12:30 p.m.

At the meeting which staff attended, members of both utilities' boards of directors briefed the CPUC, Energy Safety, and the public on SDG&E and SCE's electric safety

initiatives, which include wildfire prevention measures and infrastructure safety concerns. These utilities specifically provided an overview of their risk analysis and mitigation planning efforts, as well as an assessment of their safety cultures, safety metrics, and current policies and rules aimed at improving safety performance.

Members of the public were additionally invited to participate in this meeting by voicing their concerns about these utilities during the public comments section at the bottom of the agenda.

The CPUC enforces regulations to ensure that power plants and utility companies operate a safe and dependable electrical system. The CPUC's Safety and Enforcement Division (SED) conducts audits and inspections, investigates safety incidents or system problems, imposes fines, monitors corrective actions, and advises the CPUC on related issues. The Office of Energy Safety Infrastructure (Energy Safety) evaluates electrical corporations' Wildfire Mitigation Plans, conducts annual wildfire-specific safety culture assessments, issues utility safety certifications, and evaluates executive compensation structures. Field inspections, audits, and a review of utility compliance and Independent Evaluator reports are all used to ensure compliance by Energy Safety.

California Department of Insurance - Policyholder Evacuation Checklist

Evacuations and road closures are becoming more common as fire activity increases. Natural disasters frequently strike in the blink of an eye, making it critical to plan ahead and take the necessary precautions to ensure that you and your family are completely

prepared. Wildfires can have a significant financial and emotional impact, making it difficult for people to rebuild their lives in the aftermath of a disaster or other emergency. Access to personal financial, insurance, medical, and other records is critical during these trying times for quickly and efficiently initiating the recovery process. Individuals can take specific, effective steps to reduce the economic devastation and life-threatening risks associated with major disasters.

As wildfires threaten Californians once again, the California Department of Insurance (CDI) has compiled an Evacuation Checklist for Policyholders. The following are some Department of Insurance tips for consumers facing evacuation:

If you are evacuating:

- Follow all evacuation orders from local authorities.
- If time allows, locate your insurance policy documents and upload them to the cloud using your mobile device.
- If time allows, make a photo or video inventory of your possessions. An inventory can be completed quickly and easily on your smartphone and safely stored in the Cloud. Download the free [home inventory guide](#) from the department's Web site.

After you evacuate:

- Homeowner and renter policies can help with evacuation and recovery expenses under *additional living expense* coverage, known as ALE. ALE coverage typically includes extra food and housing costs, furniture rental, relocation and storage, and transportation expenses.
 - The California Department of Insurance (CDI) urges evacuees to contact their insurers to verify their ALE coverage provision and limits and learn about the requirements and impact of using the coverage.
 - If financial losses due to a mandatory evacuation are significant, filing an ALE claim may be a good option for some policyholders. If so, it is critical to keep all receipts and document the date, time, and names of any insurance company employees you speak to regarding your coverage and details of the conversation.
- Policy provisions, including deductibles, vary by company; residents should check with their insurer or agent as soon as possible to confirm coverage, limits, and any other limitations and documentation requirements.
- Consumers should make sure any insurance agent or public adjuster offering their services has a valid license by checking online with the [Department of Insurance](#). Public adjusters cannot solicit business for seven calendar days after the disaster.

The California Department of Insurance's (CDI) Office of the Ombudsman is available to assist residents in resolving issues with their insurance companies. 
EMERGENCY PREPAREDNESS TIPS

Equine Emergency Preparedness

Living and owning horses in Southern California has its special challenges, particularly where emergency preparedness is concerned. It is every horse owner's responsibility to have an emergency plan in place. You are the one that can plan to keep your horses safe, either by early evacuation or ensuring they can be safely sheltered in place.

Here are some important tips to follow to keep your horse safe:

- **Plan now for Emergency Sheltering for your horses:** Be sure everyone involved with your horse knows the plan and include the address and driving directions in your emergency kit.
- **Become involved with your neighborhood network:** During a disaster, we all need to help each other. Neighbors can work together to help the horse owners on their street who do not have a horse trailer.
- **Make a list of emergency contacts: emergency shelter, vet, family contacts, etc.** - Keep this information on all your smart devices as well as in your emergency kit.
- **Take photographs and prepare a written description of each horse:** Keep one in a safe place with you and another set in your emergency kit.
- **Have a halter and rope readily available for each horse:** Make sure halters are marked/engraved with your contact information. Keep duct tape available so you can write information on it if needed. Include your name, number, address with an alternate contact number. If your horse has special needs or medical issues, record the information on a luggage tag and attach it to the halter.



HORSES AND LARGE ANIMALS

Emergency preparedness is important for all animals, but preparedness for horses and large animals is especially important because of their size and special transportation needs.

Horses should be evacuated as soon as an EVACUATION WARNING is issued. Do not wait for the EVACUATION ORDER. If you are unprepared or wait until the last minute, you may need to leave your animals behind. Consider these tips as you prepare your evacuation plan:

ANIMAL EVACUATION PLAN

- Before the emergency, make arrangements to shelter your animals at two different locations far apart from each other.
- If you have large animals, evacuate when you hear the EVACUATION WARNING.
- Train horses to load and trailer so that they become comfortable with the process.
- Keep your truck and trailer in safe, working condition (gas tank full). If you don't have a truck and trailer, make arrangements in advance to have someone evacuate your animals.
- Know who is evacuating your animals. Be sure to exchange phone numbers, California Drivers License numbers and other relevant information with the person evacuating your horse. Know where your animals will be taken.
- Network with your neighbors prior to an emergency. Work together to help horse/pet owners on your street who do not have horse trailers or who are not home during an emergency.

TIP Mount fire extinguishers near barn entrances and around stables for easy access in the event of a barn fire. Store hay outside the barn in a dry covered area when possible.

HAVE A PLAN

The County of Los Angeles Department of Animal Care & Control has an Emergency Response Program that includes animal control officers and volunteers trained to deal with small and large animals during an emergency. The Emergency Response Program has specially trained and equipped teams including the Animal Rescue Field Support, Equine Response Team (ERT), and Department Animal Rescue Team (DART).

- **Microchip your horse:** This is an easy, inexpensive way to help identify your animals.
- **Have a minimal 3-day supply of feed and water per horse:** This is particularly important if you plan to shelter in place, but you should also bring feed (and buckets!) in the instance you need to evacuate. Make sure to include all medications your horse may need and label all of your equipment.
- **Teach your horse how to trailer:** Spend time loading and unloading your horses so they are safe and willing to load in the need of an evacuation.
- **Keep trucks, trailers, and vans well-maintained and ready to move:** Keep your gas tank full, particularly during Red Flag Warning days.

Build an Emergency Preparedness Kit for your horse:

- Leads, Halters, Shanks
- 3-Day supply of feed/water/meds
- Portable radio with extra batteries
- Buckets for feed/water
- Emergency contact list/Horse ID photos
- Flashlights
- Cell phone with charger
- First Aid kit
- Leg wraps
- Blanket or sheets
- Hoof pick
- Tarps
- Sharp knife
- Shovel
- Water hose
- Duct tape
- Wire cutters

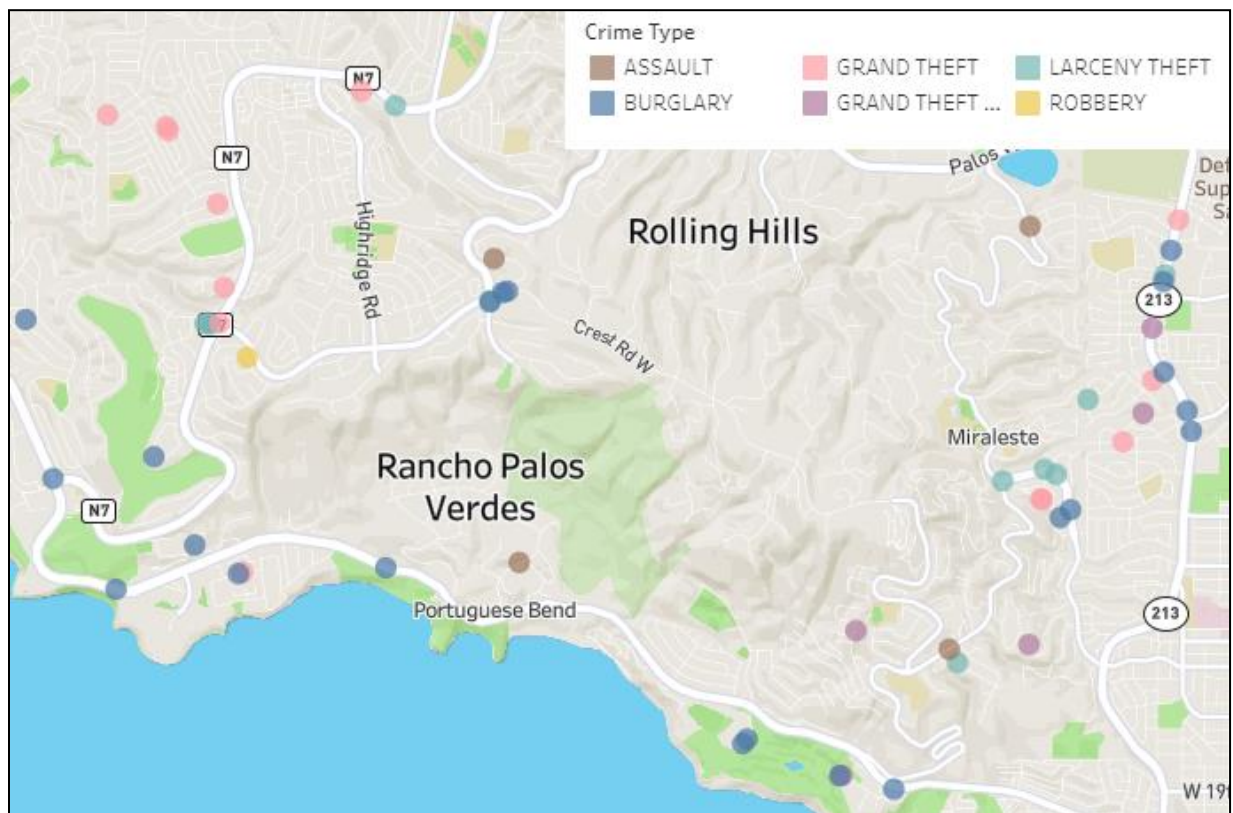

Distracted Driving is Dangerous Driving

Distracted driving is any activity that diverts attention from driving, including talking on the phone or texting, fiddling with the stereo or navigation system, eating and drinking, or talking to people in your vehicle.

Taking your eyes off the road for 5 seconds at 55mph is like driving the length of an entire football field with your eyes closed. You cannot drive safely unless the task of driving has your full attention. Any non-driving activity you engage in is a potential distraction and increases your risk of crashing.

Hands-Free Does Not Mean Distraction Free

Your vehicle may be equipped with various technologies, such as allowing you to talk on the phone or play music from an electronic device in hands-free mode. However, hands free does not necessarily mean distraction free – it is important to remain aware of the road and avoid distractions.

With any technology in your vehicle, ensure you learn about its functions and how to properly use it without adding distractions to your driving experience.

Just because you can respond to a text hands-free doesn't necessarily mean you should: driving safely should be your top priority and any hands-free devices that cause a distraction can wait until you are safely parked.

FINANCE DEPARTMENT

Statewide Sales Tax Trends

The Finance Department works with several outside consultants and analysts to monitor trends related to the City's revenue sources. HdL provides a quarterly look at sales tax trends by sector. Below you will find insights and projections for two sectors.

U.S. Real GDP Growth

FY20-21: Projected 12.9% growth

FY21-22: Projected 6.0% growth

With many states doing away with the last vestiges of the pandemic lockdown, the U.S. economy is now near the top of the "V" shape recovery that we predicted last year. The transition from online back to the real world has led to pockets of supply and demand misalignment leading to shortages and sharp price increases in certain markets such as lumber and used auto sales. These distortions should moderate in 2022 as the labor market recovers. Rebounding consumer spending and government stimulus measures will continue to filter through the economy powering a strong recovery, albeit with higher levels of inflation, through 2022.

CA Median Existing Home Price

FY20-21: \$591,026

FY21-22: \$657,404

California is once again near the front of the pack of a nationwide housing boom. Home sales have surged as homeowners look to cash in on their new-found wealth. In some markets, such as Southern California, single-family home prices have risen by 20% from April of last year. This trend should continue into next year, but concerns remain over the sustainability of these stratospheric price rises, especially as an increasingly hawkish U.S. Federal Reserve considers drawing down monetary stimulus in late 2022 or early 2023.

FAC Meeting

On August 24, 2021, the Finance Advisory Committee (FAC) of the City of Rancho Palos Verdes met to discuss the new financing option opportunities for the Ladera Linda Community Center and Park Project and the preliminary spending plan for the American Rescue Plan Act (ARPA) Fund. Both items will be continued to the September 9, 2021 meeting. The full agenda for the September 9, 2021, will be available at least 72 hours before the meeting date.



Ladera Linda Community Center and Park Project

On May 18, 2021, the City Council approved the FAC's recommendation for the financing options for the Ladera Linda Community Center and Park Project and directed staff to proceed with filing the necessary application with iBank. In late May, Staff began the prequalification process with iBank, and on August 20, the City received the invitation to apply for the loan.

In July, a private bank contacted the City expressing interest in assisting the City finance the Ladera Linda Community Center and Park Project. After a brief discussion with the bank, the bank could not offer a better rate than iBank. Subsequently, Staff took this opportunity and reached out to the City's operating bank company and requested for a financing program information that can be offered to the City. Once the new financing information was received, Staff prepared a summary of the proposal which was then presented to FAC for review and consideration.

American Rescue Plan Act (ARPA) Fund

At the same meeting, the FAC also received a status report on the ARPA, including eligibility requirements and the framework in developing the preliminary spending plan for the City's allocation of \$9.9 million.

The preliminary spending plan was developed by City management by setting the following framework based on the Department of Treasury's guidelines and local government agencies' guiding principles in spending ARPA funds:

- Consider eligible projects that directly provide services or aid to citizens, maintenance or pay-go funded building of infrastructure, modernization of cybersecurity, including hardware, software, and protection of critical infrastructure.
- Higher priority on projects with one-time costs and deferred maintenance that are normally supported by the General Fund.
- Higher priority on capital projects. The Capital Improvement Fund (CIP) is the most affected fund from the economic downturn due to the reduced transfers from the revenue loss in Transient Occupancy Taxes. Hence, it would be prudent and consistent with eligibility requirements to allocate ARPA funding for the City's capital infrastructure projects. The framework for choosing capital projects are as follows:
 - Consider deferred citywide projects.
 - Consider unfunded or partially funded projects in the adopted FY 2021-22 Five-Year Capital Improvement Program. These projects have been approved by the Infrastructure Management Advisory Committee and adopted during the budget process by the City Council.
 - Projects with high degree of confidence that funds will be spent by December 31, 2026.

Undergrounding Along Palos Verdes Drive South - Update

Last week, overhead utility cables that fell in the San Ramon Reserve were restored and secured on the poles. These cables are part of the infrastructure that will be removed once connections to the new underground cables along Palos Verdes Drive South are made. City staff is working with associated utility companies to confirm the schedule for those connections, which are likely to be made in early September. Once those connections are made, the overhead wires will be scheduled to be removed. After this occurs, the removal of the utility poles along Palos Verdes Drive South, from La Rotonda Drive to the eastern City limit, will be scheduled. As reported in the past, three poles will remain (for the time being) to accommodate a power line, wireless telecommunication facilities, and the City's Automated License Plate Recognition (ALPR) camera.

City of PVE Street Improvement Project Along Via Campesina

City of Palos Verdes Estates has begun their Street Improvement Project along Via Campesina from Via La Cuesta to Paseo del Campo. This work affects residents of over forty Rancho Palos Verdes properties, who use Via Campesina as the main access to their homes. This project involves, but is not limited to storm drain inlet modification, asphalt overlay, localized pavement repairs, and pavement markings. The proposed schedule of the project is from Monday, August 16 – October 1, between the hours of **7:00 a.m. to 4:00 p.m.** Monday through Friday. Access to driveways will be maintained except during repairs and concrete pouring operations when access may be limited. In which case, you will be notified 72 hours prior to the access restriction. Access entering or exiting driveways may also be limited while paving operations is taking place. During

this operation, there will be brief delays. On trash days, place your trash cans on top of the curb instead. Please contact Alan DeWitt (Public Works Inspector for City of Palos Verdes Estates) for questions or comments at 909-240-9918. Please see the attachment.

Los Angeles County Cities Sustainability Summit

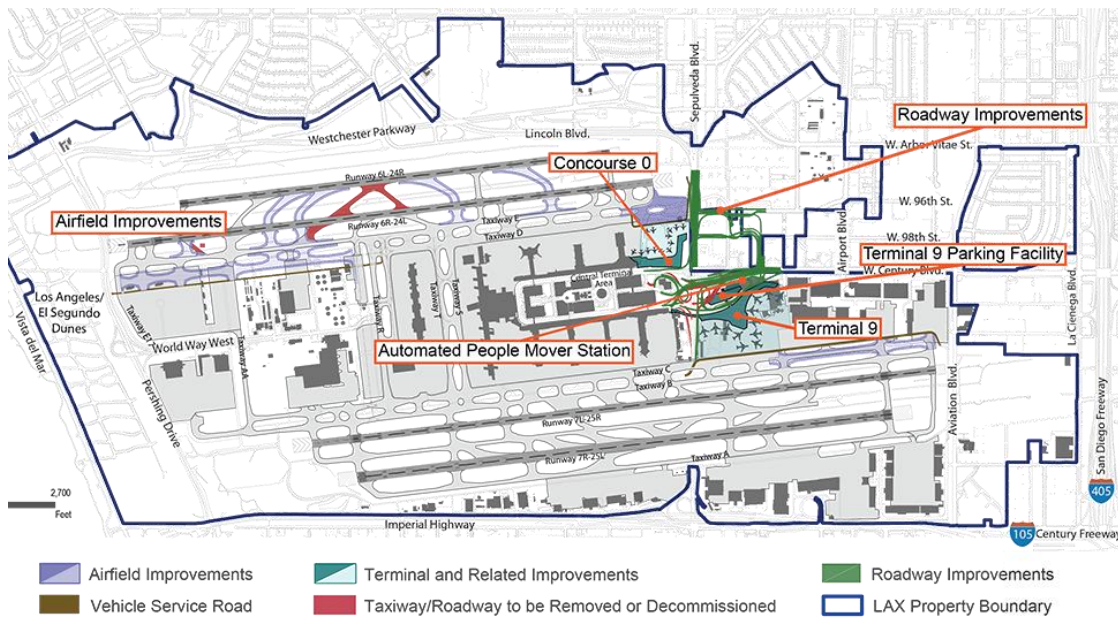

LAX Airfield & Terminal Modernization Project Final Environmental Impact Report (EIR)

The Los Angeles World Airports (LAWA) has released a Final EIR for the LAX modernization project. As previously reported, the Project proposes to construct a new aerial roadway, a new concourse next to Terminal 1, and a new terminal (Terminal 9) with improvements to the North Airfield, as outlined in the aerial map below:



The City of Rancho Palos Verdes previously submitted a comment letter (Attached) on the Draft Environmental Impact Report (DEIR), which centered on regional aircraft noise/pollution impacts and the projected increase in passenger trips from LAX without dispersing air traffic to other airports. In accordance with the California Environmental Quality Act (CEQA), the Final EIR includes all public comments on the Draft EIR and LAWA's responses to those public comments (see www.lawa.org/ATMP under "Documents"). The Final EIR considers the City's concerns and provides responses to those concerns. On September 14, 2021, at 10:00 a.m., LAWA's Board of Airport Commissioners is scheduled to consider certification of the Final EIR and related actions at a Special Meeting. 2020 Preserve Annual Report

The 2020 Annual Report for the Rancho Palos Verdes Natural Communities Conservation Plan/Habitat Conservation Plan (NCCP/HCP) is scheduled for the September 7, 2021, City Council Meeting. The Annual Report was released for public review on August 15. This report was sent out through the Preserve listserv group and can be found on the City's Preserve webpage, under the NCCP/HCP PUMP menu item. It is linked below:

The Annual Report fulfills annual submittal requirements by the Palos Verdes Peninsula Land Conservancy and the City of Rancho Palos Verdes for the Palos Verdes Nature Preserve. In addition, it serves to evaluate the implementation of the NCCP/HCP during the preceding year and the adequacy of the overall progress being made toward reaching the conservation goals of the NCCP/HCP. Annual submittal requirements are:

- Gains/losses to habitat within the plan Area
- A list of all covered activities performed and project review process
- Impacts of public uses and recommendations, if necessary, for minimizing impacts to the Preserve
- A summary of night-time use of the Preserve
- All contributions toward the preservation of habitat lands
- Description of the management of invasive plant species
- Documentation of the habitat restoration efforts to enhance and restore native plant communities and the results of biological monitoring
- Annual evaluation of management activities, enforcement activities, funding needs, and ability to accomplish resource management goals
- A separate fiscal report prepared jointly by the City and PVPLC
- A summary of clerical changes made to the plan, including corrections to maps or exhibits, and changes made to the survey monitoring, or reporting protocols

Additionally, this report details stewardship activities, research, funding, enforcement reports, trail counter data, and community involvement in the Preserve during the period January 1 through December 31, 2020.

ParkMobile Parking App Update

On July 6, the City of Rancho Palos Verdes launched an online parking reservation system for Del Cerro Park and the popular Portuguese Bend Reserve. Visitors can now use the ParkMobile website or mobile app to reserve parking spaces on Crenshaw Boulevard south of Crest Road and Park Place, near the Rattlesnake and Burma Road Trailheads. A total of 131 reservations were made between August 16-August 22: 48 paid reservations, 46 resident reservations, and 37 free reservations on weekdays from 7:00 a.m. to 8:45 a.m.

Staff will continue to report on total reservations and other data points each week.

The system is being implemented to manage parking and improve traffic flow in the Del Cerro Park area. Staff is working closely with ParkMobile personnel to fine-tune the system and respond to all user concerns and issues. An update on the program will be presented to the City Council on October 5.

Parking with ParkMobile

- **Update:** Starting the week of August 2, reservations were no longer free of charge. Reservations are now \$10 per reservation block and can be paid using ParkMobile. An additional \$0.35 processing fee will apply to all paid reservations.
- ParkMobile reservations are now required for all 58 spaces on Crenshaw Boulevard south of Crest Road and Park Place.
- Reservations must be made by 11:59 p.m., the night before your visit.
- Visitors are not able to park and then reserve their spot.
- Reservations are limited to blocks of two hours and 45 minutes from 7:00 a.m. to an hour after sunset. Shorter or longer blocks are not available at this time.
- Parking is free from 7:00 a.m. to 8:45 a.m. on weekdays.
- Fifteen spaces on Park Place adjacent to Del Cerro Park remain available to those who hold a Residential Recreational Parking Permit at this time. Permit holders will need to reserve these spaces (in Zone A) using ParkMobile.
- The two ADA parking spaces on Park Place no longer require Residential Recreational Parking Permits or ParkMobile reservations. They are available on a first-come-first served availability basis for any visitor with a valid ADA parking placard. This reduces the total number of reservable spaces from 60 to 58.
- Street parking on Crenshaw Boulevard north of Crest Road is free and does not require reservations.

On August 19, Los Angeles County Sheriff Department was called after a patron was seen in his vehicle inhaling an unknown substance, resulting in loss of consciousness. The individual was taken to the hospital, and their vehicle was towed.



On August 22, Lifeguards observed an individual walking away with two Preserve signs: “Falling Rock” and “No Animals on the Beach.” It is not known whether the individuals removed the signs from their posts or simply found them. The individual refused to comply when asked to leave the signs. Rangers were called and were able to confiscate the signs from the individual.

Forrestal Reserve/Adjacent Properties

Rangers continue to educate patrons on permitted and approved use of Ladera Linda fields located on PVPUSD property during this reporting period. Three dog walkers and two patrons were advised to use the field at Ladera Linda Park for casual soccer play or to use existing trails within the Forrestal Reserve to access the trail system.

On August 20, OSM staff removed two (2) metal posts within the trailbed. The posts were no longer used and were removed to eliminate potential safety hazards.

Ocean Trails Reserve

Trail closures in Ocean Trails Reserve remain in effect, including the Coastal Switchback Trail and adjacent beach area. In addition, the nearby bridge along Catalina Trail and Lakeview Trail is also closed due to land movement. Geologists continue to inspect this area weekly to monitor additional movement and will be providing recommendations to staff for trail reroutes.



Parks and Trails Open

Beaches, parks, and trails, including the Palos Verdes Nature Preserve, are open. In accordance with the L.A. County and State of California Health Officer Orders, private, informal, outdoor gatherings outdoors are permitted. L.A. County continues to urge everyone, especially those who are not or cannot be vaccinated against COVID-19, to exercise caution and good judgment as physical distancing requirements and capacity limitations have lifted. In addition, all individuals must follow the requirements in the Guidance for the Use of Face Coverings issued by the L.A. County Department of Public Health.

When participating in gatherings or activities, all park rules must be followed, and attendance at informal gatherings cannot exceed thresholds in the Special Event Permits ordinance.

Dear Speaker Rendon,

The City of Rancho Palos Verdes writes to express our continued opposition to SB 9 (Atkins). SB 9 would require cities and counties to ministerially approve, without conditions or discretion, a housing development containing two residential units on an individual parcel in single-family zones and lot splits, creating two independent lots that may be sold separately.

Housing affordability and homelessness are among the most critical issues facing California cities. Affordably priced homes are out of reach for many people and housing is not being built fast enough to meet the current or projected needs of people living in the state. Cities lay the groundwork for housing production by planning and zoning new projects in their communities based on extensive public input and engagement, state housing laws, and the needs of the building industry.

While the City of Rancho Palos Verdes appreciates President pro Tempore Atkins' desire to pursue a housing production proposal, as currently drafted, SB 9 will not spur much-needed housing construction in a manner that supports local flexibility, decision making, and community input. Nor does SB 9 establish provisions for affordability. State-driven ministerial or by-right housing approval processes fail to recognize the extensive public engagement associated with developing and adopting zoning ordinances and housing elements that are certified by the California Department of Housing and Community Development.

Furthermore, the City of Rancho Palos Verdes primarily resides in a Cal Fire-designated Very High Fire Hazard Severity Zone. Due to topography and large amount of dedicated open space, egress is limited. In the event of a wildfire, quickly and safely evacuating the existing population would pose a significant challenge. Increased density as contemplated under SB 9 would exacerbate this problem and could result in the significant loss of life and property.



The City of Palos Verdes Estates has contracted All American Asphalt for the Via Campesina Street Improvements City Project No. PW-674-19 on Via Campesina from Via La Cuesta to Paseo Del Campo. This project involves, but is not limited to, cold milling existing AC pavement, Asphalt Rubber Hot Mix (ARHM) overlay, AC berm, localized pavement repairs and pavement marking and striping.

This work will be performed between the dates of 8-16-21 and anticipated completion of 10-1-21. Normal working hours will be between the hours of 7:00 A.M. and 4:00 P.M. Monday through Friday.

Access to driveways will be maintained except during repairs and concrete pouring operations when access may be limited. In which case you will be notified 72 hours prior to access restriction. Access entering or exiting driveways may also be limited while paving operation is taking place. During this operation there will be brief delays.

SUBJECT: Comments to the Draft Environmental Impact Report for the LAX Airfield & Terminal Modernization Project

Dear Ms. Quintanilla,

Thank you for the opportunity to comment on the Draft Environmental Impact Report (DEIR). The City of Rancho Palos Verdes, herein the City, is a quiet coastal town on the Palos Verdes Peninsula, approximately 11 miles south of the Los Angeles International Airport (LAX), but near eastbound aircraft pathways departing from LAX. In review of the DEIR for the LAX Airfield & Terminal Modernization Project (ATMP), the City wishes to express the primary concern that the ATMP will result in an increase in aircraft noise pollution caused by eastbound passenger jets overflying the airspace above the Palos Verdes Peninsula.

As you may know, this community and the rest of the Palos Verdes Peninsula has a long history of expressing concerns to Los Angeles World Airports (LAWA) and the Federal Aviation Administration (FAA) regarding noise impacts associated with departing passenger aircraft from LAX. The City is an active participant on the LAX Roundtable and has made exhaustive requests to the FAA to curb passenger jet aircrafts being vectored by FAA air traffic controllers (ATC) over the Peninsula. Despite these repeated requests to simply adhere to the approved flight paths, the Peninsula continues to suffer from noisy passenger jet overflights originating from LAX.

General Comments

1. In general, the City is concerned that the ATMP will induce more passenger flights departing from LAX, thus, increasing the likelihood that air traffic controllers will "cut the corner" and improperly and against FAA procedures (OSHNN8), vector additional aircraft at low altitudes over the Palos Verdes Peninsula's airspace. This has been, and continues to be an issue, additional flight will only exacerbate the issue and increase its likelihood.
2. The City also shares the concerns that have been expressed in separate correspondence by partner cities and the South Bay Cities Council of Governments (SBCCOG). We share the concern that LAWA needs to prioritize efforts to disperse

air traffic to their other regional airports. Without a coordinated plan to disperse infrastructure improvements to other local airports, LAX is guaranteed to see an accelerated growth of air traffic activity. This increase in air traffic activity will inevitably result in noisy air traffic near and over the Peninsula, increased traffic congestion, additional local air pollution concentrations and other negative unintended consequences.

Specific Comments

1. In reference to Section 2.3.1.2, the City questions the DEIR's projected air traffic passenger growth data, since the LAWA's study was done prior to the outset of the COVID-19 pandemic. LAWA should reconsider the projected growth in light of changes to pandemic-induced passenger travel behavior and reconsider the projected growth at other airports and those airports' ability to handle the projected growth.
2. In reference to Section 4.4, the City encourages LAWA to consider expanding the scope of study for greenhouse gas emissions based on projected aircraft departures from LAX under known aircraft dispersal patterns. Specifically, air pollutants should be studied, which are emitted from passenger jets vectored over the Palos Verdes Peninsula. The toxic air contaminants of concern should be studied over exposed populations based on the quantity and altitudes of passenger jet with Peninsula overflights. LAWA should consider a range of mitigation measures available to lessen passenger jet air pollution over Peninsula residents, including effective communication with TRACON air traffic controllers to vector passenger jets over the ocean east of the HOLTZ waypoint.
3. Specific to Section 4.7.1 of the DEIR and only specific to the construction phase of the project, the City is concerned that the proposed improvements to Runway 6L-24R will cause significant aircraft departure delays and disruptions. Disrupted and inefficient aircraft movement on the ground has the potential of causing FAA departure controllers to rush departures, resulting in congested air traffic between LAX and the Peninsula. We have witnessed that congested air traffic increases the likelihood of vectoring aircraft from the published offshore flight path (OSHNN8) towards the Peninsula because of the FAA's requirement to maintain aircraft separation for safety purposes or because of the pressure placed on air traffic controllers to make up time for departure delays. In addition, given the projected length of the proposed runway construction from 2021 to 2025 and due to the length of runway closures occurring in 4.5-month duration periods, the City is especially concerned that these runway closures may result in disturbing aircraft noise impacts to the community for lengthy periods of time.
4. Section 4.7.1.5.1.1 of the DEIR does not adequately address the foreseen airspace congestion impacts attributed to temporary airfield construction described above nor does the DEIR adequately address or provide mitigation measures for aircraft noise impacts to communities, such as the City of Rancho Palos Verdes, outside of LAWA's Noise Exposure Map. Although the City is not adjacent to LAX, where the Noise Exposure Map illustrates elevated noise disturbances, the City considers

itself a noise-sensitive community due to the low ambient noise levels enjoyed by its visitors and residents.

5. In reference to Section 4.8 of the DEIR, the City, along with the SBCCOG, believes that the DEIR does not adequately evaluate impacts to motorists coming from the South Bay. Although CEQA may not require it, LAWA should not use the Vehicle Miles Traveled standard to avoid responsibility for the increased congestion on the critical thoroughfares that will directly result from this large airport expansion. The City encourages LAWA to work with stakeholders such as the SBCCOG, LA Metro, Caltrans, and surrounding cities who have been working together to identify freeway improvements and can do so again to address off site roadway mitigation improvements necessitated by this project. Even though LAWA may have restrictions by the FAA on paying for these off-facility improvements, the impacts to these facilities occur, nonetheless. For example, it may prove beneficial for LAWA to work with other implementing agencies to address the Century Boulevard exit on the northbound I-405 to allow motorists to head west on Century Boulevard without the need for a traffic signal.
6. In reference to Section 4.8.3.2.1 of the DEIR, the City supports LAWA's proposal to eliminate permanent access from Sepulveda Boulevard to Terminal 9. However, we share the same traffic concerns as that of the SBCCOG about opening the new Terminal 9 before the aerial roadway system is complete. We also believe that temporary access from Sepulveda Boulevard is unwise. There will already be access to Terminal 9 via Century Boulevard and the new Jet Way street, which are not dependent on the construction of the aerial roadway and they should alleviate the need for temporary access from Sepulveda Boulevard, particularly given the burden it will cause on the traffic traveling through the tunnel. We urge you to commit to eliminating any access from Sepulveda Boulevard at any time to Terminal 9. Temporary access is costly and unsafe as you have already recognized by eliminating the permanent access from Sepulveda Boulevard. If a third means of access to Terminal 9 is deemed necessary, then we would ask that you delay the opening of Terminal 9 until the aerial roadway system is completed.


The City supports the concept of continued evolution and a more efficient, modernized LAX. However, it is difficult to support the ATMP without first addressing some of the current vexing issues, such as FAA improper routing of low flying aircraft, local air space congestion, and environmental sustainability. We must have confidence that LAWA is effectively communicating aircraft noise concerns to the FAA and the two agencies are working together to solve this ongoing issue. The City expects LAWA to champion the concerns of those communities affected by aircraft noise pollution and use their resources to influence the FAA, particularly the FAA's air traffic controllers, to adopt more enforceable, reliable, meaningful and measurable aircraft noise mitigation measures than those described in DEIR.

We appreciate your attention to the City's concerns as LAWA finalizes the environmental review. We hope the provided comments, as well as those comments from affected communities, will translate into implementing amicable measures that will mitigate project related impacts to those affected communities, including the City of Rancho Palos Verdes.
