

Legislation Corner: Bills Awaiting Governor's Signature or Veto

The State Legislature's session ended on September 10, 2021, passing hundreds of bills to the Governor's desk. The Governor has until October 10 to sign or veto the bills.

The City Council took a position on the following bills, which have been passed by the Legislature. The City is issuing letters to the Governor encouraging his signing or vetoing bills, in alignment with the Council's position:

- AB 215 would authorize the California Department of Housing and Community Development (HCD) to appoint or contract with other counsel if the Attorney General declines to represent HCD in a lawsuit against a city. The City Council opposed this bill.
- AB 339 would allow cities to have call-in and internet public participation at all City Council meetings and issues requirements for cities with populations greater than 250,000. The City Council supported this bill.
- AJR 2 issues a formal request from the state to the US Congress and the US Environmental Protection Agency (EPA) to take all measures necessary to prevent further damage to California's citizens, wildlife, and natural resources by the DDT waste dumped in the waters near Santa Catalina Island. The City Council supported this bill.
- SB 9 would require ministerial approval of lot splits and duplexes on single-family zoning, quadrupling the number of housing units. The City Council opposed this bill. **A coalition letter from the League of California Cities and 241 cities, including Rancho Palos Verdes, was sent to the Governor requesting his veto of the bill (see attachments).**
- SB 10 would allow cities to upzone by ordinance in transit-rich and urban infill sites. The City Council opposed this bill.
- SB 63 makes multiple changes in state law in relation to the California Department of Forestry and Fire Prevention (CAL FIRE), including expanding the area where fire safety building standards apply. The City Council opposed this bill.
- SB 556 would require cities to make street light poles, traffic signal poles, utility poles, and support structures available to telecommunications providers. The City Council opposed this bill.

Delta Variant Accounts for All Samples Sequenced in L.A. County

The Delta variant now accounts for 100% of the COVID-19 strains seen among sequenced samples in the Los Angeles County. This variant is more infectious and more efficiently transmitted between people compared with earlier COVID-19 strains. While emerging data affirms that fully vaccinated people are well protected from severe infections with Delta variants, it now is clear that fully vaccinated people can become infected, and if infected with Delta, can infect others.

As a result of reanalyzing many samples with an updated version of the genetic library used to identify variants, a lab that performs much of the variant sequencing reclassified many older specimens as Mu or Lambda variants, resulting in an increase in the total number of these variants reported linked to L.A. County residents. To date, 232 cases linked to Mu variants and 28 cases linked to Lambda variants have been identified. Most of those specimens were collected earlier in the summer.

Remember Safety While Driving with Pets

As a member of the family, we take our pets everywhere! Whether it's going on a much needed vacation, driving them to an area park to run and play, or maybe, it's a quick trip to the veterinarian for a check-up – some furry passengers just love to ride! But traveling in automobiles can be extremely dangerous for your family companion – and you.

Loose pets inside of vehicles can become a deadly distraction for drivers. Moreover, unrestrained pets can become hazards themselves during an accident. Without proper restraint, a simple joyride with your four-legged friend could result in harsh consequences for everyone.

Follow these important tips from the RPV Emergency Preparedness Committee and the American Humane Society to help keep you, your best friend, and others safe and happy on your next trip:

- **Never leave pets unattended inside of vehicles:** Remember that cars heat up fast – even with the windows cracked!
- **Microchip and identify your pet:** Update your microchip registration and pet license information to ensure its current and consider including the name and phone number of an emergency contact.
- **Start with shorter journeys and build up:** To avoid unnecessary stress and anxiety, work your pet up to longer trips by taking shorter treks before taking on a long expedition.
- **Keep your pets restrained:** Properly restrain, contain or crate your pets inside of your vehicle prior to your trip. Consider purchasing a specially designed pet seatbelt, carrier or barrier to avoid irreversible consequences due to distractions or other mishaps.
- **Never put a pet in the front seat:** Pets should not be permitted to ride in the front seat or on your lap, as they may be injured by airbags in the event of an accident. Pets, like children, are most secure in the back seat.
- **Never allow pets to stick any portion of their bodies out the window:** Although most dogs love to stick their heads out open windows, the wind can seriously irritate mucous membranes and blow pieces of grit or other debris into their eyes. Pets could also be seriously injured by objects as you drive down the road.
- **Pets should never be transported in the bed of a pickup truck:** Not only could this injure or kill your pet, this could also cause an accident which may harm someone else. Do not leave your pet inside of a truck bed even when parked to avoid strangulation hazards and because open truck beds do not provide any protection from the weather. A dog left sitting in the broiling sun without water or shade may suffer from heat stroke.

Keeping pets safe is every pet owner's responsibility. Being a safe driver is not only your obligation – it's the law!

Extreme Heat Safety Tips

Extreme heat is a period of high heat and humidity with temperatures above 90 degrees for at least two to three days. In extreme heat, your body works extra hard to maintain a normal temperature, which can lead to death. In fact, extreme heat is responsible for the highest number of annual deaths among all weather-related hazards.

When experiencing hot temperatures, it's important to remember to: **Stay cool, Stay hydrated and Stay informed.**

STAY COOL:

- **Wear Appropriate Clothing:** Choose lightweight, light-colored, loose-fitting clothing.
- **Stay Cool Indoors:** Stay in an air-conditioned place as much as possible. If your home does not have air conditioning, go to a shopping mall or public library—



even a few hours spent in air conditioning can help your body stay cooler when you go back into the heat.

- **Schedule Outdoor Activities Carefully:** Try to limit your outdoor activity to when it's coolest, like morning and evening hours. Rest often in shady areas so that your body has a chance to recover.
- **Pace Yourself:** Cut down on exercise during the heat. If you're not accustomed to working or exercising in a hot environment, start slowly and pick up the pace gradually. If exertion in the heat makes your heart pound and leaves you gasping for breath, STOP all activity. Get into a cool area or into the shade, and rest, especially if you become lightheaded, confused, weak, or faint.
- **Do Not Leave Children in Cars:** Cars can quickly heat up to dangerous temperatures, even with a window cracked open. While anyone left in a parked car is at risk, children are especially at risk of getting a heat stroke or dying. When traveling with children, remember to do the following:
 - Never leave infants, children, or pets in a parked car, even if the windows are cracked open.
 - To remind yourself that a child is in the car, keep a stuffed animal in the car seat. When the child is buckled in, place the stuffed animal in the front with the driver.
 - When leaving your car, check to be sure everyone is out of the car. Do not overlook any children who have fallen asleep in the car.

STAY HYDRATED:

- **Drink Plenty of Fluids:** Drink more fluids, regardless of how active you are. Don't wait until you're thirsty to drink.
- **Stay away from very sugary or alcoholic drinks**—these actually cause you to lose more body fluid. Also avoid very cold drinks, because they can cause stomach cramps.
- **Replace Salt and Minerals:** Heavy sweating removes salt and minerals from the body that need to be replaced. A sports drink can replace the salt and minerals you lose in sweat.
- **Keep Your Pets Hydrated:** Provide plenty of freshwater for your pets, and leave the water in a shady area.

STAY INFORMED:

- **Check for Updates:** Check your local news for extreme heat alerts and safety tips and learn about any cooling shelters in your area.
- **Know the Signs:** Learn the signs and symptoms of heat-related illnesses and how to treat them.

- **HEAT CRAMPS**

- **Signs:** Muscle pains or spasms in the stomach, arms or legs
- **Actions:** Go to a cooler location. Remove excess clothing. Take sips of cool sports drinks with salt and sugar. Get medical help if cramps last more than an hour.

- **HEAT EXHAUSTION**

- **Signs:** Heavy sweating, paleness, muscle cramps, tiredness, weakness, dizziness, headache, fainting, nausea, vomiting, Fainting.
- **Actions:** stop physical activity, move to an air-conditioned place, and lie down. Loosen or remove clothing. Take a cool bath. Take sips of cool sports drinks with salt and sugar. Get medical help if symptoms get worse or last more than an hour.

- **HEAT STROKE**

- **Signs:** Extremely high body temperature (above 103 degrees) taken orally, Red, hot and dry skin with no sweat, Rapid, strong pulse, dizziness, confusion, or unconsciousness
- **Actions:** Call 9-1-1 or get the person to a hospital immediately. Cool down with whatever methods are available until medical help arrives.

- **Monitor Those at High Risk:** Although anyone at any time can suffer from heat-related illness, some people are at greater risk than others:

- Infants and young children
- People 65 years of age or older
- People who are overweight
- People who overexert during work or exercise
- People who are physically ill, especially with heart disease or high blood pressure, or who take certain medications, such as for depression, insomnia, or poor circulation




From August 29-September 4, there were eleven reported crimes in the City of Rancho Palos Verdes: four vehicle burglaries, three residential burglaries, two petty thefts, and two grand thefts.

Tips to Prevent Vehicle Burglaries

Take steps today to prevent thefts from your vehicle. Residents are strongly encouraged to use "Lock It or Lose It" prevention tips every day. It only takes a matter of seconds for a thief to break into your car and grab your valuable items.

Look through the windows of your vehicle. What do you see? A bag on the passenger seat? A charging cord? A garage door opener? Change in a cup holder? Take it with you or remove it from plain view and be sure to close all windows and lock doors.



Follow these tips to help prevent vehicle burglaries:

1. Remove all valuable items from your car, including purses and electronics.
2. If you must leave valuables behind, put them in your trunk or locked glovebox before you reach your destination. Avoid doing so while in plain view.
3. Close all windows and lock your doors.
4. Park in a locked garage or well-lit areas.

If you see suspicious activity, report it immediately to the Lomita Sheriff's Station at 310-539-1661. In case of emergency, call 9-1-1.

Vacation Security Tips

While planning and going on a vacation, consider these tips to help enhance your safety, and secure the safety of your property:


- Avoid posting about your vacation on social media – doing so may alert thieves that your home is vacant.
- Have friends or neighbors clear your newspapers and mail if you leave town, or temporarily suspend deliveries.
- Ask trusted neighbors to keep an eye on your home and report any suspicious activity to the Sheriff's Department.
- Set lights on a timer, so your home looks occupied.
- When on vacation, know the locations of local law enforcement stations and phone numbers.
- Agree on a rendezvous point with members of your party in the event you get separated.
- Share your itinerary with friends and family.

Be aware. If you see something suspicious, contact the local law enforcement agency immediately or 9-1-1 in an emergency.

Neighborhood Security Cameras Update

Since 2016, the City has offered a number of grant programs to assist neighborhoods in acquiring security cameras. By the end of this week, 24 City-subsidized cameras will have been installed in neighborhoods across RPV. Fourteen of these cameras have been installed in the last year.

Public Safety is a top priority of the City Council. Additional funds for continued security camera subsidies have been appropriated by the City Council, and a new grant program will be released in the coming months. Interested in a reimbursement to help purchase a security camera for your neighborhood entrance or a doorbell security camera? Email mbright@rpvca.gov to receive an email when program details are available, and applications have been released.

In addition to neighborhood-owned security cameras, there are 25 automatic license plate reading (ALPR) cameras owned by the Peninsula cities at all major entrances and exits on the Peninsula. The City of RPV additionally owns 17 ALPR cameras at strategic locations along Western Avenue. The information from these ALPR cameras is sent directly to the Lomita Sheriff's Station and the Palos Verdes Estates Police Department.

Fiscal Health of California Cities Report Fiscal Year 2019-2020



The California State Auditor's Fiscal Health Analysis Report is now available for FY 2019-2020. The report ranks fiscally challenged cities in California from highest to lowest risk (where #1 is the worst).

Based on the FY 2019-2020 report, out of the 423 cities included, the City of Rancho Palos Verdes ranked number 385 for overall risk. The City scored 91.23 out of 100 points, as a result, designated as low risk for financial distress. The points awarded encompass the city's ability to pay for short-term and long-term services. Compared to the report last year, the City improved its ranking score by almost 2 points from a score of 89.47, mainly from an improvement of the City's general fund reserves. The City's overall ranking position went down from 390 to 385, but this is due to the smaller number of cities included in the FY 2019-2020 report (prior year included 471 cities).

The following is a more detailed discussion of the report.

Report Overview

In October 2019, the California State Auditor launched a new program to identify local government agencies that are at high risk for the potential of waste, fraud, abuse, or mismanagement, or that have major challenges associated with their economy, efficiency, or effectiveness. The first element of the program is producing an interactive dashboard tool ranking of California cities that could be facing fiscal challenges. The second element of the program is to conduct audits for the cities designated as high risk.

Methodology for Ranking California Cities

The California State Auditor analyzed and assessed the FY 2019-2020 audited financials of all cities included in the report. Afterward, the cities ranked as either high, moderate, or low risk for fiscal distress. The financial indicators used for ranking and the City's awarded points are noted below.

Peninsula Cities Results

Overall, the City of Rancho Palos Verdes ranked second with the lowest risk compared

to the neighboring Peninsula cities. The City of Rolling Hills scored slightly higher than the City of Rancho Palos Verdes, mainly due to the difference in size of operations (lower liabilities). The overall comparison of the neighboring cities are as follows:

City of Rancho Palos Verdes Results

The City of Rancho Palos Verdes ranked number 385 for overall risk. Of the ten financial indicators, the City ranked low risk for seven indicators, including general fund reserves, debt burden, liquidity, pension obligations, pension costs, post-employment benefits obligations, and other post-employment benefits funding.

For the revenue indicator category, the City is designated as high risk. To improve the score in this category, the City's revenues must increase rather than decrease over the last few years. On average, the City's revenues have decreased by 2 percent over the last few years, and specifically, in FY 2019-2020, the revenues were impacted by the COVID-19 pandemic.

For the remaining two financial indicators, the City is designated as moderate risk for pension funding and future pension costs. These indicators are mainly tied to the City's accrued pension liabilities. At the end of FY 2019-2020, the City's funded status is 74% of its accrued liabilities. The funded status is similar to the neighboring Peninsula cities of 71%-84%. As part of the City Council goals in FY 2020-2021, the City Council adopted a pension guideline addressing a financial plan on the City's pension liability, which may increase this score in the future.

Overall, at the end of FY 2019-2020, the City of Rancho Palos Verdes' ranking indicates that the City's overall financial position is relatively strong. This is attributed to the City's long history of conservative fiscal policies, prudent spending, and stable property tax revenues. Lastly, the ranking also confirms the City's low risk for the potential of waste, fraud, abuse, or mismanagement.

Ladera Linda Park and Community Center


On September 7, the City Council awarded a contract to Griffin Structures to provide project and construction management services for the Ladera Linda Park and Community Center project. Griffin Structures will provide general management for the project; including quality assurance reviews of construction documents, value engineering, budget and schedule management, and City representation with the construction contractor and architect/engineer.

At this time, the project schedule anticipates breaking ground around March 2022. Between now and then, the focus will be on completing construction drawings, completing the bid process, and awarding a construction contract.

The Griffin Structures contract will be funded by federal funding received through the American Rescue Plan Act (ARPA).

Undergrounding Along Palos Verdes Drive South

On September 13, Southern California Edison's contractor removed the poles along Palos Verdes Drive South, from La Rotonda Drive to the eastern city limit, with the exception of three poles that need to remain to support needed infrastructure. One pole is for connection of power lines up the hill from Palos Verdes Drive South, a second pole for a cell site, and a third pole is utilized for a City Automated License Plate Recognition camera. Staff is investigating if a City camera on one of the poles can be relocated to reduce the number of remaining poles from three to two. The removal of the poles completes the undergrounding project in this area, replacing overhead utility wires and cables with new underground infrastructure.



New Traffic Signal at Intersection of Palos Verdes Drive South and Palos Verdes Drive East

Work continues this week for site preparation, including utility locations, and digging for signal pole foundations for the new traffic signal to be installed at the intersection of Palos Verdes Drive South and Palos Verdes Drive East. This new signal was approved by the City Council in 2019. Work will take place through the end of December from approximately 8:30 a.m. to 4:30 p.m. Monday through Friday, with regular partial eastbound and westbound bike lane closures around the intersection. Expect delays, proceed cautiously through the work zone, and follow all signs and instructions.



Next Paper/Document Shredding Event

The next paper/document shredding event is scheduled for Saturday, October 23, from 8 a.m. to 11 a.m. at City Hall/Civic Center in the overflow parking lot. More details on this event will be provided in the coming weeks.



Prepare for the Citywide Brush Clearing

The autumn season brush-clearing event begins on Saturday, October 2, and will continue for four consecutive Saturdays. Each week a different area of RPV is serviced. The goal of the event is to assist homeowners' dispose (free of charge) of excess brush, shrubs, hedges, tree branches, and bushes to comply with the Los Angeles County Fire Department's fire safety guidelines. This is a great opportunity to help prevent local brush fires! Mixed-Use Overlay Zoning District Status Update



Mixed-Use Overlay Zoning District in the City's commercial, and some institutional zoning districts, is one of the various strategies that the City is exploring to accommodate the 6th Cycle Regional Housing Needs Assessment (RHNA) allocation as part of the Housing Element Update and to foster economic development along Western Avenue.

It is anticipated that the full scope of services will be completed in March 2023, which will include opportunities for public engagement through community workshops and public hearings. 

Board of Airport Commissioners Approve LAX Airfield and Terminal Modernization Project

On September 14, 2021, staff attended a virtual public meeting hosted by the Los Angeles World Airports (LAWA). The Board of Airport Commissioners (BAC) heard public testimony concerning LAWA's proposal to certify the Final Environmental Impact Report (FEIR) and approve the Los Angeles International Airport (LAX) Airfield and Terminal Modernization Project (ATMP). As previously reported, the ATMP at LAX will involve the construction of a new aerial roadway, a new concourse next to Terminal 1, and a new terminal (Terminal 9) with improvements to the North Airfield as outlined in the aerial map below.



As part of the ATMP environmental assessment review, the City expressed a primary concern that LAWA did not conduct an aircraft noise assessment on the Palos Verdes Peninsula and that the ATMP will cause an increase in aircraft overflights. As cited in the Final EIR, LAWA dismissed these concerns because aircraft noise assessments and

mitigation measures are confined to noise-producing aircraft heard in communities closest to the airport. Furthermore, LAWA asserts that any aircraft noise and overflights that occur across distant communities, such as Rancho Palos Verdes, is within the purview of the Federal Aviation Administration (FAA) and not LAWA, an entity of the City of Los Angeles, which is mainly concerned with airport ground operations and facilities.

After hearing public testimony, the BAC voted to reconvene at their next meeting on October 7. Staff will provide additional updates as more information becomes available.

LAX Community Noise Roundtable Meeting

The LAX Community Noise Roundtable held a public meeting on Wednesday, September 15, 2021. The meeting addressed noise concerns caused by passenger jets arriving and departing from LAX. The meeting agenda is attached [here](#). The Roundtable also received a report from the LAX Metroplex/Wide Area Ad Hoc Committee concerning the arrival flightpath and received a briefing on the FAA Noise Complaint Portal. Plans are underway to unveil a memorial honoring the Gabrieleño/Tongva San Gabriel Band of Mission Indians—the “First Peoples of the Los Angeles Basin.” This project dates back to 2016 when Tom Steers first approached the City with the idea for a memorial. Tom has coordinated the funding of this project with private donations. The City is very excited to educate the public about the Gabrieleño/Tongva Native Americans and the important role they have played in the history of Southern California, specifically Rancho Palos Verdes. Gabrieleño/Tongva descendants have been closely involved in the design and artwork for the monument plaques to ensure their historical accuracy and appropriateness. The City is very appreciative of professional sculptor Geri Jimenez Gould for creating such a remarkable piece of artwork.

A monument unveiling event is scheduled for October 16 from 10 a.m. to 12 p.m. Chief Anthony 'Red Blood' Morales and tribal members will participate with blessings and songs in their regalia. Additional details will be forthcoming.



National Forests in California Closed September 1-17

All national forests are closed in California, effective September 1 through at least September 17, due to wildfire risk and limited resources for firefighting throughout the state. Open Space Management and Park Ranger Staff are aware and will be monitoring to see if these closures lead to an observable increase in usage in the Palos Verdes Nature Preserve and open space areas. Playground Equipment Surface Replacement Project

Replacement of the playground equipment surfaces at City Parks began on September 8. This project involves the removal of existing sand, resealing of the hard surface, and the addition of engineered wood fiber at the playground equipment areas at Fred Hesse Jr. Community Park, Robert E. Ryan Community Park, and Eastview Park. Work at Hesse Park and Ryan Park began on September 8 and is scheduled to end on September 20. Work at Eastview is scheduled to begin on September 20 and end on September 24. The contractor will provide a physical barrier between the construction zone and the other open areas of the parks. Ladera Linda Park's playground was originally included in this project but was removed due to the Ladera Linda project scheduled for early 2022.

ParkMobile Parking App Update

On July 6, the City of Rancho Palos Verdes launched an online parking reservation system for Del Cerro Park and the popular Portuguese Bend Reserve. Visitors can now use the ParkMobile website or mobile app to reserve parking spaces on Crenshaw Boulevard south of Crest Road and Park Place, near the Rattlesnake and Burma Road Trailheads. A total of 141 reservations were made between September 6- 12: 69 paid reservations, 36 resident reservations, and 36 free reservations on weekdays from 7:00 a.m. to 8:45 a.m.

Staff will continue to report on total reservations and other data points each week.

The system is being implemented to manage parking and improve traffic flow in the Del Cerro Park area. Staff is working closely with ParkMobile personnel to fine-tune the system and respond to all user concerns and issues. An update on the program will be presented to the City Council on October 5.

Parking with ParkMobile

- **Update:** The ParkMobile reservation system is now in effect.
- Those with Residential Parking Permits should park in zone A and always display their parking permit on the bottom left side of the vehicle windshield. (If you are a city resident, obtain your Permit through Rancho Palos Verdes Public Works Department)
- Zone A Residential Permit holders park for free and will be given an access code that will allow for reservations in Zone A. For assistance with obtaining your code, please email preserveparking@rpvca.gov

- Residential Parking Permit holders should refrain from parking in other locations unless a reservation has been made and paid for in a different zone.

- Reservations are now \$10 per reservation block and can be paid using ParkMobile. An additional \$0.35 processing fee will apply to all paid reservations.
- ParkMobile reservations are now required for all 58 spaces on Crenshaw Boulevard south of Crest Road and Park Place.
- Reservations must be made by 11:59 p.m. the night before your visit.
- Visitors are not able to park and then reserve their spot.
- Reservations are limited to blocks of two hours and 45 minutes from 7:00 a.m. to an hour after sunset. Shorter or longer blocks are not available at this time.
- Parking is free from 7:00 a.m. to 8:45 a.m. on weekdays.
- Two ADA parking spaces are located in Zone A, and no longer require Residential Recreational Parking Permits or ParkMobile reservations. They are available on a first-come-first-served availability basis for any visitor with a valid ADA parking placard. This reduces the total number of reservable spaces from 60 to 58.
- Street parking on Crenshaw Boulevard north of Crest Road is free and does not require reservations.

Abalone Cove Reserve, Park and Beach

On September 3, Staff reinstalled a caution sign, to advise the public to use caution when accessing trails in Sacred Cove area. A previous sign had fallen as a result of a rockslide at Sacred Cove Beach.

From September 6 through 12, Staff observed a decrease in poaching activity within the Abalone Cove Marine Protected Area.

On September 12, Staff reported and assisted Marine Animal Rescue in safely loading an injured seal for transport and care by trained volunteers and professionals.



Forrestal Reserve/Adjacent Properties

Park Rangers continued to educate patrons on permitted and approved the use of Ladera Linda fields located on PVPUSD property. Rangers observed and made contact with three (3) patrons and two (2) off-leash dogs. All parties observed on the fields are contacted and encouraged to use Ladera Linda Park fields or hike within the Forrestal Reserve to access the trail system. The parties leashed their dogs when asked.

Additionally, the City has received increased reports of violations, including dogs off-leash, failure to pick up dog feces, and bicyclists on non-bike trails within the Forrestal Reserve and adjacent area. As a result, rangers have increased patrols to address these violations, educate the public, and enforce as necessary. During these patrols, Rangers observed little to no violations inside the Reserve and have received compliments from patrons for their increased presence.

Portuguese Bend Reserve

On September 9, Open Space Management was notified of an emergency that took place on Burma Road Trailhead, resulting in damages to the pedestrian gate and trail counter on Burma Road Trail. Los Angeles County Sheriff Department and Los Angeles County Fire Department were on scene. OSM cleaned up any remaining debris, and Public Works assisted with the removal of the fence. Preserve hours remain in effect and only authorized vehicles are permitted within the Palos Verdes Nature Preserve. Violators will be cited.



Cal Water is inspecting and trimming native lemonade berry around the Water Tank located at Burma Road / Fire Station Trail junction this week in preparation for future maintenance work.



Parks and Trails Open

Beaches, parks, and trails, including the Palos Verdes Nature Preserve, are open. In accordance with the L.A. County and State of California Health Officer Orders, private, informal, outdoor gatherings outdoors are permitted. L.A. County continues to urge everyone, especially those who are not or cannot be vaccinated against COVID-19, to exercise caution and good judgment as physical distancing requirements and capacity limitations have lifted. In addition, all individuals must follow the requirements in the Guidance for the Use of Face Coverings issued by the L.A. County Department of Public Health.

When participating in gatherings or activities, all park rules must be followed, and attendance at informal gatherings cannot exceed thresholds in the Special Event Permits ordinance.

**RE: SB 9 (Atkins) Increased Density in Single-Family Zones
VETO REQUEST**

Dear Governor Newsom,

The League of California Cities (Cal Cities) and the 241 cities listed in this letter write to request your **VETO** on SB 9 (Atkins).

SB 9 would require nearly all cities, regardless of existing circumstances, to ministerially approve, without condition or discretion, a housing development containing up to four units on a parcel that was otherwise designated for one single-family home. Additionally, this measure would require local governments to ministerially approve an urban lot split, thus creating two independent lots that may be sold separately.

Housing affordability and homelessness are among the most critical issues facing California cities. Affordably priced homes are out of reach for many people and housing is not being built fast enough to meet the current or projected needs of people living in the state. Cities lay the groundwork for housing production by planning and zoning new projects in their communities based on extensive public input and engagement, state housing laws, and the needs of the building industry. Importantly, cities are currently updating housing plans to identify sites for more than two million additional housing units.

While we appreciate President pro Tempore Atkins' desire to pursue a housing production proposal, SB 9 as currently drafted does not guarantee the construction of affordable housing nor will it spur additional housing development in a manner that supports local flexibility, decision-making, and community input. State-driven ministerial or by-right housing approval processes fail to recognize the extensive public engagement associated with developing and adopting zoning ordinances and housing elements that are certified by the California Department of Housing and Community Development.

Policymakers must avoid pushing new, unproven policies that would undermine local planning, change the rules mid-stream, or conflict with the myriad of new housing laws recently passed that cities are now implementing.

We strongly urge you to VETO SB 9.






Palos Verdes Peninsula – Jet Overflights


The graphs below show the total number of jets turning south upon departure from LAX and the number of those departures that fly over the Palos Verdes Peninsula.
