### **City Staff and Councilmember Dyda Attend Cal Cities Conference**

Last week, City Staff and Councilmember Dyda attended the Cal Cities (formerly League of California Cities) Annual Conference and Expo in Sacramento. Staff attended sessions on wildfire preparedness, homelessness, housing, land use, resident engagement, social media, financial resiliency, and diversity, equity, and inclusion (DEI) programs and policies, among other topics. Councilmember Dyda voted on behalf of the City Council to shape Cal Cities policy platforms related to the distribution of taxes collected from online purchases and security railroad property maintenance.

Assistant City Attorney Elena Gerli led a diversity, equity, and inclusion (DEI) session with Carson City Attorney Sunny Soltani (both with the lawfirm Alehire and Wynder) dedicated to identifying and dismantling barriers to advancement and to creating opportunities for all employees to reach their full potential.

Established in 1898, Cal Cities is a nonprofit statewide association that advocates for cities with the state and federal governments and provides education and training services to elected and appointed city officials. Cal Cities' mission is to expand and protect local control for cities through education and advocacy to enhance the quality of life for all Californians.

## Caltrans Western Avenue Bicycle Pedestrian Improvement Project Info Session

Join representatives from Caltrans for a virtual presentation about the Bicycle Pedestrian Improvement Project along Western Avenue. The proposed project would upgrade existing curb ramps to ADA standards and add bike lanes along Western Avenue from 25th Street in San Pedro to Carson Street in Torrance. ## Update on Proposed Temporary Maritime Tower at Point Vicente

Earlier this week, Staff contacted U.S. Customs and Border Protection (CBP) to follow up on the agency's plans to study alternative locations at the Civic Center for the relocatable remote surveillance system maritime (RSS-M) tower it seeks to install in Rancho Palos Verdes for six months to one year to detect and track illegal border activities. The City previously raised visual concerns with CBP's proposed location for the 30- to 80-foot-tall tower on federally-owned land near the Point Vicente Lighthouse.

Today, CBP informed Staff that due to the long delay in attempting to get a site approved in this area and the end of fiscal year accounting, CBP is pausing all work toward a site in this area. If things change in the future, CBP will re-engage with the City.

Staff will continue to monitor this issue.

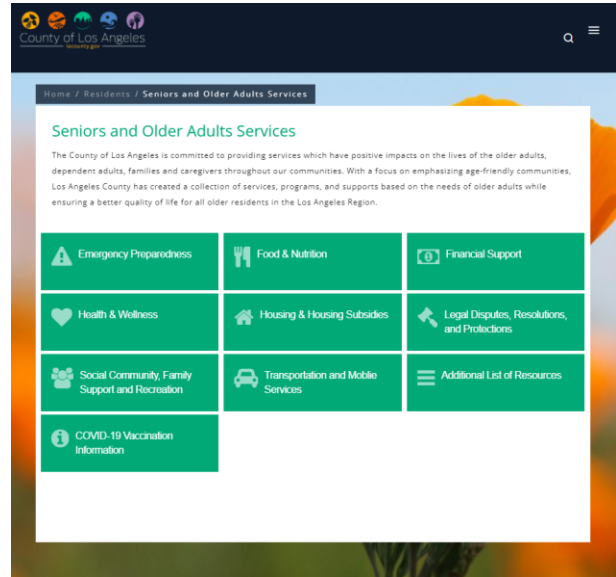

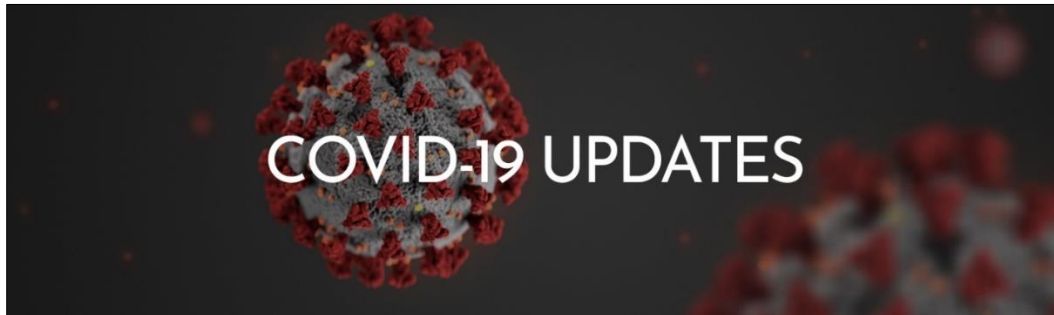

## **Pfizer Booster Available to Eligible Residents**

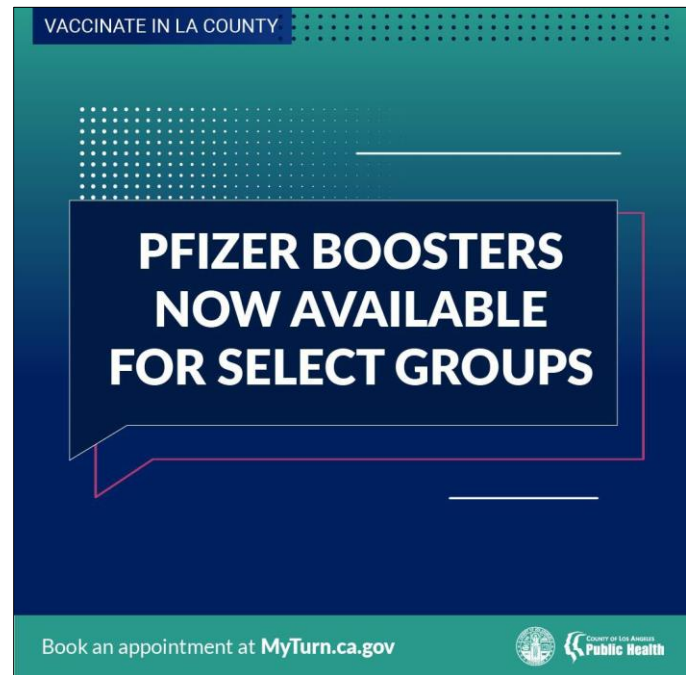
Following CDC's endorsement of a recommendation for a booster dose of the Pfizer COVID-19 vaccine in several population groups, eligible L.A. County residents can begin receiving their booster doses at any of the hundreds of sites offering the Pfizer vaccine.

L.A. County residents eligible for a booster dose of Pfizer include the following groups of people who received the second of the two-dose Pfizer vaccine series at least six (6) months ago and are either:

- People aged 65 years or older
- Residents of long-term care facilities
- People aged 18 to 64 years with underlying medical conditions
- People aged 18 to 64 years with high institutional or occupational risk, including healthcare workers, first responders, teachers, and daycare staff, grocery workers, and workers in homeless shelters or prisons, among others

Residents who received Moderna and Johnson & Johnson vaccines will need to wait until the FDA reviews the data and determines the need for and safety of boosters for these vaccines.

Those not yet vaccinated can make an appointment to get vaccinated by using the [MyTurn](#) system. Eligible residents who completed their two-dose Pfizer vaccine series at least six months ago can also make an appointment for their boosters by using





the [MyTurn](#) system or by making an appointment at a pharmacy or clinic that offers Pfizer vaccinations.

Residents will need to bring proof they received two previous Pfizer doses, which for most people will be in the form of the white vaccination card, or a photo of the white card, or a digital record of your two doses. At many sites, residents may be asked to sign an attestation form indicating they meet the criteria to receive the Pfizer booster.

## **L.A. County Board of Supervisors Vote to Extend the County's COVID-19 Tenant Protections through January 31, 2022**

On Tuesday, the Board of Supervisors voted to extend Los Angeles County's temporary eviction moratorium through January 31, 2022. These protections, which went into effect March 2020 and are set to expire on September 30, 2021, provided a set of affirmative defenses against evictions for residential and commercial tenants, as well as mobile home space renters.

The updated policy, now renamed the county's COVID-19 Tenant Protections Resolution, continues to provide a defense against eviction for residential and commercial tenants while also expanding the owner move-in provisions. Notably, the updated resolution expands the owner move-in exception to allow property owners or their qualifying family members to move into up to two units as their principal residence(s) if the single-family home, condominium unit, mobile home space, duplex and/or triplex was purchased by the property owner on or before June 30, 2021, and if certain conditions are met. It also clarifies provisions not preempted by state law, such as residential nonpayment of rent due to COVID-19 financial hardship.

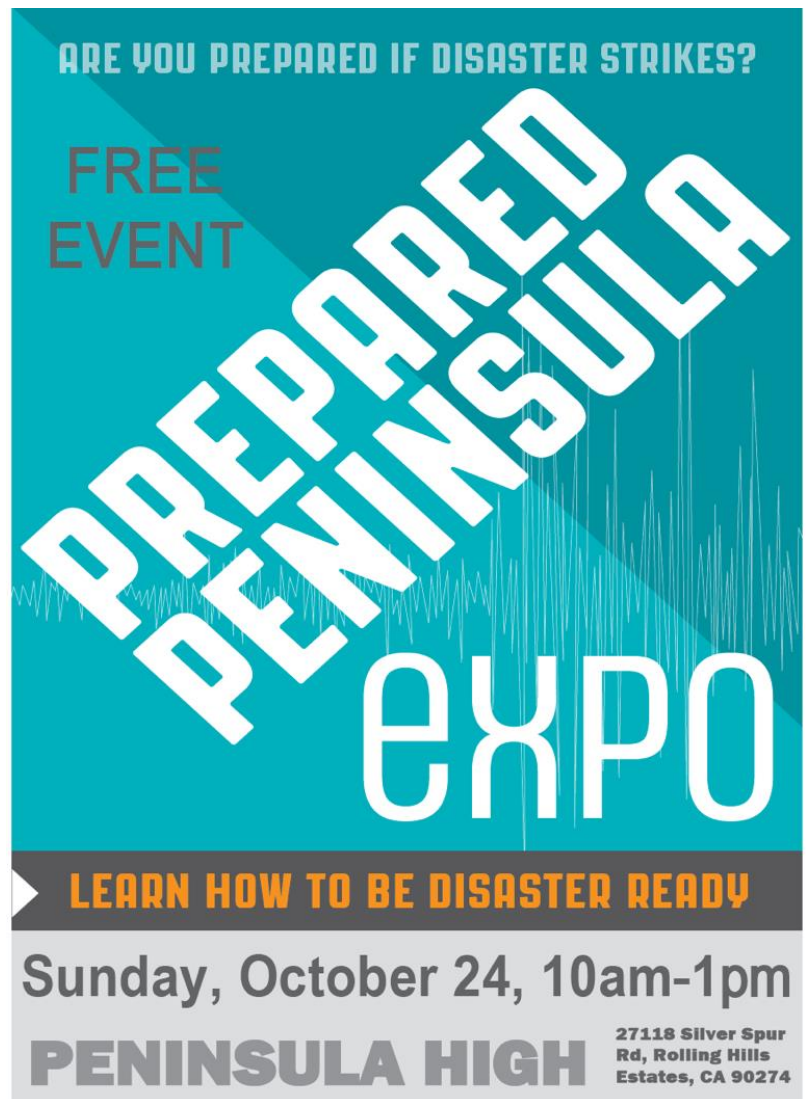

## **Seventh Annual Prepared Peninsula Expo – October 24**

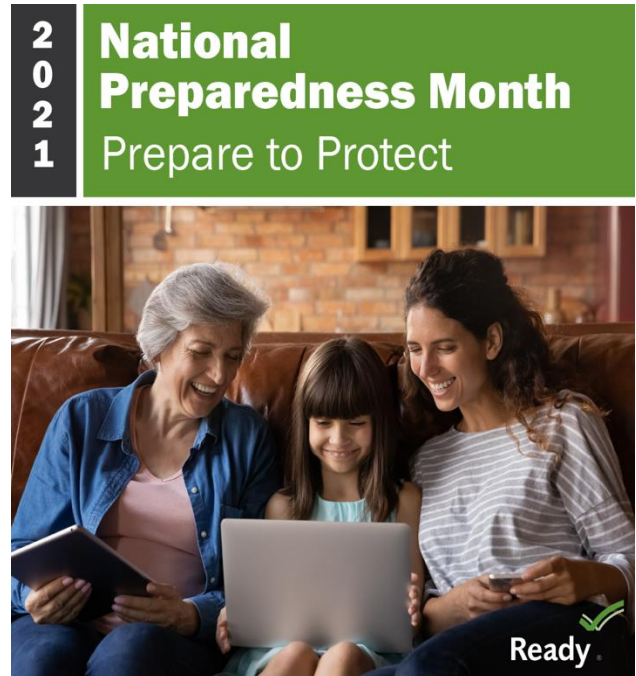
The four cities of the Palos Verdes Peninsula are once again teaming up to educate residents and the broader community on emergency preparedness at the 7th Annual Prepared Peninsula Expo on Sunday, October 24, from 10 a.m. to 1 p.m. at the Palos Verdes Peninsula High School, 27118 Silver Spur Rd, Rolling Hills Estates, CA 90274. The Prepared Peninsula Expo is an annual event the Peninsula Cities produce to help the Palos Verdes Peninsula residents learn to mitigate, prepare, respond, and recover should a disaster strike. This free event will teach you how to protect yourselves, your family, and your pets in a disaster.

This information-filled expo will provide a free lunch (while supplies last) and feature dozens of exhibitors, demonstrations, and equipment displays. Exhibitors include local organizations giving tips and tools and retail vendors selling preparedness goods, like extended life water, emergency bags, meals-ready-to-eat (MREs), and more. The Prepared Peninsula Expo is a great opportunity to learn from experts in emergency readiness about how to prepare your family and safeguard your home for the event of an earthquake, wildfire, or other disasters.



## National Preparedness Month

National Preparedness Month (NPM) is recognized annually in September to encourage family and community disaster planning not only for a month but throughout the year. This year's theme is #PrepareToProtect. Preparing for disasters is protecting everyone you love. National Preparedness Month is a call to action to all parts of our government, industrial and commercial sectors, academia, non-governmental organizations, civic groups, religious institutions, and families. By working together today, we can ensure that our Nation is prepared for tomorrow's natural and human-made threats.

Start today by signing up for alerts, safeguarding important documents, and taking other low-cost and no-cost preparedness actions to lessen the impact of disasters and emergencies for you and your family.



- **Week 4 September 19-25: Teach Youth About Preparedness:** Talk to your kids about preparing for emergencies and what to do in case you are separated. Reassure them by providing information about how they can get involved. ## 2021 Wildfires Virtual Insurance Recovery Forum

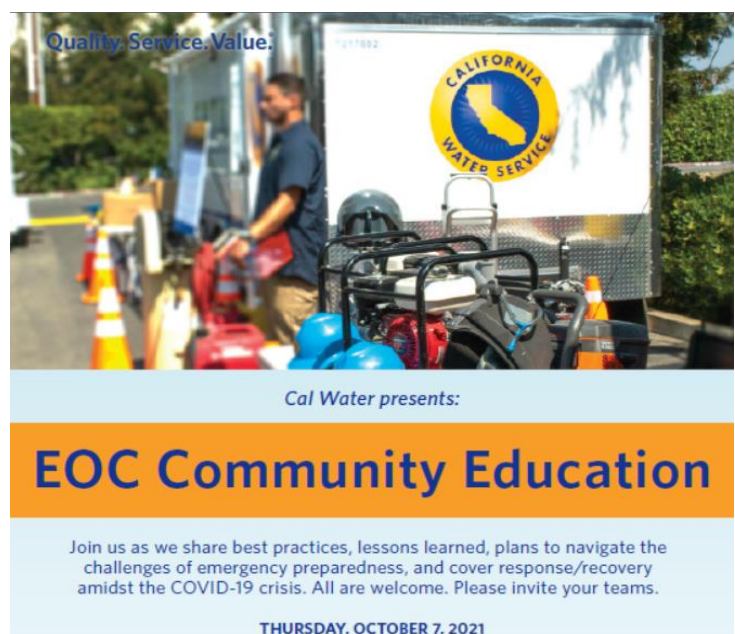

## Cal Water Virtual EOC Training

On October 7, 2021, City Staff will attend a virtual Emergency Operations Center (EOC) Community Education Presentation hosted by Cal Water representatives to improve regional coordination among key public safety agencies in the event of a large-scale emergency or disaster. Chief Al Terrell, Cal Water's Director of Safety, Emergency Response, and Physical Security will moderate the October 7th meeting.





During this meeting, participants will have the opportunity to share best practices, lessons learned, and strategies for navigating the difficulties associated with emergency preparedness, response, and recovery in the aftermath of the COVID-19 crisis and wildfires this year. This training is an excellent opportunity for City staff, representatives from local agencies, and Cal Water to build relationships so that, in the event of an emergency or disaster, these representatives can work more effectively together to serve community members.



## Wildfire Preparedness

Are you prepared in case a wildfire strikes? As we've seen in recent years, California's fire seasons are lengthening and intensifying. To date, the state has burned over 2.26 million acres, and over 10,500 personnel remain assigned to 14 large active wildfires. ## Have you Signed up for Alert SouthBay?

Alert SouthBay is a multi-jurisdictional emergency notification system used by 14 South Bay cities including Rancho Palos Verdes to keep our communities informed about disasters and emergencies with uniform, expeditious alerts.

Alert SouthBay is an opt-in system using the Everbridge software application. Similar to Nixle alerts, Everbridge sends notifications via email, text message, cellular, and landline phones. Users can subscribe to receive alerts from multiple South Bay cities. If you live in Rancho Palos Verdes, for example, but work in Torrance, you can subscribe to alerts from both cities.



Everbridge is the City's primary vehicle for emergency communication. Users can sign up by:

## MyShake App: Take Cover Before The Ground Shakes

Did you know there is an app on your phone that can alert you seconds before an earthquake hits, giving you time to act? The [MyShake app](#), is the country's first publicly available, statewide warning system giving California residents crucial seconds to take cover before shaking begins. Managed by the Governor's Office of Emergency Services (Cal OES), the MyShake App uses ground motion sensors from across the state to detect earthquakes before humans can feel them and can notify Californians to "Drop, Cover and Hold On" in advance of an earthquake.

The Great ShakeOut Earthquake drills, held on the third Thursday of October (October 21), is a worldwide earthquake safety movement involving 16.5 million people registered to participate in 2021 (and counting). Most participate in ShakeOut by registering to practice. People who have downloaded the MyShake app to their phone will receive a TEST warning at 10:15 a.m. with guidance to Drop, Cover, and Hold On!

During the self-led drill, participants practice how to "Drop, Cover, and Hold On." Endorsed by emergency officials and first responders, the safe response to an earthquake is to:

- DROP where you are, onto your hands and knees.
- COVER your head and neck with one arm and hand.
- If a sturdy table or desk is nearby, crawl underneath it for shelter.
- If no shelter is nearby, crawl next to an interior wall (away from windows).
- Stay on your knees, bend over to protect vital organs.
- HOLD ON until shaking stops.
- Under shelter: Hold on to it with one hand and be ready to move with your shelter if it shifts.
- No shelter: hold on to your head and neck with both arms and hands.

Having tools and resources on hand, such as the MyShake app, is an important step toward being prepared. This tool can give you seconds of warning before an earthquake, giving you time to prepare and act. 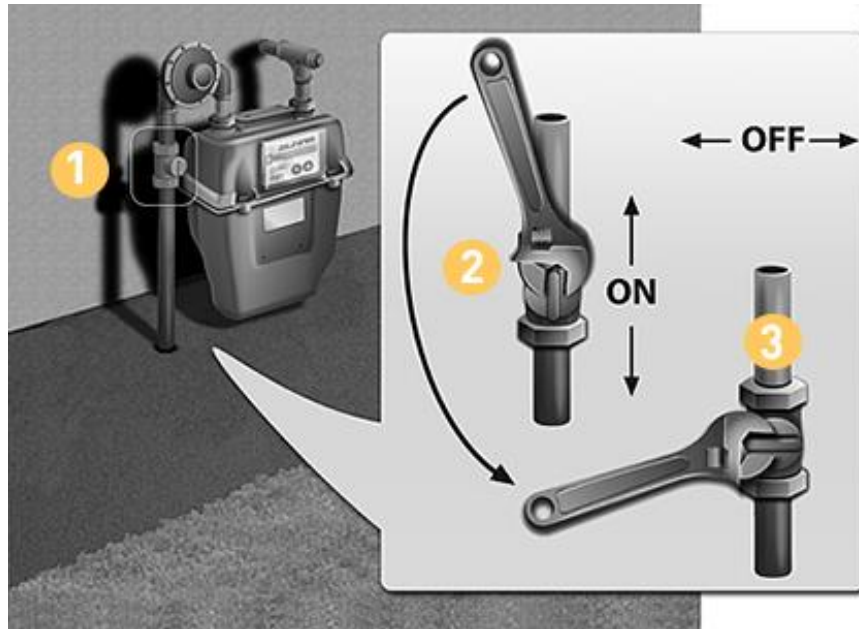


### **How to Shut-off Utilities in an Emergency**

When a disaster strikes, one or more of our homes' utility systems are frequently impacted. Natural disasters strike without warning, and during a disaster, utilities may be disrupted. In some emergencies, seconds count, a broken gas line pumping natural gas into your home, or a water main flooding room, needs to be shut down as quickly as possible to prevent damage or injury. To minimize the chance of injury and property damage, you and your loved ones must know when utilities should be turned off, where to find the shut-off mechanism, and how to do so safely.

Here are some tips if you need to power down utilities after a natural disaster or an emergency strikes. This information can also help prevent costly late-night emergency service runs. For example, if you can shut off a water leak yourself in the middle of the night, it might be possible to wait until morning to have a plumber come out.





### HOW TO SHUT OFF YOUR NATURAL GAS

Natural gas leaks and explosions cause a significant number of fires after disasters. All household members must know how to shut off natural gas. Make sure everyone in your household knows the proper shut-off procedure for your meter. Do not actually turn off the gas when practicing shutting it off.

- If you smell gas or hear a blowing or hissing noise, open a window and get everyone out quickly. Turn off the gas using the outside main valve if you can, and call the gas company from a neighbor's home.
- Caution: If you turn off the gas for any reason, only a qualified professional can turn it back on. **NEVER** attempt to turn the gas back on yourself.

#### **Step 1: Locate Your main gas shut-off valve.**

- It's important to know exactly where your natural gas meter is so you can find it in case of an emergency. Your main gas shut-off valve is normally located near your gas meter. The most common places are on the side or front of a building, a cabinet located inside a building, or a cabinet meter outside a building.

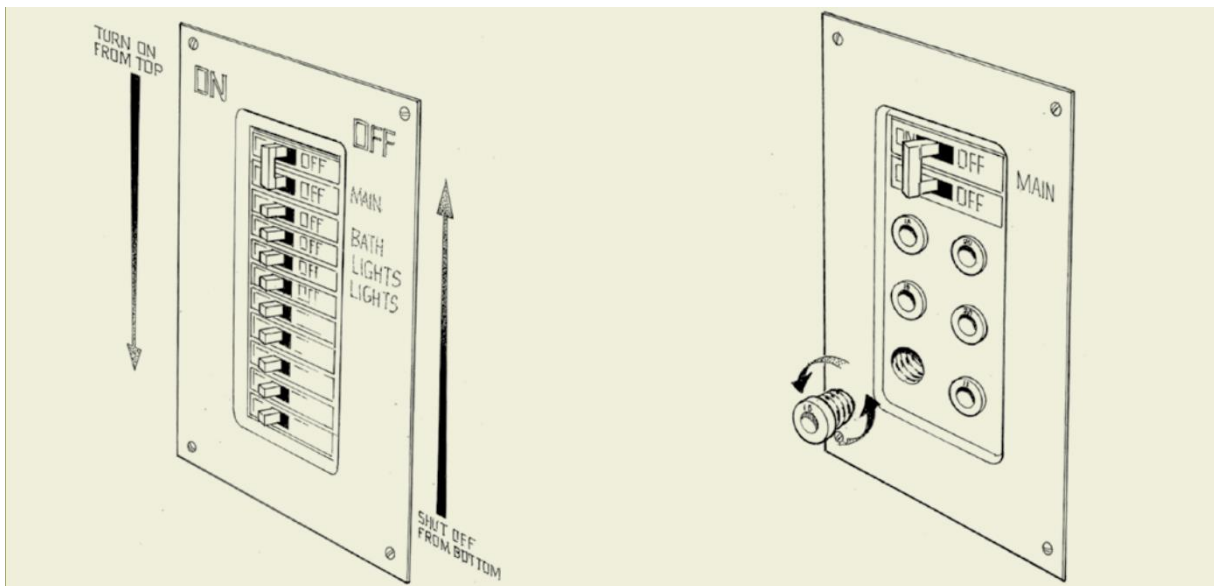
#### **Step 2: Have a wrench handy**

- Keep a 12-inch or larger adjustable wrench with your emergency supplies or next to your valve. Do not store the wrench on the meter or other natural gas piping or related equipment.



### Step 3: Give the valve a quarter turn.

- As you face the meter, you'll see a pipe running from the ground to the meter. There is a shut-off valve running parallel with the pipe, usually located about 6 to 8 inches above the ground.
- **To turn gas off**, Take a 12-inch or larger adjustable wrench, and turn the valve 1/4 turn in either direction until the valve is crosswise to the pipe.
- When the lever is crosswise (perpendicular) to the direction of the pipe (see above), the gas is off.



### HOW TO SHUT OFF YOUR ELECTRICITY

Electrical sparks may ignite a number of things following a natural disaster. This is why, in an emergency, the electricity will likely need to be shut-off immediately. If your home has a basement, the electrical circuit box is generally located there, but that's not always the case. Be sure that everyone in your home knows where the circuit box is well in advance of an emergency.

- Unlike gas, turning off the electricity doesn't require any tools. To shut it down, locate the electrical circuit box and switch off all the individual circuits before turning off the main circuit.
- Power should remain off until a professional can ensure there are no gas leaks in the home.

### Shut off electricity when:

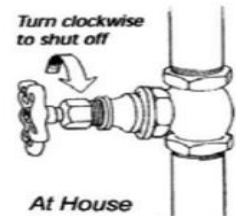
- Arcing or burning occurs in electrical devices.

- There is a fire or significant water leak.
- You smell burning insulation.
- The area around switches or plugs is blackened and/or hot to the touch.
- A complete power loss is accompanied by the smell of burning material.

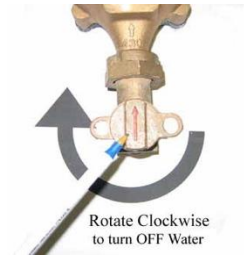
## **HOW TO SHUT OFF YOUR WATER**

Water leaks can cause property damage and create an electrocution hazard. After a major earthquake, it may be necessary to shut off your water supply to protect the water in your house. Cracked pipes may allow contaminants into the water supply in your home. There are a couple of ways to turn off the water at your property. **Water may be turned off at either of the two locations:**

- At the water shut off valve where the water supply enters your home. Typically, this valve is found on an exterior wall near the front of your home. Generally, this shut-off valve can be turned off manually by turning the handle clockwise to shut off all water to the house valve handle clockwise to turn off all water to the house.
- If you are unable to locate or operate the shut-off valve in your home, another alternative is to operate the main water valve at the street to turn off the water to your home.
  - **STEP ONE:** - Find your water meter. Residential water meters are generally installed inside concrete or plastic meter boxes and placed close to the street. The meter box may be on the sidewalk or near your property line in front of your house, and the lid will be labeled "Water Meter." The meter itself is a round dial, sometimes with its flip-up lid.
  - **STEP TWO:** Remove the metal lid of the meter box. A standard screwdriver can be used to help lift the lid.



- **STEP THREE:** To shut off your water at the meter using the shut-off valve in the meter box, use an adjustable wrench to turn the valve CLOCKWISE. If the shut-off is too tight, you may need a screwdriver to leverage in the wrench handle for shutting off your meter. See illustration below

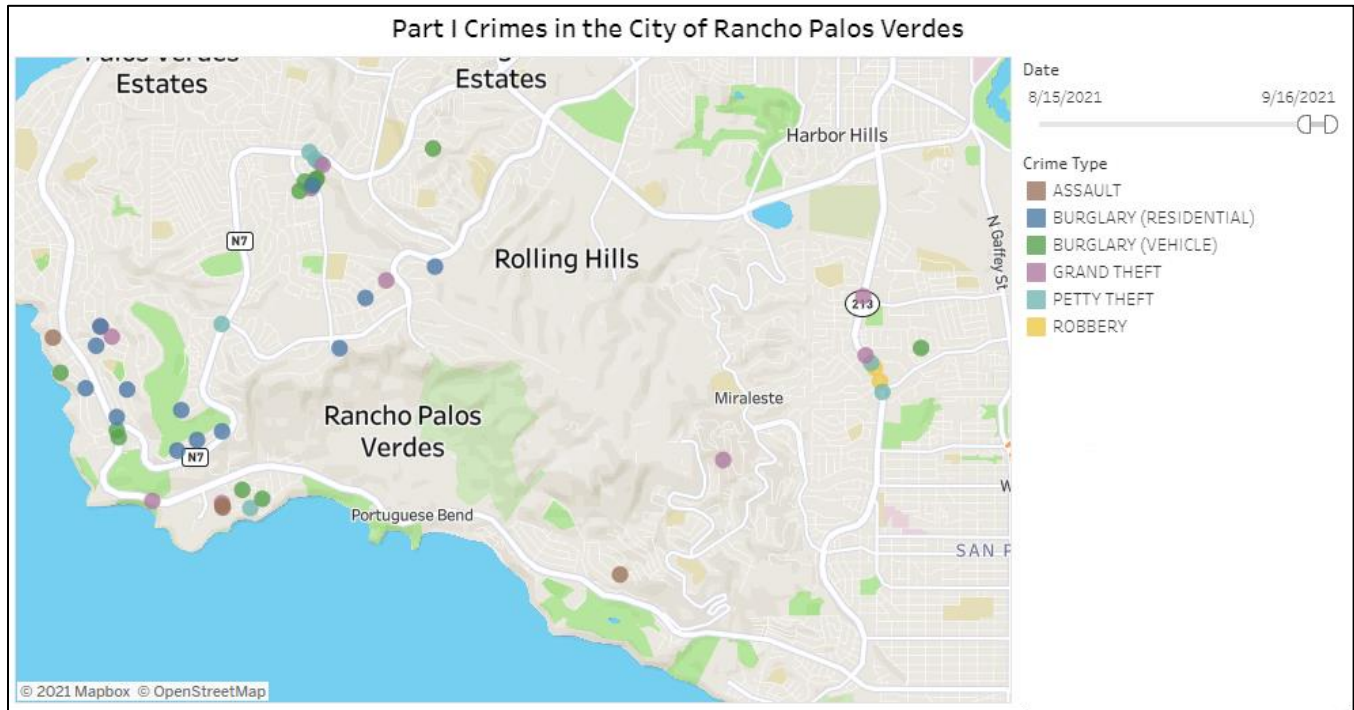

## CORE Deputies Visit City Hall

This week, two Lomita Station Deputies met with City staff to answer staff's questions about their mobile digital computer/computer-aided dispatch (MDC/CAD) and outline how calls are routed through the system.

Did you know that when you call 9-1-1, the Lomita Station dispatch is the one to answer your call?  
Thanks, Lomita Station!

If you see something suspicious, make sure you call 9-1-1 in an emergency or Lomita Station





directly at 310-539-1661. Check that you have the Lomita Station line saved as a favorite in your contacts, so you have a quick way to contact the Station when something seems amiss.

## Who Should I Call? 9-1-1 or the Lomita Station?

Call 9-1-1 in an emergency, where Sheriff, Fire, or EMS presence is immediately required. Call the Lomita Sheriff's Station at 310-539-1661 for non-emergency situations, such as reports of power outages or missing pets, general inquiries toward the Sheriff's office, noise complaints, reports of a crime that occurred in the past, or to report something suspicious.



Call your loved ones **after** you report the situation to the Sheriff's department. Make a post about the incident **after** you report it to the Sheriff's department. Email your elected officials **after** you report it to the Sheriff's department.

When in doubt if you should report something, **always** call 9-1-1 or 310-539-1661. The dispatcher will be able to direct your call if necessary.

When calling 9-1-1, be prepared to answer the dispatcher's questions, such as:

- the location of the emergency, including the street address and room/apartment number, if applicable;
- the phone number you are calling from;
- the nature of the emergency;



- details about the emergency, such as a physical description of a person who may have committed a crime, a description of any fire that may be burning, or a description of injuries or symptoms being experienced by a person having a medical emergency.

Avoid disconnecting a 9-1-1 call before the dispatcher has a chance to collect all of the necessary information. If you dial 9-1-1 by mistake, do not hang up – explain to the dispatcher what happened and disconnect only when instructed to do so.

Remember, the dispatcher's questions are important to get the right kind of help to you as quickly as possible. Be prepared to follow any instructions the dispatcher gives you.

### **See Something, Say Something**

Always be aware of your surroundings. Recognize what is normal for your neighborhood and what is not. Be on the lookout for suspicious activity on your street. Note the time of day, along with descriptors of what you observe. Or take a photo if it is safe to do so.

### **Taxpayers Who Aren't Eligible for the Child Tax Credit Should Look Into the Credit for Other Dependents**

The credit for other dependents is a tax credit available to taxpayers for each qualifying dependents who can't be claimed for the child tax credit. The maximum credit amount is \$500 for each dependent who meets certain conditions. These include:

- Dependents who are age 17 or older.
- Dependents who have individual taxpayer identification numbers.
- Dependent parents or other qualifying relatives supported by the taxpayer.
- Dependents living with the taxpayer who isn't related to the taxpayer.



The credit begins to phase out when the taxpayer's income is more than \$200,000. This phaseout begins for married couples filing a joint tax return at \$400,000.

#### **A taxpayer can claim this credit if:**

- They claim the person as a dependent on the taxpayer's return.
- They cannot use the dependant to claim the child tax credit or additional child tax credit.
- The dependent is a U.S. citizen, national or resident alien.

Taxpayers can claim the credit for other dependents in addition to the child and dependent care credit and the earned income credit.

Taxpayers can use the worksheet in Publication 972, *Child Tax Credit and Credit for Other Dependents*. This worksheet will help them determine if they can claim the credit for other dependents.

### **New Traffic Signal at Intersection of Palos Verdes Drive South and Palos Verdes Drive East**



Work continues this week for the new traffic signal project at the intersection of Palos Verdes Drive South and Palos Verdes Drive East, including boring for underground conduit and digging for signal pole foundations. Work will take place through the end of December from approximately 8:30 a.m. to 4:30 p.m. Monday through Friday, with regular partial eastbound and westbound bike lane closures around the intersection. 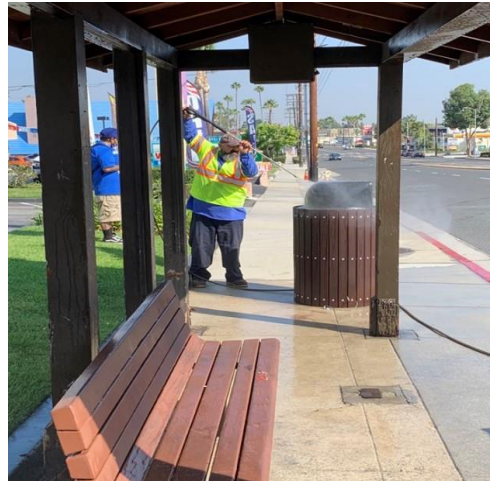
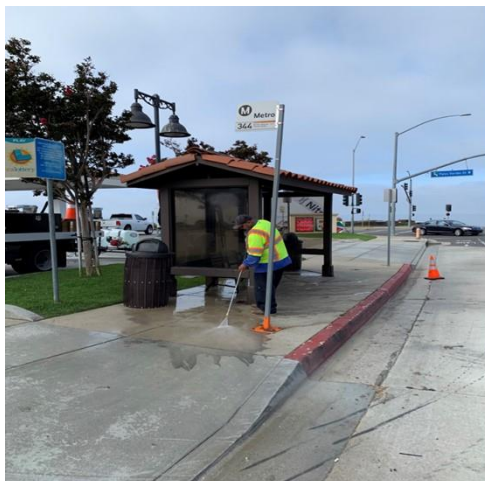


- On the corner of Silver Spur Road and Ironwood Street, Public works had its vendor, West Coast Arborist, trim two overgrown trees at the following locations:

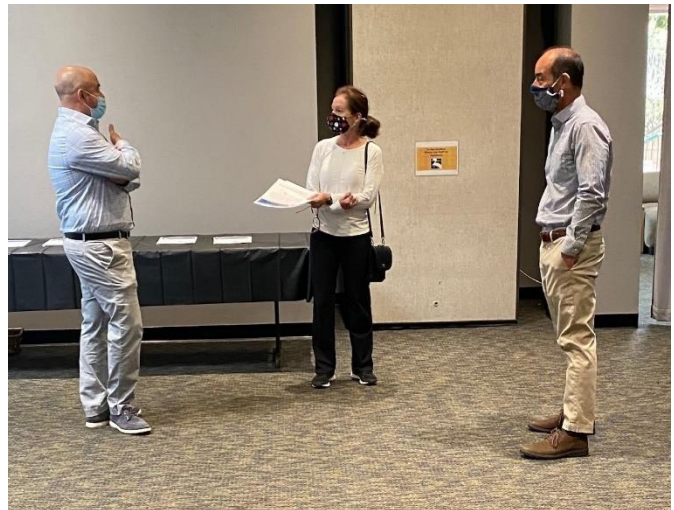
#### Open House

## Ladera Linda Community Center and Park Project Revisions

On September 21, the City Council considered and provided input on proposed safety and security elements to be incorporated into the design of the proposed Ladera Linda Community Center and Park improvements. The discussion on this matter will continue with the City Council on October 19. Some of the proposed components of the security plan will require revisions to the previously approved Variance and established Conditions of Approval (CUP) for the project. Specifically, the City Council will consider revisions to Condition of



Approval No. 12, 29, 57, 60, and 61 to accommodate an increase in the height of light standards and poles from 10 feet to 16 feet to accommodate the collocation of surveillance cameras. A revision to Condition of Approval No. 41 and 42 will also be considered in order to clarify project hours of operation. On September 30, the Community Development Department will issue a public notice regarding proposed CUP revisions to be considered on October 19. The City is very excited to educate the public about the Gabrieleño/Tongva Native Americans and the important role they have played in the history of Southern California, specifically Rancho Palos Verdes. Gabrieleño/Tongva descendants have been closely involved in the design and artwork for the monument plaques to ensure their historical accuracy and appropriateness. The City is very appreciative of professional sculptor Geri Jimenez Gould for creating such a remarkable piece of artwork.

A monument unveiling event is scheduled for October 16 from 10 a.m. to 12 p.m. Chief Anthony 'Red Blood' Morales and tribal members will participate with blessings and

songs in their regalia. Invitations were sent last week to elected officials. Additional details will be forthcoming.



### **City Council to Receive Update on ParkMobile Parking System and Related Preserve Parking Issues**

On October 5, the City Council will consider making changes to the ParkMobile parking reservation system for the Palos Verdes Nature Preserve, ending the parking moratorium on six spaces on Crenshaw Boulevard, and sunsetting the Pilot Preserve Shuttle Program. Below are the recommended City Council actions:

- (1) Receive and file an update on the implementation of the ParkMobile app;
- (2) Approve the following modifications to the ParkMobile parking system:
  - a) Allow same-day reservations (cutoff one hour prior to reservation start)
  - b) Create simplified access to the ParkMobile reservation link
  - c) Improve instructional signs
  - d) Discontinue requiring reservations for Recreational Residential Parking Permit holders
- (3) Allow the parking moratorium on six parking spaces along Crenshaw Boulevard to expire on October 19, 2021;
- (4) Receive and file an update on the ParkMobile Parking System's impacts to other trailheads and neighborhoods;
- (5) Receive and file an update on the City's search engine optimization and related efforts; and,
- (6) Sunset the Pilot Preserve Shuttle Program.



The hybrid in-person/virtual meeting will take place at 7 p.m. and be live-streamed on the City website and televised on RPTV Cox 33/Frontier FiOS 38. Public participation will be limited to the virtual platform only.

## Playground Equipment Surface Replacement Project

Replacement of the Playground Equipment Surface on City Parks began on Thursday, September 9. Fencing was placed around the playground equipment areas at Fred Hesse Jr. Community Park, Robert E. Ryan Community Park, and Eastview Park. The existing sand was removed, and the hard surfaces were re-sealed. The engineered wood fiber was installed in place of the sand. Work on Ryan Park and Eastview Park has been completed. The work at Hesse Park is expected to be completed by the end of this week.

## ParkMobile Parking App Update

On July 6, the City of Rancho Palos Verdes launched an online parking reservation system for Del Cerro Park and the popular Portuguese Bend Reserve. Visitors can now use the ParkMobile website or mobile app to reserve parking spaces on Crenshaw Boulevard south of Crest Road and Park Place, near the Rattlesnake and Burma Road Trailheads. A total of 98 reservations were made between September 20-26: 46 paid reservations, 26 resident reservations, and 26 free reservations on weekdays from 7:00 a.m. to 8:45 a.m.

Staff will continue to report on total reservations and other data points each week.

The system is being implemented to manage parking and improve traffic flow in the Del Cerro Park area. Staff is working closely with ParkMobile personnel to fine-tune the system and respond to all user concerns and issues. An update on the program will be presented to the City Council on October 5.

## Parking with ParkMobile

- **Update:** The ParkMobile reservation system is now in effect.
- Those with Residential Parking Permits should park in zone A and always display their parking permit on the bottom left side of the vehicle windshield. (If you are a city resident, obtain your Permit through Rancho Palos Verdes Public Works Department)
- Zone A Residential Permit holders park for free and will be given an access code that will allow for reservations in Zone A. For assistance with obtaining your code, please email [preserveparking@rpvca.gov](mailto:preserveparking@rpvca.gov)
- Residential Parking Permit holders should refrain from parking in other locations unless a reservation has been made and paid for in a different zone.
- In the event zone A permit holders encounter difficulty reserving a space, please use the website [rpvca.gov/parkmobile](http://rpvca.gov/parkmobile), or call ParkMobile Member Services at 866-330-7275.
- Reservations are now \$10 per reservation block and can be paid using ParkMobile. An additional \$0.35 processing fee will apply to all paid reservations.
- ParkMobile reservations are now required for all 58 spaces on Crenshaw Boulevard south of Crest Road and Park Place.
- Reservations must be made by 11:59 p.m. the night before your visit.
- Visitors are not able to park and then reserve their spot.

- Reservations are limited to blocks of two hours and 45 minutes from 7:00 a.m. to an hour after sunset. Shorter or longer blocks are not available at this time.
- Parking is free from 7:00 a.m. to 8:45 a.m. on weekdays.
- Two ADA parking spaces are located in Zone A, and no longer require Residential Recreational Parking Permits or ParkMobile reservations. They are available on a first-come-first-served availability basis for any visitor with a valid ADA parking placard. This reduces the total number of reservable spaces from 60 to 58.
- Street parking on Crenshaw Boulevard north of Crest Road is free and does not require reservations.

Visitors can make parking reservations on a mobile web browser or by downloading the free ParkMobile app for iOS or Android devices from the App Store or Google Play. Reservations can also be made by calling ParkMobile Member Services at 866-330-7275.

Working with clay is an excellent sensory activity that helps our participants relax, focus, and stay centered. All participants were excited to replicate the beauty of butterflies and share their final artworks with each other!



## Recreation Activities

Registration for fall recreation classes is now open and activities are filling up fast! Over twenty activities are available for all ages. New classes include Kid's Cooking with CrEATive Plate, Chair Yoga for Adults, and Movement for Health for adults.

Recreation Classes are independent contractor-led activities. Instructors are vetted by the City but select their course material and teaching methods. Class fees vary and are determined by the instructor and approved by the Recreation and Parks Department. Fall activities began the week of September 13 and continued through November. So far 120 registrations have been processed for 22 classes with start dates in September and October. The maximum number of students per class varies from 5 – 20 students. Registration takes place on a rolling basis, and late registration for classes that have already begun may be accepted if approved by the instructor.

All classes are conducted in accordance with L.A. County's Best Practices to Prevent COVID-19 guidance.

### **Abalone Cove Reserve, Park and Beach**

From September 20-26, no poaching/take activity was observed within the Abalone Cove Marine Protected Area.

On September 29 and 30, Park Rangers and OSM Recreation Specialists participated in a ride-along with Los Angeles Waterkeeper to conduct surveys from Point Vicente and Abalone Cove Marine Protected Areas. From along the coast, a team can collect GPS, photo, and activity data on all boating and fishing activity in and around the MPAs, where access may be limited by foot. This coordination between Los Angeles Waterkeeper and City Rangers helps the City enforce and educate within the Marine Protected Areas.

### **Forrestal Reserve/Adjacent Properties**

Ladera Linda Park staff received a report of two unauthorized vehicles in the Reserve, believed to be dirt bikes. The reporting party, a bicyclist, indicated the two dirt bikes were driving recklessly and causing damage to trails. Park Rangers patrolled trails but were unable to locate the individuals.

## Portuguese Bend Reserve

The fall 2021 Landslide Monitoring Survey, conducted through the Public Works Department, began at Portuguese Bend on Monday, September 27. The survey is expected to last for a week at most. During the survey period, McGee Survey Consulting personnel will be granted vehicle access to the Preserve and will be setting up GPS instruments at various locations to monitor the Portuguese Bend landslide areas. No trail closures will take place.

## Three Sisters Reserve

Southern California Edison will be clearing around six power poles at Three Sisters Reserve starting October 7, 2021. The work will not take place on the trails, but due to the equipment needed for the project, patrons are advised to use caution around work areas. No trail closures will take place.



## Parks and Trails Open

Beaches, parks, and trails, including the Palos Verdes Nature Preserve, are open. In accordance with the L.A. County and State of California Health Officer Orders, private, informal, outdoor gatherings outdoors are permitted. L.A. County continues to urge everyone, especially those who are not or cannot be vaccinated against COVID-19, to exercise caution and good judgment as physical distancing requirements and capacity limitations have lifted. In addition, all individuals must follow the requirements in the Guidance for the Use of Face Coverings issued by the L.A. County Department of Public Health.

When participating in gatherings or activities, all park rules must be followed, and attendance at informal gatherings cannot exceed thresholds in the Special Event Permits ordinance.
