Draft Housing Element Update Now Available for Review

The City's 2021-2029 Draft Housing Element is now available for public review. A copy of the document is available for review on the City's Housing Element Update homepage:

A key component of the draft Housing Element is the preparation of the potential housing sites inventory to accommodate the City's 6th Cycle RHNA allocation of 647 (includes an 8-unit carry over from the 5th Cycle RHNA). Given the large increase in the City's RHNA from the 5th to 6th Cycles, it was a challenging process to identify housing sites sufficient to fully accommodate the required housing units. Fifty potential housing sites have been identified, which includes a combination of developed properties along commercial corridors and in commercial districts and vacant residential sites citywide. The list of potential housing sites also outlined potential density, which considered site

constraints and availability of infrastructure. The list also identifies zoning modifications (mixed-use in commercial districts and higher density in residential zones) for the identified sites along with preliminary housing unit yields.

The Leadership Academy Kicks Off!



The City is excited to welcome the first cohort of the newly redesigned RPV Leadership Academy! Last week, residents learned about City history, organization, and the Administration Department from Councilmember Dyda, City Manager Mihranian and City Clerk Takaoka. The evening ended with a friendly game of Jeopardy!

This week, participants will hear from Mayor Pro Tem Dave Bradley, Councilmember John Cruikshank, South Bay Cities Council of Governments (SBCCOG) Executive Director Jacki Bacharach, and the City's Community Development Department.

Response Letter from Southern California Edison Regarding Utility Line Undergrounding

Last week, the City received a response to its letter dated August 17, 2021, to Southern California Edison's (SCE) CEO Kevin Pane urging SCE to match or exceed PG&E's recent announcement of a commitment to underground approximately 10,000 miles of above ground utility and by prioritizing funding for undergrounding projects. (See attachments). In his response, SCE CEO Kevin Payne stated that SCE has been working closely with the California Public Utilities Commission (CPUC) and other state agencies to develop and refine fire risk mitigation policies and procedures, including vegetation management, system inspections, and system hardening.

SCE CEO Payne additionally stated that SCE has prioritized above-ground system hardening and will pursue undergrounding only in very specific high-risk areas where hardened overhead lines would not adequately address wildfire risk. CEO Payne further indicated that SCE has no immediate plans to underground overhead power lines in Rancho Palos Verdes but expects SCE to install some covered conductors (insulated wires to help reduce the risk of wildfires) in the City beginning in 2023.

For the past two years, the City of Rancho Palos Verdes has been actively engaged with the League of California Cities in advocating for changes to the state's Rule 20 program, which regulates undergrounding projects, in order to allow more communities to use undergrounding for fire prevention. The City is actively monitoring this situation and is currently considering drafting a response letter.



Planning Commission Recruitment

The City of Rancho Palos Verdes is accepting applications for four vacancies on the Planning Commission, which considers land use applications and advises the City Council on zoning and development matters. Applications are due on October 22 by 4:30 p.m.

The seven-member Planning Commission makes decisions on specific private land use planning applications such as subdivision maps, variances, and conditional use permits; reviews environmental assessments, such as Environmental Impact Reports and Negative Declarations; makes decisions on development projects, zoning changes, grading, and neighborhood compatibility applications, view restoration permits, utility projects and right-of-way encroachments in the City; considers appeals of staff decisions on land use planning applications, and considers wireless telecommunication permit applications in the public right-of-way. The Planning Commission holds evening meetings at 7:00 p.m. on the 2nd and 4th Tuesday of each month, unless a special meeting is scheduled.



Vaccination Verification Now Required at Outdoor Mega Events and Indoor Portions of Bars and Similar Establishments

As of October 7, proof of full vaccination or a negative test result is required to enter outdoor mega events, and proof of at least one dose of the COVID-19 vaccine is required to enter or work in indoor portions of bars, lounges, nightclubs, breweries, wineries, and distilleries in L.A. County.

On November 4, bars and similar establishments throughout L.A. County will be required to verify full vaccination of all patrons and employees prior to entry to indoor portions of their establishments.

VACCINATE LA COUNTY

Targeted Vaccine Requirements

- Just like Indoor Mega Events, vaccine verification or a negative test within 72 hours prior to attending Outdoor Mega Events will be required effective Oct 7th (**must be fully vaccinated**)
- Vaccine verification will be required for customers and employees at indoor portions of bars, wineries, breweries, night clubs, and lounges effective Oct 7th (**at least one dose by the 7th and fully vaccinated by Nov. 4th**)
- Vaccine verification is strongly recommended for customers eating or drinking at indoor portions of restaurants
- Indoor masking requirements will remain



Creating inclusion and equity are vital to building healthy and resilient communities. The 2021 LA vs Hate United Against Hate Week, we will focus on actions that community members can take to build stronger connections with civic leaders, businesses, and schools to create an inclusive and accepting Los Angeles County.

Fire Weather Watch Issued For Friday In LA County

The US National Weather Service Los Angeles/Oxnard has issued a Fire Weather Watch that will be in effect from the morning to evening of Friday, October 15, due to wind and low relative humidity. A Fire Weather Watch means that critical fire weather conditions are forecast to occur. Listen for later forecasts and possible Red Flag Warnings. This is the time to get set with assembling your emergency supply kit and knowing your evacuation route. Today, take time to educate yourself on the following tips and best practices to safeguard your home and prepare your family.

Seventh Annual Prepared Peninsula Expo – October 24





October 7- Cal Water Virtual EOC Training

On October 7, 2021, City Staff attended a regional Emergency Operations Center (EOC) concepts training hosted by Cal Water representatives to strengthen regional coordination efforts in the event of a large-scale emergency or disaster. Chief Al Terrell, Cal Water's Director of Safety, Emergency Response, and Physical Security, moderated the event, which provided participants with an opportunity to share best practices, lessons learned, and strategies for navigating the challenges of emergency preparation, response, and recovery in the aftermath of the COVID-19 crisis.

This training provided an excellent opportunity for additional collaboration between City staff, representatives from local agencies, and Cal Water to strengthen relationships and work more effectively during a disaster or emergency. City staff will continue to work closely with Cal Water and other regional agencies to ensure the success of the City's resiliency planning efforts.

Severe Weather Preparedness Tips

Severe weather can happen anytime, in any part of the country. Severe weather can include hazardous conditions produced by thunderstorms, including damaging winds, large hail, flooding, and flash flooding. Severe weather events can cause downed trees and power lines and flying debris, leading to power outages, transportation disruptions, damage to buildings and vehicles, and injury or death. Proper planning and understanding of the risks may help save your family from injury and inconvenience when severe weather strikes.

Understanding Severe Weather Alerts: The National Weather Service issues a number of Watches, Warnings, and other products to alert the public about severe weather events. Be prepared for severe weather by educating yourself on the differences between Warnings, Watches, and Advisories how the warning process works.

- **HIGH WIND WARNING:** Take Action! Sustained, strong winds with even stronger gusts are happening. Seek shelter. If you are driving, keep both hands on the wheels and slow down.
- **HIGH WIND WATCH:** Be Prepared! Sustained, strong winds are possible. Secure loose outdoor items and adjust plans as necessary so you're not caught outside.
- **WIND ADVISORY:** Take Action! Strong winds are occurring but are not so strong as to warrant a High Wind Warning. Objects that are outdoors should be secured, and caution should be taken if driving.

- **SEVERE THUNDERSTORM WATCH:** Be Prepared! Severe thunderstorms are possible in and near the watch area. Stay informed and be ready to act if a severe thunderstorm warning is issued. The watch area is typically large, covering numerous counties or even states.
- **SEVERE THUNDERSTORM WARNING:** Take Action! Severe weather has been reported by spotters or indicated by radar. Warnings indicate imminent danger to life and property. Take shelter in a substantial building. Warnings typically encompass a much smaller area (around the size of a city or small county) that may be impacted by a large hail or damaging wind identified by an NWS forecaster on radar or by a trained spotter/law enforcement who is watching the storm.

PREPARING FOR SEVERE WEATHER EVENTS: In advance of any storm, be sure your property is secure. Make a list of items outside your home you will need to tie down or put away so that they don't blow away or fly through a window.

- **Be Weather-Ready:** Check the forecast regularly to see if you're at risk for severe weather. Listen to local news or a NOAA Weather Radio to stay informed about severe weather watches and warnings.
- **Prepare Your Home:** Keep trees and branches trimmed near your house. If you have time before severe weather hits, secure loose objects, close windows and doors, and move any valuable objects inside or under a sturdy structure.
- **If a severe weather alert is issued, consider the following:**
 - Bring in unsecured objects from patios and balconies and secure outdoor objects such as lawn furniture or garbage cans that could blow away and cause damage or injury.
- **Update your emergency kit,** and be sure to include enough food and water to last for 3 days for each person in your home.

STAYING SAFE DURING SEVERE WEATHER: During any severe storm, whether at home or work, you should take shelter as quickly as possible; the safest place to during high winds is indoors. Postpone outdoor activities if a severe weather advisory or warning has been issued.

- **Monitor Weather Conditions:** Listen to the local news or NOAA Weather Radio to keep abreast of approaching storms, their severity, and reported severe weather.
 - A NOAA Weather Radio will alert you if any watches or warnings are in effect or issued for your area.

- If a WATCH is issued, pay special attention to changing weather conditions and be ready to take action if a WARNING is issued or severe weather strikes.
- **If Caught Outside or Driving:**
 - Immediately go inside a sturdy building during a high wind warning or severe thunderstorm warning and move to an interior room or basement.
 - Listen to the local news or NOAA Weather Radio for updates.
 - Take shelter in your car if you are not near a sturdy building. If possible, drive to a nearby sturdy building. Otherwise, move your car to a location where it is less likely to be hit by falling trees or power lines.
 - If no shelter is available, avoid trees, power lines, and the side of the road. Keep in mind that power lines that are laying on the ground may be live.

STAYING SAFE AFTER SEVERE WEATHER:

- Continue listening to local news or a NOAA Weather Radio for updated information and instructions. Access to some parts of the community may be limited, or roads may be blocked.
- Do not go near downed power lines. Report downed lines to your local utility emergency center and the police. Do not try to free lines or remove debris yourself.
- Help people who require special assistance—infants, elderly people, those without transportation, large families who may need additional help in an emergency situation, people with disabilities, and the people who care for them.
- Avoid driving and other travel until conditions have improved. If you are using a portable generator, take precautions against carbon monoxide poisoning, electrocution, and fire.
- Exercise caution when handling debris that may have blown into your yard.

Be careful near damaged buildings

Do not enter a damaged building until local authorities say it's safe. Leave your home if there's shifting or unusual noises. If you smell gas, get outdoors immediately and call 911.



Watch out for power lines

Stay far away from damaged power lines, whether they've fallen to the ground or are dangling overhead.



Don't walk or drive through floodwaters

They can contain harmful bacteria, chemicals, sharp objects, live wires and reptiles/other animals. It only takes 12 inches of fast-moving water to sweep a car away.

Practice Your 9PM Routine

Every night at 9:00PM, the community is encouraged to lock up property, turn on lights, and bring in valuables to reduce the likelihood of falling victim to property crimes.

Lock all doors and windows, including garage doors, turn on lights or set them on a timer if you plan to be away, and avoid leaving valuables in visible areas. These actions help deter burglars and may help prevent residential burglaries.

Be aware, and if you see something suspicious, say something! The City encourages you to call the Lomita Sheriff's Station at 310-539-1661 if you see suspicious persons or activities.

Safe Drug Drop Off Locations

The public is urged to safely drop off unused prescription drugs at Public Disposal Locations. To locate local pharmacies participating in this program, visit the DEA's Public Disposal Locations [Search Utility](#). Before disposing of any medications, be sure to remove or scratch out all personal information on labels or packaging.

Residents can safely and anonymously drop off expired or unused prescriptions and over-the-counter medications. Saving unused or expired medications can lead to improper and illegal use if they fall into the wrong hands. A safer solution is to bring your old medications to designated drug drop-off boxes.

If you are unable to go to a drop-off site, you can take the following steps to dispose of medications at home.

1. Check if your medication is on the FDA's [flush list](#). If it is, remove the medicine from all packaging and flush it down the sink or toilet.

2. If your medication is not on the flush list, mix the medication with an undesirable substance like dirt or cat litter in a sealable plastic bag and throw it away in your household trash.
3. Remove all personal information from labels or packaging and discard all outer packaging.

Southern California Edison Upcoming Project

Southern California Edison (SCE) will start a project involving covered conductor wires and equipment upgrades. These upgrades will be executed to increase protection from trees, animals, or balloons causing power outages and potentially starting fires; increase protection from power surges, and increase power capacity to the area. The work will include pole replacements and increasing wire sizes and equipment. The work will be completed along Palos Verdes Drive East, including but not limited to Bronco Drive, Stallion Road, Surrey Lane, Cayuse Lane, and Via El Miro. SCE anticipates the work to begin on October 15 and conclude on or around October 20. SCE has informed the affected residents in advance of this work.



New Traffic Signal at Intersection of Palos Verdes Drive South and Palos Verdes Drive East Update



Work continues this week for the new traffic signal project at the intersection of Palos Verdes Drive South and Palos Verdes Drive East, including boring for underground conduit and digging for signal pole foundations. Work will take place through the end of December from approximately 8:30 a.m. to 4:30 p.m. Monday through Friday, with regular partial eastbound and westbound bike lane closures around the intersection. Expect delays, proceed cautiously through the work zone, and follow all signs and instructions.

Drive-thru Shredding Event – October 23

The City of Rancho Palos Verdes and its contractor, EDCO, are offering a free document/paper shredding event on October 23 from 8:00 a.m. -11:00 a.m. in the RPV City Hall overflow parking lot located at 30940 Hawthorne Boulevard.

Bring your sensitive, private, and confidential documents (such as pay stubs, medical and insurance records, old income tax returns, and bank/mortgage statements) in your trunk or truck bed for secure on-site shredding to prevent or reduce the possibility of identity theft or fraud. There is a limit of three bankers boxes (approximately 10"x12"x15") or paper bags per household. Documents with staples or paper clips are acceptable. However, remove all papers from metal three-ring binders. This event is offered free of charge to RPV residents to assist with the destruction of their personal documents. This event is not offered to businesses or residents of other cities. Please bring proof of RPV residency, such as a utility bill or ID.

Due to COVID-19 safety measures, residents must remain in their vehicle and wear a face covering.

Additionally, EDCO will collect electronic waste (computers, TVs, printers, etc.) and provide mulch (self-serve, self-load, self-haul) for residents. Bring your shovel, gloves, and cans for the mulch. Maximum of three cans per vehicle.

Please note that due to the shredding event, the Rancho Caninos Dog Park will be closed from 6:30 a.m. to 12:00 p.m.



Public Works Training

The Public Works Department is committed to continuous safety and industry training for its staff. Below is a recent training course completed by the Public Works Team.

- Public Works Maintenance staff attended a training course offered by the California Joint Powers Insurance Authority on Material Safety Data Sheets (MSDS). Training will help staff identify the name of a chemical being used and common names of the substances in it. MSDS also contains listings of the ingredients that are known carcinogens or other known hazards in chemicals that are commonly used by staff.

COMMUNITY DEVELOPMENT DEPARTMENT

Arterial Fence/Wall Surveys Underway

Staff has launched a project to develop a set of design guidelines for the City's arterial fence and walls along the City's arterial corridors as part of the City's Arterial Fence and Wall Master Plan project. Currently, staff is in the process of surveying and creating a photo inventory of existing fences and walls that abut the City's major arterial streets. The purpose of the surveys and photo inventory is to build on the findings contained in the City's 2016 Arterial Fences and Walls Assessment report and to develop a set of design guidelines for different areas of the City to beautify the City's arterial streets and help property owners understand what types of replacement fencing are allowed.

As of October 12, 2021, Staff has surveyed arterial fences and walls located along Silver Spur Road, Western Avenue, Crest Road, and portions of Hawthorne Boulevard. Staff will next survey fences and walls located along Palos Verdes Drive East, Miraleste Drive, Palos Verdes Drive South, Palos Verdes Drive West, and the remaining portions of Hawthorne Boulevard in the upcoming weeks.

Code Enforcement Division staff recently attended the 2021 CACEO seminar, which provides Code Enforcement Officers an opportunity to earn continuing education units towards the certification as a Certified Code Enforcement Officer through CACEO. The four-day event was packed with several informative courses geared towards current events happening throughout the State of California. Topic of discussions included:

On closing day, SB296 Code Enforcement Officer Safety bill was signed into law. This bill requires, for the first time ever, all cities and counties to adopt safety standards specific to code enforcement officers and the hazards and threats they face in their respective jurisdictions. This is the first CEO safety bill in the nation.




L.A. Board of Airport Commissioners Certifies and Approves the LAX Modernization Project (ATMP)

As reported by Staff on September 15, the Los Angeles Board of Airport Commissioners held a public hearing to consider the Los Angeles International Airport (LAX) Airfield Terminal Modernization Project (ATMP), as seen in the aerial map below, and the project's Final Environmental Impact Report (FEIR).

After taking lengthy public testimony, the Board continued the hearing, which entails the proposed construction of a new aerial roadway, a new concourse next to Terminal 1, and a new terminal (Terminal 9) with improvements to the North Airfield. On October 7, 2021, after taking additional public testimony, the board voted to certify and approve the Final Environmental Impact Report for the project.

The Los Angeles City Council will provide the final review of the project during a forthcoming public hearing (TBA). If approved by the Los Angeles City Council, then the project construction phase is expected to commence in early 2022 with a completion date prior to the start of the 2028 Los Angeles Olympic Games. Gabrieleño/Tongva Native American Memorial Unveiling Ceremony this Weekend at Abalone Cove Park on October 16

Plans are underway to unveil a memorial honoring the Gabrieleño/Tongva San Gabriel Band of Mission Indians—the “First Peoples of the Los Angeles Basin.” This project dates back to 2016 when Tom Steers first approached the City with the idea for a memorial.



Tom has coordinated the funding of this project with private donations. The City is very excited to educate the public about the Gabrieleño/Tongva Native Americans and the important role they have played in the history of Southern California, specifically Rancho Palos Verdes. Gabrieleño/Tongva descendants have been closely involved in the design and artwork for the monument plaques to ensure their historical accuracy and appropriateness. The City is very appreciative of professional sculptor Geri Jimenez Gould for creating such a remarkable piece of artwork.

A monument unveiling event will be held on October 16 from 10 a.m. to 12 p.m. Chief Anthony 'Red Blood' Morales and tribal members will participate with blessings and songs in their regalia. Invitations were sent to elected officials.

City Council Update on ParkMobile Parking System and Related Preserve Parking Issues

On October 5, the City Council made changes to the ParkMobile parking reservation system and other Preserve parking-related issues. Below are the actions taken by City Council:

- (1) Received and filed an update on the implementation of the ParkMobile system;
- (2) Approved, if feasible, the following modifications to the ParkMobile parking system:
 - a) Allow same-day reservations (cutoff one hour prior to reservation start) with change to one-hour blocks of time at pro-rated amount if feasible and return in 90 days with an update.
 - b) Create simplified access to the ParkMobile reservation link
 - c) Improve instructional signs
 - d) Discontinue requiring reservations for Recreational Residential Parking Permit holders
 - e) Incorporate a QR code that directs people to the reservation page.
 - f) Direct staff to work with ParkMobile to improve efficiency and usability of system
- (3) Continue the parking moratorium on six parking spaces along Crenshaw Boulevard until December 21, 2021;
- (4) Received and filed an update on the ParkMobile Parking System's impacts on other trailheads and neighborhoods;
- (5) Received and filed an update on the City's search engine optimization and related efforts;
- (6) Sunsetted the Pilot Preserve Shuttle Program; and
- (7) Directed staff to return with an alternative Rattlesnake Trailhead gate location

A further update on the ParkMobile parking system and Preserve parking issues is scheduled for December 21. A total of 65 ParkMobile reservations were made between

City Council Considers Adoption of Preserve-Related Municipal Code Changes On October 19

On October 5, 2021, the City Council introduced Ordinance No. 650 to:

- Repeal and replace Chapter 12.16.020 to allow Class 1 e-bikes in the Preserve
- Repeal and replace Chapter 12.16.010 to strengthen regulations to protect public facilities from damage/vandalism
- Repeal and replace Chapter 12.16.045 to prevent flight of ultra-light aircraft (paragliders, parasails, etc.) over City property
- Add Chapter 12.16.170 to regulate vending, commercial services, and industrial activity in parks, preserve, beaches, and recreational facilities
- Rename Chapter 12.16 of the Municipal Code

The City will hold a virtual Quarterly Preserve Public Forum on October 13 at 6 p.m. to share information and solicit feedback on Preserve operations and projects, including the proposed revisions to the Municipal Code.

Recreation Classes are independent contractor-led activities. Instructors are vetted by the City, but they select their course material and teaching methods. So far 122 registrations have been processed for 22 classes with start dates in September and October. The maximum number of students per class varies from 5 – 20 students. Registration takes place on a rolling basis, and late registration for classes that have already begun may be accepted if approved by the instructor.



County continues to urge everyone, especially those who are not or cannot be vaccinated against COVID-19, to exercise caution and good judgment as physical distancing requirements and capacity limitations have lifted. When participating in gatherings or activities, all park rules must be followed, and attendance at informal gatherings cannot exceed thresholds in the Special Event Permits ordinance.



Re: Prioritize Funding for Undergrounding Projects

Dear Mayor Alegria,

Thank you to the City of Rancho Palos Verdes (the City) for your letter dated August 17 expressing concern over SCE's overall approach to wildfire mitigation. As you correctly stated, wildfires are becoming increasingly destructive; while utility related fires represent a relatively small portion of all the fires in California, the impacts of climate change provide a dangerous mix of conditions ripe for the spread of wildfire from any ignition source.

We are aware of PG&E's recent announcement to underground approximately 10,000 miles of power lines in parts of the high fire risk areas in their service territory. SCE and PG&E serve areas with very different and diverse geography, terrain, vegetation and fuel mix, demonstrating that wildfire risk mitigation is complex and cannot be addressed with a one-size-fits-all approach. SCE has been working closely with the California Public Utilities Commission (CPUC) and other state agencies to develop and refine the policies and methods that we are leveraging to minimize the risk of fire. This includes a robust program of vegetation management, inspections and system hardening. In addition to mitigating the risk of fire, this approach increases system resiliency during challenging weather and reduces the need for preventative power shutoffs during high wind conditions.

We have decided along with the CPUC to focus on above-ground system hardening and that undergrounding will only be pursued for very specific high-risk areas where hardened overhead lines would not sufficiently address wildfire risk. This decision was made with consideration to the amount of wildfire risk above-ground system hardening mitigates, the speed with which it can be deployed, and its significantly lower cost as compared to undergrounding. This approach strikes the right balance to ensure that SCE can continue to safely, reliably and affordably serve our customers.

Based on SCE's current wildfire risk models, which allow greater levels of granularity and detail when compared to the State's two-tier high fire risk area model, the City is in a relatively lower wildfire risk area than other parts of our service territory. Additionally, there has not been a public safety power shutoff event in this area. Therefore, at this time, we do not have any plans to pursue undergrounding of our lines in Rancho Palos Verdes, and while we appreciate the City's concern, we do not foresee a

change in those plans in the near term. However, based on our risk modeling, we do anticipate installing some covered conductor beginning in 2023. SCE remains committed to protecting public safety and looks forward to working with the City as we continue to make improvements for wildfire resiliency and to ensure reliable service.

We appreciate your feedback and value Rancho Palos Verdes as a partner in mitigating the risk of wildfire for the benefit of your residents and our customers. The City has a valuable role in expediting SCE's wildfire mitigation work by processing permits for items such as vegetation management and infrastructure replacement. SCE looks forward to continued collaboration with the City as we continue this critical work.

As a follow up, if you would find it helpful, I am happy to arrange briefings for you and your staff on our wildfire mitigation efforts and how they pertain to Rancho Palos Verdes specifically.
