
Cal Water Roadwork on PV Drive East and Via Subida Starting November 15

As early as November 15, a Cal Water contractor will begin installing water pipeline along Palos Verdes Drive East from Via Colinita to La Vista Verde Drive, and in the 6200 block of Via Subida.

Work will take place over two months from Monday to Friday from approximately 9 a.m. to 3 p.m. Cal Water will minimize traffic impacts and notify customers of any service interruptions.

Please proceed cautiously through the work zone and obey all signs and instructions due to lane closures and construction equipment. All construction timing is estimated and could change based on several factors, including unforeseeable field circumstances.

This work is part of a wildfire hardening project to improve water supply reliability and provide fire protection in the area. If you have questions about this project, please contact Cal Water at 310-257-1400. A notification letter with more information is available [on the City website](#).

At the City Council meeting on November 2, the Council awarded the cohort with certificates of completion. Congratulations to the participants of the Leadership Academy!





Public Health Provides Framework for Lifting Masking Requirements and Update on Plans to Vaccinate Children 5 to 11

Earlier this week, the Los Angeles County Department of Public Health (Public Health) provided the framework for lifting masking requirements at events and indoor establishments.

For outdoor mega-events involving more than 10,000 people, Public Health outlined that before masking requirements are lifted, all of the following criteria need to be met: L.A. County case rates must demonstrate three consecutive weeks at or below moderate transmission as defined by the CDC – that is, less than 50 new weekly cases per 100,000 residents; hospitalizations remain low and stable at or below 600 daily COVID hospitalizations for three consecutive weeks; 80% or more of county residents 12 and older are fully vaccinated, and there are no emerging reports of significantly circulating new variants of concern that threaten vaccine effectiveness.

For masking requirements to be lifted at indoor events or establishments involving fewer than 1,000 people, including indoor offices and worksites, sites must have a vaccination verification process in place, and all employees and customers must be fully vaccinated, accommodating with additional requirements those employees with approved exemptions. Additionally, L.A. County metrics must meet all of the same standards for lifting masking requirements at outdoor mega-events.

Indoor masking will remain mandatory due to federal and state requirements on public transit and transportation hubs (federal), and at TK-12 schools, childcare, and youth settings; healthcare settings; correctional facilities; homeless and emergency shelters and cooling centers; and indoor mega-events involving more than 1,000 people (state).

In L.A. County, 900,000 children between the ages of 5 and 11 will likely become newly eligible for vaccination this week. The County is well prepared to vaccinate children once the CDC grants final approval. Currently, the County expects to get nearly 300,000 doses as part of its first three waves of vaccine supply by the end of this week. When the CDC approves pediatric vaccines, sites that have already received doses may be able to start vaccinating as early as today or on Thursday. Doses are being allocated to the County and to the rest of the country on a pro-rata basis. Public Health does not anticipate scarcity and expects there will be ample vaccines to meet demand.

A network of nearly 900 providers countywide is prepared to provide vaccines to children between the ages of 5 and 11. County mobile vaccination teams will work to supplement vaccinations offered by existing providers so that children have easy access to our most powerful protection from COVID-19. Over the course of the month of November, vaccines for children will be offered at 480 school-based events with a focus on schools in high-need areas.

Tips to Prevent Vehicle Burglaries

Take steps today to prevent thefts from your vehicle. Residents are strongly encouraged to use "Lock It or Lose It" prevention tips every day. It only takes a matter of seconds for a thief to break into your car and grab your valuable items.

Look through the windows of your vehicle. What do you see? A bag on the passenger seat? A charging cord? A garage door opener? Change in a cup holder? Take it with you or remove it from plain view and be sure to close all windows and lock doors.

Follow these tips to help prevent vehicle burglaries:

1. Remove all valuable items from your car, including purses and electronics.
2. If you must leave valuables behind, put them in your trunk or locked glovebox before you reach your destination. Avoid doing so while in plain view.
3. Close all windows and lock your doors.
4. Park in a locked garage or well-lit areas.

If you see suspicious activity, report it immediately to the Lomita Sheriff's Station at 310-539-1661. In case of emergency, call 9-1-1.

Update on Installing Wildfire Monitoring Cameras

During the November 2, 2021, City Council meeting, the city's Emergency Services Coordinator, along with members of the City's Emergency Preparedness Committee, provided the Council with an update on the progress made in investigating the viability of implementing a wildfire monitoring camera system for the City, as well as solicited the Council's direction on potential placement locations for monitoring cameras, and what type of camera system to pursue (surveillance with the use of volunteers or Artificial Intelligence (AI) a technology-based detection). Specifically, the presentation covered various topics, including an overview of the [ALERTWildfire Network camera system](#), recommendations from the Emergency Preparedness Committee (EPC) on Proposed Wildfire Fire Camera locations and coverage, and an examination of the differences between camera systems (surveillance vs. detection).

There are generally two types of camera systems that can be used to monitor fires, depending on the overarching objective of the installed cameras: surveillance and detection. However, there is a critical distinction to be made between detection monitoring and surveillance monitoring. Surveillance necessitates viewing the camera's video stream by a human, which could be a source of detection but is susceptible to human fatigue due to the requirement of volunteers or staff monitoring camera streams 24 hours a day, seven days a week which will notify emergency personnel when fires are detected via fire cameras, regardless of whether anyone is actively monitoring the cameras video streams. During the November 2 presentation, staff summarized two proposed objectives and associated projects for these camera systems to enable the council to decide which system to pursue.

As a result of this meeting, the Council expressed an interest in pursuing a wildfire detection system that uses AI technology to monitor for signs of smoke indicative of wildfire ignition activity. Council directed Staff to present the concept to the Peninsula Public Safety Committee (PPSC) at their upcoming November 18 Committee meeting to gauge interest in a cooperative regional wildfire monitoring and detection camera system amongst the four Peninsula Cities. Additionally, the Council directed staff to coordinate with the RPV Emergency Preparedness Committee and the Los Angeles County Fire Department to identify and finalize camera installation locations for consideration by the council. Lastly, to proceed with issuing a Request for Proposals for the procurement and installation of a wildfire detection system for the City and report back to the City Council with additional information.

EMERGENCY PREPAREDNESS TIPS

Winter Weather Safety Tips

Can you believe it's November? That means winter is almost here, and some areas are already experiencing bitter cold. Winter storms can bring snow, sleet, and freezing rain to the entire United States and territories. Even Hawaii's Big Island receives snow, and major cities as far south as Atlanta and Dallas have been rendered inoperable by snow and ice. Winter storms increase the risk of car accidents, hypothermia, frostbite, carbon monoxide poisoning, and heart attacks due to overexertion.

PREPARING FOR WINTER WEATHER:

Before a winter storm hits, make sure you have enough supplies in your home, office, and vehicles. Ensure that your pets have the necessities they will require during a winter storm.

- **At Home and Work:** Your primary concerns at home or work during a winter storm are loss of heat, power, and telephone service and a shortage of supplies if storm conditions continue for more than a day.
 - **In either place, you should have available:**
 - Flashlight and extra batteries
 - Battery-powered NOAA Weather Radio and portable radio to receive emergency information
 - Extra water and food such as dried fruit, nuts, granola bars, and other food requiring no cooking or refrigeration.
 - Extra prescription medicine
 - Baby items such as diapers and formula
 - First-aid supplies
 - Emergency heat source: fireplace, wood stove, or space heater properly ventilated to prevent a fire
 - Fire extinguisher, smoke alarm; test smoke alarms monthly to ensure they work properly
 - Extra pet food and warm shelter for pets

- **Remember to review generator safety:** Never operate a generator in a confined space. Check that your carbon monoxide detector is operational and that the outside vent is free of leaves and debris. Home fires are common in the winter as people try to stay warm. Examine how you can keep your home and loved ones safe.
- **In Vehicles:** Each year, on average, more than 5,000 people are killed, and more than 418,000 are injured due to weather-related vehicle crashes. Before you leave the house, especially before a longer trip in winter, make sure all fluid levels are full and ensure that the lights, heater, and windshield wipers are in proper condition. Keep your gas tank near full to avoid ice in the tank and fuel lines.
 - **Fully check and winterize your vehicle before the winter season begins.**

Carry a Winter Storm Survival Kit that includes the following:

- Mobile phone, charger, batteries
- Blankets/sleeping bags
- Flashlight with extra batteries
- First-aid kit
- High-calorie, non-perishable food
- Extra clothing to keep dry
- Windshield scraper and brush
- Tool kit
- Tow rope
- Battery booster cables
- Compass and road maps don't depend on mobile devices with limited battery life

STAYING SAFE DURING WINTER WEATHER:

- **Stay off roads if at all possible**
- **Limit your time outside.** If you need to go outside, wear layers of warm clothing. Watch for signs of frostbite and hypothermia.
- **Avoid carbon monoxide poisoning.** Only use generators and grills outdoors and away from windows. Never heat your home with a gas stovetop or oven.
- **Reduce the risk of a heart attack.** Avoid overexertion when shoveling snow. Watch for signs of frostbite and hypothermia and begin treatment right away.
- **Check on neighbors.** Older adults and young children are more at risk in extreme cold.
- **Learn the signs of basic treatments for frostbite and hypothermia:**
 - **Frostbite causes loss of feeling and color around the face, fingers, and toes.**

- **Signs:** Numbness, white or grayish-yellow skin, firm or waxy skin.
- **Actions:** Go to a warm room. Soak in warm water. Use body heat to warm. Do not massage or use a heating pad.
- **Hypothermia is an unusually low body temperature. A temperature below 95 degrees is an emergency.**
 - **Signs:** Shivering, exhaustion, confusion, fumbling hands, memory loss, slurred speech or drowsiness.
 - **Actions:** Go to a warm room. Warm the center of the body first—chest, neck, head, and groin. Keep dry and wrapped up in warm blankets, including the head and neck.

New Traffic Signal at Intersection of Palos Verdes Drive South and Palos Verdes Drive East



Boring for new electrical conduit was successfully completed last Friday, and work resumed this week digging for signal pole foundations for the new traffic signal project at the intersection of Palos Verdes Drive South and Palos Verdes Drive East. The digging is expected to be complete this week, and the contractor is scheduled to start installing the concrete foundations for the poles this week. Work is limited to approximately 8:30 a.m. to 4:30 p.m. Monday through Friday, with regular partial eastbound and west bound bike lane closures around the intersection. Expect delays, proceed cautiously through the work zone, and follow all signs and instructions. The signal is expected to be complete by the end of December.

Regular Trash/Recycling Collection on Veteran's Day and Holiday Schedule for Thanksgiving Day

There will be NO DELAY in the trash/recycling collection on Thursday, November 11 (Veteran's Day).

There will be no trash, recycling, or green waste collection on Thanksgiving Day, Thursday, November 25. The Thursday route will be serviced on Friday, November 26, and the Friday route will be serviced on Saturday, November 27. Monday through Wednesday, the collection will remain unchanged.

There will be no street sweeping services scheduled for Thursday, November 25 (Thanksgiving Day). The fourth Thursday route will be performed on Wednesday, November 24.




As a reminder, please remove all trash/recycling cans from the curb after collections and temporarily remove parked cars from the curb on sweeping days.





- As we move into the rainy seasons, please remember that City Hall provides self-serve sandbags and fill to all Rancho Palos Verdes residents. Proof of residence is required. Below are a few guidelines about filling and using emergency sandbags.
 - Fill the sandbag only halfway, and make sure to tie the top of the bag securely.
 - Prevent injury from heavy lifting by using correct posture and lifting with the legs in a squat position.
 - For proper layering technique, lay the first layer parallel to the flow of water. The bag needs to lay half full and half empty so that the full side will rest on the empty side of the bag before it. Walk on each layer to compact the sand. To add more layers, offset it by half a bag to prevent straight seams. Cover the finished barrier with plastic. Draft Housing Element Available for Review

Public comments on the City's 2021-2029 Draft Housing Element is being accepted through Thursday, November 4.

A key component of the draft Housing Element is the preparation of the potential housing sites inventory to accommodate the City's 6th Cycle RHNA allocation of 647 (includes an 8-unit carry over from the 5th Cycle RHNA).

Given the large increase in the City's RHNA from the 5th to 6th Cycles, it was challenging to identify housing sites sufficient to fully accommodate the required housing units. Nearly 50 potential housing sites have been identified, which includes a combination of developed properties along commercial corridors and in commercial districts and vacant residential sites citywide. The list of potential housing sites also outlined potential density, which considered site constraints and availability of infrastructure. The list also identifies zoning modifications (mixed-use in commercial districts and higher density in residential zones) for the identified sites along with preliminary housing unit yields.

Peafowl Trapping Program Update

This year, City Council approved humane trapping and relocating of fifty birds from two targeted neighborhoods, including Sunnyside Ridge and Vista Grande. The Peafowl Trapping and Relocation Program helps control the overall peafowl population in the City and reduces property damage caused by these birds.

To date, trapping in the Sunnyside Ridge neighborhood has yielded twenty-five birds that were safely captured and relocated. This represents the most captured in a single location since the implementation of the Peafowl Trapping Program in 2016. In total, thirty-six birds have been captured to date, with the remaining fourteen coming from the Vista Grande neighborhood.


The rink will operate for a total of 14 days in December. Below are the proposed dates and times (including the week school is out on holiday break):

Preserve-Related Municipal Code Changes

On November 2, 2021, the City Council adopted the second reading of Ordinance No. 650, which makes the following changes to the City's Municipal Code:

1. Renaming RPVMC Chapter 12.16 to include the word "Preserve" and to read, "Streets, Parks, Preserve, and Recreational Facilities."
2. Repealing and replacing RPVMC 12.16.010 to prohibit damage to City facilities, including vegetation.
3. Repealing and replacing RPVMC 12.16.045 to prohibit ultralights including paragliding from flying over City property.
4. Adding RPVMC 12.16.170 to regulate vending, commercial services, and industrial activities in parks, Preserve, beaches, and recreational facilities.

These Municipal Code amendments go into effect on December 2, 2021. Additionally, on November 2, 2021, the City Council introduced Ordinance No. 653 to regulate the operation of certain motorized vehicles and to prohibit motorized bicycles and electric bicycles in the City's parks, Preserve, beaches, and recreational facilities. Ordinance No. 653 also establishes a policy for using other power-driven mobility devices in recreational areas in accordance with the Americans with Disabilities Act. The second reading of this ordinance will be considered at the November 16 City Council meeting.

ParkMobile Parking System Update

Following City Council action on October 5, the following changes have been made to improve the ParkMobile parking reservation system in the Del Cerro area:

- Allow same-day reservations (cutoff one hour prior to reservation start) with change to one-hour blocks of time at a pro-rated amount if feasible.
- Create simplified access to the ParkMobile reservation link
- Improve instructional signs
- Discontinue requiring reservations for Recreational Residential Parking Permit holders
- Incorporate a QR code that directs people to the reservation page.

Reservations currently end at 5:45 p.m.

A further update on the ParkMobile parking system and Preserve parking issues is scheduled for the December 21 City Council meeting. A total of 89 ParkMobile reservations were made between October 25-31: 62 paid reservations and 27 free reservations. Residential Parking Permit holders can park within Del Cerro Park. Staff will continue to report on total reservations and other data points each week.

Virgin Orbit

Virgin Orbit, a Long Beach-based company that provides launch services for small satellites, utilized several parking spaces at City Hall to monitor satellite activities from October 26-29. Virgin Orbit personnel was on-site during the day and overnight. Virgin Orbit will also use parking spaces at City Hall on November 18-24.

Abalone Cove Reserve, Park and Beach

From October 25 – October 31:

Three (3) fishing violations by boat were observed at Point Vicente State Marine Conservation Area.

Four (4) people collecting for observation purposes were contacted by OSM staff at Abalone Cove State Marine Conservation Area.

On October 24, two separate incidents were reported to staff. One involved a vehicle that drove through Chapel View Trail from the Abalone Cove parking lot in an effort to exit out of the parking lot. The second instance involved a bicyclist who stated they did not observe the cable across the trailhead and received several scratches as a result of going through it. Staff installed additional reflective barriers to ensure the cable and trailhead were clearly visible and marked.

Ocean Trails Reserve

On Friday, October 29, trail consultants hired by Trump National Golf Club completed repairs to both Catalina Trail and Southshore Coastal Trail in the Eastern section of Ocean Trails Reserve. OSM staff coordinated on the project to ensure NCCP/HCP compliance.



Two sets of timber box steps were installed on the upper and middle sections of Southshore Coastal Trail, among other improvements, to assist with water control measures. The image on the left was taken in February 2021. The center and right images were taken in November 2021 in the same location from different angles.

Portuguese Bend Reserve

Starting November 1 through November 5, crews will be on-site at Peppertree Trail for trail work. Grade dips and drainage swales will be installed on the trail to assist with water control measures. No trail closures will be needed.
