City Council Adopts Camping Ordinance

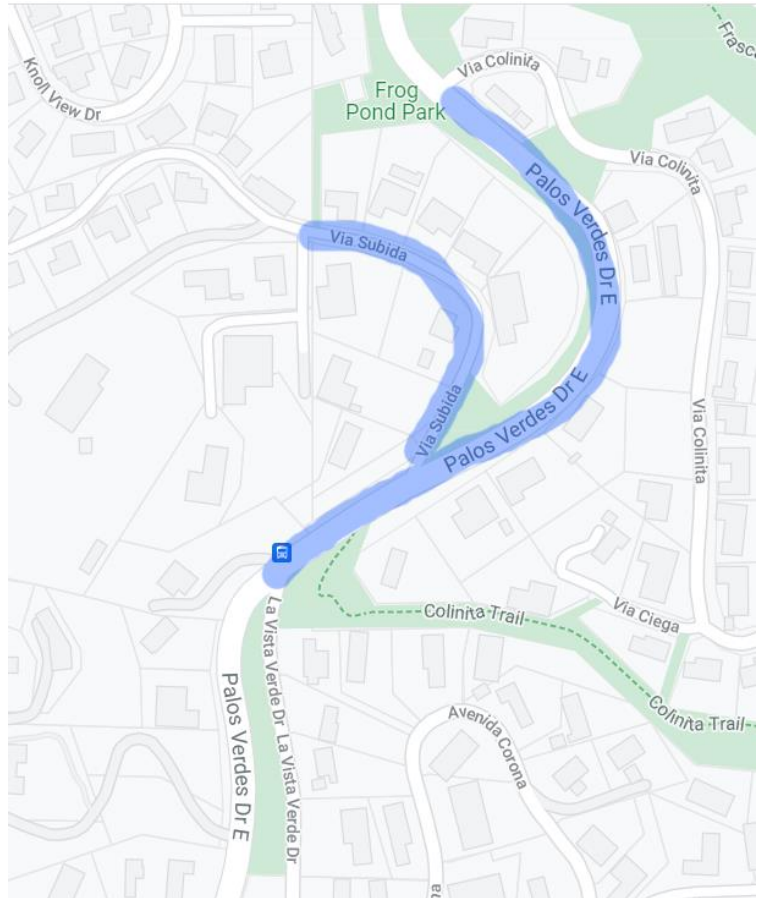
Last night, the City Council, as second reading, adopted Ordinance No. 654, repealing and replacing Chapter 12.16.140 of the Rancho Palos Verdes Municipal Code to prohibit camping in certain public places expanding the current prohibition of camping in the Palos Verdes Nature Preserve. Effective December 16, 2021, Ordinance No. 654 would:

- Prohibit camping and storage of private property in public places if there is shelter available as defined in *Martin v. City of Boise*.
- If shelter is not available, it establishes camping parameters where camping is prohibited in certain named areas in the City, such as parks and City facilities, and defines certain times when camping is prohibited in the Very High Fire Hazard Severity Zone (VHFHSZ).
- Exceptions can be made to the camping prohibition during a declared emergency such as an earthquake or fire or with a City-approved permit.

Cal Water Roadwork on PV Drive East and Via Subida

Over the next two months, Cal Water contractor will be installing water pipeline along Palos Verdes Drive East from Via Colinita to La Vista Verde Drive, and in the 6200 block of Via Subida.

UPDATED HOURS: Work will take place over two months from approximately 9 a.m. to 1 p.m. on Mondays and from 9 a.m. to 2:30 p.m. Tuesday-Friday. No work will take place from November 22-26, and December 20-31. Cal Water will minimize traffic impacts and notify customers of any service interruptions.



Please proceed cautiously through the work zone and obey all signs and instructions due to lane closures and construction equipment. All construction timing is estimated and could change based on several factors, including unforeseeable field circumstances.

This work is part of a wildfire hardening project to improve water supply reliability and provide fire protection in the area. If you have questions about this project, please contact Cal Water at 310-257-1400.

West Basin Calls on Community to be *Super-Cali-Frugalistic* with Water

The West Basin Municipal Water District announced its latest drought outreach campaign, calling on its 17 cities and portions of unincorporated Los Angeles County to be SUPER-CALI-FRUGALISTIC with our water.

The campaign call to “Save Water, Save California” highlights how local actions can make a far-reaching impact. The SUPER-CALI-FRUGALISTIC drought campaign challenges West Basin local communities to be frugal – in other words, prudent– with their water use in order for all communities to thrive.



“When we use less water as individuals, we preserve limited supplies for our communities and all Californians during this severe statewide drought,” said West Basin Board President Harold C. Williams, MSCE, P.E.

Historically low allocations of water from Northern California and strained supplies from the Colorado River - which combined make up nearly 60% of the West Basin water supply portfolio - mean that West Basin water users must use less to see us through this drought and beyond.

For West Basin, a 15% reduction means actively decreasing water use by 20 gallons per person per day on average. Overall, district-wide water use is trending downward with a commendable 5% decrease compared to 2020. The West Basin service area has successfully demonstrated an ability to save water throughout the decades. However, we can still save more. Together we can reach the current 15% reduction goal, as West Basin, Metropolitan Water District of Southern California, and Governor Gavin Newsom are calling on each of us to do.

In the upcoming months, the SUPER-CALI-FRUGALISTIC campaign will include memorable community outreach experiences like drought kit giveaways that will highlight the substantial benefits of West Basin’s water use efficiency programs.

Booster Doses Now Recommended for Everyone Ages 18+

California has expanded eligibility for COVID-19 vaccine booster shots to everyone ages 18+.

If you received the Pfizer or Moderna vaccine:

CALIFORNIANS 18+ ARE ELIGIBLE FOR A COVID-19 VACCINE BOOSTER IF:

- ➔ **6 MONTHS HAVE PASSED SINCE THEIR SECOND DOSE OF PFIZER OR MODERNA**
- ➔ **2 MONTHS HAVE PASSED SINCE THEIR JOHNSON & JOHNSON DOSE**

The L.A. County Department of Public Health **recommends** booster doses for everyone age 18 and older who received their second dose at least six (6) months ago. Booster doses are **strongly recommended** if you are:

- Age 65 and older
- Age 18 and older and have an [underlying medical condition](#) or have a risk of exposure at work or in the community.

If you are moderately to severely immunocompromised and have already received your third dose, you should **consider** getting a booster dose (this would be six months after your third dose). Talk with your doctor.

If you received the Johnson & Johnson vaccine:

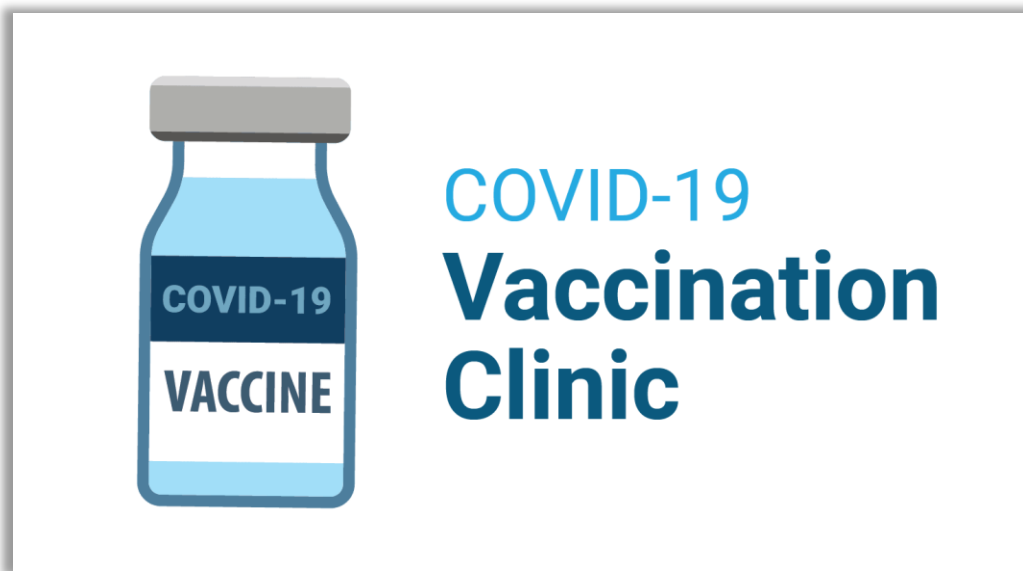
The L.A. County Department of Public Health **strongly recommends** booster shots for everyone who was vaccinated two or more months ago.

Can I get a different vaccine for my booster dose?

You may choose which vaccine you receive as a booster dose. It can be a booster dose of Pfizer, Moderna, or J&J COVID-19 vaccine. Talk to your doctor if you have questions about the risks and benefits of a booster or about which vaccine to get as a booster.

Need an In-Home Vaccination?

If you are home-bound, you can request an in-home vaccination from the L.A. County Department of Public Health by calling the DPH Vaccine Call Center 833-540-0473 (open daily from 8 a.m. to 8:30 p.m.), or by filling out an online request form at vaccinatelacounty.com.

The clinic will offer the **pediatric Pfizer vaccine only. Appointments are required. No walk-ins will be available.**

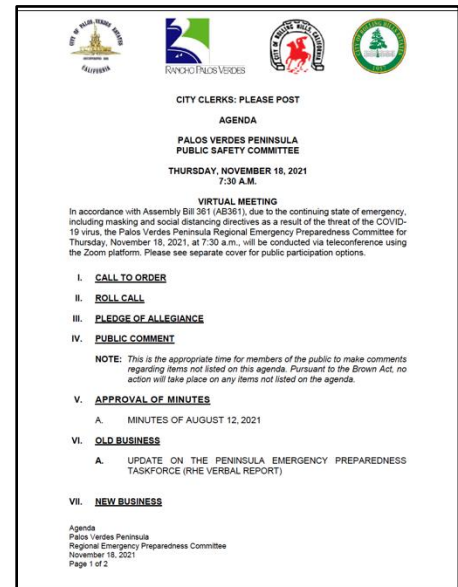

The RCLC is comprised of two council members from Rancho Palos Verdes, Rolling Hills, and Rolling Hills Estates and meets quarterly to oversee the cities' contract with the Los Angeles County Sheriff's Department.

EPC Monthly Meeting



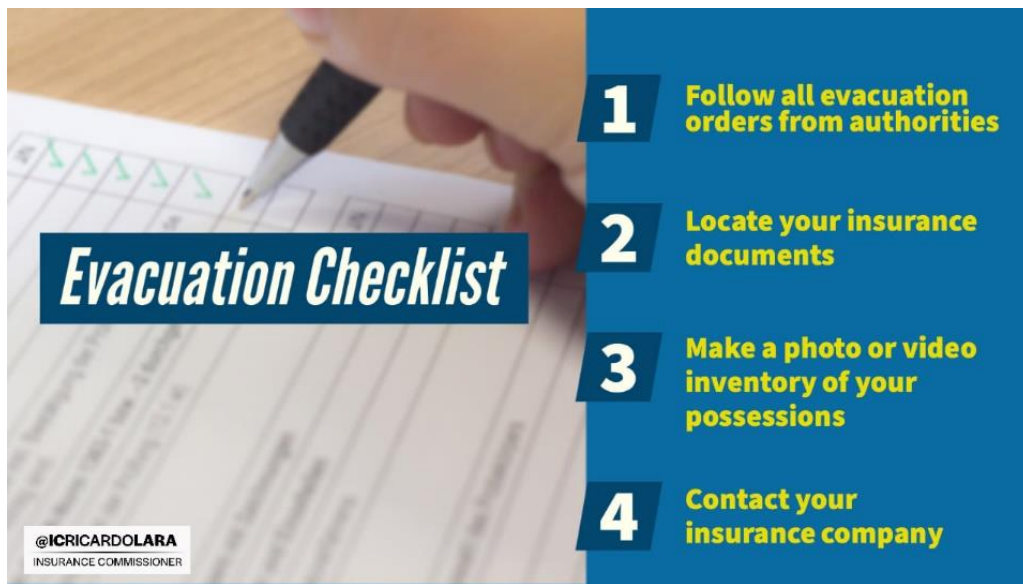

California Department of Insurance - Policyholder Evacuation Checklist

Evacuations and road closures are becoming more common as fire activity increases. Natural disasters strike in the blink of an eye, making it critical to plan ahead and take the necessary precautions to ensure that you and your family are completely prepared. Wildfires can have a significant financial and emotional impact, making it difficult for people to rebuild their lives in the aftermath of a disaster or other emergency. Access to personal financial, insurance, medical, and other records is critical during these trying times for quickly and efficiently initiating the recovery process. Individuals can take specific, effective steps to reduce the economic devastation and life-threatening risks associated with major disasters.

As wildfires threaten Californians once again, the California Department of Insurance (CDI) has compiled an Evacuation Checklist for Policyholders. In addition, the following are some Department of Insurance tips for consumers facing evacuation:

If you are evacuating:

- Follow all evacuation orders from local authorities.
- If time allows, locate your insurance policy documents and upload them to the Cloud using your mobile device.
- If time allows, make a photo or video inventory of your possessions. An inventory can be completed quickly and easily on your smartphone and safely stored in the Cloud. Download the free [home inventory guide](#) from the department's Web site.

After you evacuate:

- Homeowner and renter policies can help with evacuation and recovery expenses under *additional living expense* coverage, known as ALE. ALE coverage typically includes extra food and housing costs, furniture rental, relocation and storage, and transportation expenses.
 - The California Department of Insurance (CDI) urges evacuees to contact their insurers to verify their ALE coverage provision and limits and learn about the requirements and impact of using the coverage.
 - If financial losses due to a mandatory evacuation are significant, filing an ALE claim may be a good option for some policyholders. If so, it is critical to keep all receipts and document the date, time, and names of any insurance company employees you speak to regarding your coverage and details of the conversation.
- Policy provisions, including deductibles, vary by company; residents should check with their insurer or agent as soon as possible to confirm coverage, limits, and any other limitations and documentation requirements.
- Consumers should make sure any insurance agent or public adjuster offering their services has a valid license by checking online with the [Department of Insurance](#). Public adjusters cannot solicit business for seven calendar days after the disaster.

The California Department of Insurance's (CDI) Office of the Ombudsman is available to assist residents in resolving issues with their insurance companies. EMERGENCY PREPAREDNESS TIPS

Food Safety Tips -Thanksgiving Turkey

Next week, Americans will enjoy a delicious meal on Thanksgiving Day with family and friends – either in person or virtually. Taking the necessary steps toward safe food handling and sanitation will help protect you and your loved ones this year. To make sure your Thanksgiving meal is prepared safely, The [U.S. Department of Agriculture \(USDA\)](https://www.usda.gov/) is offering the following food safety information to reduce foodborne illness on Thanksgiving Day.

KEEP IT CLEAN:

Handwashing is the first step to protect you and everyone around your Thanksgiving table. It's also the best way to keep uninvited guests like bacteria out of your kitchen. In several observational studies, USDA found that consumers repeatedly failed to properly wash their hands, specifically not scrubbing their hands with soap for the 20 seconds required to remove germs.

There are five simple steps to properly wash your hands:

- **Wet** your hands with clean, running water (warm or cold), turn off the tap, and apply soap.
- **Lather** your hands by rubbing them together with the soap. Be



sure to lather the backs of your hands, between your fingers, and under your nails.

- **Scrub** your hands for at least 20 seconds.
- **Rinse** your hands well under clean, running water.
- **Dry** your hands using a clean towel.

Make sure food preparation surfaces and utensils are clean and sanitized before you start cooking.

- To clean your surfaces, you will need soap and hot water and a paper or dish towel. Use these to remove any dirt and debris you can see.
- Then, you should sanitize the surfaces to kill any remaining bacteria. Many different sanitizers can be used. An easy homemade sanitizing solution can be made by mixing one tablespoon liquid chlorine bleach with one gallon of water, or you can use a commercial sanitizer or sanitizing wipe. Allow to air dry and follow the label instructions on commercial sanitizers to determine whether you need to rinse food preparation areas after use.

AVOID CROSS-CONTAMINATION:

Improper handling of raw poultry can create an inviting environment for cross-contamination. As a result, harmful bacteria can spread to food and throughout the kitchen leading to a foodborne illness.

- Never place cooked food or fresh produce on a plate, cutting board, or other surface that previously held raw turkey.
- Be sure to Use separate cutting boards, plates, and utensils to avoid cross-contamination between raw meat or poultry and foods that are ready to eat.

COOK YOUR TURKEY THOROUGHLY:

A whole turkey is safe when cooked to a minimum internal temperature of 165°F as measured by a food thermometer in three parts: the thickest part of the breast, the innermost part of the wing, and the innermost part of the thigh.

REFRIGERATE PROMPTLY:

To make sure food stays safe to eat through the weekend, all perishable items should be refrigerated within two hours of when they finished cooking. If foods have been left out for more than two hours, they should be discarded.

- Carve the turkey into smaller portions to ensure it cools safely. It is not safe to refrigerate a whole cooked turkey.

- Consume leftover food within three to four days. If you're looking to stretch your turkey for a longer period of time, store the leftovers in the freezer for up to two to six months.
- Reheat leftovers thoroughly to an internal temperature of 165 °F.

In case the holiday meal becomes overwhelming, USDA has a toll-free hotline open on Thanksgiving Day from 8 a.m. to 2 p.m. ET, with live food safety experts available to help in English and Spanish. Call the USDA Meat and Poultry Hotline at 1-888-MPHotline (1-888-674-6854). The hotline is open regularly from 10 a.m. to 6 p.m. ET, Monday through Friday.

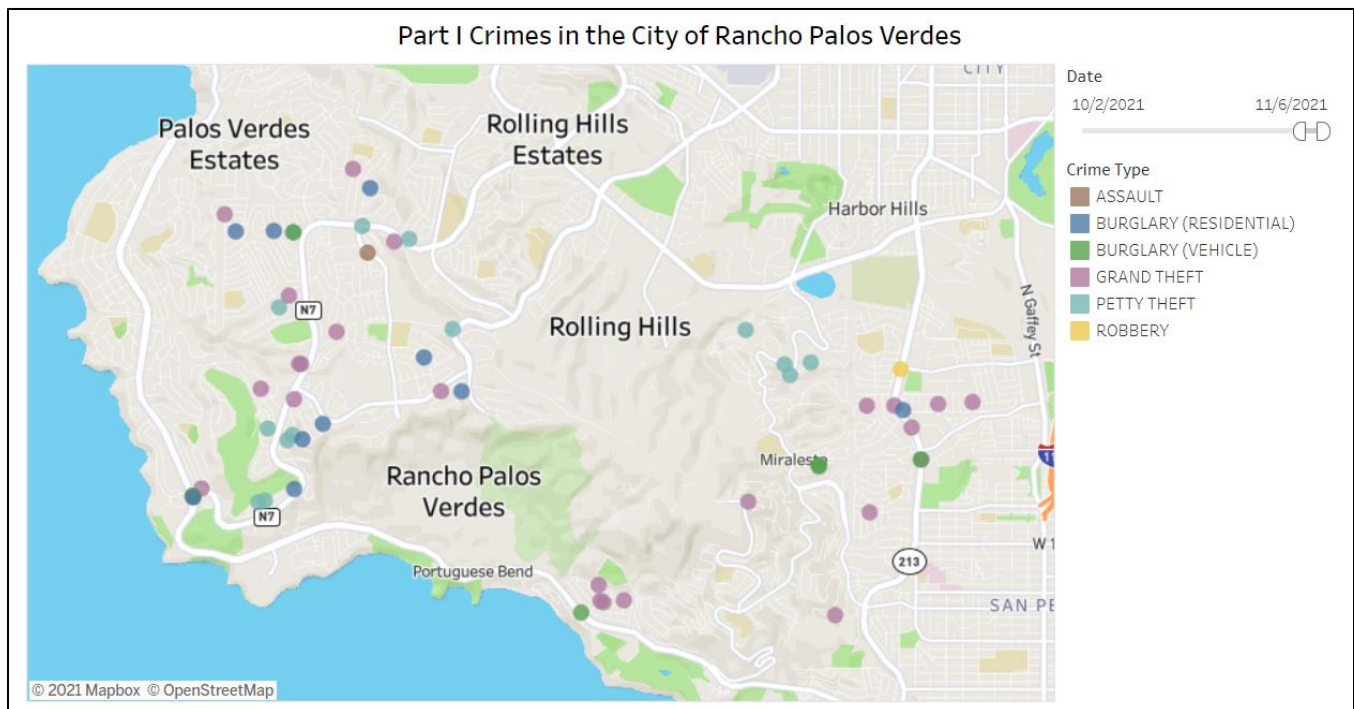

Tips to Prevent Thefts from Vehicles

Take steps today to prevent thefts from your vehicle. Residents are strongly encouraged to use “Lock It or Lose It” prevention tips every day. It only takes a matter of seconds for a thief to break into your car and grab your valuable items.

Look through the windows of your vehicle. What do you see? A bag on the passenger seat? A charging cord? A garage door opener? Change in a cup holder? Take it with you or remove it from plain view and be sure to close all windows and lock doors.

Follow these tips to help prevent vehicle burglaries:

1. Remove all valuable items from your car, including purses and electronics.
2. If you must leave valuables behind, put them in your trunk or locked glovebox before you reach your destination. Avoid doing so while in plain view.
3. Close all windows and lock your doors.
4. Park in a locked garage or well-lit areas.

If you see suspicious activity, report it immediately to the Lomita Sheriff’s Station at 310-539-1661. In case of emergency, call 9-1-1.

Catalytic Converter Etching Event and Suspects Arrested

On Saturday, November 13, the Lomita Sheriff’s Station hosted a Catalytic Converter Etching event to etch vehicle identification numbers on catalytic converters free of charge. Over 167 vehicles participated! Thanks to Lomita Station, Van Lingen Towing, the city of Lomita, and the Task Force for Regional Auto Theft Prevention (TRAP) for this successful event.

That evening, a resident in the area of Highridge Rd and Ridgeway Dr observed three males crawling under a car and stealing a catalytic converter called the Sheriff’s Station, providing a vehicle description and a license plate number for the suspects. Deputies were able to locate the vehicle and the three suspects, recovering recently stolen catalytic converters!



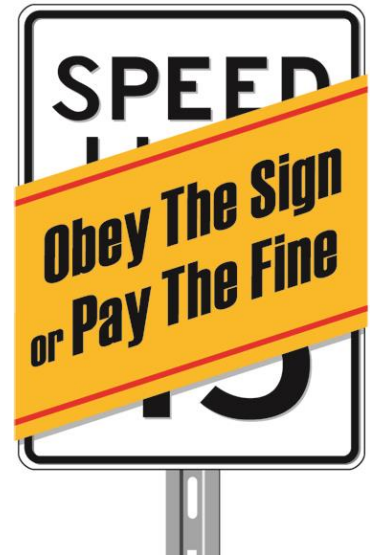

Let's Keep RPV Roadways Safe

To help reduce crashes, as well as prevent injuries resulting from speeding and aggressive driving, Lomita Station deputies conduct daily enforcement operations, but traffic enforcement alone will not solve the problem. Speeding and aggressive driving can only be reduced if drivers actively choose to do their part.

Your actions can help maintain and improve the safety of the roads in RPV.



Speeding is Not Worth the Cost

Speeding comes at a high price. For the speeding driver, there are fines and potentially lost driving privileges, and criminal charges. For other motorists, pedestrians, and bicyclists, there could be fatal consequences. According to the [NHTSA](#), about one-third of vehicle fatalities are the result of speeding. It is a high price to pay for traveling a few extra miles per hour. Speeding is not worth the cost!

How to Report Speeding

If you are aware of a dangerous condition or a continual traffic violation, report it to the Lomita Sheriff's Station's non-emergency line at 310-539-1661. If you see someone driving in a dangerously reckless manner, including swerving, speeding, texting, or behaving aggressively, **pull over** and call 9-1-1.

3rd Quarter Home Sale Value Trends Comparison

Detached single-family residential median sales price fell for the first time during the 3rd quarter after four quarters of continuous growth. Median sale prices fell 5.29% for the City of Rancho Palos Verdes. Los Angeles County as a whole grew by 0.59% during this same period.

During the 3rd quarter the average price of a detached single-family residential home decreased to \$1.89 million, while the median price decreased to \$1.7 million from \$1.8 million during the previous quarter. Median home price is more indicative of actual growth in value as it is not as strongly influenced by single large value home sales that are outliers.

New Traffic Signal at Intersection of Palos Verdes Drive South and Palos Verdes Drive East Update



Concrete was placed for the last pole foundation on Tuesday of this week for the new traffic signal project at the intersection of Palos Verdes Drive South and Palos Verdes Drive East. Work will continue this week with the, installation of the new controller cabinets and wires. A crane is scheduled for next Monday and Tuesday (November 22 and 23) for

the installation of the poles.

Work is limited to approximately 8:30 a.m. to 4:30 p.m. Monday through Friday, and no work is scheduled for next Wednesday, Thursday, and Friday (November 24, 25, and 26) in observance of the Thanksgiving holiday. Regular partial eastbound and westbound bike lane closures around the intersection. Expect delays, proceed cautiously through the work zone, and follow all signs and instructions. The signal is expected to be complete and operational by the end of December.

Road Work Along PVDS

Green Hills Memorial Park Updated Public Notice for Use of the Existing Vaults on Inspiration Slope Mausoleum Roof



On November 16, the City Council reviewed a request by Green Hills Memorial Park to utilize existing stored concrete vaults for burials on the rooftop of the Inspiration Slope Mausoleum. At the meeting, the City Council voiced concerns about the potential impacts to the adjacent residences and stated that prior to rendering a decision, they would like to visit the site as well as some adjacent residents'

properties, in order to discern if there would be potential adverse impacts caused by the rooftop burials. The City Council directed Staff to bring a resolution to the December 7 City Council meeting, where any new conditions of approval could be reviewed and incorporated into a Condition Use Permit revision should the rooftop interments be approved. In response to this direction, on November 18, the Planning Division will issue a public notice for Revision "F" to the Green Hills Memorial Park Conditional Use Permit No. 55 to inform the public of Green Hills Memorial Park's request to utilize existing stored concrete vaults for burials on the rooftop of the Inspiration Slope Mausoleum. Natural Communities Conservation Plan & Habitat Conservation Plan (NCCP/HCP) Code Amendment Update

On December 14, 2021, Staff will be presenting proposed code amendments to the Planning Commission to establish development standards such as lighting, fencing, and landscaping for lots abutting the Palos Verdes Nature Preserve (Preserve) in order to comply with the City's NCCP/HCP, which was adopted in



2019. The goal of the NCCP/HCP is to maximize the benefits to wildlife and vegetative communities within the Preserve while accommodating appropriate development within the City. Staff is working with State and Federal Wildlife agencies, who helped craft adopted NCCP/HCP, on the preparation of the proposed code amendments. A public notice will be issued on November 25, providing the public a 15-day comment period on the proposed amendments prior to the December 14 Planning Commission meeting. If recommended for approval, staff intends to present the proposed amendments to City Council in early 2022. Swale Maintenance Season Reminder

Starting in December, the Code Enforcement Division will be distributing letters city-wide reminding residents of their need to maintain swales and bench drains located on their properties from leaves, overgrown vegetation, and debris to prevent overflows and property damage. Appropriate maintenance includes clearance of all leaves, vegetation, and other debris or obstructions from the drain. Improperly maintained swales and bench drains can result in property damage from slope failure, erosion, or excess storm-water runoff. The City found that after a heavy rainstorm, there are often slope erosion problems on private property that were caused by unmaintained drainage swales and bench drains that overflowed, resulting in the slope being eroded or failing. It is the responsibility of property owners who have swales and bench drains on their property to maintain them so that they function properly. The letter will also include a reminder that the City's Municipal Code does not permit the construction of structures within or above a drainage swale or on a slope on or equal to 35% or greater. 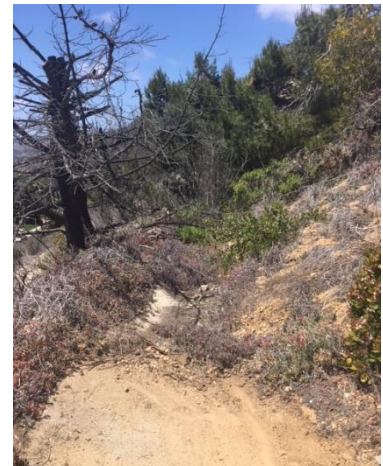


Figure 1 Swale Violation

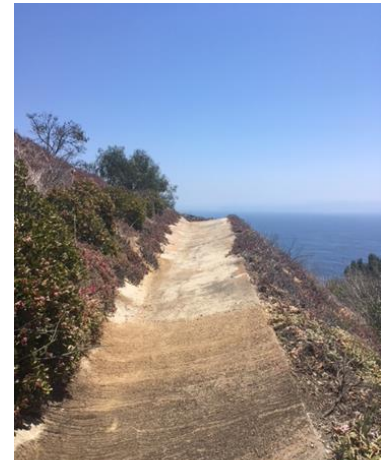


Figure 2 Compliant Swale

Preserve-Related Municipal Code Changes

On November 2, 2021, the City Council introduced Ordinance No. 653 to regulate the operation of certain motorized vehicles and to prohibit motorized bicycles and electric bicycles in the City's parks, Preserve, beaches, and recreational facilities. Ordinance No. 653 also establishes a policy for using other power-driven mobility devices in recreational areas in accordance with the Americans with Disabilities Act. The second reading of this ordinance was adopted at the November 16 City Council meeting, and it will go into effect on December 16.

ParkMobile Parking System Update

Following City Council action on October 5, the following changes have been made to improve the ParkMobile parking reservation system in the Del Cerro area:

- Allow same-day reservations (cutoff one hour prior to reservation start) with change to one-hour blocks of time at a pro-rated amount if feasible.
- Create simplified access to the ParkMobile reservation link
- Improve instructional signs
- Discontinue requiring reservations for Recreational Residential Parking Permit holders
- Incorporate a QR code that directs people to the reservation page.

Reservations currently end at 5:45 p.m.

A further update on the ParkMobile parking system and Preserve parking issues is scheduled for the December 21 City Council meeting. A total of 130 ParkMobile reservations were made between November 8-14: 95 paid reservations and 35 free reservations. This was the highest number of paid reservations in a week since the ParkMobile program started. Residential Parking Permit holders can park within Del Cerro Park. Staff will continue to report on total reservations and other data points each week.
