During the past year, which marked the beginning of our reopening and recovery from the pandemic, the City achieved many significant milestones.


- Achieved a ranking as the fourth safest city in the State of California.

The City is committed to continuing to serve you and we are looking forward to continued progress and high levels of service in the new year. I, and the City Council, wish you a safe, happy holiday season.

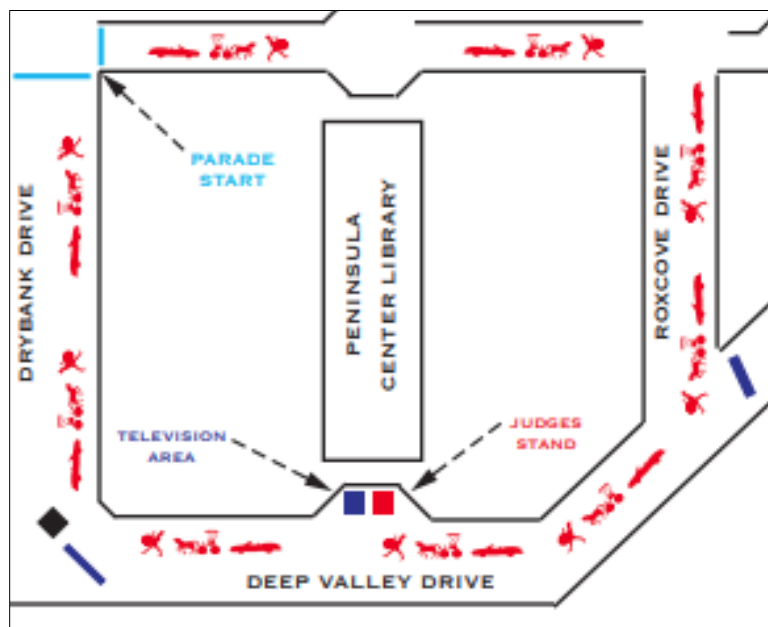

Don't Miss the PV Peninsula Parade of Lights on December 4!

The City of Rolling Hills Estates is excited to once again light up the season with the **Palos Verdes Peninsula Holiday Parade of Lights on Saturday, December 4, 2021.** This annual event will take place from **6:00 p.m. to 7:30 p.m.**, with festive floats and cheerful participants parading through the commercial district along Silver Spur Road to Roxcove Drive to Deep Valley Drive and concluding on Drybank Drive (**note* the route has been slightly modified and will not be going through the Promenade on the Peninsula mall this year*).



Serving as this year's **Grand Marshal is MLB World Series Champion and pitcher Kenley Jansen.** Kenley Jansen is a professional baseball player born in the island country of Curaçao. He has been a resident of the Palos Verdes Peninsula since 2017. Kenley made his Major League debut for the Los Angeles Dodgers in 2010. Over his 11-season career with the Dodgers, he totaled 350 Saves and 1,022 Strikeouts. Kenley was named the National League Reliever of the Year (Trevor Hoffman Award) in 2016 and 2017. In

addition, he is a World Series Champion (2020) and a three-time MLB All-Star (2016-18). Kenley likes to explore PV in his free time, play his piano and bass guitar, and spend time with his wife Gianni and four children.

Also featured are retired Rolling Hills Estates Councilmember and Mayor, Judith Mitchell as Hometown Marshal and the Palos Verdes Peninsula Chamber of Commerce Citizens of the Year, our local First Responders, which include Los Angeles County Fire, Sheriff and EMTs, Palos Verdes Estates Police Department and local hospital representatives from Torrance Memorial, Little Company and Kaiser Permanente.

Members of the Rancho Palos Verdes City Council will also participate in the parade.

To showcase the unique character of the Palos Verdes Peninsula, community and civic groups, school and youth organizations, marching bands, drill teams, equestrian units, local businesses, and others are encouraged to participate in the parade. And of course, it wouldn't be the traditional event if we didn't have Santa himself joining in on the fun.

Awards are given in various categories: Sweepstakes (Musical), Equestrian Sweepstakes, Best Commercial Float, and Mayor's Trophy for the best local entry and the Susan Seaman's Founders Award. West Basin Escalates Water Shortage Contingency Plan to Shortage Level Three

Last week, the West Basin Municipal Water District Board of Directors moved to escalate its Water Shortage Contingency Plan (WSCP) from shortage level one to level three for its service area representing nearly one million people in 17 cities (including Rancho Palos Verdes) and unincorporated areas in Los Angeles County.

Given recent emergency drought declarations by the Governor and water wholesaler Metropolitan Water District of Southern California and the need to proactively ensure water reliability in the midst of worsening conditions, the West Basin Board declared a shortage level three to reflect its resolution seek immediate increased water savings.

WSCP level three will increase regional drought response actions to include more water use efficiency measures and expanded outreach and public information to support water savings in the West Basin communities.

West Basin currently offers grass replacement rebates of up to \$5 for every square foot of grass replaced with drought-resilient landscaping, with plans to provide even higher rebate levels to the region's public agencies.

In addition, on Nov.16, West Basin launched its SUPER-CALI-FRUGALISTIC drought campaign, calling on district communities to "Save Water, Save California." The campaign challenges individuals in the service area to be prudent with their water use to preserve limited supplies for the region and State. The campaign will also offer memorable community outreach experiences like drought kit giveaways that highlight the substantial benefits of West Basin's water use efficiency programs in the months ahead.

West Basin's WSCP includes six standard water shortage levels, corresponding to increasingly severe shortage conditions compared to normal reliability conditions. Each level aligns with specific response actions that West Basin can implement to address and resolve any current or expected supply-demand gaps created by the associated water shortage. At present, West Basin is not implementing mandatory water use reductions or rationing. The 2021 WSCP and a summary of drought actions is available online at westbasin.org/drought.

Cal Water Encourages Water Conservation

At the Council meeting on December 7, Cal Water representatives will present conservation tips and rebates available to customers.

Cal Water offers rebates on a variety of high-efficiency products. They also have a Smart Landscape Tune-Up program, where a contractor will make recommendations on how you can improve water conservation in your landscaping, and Cal Water will provide the recommended purchases and installations for free! Help Document the King Tides December 4-5

The California Coastal Commission is calling on the public to help photograph upcoming King Tides for the [California King Tides Project](http://california.kingtides.net).

A "King Tide" is a non-scientific term used to describe very high tides caused when there is an alignment of the gravitational pull between the sun, moon, and Earth. When King Tides occur during floods or storms, water levels can rise higher and potentially cause great damage to the coastline and coastal property.



Documenting these tides helps us preview the impacts of sea-level rise and understand how our shoreline is affected by high water today.

The next King Tides will arrive December 4-5. If you're able to take photos at the coast during King Tides safely, you will be contributing to an important community science effort. L.A. County Prepares Response to Potential Challenges Presented by Omicron

The Los Angeles County Department of Public Health (Public Health) continues to track variant cases in L.A. County. While the Delta variant remains the dominant variant detected among L.A. County residents and continues to account for 100% of cases sequenced, the Omicron variant identified by the World Health Organization in South Africa as a “variant of concern” is being closely monitored as Public Health works with others across the globe to prepare to mitigate the challenges a new variant of concern may pose for residents and workers across the county.

This includes adhering to the travel restrictions issued by the White House and the CDC.

Although more studies are needed to determine whether the Omicron variant is more contagious, more deadly, or resistant to vaccine and treatments than other COVID-19 strains, as with any variant of concern that is found in other countries, there are important steps we all need to take to protect ourselves from COVID-19 and from emerging variants of concern.

**UPDATE ON THE
OMICRON VARIANT**

New variants will continue to evolve as long as there are large proportions of unvaccinated people.

The Omicron Variant identified by the WHO as a “variant of concern” is being closely monitored as we work with others across the globe to prepare to mitigate the challenges it may pose for LA county.

The best way to protect yourself is to get vaccinated, get your booster when eligible, wear a mask, get tested, and quarantine if infected or have been in close contact with someone who has COVID-19.

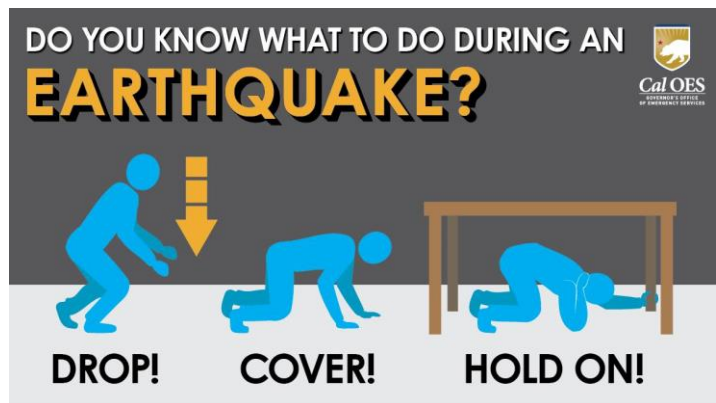
The most important strategy remains to make sure that everyone five years and older get fully vaccinated or receives their booster dose as quickly as possible to reduce transmission of the virus currently dominating across the county. The vaccines are effective against the Delta variant and earlier strains of the virus, which makes us hopeful that the approved vaccines will also provide some protection against Omicron. However, given that there continues to be a substantial transmission of COVID-19 and we have uncertainty about the level of vaccine efficacy against this new variant of concern, all residents across L.A. County need to be sure to adhere to the masking requirements and wear a mask when indoors or at large outdoor mega-events regardless of vaccination status. Public Health continues to strongly recommend that individuals wear a mask when at any crowded indoor or outdoor events. Residents are reminded that they are legally required to isolate if they have a positive COVID test result and that vaccinated close contacts with symptoms, and unvaccinated close contacts need to quarantine. Testing is an important tool in early detection of infection to reduce spread, and residents who have traveled for the holidays are encouraged to get tested if they traveled internationally or to locations in this country with high transmission rates, or they participated at gatherings and events with large numbers of people, some of whom may be unvaccinated.

While we are still learning much about Omicron, we know enough about COVID to take steps to reduce transmission as we prepare to better understand the additional strategies that may be needed to mitigate this new variant of concern.

Earthquakes can happen at any time, often with little to no warning. The widespread devastation caused by a catastrophic earthquake has the potential to cut you off from the rest of the world for several days. Following an earthquake, first responders will arrive on the scene as soon as possible to assist you, but it may take some time for them to reach you.



Preparing for disaster is not a matter of if—it's a matter of when. Disasters affect millions of people each year on a personal, business, local community, or national level. Although it may feel easier to put off preparing for emergencies, a disaster can occur at any time. Some disasters give a warning, such as a storm preceding a flood. Others, such as earthquakes, give little or no warning. Once a disaster happens, the time to prepare is gone. The following are ten essential actions you can complete today to ensure the safety of you and your family during a disaster.

The time to begin planning for an emergency is before one occurs. To ensure the safety of your family and loved ones in the event of an emergency, Gail Lorenzen, Volunteer Coordinator for Rancho Palos Verdes Neighborhood Watch, has developed an in-depth educational series for all residents that includes emergency preparedness information that include tips on how to prepare yourself and your family for the next "Big One."

Holiday Decorating Safety Tips

Decorating is one of the best ways to get in a holiday mood, but emergency rooms see thousands of injuries involving holiday decorating every season.

When decorating, follow these tips:

- Keep potentially poisonous plants – mistletoe, holly berries, Jerusalem cherry, and amaryllis – away from children
- If using an artificial tree, check that it is labeled “fire-resistant.”
- If using a live tree, cut off about 2 inches of the trunk to expose fresh wood for better water absorption; remember to water it and remove it from your home when it is dry
 - Place your tree at least 3 feet away from fireplaces, radiators, and other heat sources, making certain not to block doorways
 - Avoid placing breakable ornaments or ones with small, detachable parts on lower tree branches where small children can reach them
- Only use indoor lights indoors and outdoor lights outdoors, and choose the right ladder for the task when hanging lights
 - Replace light sets that have broken or cracked sockets, frayed or bare wires, or loose connections
 - Follow the package directions on the number of light sets that can be plugged into one socket
 - Never nail, tack, or stress wiring when hanging lights, and keep plugs off the ground away from puddles and snow
 - Turn off all lights and decorations when you go to bed or leave the house

Watch Out for Fire-Starters

The use of candles and fireplaces, combined with an increase in combustible, seasonal decorations in many homes during the holidays, means more risk for fire.

Keep these safety tips in mind when using candles and fireplaces:

- [Candle Safety](#): Place candles where they cannot be knocked down or blown over and out of reach of children.
- Keep matches and lighters up high and out of reach for children in a locked cabinet.

- Use flameless, rather than lighted, candles near flammable objects.
- Don't burn trees, wreaths, or wrapping paper in the fireplace.
- Always use a screen on the fireplace when a fire is burning.
- Never leave candles or fireplaces burning unattended or when you are asleep.
- Check and clean the chimney and fireplace area at least once a year

Pet Preparedness

Pets are an essential part of our society, and for many, an extension of their household and members of the family. In an emergency, your pets will be even more dependent on you for their safety and well-being. Although, when a disaster strikes, it is too late to consider how you will care for your pets, that is why it is important to incorporate a plan for your pets in your family's emergency plans. The following are some basic tips that will help ensure you and your pets are prepared in the face of an emergency:



MAKE A PLAN:

- **Have an evacuation plan for your pet:** Many public shelters and hotels do not allow pets inside. Identify a safe place where you can take your pets before disasters and emergencies happen.

- **Develop a buddy system:** Before an emergency, be sure to plan with your neighbors, friends, or relatives to make sure that someone is available to care for or evacuate your pets if you are unable to do so.
- **Have your pet microchipped:** Make sure to keep your address and phone number up-to-date and include contact information for an emergency contact outside of your immediate area.

BUILD A KIT:

Ensure your pet is prepared for an emergency by assembling a pet disaster kit in advance of a disaster. Be sure to discuss the types of things you should include in your pet's emergency first aid kit with your veterinarian. Below are basic items you should include in your pets' disaster kits.

Your kit should include:

- Sturdy leashes, harnesses and/or carriers to transport pets safely and ensure that they can't escape.
- Food, drinking water, bowls, cat litter/pan, and a manual can opener if your pet eats canned food.
- Medications and copies of medical records are stored in a waterproof container.
- Current photos of you with your pet(s) in case they get lost. Since many pets look alike, this will help to eliminate mistaken identity and confusion.
- Information on feeding schedules, medical conditions, behavior problems, and the name and number of your veterinarian in case you have to foster or board your pets.
- Pet beds and toys, if easily transportable.

TIPS FOR LARGE ANIMALS:

Emergency preparedness is important for all animals, but it is especially important for horses and larger animals because of their size and special transportation needs.

Consider these tips as you prepare your evacuation plan:

- Before the emergency, make arrangements to shelter your animals at two different locations far apart from each other.
- If you have large animals, evacuate when you hear the evacuation warning.
- Train horses to lead and trailer so that they become comfortable with the process.

- Keep your truck and trailer in safe, working condition (gas tank full). If you don't have a truck and trailer, make arrangements in advance to have someone evacuate your animals.
- Know who is evacuating your animals. Be sure to exchange phone numbers, California Driver's License numbers and other relevant information with the person evacuating your horse. Know where your animals will be taken.
- Network with your neighbors prior to an emergency. Work together to help horse/large pet owners on your street who do not have horse trailers or who are not home during an emergency.

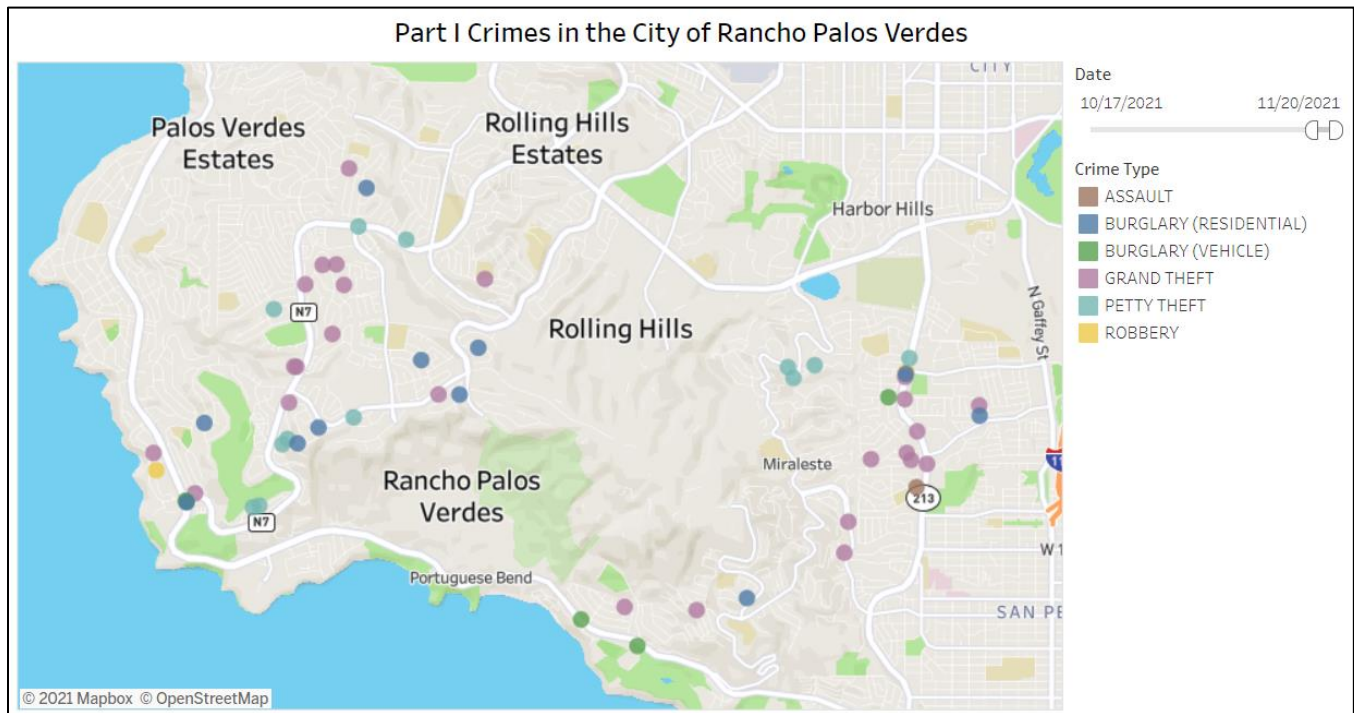

Tips to Prevent Thefts from Vehicles

Take steps today to prevent thefts from your vehicle. Residents are strongly encouraged to use "Lock It or Lose It" prevention tips every day. It only takes a matter of seconds for a thief to break into your car and grab your valuable items.

Look through the windows of your vehicle. What do you see? A bag on the passenger seat? A charging cord? A garage door opener? Change in a cup holder? Take it with you or remove it from plain view and be sure to close all windows and lock doors.



Follow these tips to help prevent vehicle burglaries:

1. Remove all valuable items from your car, including purses and electronics.
2. If you must leave valuables behind, put them in your trunk or locked glove box before you reach your destination. Avoid doing so while in plain view.
3. Close all windows and lock your doors.
4. Park in a locked garage or well-lit areas.

If you see suspicious activity, report it immediately to the Lomita Sheriff's Station at 310-539-1661. In case of emergency, call 9-1-1.

Announcing RPV's 10 Days of Holiday Safety

Follow along on the City's Public Safety listserv and the City's Nextdoor page for simple safety tips to share with friends and neighbors. Or, watch for a compiled list in this report!

Day 1: Practice Your 9pm routine

Every night at 9pm, the community is encouraged to lock all gates and doors, including side gates and garage doors, turn on exterior lights or set them on a timer if you plan to be away, and remove all valuables from plain view.



Day 2: See Something, Say Something!

Be aware of your surroundings. If you see something suspicious, call the Lomita Sheriff's Station at 310-539-1661.

Day 3: Prevent Package Theft

Arrange for delivery alerts and retrieve your packages as soon as they are delivered. If you cannot retrieve your package, ask a neighbor to bring it in for you or have the package shipped to the store.

Day 4: Safe Shopping

When shopping in a store, make sure your purse or wallet is secured on your person. Never leave purchased items unattended. If shopping online, make sure you are using a trusted site and be wary of providing your personal information.

Day 5: Secure Your Vehicle

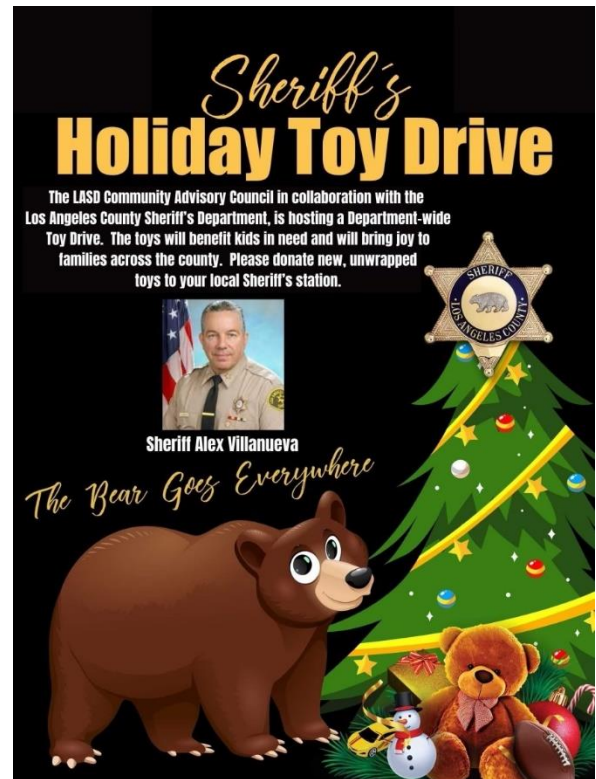

New Traffic Signal at Intersection of Palos Verdes Drive South and Palos Verdes Drive East Update

The traffic signal poles and intersection street lights were installed last week for the new traffic signal project at the intersection of Palos Verdes Drive South and Palos Verdes Drive East. Work is continuing this week with the installation of new curb ramps and modifying the existing median, as well as inspection by Southern California Edison (SCE) of the conduit and installed service panel. Once SCE has verified the conduit and service panel are acceptable, SCE will schedule a date to establish power for the new signal. The signal is expected to be complete by the end of December.



Work is limited to approximately 8:30 a.m. to 4:30 p.m. Monday through Friday. Regular partial eastbound and westbound bike lane closures will occur around the intersection. Expect delays, proceed cautiously through the work zone, and follow all signs and instructions.

Maintenance Tip

As the holiday season is upon us and we welcome family and friends to a holiday feast, don't pour cooking grease down the drains. Once in the plumbing, cooking grease solidifies and causes stoppages. The best way to dispose of fat, oil, or grease is to put it in a disposable container, let it cool, and then toss it in the trash.

Maintenance Activities

In addition to regularly scheduled maintenance and repairs, Public Works performed the following:

PARK MAINTENANCE

- Public Works continues weekly landscape maintenance at all City parks.
- Public Works continues daily cleaning and sanitizing parks' facilities.
- Ruts and divots in the Decomposed Granit (DG) walking paths at the Point Vicente Interpretive Center were filled by the Public Works landscape crew.



- Public Works upgraded the dog ramp in the large dog section at the Rancho Caninos Dog Park at City Hall. The previous wooden ramp was worn and showed signs of deterioration. A new non-slip ramp was installed for our four-legged friends to enjoy.





Street Median and Public Right of Way Landscape Maintenance

- Public Works Landscape crews completed weed removal and bush trimming in the medians on Crest Road, Montemalaga Drive, Highridge Road, Crenshaw Boulevard, and Silver Spur Road.



- Public Works Landscape crew removed illegally dumped tree debris which obstructed the sidewalk near Hawthorne Boulevard and Vallon Drive.



- Public Works Landscape crew cleared weeds and brush along Calle Entradero to enhance the right of way and trail.



Public Right of Way/Roadway Repairs

- Public Works completed roadway and sidewalk deviation repairs at the following locations:
 - 5919 Mossbank Drive: Deviations were ground to create a smooth sidewalk surface.
 - 30684 Palos Verdes Drive East: An asphalt ramp was created for lifted areas of the sidewalk.
 - 4319 Dauntless Drive: Sidewalk and roadway deviations were filled with asphalt crack filler and subsequently smoothed.
 - 6521 Via Siena: Concrete patches were applied to cracked curb and gutters resulting from trees.



- Public Works repaired large sections of damaged guardrail along Palos Verdes Drive East. The following sections were repaired this week:
 - Palos Verdes Drive East near Colt Road, 225 feet of guardrail was replaced.
 - Palos Verdes Drive East between Headland Drive and Horseshoe Lane, 40 feet of guardrail were replaced.



- On Silver Spur and Ironwood Street, Public Works removed damaged fencing located on the inner Silver Spur Road median. Additionally, the dry brush was cut back.





- Public Works trimmed, removed debris, and excess vegetation on two palm trees at City Hall to facilitate decorating for the upcoming holiday season celebrations at City Hall.



Graffiti Removal

- **Forty-Six** cases of graffiti were reported and removed this week.
- The RPV Graffiti reporting App can be downloaded for Android and Apple devices under the name of "**RPV Clean.**" Residents can help keep RPV looking great by using this App.



Emergency Response Items

- Public Works responded to fallen debris which covered the bike lane along Palos Verdes Drive East between Via Colinita and Crest Road. The debris was removed quickly to maintain roadway and vehicular safety.

UPDATE: Site Visit to Green Hills Memorial Park- Inspiration Slope

On November 16, the City Council considered a request by Green Hills Memorial Park to utilize existing stored concrete vaults for burials on the rooftop of Inspiration Slope Mausoleum. As part of this action, the City Council continued the public hearing to December 7 to allow City Council members an opportunity to visit the project site, in order to assess further assess the proposal.



On November 22, some City Councilmembers along with City staff and representatives from Green Hills and the Peninsula Verde HOA visited the Inspiration Slope Mausoleum rooftop to better understand the proximity of the proposed rooftop burials to the adjacent residential neighborhood. The visit also included two properties in the adjacent Peninsula Verde neighborhood. Public Notice Issued for Natural Communities Conservation Plan/Habitat Conservation Plan (NCCP/HCP) Code Amendments

On December 14, staff will be presenting proposed code amendments to the Planning Commission to establish development standards for lots and equestrian-related uses abutting the Palos Verdes Nature Preserve and lots outside of the Preserve that support Coastal Sage Scrub to comply with provisions of the City's



NCCP/HCP. Provisions include, but are not limited to, fencing, prohibiting direct access to the Preserve and open space lots from private property, lighting, landscaping requirements, and biological monitoring for cowbirds on equestrian facilities within 500 feet of the Preserve.

The goal of the NCCP/HCP is to maximize the benefits to wildlife and vegetative communities within the Preserve while accommodating appropriate development within the City. Staff is working with State and Federal Wildlife agencies, who helped craft the adopted NCCP/HCP, on the preparation of the proposed code amendments.

A [public notice](#) was issued on November 25, providing the public a 15-day comment period on the proposed amendments prior to December 14 Planning Commission meeting. If recommended for approval, staff intends to present the proposed amendments to City Council in early 2022. Drafts of the proposed amendments are available at the Community Development Department. 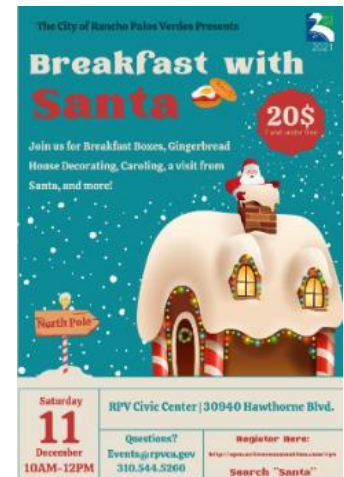

Following City Council action on October 5, the following changes have been made to improve the ParkMobile parking reservation system in the Del Cerro area:

- Allow same-day reservations (cutoff one hour prior to reservation start) with change to one-hour blocks of time at a pro-rated amount if feasible.
- Create simplified access to the ParkMobile reservation link
- Improve instructional signs
- Discontinue requiring reservations for Recreational Residential Parking Permit holders
- Incorporate a QR code that directs people to the reservation page.

Reservations currently end at 5:45 p.m.

A further update on the ParkMobile parking system and Preserve parking issues is scheduled for the December 21 City Council meeting. A total of 102 ParkMobile reservations were made between November 15-21: 66 paid reservations and 36 free reservations. A total of 152 ParkMobile reservations were made between November 22-28: 115 paid reservations and 37 free reservations. The 115 paid reservations were the highest total yet for a week. Residential Parking Permit holders can park within Del Cerro Park. Staff will continue to report on total reservations and other data points each week.

Abalone Cove Reserve, Park and Beach

Portuguese Bend Reserve

New Park Mobile signage has been updated and installed at Crenshaw Boulevard. The signage includes the modification allowing reservations to be made up to one hour before the start of the reservation time block. On Wednesday, November 24, a water main break occurred near Vanderlip Trail in the Portuguese Bend Reserve. CalWater was notified and made emergency repairs to ensure the water was shut off. The grade dips previously installed by the Volunteer Trail Crew decreased further damage to the trail. Volunteers quickly repaired the trail damage after the incident. The trail was temporarily closed from Burma Road Trail junction to Kubota Trail junction until Saturday, November 27.



Before and after pictures of ruts created on Vanderlip Trail by the water main break on November 24. In some locations, ruts were as deep as 10-12 inches deep and up to 6-12 inches wide.



On Monday, November 29, Los Angeles County Fire Department and Torrance City Fire Department conducted training at Del Cerro Park, Filiorum Reserve, and Portuguese Bend Reserve. No trail closures took place. Training allows personnel to use their equipment in real-world conditions and familiarize crews with trails and other factors such as wind, fuel loads, etc.



Image above was taken from Crenshaw Boulevard, depicting LACFD Crews testing water pressure and distance for water resources.

The Palos Verdes Peninsula Land Conservancy installed a wooden fence barrier on Ishibashi Trail to deter unauthorized use. The area was cleared by crews for access to identify and remove invasive Acacia trees as part of a fuel load reduction project.



San Ramon Reserve

The stonework on the San Ramon Reserve Monument sign located near Palos Verdes Drive East and Palos Verdes Drive South was damaged. Due to nearby vehicle debris, the damage is believed to be caused by a vehicle collision. No further information is known at this time. The City is working with the Palos Verdes Peninsula Land Conservancy to determine repairs.





Parks and Trails Open

Beaches, parks, and trails, including the Palos Verdes Nature Preserve, are open. In accordance with the L.A. County and State of California Health Officer Orders, private, informal, outdoor gatherings outdoors are permitted. L.A. County continues to urge everyone, especially those who are not or cannot be vaccinated against COVID-19, to exercise caution and good judgment as physical distancing requirements and capacity limitations have lifted. In addition, all individuals must follow the requirements in the Guidance for the Use of Face Coverings issued by the L.A. County Department of Public Health.

When participating in gatherings or activities, all park rules must be followed, and attendance at informal gatherings cannot exceed thresholds in the Special Event Permits ordinance.
