



DISASTERS DON'T PLAN AHEAD - YOU CAN

Disaster can happen at any time, often with little to no warning. The widespread devastation caused by a catastrophic disaster has the potential to cut you off from the rest of the world for several days. Following a disaster, emergency rescuers will arrive on the scene as soon as possible to assist you, but it may take some time.

The time to start thinking about what to do in an emergency is before it happens. By following some simple guidelines, you can help prepare your family, neighborhood, business, or school to be better prepared and self-sufficient after the next disaster.



MAKE A PLAN

Making a family emergency plan is a good place to start. Because your family may not be together when a disaster strikes, it is critical to plan communication strategies with your friends and family before, during, and after a disaster. Your plan should include every member of your household, including pets, and should take into account the specific needs of your household. Fill out a family emergency plan or use it as a guide to create your own plan today.

LADERA LINDA COMMUNITY PARK: THE FUTURE IS NEAR



It's not every day that a new RPV park is built; heck, it's not even every decade. Eight years of planning, dozens of large and small community meetings, multiple design iterations, numerous City Council meetings, and 1,001 details and decisions have led Ladera Linda Community Park to the edge of construction. Forty years after the former school site became a City park, the City Council approved a construction contract on March 1 for the demolition of the existing buildings, and the construction of a new Community Center and improved amenities including trails and walking paths, paddle tennis and basketball courts, a naturalistic playground, and grass fields.

The general contractor is expected to mobilize in late March to early April 2022. The contract requires construction to be completed within approximately 15 months of commencement. However, unforeseen conditions and weather may be encountered during the course of construction, so the project may extend beyond this duration. When completed, the RPV community and park visitors will have a park they can enjoy for another 40 years or more. Kudos to all the residents who participated so patiently in this complex and lengthy process; we hope you enjoy the end result!

LA COUNTY FIREFIGHTER JONATHAN FLAGLER: IN MEMORIAM

JONATHAN FLAGLER

OCTOBER 9, 1974 - JANUARY 6, 2022



On January 6, 2022, Los Angeles County Firefighter Jonathan Flagler tragically lost his life while bravely battling a house fire in Rancho Palos Verdes. Tributes have poured in for this devoted husband, father, uncle, friend, and hero who died serving the community that raised him. He was born at San Pedro Hospital, grew up in an unincorporated area that was later annexed to the City of Rancho Palos Verdes, and attended San Pedro High School. He lived in his childhood home in Eastview until 2009, when he moved to Orange County. Firefighter Flagler was a 21-year veteran firefighter who spent most of his career in the City of Vernon before he joined the Los Angeles County Fire Department in October 2020 and began working at Station 83 in Miraleste. The City is exploring options for a permanent memorial in RPV. His heroism and selfless devotion to others will not be forgotten.

SPOTLIGHT ON NORMA SALDAÑA



Tell me a little about your work experience and education before coming to Rancho Palos Verdes.

I've been in the outdoor recreation sector for 11 years, having started as a volunteer with the U.S. Forest Service under the Fisheries Resource Volunteer Corps conducting patrols along North Fork and East Fork in the San Gabriel Mountains, before its designation as a National Monument. Since then, I've served various positions across a variety of agencies including non-profit organizations and cities, all with an emphasis on natural resource protection, interpretation, and community engagement.

I obtained my bachelor of arts degree in science technology and society, with a minor in botany, and a master of science degree in regenerative studies from Cal Poly Pomona.

Open Space has been a major City priority for years but many of our readers may not know much about the City's relatively new Park Ranger Program.




FIRE SAFETY 101

Concerned about wildfire? You need to plan ahead. Create and maintain a defensible space around your home to increase your home's chance of surviving a wildfire. This space is needed to slow the spread of wildfire and to help protect your home from catching fire—either from a direct flame contact or radiant heat.

Brush fires continue to be a threat to life and properties within the Very High Fire Hazard Severity Zone. Property owners in high-risk wildlife zones are expected to maintain their properties free of hazardous or nuisance vegetation year-round, and properties shall have brush cleared by June 1, when LA County fire begins inspections. Owners found to be non-compliant will be assessed fines, and clearance costs performed by the County will be assessed to the parcel's property tax bill.

If property is found to be non-compliant, City staff will strive to gain voluntary compliance by working diligently with the property owner. A re-inspection of the property will occur after the 30-day compliance timeframe. If violation on the respective property continues with no attempt to correct the violation, owners can be subject to an administrative citation.

How to ORDER FREE AT-HOME TESTS

The U.S. Postal Service is taking orders for free COVID-19 at-home tests. The federal government is offering American households four free rapid antigen tests via mail, which can be ordered online at COVIDtests.gov. Orders ship free, usually in 7-12 days. Learn more at: covidtests.gov/faq.

If you have difficulty accessing the internet or need additional support placing an order, you can call 1.800.232.0233 (TTY 1.888.720.7489) to get help in English, Spanish, and more than 150 other languages – 8 am to midnight ET, 7 days a week.

211 LA CONNECTS RESIDENTS WITH COUNTY SERVICES

211 LA is the hub for residents looking for all types of health, human, and social services in Los Angeles County.

211 LA provides information and referrals to services that best meet individual needs, through a 24-hour 2-1-1 call line, and through website and chat services. It also provides an online community calendar, connecting people to local events that offer services and community connections.

Special programs provide outreach and education, service navigation, and care coordination to assist people with accessing and obtaining services.

211 LA maintains and updates LA County's official comprehensive database of over 50,000 health and human services, including mental health, older adult, disability, veteran, and youth services.

211 LA is available 24/7 by calling 2-1-1, or visiting 211la.org. 211 LA's purpose is to link people to community services, so that everyone in LA County can survive, thrive, and be empowered, no matter their situation or background.

Tell us about the Rangers and your role.

In 2019, the City began its first Park Ranger Program after 10 years of contracting out enforcement services. Bringing the program into the Recreation and Parks Department allowed the City to more than double its presence on trails at a significant cost savings. We currently have four full-time Park Ranger positions and three part-time Parking Enforcement Rangers.

The City owns and manages an extensive trail network, including the 30 miles of trails within the Palos Verdes Nature Preserve. Park Rangers patrol, educate, enforce, and provide public safety assistance on City trails. Education and rules enforcement is especially important in the Nature Preserve to protect the sensitive species and their habitats.

This is a lot of ground to cover! Park Rangers receive invaluable support from our management partners, partnering agencies, and a host of volunteers who build and repair our trails, serve as additional eyes and ears in the City's open space areas, and do so much more.

You started in 2020 right before COVID shut down trails. Tell us how you and your team has dealt with that unexpected event and other challenges.

It was a challenging start. The role of Park Rangers drastically changed gears from shaping behavior and preserving public safety within open space areas to keeping the public out of open space areas for public safety. Like most trail managers in Southern California, RPV experienced a surge of increased trail use when trails reopened in May 2021, with use doubling at popular trailheads, such as those near Del Cerro Park.

Rangers also increased public education and worked with the City's habitat manager, PVPLC, to monitor for damage to natural resources resulting from the increased use of the Nature Preserve.

What do you see as the future of the Open Space Management Division in RPV? What are the management and operational goals you'd like to see put into action?

I see continued popularity of the City's trails and natural areas, and the continued need for public education and enforcement to balance natural resource protection with public enjoyment of the City's amazing natural resources.

A goal I would like to put into action is increasing public involvement in management of the City's open space areas.

Another goal is increasing opportunities for local youth to learn about the City's natural resources. Park Rangers have had the opportunity to meet with Palos Verdes Boy Scout and Girl Scout Troops, and the Los Serenos de Point Vicente Docents offer public hikes throughout the City's trail system.

How do you enjoy spending time away from work?

When I'm away from work, I enjoy hiking and exploring local trails and learning the local history of the San Gabriel Mountains.

Favorite book, movie, type of music/sport etc...?

My favorite books are written by local historian, John W. Robinson, on the subject of the San Gabriels.

HOUSING QUESTIONS? WE'VE GOT HOUSING ANSWERS! RPV HOUSING ELEMENT UPDATE AND Q&A

Last year, the City embarked on a comprehensive process to update its state-mandated Housing Element for the 6th Cycle, which covers the 2021-2029 housing period. Below is a shortlist of frequently asked questions collected as part of the City's public outreach efforts along with staff responses:



Q: What is a Housing Element and why is it important?

A: All California cities are required to adopt a comprehensive General Plan to guide land-use planning decisions. The Housing Element is a key component that provides an analysis of a community's housing needs for all income levels.

Q: How much new housing is needed and where will it be constructed?

A: The Housing Element serves as a framework for the City to determine how to meet its state-mandated Regional Housing Needs Assessment (RHNA) allocation of zoning for 647 new housing units through 2029. A list of 43 potential housing sites was included in the initial draft of the housing element. The vacant and non-vacant sites are located throughout the City's commercial corridors and residential areas.

Q: What is the status of the RPV Housing Element Update?

A: City Staff is working with representatives from the State of California's Housing Community Development Department (HCD) to prepare a final draft of the housing element to present to appointed and elected officials as well as interested parties and members of the public. The final draft will include provisions to address HCD comments of their initial review of the draft document. As part of this action, City Staff will also present findings associated with the environmental review analysis of the proposed update.

Q: Will there be more opportunities for participation?

A: Yes, public participation is always welcome. The City's Planning Commission and City Council will consider a final draft of the document at duly noticed public hearings tentatively scheduled for early Spring 2022. A virtual town-hall meeting is also planned to answer questions and receive comments from the public regarding the final draft.

CIVIC CENTER PROJECT (UNDER NEW MANAGEMENT)



New project management that is! After a thorough search, Griffin Structures (Griffin) was selected as the Civic Center Project Manager on February 15. While the intent is to have Griffin onboard until the end of construction, the initial focus is on Phase 1 of the project: Project Feasibility and Preliminary Site Planning. Using the City Council-approved Program Document that lists potential site components and approximate square footage, Griffin will work with Staff, the Civic Center Advisory Committee and the public to perform the following key Phase 1 steps:

- Initial Project Document Review
- Preliminary Site Planning
- Geotechnical Investigation
- Delivery Analysis
- Project Schedule
- Project Budget

The City also entered into an agreement with the renowned architecture firm Gensler to work on site planning. Gensler has an in-depth understanding of the site due to its facilitation of the program document process.


SPRING CRIME CORNER



Public safety is a top City priority. Protecting yourself and those around you begins with learning what to do, how to prepare and react, and becoming connected in your community.

Fourth Quarter Crime Report: Focus on Thefts and Burglaries

From January-December 2021, there were 400 Part I Crimes in the City of Rancho Palos Verdes. Part I Crimes are classified by the FBI and fall into two categories: violent crimes and property crimes, which include burglaries, thefts, and arson. Residential burglaries and petty thefts remained relatively constant compared to previous years, but there has been an increase in vehicle burglaries and grand thefts. Many of the vehicle burglaries involved items left behind in visible places, while many of the grand thefts were the result of valuables being left in unlocked vehicles. Remember to always lock your car and bring your valuables with you or lock them in your trunk.






Create a plan by discussing the following questions with your family, friends, or household to kick-start your emergency preparedness:

- Do I need to update my emergency preparedness disaster supply kit?

BE INFORMED

It is important to know what disasters and hazards could affect your area, how to get emergency alerts, and where you would go if you and your family need to evacuate. Make sure your family has a plan and practices it often.

KICK YOUR BRUSH TO THE CURB!

SPRING BRUSH CLEARANCE

Lots of dried branches, twigs, and trees in your backyard or canyon? Worried about brush fires? Remember the county's June 1 property brush clearance deadline.

EDCO's spring season's free excess green waste collection service helps you remove excess vegetation growth, overgrown bushes and shrubbery, and trim trees in your backyard, canyon, and elsewhere on your property without having to rent bins or incur additional costs for hauling the green waste material away.

Find your regular collection day below and then see your brush clearance day. Plan to complete your brush clearing before your designated day.

TRASH COLLECTION SCHEDULE

March and April 2022: No Changes.

May 2022: No service on Memorial Day-Monday, May 30, 2022. Services for all routes (Monday through Friday) will be delayed by one day.

June 2020: No changes.

Regulations for Hours for Trash Cart/Can Placement: The City's Municipal Code (Section 8.20.330) has regulations on when trash, recycling and green waste carts can be left at the curb for collection. Carts can be placed at the curb after 4 pm the day before collection day and empty carts must be removed no later than 10 pm on collection day. **Empty carts cannot be left on the street overnight.** Containers have to be stored on the side or back of the property, at a location that is substantially screened from view. Please help keep your neighborhood attractive and aesthetically pleasing.

BACKYARD SERVICE: EDCO provides backyard service to customers at an additional monthly charge. If you have temporary or permanent physical or medical limitations or travel frequently, call EDCO and inquire about this service.

In celebration of Earth Day, the City is hosting recycling events celebrating reusing, reducing, recycling, and re-purposing. Let's make it easy being green!

SHREDDING, E-WASTE, AND MULCH GIVEAWAY-OH MY!



The next shredding event is scheduled for April 30, 2022. Bring your personal and private documents such as draft or old tax returns, paycheck stubs, mortgage and medical files, and/or bank and credit card statements that you want confidentially shredded to RPV Civic Center (City Hall) in the overflow parking lot, 30940 Hawthorne Blvd., from 8-11 am. Certified shredding trucks will shred your documents confidentially on-site.

Additionally, bring your unwanted electronics such as TVs, computer monitors, CPUs, printers, fax machines, VCRs, DVD players, and answering machines. EDCO will collect and recycle them.

However, absolutely no household hazardous waste (HHW) material (e.g. no paint, no fluorescent light bulbs, etc.) will be accepted.

Love Gardening? Free mulch will be available to residents, while supplies last. This is a self-service and self-haul event. Please bring your own trashcans or sturdy yard bags, gloves and a shovel. Limit of 3 cans/bags per vehicle. If you plan to haul your compost in an open truck or trailer, please remember to bring a tarp to cover your material.

Please bring proof of RPV residency such as a recent utility bill.

HOUSEHOLD HAZARDOUS WASTE AND ELECTRONIC WASTE ROUNDUP

The PV Peninsula's Annual Household Hazardous Waste /Electronics Waste Roundup is on **April 2, 2022** from 9 am to 3 pm at RPV Civic Center, 30940 Hawthorne Blvd. Clean out your garage and/or gardener's shed, and help the environment. Visit the County website www.lacsd.org or call 1.888.CleanLA for a list of allowable items. This event is open to all Los Angeles County residents.



THE (RE)CYCLE OF LIFE ORGANIC WASTE RECYCLING COMING SOON

You may have heard that effective January 1, 2022, Californians are now required to separate organics waste, such as leftover food and kitchen scraps, from their trash and place it in their green waste bins. SB 1383 aims to reduce methane emissions by diverting organics waste from landfills for other uses like compost, mulch, and renewable energy.



What does this mean for RPV? On January 18, 2022, the City Council approved an agreement with EDCO to provide organics waste collection to residential customers (single-family and multi-family dwellings) after April 1. A public hearing is scheduled for the March 15 City Council meeting. Prior to the City's implementation of organics waste collection, a robust outreach campaign will be conducted. Please stay tuned for updates.
