\$2 Million Secured in Appropriations Bill for Portuguese Bend Landslide

Last week, President Biden signed the [2023 Appropriations Bill](#), which includes \$2 million requested by Senator Dianne Feinstein toward the City's efforts to slow the Portuguese Bend Landslide.

The proposed Portuguese Bend Landslide Remediation Project aims to address ongoing land movement that could result in a public safety and environmental disaster in the event of the failure of Palos Verdes Drive South. The City's project was one of 17 statewide recommended by Senator Feinstein for consideration for Homeland Security Appropriations Bill funding after her senior field representative toured the landslide in 2021.

The \$2 million was specifically requested for installing hydraugers, implementing new drainage features, and filling fissures caused by land movement, which make up a major component of the overall \$33 million project.

Additionally, in December, the City submitted an application for the Federal Emergency Management Agency's (FEMA) Building Resiliency Infrastructure and Communities (BRIC) grant funding program, which could provide \$23.1 million (requiring a 25% match). A draft Environmental Impact Report for the Portuguese Bend Landslide Remediation Project is expected to be released in the coming weeks.

The City expresses its deepest gratitude to Senator Feinstein for her attention to this issue and her efforts to help RPV complete this critical remediation work.

U.S. Coast Guard Helicopter Training at Point Vicente Lighthouse January 9 and 13

The U.S. Coast Guard is scheduled to conduct training on January 9 and 13 at the Point Vicente Lighthouse. The training exercises will consist of one helicopter conducting simulated cliff rescues on Coast Guard property from approximately 2-3:30 p.m. on January 9 and 9:30-11 a.m. on January 13.

Apply Today for a Security Camera Grant!

The City is proud to announce that the Public Safety Reimbursement Program is once again accepting applications! The program provides a partial reimbursement to individuals and neighborhoods for a public safety purchase such as a security camera.

Individuals are eligible to apply for a 50% reimbursement up to \$100, awarded based on a random draw, for external security cameras such as doorbell cameras. Neighborhoods are eligible to apply for a 50% reimbursement up to \$2,000, awarded based on a rubric, for neighborhood entrance/exit security cameras.

Cal Water Announces November Conservation

Cal Water has announced that Palos Verdes continues to be among the top water-conserving districts, reducing water usage by 16.8% in November 2022 compared to November 2020.

Cal Water reduced water use company-wide by 13.6% in November, up from 12.1% in October and 10.6% in September.



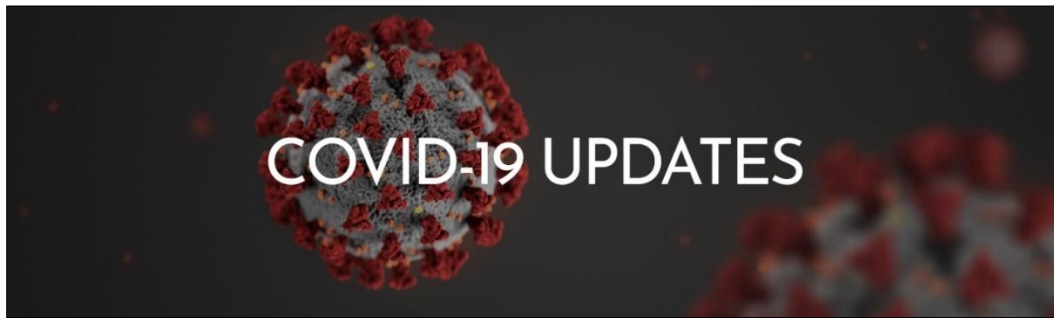
During wetter winter months, Cal Water reminds customers to remember simple indoor water-saving tips, such as turning off the tap when brushing teeth or shaving, running full loads of laundry and dishes, and checking toilets for leaks.

988 is the Suicide and Crisis Lifeline

988, the Suicide and Crisis Lifeline, provides 24/7 confidential support to people in suicidal crisis or mental health- or substance use-related distress. When people call or text 988, or chat at 988lifeline.org, they will be connected to trained crisis counselors who will listen, provide support, and connect them to resources if necessary.





Indoor Masking Recommended for At Least 10 Days When Returning to Work and School

To reduce the post-holiday spread of COVID-19, the L.A. County Department of Public Health recommends everyone returning to work and school should wear a mask for at least the first 10 days.

Masking can slow transmission, minimize disruptions to work and learning, protect those most vulnerable, and help hospitals from becoming overwhelmed.

Vaccine Booster Eligibility Expanded to Ages 6 Months+

Updated ([bivalent](#)) boosters are recommended for everyone ages 6 months and older with one exception. Children 6 months through 4 years of age who finished a Pfizer vaccine primary series are not eligible for a booster dose at this time.

FREE COVID-19 Home Tests Available for Pickup at Two City Parks

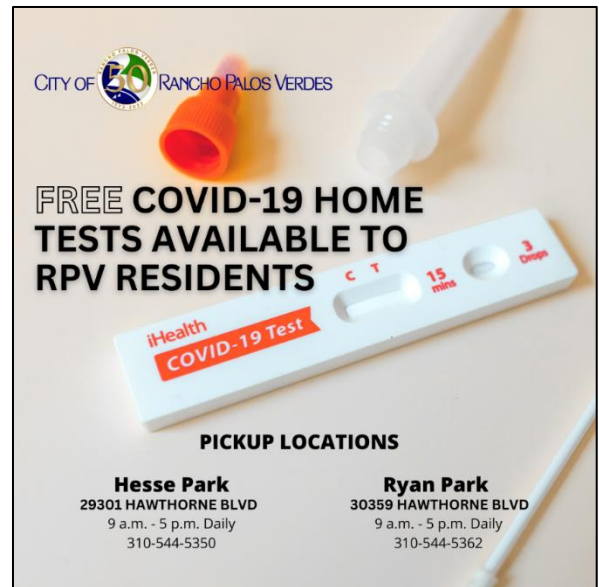
Free at-home COVID-19 rapid antigen tests are now available for pickup to RPV residents at two City parks.

Two test kits (each containing two tests) per household are available for pickup at the front desks at Hesse Park and Ryan Park from 9 a.m. to 5 p.m. daily. **Proof of RPV residency, such as an ID or utility bill, is required.**

These iHealth COVID-19 Antigen Rapid Test kits were provided to the City for distribution by the Los Angeles County Department of Public Health (DPH). Please note that while the tests have a July 2022 expiration date, both the DPH and the California Department of Public Health have endorsed the emergency use of COVID-19 home antigen tests beyond their expiration date until further notice. L.A. County Eviction Moratorium Extended Through January 31

The L.A. County Eviction Moratorium took effect in March 2020, protecting tenants from evictions, freezing rent increases for certain units, and extending protections for non-payment of rent due to financial hardship related to COVID-19. The County has announced that the Eviction Moratorium was extended through January 31, 2023.

What Protections Are Currently in Place?

The following protections are currently in place through January 31, 2023:

For Residential Tenants, including Mobilehome Space Renters:

- Rent increase freeze (including new pass-throughs or related charges) for rent-stabilized units in unincorporated areas of the County; and
- Anti-harassment and retaliation protections
- Protections against evictions for:
 - Non-payment of rent due between July 1, 2022 and January 31, 2023 due to a COVID-19 financial hardship, only for tenant households with income at or below 80% of the Area Median Income (AMI);
 - No-Fault eviction reasons (except for qualified Owner Move-in);
 - Nuisance; and
 - Unauthorized occupants or pets

For Commercial Tenants:

- Anti-harassment and retaliation protections; and
- Personal guarantee protections for smaller (0-9 employees) commercial tenants

What Protections Are Being Extended Beyond January 31, 2023?

While many of the emergency tenant protections under the Resolution will be expiring, the following protections will be extended beyond January 31, 2023, for residential tenants and mobile home space renters who utilized the County's non-payment of rent protections between July 1, 2022 and January 31, 2023:

- **No-Fault evictions reasons**, except for qualified Owner Move-in Evictions
- **Anti-harassment and retaliation protections** during the Resolution's protection periods

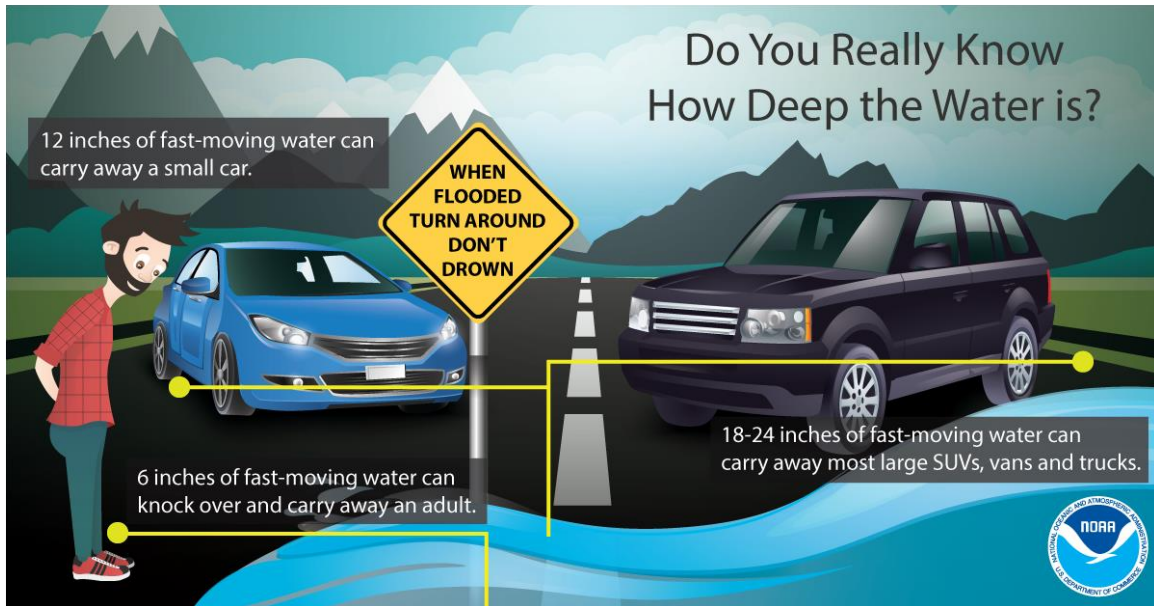


It's Raining, It's Pouring – Be Prepared for Rainy Days Ahead

The rainy season is here. During storms, there is increased potential for flash floods, falling rocks, and mud and debris flows. Be aware of weather forecasts and associated impacts where you live, work, and play, and take steps to be prepared and stay safe.

Rain Safety Tips:

- Heed all instructions from emergency responders and emergency alert notifications.
- Drive cautiously and slow down – many roadways will be wet and slippery.
- Do not attempt to cross flooded areas, and never enter moving water. As little as 6 inches of water can knock over and carry away an adult, and 18-24 inches of water can carry away most large SUVs, vans, and trucks. **Turn around, don't drown!**



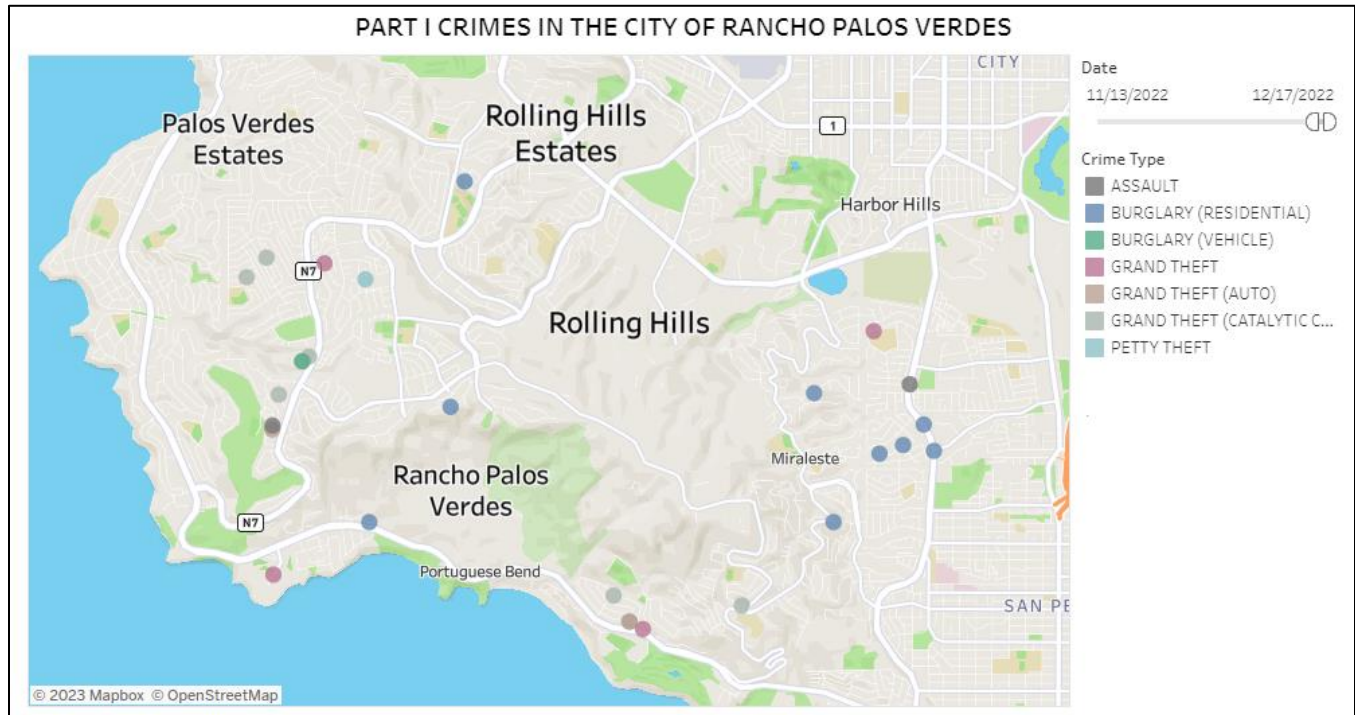

Passing a Bicyclist? Move Over! And Other New Traffic Laws

When passing a bicyclist, drivers are now required to change into another lane, when possible, to pass cyclists. Think of a bike like an emergency vehicle with its flashing lights on, parked on the shoulder.

Sideshowes at Parking Facilities: sideshows and street racing are now banned in all parking lots alongside public roads.

Toll Exemptions for Certain Veterans: Vehicles registered to veterans displaying specialized license plates are exempted from paying tolls. This only applies to vehicles with license plates that are issued to a disabled veteran, Pearl Harbor survivor, prisoner of war, or to veterans who have received distinctions such as the Purple Heart or the Congressional Medal of Honor.

Safe Drug Drop-off Locations

The public is urged to safely drop off unused prescription drugs at Public Disposal Locations. To locate local pharmacies participating in this program, visit the DEA's Public Disposal Locations [Search Utility](#). Before disposing of any medications, be sure to remove or scratch out all personal information on labels or packaging.

Residents can safely and anonymously drop off expired or unused prescriptions and over-the-counter medications. Saving unused or expired medications can lead to improper and illegal use if they fall into the wrong hands. A safer solution is to bring your old medicines to designated drug drop-off boxes.



If you are unable to go to a drop-off site, you can take the following steps to dispose of medications at home.

1. Check if your medication is on the FDA's [flush list](#). If it is, remove the medicine from all packaging and flush it down the sink or toilet.
2. If your medication is not on the flush list, mix the medication with an undesirable substance like dirt or cat litter in a sealable plastic bag and throw it away in your household trash.
3. Remove all personal information from labels or packaging and discard all outer packaging.

See something suspicious or out of the ordinary? Call the Lomita Sheriff's Station at 310-539-1661 to report it, or 9-1-1 in an emergency.

Deputies do not monitor social media sites like Nextdoor. Always report suspicious activity to the Sheriff's Station before posting about it so a deputy can be dispatched to respond. Once you hang up with the dispatcher, then you can share the information with friends, Neighborhood Watch, and neighbors, knowing the issue is being responded to.



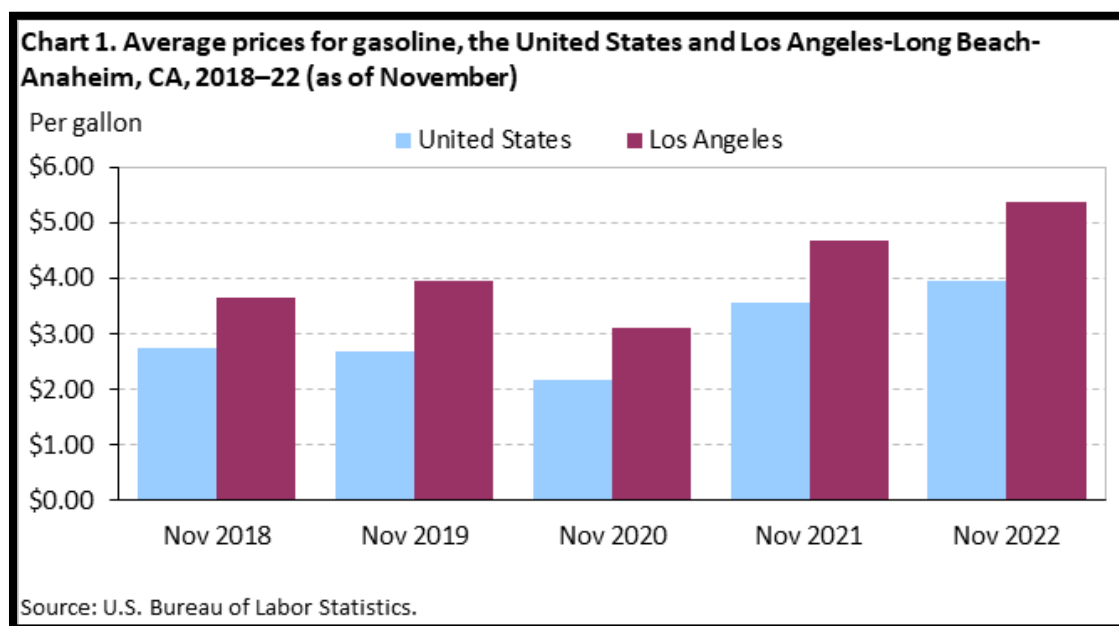
The time you wait to call to make a post is time that a deputy could be responding. If you don't call, the station won't know to dispatch a deputy. You can also report suspicious activity after the event so the station has the incident on file, even if there is no need for a response.

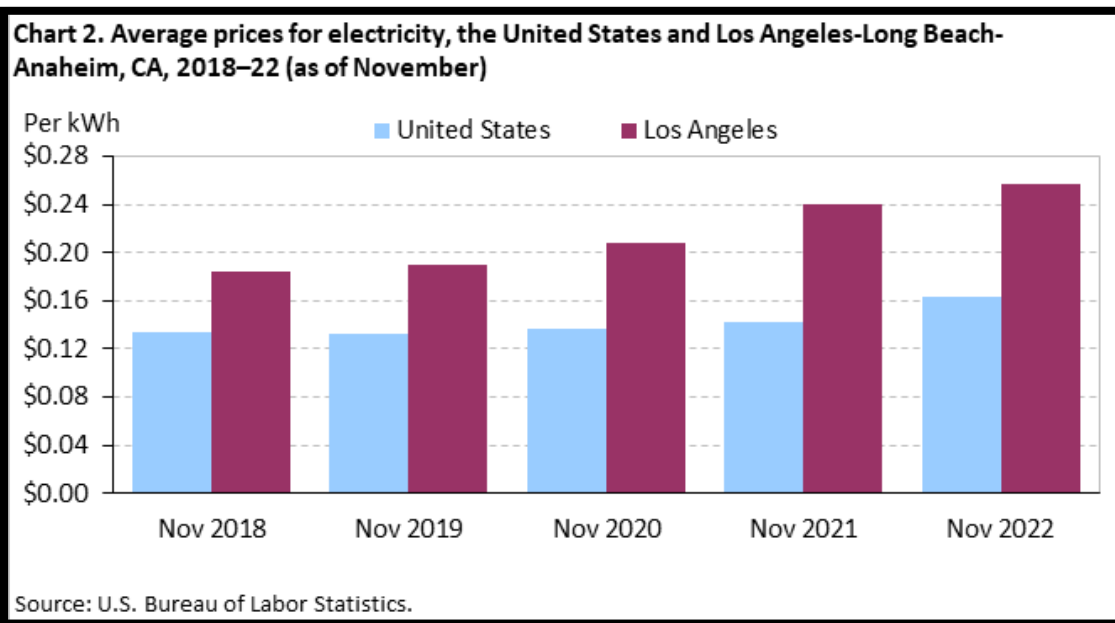

Average Energy Prices – November 2022

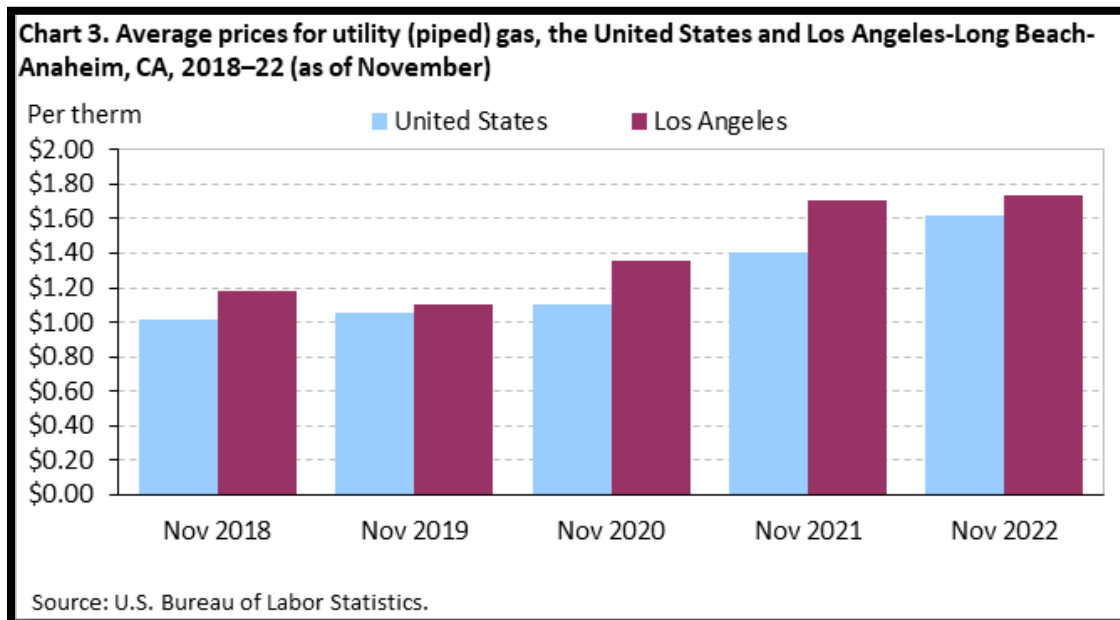
At the end of December, the U.S. Bureau of Labor Statistics reported that gasoline prices averaged \$5.38 per gallon in the Los Angeles-Long Beach-Anaheim area in November 2022. Gasoline prices were 69.3 cents higher than last November, which averaged \$4.69 per gallon. At \$5.38 per gallon, Los Angeles area consumers paid 36.1% more than the national average during the same period. The local price of a gallon of gasoline has ranged from 31.3% to 47.3% above the national average in the month of November during the past five years. (See chart 1)



Los Angeles area households paid an average of 25.7 cents per kilowatt hour (kWh) of electricity in November 2022, slightly higher than the 24.0 cents price per kWh paid in November 2021. The 25.7 cents per kWh Los Angeles households paid for electricity in November 2022 was 57.7% more than the nationwide average of 16.3 cents. In the past five years, prices paid by Los Angeles area consumers for electricity exceeded the U.S. average by 37.3% or more in November. (See chart 2)



The average cost of utility (piped) gas at \$1.74 per therm in November was higher than the \$1.71 spent last year. Prices paid by Los Angeles area consumers for piped gas, commonly referred to as natural gas, were 7.7% more than the national average in November 2022. Over the past five years, the cost for natural gas in November has varied between 4% and 22.5% above the U.S. average. (See chart 3)

Ladera Linda Community Park Project

After a week off for the holiday season, work for this week is suspended due to rain in the forecast. Work is currently scheduled to resume on January 9.

Before the holiday break, the Southern California Edison (SCE) inspector approved the conduit for the new electrical service to the building. The contractor will inspect the trench for any impacts from the rain this week and can then encase the conduit in concrete and backfill the trench. For this reason, it is anticipated that the gate to the lower tier will be used for site access for one week upon resuming work. The City expects the contractor will resume the use of the main gate on January 16.

Rattlesnake Trailhead Fence and Gate

Work has started on installing the pilasters for the Rattlesnake Trailhead fence and gate. In the coming weeks, weather dependent, work will continue on the pilasters and work will start on the posts as well as the panels for the fence and gate.



Burma Road Bollards and Gate

Work has started on installing the bollards designed to protect the gate to the Burma Road Trail. Following completion of the bollard installation, the repaired gate will be installed. All work is expected to be completed by the end of January, weather dependent.

Holiday Tree Recycling

How To Dispose of Your Holiday Tree

Prepare your tree for collection by removing all plastic containers, metal stands and bars, ornaments, lights, and the bulk of tinsel or garland. There's no need to cut the tree into smaller pieces (unless it's over 6 feet tall).



Flocked trees, or trees coated with a fire retardant, will be accepted. Wreaths and other holiday foliage will be accepted.

Leave your Christmas tree at the curb on your regular collection day through January 13.

Residents can also cut up their trees and place them in the green waste bin for pickup on their regular waste collection service day.

If you live in a multi-family complex, ask your management company or homeowners association about the designated tree drop-off location for your complex. This location is typically in the garage area or near the recycling bins.

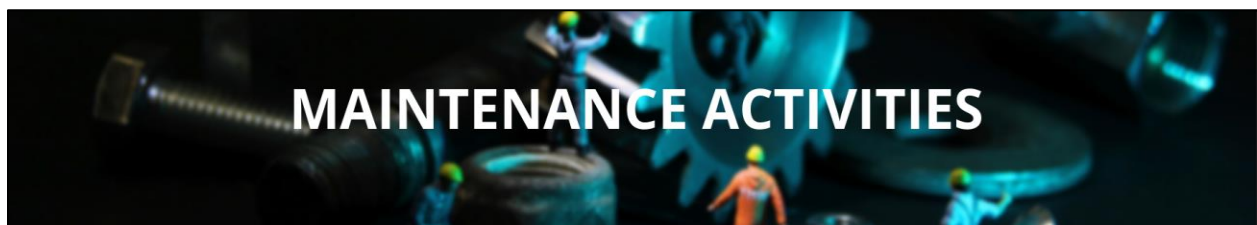
Due to the holidays, the Monday street sweeping route will occur on Wednesday, January 4.

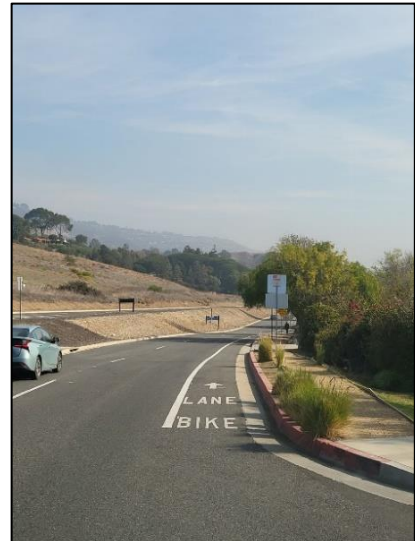

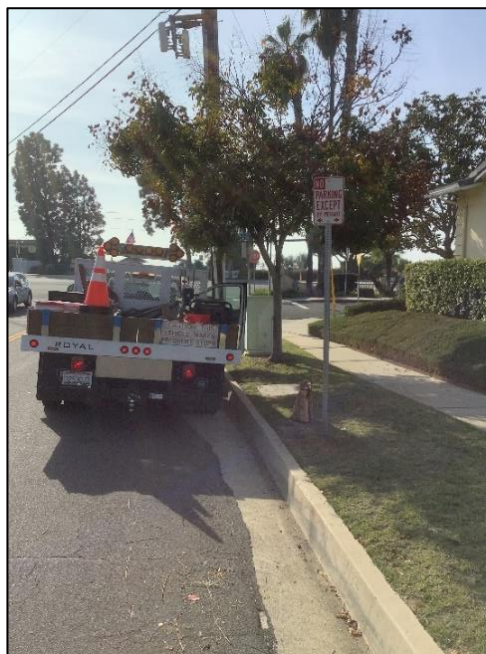
- Crews replaced a damaged “No U-Turn” sign in the median on Hawthorne Boulevard at Ravenspur Drive.

- Crews installed a new 45 mile per hour sign on Hawthorne Boulevard and Seamount Drive. New signage will help inform drivers of the speed limit in that area.



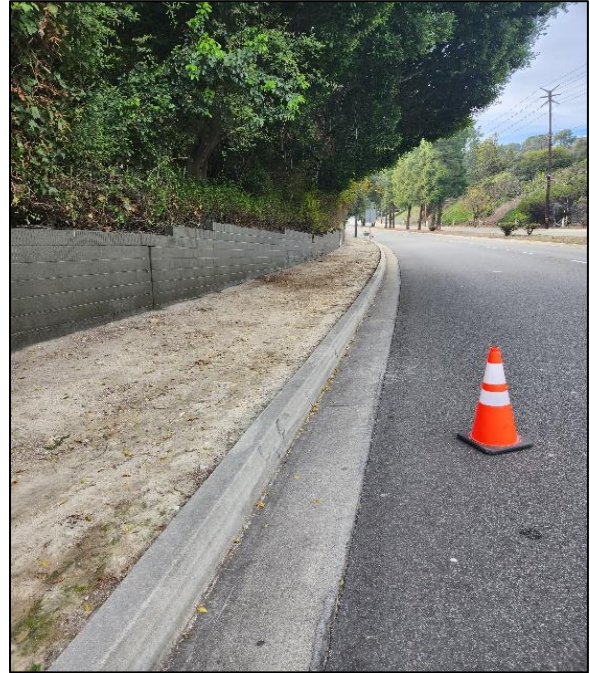
- Crews installed speed feedback signs at the following locations to increase speed awareness around nearby schools:

- Crews installed a new “No Parking Except by Permit” sign on the corner of Schooner Drive and Palos Verdes Drive South.

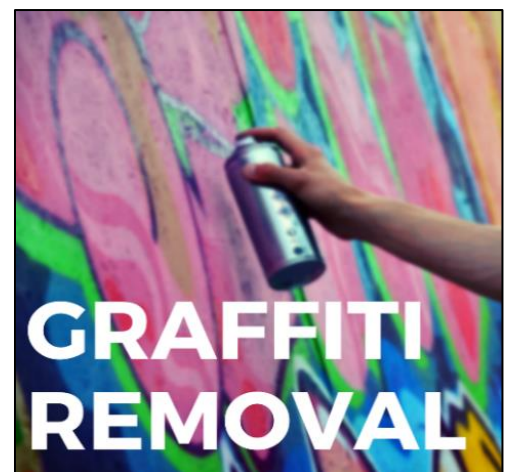

- The RPV graffiti reporting app can be downloaded for Android and Apple devices under the name **RPV Clean**. Residents can help keep RPV looking great by using this app.



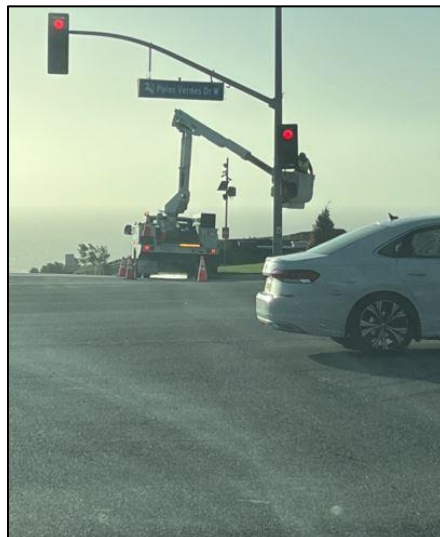


Public Works provided storm response throughout the City.

New Building Codes Effective January 1

The 2022 California Building Standards Code went into effect on January 1, 2023. The new codes were adopted by the City Council on November 15, 2022, as part of Ordinance No. 669. The Ordinance adopts by reference the 2022 Code, which consists of the following:

- The 2022 California Building Code
- The 2022 California Residential Code
- The 2022 California Green Building Standards Code
- The 2022 California Electrical Code
- The 2022 California Mechanical Code
- The 2022 California Plumbing Code

Rattlesnake and Burma Fence and Gate Progress Report

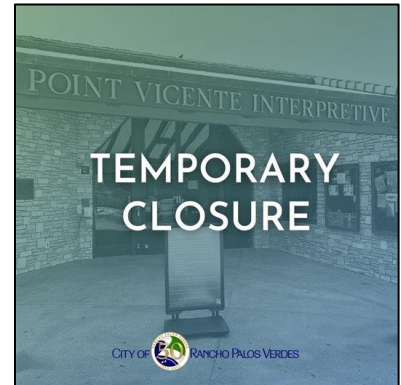
Work continued on the Rattlesnake fence and gate project and the Burma Road fence and gate project began this past week. The Rattlesnake fence pillars were completed and are awaiting the topper and fencing to be installed.

SoCalGas and Cal Water Service completed their USA utility markings for the Burma Road gate and bollards. Unfortunately, forecasted rain on December 27 delayed the excavation by a day. The excavation for the Burma Road bollard base was completed and compacted on December 28 while still allowing Fire Department access across the excavation. The bollards were installed and aligned on December 30 and the continuous bollard base was poured.



PVIC Temporary Closure Update

Point Vicente Interpretive Center exhibits remain temporarily closed through at least January 31. A leaky pipe caused the damage, but the water did not spread beyond the hallway, restrooms, and a few adjacent offices utilized by Los Serenos de Point Vicente docents and City Staff. There is no damage to the exhibit areas, the gift shop, displays, or artifacts. The Sunset Room has been converted into a temporary pop-up gift shop. Due to the repairs needed, the museum remains closed.

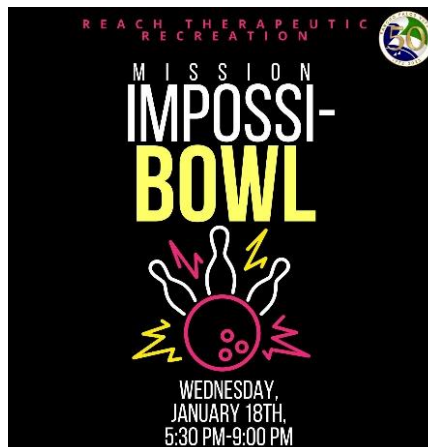

Forrestal Reserve:

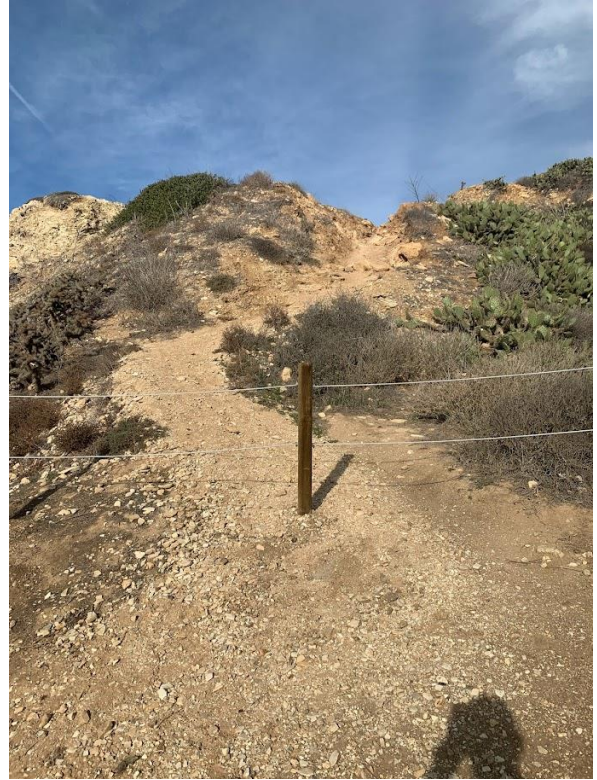
On January 1, Rangers observed and reported two portable restrooms located at the end of Forrestal Drive had been knocked over. Public Works was notified and assisted in notifying the contractor.



Ocean Trails Reserve:

On December 23, Rangers retrieved several items from an abandoned encampment. Valuable items were tagged and are temporarily stored for 90 days to be claimed; the remaining items at the site were discarded.

Trump National Golf Club staff installed new posts and cables near the bottom of Sunrise Trail to deter access to a spur trail. Spur trails are unauthorized trails that are not maintained and pose a negative impact as they fragment habitat.



Portuguese Bend Reserve:

On December 25, Rangers were notified of a hole on Klondike Canyon Trail. Repairs were made to fill in the hole and repair the slope on the trail.



On December 25, Rangers were notified by Los Angeles County Sheriff's Department of an unauthorized vehicle that drove through Burma Road Trail. Rangers responded and

with the assistance of sheriff's deputies, were able to locate and stop the driver. Repairs were made to the entry to secure the chain; the vehicle was driven out by deputies **and the driver was arrested.**

On December 28-29, Open Space Management Staff inspected and conducted repairs on several grade dips on Burma Road Trail. These grade dips were designed to divert water flow away from the trail to minimize ruts, which require ongoing maintenance to clear out sediment and debris.




Vicente Bluffs Reserve:

On December 26, Rangers were notified of a vehicle on Interpretive Trail on Christmas Day. No other information was provided, and the owner was not identified.
