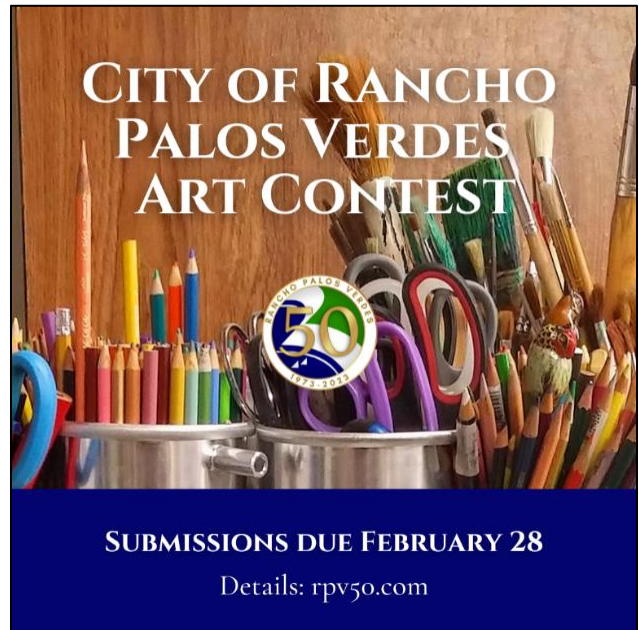

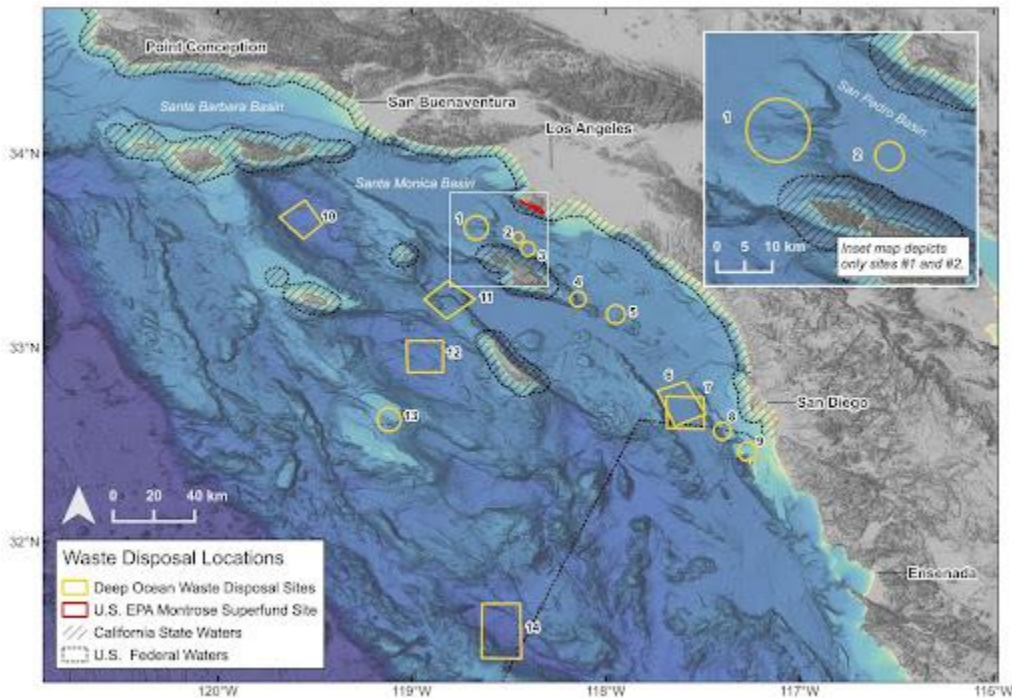

## Sea Grant Releases Deep Ocean DDT+ Report

On January 18, the University of Southern California (USC) Sea Grant Program and the California Sea Grant Program jointly announced the release of a new report detailing what research is needed most urgently to address the deep ocean DDT contamination off the coast of Los Angeles. The [report \(PDF\)](#) is the unique culmination of a nine-month collaborative and inclusive process to engage the perspectives of leading scientists as well as those of policy, nonprofits, federal and state agencies, formal and non-formal educators and education centers, tribal representatives, anglers, aquatic recreation communities, and interested members of the public.

DDT, an insecticide banned in 1972, has harmful impacts on wildlife and potential carcinogenic effects on humans. The contaminated areas within the San Pedro and Santa Monica Basins fall outside the Environmental Protection Agency's Montrose Superfund site. Recent research illuminates new concerning aspects of this deep ocean DDT—a much broader suite of DDT breakdown products and related byproducts (more than 45 compounds collectively referred to as “DDT+”) that may have toxic effects and have not historically been monitored in the environment.

The unknowns about this deep ocean DDT+ instigated a call to action by researchers, national and state leadership, and the broader Southern California community. In response, the USC Sea Grant Program, based in Los Angeles, and the California Sea Grant Program, based in San Diego—both a part of the national network of 34 Sea Grant programs under the National Oceanic and Atmospheric Administration—jointly conducted a research needs assessment in 2022 and developed the subsequent research needs report.

Titled A Deep Ocean DDT+ Research Needs Assessment of the Southern California Bight, the newly released report provides a comprehensive agenda for critical, deep ocean DDT+ research to inform future action to protect marine and human health.

The federal government appropriated \$5.6M for studies on the San Pedro Basin DDT dump site, an amount which the State of California intends to match in spending on DDT+ initiatives between 2023 and 2025. This impending funding makes this report timely and critical for leveraging the greatest impact quickly from these dollars.

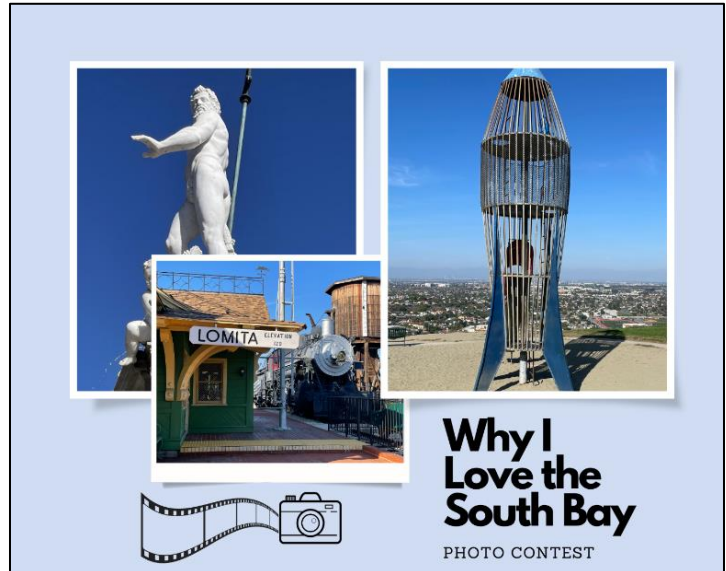

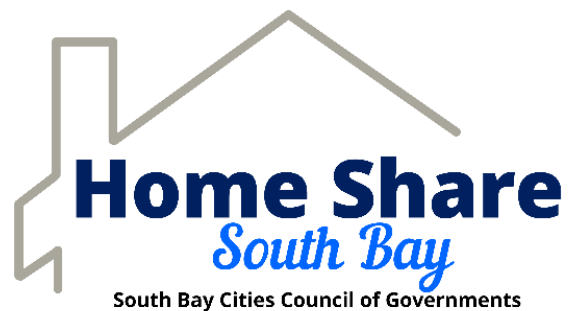

## L.A. County Extends Eviction Moratorium through March 31

The L.A. County Eviction Moratorium took effect in March 2020, protecting tenants from evictions, freezing rent increases for certain units, and extending protections for non-payment of rent due to financial hardship related to COVID-19. The Eviction Moratorium has been extended through March 31, 2023.

### What Protections Are Currently in Place?

The following protections are currently in place through March 31, 2023:

For Residential Tenants, including Mobilehome Space Renters:

- Rent increase freeze (including new pass-throughs or related charges) for rent-stabilized units in unincorporated areas of the County; and
- Anti-harassment and retaliation protections
- Protections against evictions for:
  - Non-payment of rent due between July 1, 2022 and March 31, 2023 due to a COVID-19 financial hardship, only for tenant households with income at or below 80% of the Area Median Income (AMI);
  - No-Fault eviction reasons (except for qualified Owner Move-in);
  - Nuisance; and
  - Unauthorized occupants or pets

For Commercial Tenants:

- Anti-harassment and retaliation protections; and
- Personal guarantee protections for smaller (0-9 employees) commercial tenants

### What Protections Are Being Extended Beyond March 31, 2023?

While many of the emergency tenant protections under the Resolution will be expiring, the following protections will be extended beyond March 31, 2023:

- For residential tenants and mobilehome space renters who utilized the County's **non-payment of rent protections** between July 1, 2022 and March 31, 2023: except for qualified Owner Move-in Evictions



- Protected against eviction for **No-Fault evictions reasons**, except for qualified Owner Move-in
- **Anti-harassment and retaliation protections** during the Resolution's protection periods
- Starting **April 1, 2023**, landlords are required to serve tenants with a written 30-Day Notice prior to filing an eviction based on nonpayment of rent for rent accrued through March 31, 2023.
- For residential tenants and mobilehome space renters with **unauthorized occupants or pets** due to COVID-19 who began residing in the unit **on or before January 20, 2023**:
  - **Anti-harassment and retaliation protections** during the Resolution's protection periods
  - Starting **April 1, 2023**, landlords are required to serve tenants with a written 30-Day Notice prior to filing an eviction based for the presence of unauthorized occupants or pets

## Local Data Makes Strong Case for Getting Bivalent Booster

Recent data from L.A. County Department of Public Health shows the bivalent booster offers robust protection against hospitalization and death.

For hospitalizations:

- Unvaccinated individuals were over 6x more likely to be hospitalized than those who had gotten the bivalent booster.\*
- Vaccinated individuals who hadn't had the bivalent booster were more than 2x as likely to be hospitalized than those who got it.\*

For deaths:

- Unvaccinated individuals were more than 7x as likely to die than those who had received the bivalent booster.^
- Vaccinated individuals who hadn't had the bivalent booster were more than 2x as likely to die than those who got it.^

## Pano AI – Wildfire Camera Site Audits

Last week, representatives from the Pano AI wildfire detection company met with city staff to discuss the installation of the forthcoming Peninsula Wide wildfire detection camera network.

The meeting included a site inspection of the proposed locations for camera installation, where Pano AI collects cellular readings, identifies clear paths to available power/server rack mounting locations, and captures shed



views of the proposed installation locations.

This past year, Rancho Palos Verdes and its neighbors on the Palos Verdes Peninsula conducted extensive research on a camera detection system for wildfires that provides municipal agencies with accurate and timely warnings of fire ignitions. Pano AI, will install four 360-degree, high-definition cameras at high vantage points in the city. The cameras will not only cover Rancho Palos Verdes, but also the entire Palos Verdes Peninsula.

Pano AI cameras scan a 15-mile-plus radius from a high vantage point to detect, evaluate, and report on wildfire activity. In the event of a fire, it provides fire monitoring professionals with auto-centered images with enhanced zoom, rapid confirmation, and triangulation of the fire's precise location. The Peninsula-wide system use four camera sites in Rancho Palos Verdes consisting of three existing communication tower stations and one standalone station. ## Tips for Finding Residential Fire Insurance

Need help finding fire insurance for your home? In the wake of destructive fire seasons, homeowners in areas of California that are at high risk for wildfires have reported losing their homeowners' insurance or seeing their premiums skyrocket. As a result, many have been left to seek expensive, limited coverage through the California Fair Access to Insurance Requirements (FAIR) Plan as a last resort.

The California Department of Insurance (CDI) provides a number of tools on its website ([www.insurance.ca.gov](http://www.insurance.ca.gov)) to help consumers understand home/residential insurance so that they can make the best decision for their situation, including [informational guides](#), a [premium comparison tool](#), and a [new coverage comparison tool](#) that allows consumers to compare differences between insurance policies offered by insurers.

## Common Fire Hazards in the Home

In just two minutes, a fire can become life-threatening. In five minutes, a residence can be engulfed in flames. The causes of these fires can range from candles left burning to unattended food in the kitchen. Knowing where and when fires are most likely to ignite can help you protect yourself, your family, and your home from tragedy.

**Kitchen Fires:** Most home fires start in the kitchen during cooking — usually on stovetops —not in the oven. Specifically, unattended cooking is the leading cause of kitchen fires and fire-related injuries.

**These home fires are also easily preventable:** Keep an eye on the stove, oven, and other appliances like toaster ovens, and move combustible items away from the stove. Stay in the kitchen when frying, grilling, or broiling food. If you leave the kitchen for even a short period of time, turn off the stove.

**Portable Space Heaters:** With the following safety tips and precautions, you can prevent most heating fires from happening.

- Make sure to always keep anything that gives off heat at least 3 feet away from flammable materials or items.
- Never plug more than one heating appliance into an outlet.
- Buy only heaters evaluated by a nationally recognized laboratory, such as Underwriters Laboratories (UL).
- Check to make the portable heater has a thermostat control mechanism and will switch off automatically if the heater falls over.
- Keep portable gas generators outside and away from windows to avoid carbon monoxide poisoning.
- If you have a fireplace, make sure your chimney is checked and cleaned by a professional once a year. Use a metal or glass screen that is large enough to prevent embers escaping.



**Electrical Safety:** Electrical fires can be caused by an equipment malfunction, an overloaded circuit, or an overheated appliance such as a washer, dryer, or space heater.

**Safety Tips:**

- Frayed wires can cause fires. Replace all worn, old, or damaged appliance cords immediately, and do not run cords under rugs or furniture.
- If an appliance has a three-prong plug, use it only in a three-slot outlet. Never force it to fit into a two-slot outlet or extension cord.
- Immediately shut off, then professionally replace light switches that are hot to the touch and lights that flicker.
- Don't overload circuits or outlets.
- Consider having additional circuits or outlets added by a qualified electrician so you don't have to use extension cords.
- Consider hiring an electrician to perform an annual checkup of your home's wiring.

**Candles:** The National Fire Protection Association estimates that candles cause an average of 8,200 house fires each year in the U.S. The matches and lighters used to light candles are equally dangerous if left in a place where children can reach them.

**Candle Safety Tips:**

- Blow out all candles when you leave the room or go to bed.
- Avoid the use of candles in the bedroom and other areas where people may fall asleep.
- Keep candles out of the reach of children and pets.
  - Do not place lighted candles where children, pets, or anyone else can knock them over.
- Never burn a candle on or near anything that can catch fire.
  - Keep burning candles away from furniture, drapes, bedding, carpets, books, paper, flammable decorations, etc.
- Put candle holders on a sturdy, uncluttered surface.
- Light candles carefully. Keep your hair and any loose clothing away from the flame.
- Don't burn a candle all the way down — put it out before it gets too close to the holder or container.
- Have flashlights and battery-powered lighting ready to use during a power outage. Never use candles.

**Laundry rooms:** Dryers are responsible for about 9 out of 10 appliance fires.

Fortunately, preventing laundry fires is simple for the most part:

- Don't overload your washer or dryer or pack items down. Instead, leave room for laundry to tumble. Follow your machine manufacturer's recommendations for capacity.
- Clean the lint screen and drum between loads to prevent buildup.
- About once a year, clean the dryer exhaust vent and ducts.
- Replace plastic venting material with flexible metal venting material.
- Ensure that your appliances are plugged into outlets with the proper voltage.

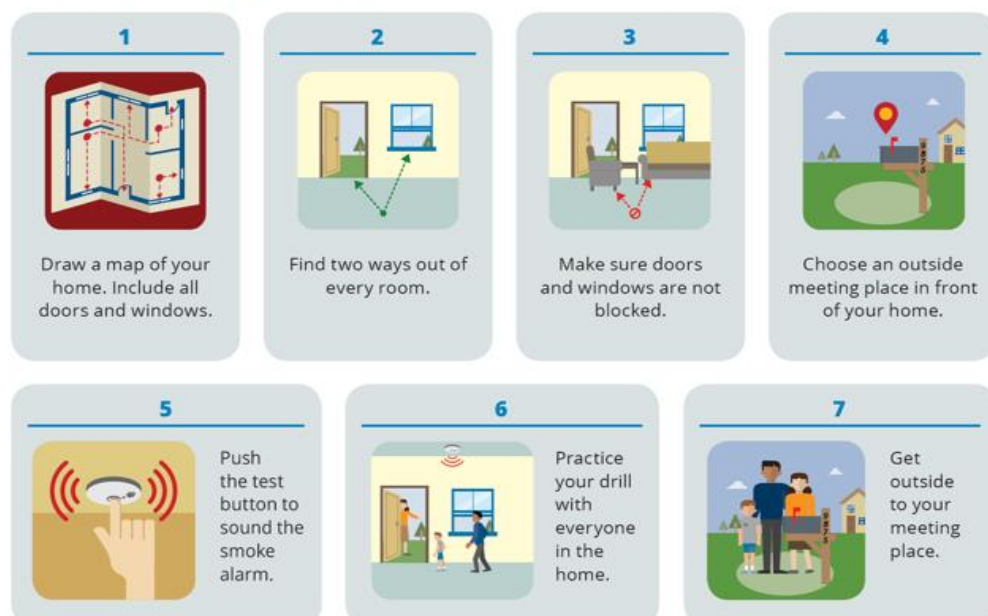

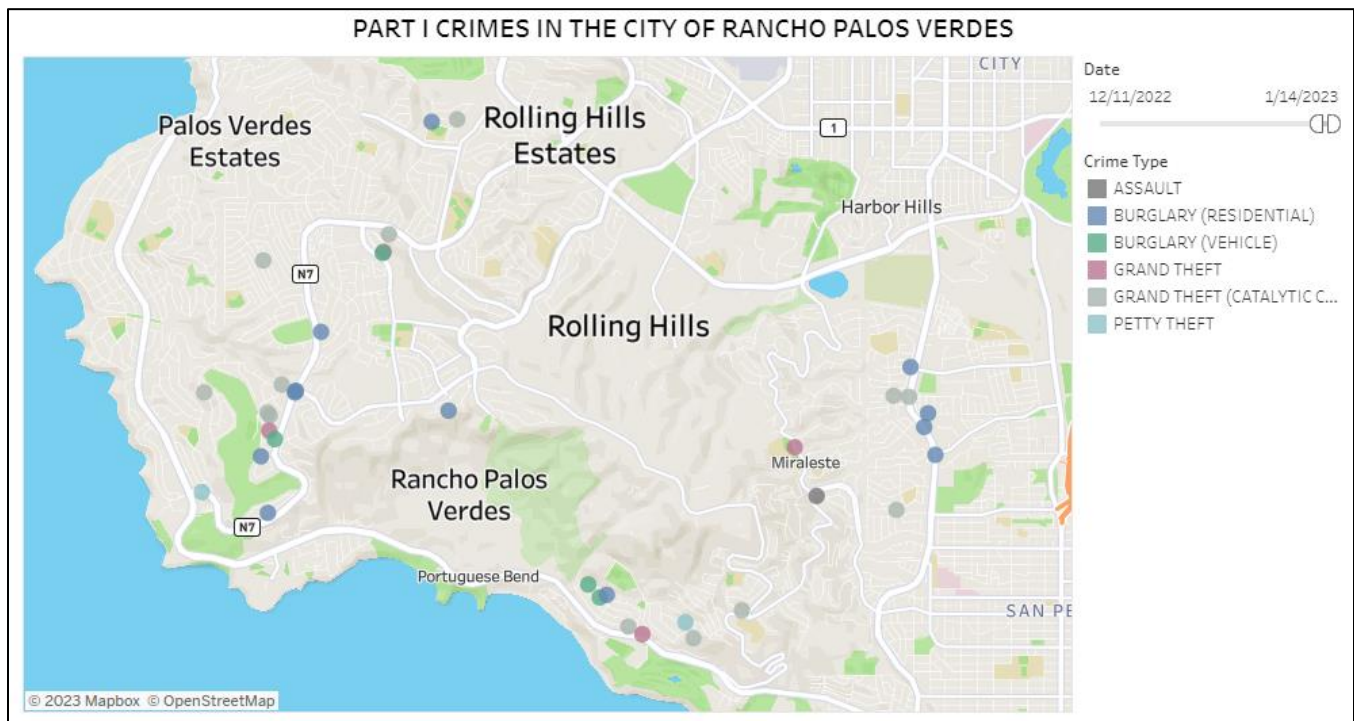




## Weekly Crime Report Summaries

## Apply Today for a Security Camera Grant!

The City is pleased to announce that the Public Safety Reimbursement Program is once again accepting applications! The program provides a partial reimbursement to individuals and neighborhoods for a public safety purchase such as a security camera.

Individuals are eligible to apply for a 50% reimbursement up to \$100, awarded based on a random draw, for external security cameras such as doorbell cameras. Neighborhoods are eligible to apply for a 50% reimbursement up to \$2,000, awarded based on a rubric, for neighborhood entrance/exit security cameras.

## Watch Your Speed, RPV

Speeding is not worth the cost. Keeping roadways safe is a shared responsibility – pay attention to speed limit sign changes and always drive at a safe speed.

According to the National Highway Traffic Safety

Administration (NHTSA), when a car is going 40 mph, two in 10 pedestrians struck survive. When a car is going 30 mph, six out of 10 pedestrians survive. Speed limits are there for a reason.



Speeding comes at a high price. For the speeding driver, there are fines and potentially lost driving privileges and criminal charges. For other motorists, pedestrians, and bicyclists, there could be fatal consequences. According to the [NHTSA](#), about one-third of vehicle fatalities are the result of speeding. It is a high price to pay for traveling a few extra miles per hour.

If you observe someone driving recklessly, pull over and call 9-1-1. To report a continual traffic violation, report it to the Lomita Sheriff Station at 310-539-1661.

### Ladera Linda Community Park Project Update

Last week, work continued on the building and the fence on the slope adjacent to Forrestal Drive. Crews placed the curb and gutter for the new parking lot, waterproofed the new retaining walls, set boulders at the stepped terrace, and resumed site grading on the middle tier. Crews completed backfilling the trench at the bottom of the main driveway, which allowed them to resume the use of the main gate on January 31.





Additionally, CalWater completed the installation of new water lines under Forrestal Drive, and staff is working to confirm their schedule for repairing the asphalt and replacing the vegetation.

Problems were encountered last week with the parking lot light mock-up, which prevented residents from viewing the light. The light will be turned on February 1 and February 2 from 5:00 p.m. until 10:00 p.m. to allow residents to view the light from outside the park and provide comments to City staff. ## Rattlesnake Trailhead Fence and Gate



Installation work was temporarily put on hold for a design revision to accommodate a concern raised by the community about how the fencing panels stepped down to accommodate the natural slope of the walkway. The revised design is for the fence to step down incrementally along the length of the walkway. Work will resume this week and includes the fabrication and installation of the remainder of the fence, as well as construction of the fence and gate post footings. The

remaining work is anticipated to be completed by mid-February.

## Burma Road Bollards and Gate

Excavation work for the bases of the gate revealed a previously unknown conflict with existing underground concrete. The project team is currently exploring options for resolving this conflict, and work will resume once the conflict is resolved, which is expected to be in mid to late February.

  - Repainted and refreshed eight park benches at the Hesse Park picnic area.

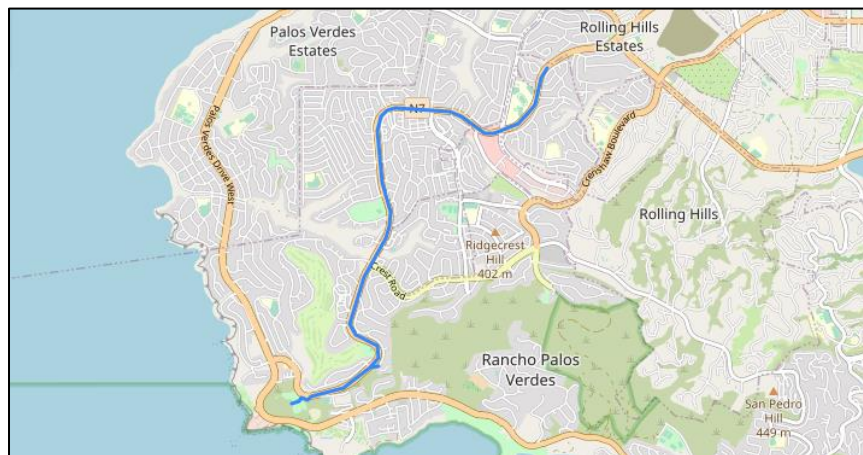

## Graffiti Removal

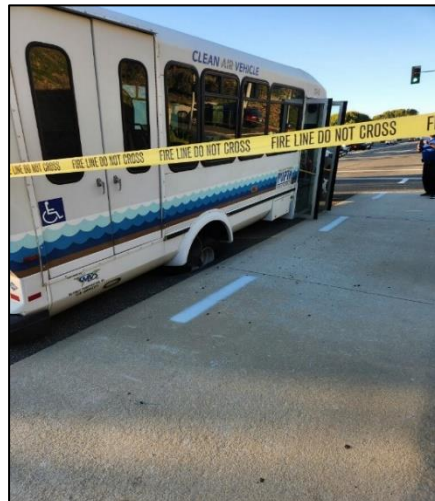
- Twenty four cases of graffiti were reported and removed this week.

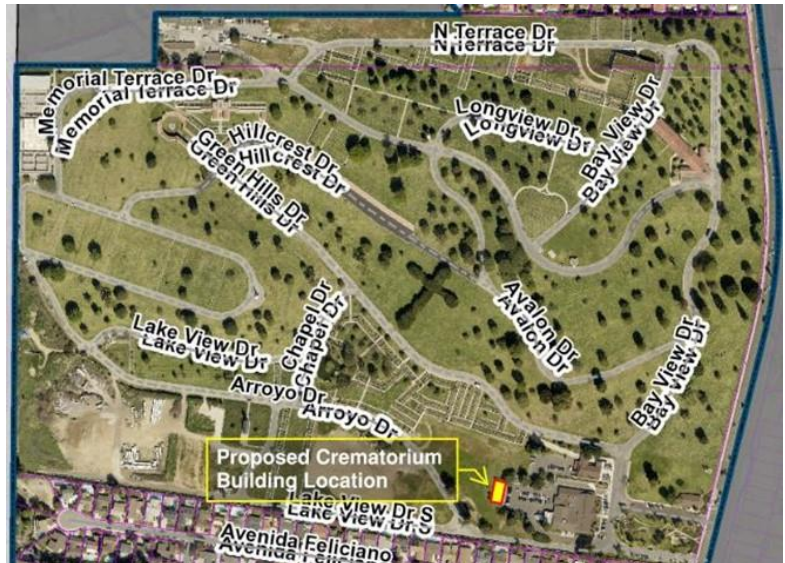

On October 6, 2022, Green Hills Memorial Park submitted a Conditional Use Permit (CUP) Revision application for the construction of a new 2,800 ft<sup>2</sup> crematorium building to be located to the west of the existing Administration Building parking lot. The proposed project also includes ancillary site improvements and grading in support of the project. Consideration of the requested applications, along with the Green



Hills Memorial Park Annual Compliance Review, has been scheduled for the February 21 City Council meeting. A public notice describing the proposed crematorium building and the Annual Compliance Review will be published in the Peninsula News and will be mailed to the adjacent neighborhoods on February 2, 2023. 

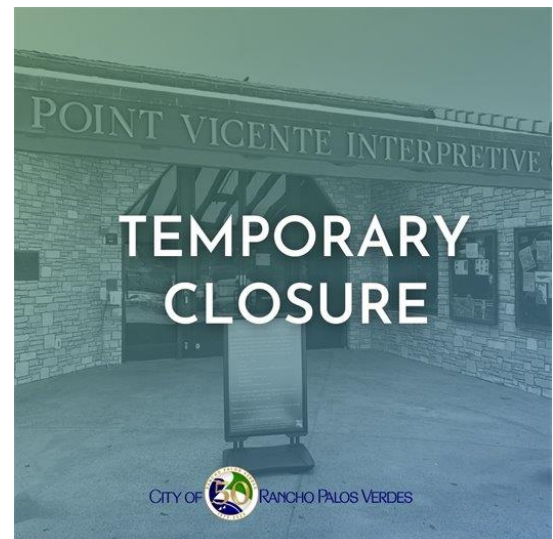

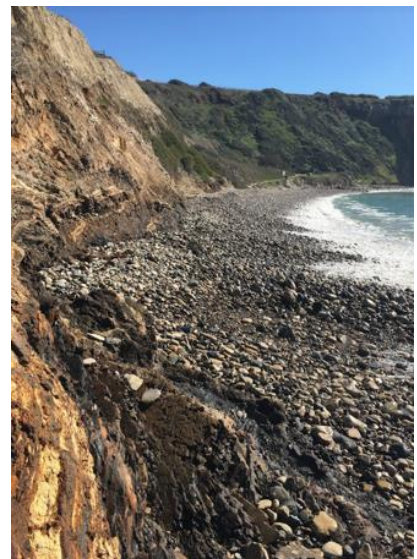

## Abalone Cove Reserve:

On January 30, OSM Staff conducted a foot patrol of the Reserve to assess the impact of overnight rains. It confirmed the upper section of Abalone Cove Trail near the picnic area had not appropriately drained. As a result, this section of the trail was temporarily closed as it continued to dry out.



On January 25, OSM Staff continued to monitor beach conditions affected by king tide and rain storm events earlier in the month. As an example, Abalone Cove Beach between Olmsted Trail and Beach School Trail has seen an increase of rocks covering the sandy beach.

### **Alta Vicente Reserve:**

On January 28, Park Rangers received a call about a sleeping bag off-trail in the Reserve. Park Rangers arrived, and located the belongings but did not observe any individuals in the area. The location was tagged and will be monitored.

On January 30, after a brief period of rain overnight, OSM Staff conducted a foot patrol to assess the impact on the Reserve. It confirmed that an approximately 15-foot section of Alta Vicente Trail had pooled with water because of poor drainage. Three channels were created to allow the water to drain out and were continuously monitored to ensure the area would dry. The trail remained open to the public as it remained passable on the inland side of the trail.



### **Forrestal Reserve:**

On January 26, Staff received a call reporting a lost stroller on Forrestal Drive. The stroller was located on January 31, and was returned to its rightful owner. For lost and found items in the Palos Verdes Nature Preserve, the public is encouraged to call the OSM Office Line at 310-544-5353 and provide a brief description of the item and contact information.

### **Ocean Trails Reserve:**

On January 31, OSM Staff conducted a beach cleanup on the eastern section of the beach below the Southshore Coastal Trail. Four 45-gallon bags of trash and several large pieces of wood were collected. This trash had been washed ashore during the king tide and rain storms earlier in the month.

## Portuguese Bend Reserve:

On January 26, OSM Staff identified damage to a chain on the Peppertree vehicle access point. Staff made repairs and replaced the chain sleeve to improve visibility.
