CITY MANAGER'S OFFICE

February 21, 2023, City Council Meeting Highlights

Last night, the City Council took no action on the Palos Verdes Historical Society's proposal to build a museum to house its collection of artifacts. The Council expressed that Lower Point Vicente does not appear to be the Council's preferred location, and that the other Peninsula cities should be involved in the process. There are no plans to revisit the proposal at this time.

The Council reviewed home fire insurance policy renewal data for RPV, which showed an overall upward trend in both voluntary and involuntary non-renewals in recent years. Tips for finding insurance are available on the City website at rpvca.gov/emergency.

The Council also approved sending a letter to the U.S. Coast Guard and federal legislators expressing the City's continued interest in acquiring both the Point Vicente Lighthouse and Battery Barnes WWII-era bunker properties.

Draft Environmental Impact Report for the Portuguese Bend Landslide Mitigation Project is Available for Review

On February 9, the City released a Draft Environmental Impact Report (DEIR) for the proposed Portuguese Bend Landslide Remediation Project. The project aims to slow a continuously moving landslide that has significantly damaged homes, utilities, and infrastructure over the past seven decades.

More than 900 residents in the vicinity of the project received a Notice of Public Hearing and Notice of Availability of Draft Environmental Impact Report for the Portuguese Bend Landslide Remediation Project. The letter included the project background and where interested persons can view the DEIR.



Student Visionary of the Year to honor the legacy of his father, who died of colon cancer in 2021.



Older Adults Who Received Bivalent Boosters Significantly Less Likely to be Hospitalized, Die from COVID-19

New data from the L.A. County Department of Public Health shows older adults who received the bivalent booster were significantly less likely to be hospitalized or die from COVID-19 than their counterparts who either were unvaccinated or were vaccinated and have not yet received the bivalent booster.

Unvaccinated adults 80 years old and older were more than three times as likely to be hospitalized and more than five-and-a-half times as likely to die than people in the same age group who received the bivalent boosters.

These trends are even more pronounced amongst those ages 65 to 79. Unvaccinated people in that age group were 12 times as likely to be hospitalized and almost 16 times more likely to die compared to others the same age who had received the bivalent booster.

Health outcomes for older people who received the booster also were significantly better than for older people who were vaccinated and have not yet gotten the booster.

People 80 years old and older who got the original series vaccinations only were more than twice as likely to be hospitalized and nearly three times more likely to die compared to others in the same age group who were fully vaccinated and had received the bivalent booster.

The same held true for people ages 65 to 79. They were nearly three times as likely to be hospitalized and three times more likely to die if they had just the original series vaccinations as compared to people the same age who received both the original vaccinations and the bivalent booster.

Cold and Dangerous Winter Storm – Be Prepared RPV!

Now is the time to prepare for a **COLD AND DANGEROUS** winter storm. Many hazards are expected over the next several days. The US National Weather Service is forecasting Several FEET of snow in the mountains, with a few inches possible as low as 1000 feet in elevation. Widespread gusty and potentially damaging winds are also expected tonight into Wednesday. Dangerous sea conditions are also likely, both in terms of winds and waves. Cold and Dangerous Winter Storm

Wednesday – This Weekend

Rain: Highest chance Thursday–Friday

- **Coasts/Valleys:** 2–3 inches
- **Peak rain rates:** 0.50–0.75 inch/hour

Snow: Highest chance Wed, Fri-Sat AM

- **Major Snow Event Likely**
 - Above 6000': 3–5 feet, up to 7 feet
 - 4000–6000': 1–3 feet
 - 2500–4000': 6–12 inches
 - 1,000'–2500': 1–4 inches

Winds: Strongest tonight–Wed

- **Mountains/Foothills:** N-NW 55–75 mph
- **Coasts/Valleys:** N-NW 35–55 mph

Cold Temperatures:

- 10–20 degrees below normal
- *Mountain wind chills 10 to 20 F, locally –5 F*

Actions/Impacts

- Be Weather-Ready by checking NWS forecasts
- Prepare for widespread road closures/delays, especially on mountain, foothill, and desert roads
- Downed trees and power lines possible
- Whiteout and blizzard conditions likely with increased threat of avalanches

Winter Weather Safety Tips



PREPARING FOR WINTER WEATHER:

Before a storm strikes, make sure your home, office, and vehicles are stocked with the supplies you might need. Make sure farm animals and pets also have the essentials they will need during a winter storm. [Know how to dress for varying degrees of cold weather.](#)

At Home and Work

Your primary concerns at home or work during a winter storm are loss of heat, power, and telephone service and a shortage of supplies if storm conditions continue for more than a day. **In either place, you should have available:**

- Flashlight and extra batteries
- Battery-powered NOAA Weather Radio and portable radio to receive emergency information



- Extra food and water such as dried fruit, nuts, granola bars and other food requiring no cooking or refrigeration.
- Extra prescription medicine
- Baby items such as diapers and formula
- First-aid supplies
- Heating fuel: refuel before you are empty; fuel carriers may not reach you for days after a winter storm
- Emergency heat source: fireplace, wood stove, or space heater properly ventilated to prevent a fire
- Fire extinguisher and smoke alarm; test smoke alarms monthly to ensure they work properly
- Extra pet food and warm shelter for pets
- Review generator safety: Never run a generator in an enclosed space
- Ensure your carbon monoxide detector is working correctly and the outside vent is clear of leaves and debris. During or after the storm, make sure it is cleared of snow.
- Home fires are common each winter when trying to stay warm. Review ways to keep your home and loved ones safe

In Vehicles:

Before you leave the house, especially before a long winter trip, ensure all fluid levels are full and that the lights, heater, and windshield wipers are in proper condition. Keep your gas tank near full to avoid ice in the tank and fuel lines. Avoid traveling alone. Let someone know your timetable and primary and alternate routes. Then call 511 for the latest traffic and road incidents, including construction and weather conditions and restrictions. Every state offers this Department of Transportation service. Call before you leave; it might change your plans!

Fully check and winterize your vehicle before the winter season begins. Carry a Winter Storm Survival Kit that includes the following:

- Mobile phone, charger, batteries
- Blankets/sleeping bags
- Flashlight with extra batteries
- First-aid kit
- Knife
- High-calorie, non-perishable food
- Extra clothing to keep dry
- Large empty can to use as an emergency toilet, tissues, toilet paper, and paper towels
- Small can and waterproof matches to melt snow for drinking water
- Sack of sand or cat litter for traction
- Shovel
- Windshield scraper and brush
- Tool kit
- Tow rope
- Battery booster cables
- Water container
- Candle and matches to provide light and, in an emergency, lifesaving heat.
- Compass and road maps don't depend on mobile devices with limited battery life

STAYING SAFE DURING WINTER WEATHER:

Stay off the roads if at all possible. If trapped in your car, then stay inside. Limit your time outside. If you need to go outside, then wear layers of warm clothing. Watch for signs of frostbite and hypothermia.

Learn the signs of, and basic treatments for, frostbite and hypothermia:

- **Frostbite** causes loss of feeling and color around the face, fingers, and toes.

- **Signs:** Numbness, white or grayish-yellow skin, firm or waxy skin.
- **Actions:** Go to a warm room. Soak in warm water. Use body heat to warm. Do not massage or use a heating pad.
- **Hypothermia** is an unusually low body temperature. A temperature below 95 degrees is an emergency.
 - **Signs:** Shivering, exhaustion, confusion, fumbling hands, memory loss, slurred speech, or drowsiness.
 - **Actions:** Go to a warm room. Warm the center of the body first—chest, neck, head, and groin. Keep dry and wrapped in warm blankets, including the head and neck.

Power Outage Preparedness Tips

As California continues to deal with extreme weather events, everyone in our state should take steps to prepare themselves and their families for events like a Public Safety Power Shutoff (PSPS), rolling blackouts, and extreme weather events.

Such events may leave many Californians without power for hours and sometimes days. Moreover, other natural disasters like earthquakes, floods, cyber-attacks, and wildfires can potentially disrupt power for long periods.

Power outages can impact the whole community and the economy by:

- Disrupting communications, water, gas, and transportation.
- Closing retail businesses, grocery stores, gas stations, ATMs, banks, and other services.
- Causing food spoilage and water contamination.

- Preventing the use of medical devices.

Be sure to take the following steps to mitigate the effects of a power outage and to keep you and your family safe in the event of a power failure.

Preparing for a Power Outage

- Take inventory of the items you need that rely on electricity.
- Plan for batteries and alternative power sources to meet your needs when the power goes out, such as a portable charger or power bank.
- Have flashlights for every household member.
- Determine whether your home phone will work in a power outage and how long battery backup will last.
- If possible, keep vehicles fully gassed and have cash on hand if ATM's are unavailable.

Know Your Medical Needs

- Talk to your medical provider about a power outage plan for devices powered by electricity and refrigerated medicines.
- Know how long your medications can be stored at higher temperatures and get specific guidance for any medications that are critical for life.

Generator Safety

Portable backup generators produce the poison gas carbon monoxide (CO). CO is an odorless, colorless gas that kills without warning. It claims the lives of hundreds of people every year and makes thousands more ill. Follow these steps to keep your family safe.

When using Portable Generators:

- Never use a generator inside your home or garage, even if you open doors and windows.
- Only use generators outside, more than 20 feet away from your home, doors, and windows.

CO Detectors

- Install battery-operated or battery-backup CO detectors near every sleeping area in your home.
- Check CO detectors regularly to be sure they are functioning properly.

Food Storage

- Have enough nonperishable food and water for every member of your household for three days.
- Open freezers and refrigerators only when necessary. Your refrigerator can keep food cold for four hours. A full freezer will maintain the temperature for two days. Use coolers with ice if necessary.
- Monitor temperatures with a thermometer. Throw out food if temperatures reach 40 degrees or higher.

After A Power Outage

- Throw away any food exposed to temperatures 40 degrees or higher for two hours or more or has an unusual odor, color, or texture.
- If the power is out for more than a day, discard any medication that should be refrigerated unless the drug's label says otherwise. Consult your doctor or pharmacist immediately for a new supply.
- Please keep away from power lines: Stay at least 35 feet away from fallen power lines and anything they touch. Call 911 and let them know.
- Restock your emergency kit so the supplies will be there when needed again.

Apply Today for a Security Camera Grant!

The City is pleased to announce that the Public Safety Reimbursement Program is once again accepting applications! The program provides a partial reimbursement to individuals and neighborhoods for a public safety purchase such as a security camera.

Individuals are eligible to apply for a 50% reimbursement up to \$100, awarded based on a random draw, for external security cameras such as doorbell cameras. Neighborhoods are eligible to apply for a 50% reimbursement up to \$2,000, awarded based on a rubric, for neighborhood entrance/exit security cameras.



Consumer Price Index, Los Angeles Area — January 2023

Overview

As measured by the Consumer Price Index (CPI), prices in the Los Angeles area increased 1.9 percent in January compared to the prior month. Over the last 12 months, the CPI-U advanced 5.8 percent. Of the major categories, food prices increased by 7.6 percent annually, while energy prices rose 17.5 percent from a year ago. The index for all items less food and energy, core inflation, rose 4.5 percent over the year. Chart 1 provides a five-year overview of annual percent changes in all items CPI-U through January 2023.

Chart 1. Los Angeles, CPI-U 1-month and 12-month percent changes, all items index



Food

Food prices advanced 0.8 percent for January. Prices for food at home rose 1.0 percent, with higher prices in five of the six grocery categories. Prices for food away from home rose 0.5 percent for the same period. Over the year, prices for food at home rose 9.3 percent since a year ago, while food away from home grew by 7.6 percent.


Energy

The energy index advanced 15.6 percent over the month. Increases remain attributable to higher prices for natural gas service and electricity, however, prices for gasoline fell 1.2 percent during the same period.

All items less food and energy (core inflation)

The index for all items less food and energy increased by 1.0 percent in January. Higher prices for apparel, new and used motor vehicles, and shelter were partially offset by lower prices for education and communication. Over the year, the index for all items less food and energy rose 4.5 percent. Chart 2 reflects annual changes from January 2020 to January 2023 to compare all items inflation to all items less food and energy.







Outreach to the United States Coast Guard on Maintenance and Repair Issues

At its February 21 meeting, the City Council received and filed a report on maintenance and repair issues at two U.S. Coast Guard properties in Rancho Palos Verdes. The two sites are the Point Vicente Lighthouse complex located off Palos Verdes Drive South and Battery Barnes, a 3.9-acre site adjacent to the Ken Dyda Civic Center that houses a World War II-era bunker.

The City Council directed Staff to send a letter from Mayor Ferraro expressing the City's continued interest in acquiring both properties as part of a Coast Guard divestiture process. Council directed Staff to include the following in the letter:

- The City's desire to preserve the sites' historic importance
- Deferred maintenance could impact opportunities for preservation
- Battery Barnes is embedded within City property
- City would highlight the legacy and history of the U.S. Coast Guard at the Point Vicente Lighthouse and would increase public awareness and access of the Coast Guard museum.
- Emphasize how integral the two sites are to the City





Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force.(2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

Continuation of Meeting:
