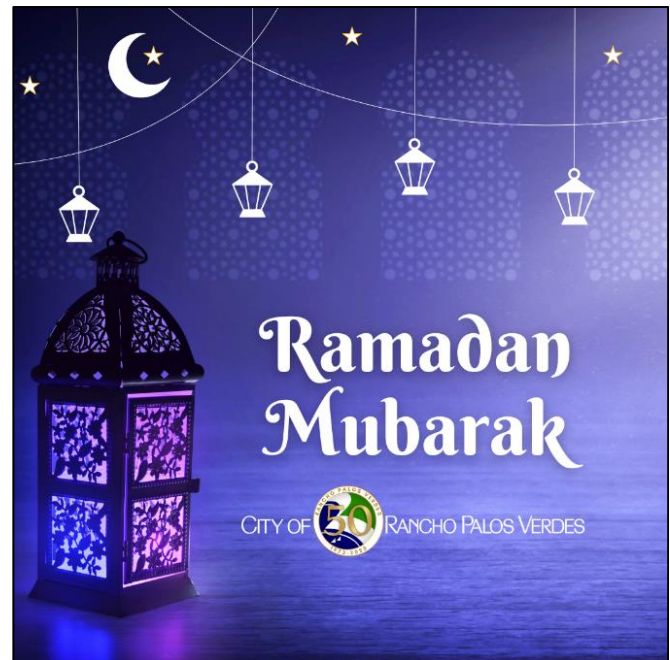

March 21, 2023 City Council Meeting Highlights

Last night, the City Council held a public hearing to seek feedback on the Draft Environmental Impact Report (EIR) for the proposed Portuguese Bend Landslide Remediation Project, which aims to significantly slow the landslide by removing groundwater and preventing rainwater from entering the earth.

Staff provided an overview of the Draft EIR, which found that the project would have less than significant impacts on the environment associated with construction, including



temporary and permanent loss of habitat for sensitive species. These impacts would be mitigated through avoidance and minimization methods, habitat restoration, and close biological monitoring, with approval from state and federal wildlife agencies per the City's Natural Community Conservation Plan/Habitat Conservation Plan.

The Council discussed feedback from the public, including questions about native vegetation that will be planted in the surface drainage system, which will convey rainwater to the ocean and prevent it from percolating underground.

After the public comment period ends on April 14, the City's environmental consultant will review the comments, respond to them, and make any final revisions to the report. A Final EIR will go before the City Council for certification at a future meeting, likely in summer 2023. Certifying the EIR does not approve the project, which is still subject to permitting by the City and other regulatory agencies .

Public Comments on Draft Environmental Impact Report for the Portuguese Bend Landslide Mitigation Project Due April 14

On February 9, the City released a Draft Environmental Impact Report (DEIR) for the proposed Portuguese Bend Landslide Remediation Project. The project aims to slow a continuously moving landslide that has significantly damaged homes, utilities, and infrastructure over the past seven decades.

More than 900 residents in the vicinity of the project received a letter, the Corrected Notice of Public Hearing and Notice of Availability of Draft Environmental Impact Report for the Portuguese Bend Landslide Remediation Project. The letter included the project background and where interested



persons can view the DEIR.

Annual Budget Workshop April 6



On April 6, the City Council will host its annual budget workshop for the General Fund (the City's chief operating fund).

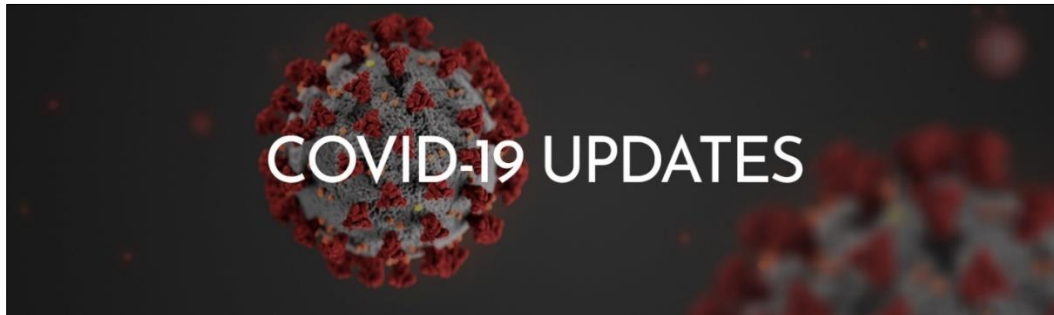

SBCCOG 2023 General Assembly - March 23

Update on Tax-Defaulted Property

Earlier this week, Staff was contacted by the L.A. County Treasurer and Tax Collector's Office (TTC) regarding a tax-defaulted property in the Portuguese Bend Landslide area that the City applied to purchase for landslide abatement via a Chapter 8 agreement following authorization from the City Council on March 7. Staff was informed that the property is no longer available, as the property owner paid the back taxes. Staff will continue to monitor lists of available properties distributed periodically by the TTC.



RPV Ends COVID-19 Local Emergency Declaration

As COVID-19 and its impact on the local medical system have subsided and it is no longer an immediate emergency, last night, the Rancho Palos Verdes City Council adopted a resolution ending the City's local emergency declaration that was originally issued on March 17, 2020. The move follows announcements to end COVID-19 emergency declarations at the federal, state, and county levels.

What does this mean for RPV?

Today, the City's virtual Emergency Operations Center (EOC) was deactivated after operating for the past three years at Level 3, the lowest activation level. While the EOC is no longer active, City Staff will continue to follow COVID-19 updates from the U.S. Centers for Disease Control and Prevention (CDC), the California Department of Public Health, the California Division of Occupational Safety and Health (Cal/OSHA), and the L.A. County Department of Public Health.

Starting next week, the City Manager's Weekly Administrative Report will no longer include a COVID-19 Updates section. Any significant future developments will be shared in the general City Manager's Office section of the report and via the City's Breaking News listserv and social media pages.



Those At-Home COVID-19 Tests You've Had for Months? They're Likely Still Good Despite What Their Expiration Dates Say

Many at-home COVID-19 tests remain effective for as much as up to one year after their original expiration dates. This has led to the Food and Drug Administration extending the expiration dates for many tests.

The easiest way to tell if a test you are using is still effective is to take the test and ensure there is a control line marked by a "C." If the control line is absent or discolored, the test is truly expired, and a different test should be used.

Remember, false negatives may occur if you test too soon after your COVID-19 exposure. In this case it is always a good idea if you have symptoms, to act as if you do have COVID until you retest – isolating and preventing potential exposure. To reduce risk of transmission, please continue to always mask within 10 days of the last exposure to a known COVID case.

At [COVIDtests.gov](https://www.covidtests.gov) residents can mail order four free tests per household. The federal government is also still requiring insurance companies to cover up to eight COVID-19 tests per month. This means that in many pharmacies you can pick up COVID-19 tests, provide your insurance information, and get the tests with no up-front costs.

Fire Hazard Severity Zone Map Changes Webinar

On March 27, Staff will participate in a Fire Hazard Severity Zone Map Changes Webinar hosted by Cal Cities. Changes to the state's fire hazard zones are anticipated to have major impacts on local land use policies and wildfire management. Areas in both the Fire Hazard Severity Zone State Responsibility Area (SRA) Map and the soon-to-be-released Local Responsibility Area (LRA) Map have been recategorized into different severity levels.

This is an opportunity to connect with city officials, Cal FIRE, and the California Office of the Insurance Commissioner to learn about the maps' methodology, as well as their effect on future insurance costs, fire mitigation efforts, planning, and zoning.

California Tsunami Preparedness Week

2023's California Tsunami Preparedness Week is March 25 – 31! As part of California's Tsunami Preparedness Week, the City encourages beachgoers, visitors, and residents who live near the City's coastline to practice tsunami awareness by accessing life-saving preparedness information to support California's Tsunami Preparedness Week - a statewide campaign.

Everyone who lives, works, or plays near the coastline, should know how to protect themselves from a tsunami. Tsunamis are large ocean waves generated by major local or distant earthquakes or major landslides in the ocean. Ocean waves, ranging from several feet or much larger, can strike the coast with devastating force. Tsunamis can occur here in Southern California and impact the Peninsula and surrounding cities.

Tsunami Hazard Area maps available on the [state's tsunami website](#) illustrate how a tsunami could impact our coastline using new data and modeling developed over the past ten years, using lessons learned from the 2011 Tōhoku region event coupled with new tsunami hazard information and mapping tools. Easy-to-use [interactive web applications](#) now reflect that some areas of our coastline may have a higher tsunami hazard than previously represented in prior hazard maps.

Tsunamis can be catastrophic in the short and long-term, affecting millions of people over wide geographical areas up to thousands of miles away from the source. Any member of the public can take these immediate preparedness steps to keep themselves, their families, and loved ones safe in the event of a tsunami:

- Take a “tsunami walk” with your family, friends, and loved ones; [get to know your zone](#) and be alert when at work, home or playing near the ocean.
- Create a personal tsunami evacuation plan. For more information on individual tsunami hazards and preparations, review the [California Tsunami Preparedness Guide](#), which explains how you can be tsunami ready.
- Next time you visit a local beach area for fun, work, or exercise, be on the lookout for local tsunami preparedness signage and identify a safe evacuation area and evacuation routes to get to higher ground quickly.



- Sign up for Alert SouthBay: Alert SouthBay is a multi-jurisdictional emergency notification system used by 13 South Bay cities – including Rancho Palos Verdes - to keep our communities informed about disasters and emergencies with uniform, expeditious alerts. Pet Preparedness Tips

Pets are an essential part of our society and, for many, an extension of their household and members of the family. In an emergency, your pets will be even more dependent on you for their safety and well-being. When a

disaster strikes, it is too late to consider how you will care for your pets. That is why it is important to incorporate a plan for your pets in your family's emergency plans. The following are some basic tips that will help ensure you and your pets are prepared in the face of an emergency:



MAKE A PLAN:

- **Have an evacuation plan for your pet:** Many public shelters and hotels do not allow pets inside. Identify a safe place to take your pets before disasters and emergencies happen.
- **Develop a buddy system:** Before an emergency, be sure to plan with your neighbors, friends, or relatives to make sure that someone is available to care for or evacuate your pets if you are unable to do so.
- **Have your pet microchipped:** Keep your address and phone number up-to-date and include contact information for an emergency contact outside of your immediate area.

BUILD A KIT:

Ensure your pet is prepared for an emergency by assembling a pet disaster kit in advance of a disaster. Be sure to discuss the types of things you should include in your pet's emergency first aid kit with your veterinarian. Below are basic items you should have in your pets' disaster kits.

Your kit should include:

- Sturdy leashes, harnesses, and/or carriers to transport pets safely and ensure they can't escape.
- Food, drinking water, bowls, cat litter/pan, and a manual can opener if your pet eats canned food.
- Medications and copies of medical records stored in a waterproof container.
- Current photos of you with your pet(s) in case they get lost. Since many pets look alike, this will help to eliminate mistaken identity and confusion.
- Information on feeding schedules, medical conditions, behavior problems, and the name and number of your veterinarian in case you have to foster or board your pets.
- Pet beds and toys, if easily transportable.

TIPS FOR LARGE ANIMALS:

Emergency preparedness is important for all animals but especially for horses and larger animals because of their size and special transportation needs. Consider these tips as you prepare your evacuation plan:

- Before the emergency, make arrangements to shelter your animals at two different locations far apart from each other.
- If you have large animals, evacuate when you hear the evacuation warning.
- Train horses to lead and trailer so that they become comfortable with the process.
- Keep your truck and trailer in safe, working condition (gas tank full). If you don't have a truck and trailer, make arrangements in advance to have someone evacuate your animals.
- Know who is evacuating your animals. Be sure to exchange phone numbers, California Driver's License numbers, and other relevant information with the person evacuating your horse. Know where your animals will be taken.
- Network with your neighbors prior to an emergency. Work together to help horse/large pet owners on your street who do not have horse trailers or who are not home during an emergency.

Apply Today for a Security Camera Grant!

The City is pleased to announce that the Public Safety Reimbursement Program is once again accepting applications! The program provides a partial reimbursement to individuals and neighborhoods for a public safety purchase such as a security camera. Individuals are eligible to apply for a 50% reimbursement up to \$100, awarded based on a random draw, for external security cameras such as doorbell cameras. Neighborhoods are eligible to apply for a 50% reimbursement up to \$2,000, awarded based on a rubric, for neighborhood entrance/exit security cameras. Retail Headlines - March 2023

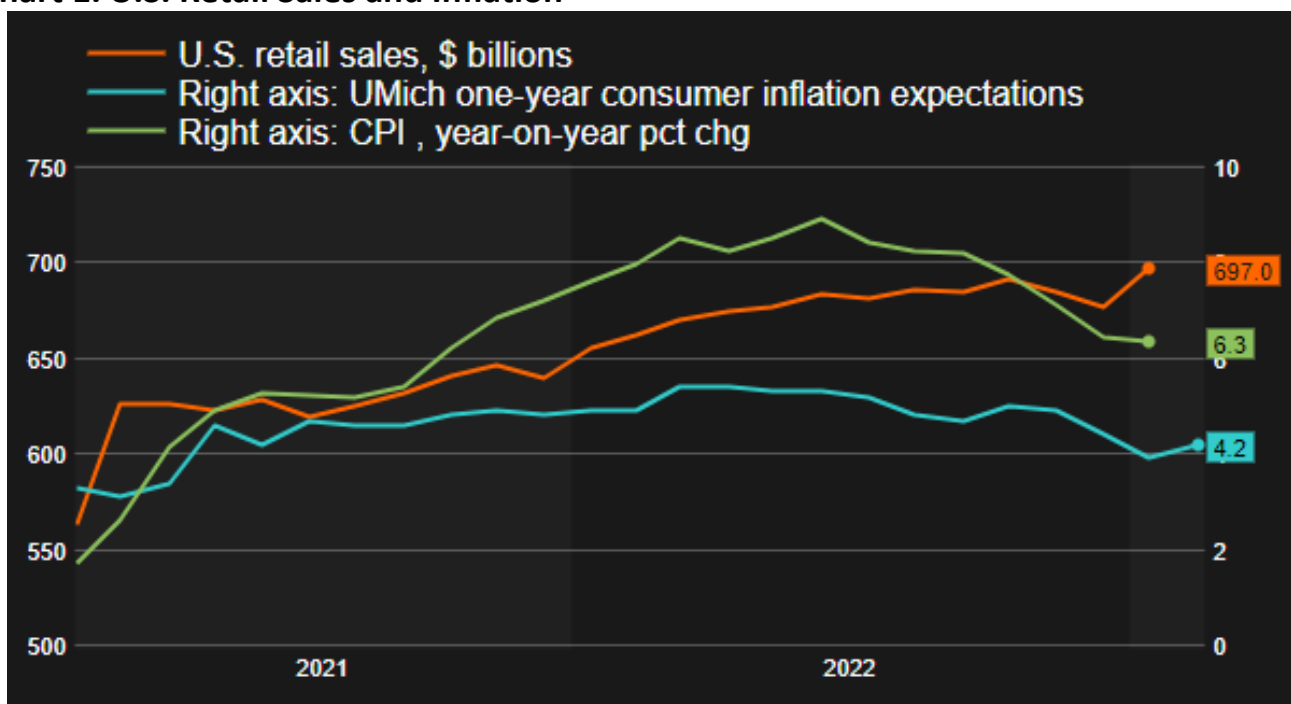
The City's revenue consultant, HdL, outlines a variety of industry headlines associated with sales tax. In March, the latest headlines covered topics including U.S. retail sales, consumer cutbacks, and used car price increases. A summary of these notable events impacting the local economy are highlighted below.

U.S. Retail Sales Roar Back in January

In January, U.S. retail sales experienced the largest increase in nearly two years following two consecutive monthly declines. This surge, primarily driven by purchases of motor vehicles and other goods, points to a resilient consumer despite higher borrowing costs. Relatively large sales increases were observed in clothing stores as well as for tax receipts at general merchandise and health care stores.

As observed in chart 1, U.S. retail sales broke through the annualized inflation rate, which has remained above sales since late 2020. While retail sales increased 3% over the prior month and 6.4% year-over-year in January.

Chart 1. U.S. Retail Sales and Inflation



Nearly 70% of Consumers Cut Back on Nonessential Spending

In a related trend, a recent survey suggests that nearly 70% percent of consumers plan to cut back on nonessential spending over the next six months. Around 15% of respondents reported intentions to halt nonessential purchases altogether. Another 26% of respondents aim to spend an equal amount on luxury and designer goods, while 21% plan to purchase more luxury goods over the same timeline.

What's the Deal with Small Format Retail?

Many retailers – from traditional big-box to local grocers – are adjusting their store models and shifting to “smaller-format” stores that occupy a fraction of the square footage of traditional models. These smaller stores provide a benefit to retailers by offering lower overhead.

CarGurus Report Finds Used Car Price Trends Reverse as Inventory Tightens

CarGurus recently released its February 2023 U.S. Intelligence Report. According to the findings, February marks the first time the average used vehicle price has risen month-over-month since July 2022.



The average used car listing price rose by 1% in February to just over \$29,500. Industry experts believe that the combination of declining used inventory, rising wholesale prices, and growing consumer demand for lower-priced vehicles has put upward pressure on prices.

Ladera Linda Community Park Project Update

The rain continued to impact various activities last week, with no work on Tuesday, Wednesday, and Thursday. Crews continued to frame the building exterior overhang and install exterior sheathing, roofing, and the utilities and trash enclosure. On the interior, they continued ceiling framing, roughing-in light fixtures, and installing HVAC control wiring.

This week, weather permitting, work will continue from last week on the accessibility ramp, stepped terrace, and parking lot drains. Site access through the lower gate is expected to be extended in response to recent and forecasted rain for the week. Adjacent neighbors have been notified.

Public Works is monitoring the roadway, and City contractors will be making repairs to affected areas as they are needed in the months to come.

Household Hazardous Waste/Electronic Waste Roundup

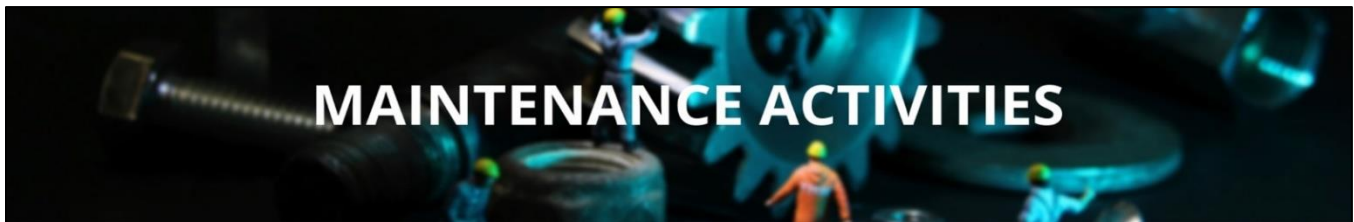

In addition to regularly scheduled maintenance and repairs, Public Works performed the following:

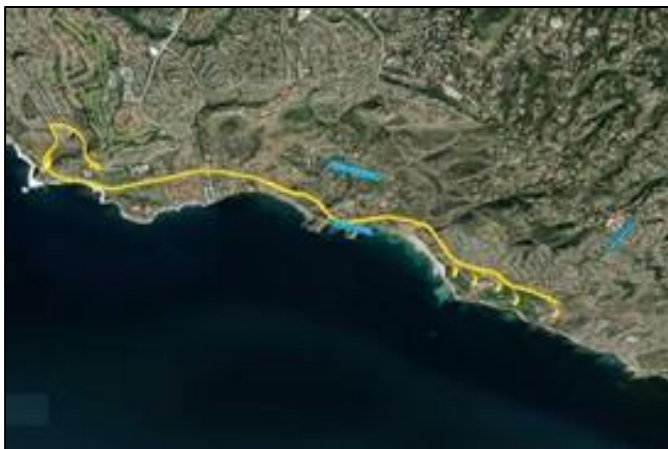


- Weekly landscape maintenance at all City parks.

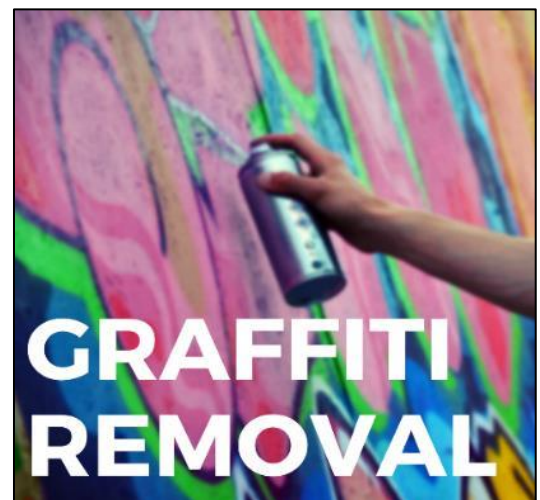
Public Right of Way/Roadway Repairs

March 15th LAX Community Noise Roundtable Meeting Summary

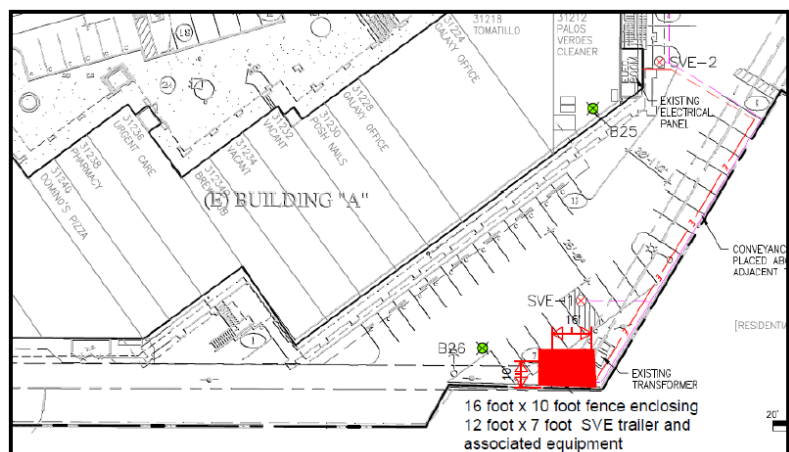

REMINDER - Public Notice Issuance for a Special Use Permit Revision at the Golden Cove Shopping Center

On March 9, 2023, the Community Development Department will issue a public notice (attached) for a Special Use Permit Revision (Case No. PLSU2023-0001) at the Golden Cove Shopping Center located at 31244 Palos Verdes Drive West for the continued on-site operation of a Spoil Vapor Extraction (SVE) system. The SVE system is located at the rear of the



shopping center, as identified in the plan above serves to remediate subsurface chemicals related to the historical dry-cleaning operations at the shopping center. The public notice serves as notification that the Director of Community Development will consider a request by the Applicant to extend the operation of the SVE for two additional years. **The public comment period will end on Friday, March 24, 2023.**

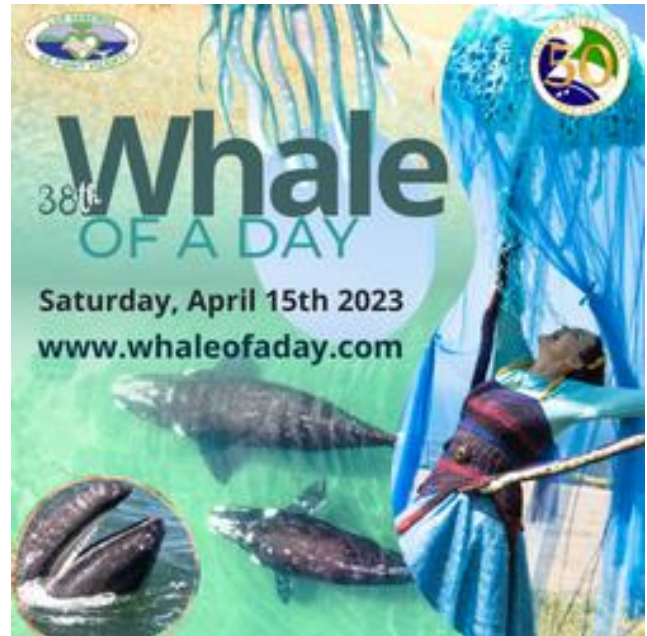

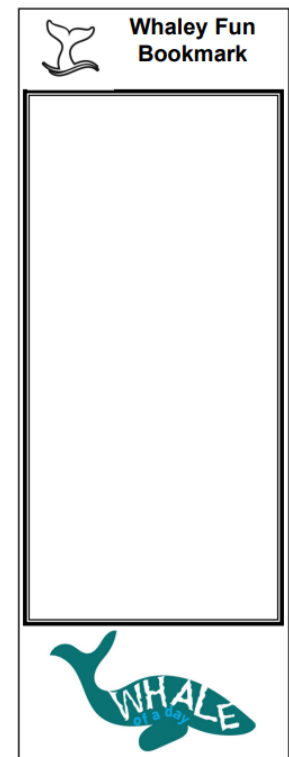

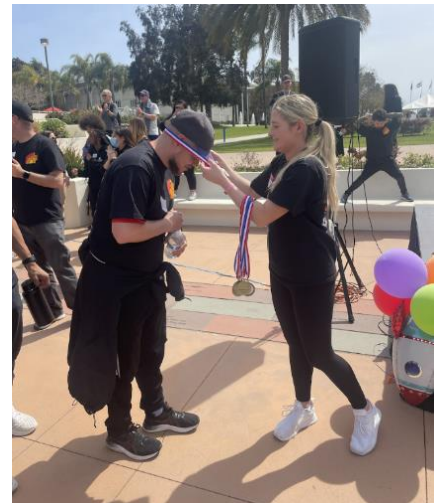
REACH Rolls On!

The REACH program serves the social and recreational needs of youths and adults with developmental disabilities and is back at Hesse Park for in-person activities.

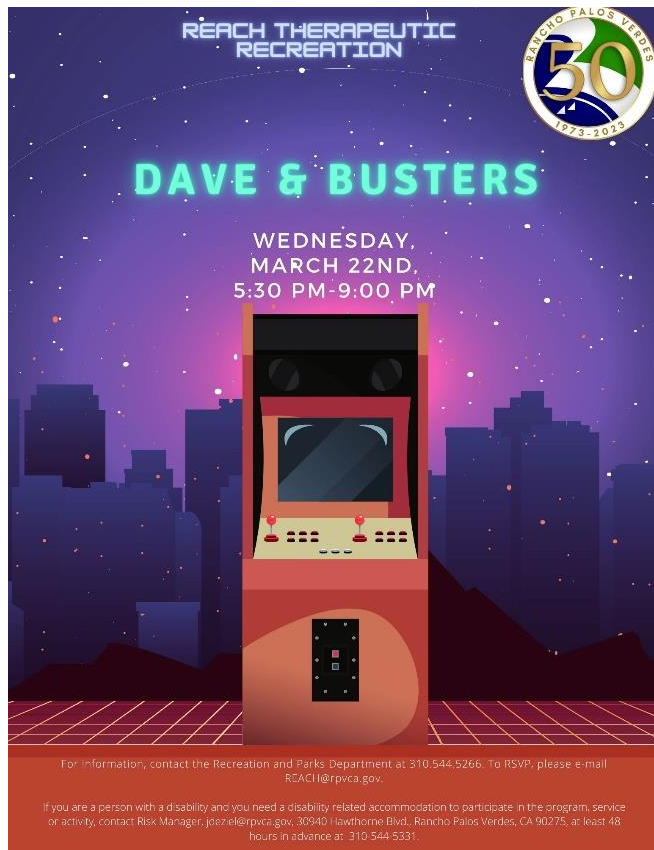

Abalone Cove Reserve:

Cliffside Trail remains temporarily closed as Staff continues to monitor land movement in this area following the additional rain projected in the forecast. There are several cracks on the trail bed, in addition to a slough that came down from the adjacent cliff.



Portuguese Bend Reserve:

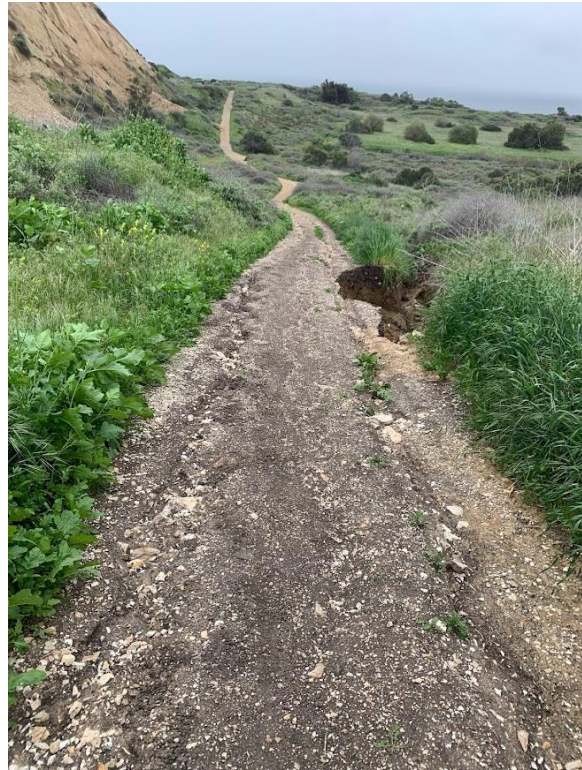
On March 17, Staff worked to clear debris from a mudslide and rockslide on Burma Road Trail to ensure the trail remains accessible for authorized vehicles. Staff continue to monitor trail conditions after rains to conduct repairs.



On March 19, Rangers repaired the lower sections of Burma Road Trail near the Barn Owl Trail by creating a small grade dip to help water flow away from the trail bed and into the adjacent habitat.



On March 19, the bottom section of Peppertree Trail between Ishibashi Farm Trail and Sandbox Trail is temporarily closed. An approximately 7-foot-deep trench has been created by the recent rains, resulting in the narrowing of the trail.



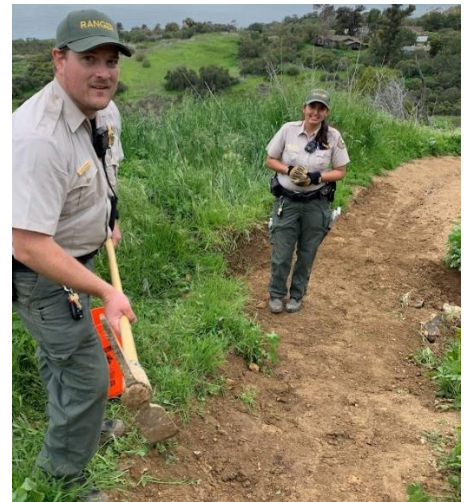
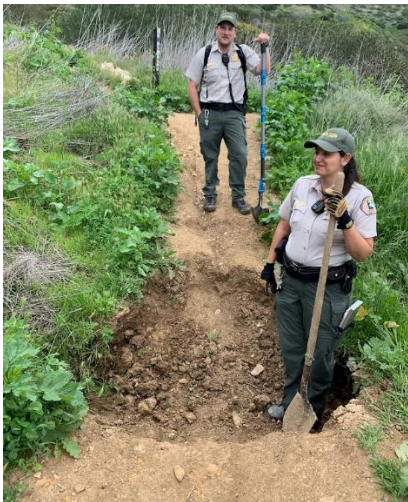
On March 19, a rockslide occurred on Peppertree, halfway between Sandbox Trail and Klondike Canyon Trail. As a result, trail users are advised to use caution.



On March 20, Garden Trail was temporarily closed due to land movement and fissures that have opened up on the trail. The City will be working with the City Geologist and with the habitat manager, Palos Verdes Peninsula Land Conservancy, to discuss solutions.



On March 20, Rangers filled in a fissure on Peppertree Trail just below Landslide Scarp Trail that had caused an 18-inch step down from the trailbed. The trailbed has been repaired and will continue to be monitored.

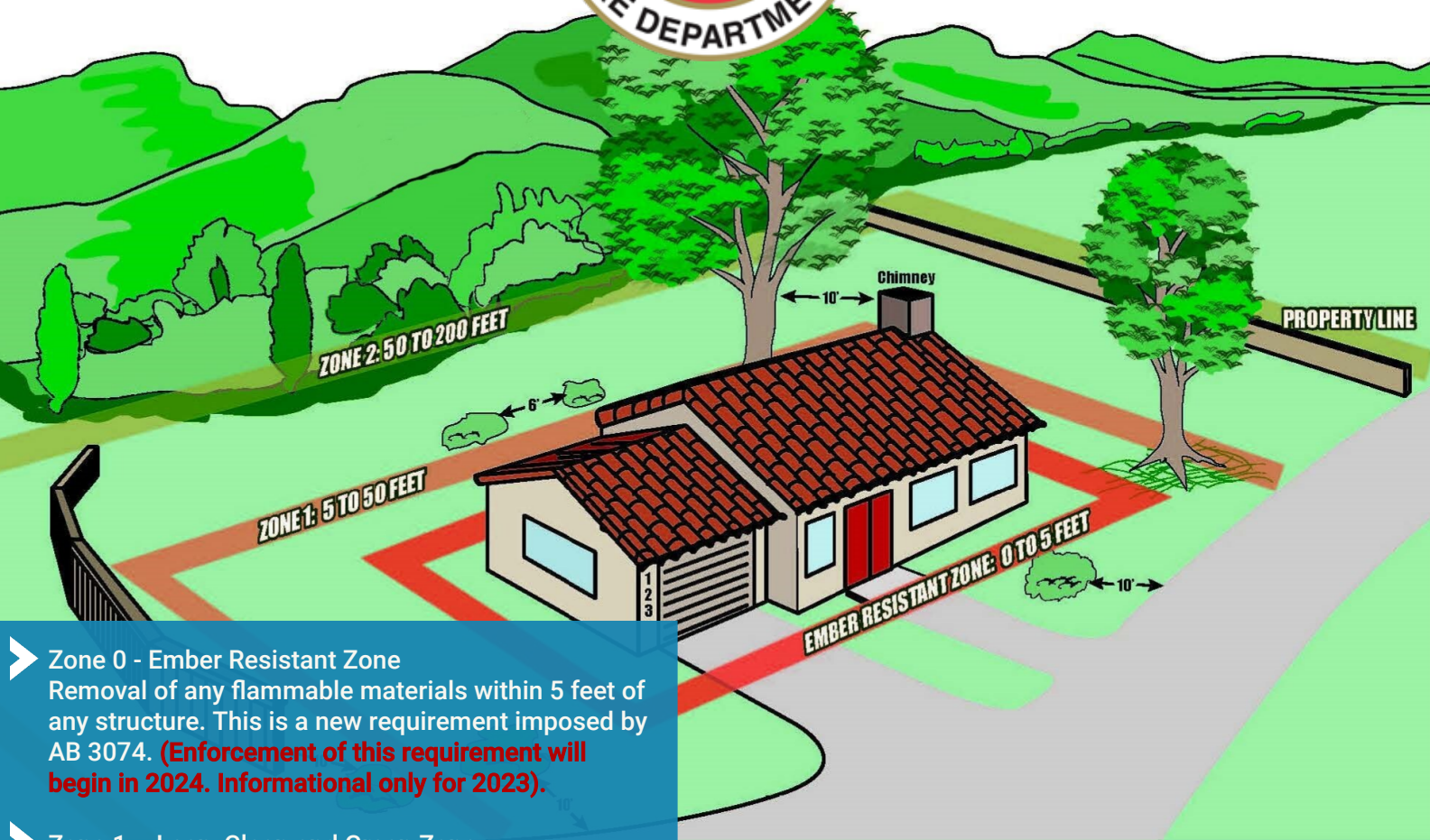

- **Zone 0 - Ember Resistant Zone**
Removal of any flammable materials within 5 feet of any structure. This is a new requirement imposed by AB 3074. **(Enforcement of this requirement will begin in 2024. Informational only for 2023).**
- **Zone 1 – Lean, Clean and Green Zone**
Removal of flammable vegetation within 50 feet of any structure.
- **Zone 2 – Reduce Fuel Zone**
Remaining vegetation for the next 150 feet, for a total of 200 feet, shall be limbed up and include removal of dead wood.
- Specimen native trees and shrubs are permitted, provided they are spaced to not allow transmission of fire to a structure.
- Access roads must maintain 10 feet of brush clearance on each side and shall maintain adequate vertical clearance.
- Fire hydrants shall maintain clearance of 3 feet.

ANNUAL BRUSH CLEARANCE REQUIREMENTS

INSPECTION TIMELINE

Your local fire station will begin inspections on June 1, 2023. If hazardous fire conditions exist on your property at the time of inspection, You will have 30 days to make the necessary corrections.

INSPECTION FEE

An Inspection Fee of \$100.00 will be assessed on all declared hazardous properties whether or not they are cleared by the property owner. Inspection fees will be assessed annually and applied to your November property Tax Bill.

Brush Clearance Annual Notice FAQs

Residents of the Palos Verdes Peninsula have recently received a Defensible Space Annual Notice (formerly known as the Brush Clearance Annual Notice) from the Los Angeles County Fire Department (LACoFD). Some homeowners are receiving this notice for the first time due to updated mapping software. Consequently, the Peninsula Cities received resident inquiries seeking clarification. In collaboration with the (LACoFD), the four cities of the Palos Verdes Peninsula are providing this Brush Clearance Annual Notice FAQ's with additional information and clarification regarding the current requirements for brush clearance.

Why Did I Receive this Notice?

- The Palos Verdes Peninsula is primarily located within a state-designated Very High Fire Hazard Severity Zone (VHFHSZ).
- State law (California Public Resources Code 4291) requires single-family dwellings within the VHFHSZ to maintain defensible space around these structures at all times.
- The LACoFD conducts defensible space inspections on residential single-family dwellings annually.

What is a Fire Hazard Severity Zone?

- CAL FIRE is required by law to map significant fire hazard areas based on fuels, terrain, local weather, and other factors.
- These designations, known as Fire Hazard Severity Zones (FHSZ), mandate how people construct buildings and protect property to reduce the risk of wildfires.
- The Palos Verdes Peninsula is almost entirely designated as a Very High Fire Hazard Severity Zone (VHFHSZ).

Why is this the First Time I Am Receiving this Notice?

- The LACoFD has recently updated its mapping software using a geospatial database to create its Defensible Space Inspection Program that is significantly more accurate.
- The updated mapping system has resulted in numerous new properties subject to the brush clearance requirement for the very first time

When will My Property be Inspected?

- Your local fire station will begin inspections on June 1, 2023.

Is There a Fee for the Inspection?

- Yes, an inspection fee has always been assessed on properties subject to the required brush clearance. However, in December of 2021, the Board of Supervisors approved increasing the inspection fee over the next 3 years at the following rate (2021 - \$50.00, 2022 - \$100.00, and 2023 - \$151.00).
- The Fee will be assessed in November as part of your property tax bill.



How will I know if I passed the Brush Clearance Inspection?

- An Inspection Report identifying compliance or non-compliance will be left on your door.

Do I Have to be Home for the Brush Clearance Inspection?

- No, your local fire station will attempt to complete the inspection through only unlocked and open access.
- If your gate is locked or your property inaccessible, a notice will be left at your day on who to call to schedule an inspection appointment.

If found to be Non-Compliant, how much time will I have to make corrections?

- Owners have a minimum of 30 days to complete corrections.

Can I Call Someone if I Need Clarity on Requirements?

- Inquiries should be directed to the Brush Clearance Unit at (626) 969-2375.

What Is Assembly Bill 38 (AB 38)?

- Assembly Bill 38 (AB-38), commonly referred to as Real Estate Inspections, took effect on July 1, 2021. AB-38 requires that during escrow the seller of a property in the VHFHSZ submit documentation of a compliant defensible space inspection prior to closing. Homes that received their annual brush inspection within six months of closing can use that inspection, if compliant, to satisfy this requirement

What Is Assembly Bill 3074 (AB 3074)?

- State Assembly Bill 3074 (AB-3074) establishes a new brush clearance zone called “Zone 0”, which is a 5 foot Ember Resistant Zone that requires removal of all flammable materials within 5 feet of any structure.
- Zone 0 requirements will not be enforced until 2024, the LACoFD will be using this year’s inspections to educate property owners on what they need to do to become compliant with next year’s Zone 0 requirements.

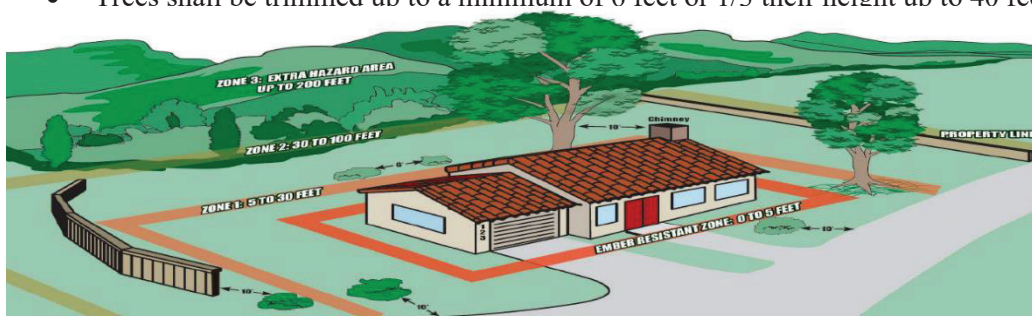


BRUSH CLEARANCE REQUIREMENTS

It is a property owner's responsibility to properly and timely clear vegetation around all structures. A fire safe landscape creates a defensible space to help protect against approaching wildfires and flying embers which could safe your home and personal belongings.

WHAT ARE YOUR RESPONSIBILITIES

- Establish a 5-foot Ember Resistant Zone around all structures. Eliminate all vegetation and materials that could be ignited by embers from a wildfire. **This is a new requirement imposed by the State of California via AB 3074. Enforcement of this requirement will begin in 2024. Informational only for 2023.**
- In the VHFHSZ, a defensible space is considered 200 feet around all structures, based on the following zones:
 - Within the first 5 feet of any structure (Zone 0), removal of all vegetation;
 - Within the next 50 feet of any structure, removal of flammable vegetation is required. Native and ornamental vegetation known to be flammable, including but not limited, to Acacia, Cedar, Cypress, Eucalyptus, Juniper, Pine, and Pampas Grass. Ornamental grasses and ground cover should be maintained at no higher than 3 inches;
 - Within the next 150 feet (or up to the property line), remaining vegetation is required to be thinned
 - Remaining vegetation for the next 150 feet (or up to property line) around any structure is required to be cleared, trimmed, thinned, limbed up removing flammable vegetation and dead wood;
 - The total defensible space should measures a total of 200 feet from any structure (or up to the property line);
 - Specimen native trees and shrubs are permitted, provided they are spaced to not allow transmission of fire to a structure; and,
 - It is recommended that specimen shall be spaced a minimum of 15 feet or 3 times diameter from other specimens, structures or surrounding native brush.
- Access road shall be maintained with a minimum of 10 feet of brush clearance on each side. Fire access roads shall have an unobstructed vertical clearance to the sky. Trees overhanging fire access road shall be maintained to provide adequate vertical clearance.
- Fire hydrants shall maintain clearance of 3 feet.
- All trees and shrubs shall be maintained free of deadwood and litter.
 - Shrubs shall be trimmed up from the ground 1/3 of their height.
 - Trees shall be trimmed up to a minimum of 6 feet or 1/3 their height up to 40 feet.

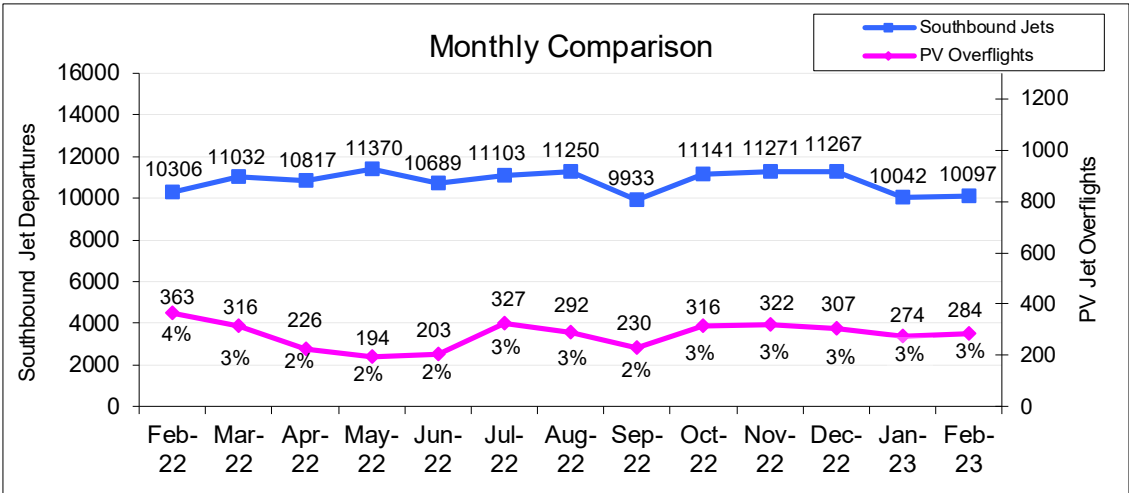
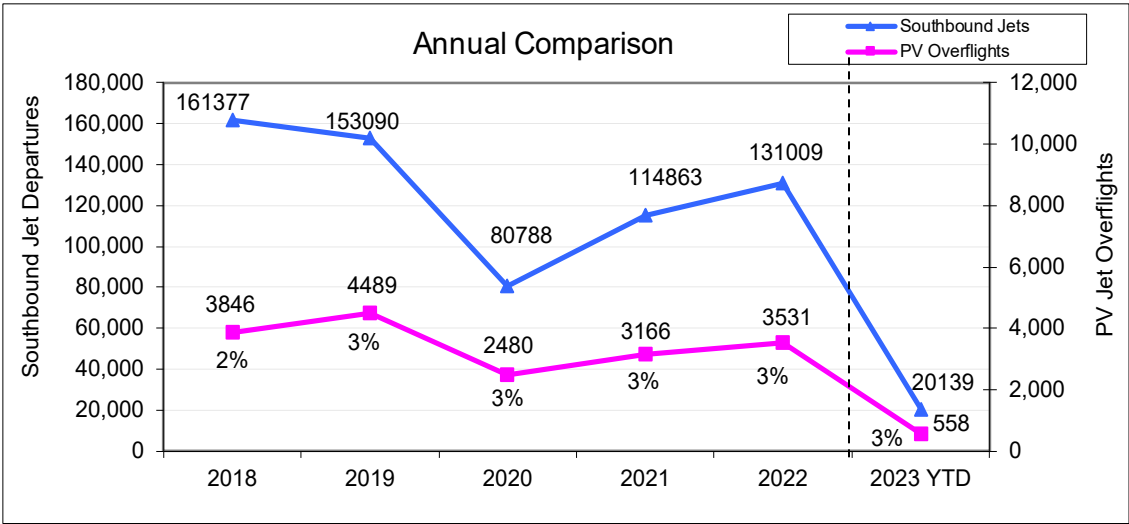
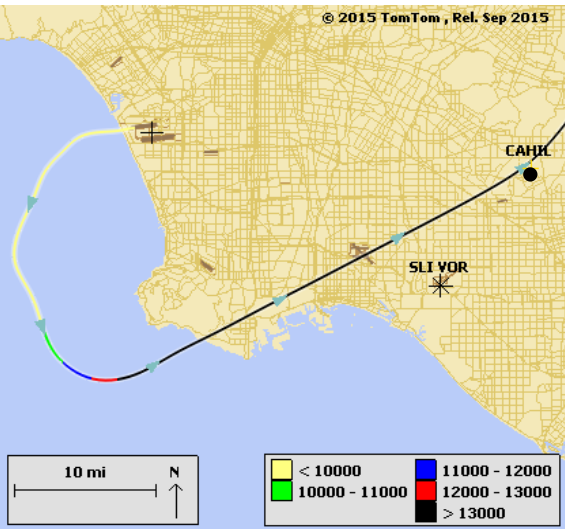

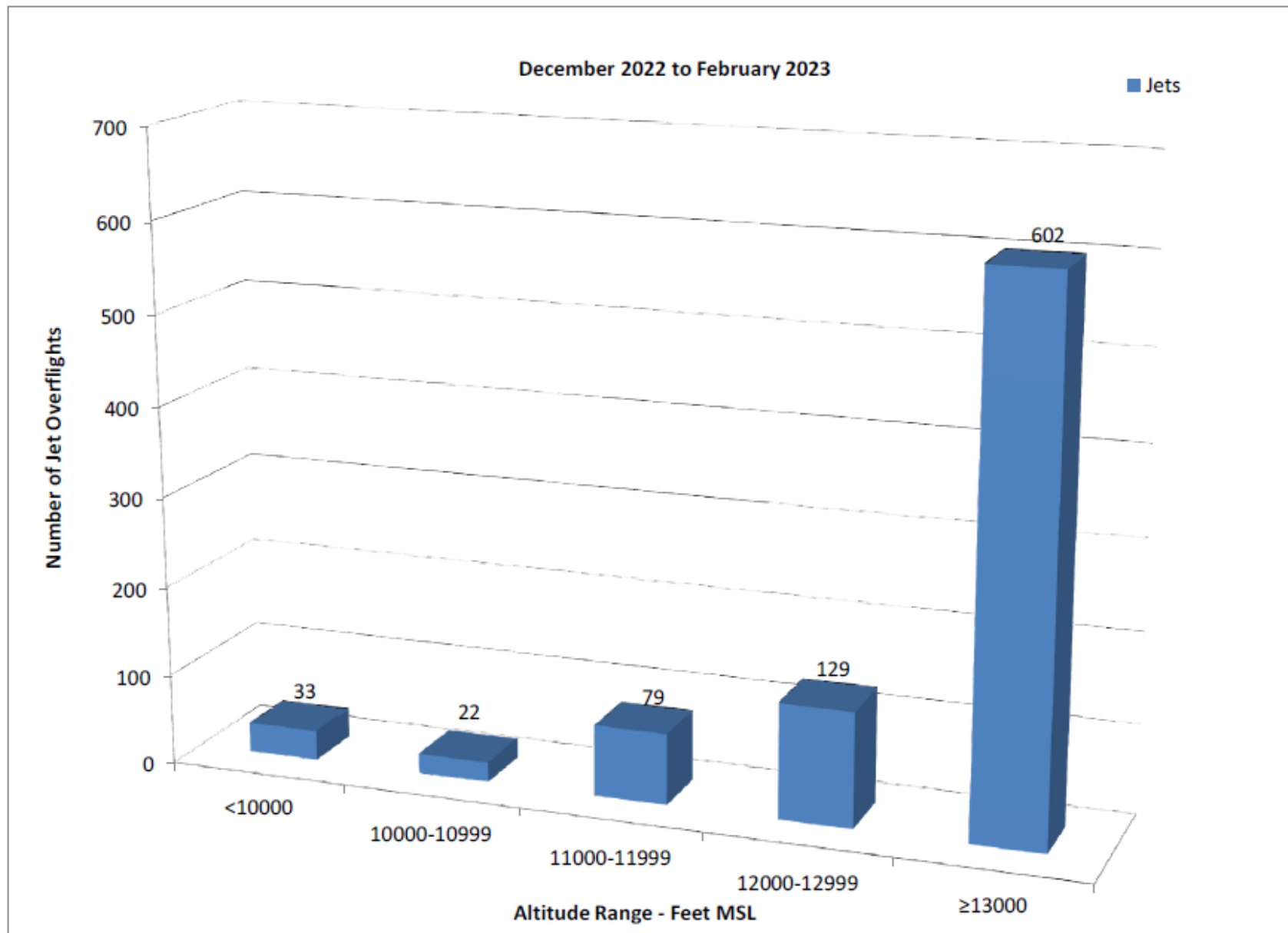
Palos Verdes Peninsula – Jet Overflights

Public Participation:

Public Comments:

The Planning Commission may limit the public input on any item based on the number of people requesting to speak, the length of the agenda, or the business of the Planning Commission.

Conduct at the Planning Commission Meeting:

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force. (2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

Continuation of Meeting:

The Planning Commission will adjourn its meetings on or before 11:00 p.m. and will not consider new business items after 10:15 p.m., unless a majority of the Planning Commission members who are present affirmatively vote either to extend the meeting after 11:00 p.m. or to consider new business after 10:15 p.m. If the meeting ends before all items listed on the agenda are completed, any unfinished business will be continued to the next succeeding day that is not a holiday, at a location to be determined.

Closed Session:

Please be advised that, pursuant to the Ralph M. Brown Act, "a person may not disclose confidential information that has been acquired by being present in a Closed Session . . . to a person not entitled to receive it, unless the legislative body authorizes disclosure of that confidential information." (Gov. Code § 54963(a).) "[C]onfidential information" means a communication made in a Closed Session that is specifically related to the basis for the legislative body of a local agency to meet lawfully in Closed Session . . ." (Gov. Code § 54963(a).) Please be further advised that any "violation of [Government Code § 54963] may be addressed by the use of such remedies as are currently available by law,

including, but not limited to: (1) injunctive relief to prevent the disclosure of confidential information prohibited by this section; (2) disciplinary action against an [public or city official] who has willfully disclosed confidential information in violation of this section; (3) referral of a member of a legislative body who has willfully disclosed confidential information in violation of this section to a grand jury.” (Gov. Code § 54963(c).)
