Public Comments on Draft Environmental Impact Report for the Portuguese Bend Landslide Mitigation Project Due on April 14

On February 9, the City released a Draft Environmental Impact Report (DEIR) for the proposed Portuguese Bend Landslide Remediation Project. The project aims to slow a continuously moving landslide that has significantly damaged homes, utilities, and infrastructure over the past seven decades.


More than 900 residents in the vicinity of the project received a letter, the Notice of Public Hearing and Notice of Availability of Draft Environmental Impact Report for the Portuguese Bend Landslide Remediation

The Council requested SCE return to the June 6 meeting with a short-term and long-term action plan to address outages, as well as concerns with customer service and outage notifications.

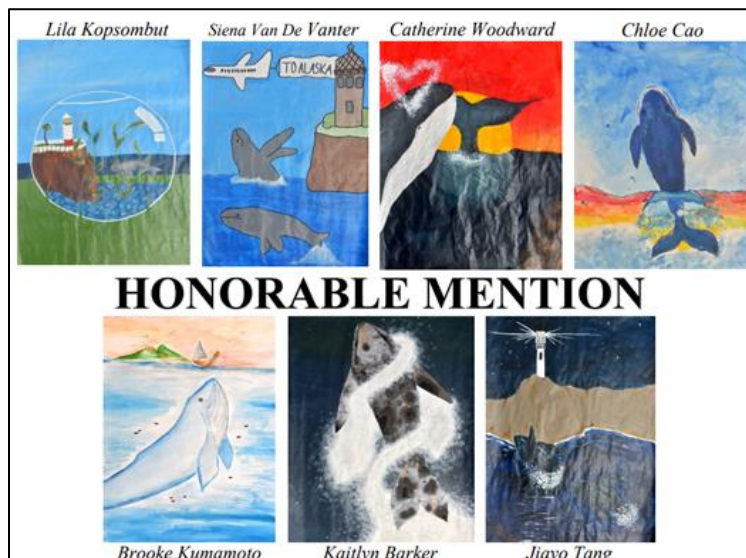
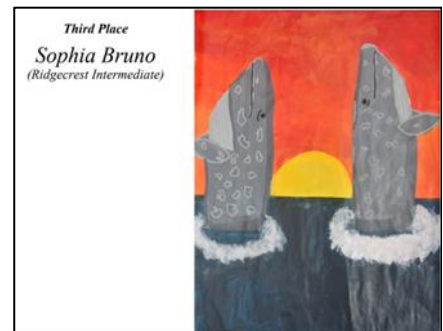
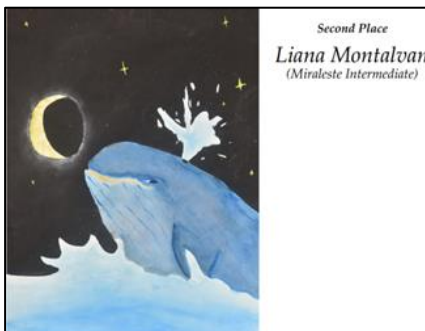
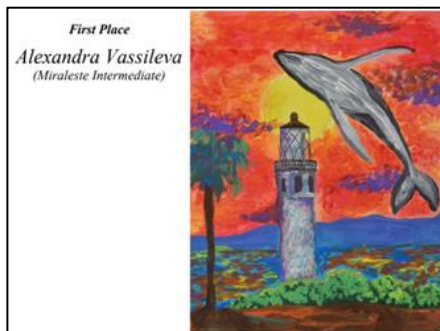
The Council also reviewed projects that make up goals for the next fiscal year in areas ranging from public safety and infrastructure to transparency and quality of life.

Annual Budget Workshop Tomorrow, April 6

On April 6, the City Council will host its annual budget workshop for the General Fund (the City's chief operating fund).

The hybrid in-person/virtual meeting will take place at 6 p.m. in McTaggart Hall at Hesse Park and via Zoom. Please note that the meeting will not be livestreamed or televised, but a recording will be available at rpvca.gov/agendas.

City Staff will present the Fiscal Year 2022-23 year-end estimate of revenues and expenditures, the assumptions used to prepare the FY 2023-24 proposed budget, and fund balance. The preliminary FY 2023-24 budget, all funds, and the 5-year Capital Improvement Plan will be presented at the May 16 City Council meeting. Responses to RFP for Grant Management Services Due on May 3

Today, the City released a request for proposals (RFP) for grant management services, with responses due May 3.

Since 2009, the City has contracted the administration of its grant program, including research, writing, applications, tracking, and other aspects of grant management. In that time, the City was awarded more than \$13.6 million in state, federal and local grants for

a variety of public works, planning, and parks projects supporting the City's goals and objectives. Because RPV is generally considered a residential community with few public transit lines and not comprised of an underserved population, the City faces a degree of challenge competing for grants that tend to favor disadvantaged, transit-oriented communities. The City is interested in pursuing grant funding for a number of anticipated future projects and initiatives, including but not limited to:

- Landslide stabilization
- Surface and subsurface drainage and water quality improvement
- Sanitary sewer improvements
- Highway safety
- Traffic calming
- Street beautification
- Rehabilitation of pavement and sidewalks
- Electric infrastructure
- Utility undergrounding
- Wildfire mitigation
- Fuel modification
- Open space acquisition and maintenance
- Park and civic center development and improvement, including emergency operations center
- Trailhead improvements
- Affordable housing development
- Economic development
- Mental health resources for youths and young adults
- Aging and disabled services
- Homelessness resources

The City is considering a one-year contract and reserves the right to extend the contract for two additional one-year terms, subject to annual review, satisfactory negotiation of terms, and the concurrence of the City Council.

LA County Excessive Heat Workshop

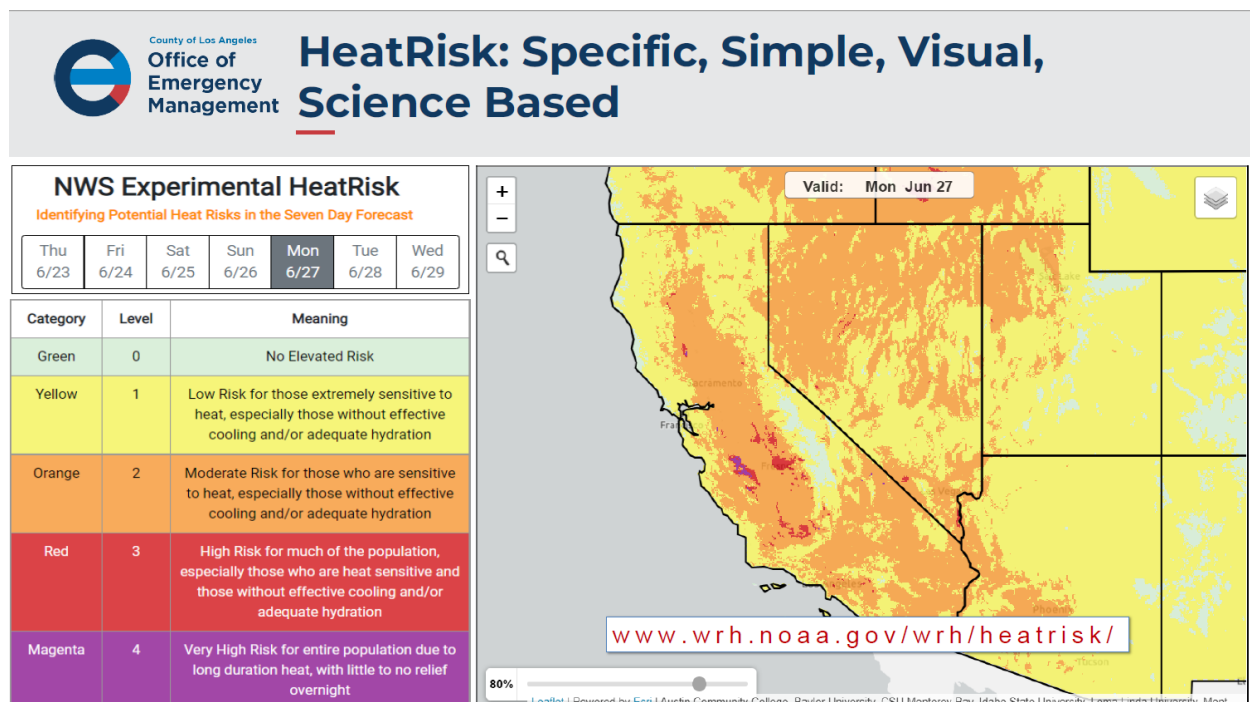
On March 30, staff attended an Extreme Heat Workshop hosted by the Los Angeles County Office of Emergency Management (OEM) at the County Emergency Operations Center (EOC). The purpose of the workshop was to provide an in-depth overview of the new [National Weather Service \(NWS\) HeatRisk tool](#), weather monitoring processes, types of heat products, and the County's Cooling Center Program. During the workshop, attendees discussed strategies to improve preparedness for extreme heat events and coordination between agencies in anticipation of the upcoming heat season.

The NWS HeatRisk tool, identifies unusual and potentially dangerous heat, taking into account various factors such as maximum and minimum temperatures, 30-year climatology, historical records, CDC Heat-Health Thresholds and Social Vulnerability Index, and duration of unusual heat over the entire 24-hour period. The HeatRisk tool

forecast provides a numeric and color scale indicating the level of heat risk concern for any location over the upcoming seven days and identifies the groups most at risk. The County Health Officer issues Heat Advisories, Excessive Heat Watches, and Excessive Heat Warnings based on HeatRisk tool guidance.

The County's Cooling Center Program operates two types of cooling centers: Cooling Centers and Augmented Cooling Centers. Cooling Centers are traditional air-conditioned public facilities that meet minimum criteria and provide relief from the heat, and Augmented Cooling Centers are pre-identified County facilities that serve as Cooling Centers outside of their normal business hours. To be an official Cooling Center, a facility must be ADA compliant, have public access to restrooms and water, and have a minimum capacity of approximately 30 or more people. Augmented Cooling Centers must meet the same minimum criteria as Cooling Centers, and formal activation is required for them to be made available.

While each city retains management and final operational decisions for their local cooling centers, the Extreme Heat Workshop provided valuable insights into effective strategies for preventing heat-related illnesses and coordinating efforts to ensure the safety and well-being of residents during extreme heat events. Attendees further identified lessons learned from previous years and discussed strategies to improve coordination between agencies. The presentation slides for the workshop are included in the attachments.



City Council Sends Letter to State Officials Requesting the City's Involvement in Cal Fire's Updated Fire Hazard Severity Zone Maps

The City Council authorized the Mayor to send a letter to state officials on March 21, requesting the City's inclusion in Cal Fire's Updated Fire Hazard Severity Zone Map for Rancho Palos Verdes (see attachment). Cal Fire has begun a public comment period for the regulatory adoption process to update its existing FHSZ map, which ranks California's State Responsibility Area (SRA) based on the likelihood of wildfires. It is expected that the Local Responsibility Areas (LRA) map for Rancho Palos Verdes will also be updated this spring using the same data and methodology as the SRA map. These maps will have an impact on local land use policies and techniques for managing wildfires, such as fuel reduction projects, defensible space, and ignition-resistant building construction. The FHSZ designations may also affect planning decisions, building code applications, and the availability and price of residential home insurance.

The City Council expressed the City's desire to collaborate with the State Fire Marshall on behalf of Rancho Palos Verdes residents. They have requested staff's participation in updating the FHSZ map for the City to consider the strategies developed by the City over the past few years, such as fuel modification in the Palos Verdes Nature Preserve, the Zonehaven Evacuation Mapping and Tools, and the installation of early wildfire detection cameras, among others. Family Emergency Planning

Some disasters strike without any warning, and family members may not all be in the same place. How will you get in touch with each other? Where will you meet? How will you get out of your house in case of a fire? What if your neighborhood is being evacuated? It's important to make a plan now so that you will know what to do, how to find each other, and how to communicate in an emergency.

Here are a few easy steps to start your family's emergency planning:

- **MAKE A PLAN:** A good place to begin emergency preparedness is by writing a family emergency plan. Your family may not be together if a disaster strikes, so it is important to talk to your friends and family about how you will communicate before, during, and after a disaster. Your plan should include every member of your household, including pets. Be sure to establish a family meeting place that's familiar and easy to find.
- **MAKE A KIT** A disaster supply kit is any pre-assembled group of items that will improve the health and safety of your family during a disaster. Gather supplies that will last for several days after a disaster for everyone living in your home.

At a minimum, your emergency supplies should include these 10 essential items:

- Water for 3-10 days (1 gallon per person per day)
 - Food for 3-10 days (including pet food)
 - First Aid Kit and Instructions
 - Flashlights (and extra batteries)
 - Radio (and extra batteries)
 - Medications (prescription and non-prescription)
 - Cash and important documents (small bills and coins, birth certificates, tax returns, deeds, titles, insurance papers, medical cards)
 - Clothing and sturdy shoes
 - Tools (wrench, duct tape, fire extinguisher, sturdy gloves, whistle)
 - Sanitation and hygiene supplies
- **BE INFORMED:** It is important to know what disasters and hazards could affect your area, how to get emergency alerts, and where you would go if you and your family need to evacuate. Make sure your family has a plan and practices it often.
 - Learn about natural hazards that may affect the City by reading our recently adopted and FEMA - approved [Local Hazard Mitigation Plan](#).
 - **Register for emergency notifications from Alert SouthBay:** Alert Southbay is the City's primary vehicle for emergency communications. Users can Sign up for Alert SouthBay emergency alerts by texting "alerts" to 888-777

Last Chance: Apply Today for a Security Camera Grant!

The City is pleased to announce that the Public Safety Reimbursement Program is once again accepting applications! The program provides a partial reimbursement to individuals and neighborhoods for a public safety purchase such as a security camera. Individuals are eligible to apply for a 50% reimbursement up to \$100, awarded based on a random draw, for external security cameras such as doorbell cameras. Neighborhoods are eligible to apply for a 50% reimbursement up to \$2,000, awarded based on a rubric, for neighborhood entrance/exit security cameras.

In the Volunteers on Patrol (VOP) program, trained volunteers work in volunteer vehicles in a volunteer uniform, assisting in the field as additional eyes and ears in the community and reporting suspicious activities to the Sheriff's Station.

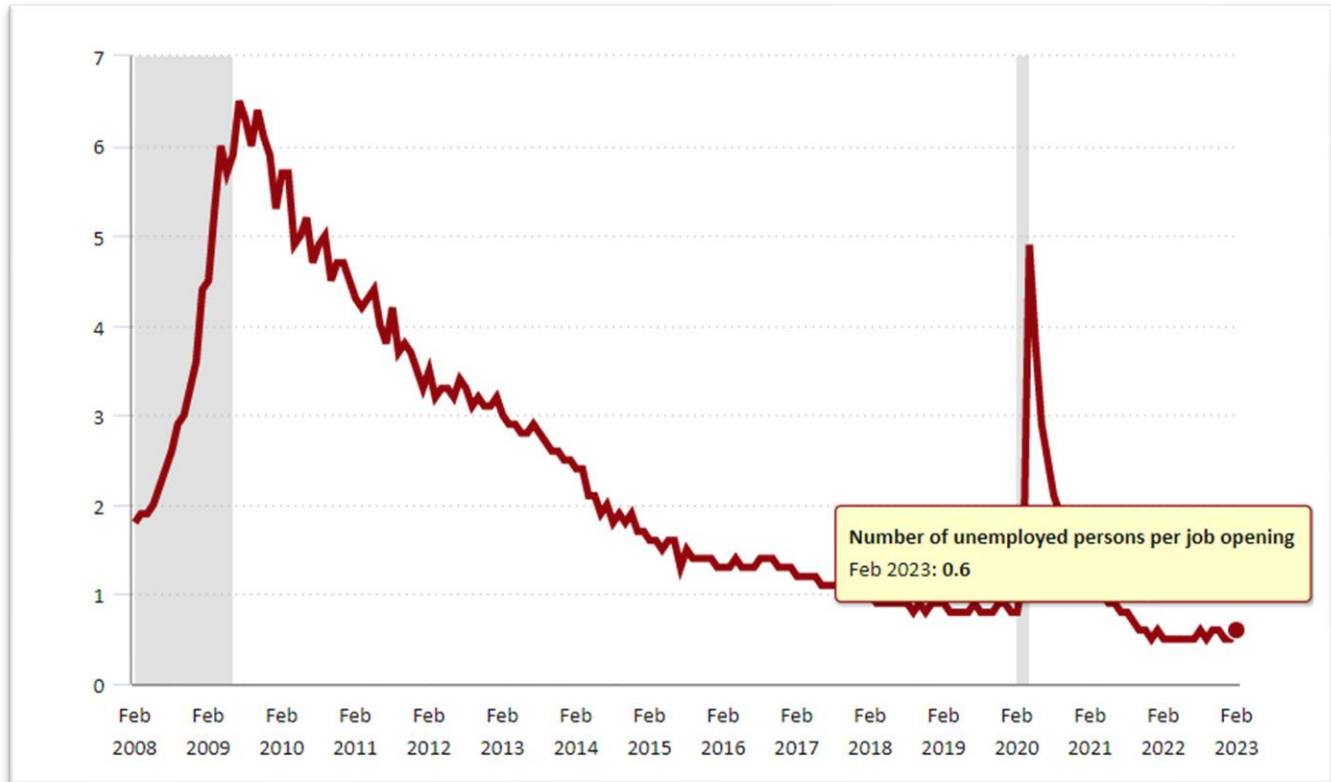

Job Openings and Labor Turnover Survey (JOLTS) – February 2023

The number of job openings decreased to 9.9 million at the end of February, the U.S. Bureau of Labor Statistics reported yesterday. February job openings fell below 10 million for the first time in nearly two years, down from January's total of 10.6 million

and well below the record 12 million reached in March 2022. Overall, the latest data conveys a solid but slightly cooler labor market as of February.

Chart 1. Number of unemployed persons per job opening, seasonally adjusted



In summary, the number of hires and total separations changed slightly to 6.2 million and 5.8 million, respectively. The increase in hires was mainly the result of an additional 8,000 hires in federal government jobs. Within separations, quits totaled 4 million, while layoffs and discharges decreased to 1.5 million. As illustrated in the chart above, the ratio of unemployed persons to job openings ticked up from 0.5 in January to 0.6 in the month ending February.

Ladera Linda Community Park Project Update

Rain and associated site conditions continued to hamper much of the site work, but crews were able to place concrete for the accessible ramp wall footing and curbs for the building wing walls. Crews were also able to continue work on the building exterior overhang, exterior sheathing, flashing, roofing, and roughing-in of cameras. On the interior, they continued ceiling framing and roughing-in of light fixtures.

This week, crews are expected to continue work on the building exterior framing, sheathing, and drywall, accessible ramp, stepped terrace, equipment enclosure, and parking lot drains.

As site conditions continue to be impacted by recent rains, site access through the lower gate is expected to be extended. Adjacent neighbors have been notified.

Goats are back to perform the important job of helping reduce fire loads and protecting homes. Although we understand many people enjoy seeing the goats, please refrain from going to see them out of respect for residents living near where the goats work.

A temporary electrified fence is used to contain the goats while they are working, and attempting to approach them puts you and the goats, at risk. Please avoid attempting to take selfies/pictures or touch the goats, especially if you have dogs or pets with you. This will prevent stress and injury to you and the goats.

In addition to the goats, you may see Stay Green crews performing brush clearance in various areas of the City as part of the City's 2023 fuel modification program.

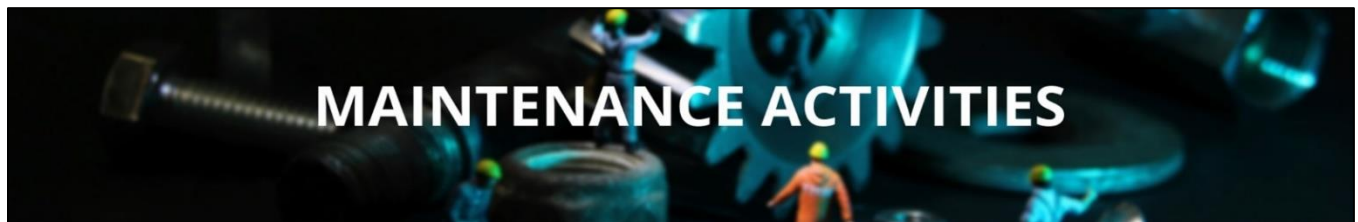

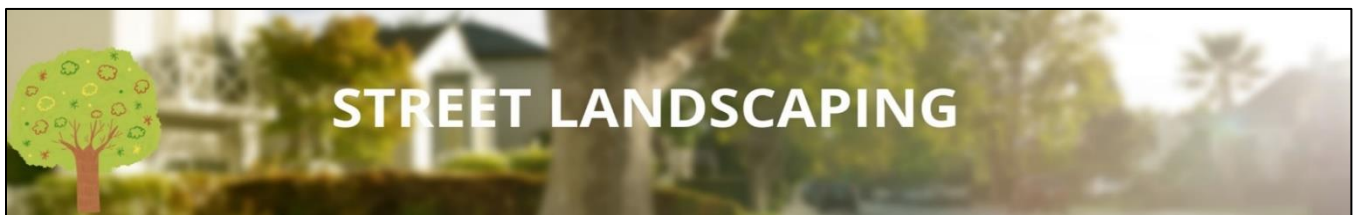


Maintenance Activities

In addition to regularly scheduled maintenance and repairs, Public Works performed the following:

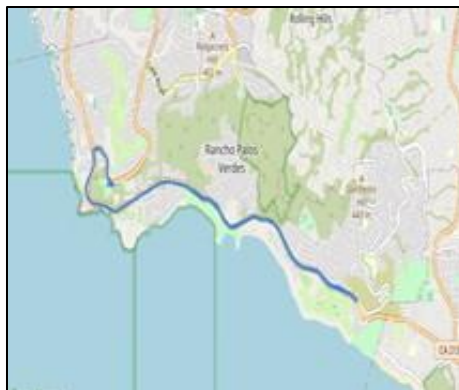


- Weekly landscape maintenance at all City parks.

Community of Abalone Cove Parking Program Revision

On April 18, the City Council will consider a revision to a City Council-approved Coastal Development Permit (Case No. PLCP2022-0001) for an after-the-fact parking program for the residents within the Community of Abalone Cove, which consists of Seacove Drive, Packet Road, Barkentine Road, and Clipper Road, as outlined in the aerial map. The City Council approved the parking program on November 15, 2022 and current program provisions are outlined below:



- Appealable Area: Permit parking from 10:00 a.m. - 3:00 p.m. between May 1 to October 31 and from sunset to sunrise, all year round.
- Non-Appealable Area: Permit parking 24 hours per day, all year round.

Under the proposed revision, parking program provisions for the Appealable Area would apply to both sides of inland streets (Packet Road and Seacove Drive), as highlighted in red in the aerial map above. 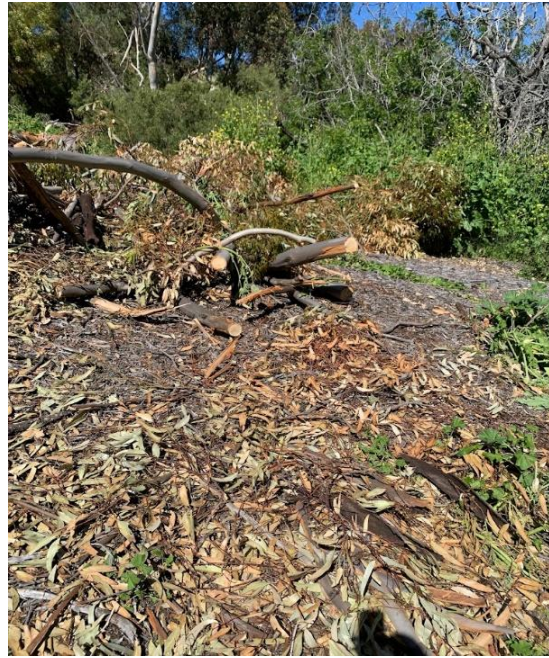

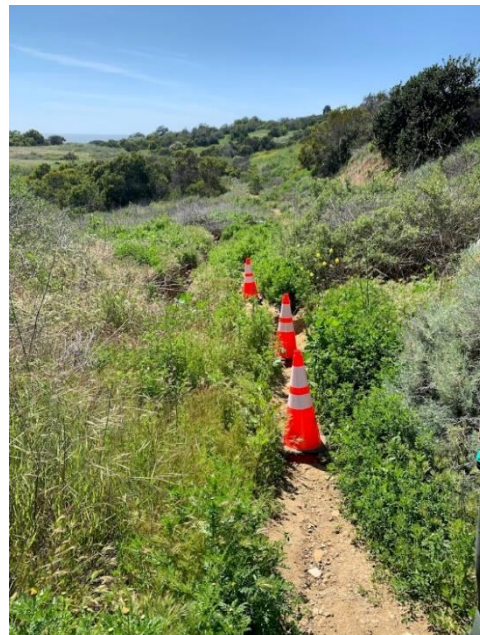

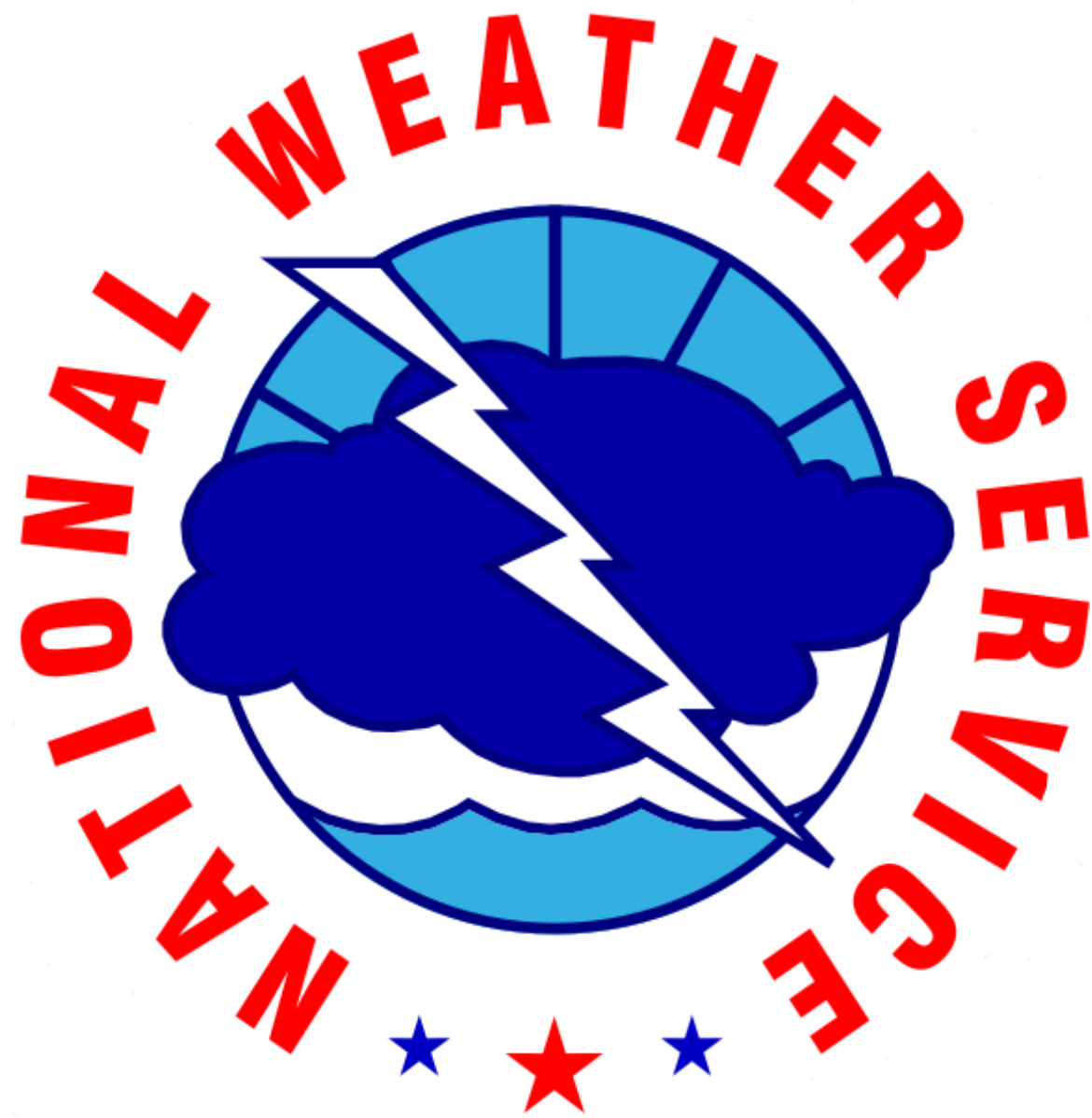

HeatRisk: What is it?

- Introduced in 2013 as a science-based framework for identifying unusual and potentially dangerous heat (still considered experimental)
- Considers:
 - Maximum and Minimum temperatures
 - 30-year Climatology (i.e., how unusually warm is it for specific location and time of year?)
 - Historical records (both highs and hi-minimums)
 - CDC Heat-Health Thresholds and Social Vulnerability Index (new in June 2022)
 - Duration of the unusual heat (2 days or longer)
- Describes potential heat risk over entire 24 hour period vs snapshot during highest temp of the day

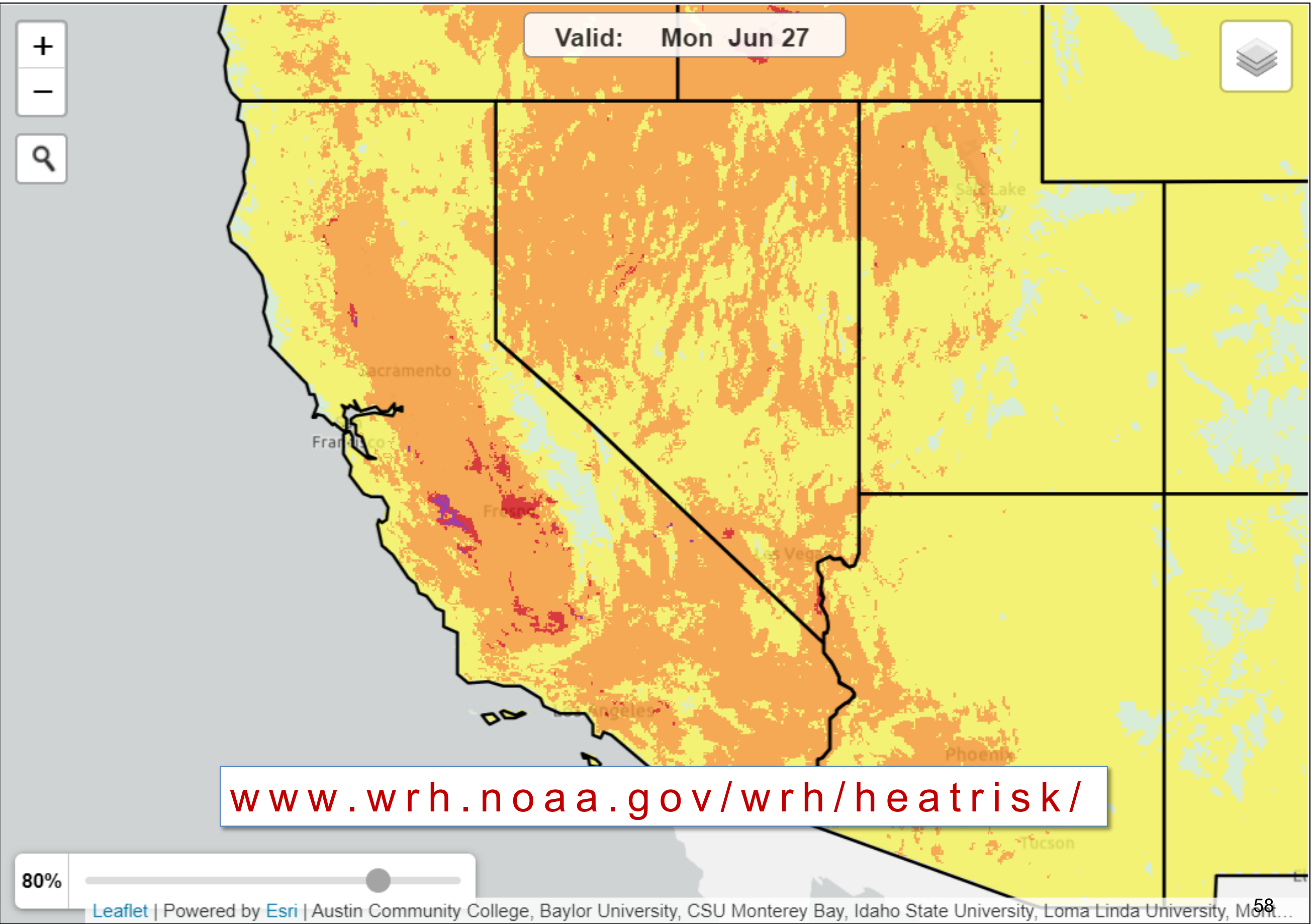

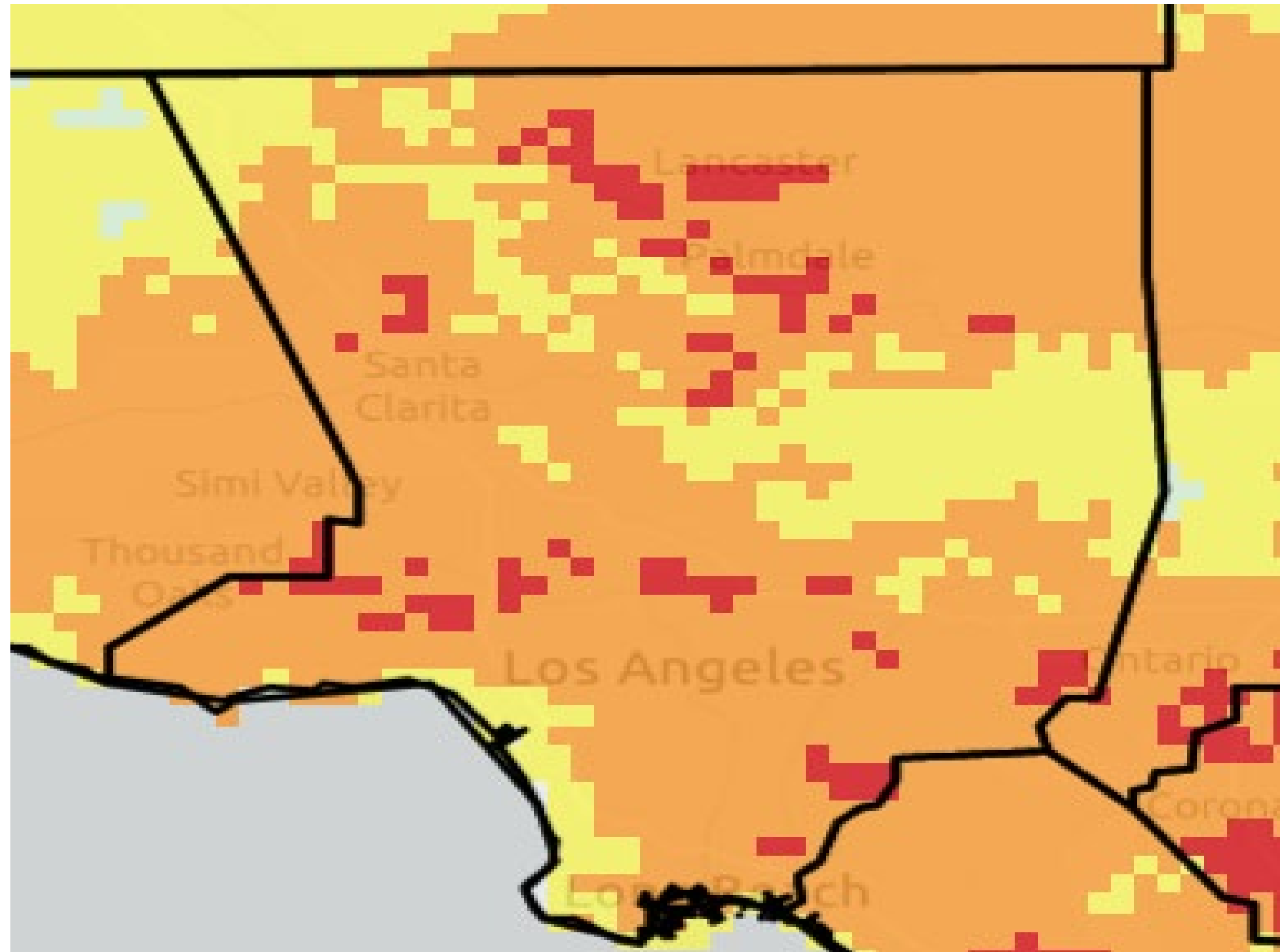

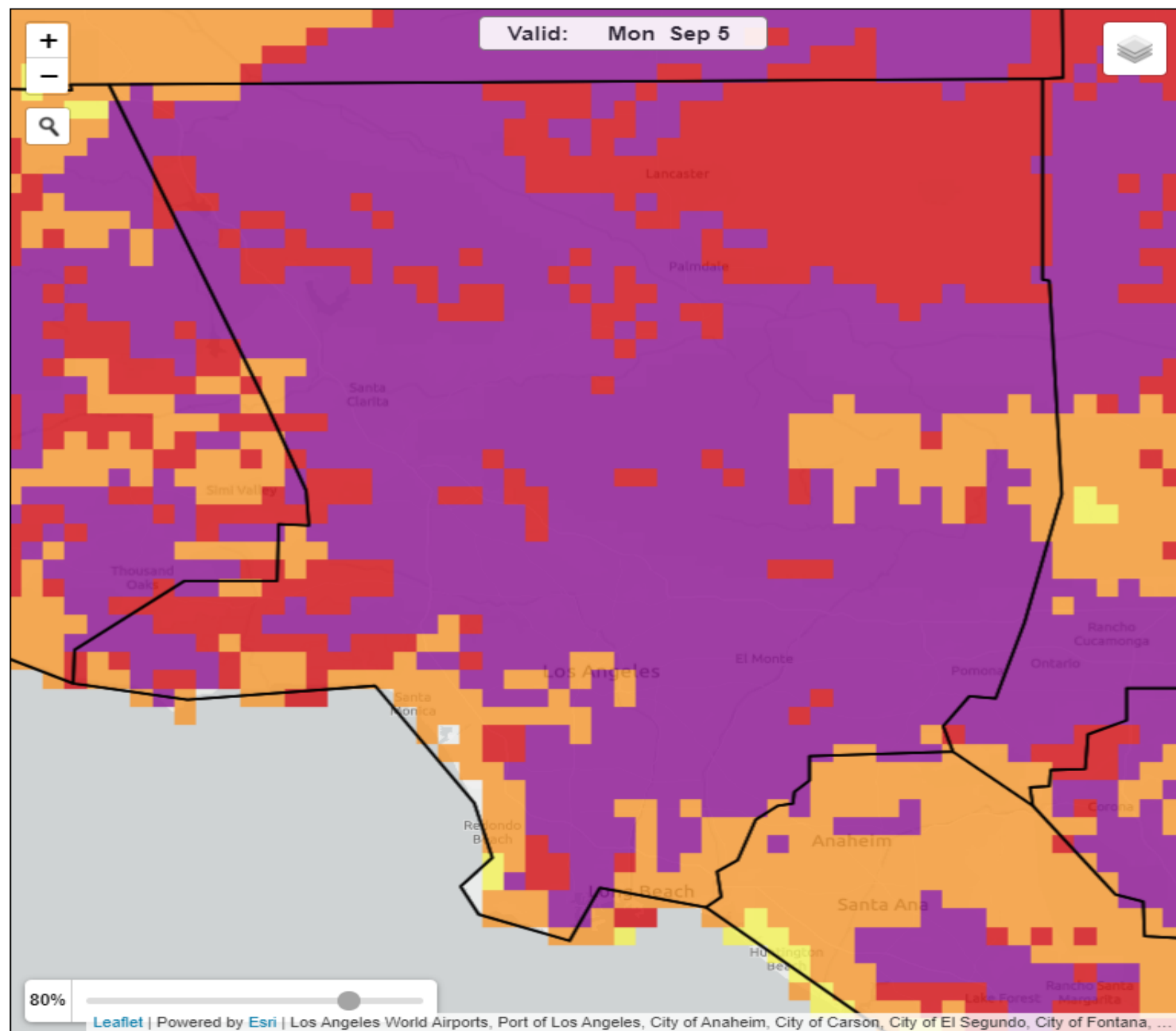

HeatRisk Map: Labor Day 2022

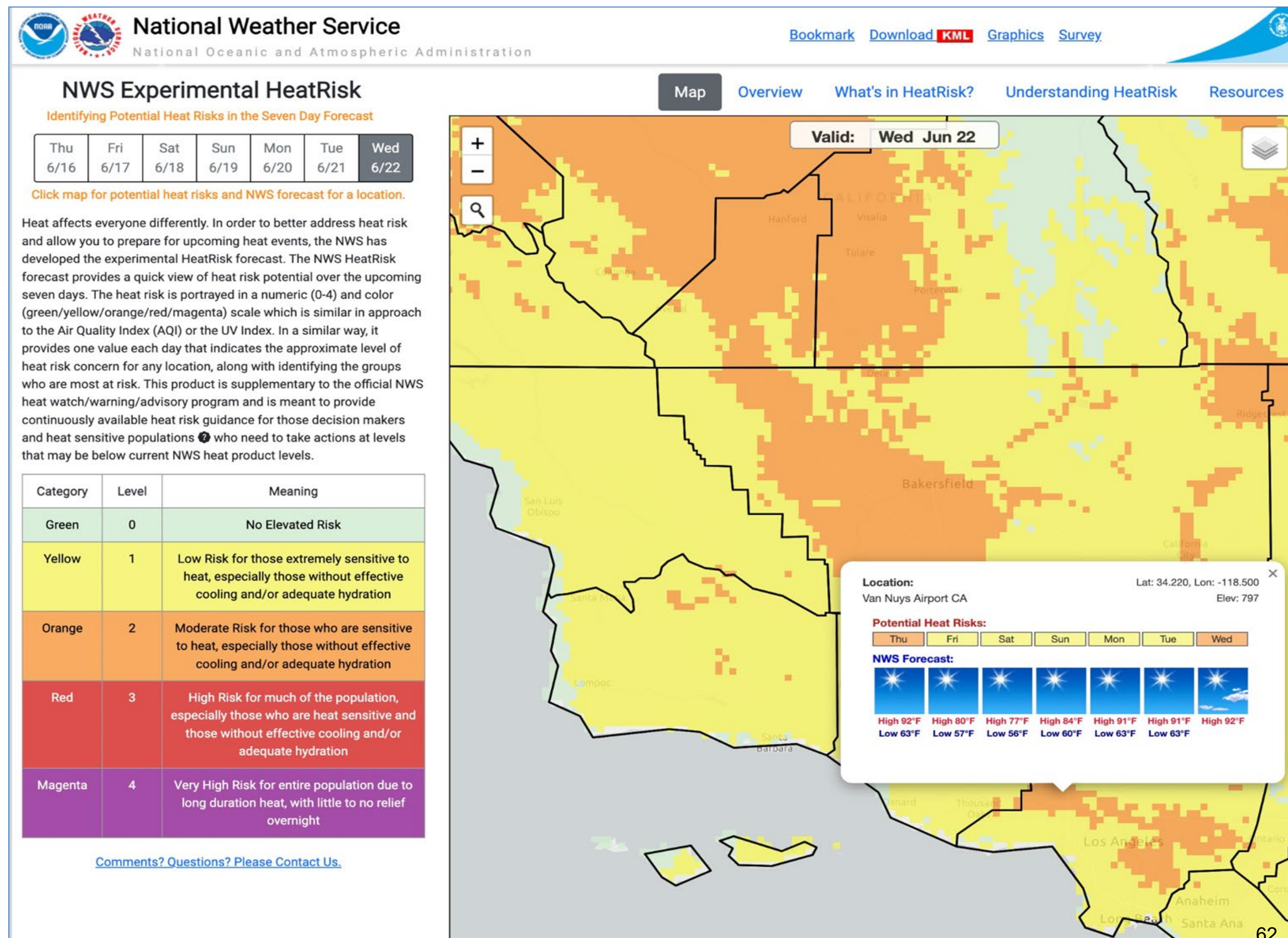

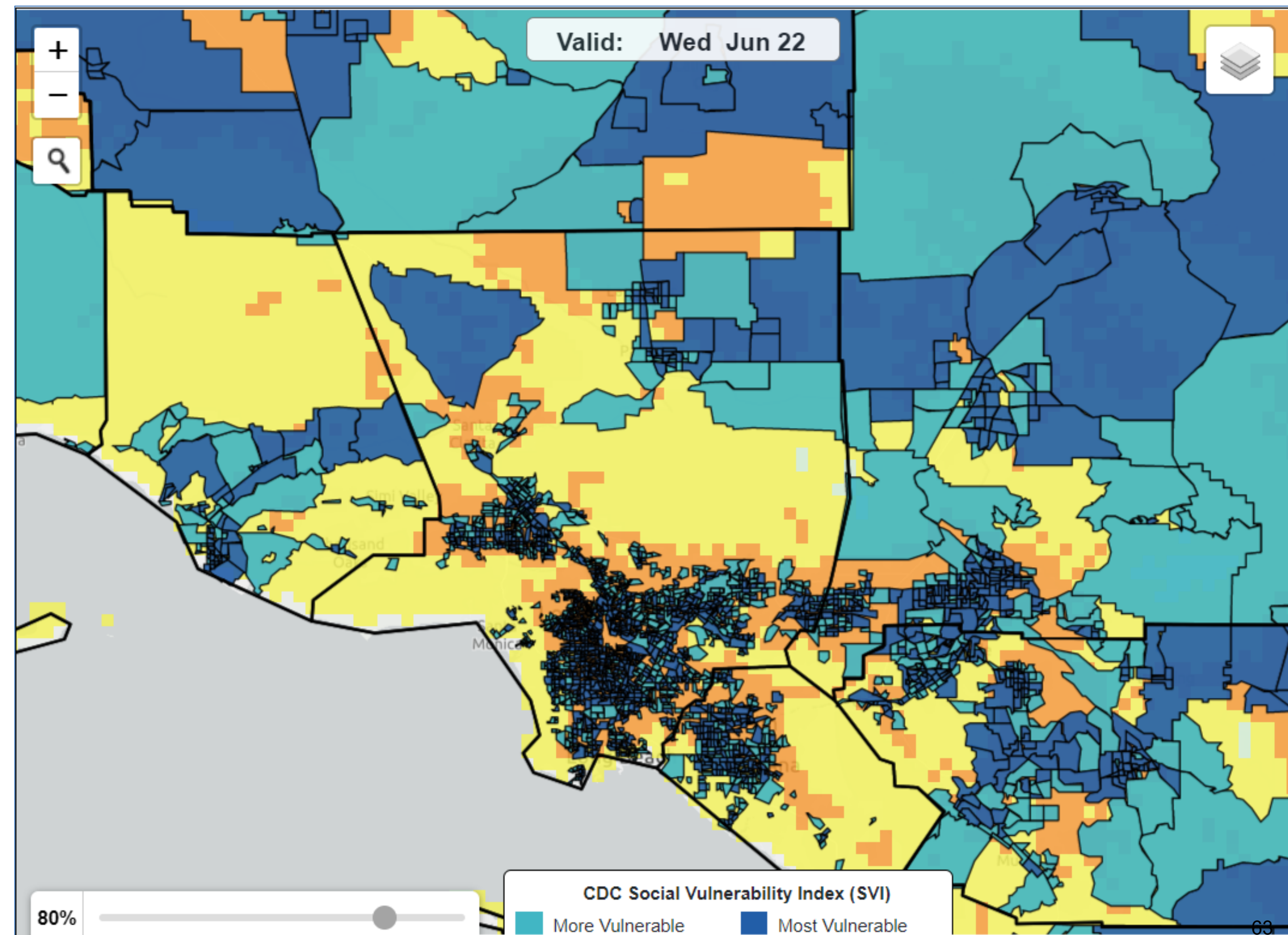

- **Social vulnerability** refers to the potential negative effects on communities caused by external stresses on human health. Such stresses include natural or human-caused disasters, or disease outbreaks.
- **The CDC/ATSDR Social Vulnerability Index (CDC/ATSDR SVI)** uses 15 U.S. census variables to help local officials identify communities that may need support before, during, or after disasters.

- NWS HeatRisk considers 24-hr max/min temperatures, duration, how unusually warm it is, time of year, CDC heat-health and social vulnerability data

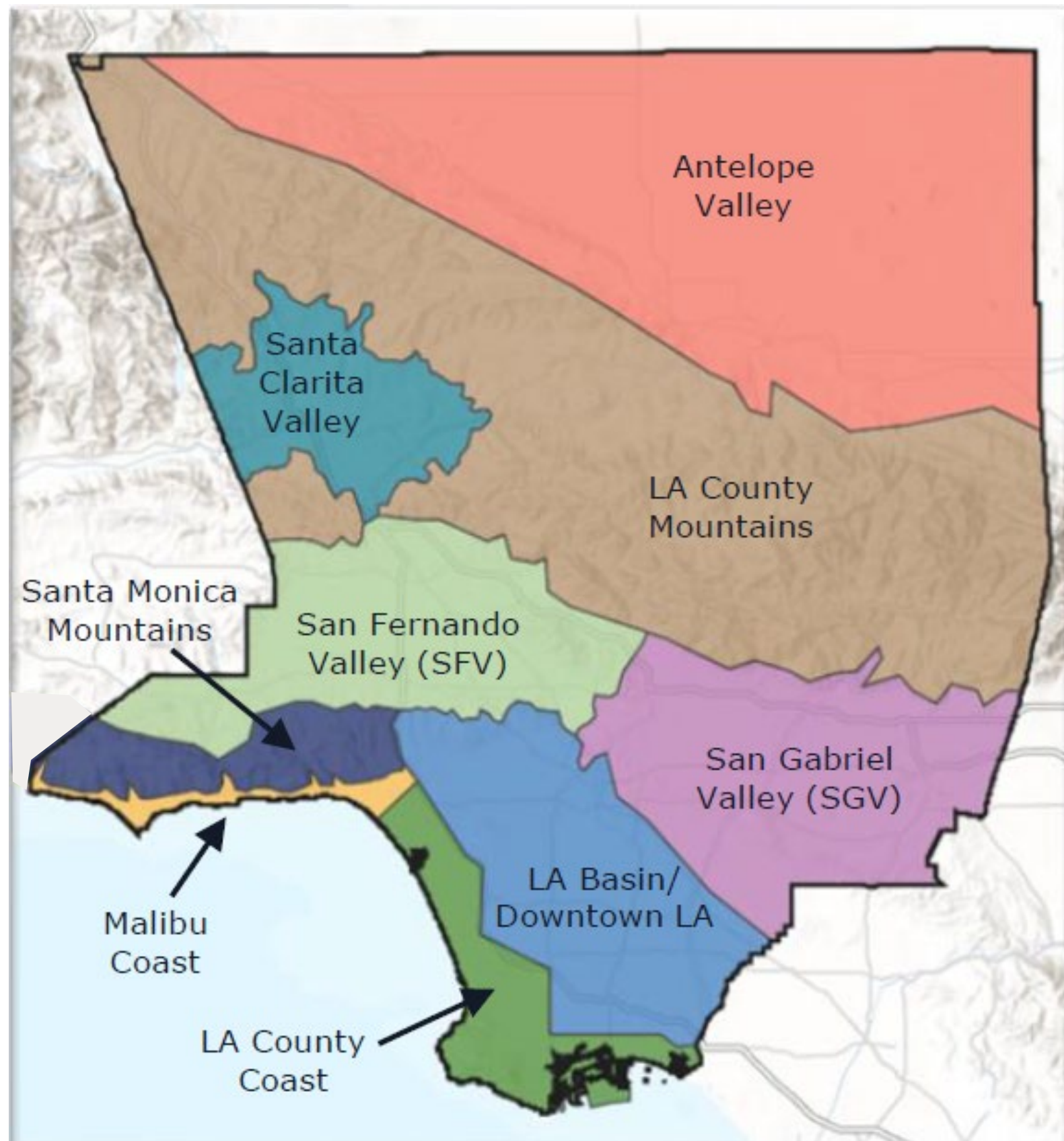

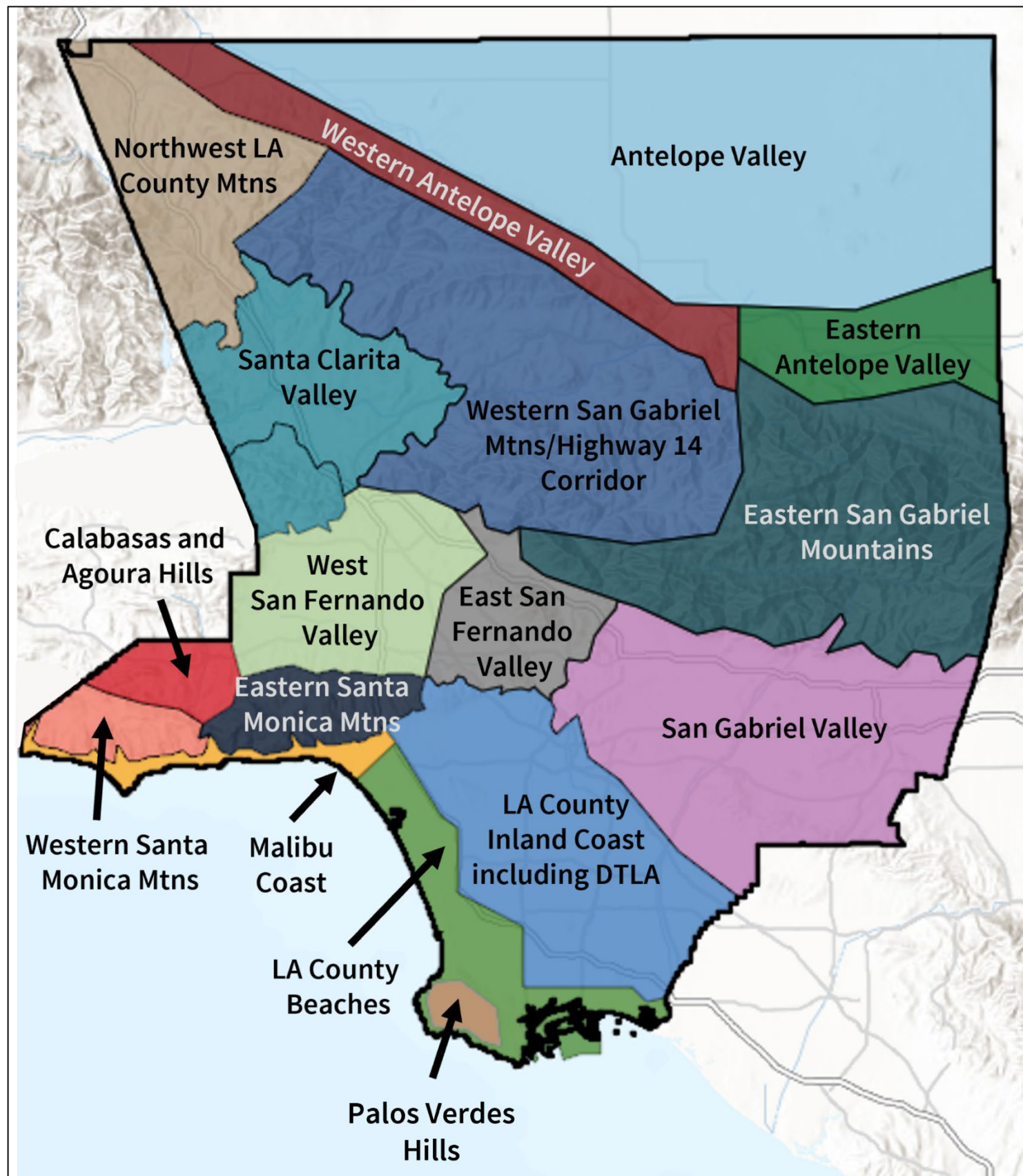

- **Cool Spots (unofficial):** Not a formally advertised concept, but a reminder that publicly accessible, cool locations can be assessed regardless of heat product issuance

Types of Cooling Centers & Activation Criteria

Cooling Center: Specific air-conditioned public facilities that meet minimum criteria and provide relief from the heat.

- Formally advertised as Cooling Centers when *Heat Advisories* or *Excessive Heat Warnings* are in effect for 2+ days. **Operate under normal business hours.**
- Minimum site criteria to be an official Cooling Center:
 - Be American Disabilities Act (ADA) compliant
 - Have public access to restrooms
 - Have public access to water (water fountains, bottled water, etc.)
 - Have a minimum capacity of approximately 30 or more people

Types of Cooling Centers & Activation Criteria

Augmented Cooling Center: Pre-identified County facilities that will serve as Cooling Centers outside of their normal business hours

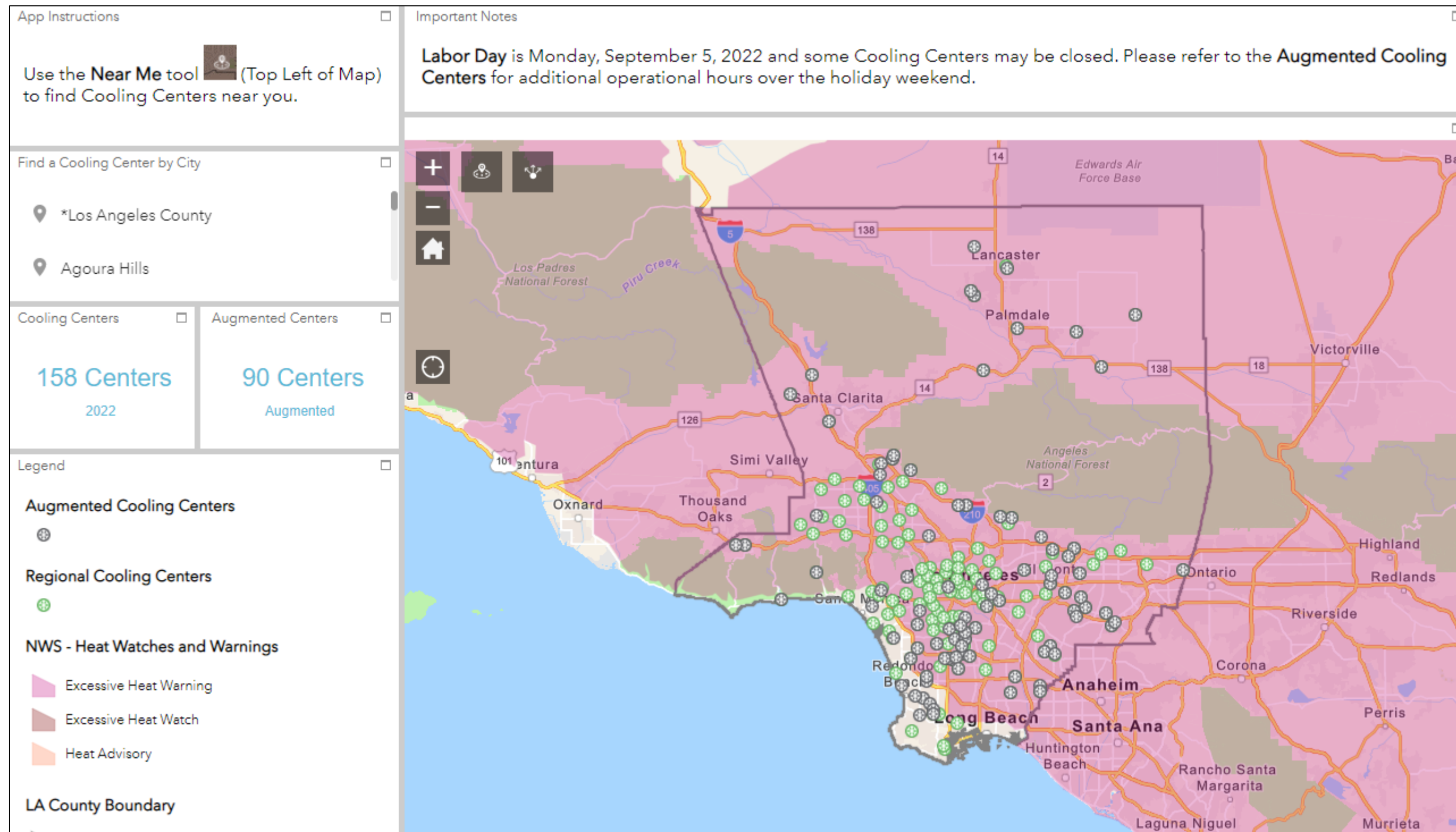
- Formal activation is required for augmented centers to be made available. Augmented Cooling Centers are activated by zone.
- **Activation Criteria:** Excessive Heat Warning in effect for 2+ days and impacting a day Cooling Centers are not otherwise available (e.g., Sunday, County Holiday)
- Augmented Cooling Centers will remain free of charge to the public
- Augmented Cooling Centers must meet same minimum criteria as Cooling Centers

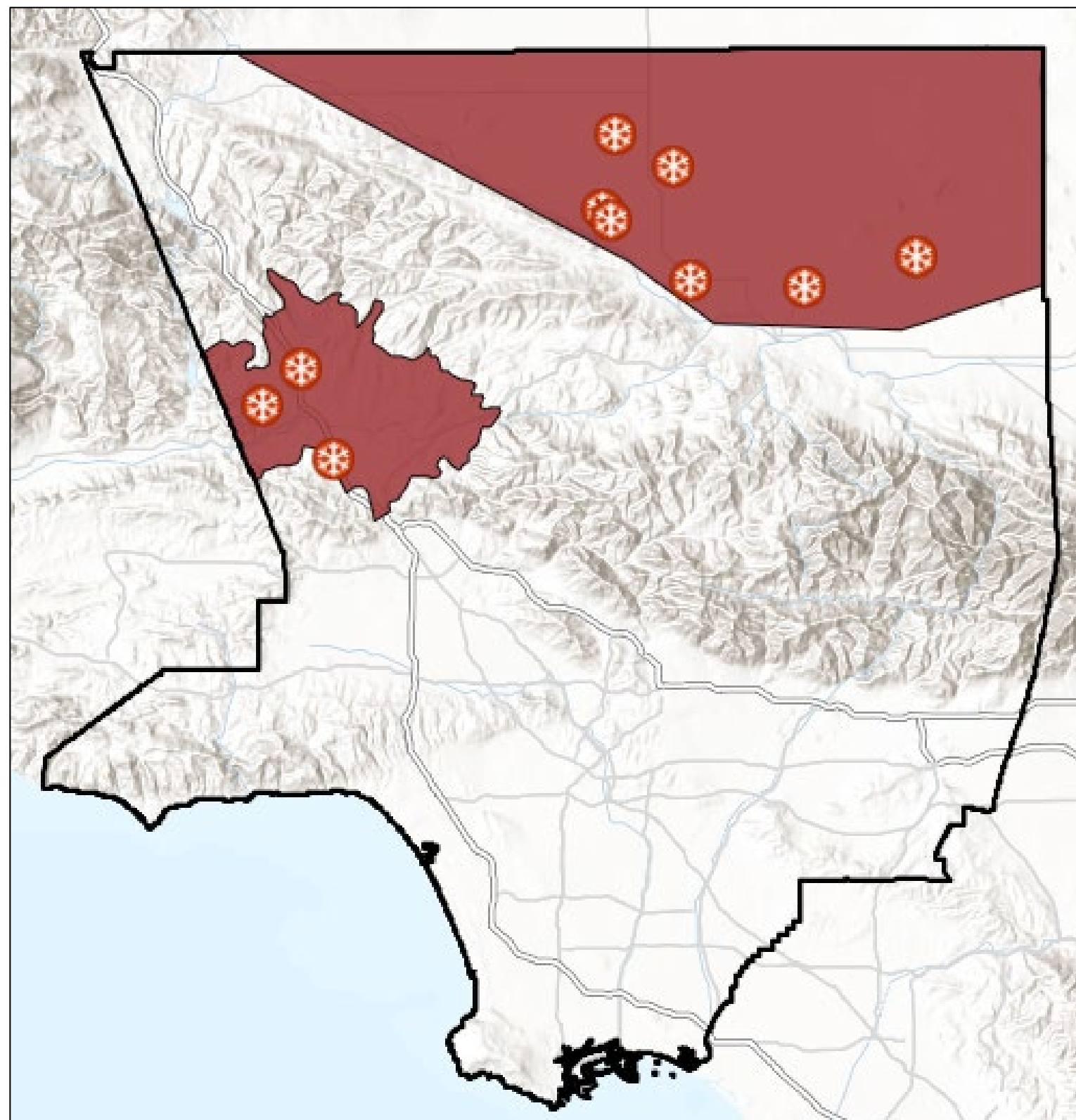

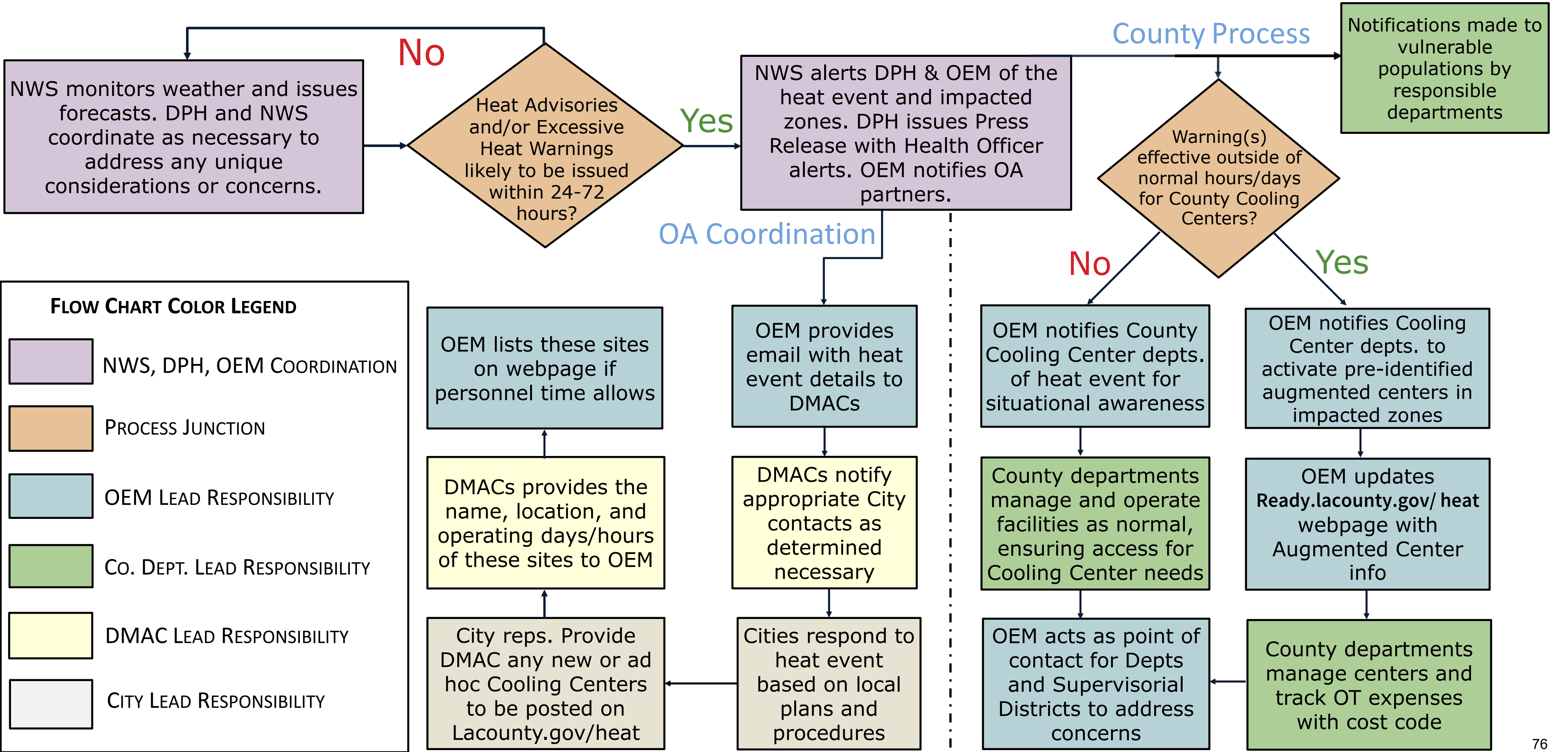

SUBJECT: Fire Hazard Severity Zones

Dear Deputy Director Berlant:

The City of Rancho Palos Verdes thanks you for the opportunity to provide comments on the draft Fire Hazard Severity Zones (FHSZ) map for the State Responsibility Areas (SRA) being prepared by the Department of Forestry and Fire Protection (Cal Fire) and the Office of the State Fire Marshal.

While the City agrees that high-level wildfire hazard mapping is an important tool for all Californians, we would like to seek clarification regarding the provisions of Assembly Bill No. 3074, which mandates the creation of a new ember-resistant zone (Zone 0) within 0 to 5 feet of a structure. This is a matter of particular importance to Rancho Palos Verdes, as the majority of the City falls within a Very High Fire Hazard Severity Zone (VHFHSZ) rating. However, the approval of AB 3074 represents an unfunded state mandate that would impose a significant financial burden on our residents, especially the elderly, who make up over a quarter of the City's population and many are on a fixed income.

Depending on the final interpretation, the potential requirement to remove all vegetation in and around homes would necessitate the removal of long-standing trees and vegetation, at a high cost to residents, and result in the destruction of habitat for several species of birds, including hawks, eagles, and owls who call these trees home. A one-size-fits-all approach to wildfire mitigation is ineffective and untenable.

We also request that Cal Fire collaborate with the Los Angeles County Fire Department and City officials to collect accurate data on the risk level of each home using standardized criteria and grant the authority to provide more relevant hazard rankings tailored to each specific home, enabling the local fire department to remove hazard rankings based on their risk assessment.

Moreover, we are interested in understanding the reasoning behind designating one side of Western Avenue as a VHFHSZ, while the other side in the City of Los Angeles is not classified as such. We believe that understanding the reasoning behind this designation would help us make informed decisions in mitigating wildfire risks in our City.

As identified by a 2019 series of news stories, [Rancho Palos Verdes is the most populated California city with 90% or more of residents living in a VHFHSZ](#), making it among communities that "could be the next Paradise." To protect our community from wildfires, we have implemented year-round brush clearance, communicated with local insurance underwriters to understand how we can avoid premium hikes and decreased insurance availability, and supported state legislation, grants, and incentives for residents and neighborhoods interested in fire-hardening their homes. We have also worked with local utility companies to reduce the risk of utility-started fires and pursued the development of a Peninsula-wide wildfire camera detection system, which would provide timely and accurate alerts of fire ignitions to the Peninsula cities and public safety agencies.

This spring, it is anticipated that the Local Responsibility Areas (LRA) map will be updated utilizing the same data and methodology as the SRA map. Both maps will influence local land use policies and techniques for managing wildfires without taking mitigation measures such as fuel reduction projects, defensible space, and ignition-resistant building construction into account. FHSZ designations have an effect on, among other things, planning decisions, building code applications, and the availability and price of residential home insurance.

After a decade of internal agency work updating FHSZ designations, we appreciate Cal Fire's determination to release an updated wildfire map. But we caution that not including the City's long history of relevant fire mitigation efforts will frustrate meaningful input and, more importantly, may result in inaccurate map designations. While we appreciate Cal Fire's intention to mitigate catastrophic wildfires, the City believes local jurisdictions can offer important insight regarding local fire safety and mitigation efforts in their communities, as opposed to a statewide strategy that applies equally to all jurisdictions.

For these reasons, the City of Rancho Palos Verdes strongly advocates for Cal Fire and the Office of the State Fire Marshal to adopt a collaborative strategy with local cities, such as Rancho Palos Verdes, when updating the LRA FHSZ Maps to ensure that decades of significant mitigation efforts are included.

Conduct at the Planning Commission Meeting:

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force. (2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a

meeting and may be discussed at any time.

Continuation of Meeting:

The Planning Commission will adjourn its meetings on or before 11:00 p.m. and will not consider new business items after 10:15 p.m., unless a majority of the Planning Commission members who are present affirmatively vote either to extend the meeting after 11:00 p.m. or to consider new business after 10:15 p.m. If the meeting ends before all items listed on the agenda are completed, any unfinished business will be continued to the next succeeding day that is not a holiday, at a location to be determined.

Code § 54963(c).)
