### Goat Vegetation Management Project – FEMA HMGP Site Visit

FEMA's [Hazard Mitigation Grant Program \(HMGP\)](#) provides funding to state, local, tribal, and territorial governments to mitigate future disaster losses in their communities. Administered by the California Governor's Office of Emergency Services (Cal OES), the program sets aside a portion of funds when a Federal Disaster Declaration is issued in California to provide funding for hazard mitigation projects through the HMGP.

In June of 2021, the City submitted a sub application to secure HMGP funding to continue using grazing goats to consume hazardous vegetation and reduce the amount or density of fuel available to burn in a wildfire. The city has been utilizing goat grazing as a method of fuel modification since 2008, which has proven to be a more efficient and cost-effective approach compared to traditional methods, especially in areas of

steep and difficult terrain where human-operated machinery is not practical. Goats are effective in creating and maintaining fuel breaks in grass, shrub, and timber fuel types, which allows for better defensible space for structures and enables firefighters to suppress wildland fires using ground and air resources more effectively.

Recently, the city was notified that the Goat Vegetation Management Project submitted under the HMGP would require biological surveys of the goat grazing areas as part of FEMA'S Environmental and Historic Preservation (EHP) review process. This week, City staff coordinated a site visit for FEMA to the goat grazing areas in the City's Fuel Mod zones. Despite the challenging terrain, a team of City staff members ensured that FEMA had safe access to over 30 goat grazing areas, all of which were surveyed by a FEMA biologist.

The biological surveys required by FEMA are crucial to ensure that the City's goat grazing project meets the necessary EHP review standards, which is critical in mitigating potential environmental and historical preservation concerns that may arise from the project. The city remains optimistic that its innovative approach to fuel modification will ultimately receive the necessary funding to continue reducing the risk of wildfires in their community.

### **City Council Sends Letter to State Officials Requesting the City's Involvement in Cal Fire's Updated Fire Hazard Severity Zone Maps**

The City Council authorized the Mayor to send a letter to state officials on March 21, requesting the City's inclusion in Cal Fire's Updated Fire Hazard Severity Zone Map for Rancho Palos Verdes (see attachment). Cal Fire has begun a public comment period for the regulatory adoption process to update its existing FHSZ map, which ranks California's State Responsibility Area (SRA) based on the likelihood of wildfires. The Local Responsibility Areas (LRA) map for Rancho Palos Verdes is expected to be updated this spring using the same data and methodology as the SRA map. These maps will impact local land use policies and techniques for managing wildfires, such as fuel reduction projects, defensible space, and ignition-resistant building construction. The FHSZ designations may also affect planning decisions, building code applications, and the availability and price of residential home insurance.

The City Council expressed the City's desire to collaborate with the State Fire Marshall on behalf of Rancho Palos Verdes residents. They have requested staff's participation in updating the FHSZ map for the City to consider the strategies developed by the City over the past few years, such as fuel modification in the Palos Verdes Nature Preserve, the

Being prepared includes having food, water, and other supplies on hand to last for several days. **MAKE A PLAN:**

Making a Family Emergency Plan is a good place to start when preparing for an emergency. Because your family may not be together when a disaster strikes, it is critical to plan communication strategies with your friends and family before, during, and after a disaster. Your plan should include every member of your household, including pets, and should take into account the specific needs of your household. Fill out a [family emergency plan](#) or use it as a guide to create your own plan today.

Create a plan by discussing the following questions with your family, friends, or household to kick-start your emergency preparedness:

- What is my shelter plan?
- What is my evacuation route?
- What is my family/household communication plan?
- Do I need to update my emergency preparedness Disaster Supply Kit?

## EMERGENCY PREPAREDNESS TIPS

### Earthquake Safety - Learn What to do During and After an Earthquake and How to Prepare for One

#### What to do: During an Earthquake

An earthquake is a sudden, rapid shaking of the earth caused by the shifting of underground rock. Deaths and injuries occur when people fall trying to walk or run during shaking or when they are hit by falling debris. Smaller earthquakes, called aftershocks, always follow the mainshock. Earthquakes can cause tsunamis, landslides, fires, and damage to utilities. Earthquakes can happen anywhere, and there is no way to predict them. But we can take action to prepare. Prepare now to protect yourself, your loved ones, and your home.



#### When Shaking Starts, DROP, COVER, and HOLD ON to Protect Yourself.

- If you are in bed, STAY there and COVER your head and neck with a pillow. Lie face down.
- If you are outdoors, drop, then crawl towards an open space if you can. Stay away from buildings, power lines, and trees
- If you are driving, stop and stay in your vehicle. Avoid stopping near buildings, trees, overpasses, and utility wires. Proceed cautiously once the earthquake has stopped. Avoid bridges or ramps.

- If you are in a wheelchair or use a walker, lock your wheels and remain seated until the shaking stops.
- Protect your head and neck with your arms, a pillow, a book, or whatever is available. If you are unable to drop, brace yourself and protect your head and neck.

### What to do: After an Earthquake

#### Stay Safe

- Wait a minute before getting up. Check for any immediate dangers around you and protect yourself.
- Anticipate broken glass and debris on the ground, so put on sturdy shoes as soon as possible.
- If it is safe, exit the building. Go outside to a clear area. Check to make sure nothing will fall on you, such as bricks from a building, power lines, and trees.
- If you do not have a safe area outside, it may be better to remain inside.
- If you are near the coast, a tsunami could follow the earthquake. As soon as the shaking stops, climb to safety. Walk quickly to higher ground or inland away from the coast. Don't wait for officials to issue a warning.
- Expect aftershocks. Drop, Cover, and Hold On whenever you feel shaking.
- If you are trapped: - Protect your mouth, nose, and eyes from airborne debris. You can use a cloth, clothing, or a dust mask to cover your mouth and nose. - Signal for help. Use a whistle or knock loudly on a solid piece of the building three times every few minutes. Rescue personnel listens for such sounds.
- Care for any injuries you may have and assist others.
- If your home has been damaged and is no longer safe, leave and go to a safer place. If you can, take your Go-Kit of supplies.
- Use flashlights, not candles, due to fire risk.
- Do not use matches, lighters, appliances, or light switches until there are no gas leaks. Sparks from electrical switches could ignite the gas, causing an explosion.

#### Stay Connected

- Listen to local radio, TV, or other news sources for emergency information.
- Let friends and family know you are safe when you can.
- Check Your Home for Safety
- Follow guidance from local officials.
- Inspect the outside of your home for damage before reentering. If safe to do so, check the inside of your home.

- Check for damage to gas, water, electrical, and sewage systems. If there is damage, turn the utility off. - If you suspect a gas leak, leave your home, and call 911. Once you are safe, report the issue to your utility company.
- If needed, have your home inspected by a professional for damage and safety issues.

## Take Care of Yourself

- It's normal to have a lot of bad feelings, stress, or anxiety.
- Eat healthy food and get enough sleep to help you deal with stress.

## BE PREPARED

### Learn Emergency Skills

- Learn [First Aid](#) and [CPR](#) to help others. People may be injured, and emergency services may not be available.
- Learn how to turn off the utilities in your home.
- Get a fire extinguisher and learn how to use it safely. Be ready to live without power, gas, and water.



### Gather Emergency Supplies

- [Gather food, water, and medicine.](#) Stores and pharmacies might be closed. Organize supplies into a Go-Kit, Stay-at-Home-Kit, and Bed-Kit:
- Go-Kit: at least three days of supplies that you can carry with you. Include batteries and chargers for your devices (cell phone, CPAP, wheelchair, etc.)
- Stay-at-Home Kit: at least two weeks of supplies.
- Bed-Kit: a bag of supplies attached to your bed. Include items you will need if an earthquake happens while you are sleeping. Store sturdy shoes to protect your feet from glass, one of the most common earthquake injuries. Also include a flashlight, glasses, a dust mask, and a whistle.
- Have a one-month supply of medication in a child-proof container and other needed medical supplies or equipment.
- Keep personal, financial, and medical records safe and easy to access (hard copies or securely backed-up). Consider keeping a list of your medications and dosages on a small card to carry with you.

### Consumer Price Index, U.S. — March 2023

Nationally, the Consumer Price Index for All Urban Consumers (CPI-U) rose by 0.1 percent in March on a seasonally adjusted basis, the U.S. Bureau of Labor Statistics (BLS) reported today. Over the last 12 months, headline inflation increased by 5.0 percent before seasonal adjustment. As noted by the BLS, this was the smallest 12-month



increase since the period ending May 2021.

The index for all items less food and energy rose 0.4 percent in March after rising 0.5 percent in February. Also known as core inflation, all items less food and energy index rose by 5.6 percent over the 12 months ending March. Chart 1 below illustrates the five-year headline and core inflation trend since January 2019.

**Chart 1. 12-month percent change in CPI-U – U.S.**



## Food Index

The food index was unchanged in March. Within this category, the food at home index fell by 0.3 percent over the month, representing the first decline in that index since September 2020. In contrast, the food away from home index rose by 0.6 percent in March for the third consecutive month.

Over the last 12 months, food at home and food away from home increased by 8.4 percent and 8.8 percent, respectively.

## Energy

The energy index fell by 3.5 percent in March after decreasing by 0.6 percent in February. On a monthly basis, the gasoline and natural gas indices decreased by 4.6 percent and 7.1 percent in March. Electricity also fell by 0.7 percent over the month, the

largest decline in that index since January 2021.

Over the last 12 months, the energy index decreased by 6.4 percent. Within this major category, gasoline decreased by 17.4 percent annually. In comparison, electricity rose 10.2 percent and natural gas 5.5 percent since one year ago.


### All items less food and energy

The shelter index was the dominant factor in the monthly increase in the index for all items, less food and energy. Among the other notable indices that rose in March, motor vehicle insurance increased by 1.2 percent, and airline fares increased by 4.0 percent.

Household furnishings and operations, new vehicles, education, and apparel also experienced an increase in March. However, the index for used cars and trucks fell 0.9 percent in March, continuing a recent downward trend.

As noted above, core inflation increased by 5.6 percent over the past 12 months. Most notably, the shelter index increased 8.2 percent over the last year and accounts for over 60 percent of the total increase. Chart 2 highlights the annual percent change in selected major categories for March 2023.

**Chart 2. 12-month percent change in Major Categories – U.S.**




## Consumer Price Index, Los Angeles Area — March 2023

According to the latest report from the BLS, Los Angeles area prices were up 0.1 percent over the past month, and up 3.7 percent from a year ago. It was also reported that the March increase was influenced by higher prices for shelter and gasoline.

Food prices declined by 0.1 percent for the month of March. On an annual basis, however, food prices increased by 6.4 percent. Energy also decreased by 0.9 percent over the month. This decline was primarily due to lower prices for natural gas. Annually, energy prices decline by 7.6 percent.

The index for all items less food and energy increased by 0.2 percent in March. Higher prices for new and used motor vehicles (0.6 percent) and shelter (0.5 percent) were partially offset by lower prices for household furnishings and operations (-1.2 percent) and medical care (-0.5 percent). Chart 3 provides a three-year overview of headline and core inflation since March 2020.

### **Point Vicente Interpretive Center**

Crews will finish carpet installation in the lobby and public areas of the Point Vicente Interpretive Center in time to open for this Saturday's Whale of a Day event. Over the past few months, damaged wall surfaces and carpeting were removed, mold testing was performed, and new drywall was installed and painted after a plumbing pipe failed in late October and flooded significant parts of the facility.



### **Ladera Linda Community Park Project Update**

This week, crews began framing the building end walls and waterproofing the exterior sheathing. In addition to ceiling framing and light fixture rough-in, the crews started installing batt insulation and door frames. On the site, the crews placed rebar and formwork for the accessible ramp and installed the electrical vault on the lower tier. They also began installing drains and base material for the parking lot and the liner for

Next week, crews are expected to continue work on the building end wall framing and exterior waterproofing and will resume the installation of the interior drywall. They are scheduled to place concrete for the accessible ramp wall and continue work on the parking lot and bioswales.





### Egg Hunt Extravaganza



**SUBJECT: Fire Hazard Severity Zones**

Dear Deputy Director Berlant:

The City of Rancho Palos Verdes thanks you for the opportunity to provide comments on the draft Fire Hazard Severity Zones (FHSZ) map for the State Responsibility Areas (SRA) being prepared by the Department of Forestry and Fire Protection (Cal Fire) and the Office of the State Fire Marshal.

While the City agrees that high-level wildfire hazard mapping is an important tool for all Californians, we would like to seek clarification regarding the provisions of Assembly Bill No. 3074, which mandates the creation of a new ember-resistant zone (Zone 0) within 0 to 5 feet of a structure. This is a matter of particular importance to Rancho Palos Verdes, as the majority of the City falls within a Very High Fire Hazard Severity Zone (VHFHSZ) rating. However, the approval of AB 3074 represents an unfunded state mandate that would impose a significant financial burden on our residents, especially the elderly, who make up over a quarter of the City's population and many are on a fixed income.

Depending on the final interpretation, the potential requirement to remove all vegetation in and around homes would necessitate the removal of long-standing trees and vegetation, at a high cost to residents, and result in the destruction of habitat for several species of birds, including hawks, eagles, and owls who call these trees home. A one-size-fits-all approach to wildfire mitigation is ineffective and untenable.

We also request that Cal Fire collaborate with the Los Angeles County Fire Department and City officials to collect accurate data on the risk level of each home using standardized criteria and grant the authority to provide more relevant hazard rankings tailored to each specific home, enabling the local fire department to remove hazard rankings based on their risk assessment.

Moreover, we are interested in understanding the reasoning behind designating one side of Western Avenue as a VHFHSZ, while the other side in the City of Los Angeles is not classified as such. We believe that understanding the reasoning behind this designation would help us make informed decisions in mitigating wildfire risks in our City.

As identified by a 2019 series of news stories, [Rancho Palos Verdes is the most populated California city with 90% or more of residents living in a VHFHSZ](#), making it among communities that "could be the next Paradise." To protect our community from wildfires, we have implemented year-round brush clearance, communicated with local insurance underwriters to understand how we can avoid premium hikes and decreased insurance availability, and supported state legislation, grants, and incentives for residents and neighborhoods interested in fire-hardening their homes. We have also worked with local utility companies to reduce the risk of utility-started fires and pursued the development of a Peninsula-wide wildfire camera detection system, which would provide timely and accurate alerts of fire ignitions to the Peninsula cities and public safety agencies.

This spring, it is anticipated that the Local Responsibility Areas (LRA) map will be updated utilizing the same data and methodology as the SRA map. Both maps will influence local land use policies and techniques for managing wildfires without taking mitigation measures such as fuel reduction projects, defensible space, and ignition-resistant building construction into account. FHSZ designations have an effect on, among other things, planning decisions, building code applications, and the availability and price of residential home insurance.

After a decade of internal agency work updating FHSZ designations, we appreciate Cal Fire's determination to release an updated wildfire map. But we caution that not including the City's long history of relevant fire mitigation efforts will frustrate meaningful input and, more importantly, may result in inaccurate map designations. While we appreciate Cal Fire's intention to mitigate catastrophic wildfires, the City believes local jurisdictions can offer important insight regarding local fire safety and mitigation efforts in their communities, as opposed to a statewide strategy that applies equally to all jurisdictions.

For these reasons, the City of Rancho Palos Verdes strongly advocates for Cal Fire and the Office of the State Fire Marshal to adopt a collaborative strategy with local cities, such as Rancho Palos Verdes, when updating the LRA FHSZ Maps to ensure that decades of significant mitigation efforts are included.
