Palos Verdes Peninsula Cities Launch the 'Know Your Zone' Website PVPReady.gov During Wildfire Awareness Month

The four Peninsula cities and our public safety partners launched the **Know Your Zone** evacuation readiness website PVPReady.gov. With the aim to prepare Peninsula residents and businesses to evacuate in the event of an emergency, the site houses Zonehaven, a cloud-based evacuation platform with pre-established, Peninsula-wide

evacuation zone maps. The zones will also help fire, police, and other emergency service agencies prepare for emergencies, streamline the evacuation process, and reduce confusion by enabling a single verified source of emergency information.

The Know Your Zone website is a collaboration between the cities of Palos Verdes Estates, Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, their public safety partners, the Los Angeles County Office of Emergency Management, and Genasys-owned evacuation management software platform Zonehaven.

Residents, visitors, businesses, and school communities on the Peninsula should go to PVPReady.gov to find their evacuation zone, save it on their smartphone, or write it down and keep it somewhere that's easy to find in an emergency, such as on their refrigerator or near the front door.

To find your zone, visit PVPReady.gov, click "Find Your Zone," enter an address in the search bar in the upper left corner of the [zone map](#), and a pop-up window will open with the corresponding zone and emergency information. During an emergency, such as a wildfire or flood, the website and corresponding alerts will show which zones are under evacuation the moment an order is issued by authorities.

As we mark Wildfire Preparedness Week in California and National Wildfire Awareness Month, the four Peninsula cities, in partnership with the L.A. County Fire Department, Sheriff's Department, and Palos Verdes Estates Police Department, encourage the entire community to Know Your Zone and get familiar with PVPReady.gov. In addition to home addresses, residents should know the zones of places they frequent, such as work, school, places of worship, or the homes of family and friends. No account, registration, or app download is required for this easy-to-use platform, which provides critical information in multiple languages.

A brief demonstration will be given at the May 16 City Council meeting – so tune in!

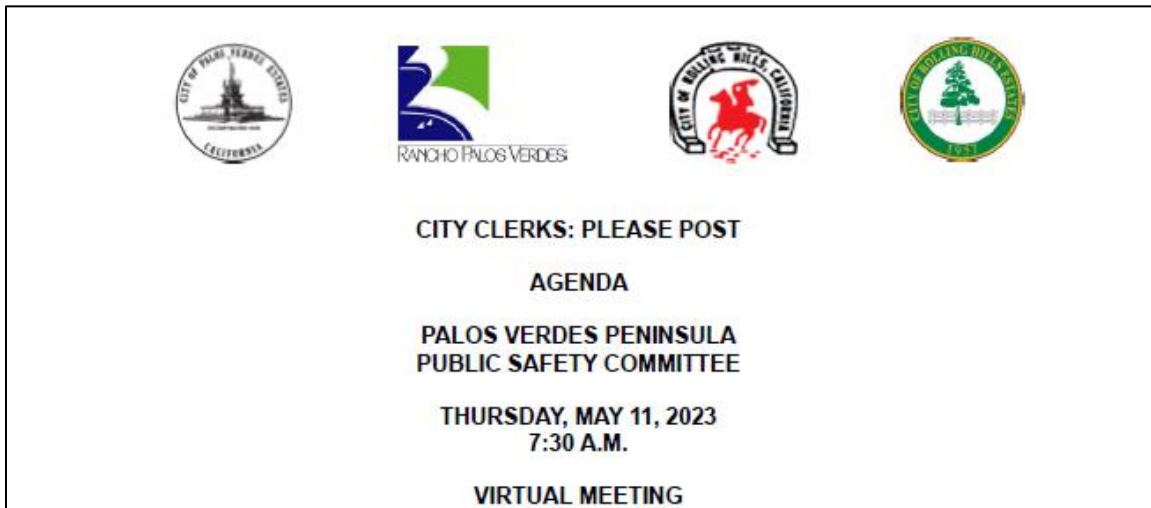

Peninsula Public Safety and Regional Contract Law Committee Meeting – May 11, 2023

The Peninsula Public Safety Committee (PPSC) and the Regional Contract Law Committee (RCLC) will convene for their quarterly meeting on May 11, in an online meeting format. The Peninsula Public Safety Committee Meeting will begin at 7:30 a.m., and the Regional Contract Law Committee Meeting will commence after its conclusion.

The Peninsula Public Safety Committee (PPSC) consists of two Council Members from all four Peninsula Cities of Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, and Palos Verdes Estates. The PPSC meets quarterly on the same day as the RCLC to discuss collaborative efforts on ensuring Peninsula-wide emergency preparedness and Public Safety. The Peninsula Public Safety Committee (PPSC) combines emergency preparedness initiatives and public safety trends and topics about the Peninsula.

The Regional Contract Law Committee (RCLC) consists of two Council Members from the Cities of Rancho Palos Verdes, Rolling Hills, and Rolling Hills Estates, who share municipal law enforcement services provided by the Los Angeles County Sheriff's Department. The RCLC meets quarterly to review the Sheriff's performance, make policy

recommendations regarding the joint contract, and review statistics for the preceding quarter concerning crime incidents, traffic enforcement, response times, false alarm rates, and the distribution of the Sheriff's patrol time throughout the region.

These experts shared valuable insights on evacuation readiness, property insurance, and home hardening and retrofitting during this informative virtual town hall.

EMERGENCY PREPAREDNESS TIPS

Ten Tips to Help You Prepare Your Pets for Wildfire Season:

With summer and warmer temperatures around the corner, all pet owners are reminded to prepare for wildfire season. Preparing in advance and making an emergency plan can make all the difference when faced with evacuation during a wildfire incident.

The following are some basic tips that will help ensure you and your pets are prepared in the face of an emergency:



1. **HAVE AN EMERGENCY PLAN FOR EACH PET:** where will you go, who will take care of them, and how you will transport them. Make a list with contact information, transportation routes, and backup plans.
2. **RESEARCH PET-FRIENDLY HOTELS AND LODGING AND KEEP THE LIST CURRENT:** Reach out to friends and family outside the area to find out if you can stay with them during an emergency.
3. **ENGAGE WITH YOUR COMMUNITY:** network with neighbors on community websites and apps to make connections with other pet owners. This can help you share resources and make a unified plan.
4. **GET YOUR ANIMALS MICROCHIPPED WITH UP-TO-DATE CONTACT INFORMATION** in the registry, an important step that many people forget. Have visible identification such as collars and tags whenever possible, and safe to do so.

5. **PREPARE A MINIMUM OF A THREE-DAY SUPPLY OF FOOD AND WATER FOR EACH ANIMAL.**
6. **HAVE AN ASSEMBLED EMERGENCY “GO-KIT” READY AT ALL TIMES:** Include medications, medical records, licensing records, a photo of the animal, collar, leash, carrier, and any comfort items that will help your pet. Make sure exotics and birds have appropriate housing and food.
7. **FOR LARGE ANIMALS, TRAIN THEM TO LOAD INTO TRAILERS PRIOR TO AN EMERGENCY:** Practice loading and unloading them. Gather any records, documents, and special items they may need.
8. **HAVE PROPER TRANSPORTATION TO TRANSPORT YOUR ANIMALS.** This is especially important for large animals. Make sure you know how you will transport your animals and that all information is current. Conduct safety checks on horse and livestock trailers to ensure they are fully operational and ready for use in an emergency.
9. **PRACTICE YOUR PLAN.** Make sure all family members and pets are familiar with the plan and what’s expected of them.
10. **EVACUATE EARLY!** Don’t wait until the last minute; activate your plan while roads are still open to avoid traffic delays.

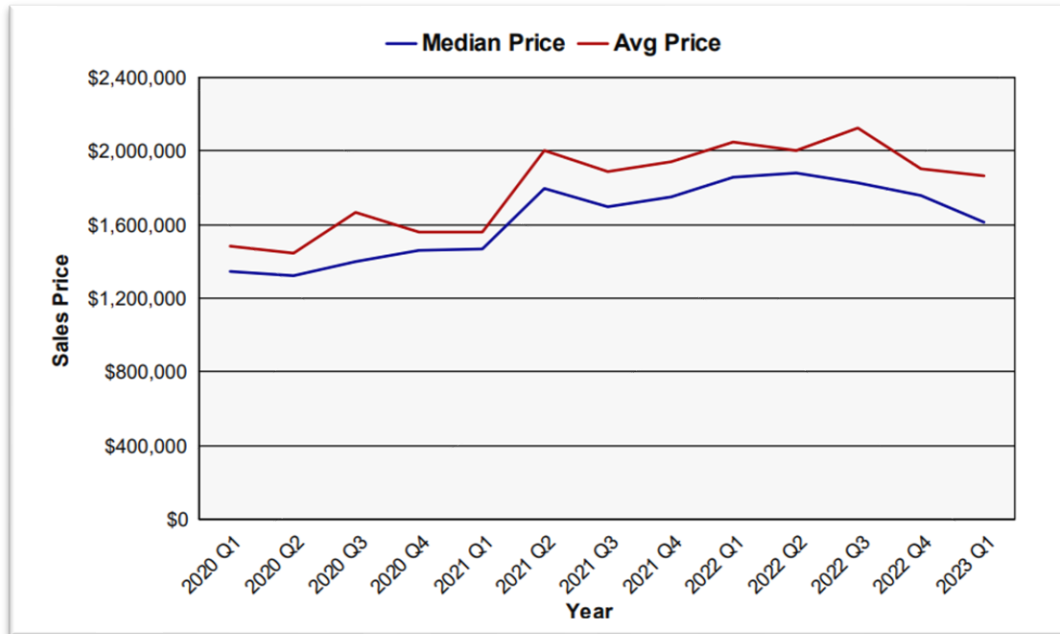


Quarterly Home Sales History – 1st Quarter 2023

Through the quarter ending March 30, 2023, the housing market remains competitive and continues to experience mixed signals, as indicated by various factors. Homes are selling faster, and the sales-to-list price ratio is improving, yet the latest data also suggests that the number of homes for sale is tightening, and the volume of sales is declining. Additionally, the statewide median home price rose to \$791,490 by the end of the first quarter, up 7.6 percent from February and down 7.0 percent from March 2022. With home prices rising more sharply than last year's normal seasonal pattern, the housing market could see larger year-over-year price drops as it moves through the spring home buying season.

The median sales price for detached single-family homes in the City of Rancho Palos Verdes fell 8.5 percent to \$1.6 million by the end of March, a decrease of nearly \$150,000 from the previous quarter. Compared to March 2022, the median sales price is down from \$1.86 million by approximately \$245,000, or 13 percent. Despite this trend, the median home price remains \$140,000, or 10 percent, above the same measure in

2021. The chart on the following page highlights quarterly changes in median and average sales prices between 2020 and 2023.



The median and average sales prices have fallen below the uniquely high values observed in 2022. Home values are simultaneously being impacted by corrections to the housing market and supported by a limited housing supply. The sales volume in Rancho Palos Verdes, as an indication of limited supply, has experienced a decline for three consecutive quarters. As of March 2023, home sales decreased by 145, or 40%, compared to the first three quarters in FY 2021-22. As noted above, the continuous decline in prices compared to 2022 is expected to spur sales activity during the spring buying season. Additional details regarding the quarterly comparisons through March 2023 are shown below.

Ladera Linda Community Park Project Update

Last week, crews continued installing exterior rigid insulation, interior drywall, and electrical wiring.

Additionally, crews continued the application of the finish coat to the accessible ramp and trash enclosure walls and waterproofing the stepped terrace walls. Crews trimmed the ocean-facing perimeter fence to 42" in height and repaired the fence between the park and the soccer fields. Crews also resumed installing storm drains at the upper tier behind the accessible ramp; continued filling bioswales at all three tiers with liners, rock, piping, and planting medium; completed grading for the new driveway and sidewalk; and placed concrete for the new curb along the driveway.

This week, crews are scheduled to continue work on the building's exterior insulation, interior drywall, electrical wiring, stepped terrace, accessible ramp, trash enclosure, driveway, and bioswales. The export of surplus spoils is also scheduled to resume this week as tests have confirmed that there are no contaminants.

A temporary electrified fence is used to contain the goats while they are working, and attempting to approach them puts you as well as the goats at risk.

Please avoid attempting to take selfies/pictures or trying to touch the goats, especially if

you have dogs or pets with you. This will prevent stress and/or injury to you and the goats.

In addition to the goats, you may see Stay Green crews performing brush clearance in various areas of the City as part of the City's 2023 fuel modification program.

Wonderful job, RPV! 23.68 tons of brush were collected during the Spring 2023 Brush Clearance! Each week a different area of RPV was serviced. The goal of the event was to assist homeowners' dispose (free of charge) excess brush, shrubs, hedges, tree branches, and bushes to comply with the Los Angeles County Fire Department's fire safety guidelines. This was a great opportunity to help prevent local brush fires! The next Brush Clearance Collection will begin on October 7!

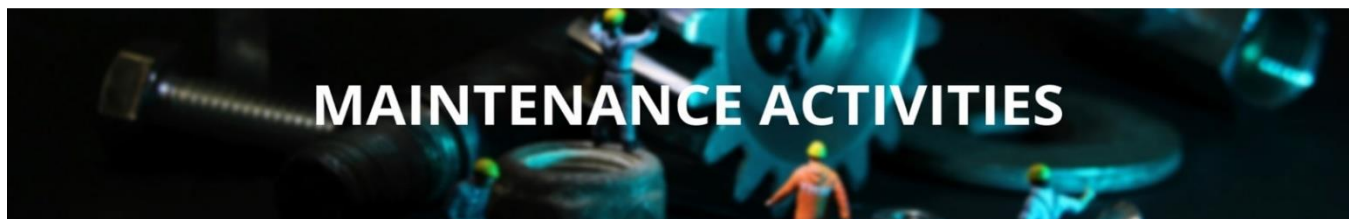


Infrastructure Management Advisory Committee (IMAC) Meeting

In addition to regularly scheduled maintenance and repairs, Public Works performed the following:



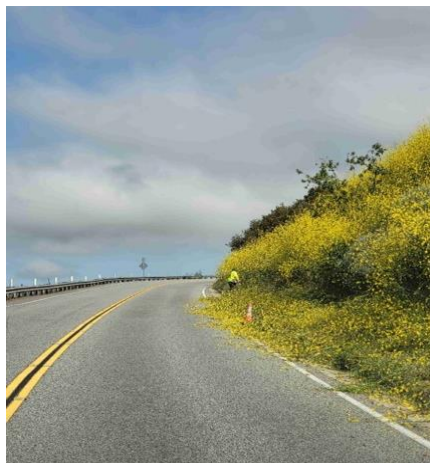
- Weekly landscape maintenance at all City parks.

2023 Peafowl Census Report

On May 16, the City Council will review the 2023 Peafowl Census Report. The review of the report is part of the Peafowl Management Plan (PMP), which was adopted in 2015 to humanely manage the peafowl population within the city. Specifically, the PMP requires an annual census to estimate the population of peafowl throughout the six program neighborhoods, which include Portuguese Bend, Crestridge, Sunnyside Ridge, Grandview, Vista Grande, and Monaco. Based on the information collected, the City Council then determines if peafowl trapping is warranted for the season. Tesla Supercharger Station Proposal for the Terraces Shopping Center

City Staff is currently reviewing a proposal by Tesla to install an electrical vehicle Super Charging Station in the top-level north lot of the Terraces, behind the Terrace Cinema Theatre. The proposal is for 24 DC Fast Charging Units, 6 Supercharger Cabinets, and 1 Switchgear. The Super Charging Station would replace some existing parking spaces. City Staff continues to work with the Applicant on a completeness review of the submitted applications and will provide additional updates as more information becomes available. Abalone Cove Reserve:

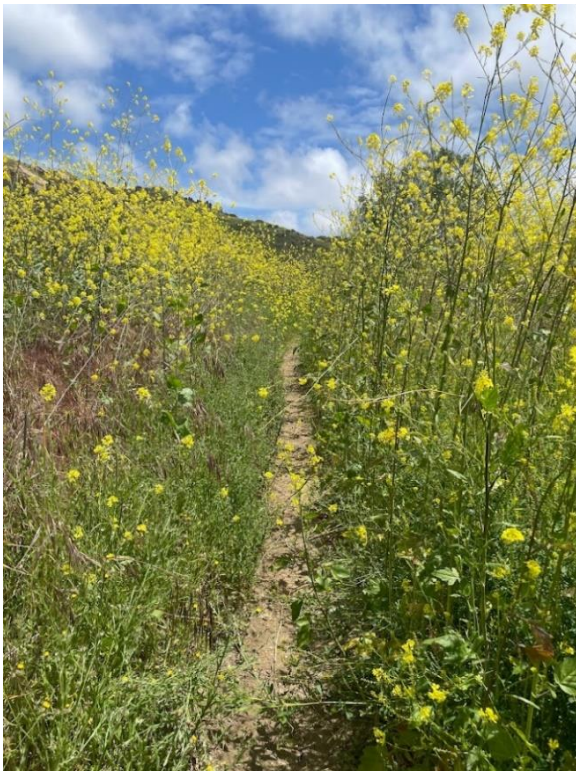
A deceased dolphin washed ashore this week. Staff is in contact with several partner agencies to remove it.

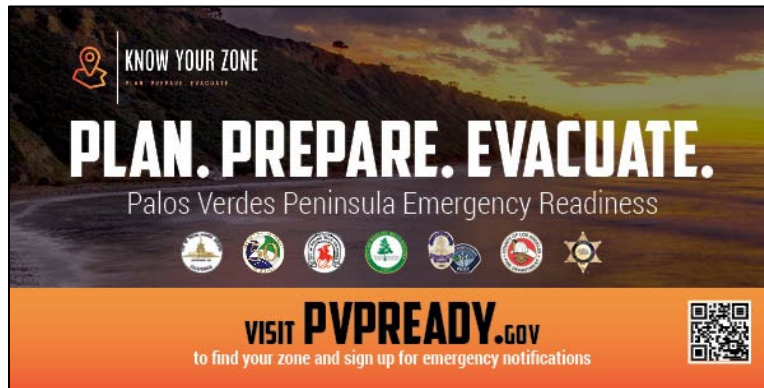

Palos Verdes Peninsula Cities Launch ‘Know Your Zone’ Website PVPReady.gov During Wildfire Awareness Month

May 8, 2023 (Palos Verdes Peninsula, Calif.) — The four cities of the Palos Verdes Peninsula today launched the **Know Your Zone** evacuation readiness website PVPReady.gov. With the aim to prepare Peninsula residents and businesses to evacuate in the event of an emergency, the site houses Zonehaven, a cloud-based evacuation platform with pre-established, Peninsula-wide evacuation zone maps. The zones will also help fire, police and other emergency service agencies prepare for emergencies, streamline the evacuation process, and reduce confusion by enabling a single verified source of emergency information.

The **Know Your Zone** website is a collaboration between the cities of Palos Verdes Estates, Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, their public safety partners, the Los Angeles County Office of Emergency Services and Genasys-owned evacuation management software platform Zonehaven.

Residents, visitors, businesses, and school communities on the Peninsula should go to **PVPReady.gov** to find their evacuation zone, save it in their smartphone, or write it down and keep it somewhere that’s easy to find in an emergency, such as on their refrigerator or near the front door. To find your zone, visit **PVPReady.gov**, click “Find Your Zone,” enter an address in the search bar in the upper left corner of the [zone map](#), and a pop-up window will open with the corresponding zone and emergency information. During an emergency, such as a wildfire or flood, the website and corresponding alerts will show which zones are under evacuation the moment an order is issued by authorities.

The zone map bridges an important gap between first responders and the community, providing real-time information directly to residents as incidents unfold. The zone map incorporates hyperlocal knowledge to model evolving disasters and subsequent impacts on evacuation zones, traffic patterns, and public safety. **PVPReady.gov** and the alert systems each city utilizes to notify their communities will be updated with zone-specific information, including evacuation status, live incident updates, weather, road and traffic conditions, and other essential information.

In addition to incident-based information, **PVPReady.gov** provides important readiness resources to help you prepare yourself and your family for a disaster year-round. On the site, you can also sign up for [Alert SouthBay](#), an alert system providing timely, accurate emergency and warning notifications to the communities of the Palos Verdes Peninsula and greater South Bay region, depending on your subscription. Information on how to contact your respective city is also available as quick and easy access for website visitors.

As we mark Wildfire Preparedness Week in California and National Wildfire Awareness Month, the four Peninsula cities, in partnership with the L.A. County Fire Department, Sheriff's Department, and Palos Verdes Estates Police Department, encourage the entire community to **Know Your Zone** and get familiar with **PVPReady.gov**. In addition to home addresses, residents should know the zones of places they frequent, such as work, school, places of worship, or the homes of family and friends. No account, registration or app download is required for this easy-to-use platform, which provides critical information in multiple languages.

The L.A. County Office of Emergency Management is rolling out Zonehaven in coordination with local law enforcement, fire protection, and government agencies as a larger resource to high hazard-prone communities in the county. This platform has been utilized elsewhere in California during major wildfires and to support evacuations for active shooter and debris flow hazards across multiple jurisdictions.

"It's been 14 years since the Peninsula had a major wildfire. Knowing your zone and getting familiar with the zone map ahead of time will be critical to making sure you and your family are ready when it's time to evacuate," said L.A. County Fire Department Assistant Fire Chief Brian Bennett.

Michael White, Acting Captain of the Lomita Sheriff's Station, said having knowledge of your zone is highly valuable in the event of an evacuation. "Our deputies are trained and prepared to evacuate neighborhoods, if necessary. Education and knowledge are key factors for any emergency situation. Being prepared is extremely important, especially for such a serious matter. You can help us and help your community by being prepared. Be proactive, get to know your zone today."

"The Know Your Zone website will be an invaluable resource during an evacuation, but in a major emergency, cell phone and internet service may not be reliable," said Luke Hellinga, Acting Chief of the Palos Verdes Estates Police Department. "That's why you should also write down your zone and keep it somewhere that's easy to find when you may only have minutes to act."

PVPReady.gov will provide the Peninsula with a new tool for emergency preparedness, but it will take all of us to ensure we are ready for a disaster. In addition to knowing your zone, have a plan in place for your family or business, maintain an emergency kit with essential items, medications, and important documents, and always know where to get the most updated information.

TIPS FOR YOUTH

BIKE SAFETY

Biking is fun, healthy, and a great way to get around and be independent. But your bike is a vehicle, not a toy!

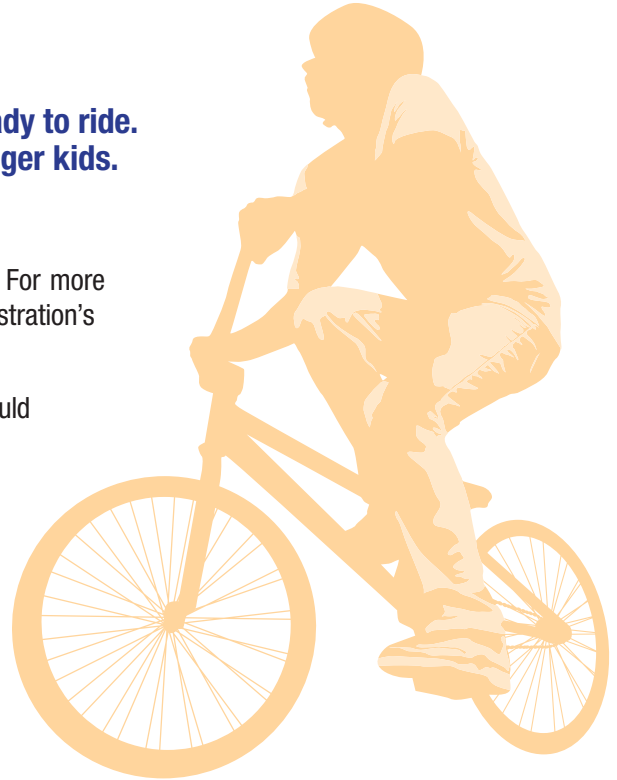
Some bike crashes can cause serious injuries and most are related to the behavior of you (the bicyclist) or the motorist. There are a number of things you can do to prevent a crash, and protect your brain if a crash occurs.

Safe Riding Tips

Before riding, make sure you and your bike are ready to ride. You can be a “Roll Model” for your peers and younger kids.

Remember to:

- **Wear a Bike Helmet.** Protect your brain, save your life. For more information see the National Highway Traffic Safety Administration’s *Fitting Your Bike Helmet*.
- **Adjust Your Bike to Fit.** Stand over your bike. There should be 1 to 2 inches between the rider and the top tube (bar) if using a road bike and 3 to 4 inches if using a mountain bicycle. The seat should be level front to back, and the height should be adjusted to allow a slight bend at the knee when the leg is fully extended. The handlebar height should be at the same level with the seat.
- **Check Your Equipment.** Before riding, inflate tires properly and check that the brakes work.
- **See and Be Seen.** Whether daytime, dawn, dusk, foul weather, or at night, make yourself visible. Wear neon, fluorescent or other bright colors when riding, to make yourselves the most visible to others. Also wear something that reflects light, such as reflective tape or markings, or flashing lights. Remember, just because you can see a driver doesn’t mean the driver can see you.
- **Control Your Bike.** Ride with two hands on the handlebars unless signaling a turn. Place books and other items in a bike carrier or backpack.
- **Watch for and Avoid Road Hazards.** Look for hazards that may make you crash, such as potholes, broken glass, gravel, puddles, leaves, and dogs.
- **Use Verbal and Non-Verbal Communication.** This includes eye contact with drivers, turn signals, pointing to road hazards for bicyclists behind you, and stating “passing on your left,” or “on your left.”
- **Avoid Riding at Night.** It’s harder for other road users to see bicyclists at dusk, dawn or nighttime. Use reflectors on the front and rear of the bike. White lights and red rear reflectors or lights are required by law in all States.



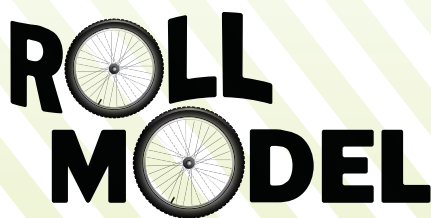
Rules for Biking on the Road

In all States, bikes on the roadway are considered vehicles, and bicyclists are the drivers of those vehicles, with the same rights and responsibilities as other motorists to follow the rules of the road, including:

- **Go With the Traffic Flow.** Ride on the right side in the same direction as other vehicles. Go with the flow – not against it.
- **Obey All Traffic Laws.** As the driver of your vehicle on the road, obey all traffic signs, signals, and lane markings.
- **Yield to Traffic.** Almost always, drivers on a smaller road must yield (wait) for traffic on a major or larger road. If there is no stop sign or traffic signal and you are coming from a smaller roadway (out of a driveway, from a sidewalk, a bike path, etc.), slow down, look for traffic, and go only when it's clear. Also yield to pedestrians in a crosswalk.
- **Be Predictable.** Ride in a straight line, not in and out of cars. Signal your moves to others.
- **Stay Alert at All Times.** Use your eyes AND ears. Look for potholes, cracks, wet leaves, storm grates, railroad tracks, or anything that could make you lose control of your bike. Listen for traffic and avoid dangerous situations; don't use personal electronic devices when you ride.
- **Look Before Turning.** When turning left or right, always look behind you for a break in traffic, and then signal before making the turn. Watch for left- or right-turning traffic.
- **Watch for Parked Cars.** Ride far enough out from the curb to avoid the unexpected from parked cars (like doors opening, or cars pulling out).

Where to Ride Safely

- **Use bike lanes or bike paths, if available.**
 - While bicycles are allowed on many roads, riders may feel safer being separated from traffic. A lane or path is a safer choice than riding on a sidewalk.
 - Riding on sidewalks puts you in a place where cars do not look for or expect to see moving traffic.
 - Sidewalk riding puts you at risk for crashes at driveways and intersections.
- **If you don't know the rules of the road, or your parents feel like you aren't ready to ride on the street, avoid riding your bike near traffic altogether.**
- **For anyone riding on a sidewalk:**
 - Check the law in your State or jurisdiction to make sure sidewalk riding is allowed.
 - Watch for vehicles coming out of or turning into driveways.
 - Stop at corners of sidewalks and streets to look for cars and to make sure the drivers see you before crossing.
 - Enter a street at a corner and not between parked cars. Alert pedestrians that you are nearby, saying, "Passing on your left," or use a bell or horn.
