May 16, 2023, City Council Meeting Highlights

Last night, the City Council voted to continue pausing the City's humane peafowl trapping program in 2023 until a new count of peacocks and peahens is conducted in 2024.

The Council also reviewed the preliminary 2023-24 City budget and approved a 6% EDCO rate increase for residential customers that will take effect July 1.

Marcotte. Finally, the Council presented outgoing RPV Finance Director Trang Nguyen with a City tile for her seven years of service to RPV before she leaves for a position at a new city.

Cal Water Service Rolls Back to Stage 1 of Water Shortage Contingency Plan

On May 8, 2023, California Water Service (Cal Water) submitted a filing with the California Public Utilities Commission (CPUC) to rescind Stage 2 of its Water Shortage Contingency Plan because of improved drought conditions and increased water supply throughout its districts. Stage 1 became effective immediately but remains subject to a 30-day review period by the CPUC.

Although Cal Water has moved to Stage 1, customers must continue to observe any city or county landscape irrigation ordinances in effect. Cal Water also encourages customers to remain vigilant about their water use and, in particular, ensure landscaping actually needs water before irrigating it.



Some outdoor water-use restrictions remain in place, including:

- No watering of non-functional turf at commercial, industrial, and institutional properties.
- Watering only between the hours of 6 p.m. and 8 a.m.

- No watering of outdoor landscapes during and within 48 hours after measurable rainfall.
- Only washing vehicles with a hose that has a shutoff nozzle or similar device, or at a car wash that uses recycled water.
- No watering driveways, sidewalks, or other paved areas, unless for health and safety purposes.

Cal Water's conservation rebates and programs will also continue, including a \$3-per-square-foot rebate for lawn-to-garden conversions, a 50 cents-per-square-foot rebate for spray-to-drip conversions, and its popular Smart Landscape Tune Up Program. Palos Verdes Peninsula Cities Launch the 'Know Your Zone' Website PVPreReady.gov During Wildfire Awareness Month

The four Peninsula cities and our public safety partners launched the **Know Your Zone** evacuation readiness website [PVPreReady.gov](https://pvpready.gov). With the aim to prepare Peninsula residents and businesses to evacuate in the event of an emergency, the site houses Zonehaven, a cloud-based evacuation platform with pre-established, Peninsula-wide evacuation zone maps. The zones will also help fire, police, and other emergency service agencies prepare for emergencies, streamline the evacuation process, and reduce confusion by enabling a single verified source of emergency information.


The Know Your Zone website is a collaboration between the cities of Palos Verdes Estates, Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, their public safety partners, the Los Angeles County Office of Emergency Management, and Genasys-owned evacuation management software platform Zonehaven.

Residents, visitors, businesses, and school communities on the Peninsula should go to PVPReady.gov to find their evacuation zone, save it on their smartphone, or write it down and keep it somewhere that's easy to find in an emergency, such as on their refrigerator or near the front door.

To find your zone, visit PVPReady.gov, click "Find Your Zone," enter an address in the search bar in the upper left corner of the [zone map](#), and a pop-up window will open with the corresponding zone and emergency information. During an emergency, such as a wildfire or flood, the website and corresponding alerts will show which zones are under evacuation the moment an order is issued by authorities.

As we mark National Wildfire Awareness Month, the four Peninsula cities, in partnership with the L.A. County Fire Department, Sheriff's Department, and Palos Verdes Estates Police Department, encourage the entire community to Know Your Zone and get familiar with PVPReady.gov. In addition to home addresses, residents should know the zones of places they frequent, such as work, school, places of worship, or the homes of family and friends. No account, registration, or app download is required for this easy-to-use platform, which provides critical information in multiple languages.

Installation of Wildfire Detection Cameras at RPV City Hall

Last week, the first cameras were installed at RPV City Hall for the Peninsula-wide network of wildfire detection cameras! These high-mounted, 360-degree Pano AI cameras will be monitored 24/7 to detect wildfire smoke so first responders can be alerted to a brush fire as early as possible. Cameras at three additional locations are expected to go up in the coming weeks.

Thanks again to Assemblymember Muratsuchi for allocating \$1.5 million in the state budget to bring this system to the Hill.

Submission of Notice of Interests for Hazard Mitigation Grant Program (HMGP) Funding

On May 10, the City submitted two notices of interest for federal grant funds provided through the Hazard Mitigation Grant Program (HMGP), which is administered by the Federal Emergency Management Agency (FEMA). These notices of interest represent the initial steps toward securing funds for the following projects:

- To address the impacts caused by the current Abalone Cove landslide movement.
- Establishment of backup power systems at critical City facilities to ensure uninterrupted operations during power outages or emergencies.

By pursuing these initiatives, the City aims to bolster its resilience and mitigate potential risks associated with land movement, wildfires, and power disruptions. A Submission of a Notice of Interest is required prior to submitting a sub application for the Hazard Mitigation Grant Program (HMGP).

FEMA's HMGP provides funding to state, local, tribal, and territorial governments so they can reduce or mitigate future disaster losses in their communities. HMGP funding becomes available after an area experiences a qualifying disaster to mitigate against such a disaster recurring in the same area. In California, these funds are managed by the California Office of Emergency Services (Cal OES) HMGP Unit.

This funding provides the opportunity for communities to implement mitigation activities to reduce risk to life and property from natural hazards. In California, natural hazards include wildfire, earthquake, drought, extreme weather, flooding, and other impacts of climate change. HMGP funding can also support the development of Local Hazard Mitigation Plans (LHMP) and project scoping activities.

Projects must be eligible, feasible, and cost-effective per FEMA's Hazard Mitigation Assistance Guidance. In addition, projects must be stand-alone activities that will reduce risk as their primary benefit, but Cal OES strongly encourages submitting projects that achieve multiple benefits.



Emergency Preparedness Virtual Town Hall Hosted by Insurance Commissioner Ricardo Lara and State Senator Ben Allen

On May 3, Staff attended a webinar centered on emergency preparedness resources in our region. Hosted by Insurance Commissioner Ricardo Lara and State Senator Ben Allen, the event featured subject matter experts from the Federal Emergency Management Agency (FEMA), California Department of Forestry and Fire Protection (CAL FIRE), and the California Earthquake Authority (CEA). During this informative virtual town hall, these experts shared valuable insights on evacuation readiness, property insurance, and home hardening and retrofitting.

Emergency Alerts

Many emergency mass notification communication tools are available to residents and businesses in Los Angeles County. For example, the Emergency Alert System broadcasts

emergency information directly to radio and television carriers for widespread emergency events. You may have already seen these messages, which are voice messages with text scrolling on the television screen.

Disaster can happen anytime, in any part of the country. When emergencies occur, public safety officials provide critical alerts and warnings to local communities. Through a variety of technologies, these organizations communicate critical information and occasionally order evacuations, allowing residents to take immediate action to stay safe.

The following is a summary of the different types of warning alerts available and how to receive them.

WIRELESS EMERGENCY ALERTS (WEAS):

Wireless Emergency Alerts (WEAs) are one of many ways public safety officials can quickly and effectively alert the public to serious emergencies. WEAs go directly to your cellphone and can be used to send out urgent alerts targeting certain geographic areas.

What you need to know about WEAs:

- WEAs can be sent by state and local public safety officials, the National Weather Service, the National Center for Missing and Exploited Children, and the President of the United States.
- WEAs look like text messages but are designed to get your attention with a unique sound and vibration repeated twice.
- WEAs are no more than 360 characters and include the type and time of the alert, any action you should take, and the agency issuing the alert.
- WEAs are not affected by network congestion and will not disrupt texts, calls or data sessions that are in progress.
- You are not charged for receiving WEAs and there is no need to subscribe.

EMERGENCY ALERT SYSTEM:

The Emergency Alert System (EAS) is a national public warning system that allows the president to address the American people within 10 minutes during a national emergency. The alerts are sent through broadcasters, satellite digital audio services, direct broadcast satellite providers, cable television systems and wireless cable systems.

The EAS may also be used by state and local authorities to deliver important emergency information such as weather information, imminent threats, AMBER alerts and local

incident information targeted to specific areas. The president has sole responsibility for determining when the national-level EAS will be activated.

OPT-IN NOTIFICATION SYSTEMS:

Opt-in mass notification systems can vary by region but operate similarly for what reasons people are notified. Alerts received could be about extreme weather or natural disasters, road closures, missing people, or evacuations. These alerts are managed by the local agency that set them up.

Alert SouthBay: Alert SouthBay is a multi-jurisdictional emergency notification system used by 14 South Bay cities – including Rancho Palos Verdes - to keep our communities informed about disasters and emergencies with uniform and expeditious alerts. Alert SouthBay will act as the City’s primary vehicle for emergency communication. Residents can sign up for Alert SouthBay by:

- Texting “alertsrb” to 888-777, which returns a link to register for Everbridge
- Registering online at alertsouthbay.com
- Downloading the free [Everbridge app](#) on an iOS or Android device from the [App Store](#) or [Google Play](#).

Alert LA County: In Los Angeles County, the Sheriff’s Department uses Alert LA County to contact residents and businesses via phone, text messages, or e-mail messages in case of emergency. This system is used to send shelter-in-place instructions, evacuation, and other emergency messages. It has accessibility features for people with disabilities and others with access and functional needs.



Consumer Price Index, U.S. — April 2023

After rising by 0.1% in March, the Consumer Price Index for All Urban Consumers (CPI-U) in the U.S. rose by 0.4 percent in April on a seasonally adjusted basis. Compared annually, the April 2023 CPI increased by 4.9% before seasonal adjustment. This change represents the smallest 12-month increase since the period ending April 2021.

The all items index less food and energy, core inflation, rose by 0.4% in April as it did in March. On an annual basis, core inflation increased by 5.5% compared to April 2022. Major indexes that contributed to the April increase include shelter, used cars and trucks, motor vehicle insurance, recreation, household furnishings and operations, and personal care. The index for airline fares and the index for new vehicles were among those that decreased over the month. Chart 1 below illustrates the annual percent change in CPI for major U.S. categories as of April 2023.

Ladera Linda Community Park Project Update

Last week, crews continued installing exterior insulation, interior drywall, and electrical wiring.

Additionally, crews continued the application of the finish coat to the accessible ramp, backfilled the stepped terrace walls, and began grading at the upper tier for the playground areas. Finally, crews connected the new irrigation service pipe at the property line and continued filling the bioswales and installing storm drains at the middle and upper tiers.

This week, crews are scheduled to continue work on the building's exterior insulation, interior drywall, electrical wiring, stepped terrace, accessible ramp, bioswales, storm drains, and playground areas. In addition, export of surplus spoils is expected to resume this week.

Goats are Here for the Fuel Modification Season!



Goats are in the City to perform the important job of helping reduce fire loads and protect homes. Although we understand many people enjoy seeing the goats, please refrain from going to see them out of respect for residents living near where the goats work.

A temporary electrified fence is used to contain the goats while they are working, and attempting to approach them puts you as well as the goats at risk.

Please avoid attempting to take selfies/pictures or trying to touch the goats, especially if you have dogs or pets with you. This will prevent stress and/or injury to you and the goats.

In addition to the goats, you may see Stay Green crews performing brush clearance in various areas of the City as part of the City's 2023 fuel modification program.

- Other 50th Anniversary celebration repairs included BBQ pit replacement, fence, and concrete repairs.






STREET LANDSCAPING

City Council to Consider Pony Club Large Animal Permit

On June 6, the City Council will consider a request to renew the Portuguese Bend Pony Club's Conditional Large Domestic Animal Permit for an additional 10 years to continue existing operations at 2 West Pomegranate (Case No. PLDC2023-0001). On May 18, the Community Development Department will issue a public notice [available on the City website](#) about this proposed permit extension. No Construction on Memorial Day Holiday (Monday, May 29, 2023)

Pursuant to Section 17.56.020(B) of the City's Zoning Code, it is unlawful to carry on construction, grading, or landscaping activities, or to operate heavy equipment on legal holidays, unless a Special Construction Permit is approved by the Director of Community Development. Special Construction Permits must be requested at least 48 hours before any such work is to begin. A Special Construction Permit must be obtained by May 26. The Special Construction Permit application is available by visiting the following link: <https://bit.ly/3oVBLTv>. Please note that minor repairs, maintenance, and landscaping activities (i.e., work that does not otherwise require a building permit) are not prohibited on legal holidays.

Annual CentralSquare User Conference

From June 4-7, Staff from the Community Development Department will attend the annual CentralSquare Conference in Nashville, Tennessee. CentralSquare is an organization dedicated to providing public sector software platforms such as TraKit, which is the City's project and permitting tracking system. Several departments in the City have been utilizing TraKit since 2018 and it has been an instrumental tool in tracking, processing, and issuing permits; and providing the platform to implement an online permit application system for building and public works permits. The user conference will provide informational sessions, customer support, and opportunities to learn more about the software to better enhance workflow efficiency and resolve system glitches.



Palos Verdes Peninsula Cities Launch ‘Know Your Zone’ Website PVPReady.gov During Wildfire Awareness Month

May 8, 2023 (Palos Verdes Peninsula, Calif.) — The four cities of the Palos Verdes Peninsula today launched the **Know Your Zone** evacuation readiness website PVPReady.gov. With the aim to prepare Peninsula residents and businesses to evacuate in the event of an emergency, the site houses Zonehaven, a cloud-based evacuation platform with pre-established, Peninsula-wide evacuation zone maps. The zones will also help fire, police and other emergency service agencies prepare for emergencies, streamline the evacuation process, and reduce confusion by enabling a single verified source of emergency information.

The **Know Your Zone** website is a collaboration between the cities of Palos Verdes Estates, Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, their public safety partners, the Los Angeles County Office of Emergency Services and Genasys-owned evacuation management software platform Zonehaven.

Residents, visitors, businesses, and school communities on the Peninsula should go to **PVPReady.gov** to find their evacuation zone, save it in their smartphone, or write it down and keep it somewhere that’s easy to find in an emergency, such as on their refrigerator or near the front door. To find your zone, visit **PVPReady.gov**, click “Find Your Zone,” enter an address in the search bar in the upper left corner of the [zone map](#), and a pop-up window will open with the corresponding zone and emergency information. During an emergency, such as a wildfire or flood, the website and corresponding alerts will show which zones are under evacuation the moment an order is issued by authorities.

The zone map bridges an important gap between first responders and the community, providing real-time information directly to residents as incidents unfold. The zone map incorporates hyperlocal knowledge to model evolving disasters and subsequent impacts on evacuation zones, traffic patterns, and public safety. **PVPReady.gov** and the alert systems each city utilizes to notify their communities will be updated with zone-specific information, including evacuation status, live incident updates, weather, road and traffic conditions, and other essential information.

In addition to incident-based information, **PVPReady.gov** provides important readiness resources to help you prepare yourself and your family for a disaster year-round. On the site, you can also sign up for [Alert SouthBay](#), an alert system providing timely, accurate emergency and warning notifications to the communities of the Palos Verdes Peninsula and greater South Bay region, depending on your subscription. Information on how to contact your respective city is also available as quick and easy access for website visitors.

As we mark Wildfire Preparedness Week in California and National Wildfire Awareness Month, the four Peninsula cities, in partnership with the L.A. County Fire Department, Sheriff's Department, and Palos Verdes Estates Police Department, encourage the entire community to **Know Your Zone** and get familiar with **PVPReady.gov**. In addition to home addresses, residents should know the zones of places they frequent, such as work, school, places of worship, or the homes of family and friends. No account, registration or app download is required for this easy-to-use platform, which provides critical information in multiple languages.

The L.A. County Office of Emergency Management is rolling out Zonehaven in coordination with local law enforcement, fire protection, and government agencies as a larger resource to high hazard-prone communities in the county. This platform has been utilized elsewhere in California during major wildfires and to support evacuations for active shooter and debris flow hazards across multiple jurisdictions.

"It's been 14 years since the Peninsula had a major wildfire. Knowing your zone and getting familiar with the zone map ahead of time will be critical to making sure you and your family are ready when it's time to evacuate," said L.A. County Fire Department Assistant Fire Chief Brian Bennett.

Michael White, Acting Captain of the Lomita Sheriff's Station, said having knowledge of your zone is highly valuable in the event of an evacuation. "Our deputies are trained and prepared to evacuate neighborhoods, if necessary. Education and knowledge are key factors for any emergency situation. Being prepared is extremely important, especially for such a serious matter. You can help us and help your community by being prepared. Be proactive, get to know your zone today."

"The Know Your Zone website will be an invaluable resource during an evacuation, but in a major emergency, cell phone and internet service may not be reliable," said Luke Hellinga, Acting Chief of the Palos Verdes Estates Police Department. "That's why you should also write down your zone and keep it somewhere that's easy to find when you may only have minutes to act."

PVPReady.gov will provide the Peninsula with a new tool for emergency preparedness, but it will take all of us to ensure we are ready for a disaster. In addition to knowing your zone, have a plan in place for your family or business, maintain an emergency kit with essential items, medications, and important documents, and always know where to get the most updated information.

Public Correspondence:

We highly encourage written materials regarding Planning Commission Agenda items be submitted no later than 4:00 P.M. the Monday prior to a Planning Commission meeting to allow the Planning Commission Members ample time to review and consider the issues raised prior to making decisions at the Planning Commission meeting. Please keep in mind that it is difficult for Planning Commission Members to carefully review materials submitted after that deadline or at the meeting. Written materials, including emails, submitted to the city are public records and may be posted on the City's website. Accordingly, you may wish to omit personal information from your written materials or oral presentation as it may become part of the public record regarding an agenda item. In addition, City meetings may be televised and may be accessed through the City's website at www.rpvca.gov/agendas.

Public Participation:

Participants must speak from the podium using the lectern microphone; comments are to be directed to the Planning Commission and not to the staff or the public; repetition should be avoided; and reading a submission that has been copied or contained in the agenda will be discouraged. Virtual participation is also offered please visit www.rpvca.gov/participate.

Public Comments:

The Planning Commission may limit the public input on any item based on the number of people requesting to speak, the length of the agenda, or the business of the Planning Commission.

Conduct at the Planning Commission Meeting:

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force.(2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

Continuation of Meeting:

The Planning Commission will adjourn its meetings on or before 11:00 p.m. and will not consider new business items after 10:15 p.m., unless a majority of the Planning Commission members who are present affirmatively vote either to extend the meeting after 11:00 p.m. or to consider new business after 10:15 p.m. If the meeting ends before all items listed on the agenda are completed, any unfinished business will be continued to the next succeeding day that is not a holiday, at a location to be

determined.

Closed Session:

Please be advised that, pursuant to the Ralph M. Brown Act, “a person may not disclose confidential information that has been acquired by being present in a Closed Session . . . to a person not entitled to receive it, unless the legislative body authorizes disclosure of that confidential information.” (Gov. Code § 54963(a).) “[C]onfidential information’ means a communication made in a Closed Session that is specifically related to the basis for the legislative body of a local agency to meet lawfully in Closed Session . . .” (Gov. Code § 54963(a).) Please be further advised that any “violation of [Government Code § 54963] may be addressed by the use of such remedies as are currently available by law, including, but not limited to: (1) injunctive relief to prevent the disclosure of confidential information prohibited by this section; (2) disciplinary action against an [public or city official] who has willfully disclosed confidential information in violation of this section; (3) referral of a member of a legislative body who has willfully disclosed confidential information in violation of this section to a grand jury.” (Gov. Code § 54963(c).)
