## **LA Fleet Week Invites Public to the LA Waterfront to Celebrate Military Services over Memorial Day Weekend**

Southern California's premier celebration of the nation's sea services, [LA Fleet Week](https://www.lafleetweek.com), returns to Los Angeles with ship tours, neighborhood activations, and a massive public expo along the LA Waterfront at the Port of Los Angeles in San Pedro.

On the LA Waterfront, Fleet Week activities kick off with the annual Downtown San Pedro Welcome Party on Thursday evening, May 25. From May 26-29, visitors can enjoy free family-friendly festivities, including live music and entertainment, ship tours, aircraft flyovers, and exhibits from the Navy, Marine Corps, Coast Guard, and Army at the LA Fleet Week EXPO area alongside the Battleship IOWA Museum.



Visitors coming to San Pedro for Fleet Week activities are encouraged to come early in the day and find parking in and around the downtown San Pedro area, where they can walk to the EXPO. Due to security and traffic constraints, vehicles will not be permitted to travel past 22nd Street, and pedestrians will not be admitted into the ship tour area. They must be shuttled in from the EXPO area.

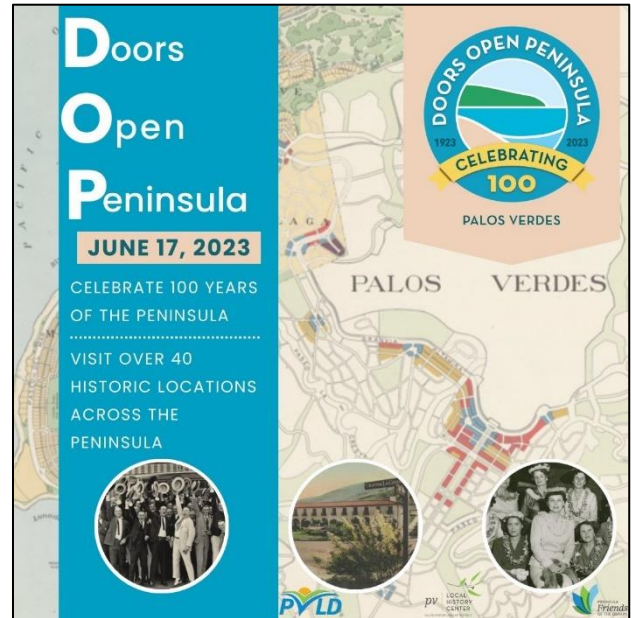

The four Peninsula cities and our public safety partners launched the **Know Your Zone** evacuation readiness website [PVPReady.gov](https://PVPReady.gov). With the aim to prepare Peninsula residents and businesses to evacuate in the event of an emergency, the site houses



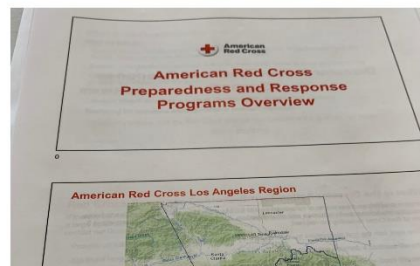
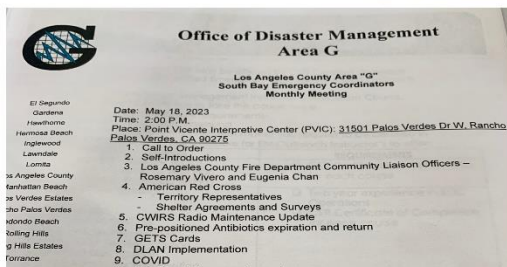
Zonehaven, a cloud-based evacuation platform with pre-established, Peninsula-wide evacuation zone maps. The zones will also help fire, police, and other emergency service agencies prepare for emergencies, streamline the evacuation process, and reduce confusion by enabling a single verified source of emergency information.

### **Why should you Know Your Zone?**

If authorities issue an evacuation order for your neighborhood during an emergency, you may only have minutes to act.

Knowing your zone and how to use the zone map at [PVPReady.gov](https://PVPReady.gov) ahead of time means you'll be the first to know when your zone is under evacuation.

## RPV-Hosted Area G Emergency Services Coordinator Meeting

On May 18, 2023, Rancho Palos Verdes hosted the monthly Area G Emergency Services Coordinator (ESC) meeting under the leadership of Disaster Management Area Coordinator (DMAC) Brandy Villanueva. Representatives from Area G cities, including El Segundo, Gardena, Hawthorne, and others, attended this meeting.

Originating from the national Civil Defense program activation during World War II, Disaster Management Area Coordinators (DMAC) were originally responsible for managing war-related activities, such as Air Raid Wardens, Coast Watchers, and Strategic Business Protection. Post-war, the role transitioned to strategizing against

nuclear threats, with emphasis on developing fallout shelters, stocking necessities, and training local emergency services. Over time, the emphasis shifted from war-oriented defense to disaster management in response to natural disasters and other emergencies.

Currently, eight Disaster Management Areas exist, each steered by a DMAC who plays a vital role in emergency management activities across cities, while also acting as a liaison between local, county, state, and federal agencies.

In this meeting, the American Red Cross presented on its shelter program and other services that it offers. ESCs also discussed potential training opportunities and shared updates on local mitigation initiatives and strategies. These meetings are essential for fostering regional preparedness and promoting best practices, common challenges discussion, and cooperative disaster management strategy development. We look forward to the continued sharing of knowledge and collaboration in future meetings.



## **Emergency Communication Planning**

You've prepared your emergency kit, but have you thought about how you'd get in touch with your family during or after a disaster? This is a step many overlook when preparing

for a disaster. We take it for granted that we can call loved ones on their cellphones. A month after Hurricane Katrina, there were still over 9,000 missing adults and 3,000 missing or separated children.

### **Print a Hard Copy of Contacts**

- Few of us have our loved ones' phone numbers memorized. If anything should happen to our phones, we'd have no way of calling them. Thus, on the most basic level, your emergency communication plan needs to include a backup contact list.

### **What contacts to include?**

- Phone numbers of family members and anyone else involved in your communication plan
- Work, school, childcare, etc. contact info
- Address of meeting places
- Local hospitals and police stations
- Resources like local emergency shelters
- Medical providers and other important services
- List of which channels will be broadcasting emergency info

### **Where to keep the hard copy?**

- Print out copies of the contacts. Ideally, you should laminate them, so they are waterproof, but this will make them harder to fold and fit in a wallet. Give everyone copies to keep in their wallets, purses, or school bags.

It's also good practice to have a backup copy anywhere you frequently go, such as at home, work, school, and in your car.

### **Create a Digital Copy of Documents**

- An emergency binder contains your emergency contact list and essential documents like your IDs, birth certificates, prescriptions, insurance info, etc. It also will include photos of your loved ones; heaven forbid you get separated, and you will have current photos to post on missing people boards.

### **Modes of Communication**

#### **Cellphones**

- You might first reach for your cellphone to get in touch with loved ones. After disasters, cellphone lines often become flooded in what's known as a mass call



event. The lines get tied up, and calls can't get through. Worse, emergency calls cannot get through because everyone is trying to check in on their loved ones.

#### Text Messaging

- Text messaging doesn't use as much network bandwidth as calling, so texts are more likely to go through even when the network is congested. Texting also won't tie up the network like calling, which is why FEMA recommends texts for communication.

#### **Tips:**

- Create a group text on your phone. Then you can send a message to everyone in your emergency contacts at once.
- Pack a portable solar power bank in your emergency kit to keep using your cell for emergency communications even with the power out.

#### Landlines

- Landlines use copper wires buried underground, making them less likely to be damaged during natural disasters than cellphone towers. They also don't require electricity to work. So, make sure you have landline numbers in your emergency contacts list.

#### **Tips:**

- Choose a corded landline phone. Cordless phones require electricity and won't work during power outages.
- If you have call forwarding on your landline, forward calls to your cell number during an emergency. This way, you will still get incoming calls, such as during an evacuation.

#### Social Media Messaging

- Social media and email are great ways to send bulk messages to friends and family during disasters. Just send one message or status report to everyone to let them know you are okay instead of wasting precious network space to call each individually.

#### **Tip:**

- Make sure you know your social media passwords if you need to access your profile from someone else's computer or phone.

#### Set Meeting Points

- The next part of your family communication plan is meeting points. These are the places where you will go if in danger or to reunite. Depending on the type of

emergency, you will need multiple meeting points.

- **Primary meeting point:** This will probably be your home.
- **Neighborhood meeting point:** This is where you will go if your home is unsafe, but the neighborhood is not affected.
- **City/town meeting point:** If you aren't at home when the disaster hits and can't get home, this is where you will go. It should be a safe location, preferably with a storm shelter and nearby places you attend frequently. For example, you might choose a hospital halfway between you and your spouse's workplace. Or you might choose your children's school as the meeting point.
- **Out-of-town meeting point:** This is where you will go if the entire region has become unsafe and you need to evacuate without your family. It might be a relative's home in the next city or state.

Lastly, it's important to **practice!** Do a communication plan drill to ensure everyone understands what to do. Go over the plan yearly and update contact information as needed.

## Public Safety and Emergency Management Presents at the Spring 2023 Cohort for the Leadership Academy

During the Spring 2023 RPV Leadership Academy (RPVLA), Emergency Services Coordinator Jesse Villalpando and Administrative Analyst Shaunna Hunter delivered a presentation on the City of Rancho Palos Verdes' public safety and emergency management programs. The cohort had the opportunity to learn about various initiatives, including the newly launched [Know Your Zone](#) website, the Pano AI wildfire camera program, and the [Alert SouthBay notification system](#). Additionally, they were given a firsthand experience of the Emergency Operations Center located at City Hall. Shaunna presented on the [Public Safety Reimbursement Program](#), highlighted the Regional Contract Law Committee, and shed light on the collaborative efforts between our City Staff and the Sheriff's Department to meet the law enforcement needs of our community.



Councilmember Alegria attended the presentation, expressing gratitude to the cohort for their active participation in the program. He also provided further details on the

recently approved Community and Safety Services Division two-year pilot program, which was discussed and authorized during the May 2, 2023 City Council meeting.

As part of their educational journey, the RPVLA cohort visited the Lomita Sheriff's Station and had the opportunity to engage with core deputies Russell and Lopez-Beltran. The cohort also visited the Nike missile silo and Battery Barnes bunker at the Ken Dyda Civic Center.

RPVLA serves as an excellent platform to familiarize oneself with local government operations. The program covers all City departments, including Administration, Public Safety, Recreation and Parks, Finance, Community Development, and Public Works. We invite everyone to join us for the next academy, scheduled for fall 2023.

Each week we will bring tips so you can get the most out of your summer while staying safe. With the Memorial Day holiday just around the corner, a quick reminder for those that will be traveling away from home for the day or the weekend.

### Safety Tip: Secure Doors & Windows

Your safety matters to us, and we want to help you create a secure environment for your home. Here's a valuable tip to enhance the security of your doors and windows:



1. Regularly check and reinforce the locks on all doors and windows. Make sure they are sturdy and in good working condition.
2. Consider installing deadbolt locks for added security. Deadbolts provide an extra layer of protection and are more resistant to forced entry.
3. Pay special attention to sliding doors. Ensure they have strong and reliable locks that cannot be easily bypassed. Alternatively, you can use a metal rod in the track to prevent forced entry.
4. Don't forget upstairs! Many break-ins occur on the second floor. Before you go, secure the second-floor windows and access points.

Remember, taking these simple steps can significantly deter potential intruders and provide you with peace of mind. Stay safe and secure!

consumer spending patterns and retail sales forecasts. Summaries of the notable articles linked to sales tax revenues are included below.

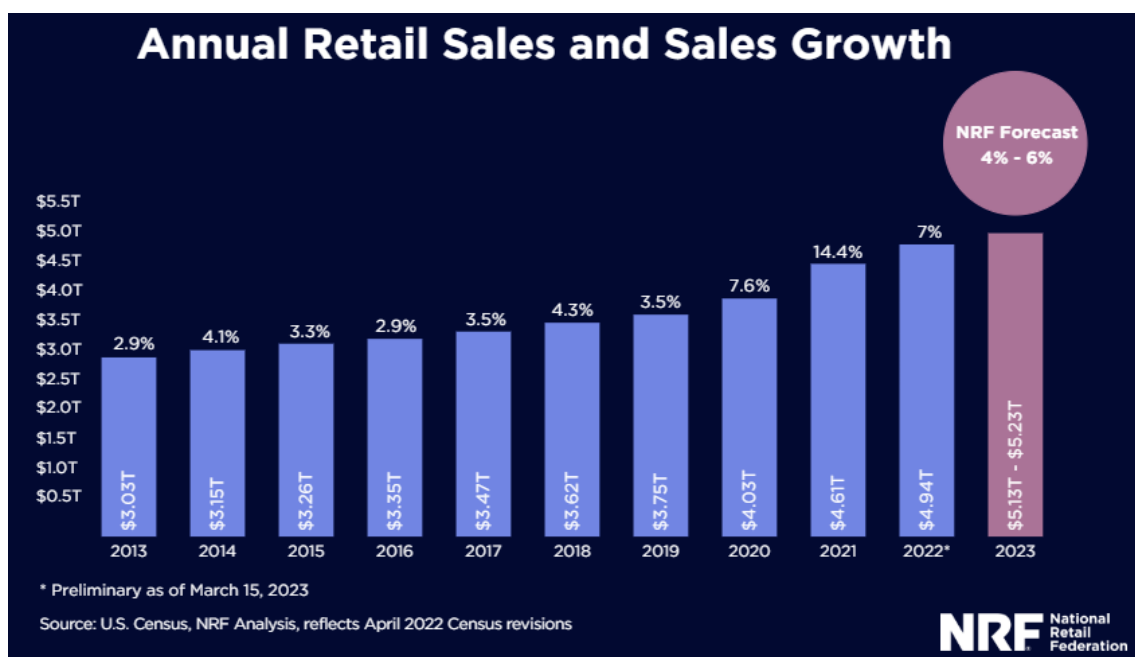
## U.S. Consumer Spending Flattens

U.S. consumer spending has remained relatively flat in recent months as increased spending on services has been offset by lower spending on goods. Stubbornly high inflation was underscored by other data showing labor costs increasing in the first quarter as a tight labor market drove wage gains in the private sector. Increased spending on services was driven by costs associated with housing and utilities, as well as healthcare. Spending on goods has declined based on fewer vehicle purchases and lower gasoline prices. Consumer spending also appears to be reaching a plateau as a growing number of individuals become more averse to high prices.

## NRF Forecasts 2023 Retail Sales to Grow Between 4% and 6%

The National Retail Federation (NRF) recently issued its annual forecast anticipating that retail sales will grow between 4% and 6% in 2023. Though optimistic, the NRF expects growth to moderate in the year ahead and remain positive as retail sales stabilize to more historical levels. It was also stated that retailers are prepared to offer a range of products at affordable prices to serve customers in the current economic climate.

### Ladera Linda Community Park Project Update

Last week, crews continued installing exterior insulation, interior drywall, and electrical wiring.

Additionally, crews continued installing storm drains in the middle tier, formed the curbs around the playground areas on the upper tier, placed rebar for the accessible ramp paving, and continued filling the bioswales with planting material. Crews began installation of fencing for the storage shed and began the application of the wall finish at the equipment and trash enclosure.

This week, crews are scheduled to place concrete for the accessible ramp and playground curbs and continue work on the building's exterior insulation, storm drains, bioswales, and fencing. Crews are also scheduled to begin installing tile in the restrooms.

The export of surplus soils will resume on May 30, and the import of base material for the parking lot pavement is scheduled to begin next week. Neighboring residents have been notified of these scheduled activities.

### **Levy of Annual Sanitary Sewer Service Charge (Abalone Cove Landslide Abatement District) for FY 2023-24**

The City Council will hold a public hearing on June 6 at 7 p.m. regarding the proposed levy of the sewer service charge for the Fiscal Year 2023-24. This meeting will be held in the City Council Chambers at Hesse Park, 29301 Hawthorne Boulevard.

The City Council has caused a written report to be prepared and filed with the City Clerk regarding the levy of the sewer service charge for FY 2023-24. This report contains a description of each parcel of real property in the Abalone Cove Landslide Abatement District connected to the sanitary sewer system and the proposed amount of the sewer service charge for each such parcel. The report computes the FY 2023-24 sewer service charge in conformity with Chapter 13.06 of the City's Municipal Code. For FY 2023-24, the proposed amount of the sewer service charge is proposed to be increased by 3.7% over the charge for last year on account of the annual increase in the Consumer Price Index.

All interested persons are invited to attend the public hearing and express opinions about the proposed levy of the sewer service charge for FY 2023-24 and the report. At the Public Hearing, the City Council will hear and consider all protests and objections against the report and all testimony regarding the proposed levy of the sewer service charge for Fiscal Year 2023-2024. ## National Public Works Week - May 21-27, 2023

**“Connecting the World Through Public Works”** is the theme for the 2023 National Public Works Week. The American Public Works Association (APWA) has defined public works as a “combination of physical assets, management practices, policies, and personnel necessary for the government to provide and sustain structures and services essential to the welfare and acceptable quality of life for its citizens.” The City of Rancho Palos Verdes, its residents, and stakeholders work together to create a **“connected”** community of which they can be proud.

The Public Works Department is responsible for the planning, engineering, construction, operation, and maintenance of the City’s transportation network, storm water system, sanitary sewer system, facilities and associated parks, and landslide monitoring and remediation. Additionally, Public Works is responsible for solid waste management, fuel modification, public street beautification and tree maintenance, and environmental sustainability programs. Public Works also provides permitting and inspection services for activities in the right-of-way. Finally, the Department coordinates utility services including gas, electricity, and water. More specifically, Public Works is responsible for the following:

- Transportation Network
  - Public streets (approximately 150 miles) with associated curbs and gutters, sidewalks, guardrails, and pavement markings
  - Traffic infrastructure including traffic signals (17), traffic signs (approximately 7,000), and streetlights (approximately 1,750)
  - Traffic engineering including traffic calming and congestion mitigation
  - Transit coordination
  - Permit parking programs

- Stormwater Program
  - Stormwater quality management program and compliance with federal and state requirements
  - 60 miles of storm sewer pipes (approximately)
  - 1,500 catch basins (approximately)
- Seven City facilities and parks
- Sanitary sewer collection for the Abalone Cove Sanitary Sewer District comprised of 270 households including approximately:
  - 4 lift stations
  - 125 manhole structures
  - 50 grinder pumps
  - 4 miles feet of gravity pipe
  - 4 miles feet of low-pressure pipe
  - 2,500 feet of force main
- Landslide monitoring and remediation
- Coordination of utility services for gas, electricity, water, and sanitary sewer collection outside of the Abalone Cove Sanitary Sewer District

- Fuel modification for approximately 300 acres of open space
- Public street landscaping and beautification
- Coastal bluff fence maintenance

- Permitting and inspection in the public right-of-way for utility work including Small Wireless Facilities
- City vehicle fleet maintenance
- Development and implementation of the City's Capital Improvement Program

## **The Goats are Here for Fuel Modification Season**



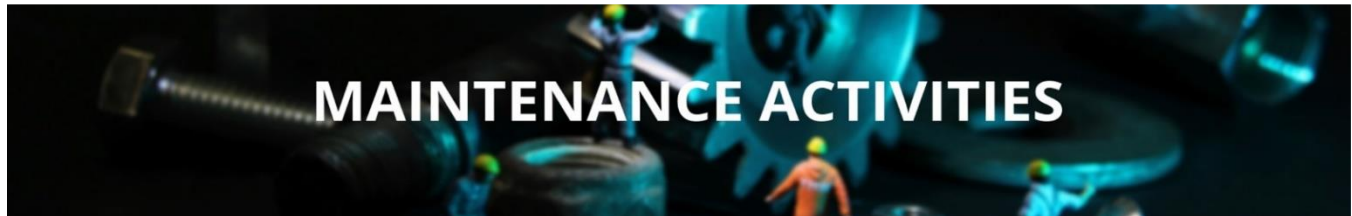
Goats are in the City to perform the important job of helping reduce fire loads and protect homes. Although we understand many people enjoy seeing the goats, please refrain from going to see them out of respect for residents living near where the goats work.

A temporary electrified fence is used to contain the goats while they are working, and attempting to approach them puts you as well as the goats at risk.



Please avoid attempting to take selfies/pictures or trying to touch the goats, especially if you have dogs or pets with you. This will prevent stress and/or injury to you and the goats.

In addition to the goats, you may see Stay Green crews performing brush clearance in various areas of the City as part of the City's 2023 fuel modification program.

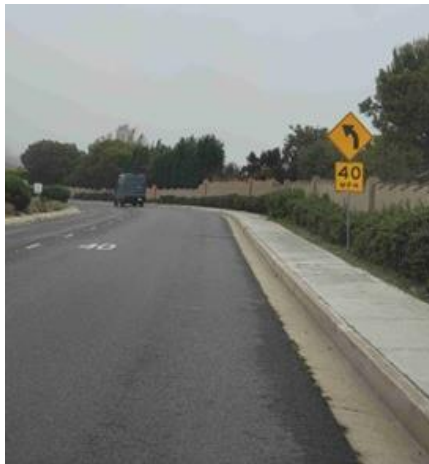

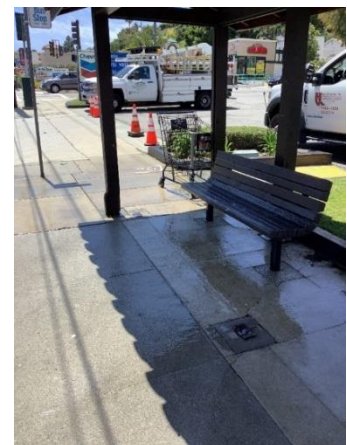

### May 17, 2023 LAX Community Noise Roundtable Meeting Summary

On May 17, 2023, the LAX Community Noise Roundtable held a regularly scheduled meeting to discuss a range of agenda items (attached) involving noise concerns caused by passenger jets arriving and departing from LAX (Los Angeles International Airport). Of particular importance to the Peninsula communities, the Federal Aviation Administration (FAA) provided a brief status update on the delayed implementation of two LAX departure procedures titled KYLOW and STHBY, between the hours of midnight and 6:30 a.m. As a reminder, on February 7, 2023, the City Council expressed concerns that these procedures would vector noisy aircraft closer to the Peninsula and sent an opposition letter to the FAA requesting changes. The FAA updated the Roundtable that FAA technicians are continuing the review of the City's and LAWA's departure procedure recommendations, and that the FAA will provide an update at a future Roundtable meeting.



During the meeting, LAWA staff also distributed passenger jet PV Peninsula overflight and altitude data for flights that occurred during March-April (attached). ## Illegal Signage Sweep

Over the weekend of May 20-21, the City's Code Enforcement Division canvassed the City as part of an effort to address illegal signage throughout the community. City Staff identified illegal signs placed in the public right-of-way, including but not limited to, center medians, sidewalks, street curbsides, and bike lanes. These illegally placed signs are a concern for public safety and the signs also detract from the aesthetics and quality of life in the area. The signage sweep resulted in the confiscation of several signs observed in violation of code provisions. The City's Code Enforcement Division will continue to conduct random sweeps in order to confiscate illegal signage. Confiscated signs can be retrieved from the Community Development Department located at City Hall, 30940 Hawthorne Blvd., RPV CA 90275, during normal business hours.

- **SIGNS MAY ONLY BE PLACED IN PARKWAYS.** In the absence of parkways, signs may be placed on unimproved public property within the right-of-way, provided the signs do not obstruct the passage of pedestrians or vehicles, and do not interfere with traffic visibility, and are a minimum of 2 feet from vehicular travel lanes.
- Signs are prohibited on street medians
- Only A-frame signs are permitted
- No flags, balloons, pennants or any other attachments are permitted
- Sign placement hours:
  - Signs may be placed on weekdays between 11 a.m. and 6 p.m.
  - Signs may be placed on weekends between 9 a.m. and 6 p.m.
  - **All signs shall be removed by 6 p.m. daily**

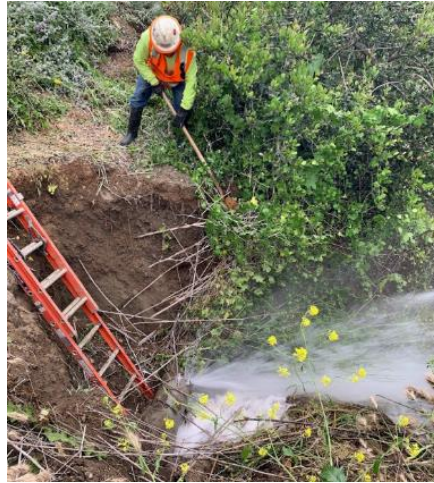

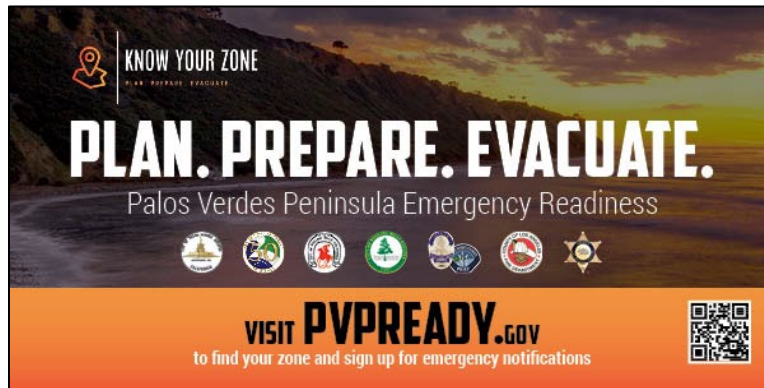

## Palos Verdes Peninsula Cities Launch 'Know Your Zone' Website PVPReady.gov During Wildfire Awareness Month

**May 8, 2023 (Palos Verdes Peninsula, Calif.)** — The four cities of the Palos Verdes Peninsula today launched the **Know Your Zone** evacuation readiness website [PVPReady.gov](https://PVPReady.gov). With the aim to prepare Peninsula residents and businesses to evacuate in the event of an emergency, the site houses Zonehaven, a cloud-based evacuation platform with pre-established, Peninsula-wide evacuation zone maps. The zones will also help fire, police and other emergency service agencies prepare for emergencies, streamline the evacuation process, and reduce confusion by enabling a single verified source of emergency information.

The **Know Your Zone** website is a collaboration between the cities of Palos Verdes Estates, Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, their public safety partners, the Los Angeles County Office of Emergency Services and Genasys-owned evacuation management software platform Zonehaven.

Residents, visitors, businesses, and school communities on the Peninsula should go to **PVPReady.gov** to find their evacuation zone, save it in their smartphone, or write it down and keep it somewhere that's easy to find in an emergency, such as on their refrigerator or near the front door. To find your zone, visit **PVPReady.gov**, click "Find Your Zone," enter an address in the search bar in the upper left corner of the [zone map](#), and a pop-up window will open with the corresponding zone and emergency information. During an emergency, such as a wildfire or flood, the website and corresponding alerts will show which zones are under evacuation the moment an order is issued by authorities.

The zone map bridges an important gap between first responders and the community, providing real-time information directly to residents as incidents unfold. The zone map incorporates hyperlocal knowledge to model evolving disasters and subsequent impacts on evacuation zones, traffic patterns, and public safety. **PVPReady.gov** and the alert systems each city utilizes to notify their communities will be updated with zone-specific information, including evacuation status, live incident updates, weather, road and traffic conditions, and other essential information.

In addition to incident-based information, **PVPReady.gov** provides important readiness resources to help you prepare yourself and your family for a disaster year-round. On the site, you can also sign up for [Alert SouthBay](#), an alert system providing timely, accurate emergency and warning notifications to the communities of the Palos Verdes Peninsula and greater South Bay region, depending on your subscription. Information on how to contact your respective city is also available as quick and easy access for website visitors.

As we mark Wildfire Preparedness Week in California and National Wildfire Awareness Month, the four Peninsula cities, in partnership with the L.A. County Fire Department, Sheriff's Department, and Palos Verdes Estates Police Department, encourage the entire community to **Know Your Zone** and get familiar with **PVPReady.gov**. In addition to home addresses, residents should know the zones of places they frequent, such as work, school, places of worship, or the homes of family and friends. No account, registration or app download is required for this easy-to-use platform, which provides critical information in multiple languages.

The L.A. County Office of Emergency Management is rolling out Zonehaven in coordination with local law enforcement, fire protection, and government agencies as a larger resource to high hazard-prone communities in the county. This platform has been utilized elsewhere in California during major wildfires and to support evacuations for active shooter and debris flow hazards across multiple jurisdictions.

"It's been 14 years since the Peninsula had a major wildfire. Knowing your zone and getting familiar with the zone map ahead of time will be critical to making sure you and your family are ready when it's time to evacuate," said L.A. County Fire Department Assistant Fire Chief Brian Bennett.

Michael White, Acting Captain of the Lomita Sheriff's Station, said having knowledge of your zone is highly valuable in the event of an evacuation. "Our deputies are trained and prepared to evacuate neighborhoods, if necessary. Education and knowledge are key factors for any emergency situation. Being prepared is extremely important, especially for such a serious matter. You can help us and help your community by being prepared. Be proactive, get to know your zone today."

"The Know Your Zone website will be an invaluable resource during an evacuation, but in a major emergency, cell phone and internet service may not be reliable," said Luke Hellinga, Acting Chief of the Palos Verdes Estates Police Department. "That's why you should also write down your zone and keep it somewhere that's easy to find when you may only have minutes to act."

**PVPReady.gov** will provide the Peninsula with a new tool for emergency preparedness, but it will take all of us to ensure we are ready for a disaster. In addition to knowing your zone, have a plan in place for your family or business, maintain an emergency kit with essential items, medications, and important documents, and always know where to get the most updated information.

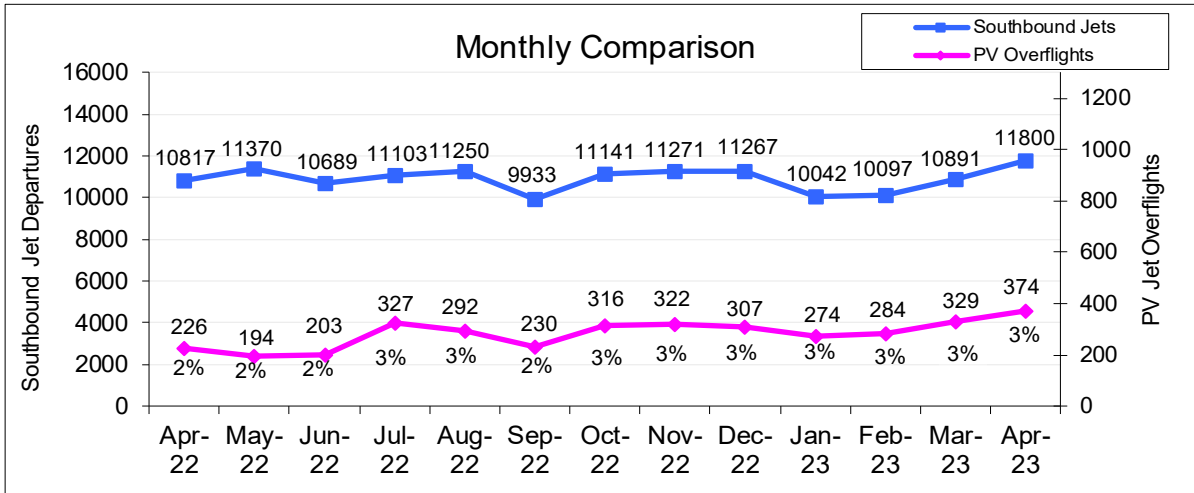
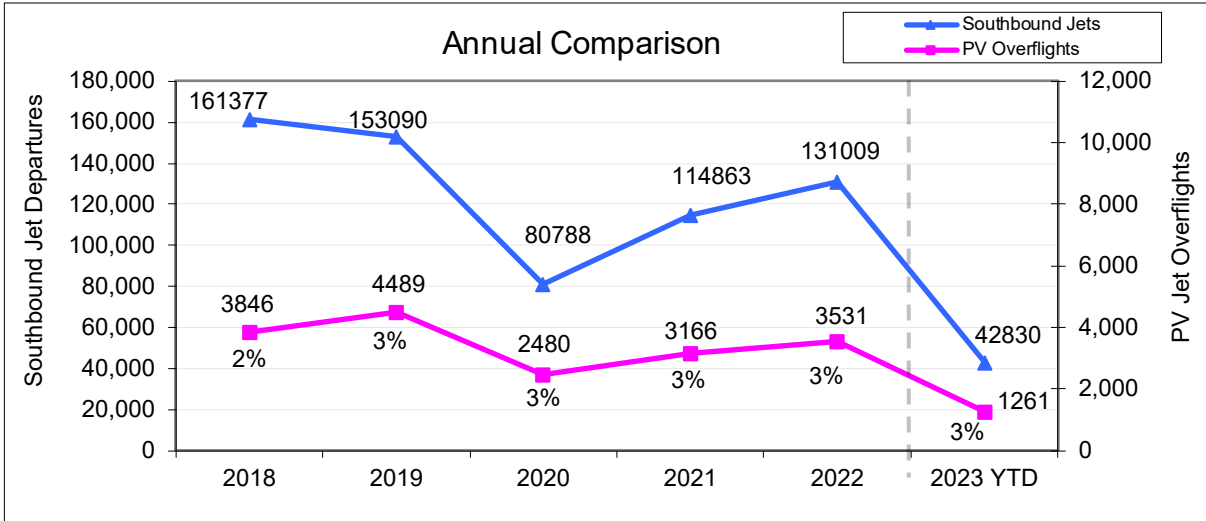
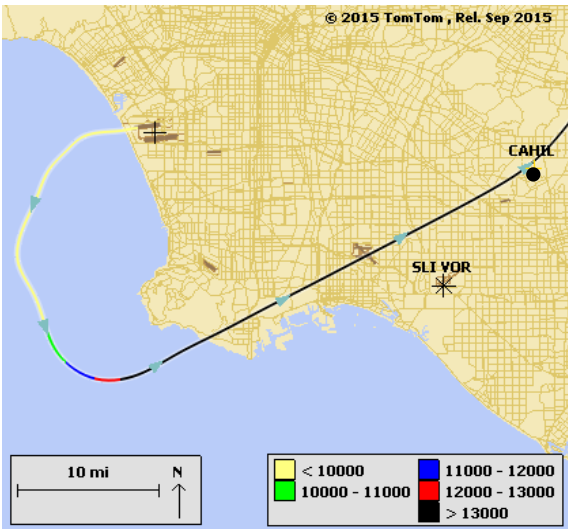

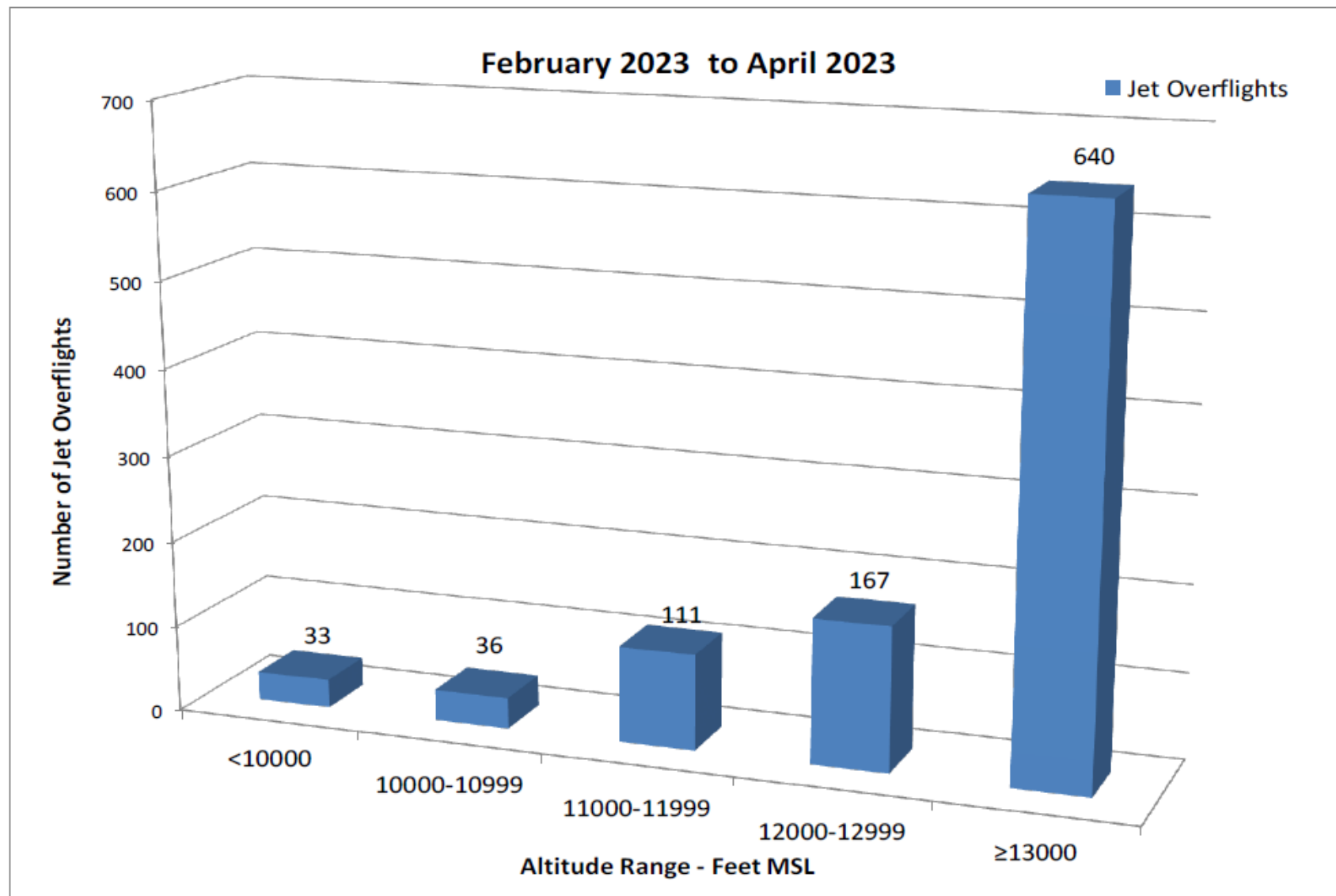
