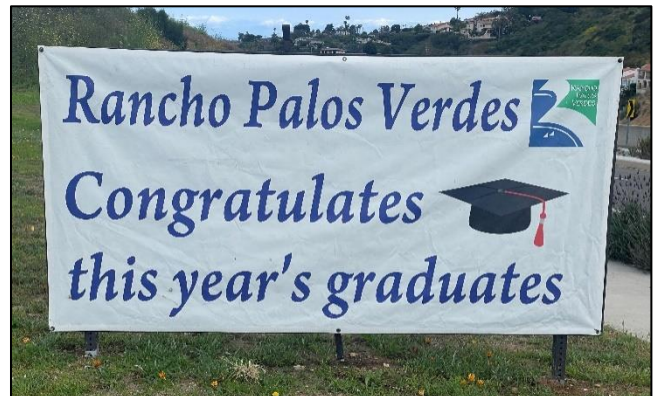

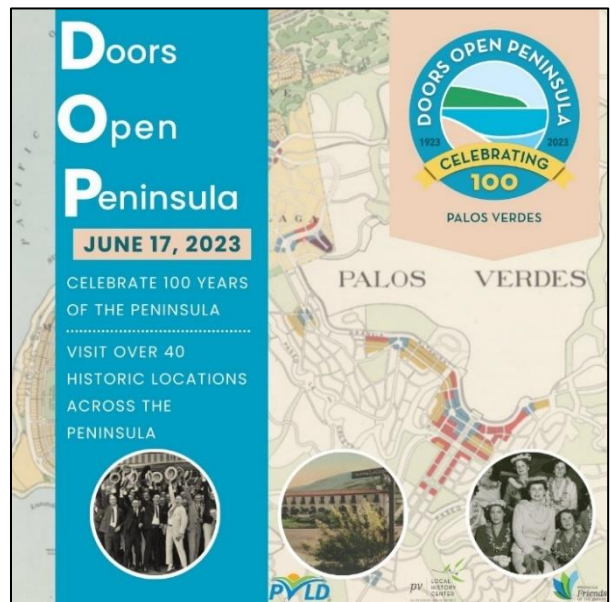

Tips for Finding Residential Fire Insurance in Response to Recent State Farm Announcement

City Staff is closely coordinating with the California Department of Insurance (CDI) following State Farm's recent [announcement](#) regarding the temporary suspension of new homeowners and certain commercial insurance policies in California. State Farm attributes this decision to factors beyond its control, such as climate change, global inflation, and rising reinsurance costs. However, it is important to note that existing State Farm customers should maintain their insurance coverage without disruption.

Amid these developments, the CDI is a valuable resource, providing support and guidance. Its ['Safer From Wildfires'](#) framework, developed in collaboration with Cal Fire and other state preparedness agencies, focuses on reducing costs and enhancing safety. It includes a new regulation requiring discounts for fire-hardened properties and communities. Homeowners can now obtain their property's "wildfire risk score" from insurance companies and appeal if necessary. For more information, refer to the official [press release](#).

If you are currently in search of home insurance, the CDI provides various tools on its website (www.insurance.ca.gov) to assist you in making informed decisions. These resources include [informational guides](#), a [premium comparison tool](#), and a [new coverage comparison tool](#) that allows you to compare policies from different insurers. Additionally, for those who have received nonrenewal notices from their insurers, the CDI has compiled a list of [Top Ten Tips for Locating Residential Insurance](#).

If you would like CDI to investigate a non-renewal notice or a premium increase, you can submit a Request for Assistance (RFA) through their website. The CDI will thoroughly review your specific situation and provide the necessary support. You can access the [RFA form](#) on CDI's website.

Palos Verdes Peninsula Cities Launch the 'Know Your Zone' Website PVPReady.gov During Wildfire Awareness Month

Earlier this month, the four Peninsula cities and our public safety partners launched the **Know Your Zone** evacuation readiness website [PVPReady.gov](https://pvpready.gov). With the aim to prepare Peninsula residents and businesses to evacuate in the event of an emergency, the site houses Zonehaven, a cloud-based evacuation platform with pre-established, Peninsula-wide evacuation zone maps.

The zones will also help fire, police, and other emergency service agencies prepare for emergencies, streamline the evacuation process, and reduce confusion by enabling a single verified source of emergency information.

Why should you Know Your Zone?

If authorities issue an evacuation order for your neighborhood during an emergency, you may only have minutes to act.

Knowing your zone and how to use the zone map at [PVPReady.gov](https://pvpready.gov) ahead of time means you'll be the first to know when your zone is under evacuation.

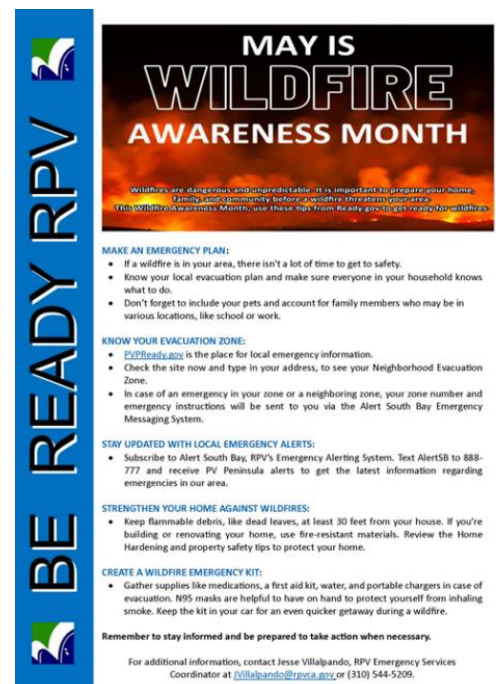

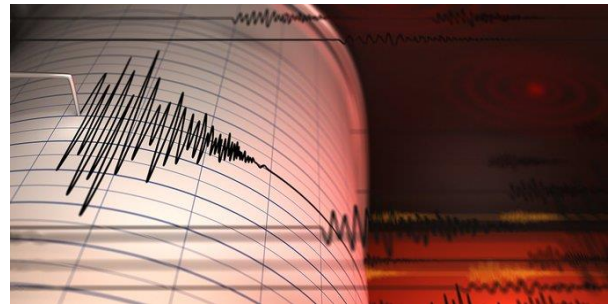

Are You Ready for the Next Big One? - Earthquake Preparedness Tips

Earthquakes can happen at any time, often with little to no warning. You could be anywhere when an earthquake strikes: at home, at work, at school, or even on vacation.



With Southern California deeply seated in "earthquake country," the City of Rancho Palos Verdes urges you and your family to always be prepared. The key to surviving an earthquake and reducing your risk of injury lies in planning, preparing, and practicing what you and your loved ones will do if it happens.

Here are a few tips on how to stay safe and prepared for the aftermath of a major earthquake.

PREPARE NOW

- [Secure items such as televisions and objects that hang on walls](#). Store heavy and breakable objects on low shelves.

- [Practice Drop, Cover, and Hold On](#) with family and coworkers. Drop to your hands and knees. Cover your head and neck with your arms. Crawl only as far as needed to reach cover from falling materials. Hold on to any sturdy furniture until the shaking stops.
- [Create a family emergency communication plan](#) that has an out-of-state contact. Plan where to meet if you get separated.
- [Make a supply kit that includes enough food and water for at least three days](#), a flashlight, a fire extinguisher, and a whistle. Consider each person's specific needs, including medication. Do not forget the needs of pets. Have extra batteries and charging devices for phones and other critical equipment.
- [Consider earthquake insurance policies](#). Standard homeowner's insurance does not cover earthquake damage. Consider a retrofit of your building if it has structural issues that make it vulnerable to collapse during an earthquake.

SURVIVE DURING

Drop, Cover, and Hold On. Drop to your hands and knees. Cover your head and neck with your arms. Hold on to any sturdy furniture until the shaking stops. Crawl only if you can reach better cover without going through an area with more debris.



DROP! Wherever you are, drop down to your hands and knees and hold onto something sturdy. If you are using a wheelchair or walker with a seat, make sure your wheels are locked and remain seated until the shaking stops.



COVER! Cover your head and neck with your arms. If a sturdy table or desk is nearby, crawl underneath it for shelter. If no shelter is nearby, crawl next to an interior wall (away from windows). Stay on your knees or bent over to protect vital organs.



HOLD ON! If you are under a table or desk, hold on with one hand and be ready to move with it if it moves. If seated and unable to drop to the floor, bend forward, cover your head with your arms and hold on to your neck with both hands.

- **IF YOU ARE INDOORS:** Stay there; do not run outside or inside your home since debris may fall and injure you. If able to do so, **DROP, COVER, and HOLD ON.**

- **IF YOU ARE IN BED:** Stay in bed and turn face down and cover your head and neck with a pillow.
- **IF YOU ARE IN A VEHICLE:** Pull over and stop in a safe area away from buildings, trees, overpasses, underpasses, or utility wires. Make sure to set the parking brake so that the vehicle does not move during the shaking. Stay inside your vehicle until the shaking subsides.
- **IF YOU ARE OUTDOORS:** Move away from wires, buildings, and anything else that could fall and hurt you, but only if you can safely do so. Otherwise, stay where you are and **DROP, COVER, and HOLD ON** if able to do so.

BE SAFE AFTER

- Expect aftershocks to follow the largest shock of an earthquake sequence.
- Check yourself for injury.
- If in a damaged building, go outside and quickly move away from the building.
- Do not enter damaged buildings.
- If you are trapped, send a text or bang on a pipe or wall. Cover your mouth for protection, and instead of shouting, use a whistle.
- If you are in an area that may experience tsunamis, go inland or to higher ground immediately after the shaking stops.
- Save phone calls for emergencies.
- Once safe, monitor local news reports via radio, television, social media, and cellphone text alerts for emergency information and instructions.

Better Together: Need a loaner Ring Camera?

The City of RPV offers a free in-home security camera rental program for its residents. This program allows residents to borrow a Ring Spotlight Cam and select accessories for up to 30 days. To participate in the program, RPV residents are required to follow these steps:

1. [Review and sign the Acknowledgment of Program Terms and Release of Liability](#):

You will need to read the terms and conditions of the program and sign the acknowledgment form, which can be found in a PDF format.

2. [Review and complete the Check Out Form](#): This form needs to be filled out with your personal information and details about the camera rental. It is also available in a PDF format.



3. Email PublicSafety@rpvca.gov to schedule a pick-up time at City Hall: Contact the provided email address to arrange a time to pick up the camera at RPV City Hall. Staff will provide you with further instructions and assistance.
4. Download the Ring app and set up your account: Prior to picking up the camera, make sure to download the Ring app on your smartphone or tablet. Follow the app's instructions to set up your account. Download the app on the App Store or Google Play.
5. Placement and return of the camera: The camera must be placed inside your home for monitoring purposes. It should be returned to City Hall within 30 days from the date of pickup. If you require an extension, contact PublicSafety@rpvca.gov before the end of the 30-day period.

Please note that to use the device, you will need to have Wi-Fi at your residence and a smartphone or tablet. Additionally, if you have any questions or need assistance with the camera, you can refer to Ring's Frequently Asked Questions for information and troubleshooting.

- Consideration and possible action to receive a report on the City's Annual Comprehensive Financial Report (ACFR).

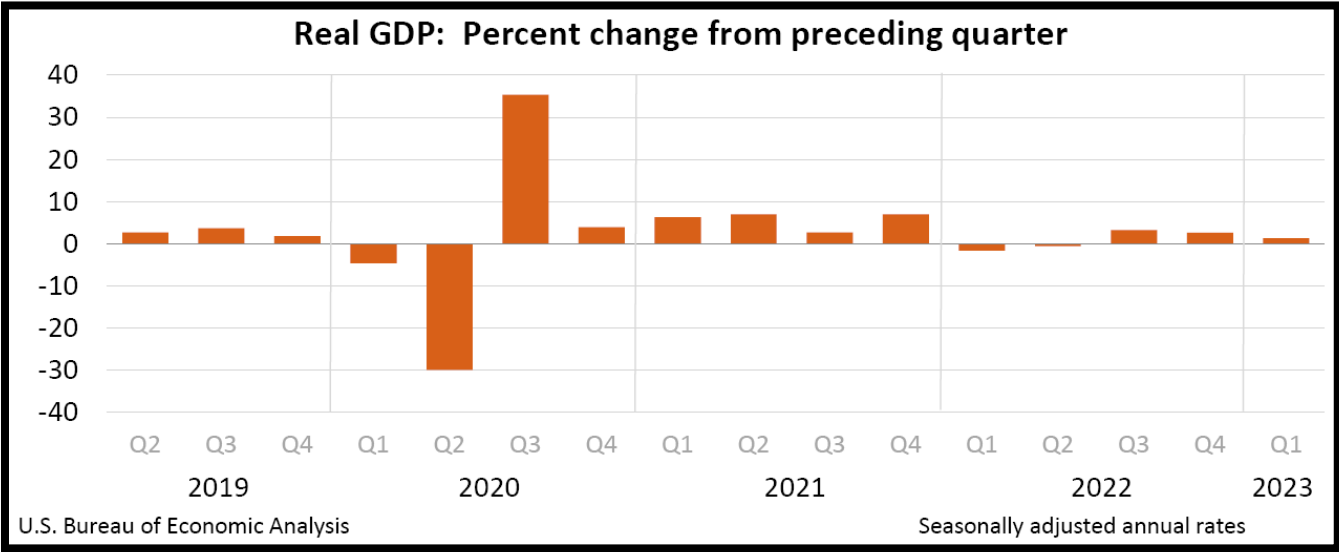

Gross Domestic Product (Second Estimate) – First Quarter 2023

On May 25, the Bureau of Economic Analysis released the second estimate of real gross domestic product (GDP) for the first quarter of 2023. Real GDP increased at an annual rate of 1.3%, according to the report. The latest estimate reflects a slight increase in GDP compared to the “advance” estimate of 1.1% issued last month and a slight decrease compared to the fourth quarter GDP rate of 2.6%. The chart below illustrates the percent change in GDP per quarter.



In summary, the growth in GDP is reflective of increases in consumer spending, exports, federal government spending, state and local government spending, and nonresidential fixed investment. However, GDP growth was partly offset by decreases in private inventory investment and residential fixed investment.

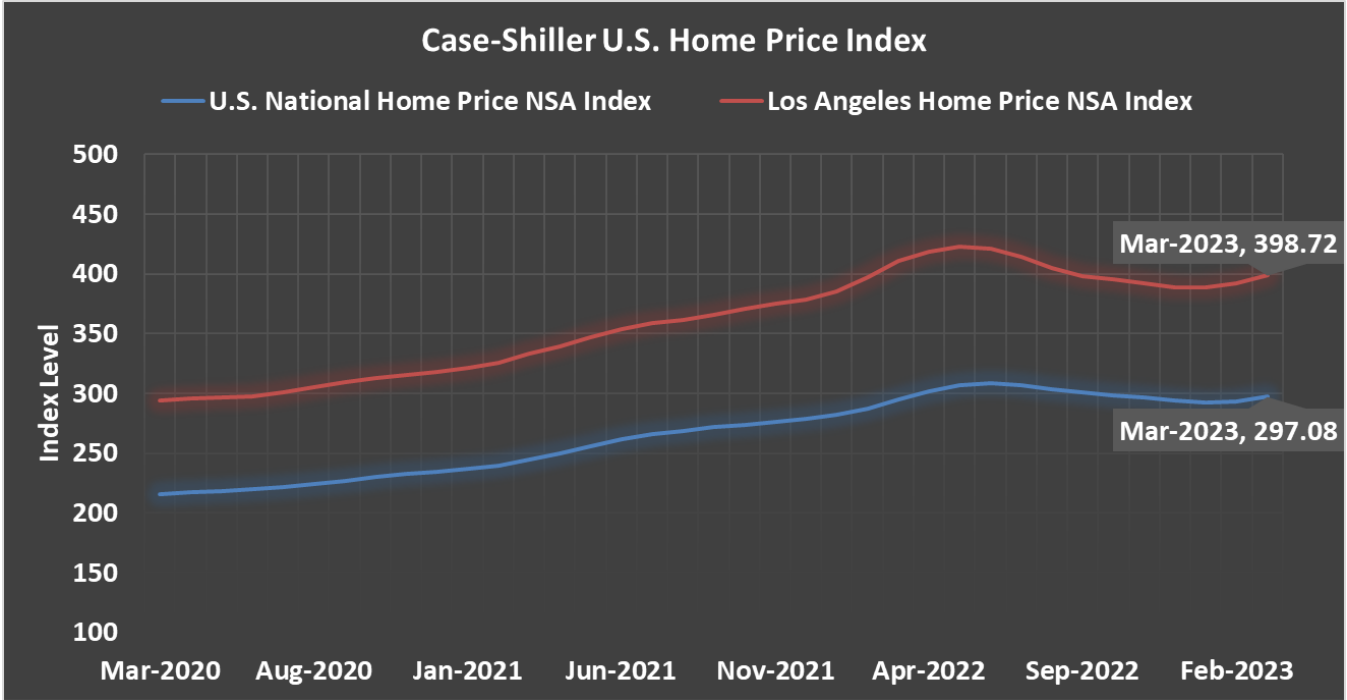
Home Price Index – December Decline

The S&P CoreLogic Case-Shiller Indices, the leading measure of U.S. home prices, released data for March 2023 showing a continuing recovery in housing prices in all major metro markets. Before seasonal adjustment, the U.S. National Index posted a 1.3% month-over-month increase in March, while the 10-City and 20-City Composites posted increases of 1.6% and 1.5%, respectively. After seasonal adjustment, the U.S. National Index posted a month-over-month increase of 0.4%, while the 10-City Composite gained 0.6% and 20-City Composites posted an increase of 0.5%.

The rise in prices observed nationally was also apparent at the local level. Before

seasonal adjustment, prices rose in all 20 major cities in March following the accelerated price gains observed between February and March. March’s results suggest that the decline in home prices that began in June 2022 may have come to an end. However, two months of price increases do not indicate a definite recovery. That said, the challenges posed by current mortgage rates and the continuing possibility of economic weakness are likely to remain a headwind for housing prices for at least the next several months.

Ladera Linda Community Park Project Update

Last week, crews continued installing exterior insulation and stucco finish for the building and began installing tile in the restrooms.

Additionally, crews set the catch basins in the bioswales and completed the installation of the curbs around the playground areas on the upper tier. Crews continued applying the plaster wall finish at the equipment and trash enclosure, cleared site weeds in preparation for landscaping work, and installed posts for the fencing around the storage shed.

This week, crews are scheduled to continue work on the bioswales, resume export of construction spoils, and begin placing base material for the asphalt driveway and parking lot. Crews are also scheduled to continue installing tile in the restrooms, installing the exterior insulation and stucco finish for the building, and begin trimming the vegetation at the existing fence along the ocean side of the park.

Levy of Annual Sanitary Sewer Service Charge (Abalone Cove Landslide Abatement District) for FY 2023-24

The City Council will hold a public hearing on June 6 at 7 p.m. regarding the proposed levy of the sewer service charge for the Fiscal Year 2023-24. This meeting will be held in the City Council Chambers at Hesse Park, 29301 Hawthorne Boulevard.

The City Council has caused a written report to be prepared and filed with the City Clerk regarding the levy of the sewer service charge for FY 2023-24. This report contains a description of each parcel of real property in the Abalone Cove Landslide Abatement District connected to the sanitary sewer system and the proposed amount of the sewer service charge for each such parcel. The report computes the FY 2023-24 sewer service charge in conformity with Chapter 13.06 of the City's Municipal Code. For FY 2023-24, the proposed amount of the sewer service charge is proposed to be increased by 3.7% over the charge for last year on account of the annual increase in the Consumer Price Index.

All interested persons are invited to attend the public hearing and express opinions about the proposed levy of the sewer service charge for FY 2023-24 and the report. At the public hearing, the City Council will hear and consider all protests and objections against the report and all testimony regarding the proposed levy of the sewer service charge for FY 2023-2024. The Goats are Here for Fuel Modification Season

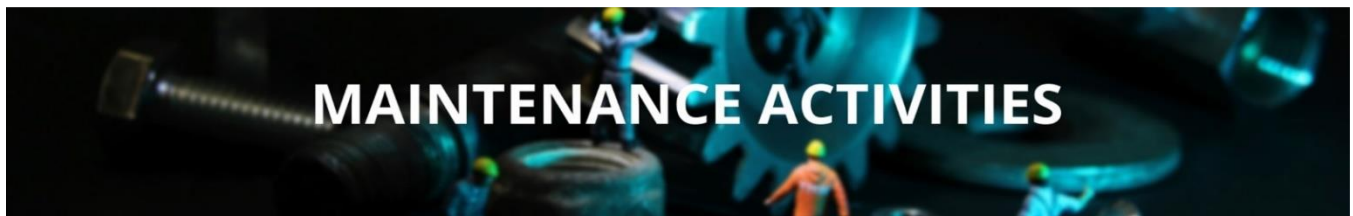


Goats are in the City to perform the important job of helping reduce fire loads and protect homes. Although we understand many people enjoy seeing the goats, please refrain from going to see them out of respect for residents living near where the goats work.

A temporary electrified fence is used to contain the goats while they are working, and attempting to approach them puts you as well as the goats at risk.

Please avoid attempting to take selfies/pictures or trying to touch the goats, especially if you have dogs or pets with you. This will prevent stress and/or injury to you and the goats.

In addition to the goats, you may see Stay Green crews performing brush clearance in various areas of the City as part of the City's 2023 fuel modification program.

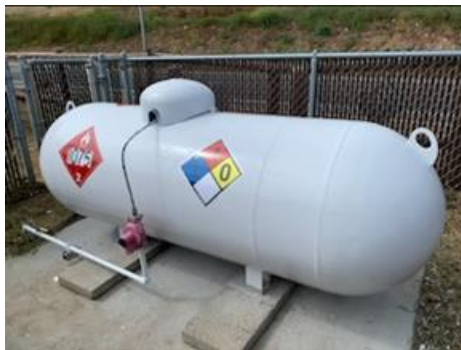


Maintenance Activities

Street Median and Public Right of Way Landscape Maintenance

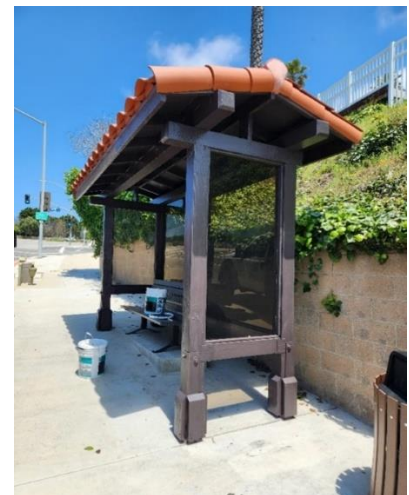
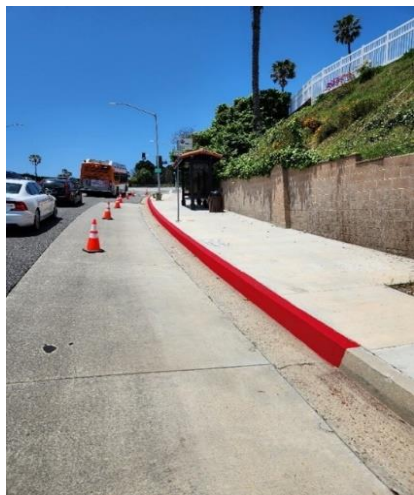
- Weed removal, brush clearance, and debris removal continued this week at the following median and right of way locations:
 - Granvia Altamira between Hawthorne Boulevard and Monero Drive.
 - Palos Verdes Drive West from Hawthorne Boulevard to the Palos Verdes Estates border.
 - 500 feet of vegetation along the right-of-way of Palos Verdes Drive West between Pelican Cove Park and the Point Vicente Interpretive Center.
- 400 feet of ruts were repaired on the Golden Cove Trail adjacent to Calle Entradero.

Public Right-of-Way/Roadway Repairs

- This past week, the roadway repair team removed and replaced approximately 300 feet of damaged guardrail. Areas included 100 feet along Palos Verdes Drive South near Narcissa Drive and another 200 feet along Palos Verdes Drive East near Headland Drive.
- Completed an asphalt patch in the roadway at 22 Narcissa Drive after City crews made a sewer pipe repair.
- The right-of-way team made repairs to Beach School Trail by filling in several fissures with sand, gravel, and filler material.
- Cleared broken glass from the roadway just north of City Hall on Hawthorne Boulevard.
- Repaired the following downed signs:
 - "Rough Road" sign was replaced on Palos Verdes Drive South at Portuguese Bend.
- The PW team refreshed the paint on the bus shelter on Hawthorne Boulevard at Dupre Drive and refreshed the red paint along the curb.



Graffiti Removal

- Forty-four cases of graffiti were reported and removed this week.

Building Permits Available Through eTRAKIT Online Portal

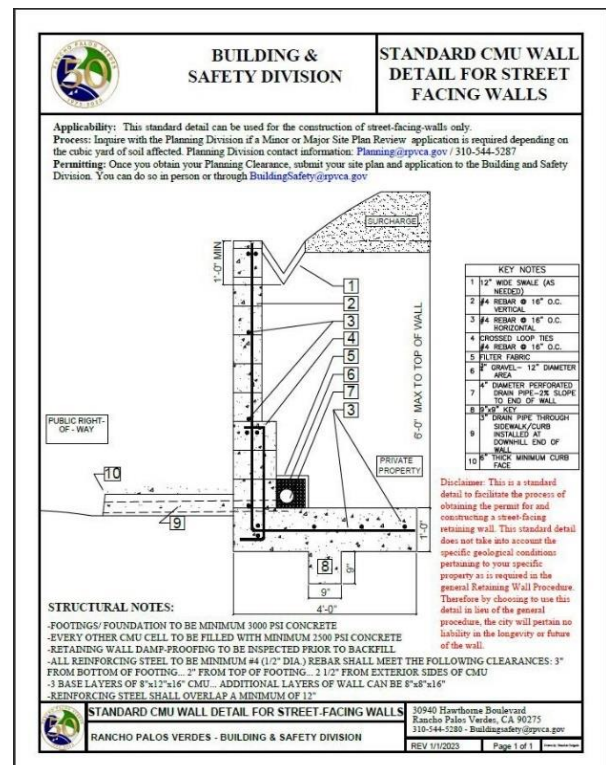
With eTRAKIT, a homeowner, developer, and contractor may apply and pay for a number of selected building permits online.



Permits available through this permit portal include, but are not limited to, electrical panel upgrades, water heater replacements, solar panel installations, and reroofing improvements. The permit portal also provides opportunities to schedule an inspection and review inspection results. Standard Detail Sheet for the Construction of Street-Facing Walls

The City's Building and Safety Division prepared a standard detail sheet to assist property owners in the repair and replacement of street-facing retaining walls. The detail sheet will be applicable to street-facing walls located along major corridors and thoroughfares throughout the City, including, but not limited to, Hawthorne Boulevard, Crenshaw Boulevard, and Silver Spur Road. 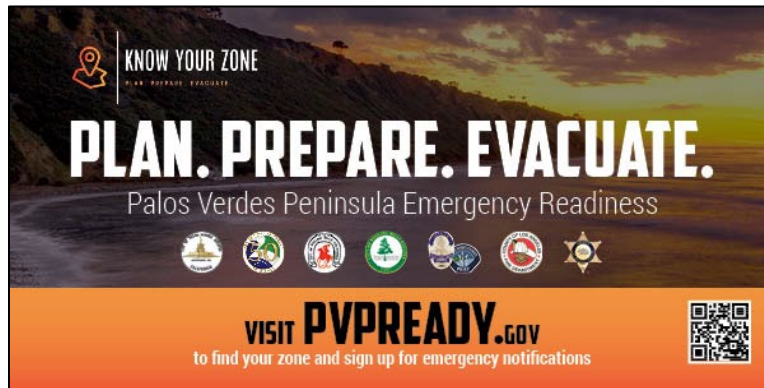

Palos Verdes Peninsula Cities Launch 'Know Your Zone' Website PVPReady.gov During Wildfire Awareness Month

May 8, 2023 (Palos Verdes Peninsula, Calif.) — The four cities of the Palos Verdes Peninsula today launched the **Know Your Zone** evacuation readiness website PVPReady.gov. With the aim to prepare Peninsula residents and businesses to evacuate in the event of an emergency, the site houses Zonehaven, a cloud-based evacuation platform with pre-established, Peninsula-wide evacuation zone maps. The zones will also help fire, police and other emergency service agencies prepare for emergencies, streamline the evacuation process, and reduce confusion by enabling a single verified source of emergency information.

The **Know Your Zone** website is a collaboration between the cities of Palos Verdes Estates, Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, their public safety partners, the Los Angeles County Office of Emergency Services and Genasys-owned evacuation management software platform Zonehaven.

Residents, visitors, businesses, and school communities on the Peninsula should go to **PVPReady.gov** to find their evacuation zone, save it in their smartphone, or write it down and keep it somewhere that's easy to find in an emergency, such as on their refrigerator or near the front door. To find your zone, visit **PVPReady.gov**, click "Find Your Zone," enter an address in the search bar in the upper left corner of the [zone map](#), and a pop-up window will open with the corresponding zone and emergency information. During an emergency, such as a wildfire or flood, the website and corresponding alerts will show which zones are under evacuation the moment an order is issued by authorities.

The zone map bridges an important gap between first responders and the community, providing real-time information directly to residents as incidents unfold. The zone map incorporates hyperlocal knowledge to model evolving disasters and subsequent impacts on evacuation zones, traffic patterns, and public safety. **PVPReady.gov** and the alert systems each city utilizes to notify their communities will be updated with zone-specific information, including evacuation status, live incident updates, weather, road and traffic conditions, and other essential information.

In addition to incident-based information, **PVPReady.gov** provides important readiness resources to help you prepare yourself and your family for a disaster year-round. On the site, you can also sign up for [Alert SouthBay](#), an alert system providing timely, accurate emergency and warning notifications to the communities of the Palos Verdes Peninsula and greater South Bay region, depending on your subscription. Information on how to contact your respective city is also available as quick and easy access for website visitors.

As we mark Wildfire Preparedness Week in California and National Wildfire Awareness Month, the four Peninsula cities, in partnership with the L.A. County Fire Department, Sheriff's Department, and Palos Verdes Estates Police Department, encourage the entire community to **Know Your Zone** and get familiar with **PVPReady.gov**. In addition to home addresses, residents should know the zones of places they frequent, such as work, school, places of worship, or the homes of family and friends. No account, registration or app download is required for this easy-to-use platform, which provides critical information in multiple languages.

The L.A. County Office of Emergency Management is rolling out Zonehaven in coordination with local law enforcement, fire protection, and government agencies as a larger resource to high hazard-prone communities in the county. This platform has been utilized elsewhere in California during major wildfires and to support evacuations for active shooter and debris flow hazards across multiple jurisdictions.

"It's been 14 years since the Peninsula had a major wildfire. Knowing your zone and getting familiar with the zone map ahead of time will be critical to making sure you and your family are ready when it's time to evacuate," said L.A. County Fire Department Assistant Fire Chief Brian Bennett.

Michael White, Acting Captain of the Lomita Sheriff's Station, said having knowledge of your zone is highly valuable in the event of an evacuation. "Our deputies are trained and prepared to evacuate neighborhoods, if necessary. Education and knowledge are key factors for any emergency situation. Being prepared is extremely important, especially for such a serious matter. You can help us and help your community by being prepared. Be proactive, get to know your zone today."

"The Know Your Zone website will be an invaluable resource during an evacuation, but in a major emergency, cell phone and internet service may not be reliable," said Luke Hellinga, Acting Chief of the Palos Verdes Estates Police Department. "That's why you should also write down your zone and keep it somewhere that's easy to find when you may only have minutes to act."

PVPReady.gov will provide the Peninsula with a new tool for emergency preparedness, but it will take all of us to ensure we are ready for a disaster. In addition to knowing your zone, have a plan in place for your family or business, maintain an emergency kit with essential items, medications, and important documents, and always know where to get the most updated information.
