
If you observe unusual cracks or difficulty in opening doors or windows, please contact the City immediately.

## Better Together: Etch and Catch Event

Los Angeles County Sheriff Department Lomita Station, in partnership with the cities of Rancho Palos Verdes, Rolling Hills, and Rolling Hills Estates, bring you a Catalytic Converter Etching Event at the Ken Dyda Civic Center, overflow parking lot. Enter the Civic Center off Hawthorne Blvd. and follow LASD Explorers and signs to the parking lot. No appointments are necessary. We will have three etching stations set up for a quick and safe process.

**Date:** July 29

**Time:** 9:00 a.m. – 1:00 p.m.

**Who:** Residents and Business Owners in the cities of Rancho Palos Verdes, Rolling Hills, and Rolling Hills Estates.

**Cost:** FREE

**What to Bring:**

- Vehicle with a Catalytic Converter
- Licensed driver, 18 years of age or older.
- Current vehicle registration, owner must be present.

**What to Expect:** Upon entering the Civic Center Property, follow LASD Explorer instructions to the overflow parking lot. LASD Deputies will check you in and verify your information, ask you to complete an indemnity form, and will guide you to the etching stations. You will remain in your vehicles while LASD personnel and City Staff assist you. The process should take 15 to 20 minutes to complete. Tow trucks will lift your vehicle so that your vehicle can be etched by the mechanics from Torrance Auto Repair. The mechanic will etch the last eight numbers of your Vehicle Identification Number (VIN) on your Catalytic Converter. Once the mechanics have etched your Catalytic Converter, your vehicle will be lowered, and you will exit the parking lot and proceed onto Hawthorne Blvd.

\*Please note, the Ranchos Caninos Dog Parks located at the Civic Center will be closed for this special event.

## **Beachgoers Advised to Avoid Sick Sea Lions**

Large algae blooms off the California coast are endangering marine mammals and making some seafood unsafe to eat, according to several Los Angeles County departments.

Domoic acid, a neurotoxin produced during these blooms, enters the food chain when plankton eat the toxic algae, and it becomes more concentrated as it moves up the food chain. In large quantities, it can cause seizures and heart failure. While sea lions and dolphins can become symptomatic after eating contaminated fish like sardines, contaminated shellfish pose the greatest threat to humans.

Already, more than 100 sea lions likely suffering from domoic acid toxicity have stranded themselves on Los Angeles County beaches—and it's likely that more will appear over the holiday weekend and Fourth of July.

Beachgoers should give sick sea lions at least 50 feet of space and immediately call the [Marine Mammal Care Center](#) (MMCC) at 800-39-WHALE (800-399-4253), according to the Los Angeles County Department of Animal Care and Control (DACC), which is supporting rescue efforts by coordinating resources. In Malibu, people should call the [California Wildlife Center](#) at 310-458-WILD (9453) and select option 1.

## PLAN. PREPARE. EVACUATE – Wildfire Preparedness

In collaboration with our public safety partners, the four Peninsula cities have launched an evacuation readiness website, [PVPReady.gov](https://PVPReady.gov). This platform is designed to efficiently equip Peninsula residents and businesses with the tools necessary to evacuate during emergencies. [PVPReady.gov](https://PVPReady.gov) incorporates a cloud-based evacuation platform. It offers pre-established, Peninsula-wide evacuation zone maps, thus providing a comprehensive source of verified emergency information. These zones benefit residents and aid fire,

police, and other emergency service agencies in their preparedness efforts, streamlining evacuation and reducing confusion during emergencies.

As Southern California enters its peak fire season, Peninsula residents must be vigilant and proactive. It's now more important than ever to prioritize wildfire prevention and preparedness.

To help safeguard your home and prepare your family, please consider the following recommendations:

- Visit [PVPReady.gov](https://www.pvpready.gov) to identify and memorize your zone. It's vital to #KnowYourZone before an emergency strikes. Save this information in your smartphone, write it down, and place it somewhere easily accessible, such as on your refrigerator or near your front door.
- Familiarize yourself with low-cost and no-cost measures to protect your home from wildfire using these tip sheets:

- Create an [evacuation plan](#) and regularly rehearse it with your family, ensuring everyone knows what to do and where to go during an emergency.
- Register for Alert SouthBay emergency notifications by texting "alertsb" to 888-777, visiting [alertsouthbay.com](https://alertsouthbay.com), or downloading the Everbridge app. These alerts will keep you informed during emergencies.
- In the event of an emergency, visit [PVPReady.gov](https://www.pvpready.gov) to check if your zone is under evacuation. Remember, cell phone and internet service may be unreliable during these times, so keep a battery-operated radio handy to access news updates.

**RPV EMERGENCY PREPAREDNESS COMMITTEE TIPS**

After an emergency, you may need to survive on your own for several days. Being prepared means having your own food, water and other supplies to last for several days. A disaster supplies kit is a collection of basic items your household may need in the event of an emergency.

Make sure your emergency kit is stocked with the items on the checklist below. Download a printable version to take with you to the store. Once you take a look at the basic items consider what unique needs your family might have, such as supplies for pets or seniors.

**Basic Disaster Supplies Kit**

To assemble your kit, store items in airtight plastic bags and put your entire disaster supplies kit in one or two easy-to-carry containers such as plastic bins, duffel bag, or backpack.

A basic emergency supply kit could include the following recommended items:

- Water (one gallon per person per day for several days, for drinking and sanitation)
- Food (at least a several-day supply of non-perishable food)
- Battery-powered or hand crank radio
- Flashlight with extra batteries
- First aid kit
- Whistle (to signal for help)
- Dust mask (to help filter contaminated air)
- Plastic sheeting and duct tape (to shelter in place)
- Moist towelettes, garbage bags and plastic ties (for personal sanitation)
- Wrench or pliers (to turn off utilities)
- Manual can opener (for food)
- Local maps
- Cell phone with chargers and a backup battery

**Additional Emergency Supplies**

Consider adding the following items to your emergency supply kit:

- Maps, soap, hand sanitizer, disinfecting wipes to disinfect surfaces
- Prescription medications and non-prescription medications such as pain relievers, anti-diarrhea medication, antacids or laxatives
- Prescription eyeglasses and contact lens solution
- Infant formula, bottles, diapers, wipes and diaper rash cream
- Pet food and extra water for your pet
- Cash or traveler's checks
- Important family documents such as copies of insurance policies, identification and bank account records saved electronically or in a waterproof, portable container
- Sleeping bag or warm blanket for each person
- Complete change of clothing appropriate and sturdy shoes
- Fire extinguisher
- Feminine supplies and personal hygiene items
- Mess kits, paper cups, plates, paper towels and plastic utensils
- Paper and pencil
- Books, games, puzzles or other activities for children



## Extreme Heat Safety Tips

Extreme heat is a period of high heat and humidity with temperatures above 90 degrees for at least two to three days. In extreme heat, your body works extra hard to maintain a normal temperature, which can lead to death. In fact, extreme heat is responsible for the highest number of annual deaths among all weather-related hazards.

With extreme heat forecasted for a large portion of Los Angeles County, the City reminds residents to take the following precautions to avoid heat-related illness, particularly among older adults, small children, outdoor workers, athletes, and those with a chronic medical condition who are particularly vulnerable to the negative health effects of extreme heat.

When experiencing hot temperatures, it's important to remember to: **Stay cool, Stay hydrated, and Stay informed.**

#### STAY COOL:

- **Wear Appropriate Clothing:** Choose lightweight, light-colored, loose-fitting clothing.
- **Stay Indoors:** Stay in an air-conditioned place as much as possible. If your home does not have air conditioning, go to a shopping mall or public library— even a few hours spent in air conditioning can help your body stay cooler when you go back into the heat.
- **Schedule Outdoor Activities Carefully:** Limit your outdoor activity to when it's coolest, like morning and evening hours. Rest often in shady areas so that your body has a chance to recover.
- **Pace Yourself:** Cut down on exercise during the heat. If you're not accustomed to working or exercising in a hot environment, start slowly and pick up the pace gradually. If exertion in the heat makes your heart pound and leaves you gasping for breath, STOP all activity. Get into a cool area or the shade, and rest, especially if you become lightheaded, confused, weak, or faint.

#### STAY HYDRATED:

- **Drink Plenty of Fluids:** Drink more fluids, regardless of how active you are. Don't wait until you're thirsty to drink.
- **Stay away from very sugary or alcoholic drinks**—these cause you to lose more body fluid. Also, avoid very cold drinks because they can cause stomach cramps.
- **Replace Salt and Minerals:** Heavy sweating removes salt and minerals from the body that need to be replaced. A sports drink can replace the salt and minerals you lose in sweat.



- **Keep Your Pets Hydrated:** Provide plenty of fresh water for your pets and keep the water in a shady area.

#### STAY INFORMED:

- **Check for Updates:** Monitor your local news for extreme heat alerts and learn about any cooling shelters in your area.
- **Know the Signs:** Learn the signs and symptoms of heat-related illnesses and how to treat them.
  - **HEAT CRAMPS**
    - **Signs:** Muscle pains or spasms in the stomach, arms, or legs.
    - **Actions:** Go to a cooler location. Remove excess clothing. Take sips of cool sports drinks with salt and sugar. Get medical help if cramps last more than an hour.
  - **HEAT EXHAUSTION**
    - **Signs:** Heavy sweating, paleness, muscle cramps, tiredness, weakness, dizziness, headache, nausea, vomiting, and fainting.
    - **Actions:** stop physical activity, move to an air-conditioned place, and lie down. Loosen or remove clothing. Take a cool bath. Take sips of cool sports drinks with salt and sugar. Get medical help if symptoms get worse or last more than an hour.
  - **HEATSTROKE**
    - **Signs:** Extremely high body temperature (above 103 degrees) taken orally; Red, hot and dry skin with no sweat; Rapid, strong pulse, dizziness, confusion, or unconsciousness.
    - **Actions:** Call 9-1-1 or get the person to a hospital immediately. Cool down with whatever methods are available until medical help arrives.

- Take cool showers or baths

- Drink more water than usual
- Don't wait until you're thirsty to hydrate
- Avoid alcohol or liquids containing large amounts of sugar
- Remind others to drink enough water throughout the day




## FINANCE DEPARTMENT

### Consumer Price Index – June 2023

#### Consumer Price Index (U.S.)

Nationally, the Consumer Price Index (CPI) rose by 0.2% in June on a seasonally adjusted basis. Compared annually, all items index (headline inflation) increased by 3.0% prior to seasonal adjustment. The index for all items less food and energy (core inflation) rose by 0.2% over the month, reflecting the smallest monthly increase to this index since August 2021. Core inflation rose by 4.8% over the last 12 months. Chart 1 illustrates the annual percent change in CPI for both categories through June 2023.

**Chart 1. U.S. 12-month Percent Change in CPI**




The shelter index was the largest contributor to the change in CPI and accounted for 70% of the increase. The food index increased by 0.1% in June, just below the previous months change of 0.2%. More specifically, the index for food at home remained unchanged in June. However, food away from home rose by 0.4% over the month. On an annual basis, the food index increased by 4.7% over the last year.

Energy prices rose 0.6% in June after falling 3.6% in May. The gasoline index, in

particular, increased by 1.0% over the month, following a 5.6-percent decrease previously. Other energy components were mixed in June, with electricity rising by 0.9% and fuel falling by 0.4%. Compared annually, the energy index fell by 16.7%.

Core inflation rose by 4.8% over the past year. The shelter index increased by 7.8% over the last year, accounting for more than two-thirds of the total increase in this category. Other indexes with notable increases over the last year include motor vehicle insurance (+16.9%), recreation (+4.3%), household furnishings and operations (+3.6%), and new vehicles (+4.1%). Chart 2 illustrates the annual change for several major categories.

**Consumer Price Index (Los Angeles)**

Prices in the Los Angeles area, as measured by CPI, were up by 0.5% in June. On an annual basis, the CPI is up 2.5% from a year ago. Core inflation also increased by 0.4% in June and grew by 4.0% on an annual basis. The June increase was influenced by higher prices for shelter in the area, similar to the results in May.


Food prices rose by 0.4%, with food at home rising by 0.5% and food away from home rising by 0.3% through June. Over the year, food prices remain 4.5% higher than prices from a year ago.

The energy index rose by 1.3% over the month primarily due to higher prices for gasoline, which rose by 1.1% in June. At the same time, energy prices in total have

decreased by 14.8% over the year, largely due to lower prices for gasoline which is down 22.8% year-over-year. Prices for natural gas service declined 24.9 percent annually, but electricity costs have grown by 9.6% during the past year.

An overview of the annual percentage change in CPI for the Los Angeles area is illustrated in Chart 3 below.

## PUBLIC WORKS DEPARTMENT

### Klondike Canyon Landslide Movement

Significant land movement has been observed in the Klondike Canyon Landslide area over the past several weeks, specifically at the intersection of Dauntless Drive and Exultant Drive. The movement caused significant damage to roadway approaches to the intersection. As a result, the roads in the immediate vicinity of the intersection are closed.

Public Works evaluated the area with a geotechnical engineer on multiple occasions and determined that there is no need for evacuations at this time.

Calwater is performing short-term work to increase the resilience of water infrastructure to land movement. That work is expected to be completed this week. Next week, Public Works will perform roadway repairs. Road closures will remain in effect until the roadway repairs are completed.

Slow land movement is expected to continue in the area. Public Works will be conducting detailed surveys over the next week to quantify the rate and direction of movement. Utilities will also be inspected for damage. This information will be used to determine possible steps that can be taken to reduce the rate of land movement and increase water and sewer infrastructure resiliency to land movement.





## Ladera Linda Community Park Project Update

Last week, construction crews continued installing interior drywall, continued assembling the aluminum framing for the exterior glazing for the building, and placed concrete for a portion of the walkway around the building.

This week, crews are scheduled to continue working on the exterior glazing for the building, interior drywall, final grading on the site, irrigation systems, and decomposed granite pathways. Crews are also scheduled to install the tile in the kitchenette area and resume work on the park entrance fencing.




## Rehabilitation of Silver Spur Road North of Hawthorne Boulevard

Crews have substantially completed rehabilitating Silver Spur Road north of Hawthorne Boulevard. Crews repaired and replaced the damaged sidewalk and curb, installed new ADA-compliant curb ramps, repaired areas of deteriorated asphalt, replaced the top layer of asphalt, and replaced pavement markings.

The project was completed ahead of schedule and under budget!

Public Works is very grateful for Palos Verdes Peninsula High School (PVPHS) staff who coordinated with the City to minimize impacts on school operations during construction. Summer school was not held at PVPHS this year, and sports activities were limited to practices only to facilitate construction.



## Western Avenue Beautification Project - Revised Council Meeting Date

The date for City Council consideration of the Western Avenue Beautification Project design concept has been rescheduled to the August 1, 2023 City Council meeting.

Staff have taken comments received at the Western Avenue Beautification Open House and from the community survey conducted in April 2023 and used them to prepare an updated design concept for the Western Avenue Beautification project. The updated design concept is based on the most popular layout, as evidenced by community input previously received, and it incorporates native trees and shrubs that are Caltrans

approved. The City Council will consider the updated design concept at their August 1, 2023 meeting.



### **Street Median and Public Right of Way Landscape Maintenance**

Public Works has nearly doubled landscape crew resources over the past several weeks and is continuing to work on acquiring additional landscape crews through various vendors to accelerate weed clearing. Public Works expects to continue to deploy additional resources in the coming weeks.

- Weed removal, brush clearance, and debris removal continued this week at the following median and right of way locations:
  - Crest Road East between Palos Verdes Drive East and Mira Catalina Elementary School.
  - Palos Verdes Drive South from Schooner Drive to city limits.
  - Palos Verdes Drive South from Abalone Cove to Hawthorne Boulevard.
  - Crenshaw Boulevard from Indian Peak Road to Crestridge Road.
  - Montemalaga Drive from Silver Spur Road to Grayslake Road.
  - Palos Verdes Drive East from the Rolling Hills Estates border to Rockinghorse Road.
  - Island View Drive from Ocean Crest Drive to the end of the cul-de-sac.
  - Peacock Ridge Road from Highridge Road to the end of the cul-de-sac.
  - Crest Road from the city gates of Rolling Hills to Crenshaw Boulevard.
  - Crenshaw Boulevard from Crest Road to Valley View Road.
- Next week, crews are expected to complete trimming and de-weeding at the following locations:
  - Palos Verdes Drive West and Silver Spur Road.





### **Public Right of Way/Roadway Repairs**

- Crews filled several potholes on Palos Verdes Drive South near the landslide area.
- Crews repaired sidewalk deviations at Sprucegrove Drive.
- Crews repaired down street signs at the following locations:
  - Stop sign at Palos Verdes Drive East and Via Subida.
  - "Keep right on median" sign at Hawthorne Boulevard and Via Capri.
- Repaired a damaged post along the guardrail on the switchbacks at Palos Verdes Drive East.
- Continued to refresh the paint at the bus stop shelters and red curbs on Hawthorne Boulevard, adjacent to Ryan Park.



## Graffiti Removal

- Fifty-five cases of graffiti were reported and removed this week.

### UCLA South Bay Update

Since UCLA's escrow closed earlier this year on the purchase of the previous California Marymount University property, City Staff have conducted regular meetings with UCLA representatives and have also been in communication with UCLA's new COO/CFOA and new Facilities Manager of the new UCLA South Bay site. The COO has provided City Staff with the following updates regarding UCLA's use of the site and property updates:



- Leadership Academy:
  - UCLA will hold a Leadership Academy on the first and third weekend of August, from Friday through Monday. Most of the programming will happen at the Villas in San Pedro; however, on August 8<sup>th</sup> and August 20<sup>th</sup>, some day and early evening programming will occur at the Rancho Palos Verdes site and will involve controlled levels of amplified sound.
  - The current understanding is that the Chancellor of UCLA will attend the first weekend.
- Campus Light Pole Banners:
  - UCLA started installing "UCLA South Bay" banners on existing poles in the RPV campus parking lot the morning of July 3, 2023. There are no banners proposed to be installed on the existing poles along the street.
- Street Signage:
  - UCLA staff is working with the City to order updated street signage to update the language from Marymount to UCLA South Bay.
  - UCLA staff is also working with the City of LA on updating the signage within their jurisdiction as well.
- Shrub Clearance:
  - Brush clearance adjacent to the properties on San Ramon Drive has recently been completed.

## ECO Gardener Workshop on July 22

The Water Replenishment District (WRD) will be hosting a sustainable landscape design workshop on July 22, 2023. The workshop is in coordination with the Lillian Kawasaki Eco Gardener Program and will be held at the Madrona Marsh Preserve located in the City of Torrance. The workshop will explore natural watershed design, which uses minimal resources and captures on-site rainfall. ## Parking Lot Maintenance and Compliance

Earlier this year, the City's Code Enforcement Division received complaints about the lack of parking lot maintenance at the shopping center located on the northeast corner of Hawthorne Blvd. and Granvia Altamira. Code Enforcement Division Staff worked diligently with property management to resurface (asphalt) the parking lot, including other minor property maintenance improvements. Overall, residents were grateful and pleased with the Code Enforcement Division's proactive approach in keeping the community safe and aesthetically improving the City's commercial corridors.



## Planning Division Monthly Activity Report


