August 15, 2023, City Council Meeting Highlights

Highlights from the August 15 City Council meeting:

- The Council voted to draft a letter to the state Legislature opposing ACA 10, a proposed ballot measure that would declare housing a fundamental right in California, which could impose legal obligations on cities.
- The Council decided to proceed with seeking the services of a development consultant to start a capital campaign to help fund major City projects, including a new Civic Center.
- The Council voted to move forward with final engineering plans for the Portuguese Bend Landslide Remediation Project while determining if modifications can be made to the project design based on public feedback on the Draft Environmental Impact Report (EIR). A Final EIR could be released in mid-2024.



The Know Your Zone website is a collaboration between the cities of Palos Verdes Estates, Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, their public safety partners, the Los Angeles County Office of Emergency Services and Genasys-owned evacuation management software platform Zonehaven.

Residents, visitors, businesses, and school communities on the Peninsula should go to PVPready.gov to find their evacuation zone, save it in their smartphone, or write it down and keep it somewhere that's easy to find in an emergency, such as on their refrigerator or near the front door.

To find your zone, visit PVPready.gov, click "Find Your Zone," enter an address in the search bar in the upper left corner of the [zone map](#), and a pop-up window will open with the corresponding zone and emergency information. During an emergency, such as a wildfire or flood, the website and corresponding alerts will show which zones are under evacuation the moment an order is issued by authorities.

Protecting Important Records During an Emergency

Most disasters happen in the blink of an eye. That is why it is important to take appropriate measures before they happen to ensure your family is fully prepared. One of those steps is ensuring you protect your important documents.

In the event of a disaster, such as a flood or fire, immediately evacuating your home is sometimes necessary. There may not be time to grab valuable possessions like documents, which, unfortunately, could be destroyed in the disaster. However, once the immediate danger passes, having your financial and medical records and important contact information will be crucial to help you start the recovery process quickly.

Taking time before a disaster strikes to safeguard these critical documents will give you peace of mind, ensure you have access to essential medical and Prescription information, and help you avoid additional stress during the difficult days following a disaster.

Emergency Alerts

Disaster can happen anytime, in any part of the country. When emergencies occur, public safety officials provide critical alerts and warnings to local communities. Through a variety of technologies, these organizations communicate critical information and occasionally order evacuations, allowing residents to take immediate action to stay safe.

This following is a summary of the different types of warning alerts available and how to receive them.

WIRELESS EMERGENCY ALERTS (WEAS):

Wireless Emergency Alerts (WEAs) are one of many ways public safety officials can quickly and effectively alert the public to serious emergencies. WEAs go directly to your cellphone and can be used to send out urgent alerts targeting certain geographic areas.

What you need to know about WEAs:

- WEAs can be sent by state and local public safety officials, the National Weather Service, the National Center for Missing and Exploited Children and the President of the United States.
- WEAs look like text messages but are designed to get your attention with a unique sound and vibration repeated twice.
- WEAs are no more than 360 characters and include the type and time of the alert, any action you should take and the agency issuing the alert.
- WEAs are not affected by network congestion and will not disrupt texts, calls or data sessions that are in progress.
- You are not charged for receiving WEAs and there is no need to subscribe.

EMERGENCY ALERT SYSTEM:

The Emergency Alert System (EAS) is a national public warning system that allows the president to address the American people within 10 minutes during a national emergency. The alerts are sent through broadcasters, satellite digital audio services, direct broadcast satellite providers, cable television systems and wireless cable systems.

The EAS may also be used by state and local authorities to deliver important emergency information such as weather information, imminent threats, AMBER alerts and local incident information targeted to specific areas. The president has sole responsibility for determining when the national-level EAS will be activated.

OPT-IN NOTIFICATION SYSTEMS:

Opt-in mass notification systems can vary by region but operate similarly in what reasons people are notified. Alerts received could be about extreme weather or natural disasters, road closures, missing people, or evacuations. These alerts are managed by the local agency that set them up.

Alert Southbay: Alert SouthBay is a multi-jurisdictional emergency notification system used by 14 South Bay cities – including Rancho Palos Verdes - to keep our communities informed about disasters and emergencies with uniform and expeditious alerts. Alert

SouthBay will act as the City's primary vehicle for emergency communication. Residents can sign up for Alert SouthBay by:

- Texting "alertsrb" to 888-777, which returns a link to register for Everbridge
- Registering online at alertsouthbay.com
- Downloading the free [Everbridge app](#) on an iOS or Android device from the [App Store](#) or [Google Play](#).





Consumer Price Index – July 2023

Consumer Price Index (U.S.)

Nationally, the Consumer Price Index (CPI) rose by 0.2% in July on a seasonally adjusted basis. Compared annually, the all items index (headline inflation) increased by 3.2% prior to seasonal adjustment. The index for all items less food and energy (core inflation) also rose by 0.2% over the month, the same increase as in June. Core inflation rose by 4.7% over the last 12 months and has remained above headline inflation since March 2023. Chart 1 further illustrates the annual percent change in CPI for both categories from January 2021 through July 2023.

Chart 1. U.S. 12-month Percent Change in CPI



The shelter index continues to be the largest contributor to the overall change in CPI and accounted for 90% of the monthly all items increase. The food index increased by 0.2% in July after rising by 0.1% in the previous month. Within the food index, prices for food at home increased by 0.3% over the month while food away from home rose by 0.2% in July. On an annual basis, the food index increased by 4.9% over the last year.



Energy prices rose by 0.1% over the month ending July after rising by 0.6% in June. Gasoline prices contributed to this rise and reflected a monthly increase of 0.2% over the period. Other energy components were mixed in July, with electricity falling by 0.7% and natural gas rising by 2%. Compared annually, the energy index fell by 12.5%.

Consumer Price Index (Los Angeles)

Prices in the Los Angeles area, as measured by CPI, were unchanged in July according to the Bureau of Labor Statistics. On an annual basis, however, prices in the area were up by 2.7% compared to a year ago. Core inflation experienced a monthly increase of 0.3% in July and rose by 3.4% annually. An overview of the annual percentage change in CPI for both major indexes in the Los Angeles area is illustrated in Chart 3 below.

Chart 3. Los Angeles Area: 12-month Percent Change in CPI



In summary, food prices advanced by 4.7% while energy prices fell by 8% in the Los Angeles area over the past 12 months. The fall in energy prices was largely due to lower prices for gasoline. Additionally, prices for shelter remain elevated locally as well as nationally, and contributed to annual increase in core inflation of 3.4%.

Repairs to the Landslide Area

Work on Palos Verdes Drive South to repair the asphalt roadway surface in the landslide was completed last week. The work addressed needed repairs in the “ski jump” area and near Wayfarers Chapel. Roadway inspection will continue on a regular basis to identify any additional repairs that may become necessary.

Ladera Linda Community Park Project Update

Last week, construction crews continued installing exterior tiles and the aluminum framing for the building’s exterior glazing system and began installing exterior metal paneling. Crews completed installing the parking lot and pathway lights, placed gravel for the maintenance driveway, and continued installing the irrigation systems and decomposed granite pathways.



This week, crews will continue installing the building’s exterior glazing system and exterior tiles, painting the interior, installing ceiling grids, and polishing the concrete floors. Crews are also scheduled to start surfacing the basketball court.





The Goats are Back!

Due to rain during this past spring, there has been significant vegetation regrowth in certain areas of the City, so you may see the goats around town again. Please be mindful that the goats are performing an important job of helping reduce fire loads to protect structures. Although we understand many people enjoy seeing the goats, please refrain from going to see them out of respect for residents living near where the goats work.



A temporary electrified fence is used to contain the goats while they are working, and attempting to approach them puts you as well as the goats at risk. 

Los Verdes Golf Course Netting Update

The Los Angeles County owned Los Verdes Golf Course recently constructed a series of poles along the south-westerly property line to accommodate the installation of golf ball netting. The improvements were installed adjacent to homes in the La Cresta Pointe and La Cresta neighborhoods in order to mitigate on-going issues of errant golf balls impacting nearby residences.

After hearing concerns from adjacent residents in the La Cresta HOA regarding the construction activities, further work on the installation of the netting has been paused. City Staff is currently working with L.A. County representatives to evaluate neighborhood concerns involving the height, placement and aesthetics of the poles. City Staff is actively working and in communication with residents and will continue to provide updates as more information is available. Six drive-through rain barrel pick-up events are scheduled on various Saturdays between September 23 – December 2 at locations throughout the WBMWD service area, including several events in the South Bay area. The WBMWD will give away a total of 1,500 barrels this fall.

Upcoming Housing Rights Workshop

The City of Rancho Palos Verdes contracts with the Housing Rights Center (HRC) for fair housing services. The HRC's goal is to actively support and promote freedom of residence through education, advocacy, and litigation, to the end that all persons have the opportunity to secure the housing they desire and can afford, without regard to their race, color, religion, gender, sexual orientation, national origin, familial status, marital status, disability, ancestry, age, source of income or other characteristics protected by law.



As part of this effort, the HRC conducts various educational workshops and events in the community to help tenants, property owners, non-profit or public representatives learn about fair housing laws, illegal housing practices and landlord-tenant responsibilities. Virtual educational workshops are tentatively scheduled for this fall including an upcoming workshop on September 7. Carbon Monoxide Alarm Preparedness

Carbon monoxide alarms are designed to provide warning of any unusual build-up of carbon monoxide in a home. Higher levels of carbon monoxide may occur from improperly maintained, installed or used fuel-burning appliances, back-drafting appliances or fireplaces, or idling cars in garages. Carbon monoxide alarms are required for existing buildings and new construction, where the two conditions exist:



- 1) The dwelling unit contains a fuel-fired appliance or fireplace.
- 2) The dwelling unit has an attached garage with an opening that communicates with the dwelling unit.

Dear Senator Portantino,

I am writing on behalf of the City of Rancho Palos Verdes to express our strong opposition to Assembly Bill 309, introduced by Assemblymember Lee. We believe that while AB 309 aims to address important housing challenges in California, it raises significant concerns that warrant careful consideration and amendments.

Rancho Palos Verdes is dedicated to promoting housing affordability and addressing homelessness within our community and across the state. We are actively engaged in robust public input processes and adhere to state housing laws to develop comprehensive plans and zoning regulations for new projects.

Our primary opposition to AB 309 revolves around the establishment of the Social Housing Program within the Department of General Services (DGS) and the provision to grant DGS the authority to make land use and zoning decisions on state excess property. This approach could potentially bypass the state-mandated planning process and local zoning regulations, which have been thoughtfully developed with community involvement. This practice would undermine the efforts of cities like Rancho Palos Verdes in crafting tailored housing solutions that align with the unique needs and character of our community.

While we understand that AB 309 currently limits DGS authority to three housing projects on declared excess state property suitable for housing, we remain apprehensive about the future expansion of this program to include all state-owned lands. This expansion could further diminish local control and disrupt the well-established planning efforts of cities throughout the state.

Considering our concerns, we kindly request that AB 309 be amended to address these issues. We propose a collaborative approach between the state and local governments, where DGS works in cooperation with cities to identify appropriate sites for social housing projects. This approach would foster greater alignment with local planning efforts and ensure that the needs and preferences of each community are appropriately considered.

Additionally, we continue to urge the Governor and lawmakers to allocate annual investments of \$3 billion to support cities in preventing and reducing homelessness, as well as encouraging affordable

housing development. This ongoing funding commitment is crucial to enable cities like ours to implement community-based solutions that cater to the housing needs of residents across all income levels, thereby fostering a more inclusive and sustainable housing landscape.

For the reasons mentioned above, the City of Rancho Palos Verdes opposes AB 309 in its current form unless the necessary amendments are made to address our concerns and preserve local planning authority.

Thank you for taking the time to consider our position on this matter. We are willing to engage in further discussions and collaborate to find common ground that advances housing affordability and homelessness solutions in California.

Public Participation:

Participants must speak from the podium using the lectern microphone; comments are to be directed to the Planning Commission and not to the staff or the public; repetition should be avoided; and reading a submission that has been copied or contained in the agenda will be discouraged. Public Comments:

The Planning Commission may limit the public input on any item based on the number of people requesting to speak, the length of the agenda, or the business of the Planning Commission.

Conduct at the Planning Commission Meeting:

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force.(2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

Continuation of Meeting:

The Planning Commission will adjourn its meetings on or before 11:00 p.m. and will not consider new business items after 10:15 p.m., unless a majority of the Planning Commission members who are present affirmatively vote either to extend the meeting after 11:00 p.m. or to consider new business after 10:15 p.m. If the meeting ends before all items listed on the agenda are completed, any unfinished business will be continued to the next succeeding day that is not a holiday, at a location to be determined.

Closed Session:

Please be advised that, pursuant to the Ralph M. Brown Act, “a person may not disclose confidential information that has been acquired by being present in a Closed Session . . . to a person not entitled to receive it, unless the legislative body authorizes disclosure of that confidential information.” (Gov. Code § 54963(a).) “[C]onfidential information” means a communication made in a Closed Session that is specifically related to the basis for the legislative body of a local agency to meet lawfully in Closed Session . . .” (Gov. Code § 54963(a).) Please be further advised that any “violation of [Government Code § 54963] may be addressed by the use of such remedies as are currently available by law, including, but not limited to: (1) injunctive relief to prevent the disclosure of confidential information prohibited by this section; (2) disciplinary action against an [public or city official] who has willfully disclosed confidential information in violation of this section; (3) referral of a member of a legislative body who has willfully disclosed confidential information in violation of this section to a grand jury.” (Gov. Code § 54963(c).)
