## CITY MANAGER'S OFFICE

### RPV Awarded \$23.33 Million FEMA Grant for Portuguese Bend Landslide Remediation Project

The City of Rancho Palos Verdes is honored and grateful to be selected as a recipient of \$23.33 million from FEMA's Building Resilient Infrastructure and Communities (BRIC) grant program to slow the Portuguese Bend Landslide, one of the largest continuously active landslides in the U.S. This is the [largest grant award](#) ever secured by the City (see attached press release).

The City was named a recipient on August 28, 2023, when [FEMA announced nearly \\$3 billion](#) in awards to help communities across the country build resilience against extreme weather events and proactively reduce natural hazard risks, including \$1.8 billion in BRIC program awards. This funding for the proposed Portuguese Bend Landslide Remediation Project will help make it possible for the City to drastically reduce land movement in the 240-acre landslide, which has significantly damaged homes, utilities, and infrastructure for nearly seven decades. To complete the estimated \$33 million project, the City will work to identify funding opportunities for about \$10 million needed in non-federal matching funds.

In addition to FEMA, the City thanks Cal OES, Hagerty Consulting, Hout Engineering, and Lisa Scola of Scola & Associates for their work on the City's grant application. We also thank elected representatives who have lent their support to the City's efforts to address the landslide, including U.S. Sen. Dianne Feinstein, Rep. Ted Lieu., California Sen. Ben Allen, Assemblymember Al Muratsuchi, California Sen. Steven Bradford, L.A. County Supervisor Janice Hahn, and L.A. County Assessor Jeff Prang, as well as neighboring agencies on the Peninsula.



First, a support position letter for SB 244 (Eggman) Right to Repair Act. Second, an opposition (unless amended) to ACA 10 (Haney) Assembly Constitutional Amendment Fundamental Right to Housing. 

Summer Is Here!  
Are You Ready for the Heat?

Summer is here and the temperatures are going up. It's that time to keep in mind the effects of warmer temperatures and take appropriate precautions to protect your health and safety. Each year approximately 20 people die from heat-related emergencies and countless others visit emergency rooms with heat-related issues. Use these tips to help keep your cool this summer.

The National Weather Service issues a number of Watches, Warnings, and other products to alert the public about severe weather events. Be prepared for severe weather by educating yourself on the differences between Warnings, Watches, and Advisories and how the warning process works. See [Watches, Warnings, or Advisories](#) from the National Weather Service.

Beat the heat this summer by:

1. Drinking plenty of fluids. Don't wait until you're thirsty.
2. Never leave infants, children, or the frail elderly unattended in a parked car.
3. Dressing in lightweight, loose-fitting clothing. Use a hat and sunscreen as needed.
4. During the hottest parts of the day, keep physical activities to a minimum and stay indoors in air-conditioning and out of the sun.
5. Open windows in the early mornings to allow the fresh cooler air to circulate when appropriate.
6. Use fans as needed. They cost less to run than Air Conditioning.

7. Signup for Emergency Alerts

## Extreme Heat Returns to Southern California This Week

As another reminder that summer is not over yet, triple-digit temperatures remain possible across significant portions of California through Wednesday. Residents are urged to stay safe and take extreme heat seriously. As of 8 a.m. on August 29, the National Weather Services has active Heat Advisories in eight counties and Excessive Heat Warnings in six counties.



- **Heat Advisories**: Lowest level of warning for heat, alerting that it will be warmer than usual.
- **Excessive Heat Warnings**: Highest level of warning for heat, with at least major heat-related impacts expected.

For an up-to-date list of counties affected by weather advisories, visit the [NWS website](#).

### DURING A HEAT EVENT:

- Avoid strenuous activity and direct exposure to the sun during the hottest parts of the day, specifically from 12 – 6 p.m.
- Stay hydrated, and don't wait until you're thirsty to drink water.
- Protect your skin using sunscreen with SPF 30 or above.
- Wear lightweight, loose-fitting clothing.
- Ensure your pets have plenty of cool, fresh water.
- NEVER leave children or pets in the car. Even when temperatures outside are mild, the temperature inside the car can reach 100 degrees in less than 10 minutes.
- If you do not have access to air conditioning, find a [public cooling center](#) near you.

### HEAT-RELATED ILLNESS:

Extreme heat poses a substantial health risk, especially for vulnerable populations. It's important to understand the warning signs of heat-related illness. Symptoms include:

- Heavy sweating

- Muscle cramps
- Weakness
- Headache
- Nausea

Vomiting, paleness, tiredness, and dizziness can also be indicators of heat-related illness. To help prevent heat-related illness, be sure to use cool compresses, misting, showers, and baths. Get medical attention if you experience a rapid, strong pulse, you feel delirious or have a body temperature above 102 degrees.

## STAY SAFE IN EXTREME HEAT



### Watch for Signs of Heat Illness

In the summer, multiple days and nights of hot weather can be very dangerous. Getting too hot can make people sick. California Department of Health recommends learning the signs and how to help someone with heat illness:

- **Heat stroke:** red, hot, dry skin; very high body temperature; dizziness; nausea; confusion, strange behavior, or unconsciousness; rapid pulse or throbbing headache. Call 9 - 1 - 1.
- **Heat exhaustion:** heavy sweating, cramps, headache, nausea or vomiting, tiredness, weakness, dizziness and fainting. Move to a cool place and get medical help if vomiting or symptoms get worse or last longer than 1 hour.



### Keep Cool

When temperatures are very high, make sure to:

- Stay hydrated. Don't wait until you are thirsty to drink.
- Wear loose, lightweight, light-colored clothing and a hat outdoors.
- Wear sunscreen and avoid too much sun.
- Slow down and avoid exercise during the hottest parts of the day.

Stay in air-conditioned buildings as much as possible. If your home doesn't have air conditioning or if there was a power outage, find a public place you can go to get out of the heat:

- Libraries, shopping malls, and community centers can be cool places to take a break from the heat.
- Ask neighbors, friends, or family if they have a cool place you can hang out.
- Call your local county to find a location near you to keep cool.

If you work outside:

- Take breaks to cool down.
- Your employer must give you water, rest, and shade.



### Look out for Others

- For people who are 65 or older, heat can be especially dangerous. Make a plan with a friend, relative, or neighbor who will call or come check on you twice a day while it is hot outside.
- Bring pets inside. Make sure they have plenty of fresh water.
- Make sure everyone is out of the car whenever you park. Never leave a child, adult, or animal alone inside a parked vehicle. Temperatures inside a car can rise almost 20 degrees within the first 10 minutes causing heat stroke or death.



## Back-To-School Preparedness Tips

Whether you're at home, at work or while your child is at school, disasters can strike anywhere, anytime. As you prepare your child to go back to school, the City encourages all families to think ahead about emergency preparedness.

Here's a few tips below to ensure you and your loved ones are safe:

### Make a family emergency plan together.

- Have a conversation with young ones about what an emergency could be and how to be safe.
- Talk about how you will find each other if your family becomes separated during an emergency.

- Decide on a safe familiar place where your family can go for protection or to reunite. If you have pets or service animals, think about animal-friendly locations.
- Think about evacuation routes if your family is at home or your child is at school.
- Practice your plan before an emergency so everyone knows what to do if a disaster occurs.
- Write down any allergies your child has, the medications they take and any emergency contact information.
- Sign up for Alert SouthBay emergency notifications by texting “alertsrb” to 888-777 or visiting [alertsouthbay.com](http://alertsouthbay.com).

### Keep a copy of your family's emergency plan in your child's backpack.

- If your child has trouble communicating or remembering the plan, include a copy of this plan to keep with them when they're not at home.
- It may be helpful to let your school know that your family has a plan in case of an emergency.
- Let your child choose a small blanket, care toy or stuffed animal to live in their backpack. It may help them stay calm during an emergency.

### Make a “Go Bag” with emergency essentials.

- Make a “Go Bag” that you can grab quickly if you need to leave during a disaster. Include basic supplies such as:
  - Medicines
  - First aid kit
  - Bottled water and non-perishable food
  - Local maps
  - Flashlights and extra batteries
  - Battery-powered radio
  - Games or books to keep little ones busy
- Consider adding additional items to your bag based on your family's needs.

### Ask your child's teachers and administrators about the school's emergency action plans.

- Every school has a unique action plan to use in the event of an emergency. Have a discussion with your child's school administration to learn about safety and emergency guidance.





# FINANCE DEPARTMENT

## Case-Shiller Home Price Index – June 2023

The S&P CoreLogic Case-Shiller Home Price Indices are the leading measures of U.S. residential real estate prices, tracking changes in the value of residential real estate nationally. Data released on August 29, 2023 for the U.S. National Home Price Index and Los Angeles Home Price Index are depicted and summarized below.

**Chart 1. National vs Los Angeles Home Price Index – 2020-2022 (3 Year)**



### Summary

The U.S. National Index posted a 0.9% month-over-month increase in June before seasonal adjustment, falling slightly to 0.7% after seasonal adjustment. Compared on an annual basis, the National Index reported no change in June, but was up from a -0.4% loss in the prior month's report. June is the fifth consecutive month in which home prices have increased across the U.S. and reflects ongoing positive momentum.

Looking regionally on a year-over-year basis, June's three best-performing cities were Chicago (+4.2%), Cleveland (+4.1%), and New York (+3.4%). On the other hand, the worst performers continue to be in the Pacific and Mountain time zones, with San Francisco (-9.7%) and Seattle (-8.8%) at the bottom. The Midwest (+2.8%) continues as



the nation's strongest region, followed this month by the Northeast (+1.6%). The West (-5.9%) remains the weakest region.

### Job Openings and Labor Turnover – July 2023


On August 29, 2023, the U.S. Bureau of Labor Statistics reported that the number of job openings edged down to 8.8 million on the last business day of July. The change in job openings fell by 338,000 compared to June resulting in a current rate of 5.3%. Changes in the job openings rate from July 2021 to July 2023 are illustrated below.

Additionally, the number and rate of hires in July changed slightly and were reported at 5.8 million and 3.7 percent, respectively. Total separations, which includes quits, layoffs and discharges, also changed slightly to 5.5 million and fell to a rate of 3.5%.







### **City of Rancho Palos Verdes Awarded \$23.33 Million FEMA Grant for Portuguese Bend Landslide Remediation Project**

**Aug. 29, 2023 (Rancho Palos Verdes, Calif.)** — The City of Rancho Palos Verdes today celebrated the news that the City has been awarded a \$23.33 million grant from the Federal Emergency Management Agency (FEMA) to slow the Portuguese Bend Landslide, one of the largest continuously active landslides in the U.S.

The City's project to significantly reduce land movement in the 240-acre landslide was one of 124 infrastructure projects chosen from 803 submitted from across the country for FEMA's Building Resilient Infrastructure and Communities (BRIC) grant program. On Aug. 28, [FEMA announced nearly \\$3 billion](#) in awards to help communities build resilience against extreme weather events and proactively reduce natural hazard risks, including \$1.8 billion in BRIC funding. [The City's award](#) is believed to be the first landslide mitigation project funded under BRIC and the largest investment in landslide mitigation under any FEMA program. It is the largest grant award ever secured by the City.

Rancho Palos Verdes Mayor Pro Tem John Cruikshank, who sits on the City Council Landslide Subcommittee, called yesterday's announcement a "game changer" for the City.

"This \$22.33 million grant is a tremendous boost that will make it possible for the City to address the long-looming threat posed to our community by the landslide and prevent a dual public safety and environmental disaster," he said. "We thank FEMA and Cal OES for recognizing the urgency of this critical project, which is underscored by the accelerated land movement we have seen in recent months."

The Portuguese Bend Landslide is part of a larger complex of ancient landslides located on the south side of the Palos Verdes Peninsula in Rancho Palos Verdes. It was reactivated in 1956 by Los Angeles County's planned extension of Crenshaw Boulevard and has been moving ever since, moving homes by hundreds of feet over the years and causing the City to spend nearly \$1 million annually on roadway repairs along a bumpy stretch of Palos Verdes Drive South. The land moves because of the dynamics of surface water percolating into the ground and water trapped deep underground, sliding as much as 8.5 feet per year.

The City is in the process of preparing a Final Environmental Impact Report (EIR) for the Portuguese Bend Landslide Remediation Project, which aims to drastically reduce the movement to 2 inches per year through a combination of engineering strategies that would remove the trapped water and prevent rainwater from entering the ground in the future.

"The City has been exploring engineering solutions to manage the landslide for decades," said Rancho Palos Verdes City Manager Ara Mihranian. "In 2017, a renewed process began that culminated in the current project that has a price tag of \$33 million. Receiving the FEMA BRIC grant in the amount of \$23.33 million will enable the City to address the costly and damaging land movement. This will leave an indelible

mark on the City, Peninsula and the South Bay for decades to come by addressing an imminent threat to public health, safety and the environment."

In addition to FEMA, Mr. Mihranian expressed the City's gratitude to Cal OES, Hagerty Consulting, Hout Engineering, and Lisa Scola of Scola & Associates for their work on the City's grant application. He also thanked elected representatives who have lent their support to the City's efforts to address the landslide, including U.S. Sen. Dianne Feinstein, Rep. Ted Lieu., California Sen. Ben Allen, Assemblymember Al Muratsuchi, California Sen. Steven Bradford, L.A. County Supervisor Janice Hahn, and L.A. County Assessor Jeff Prang, as well as neighboring agencies on the Peninsula.

The project is designed to significantly reduce the threat of sudden movement that could result in the failure of Palos Verdes Drive South, which would bifurcate the City, eliminating a major connector and evacuation route for the high fire risk Peninsula. Roadway failure could also send raw sewage spilling onto the ecologically sensitive shoreline and ocean from above-ground sanitary sewer trunk lines that serve thousands of homes. A Final EIR could be released in late 2024. If the final project is approved by the City Council, construction could start in 2025.

To complete the \$33 million project, the City will work to identify funding opportunities for about \$10 million needed in non-federal matching funds. The City was previously allocated \$2 million in Congressionally Directed Spending requested by Sen. Feinstein. Because the City already had a federal grant application pending, the funding could not be used for the project, but instead will be used for a nearby drainage improvement project in the landslide area at Palos Verdes Drive South and Peppertree Drive. That work will reconstruct an existing failed drainage system to convey water to the ocean rather than allow it to percolate into the ground and contribute to land movement.

2023 LEGISLATIVE PLATFORM**

**DATE ADOPTED: Resolution No. 2022-71 on December 20, 2022.**

**PURPOSE**

The City of Rancho Palos Verdes' 2023 Legislative Platform (Platform) outlines the policy positions of the City Council on current issues which directly or indirectly impact the City. This Platform serves as a guideline to actively pursue pending legislation, with City Council approval.

The City looks forward to working with regional, state, and federal partners to best serve residents. The statements outlined in the Platform represent the City's general position on legislative and regulatory issues of interest and concern.

**PRIORITY CITY PROJECTS**

Through the City's Capital Improvement Plan (CIP), major projects are planned for a period of five years. The list below includes important projects of regional significance listed within the CIP that do not have sufficient funding. The City is supportive of legislation, policies, programs, or administrative actions that would assist in funding these projects.

**A. Portuguese Bend Landslide Remediation Project**

**Total Cost:** \$33 million

**Status:** Environmental analysis and documentation

**Funds Committed:** \$2.3 million

The Portuguese Bend Landslide Complex (PBLC) is the largest active landslide in the continental United States, encompassing two of the City's roughly 14 square miles, directly impacting Palos Verdes Drive South, a major arterial street providing transportation for the wider region, including neighboring cities of Palos Verdes Estates and the City of Los Angeles (San Pedro). Continued land movement poses a catastrophic environmental threat to the California coastline due to an above-ground sewer trunk line located adjacent to the Pacific Ocean at severe risk of rupture. The project seeks to protect life, public health, safety, and the environment through mitigation of land movement in the PBLC area.

**1. HOUSING AND LOCAL LAND USE**

- A. Oppose legislation that usurps local control and erodes the City's authority to control its own affairs.
- B. Support actions which further strengthen local democracy, authority, and control.

- C. Support policies or programs that allow city and state collaboration on housing production, alongside sustainable transportation, broadband deployment, and other key infrastructure areas to support our communities. Support state grants, legislation, or programs which encourage sustainable and affordable housing development. Support policies or grants which encourage the development of regional housing trusts.
- D. Oppose legislation that penalizes a city or local government if the units identified in the Regional Housing Needs Allocation (RHNA) are not constructed. Oppose legislation that proposes to convert RHNA from a planning process to a production standard.
- E. Support legislation that preserves local authority to manage public rights-of-way including the appearance and aesthetics of equipment placed within them.
- F. Support legislation that preserves local authority to zone and plan for the deployment of telecommunications infrastructure in public rights-of-way.
- G. Oppose legislation that diminishes the authority of local jurisdictions to process permits and enforce building codes or mandates the manner of enforcement.
- H. Oppose legislation that seeks to limit or eliminate municipal authority to regulate street or sidewalk vendors.
- I. Support legislation and administrative actions that protect the ability for a local jurisdiction to preserve open space in and around a local government's jurisdiction.

Support legislation and local, state, and federal programs that employ evidence-based best practice strategies to reduce the number of people experiencing homelessness by preventing homelessness for those at risk; promoting mental health and substance abuse services; providing emergency and transitional housing; expanding permanent affordable housing; and promoting self-empowerment through counseling, job training, and other supportive services.
- B. Support legislation and local, state, and federal programs which seek to provide mental health services, including youth and young adult programs, community resource centers, and education in accessing mental health care.

### **4. ENVIRONMENTAL QUALITY**

- A. Support legislation, regulations, or administrative actions to remediate the harmful effects of dichloro-diphenyl-trichloroethane (DDT) and other chemicals in coastal waters, especially near Santa Catalina Island and the Palos Verdes Peninsula.
- B. Support legislation that provides rebate programs, tax credits, and other financial incentives that encourage property owners to invest in water efficient systems and landscaping and energy efficiency and renewable energy systems.

## **5. GOVERNMENT TRANSPARENCY AND EFFECTIVENESS**

- A. Support legislation that grants full cost reimbursement to local agencies by the state and federal government for all mandated programs.
- B. Support legislation that ensures the retention of existing local revenue sources, including the City's share of property taxes, sales and use taxes, transient occupancy taxes, etc. Support legislation that will enhance revenue for cities.
- C. Support legislation modernizing the methods by which a local agency may comply with the Brown Act. Support legislation that allows for the continued use of teleconferencing platforms to continue holding hybrid public meetings outside of a declared state of emergency. Hybrid meetings increase access to public meetings and encourage greater transparency.
- D. Support legislation which allows for regional considerations within Los Angeles County, particularly at the council of governments (COG) level, in relationship to public health, homelessness, and sustainability, among other areas of regional importance.
- E. Oppose legislation that would prohibit or limit local governments' ability to contract out for the provision of services.
