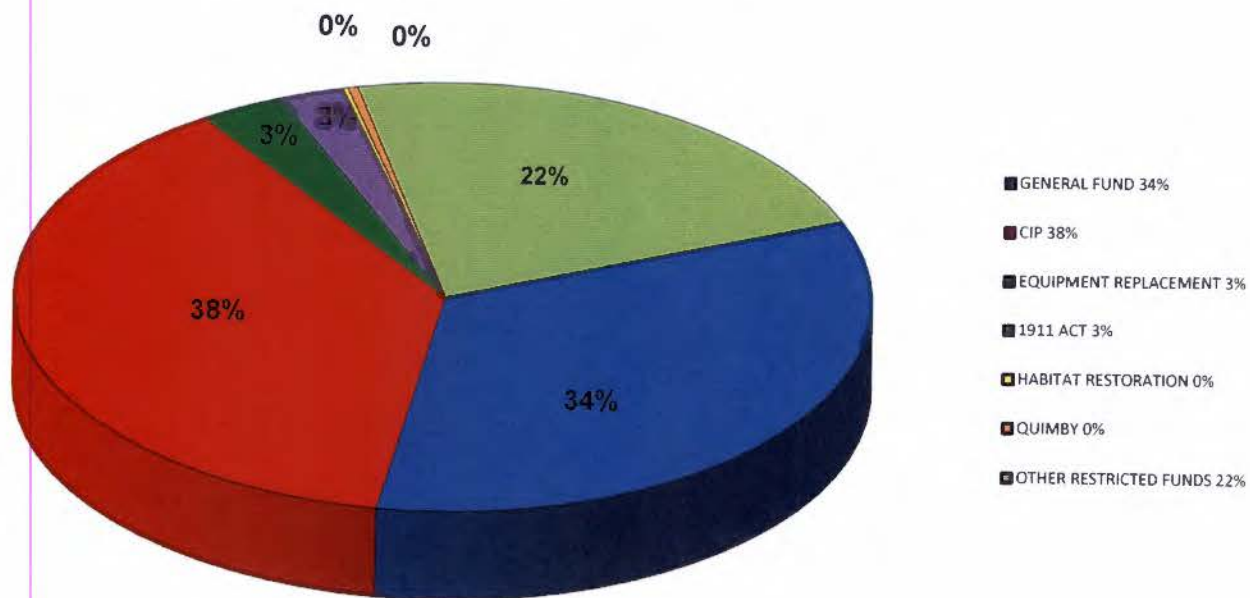

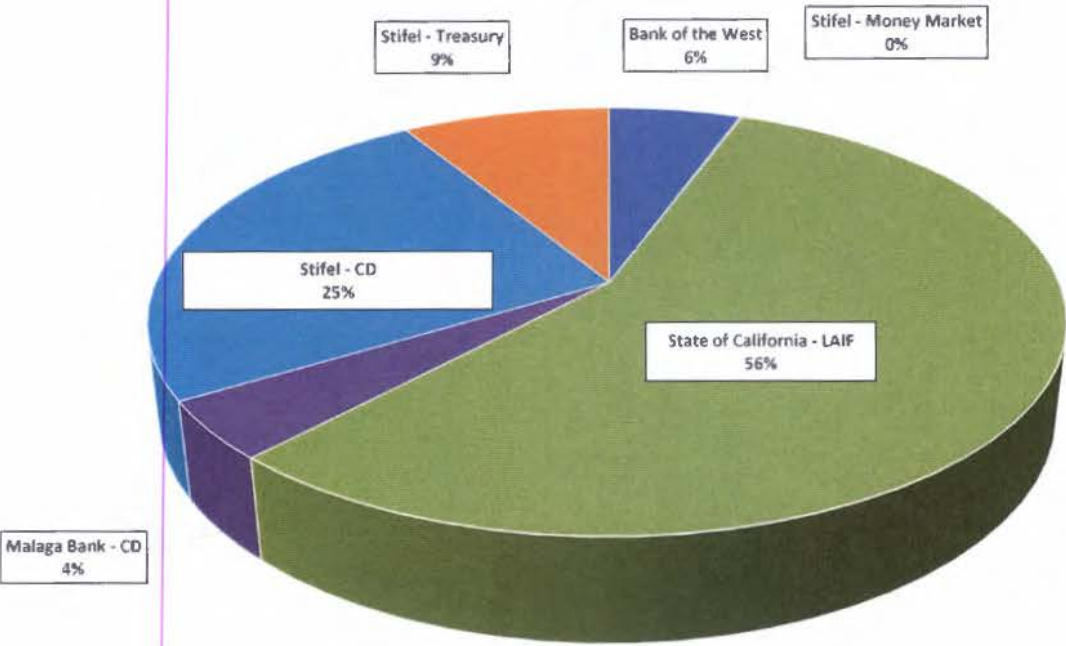

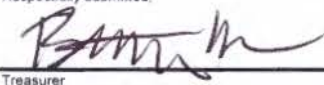
SUMMARY OF CASH BALANCE BY INSTITUTION
