RPV Landslide Complex Working Group


In response to accelerated land movement in the City's landslide complex, the City has created a working group comprised of stakeholder representatives, including Abalone Cove Landslide Abatement District (ACLAD) and Klondike Canyon Landslide Abatement District (KCLAD) board members, homeowners associations, utility representatives (Cal Water, SCE, and SoCalGas), and members of the public, to address issues related to the land movement, coordinate remediation projects, and keep channels of communication open.



Cal Water EOC Training

On October 19, Cal Water hosted a regional Emergency Operations Center (EOC) training to enhance collaboration in preparation for potential major emergencies or natural disasters. The event, lead by District Manager Ralph Felix, included a detailed classroom presentation on emergency preparedness and a practical tabletop exercise. Using the National Incident Management System (NIMS) and Standardized Emergency Management System (SEMS) Incident Command System frameworks, the training allowed first responders, City Staff, and

Cal Water representatives to collaboratively exchange ideas, expertise, strategies, and experiences in emergency planning, response, and recovery.

In addition, this training was an excellent opportunity for City Staff, representatives from local agencies, and Cal Water to build relationships so that they can serve community members more effectively in an emergency or natural disaster. City Staff will continue to work closely with Cal Water and other regional agencies to ensure the success of the City's resiliency planning efforts.

9th Annual Prepared Peninsula Expo

On October 22, the four cities on the Palos Verdes Peninsula hosted the 9th annual Prepared Peninsula Expo. This event focuses on equipping residents with vital knowledge regarding disaster mitigation, preparedness, response, and recovery. For residents keen on learning how to safeguard their families and homes from calamities such as earthquakes and wildfires, the Expo was an invaluable resource.

Emergency preparedness experts shared their wisdom, guiding attendees through comprehensive step-by-step plans to ensure the safety of both families and pets during any disaster. The day was marked with enthusiastic participation, and attendees had the chance to enjoy lunch, engage with various exhibitors, witness live demonstrations, and explore equipment displays.

The Expo was followed by a Natural Disaster Town Hall spearheaded by Assemblymember Al Muratsuchi inb collaboration with Senator Allen. This town hall comprised insightful presentations from the Los Angeles County Fire Department, Los Angeles County Office of Emergency Management, California Governor's Office of Emergency Services, and the California Department of Insurance (CDI). Join PVAN Today

Interested in supporting your community during emergencies and deepening your knowledge about ham radio communications? Consider joining the Peninsula Volunteer Alert Network (PVAN). PVAN is a dedicated group of volunteers who step up with emergency communications at the neighborhood level when conventional channels like phones and electricity falter during major incidents. Leveraging their personal two-way ham radios, PVAN volunteers bridge the communication gap by transmitting essential information to the City's Emergency Communications Center. This data is then forwarded to the City's Emergency Operations Center (EOC).

After a disaster, volunteer amateur radio operators with PVAN check on their homes and families before conducting a neighborhood-wide survey to gather vital information. The local PVAN amateur radio operator will then relay the neighborhood's status and other vital information necessary to the City's EOC or other local PVAN operators. PVAN members participate in a weekly radio net or check-ins with the City's Emergency Communications Center every Monday at 7 p.m. In addition, periodic training exercises are conducted to familiarize all personnel with the most recent radio operating procedures and policies.

To become a volunteer amateur radio operator for PVAN, you must be at least 18 years old, possess a valid amateur radio license, have access to an appropriate amateur radio transceiver, and complete a two-hour training seminar conducted by the Palos Verdes Amateur Radio Club. For courses sponsored by the Palos Verdes Amateur Radio Club, students thru grade 12 who pass their examination at a PVARC VE test session will, upon application to the Club, be eligible for reimbursement up to a maximum of \$50 to cover the cost of materials and the examination fee.

Everyone who obtains their first ham radio license through a PVARC VE test session, regardless of age, will receive a free membership in the Palos Verdes Amateur Radio Club for the remainder of the current calendar year.

Know Your Zone

The Palos Verdes Peninsula cities, in collaboration with the County of Los Angeles Office of Emergency Management and public safety partners, have launched a new evacuation tool for the Palos Verdes Peninsula. Know Your Zone maps will be utilized by local public safety agencies (law and fire departments), and your Peninsula cities to prepare you in the event of an evacuation. In urgent situations when an evacuation need arises, residents, businesses, and visitors will be provided with timely critical information for impacted zones.

To find your zone, visit PVPreaydy.gov, click “Find Your Zone,” enter an address in the search bar in the upper left corner of the [zone map](#), and a pop-up window will open with the corresponding zone and emergency information. During an emergency, such as a wildfire or flood, the website and corresponding alerts will show which zones are under evacuation the moment an order is issued by authorities.

Knowing your zone is critical to the evacuation process. If there is a wildfire or emergency situation, navigating the Know Your Zone map can help determine your next steps in emergency incidents affecting where you live, work, and play.


Become familiar with your evacuation zone on PVPready.gov

Locate Routes

Walk or drive around your zone and locate the fastest routes to nearby freeways to ensure you are familiar with the various ways of getting in and out during an emergency.

Find Your Way

Be able to find your way out of your area without access to a map/GPS or if you lose internet access.



Find Your Zone

On PVPready.gov, click Find Your Zone and type your address into the search bar.

View Zone Info

After inputting your address, view Zone Information. There, you will see the boundaries of your zone listed as north of, south of, east of, and west of certain streets.

Learn Exits

Take a screenshot of your zone and its surrounding area, print it out, and draw multiple potential exits that you can reference in the event of a disaster.

Halloween Safety Alert


As the spookiest night of the year approaches, let's make it a safe and enjoyable Halloween for everyone. Here are some tricks for a treat-filled night:

Quarterly Home Sales History – 3rd Quarter 2023

Elevated mortgage rates continue to impact the California housing market as home sales fell for the fourth consecutive month ending September. Despite the declining sales volume, the median home price in Los Angeles County increased for the third straight month, ending the quarter at \$900,000, a gain of 3%. September's statewide median home price was \$843,340, down 1.9% from August but up 3.2% from a year ago.

The trend of monthly price declines is expected to continue in line with the traditional seasonal pattern. However, positive year-over-year price growth is expected to persist through the remainder of the year as housing supply remains tight.

In the City of Rancho Palos Verdes, the median sales price for detached single family homes fell to \$1.77 million, down \$87,000 or -4.7% from the 2nd quarter. This change in value follows an increase of roughly 15% from the 1st to 2nd quarter of 2023. Compared to the same period a year ago, the median price is down by -3.2%.

The average home price in the City also decreased over the quarter and ended the period at \$1.98 million. This price reflects a decrease of about \$49,000, or -2.4%.

Additionally, sales volume in the area also declined compared to the previous quarter. The number of full-value sales fell from 92 in Q2 to 61 in Q3. This decline is attributed to the statewide trend in sales volume due to persistently high mortgage rates.



Ladera Linda Community Park Project Update

Last week, the construction contractor completed the permanent driveway fence, removed the temporary fence and completed the chip seal (finish layer) to the parking lot. Crews continued installing door hardware, exterior metal panels on the building, interior wall paneling and casework, electrical connections for security rollup doors, posts for the cable railing along the ocean side of the property, and landscaping in designated areas.

This week, the contractor will continue installing posts for the cable railing along the ocean side of the property, landscaping in designated areas, and foundations for playground equipment. Crews will continue installing interior wall paneling and casework, window shades, door hardware, and will begin installing interior flooring.

The contractor is confirming the delivery date of playground equipment, which will likely be either this Friday or early next week, and neighboring residents will be notified once the delivery date is finalized.

Document Shred, E-Waste, and Mulch Event

The City will be hosting the biannual document shredding, e-waste, and mulch event on November 4 at the Ken Dyda Civic Center (overflow parking lot) from 8 a.m. to 11 a.m.

Bring your sensitive and confidential documents (such as pay stubs, medical and insurance records, old income tax returns, and bank/mortgage statements) for on-site shredding to prevent or reduce the possibility of identity theft or fraud. There is a limit of three banker's boxes (approximately 10"x12"x15") or paper bags per household. Documents with staples or paper clips are acceptable. Remove all paper from metal three-ring binders.



Have extra electronic waste (computers, TVs, printers, etc.) around? Bring them with you to the event. This is not a household hazardous waste roundup event, so no hazardous material such as paint, expired medicine, fluorescent lights, or medical sharps will be accepted.

While you're at it, free mulch (self-serve, self-load, and self-haul) will be available. Bring your own shovel, gloves, and cans for the mulch. There is a maximum of three cans per vehicle.

This event is for RPV residents only and not offered to businesses or residents of other cities. Please bring proof of RPV residency, such as a utility bill or ID.

The Rancho Caninos Dog Park and the tennis court will be closed from 6:30 a.m. to 12 p.m. on the event day.





Forrestal Nature Reserve Abatement Update

On October 16-17, the City's Code Enforcement Division oversaw the abatement of unpermitted improvements within the City's Forrestal Nature Reserve. The improvements included a bocce game court, chicken coop, vegetable garden, a viewing area, and non-native plants and trees.

The Forrestal Reserve is one of 15 reserves that make up the Palos Verdes Nature Reserve owned by the City and managed by the Palos Verdes Peninsula Land Conservancy (PVPLC). The area is also part of the City's Natural Communities Conservation Plan/Habitat Conservation Plan, which provides for regional protection of sensitive species and their habitats.

Code Enforcement Division Staff in coordination with the PVPLC and the City's biologist assessed impacts and developed a plan for the abatement of the unpermitted improvements and restoration of the area. The two-day abatement effort proved successful in preserving the Forrestal Nature Reserve as outlined in the accompanying before and after photographs. When Do I Need to Get a Building Permit?

As a public service reminder, building permits are required for all buildings or structures that are to be altered, repaired, enlarged, remodeled or converted, when any change in the size of a room takes place and when any mechanical, electrical or plumbing work is involved. Some examples of projects requiring permits include, but are not limited to:

- Room additions
- Interior remodels
- Foundation repair
- Roof replacement
- Grading and retaining walls



In some cases, certain improvements also require approval from the City's Planning Division prior to any permit issuance. 



On October 19, Staff removed graffiti and a decal from a yellow advisory sign on the California Coastal Trail segment along Palos Verdes Drive South. That same day, Staff covered up carvings made on several trees. These carvings can make the tree prone to sickness. Staff also removed graffiti from the bridge located on the upper section of Abalone Cove Trail.

On October 23, Staff trimmed back lemonade berry bushes near Olmsted Trail to improve the line of sight toward the ocean for Los Angeles County Lifeguards.



That same day, Staff used lemonade berry bush trimmings from Olmsted Trail to cover up an unauthorized trail near Portuguese Point Loop Trail. Vegetation is used to create a natural barrier to deter and minimize habitat damage.

On October 24, Staff repaired a picnic bench located near Abalone Cove Trail after inspecting and finding that the bench was loose.

On October 18, Staff conducted litter abatement on Intrepid Trail and moved a trash can that had been moved to the back of a nearby portable restroom.
