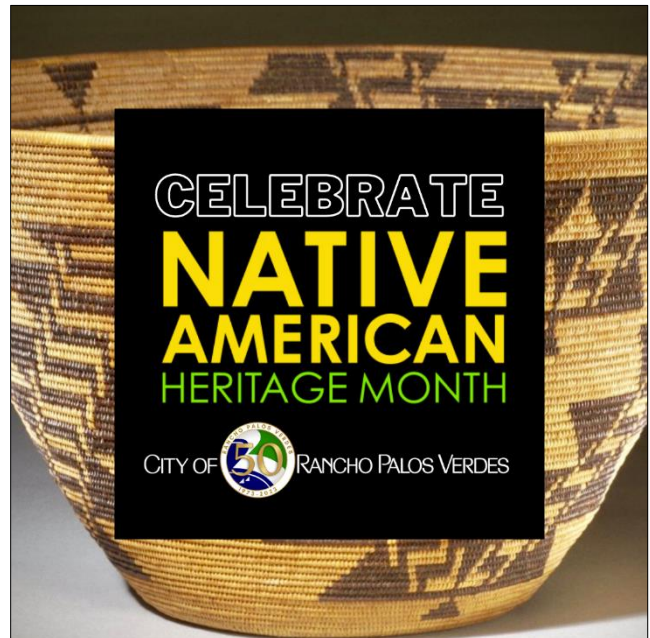

Updated Schedule for Overnight Closures of the Vincent Thomas Bridge

Caltrans has announced an updated timeline for the cable safety upgrades that began earlier this month on the Vincent Thomas Bridge. Due to unanticipated construction delays and to the upcoming holiday season, the project is now anticipated to be completed in early January.

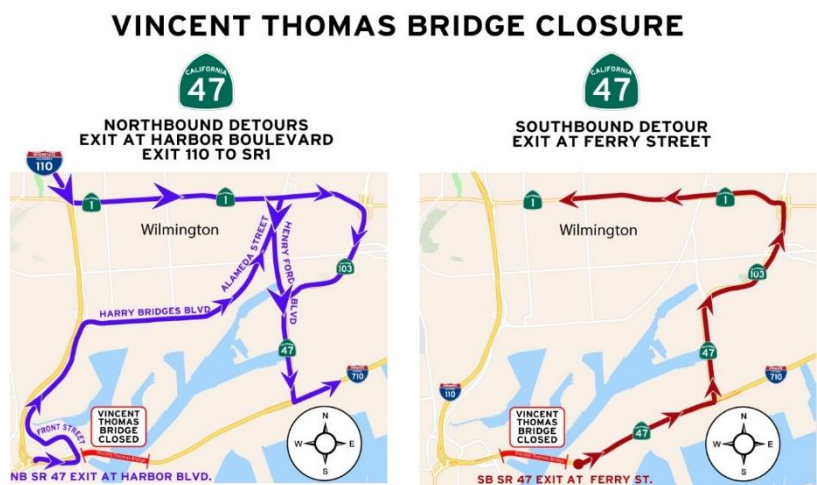
Nighttime closures of the State Route 47 bridge will continue in November and January, with the exceptions of weekends and holiday periods, during which time construction is halted to accommodate holiday travel.

During planned construction dates, the closure in one or both directions of the bridge will occur beginning as early as 8 p.m. and will reopen by 6 a.m. the following mornings. This week, the closures will take place overnight on November 1-2.

Motorists traveling southbound on SR 47 should take exit 1B to Ferry Street, turn left to take the on-ramp to northbound SR 47, continue onto northbound SR 103, take the exit for northbound SR 1 (Pacific Coast Highway) and then travel on SR 1 to the Interstate 110 (I-110) interchange.

Motorists traveling on northbound SR 47 should follow one of the following detour routes:

- From southbound I-110 exit at SR 1 (Exit 4), turn left on SR 1 and take either Harry Bridges Boulevard or SR 103 to SR 47.
- From northbound SR 47 Exit at Harbor Boulevard (Exit 1C), turn left to go northbound on Harbor Boulevard, turn right on Pacific Avenue, turn right on Harry Bridges Boulevard, which turns into Alameda Street, and then continue to SR 47.
- From southbound Harbor Boulevard, take the northbound I-110 on-ramp then exit at SR 1 (Exit 4), turn right on SR 1 and take either Harry Bridges Boulevard or SR 103 to SR 47.



Motorists are advised to avoid the area and seek an alternate route if possible.

Construction schedules are subject to change due to weather or other unforeseen circumstances. Please visit the [Caltrans Quickmap](#) for the latest road conditions and closures.

Caltrans reminds motorists to be “Work Zone Alert” and “Slow for the Cone Zone.”

Portuguese Bend Landslide Local Emergency Update

November 14 City Council Meeting

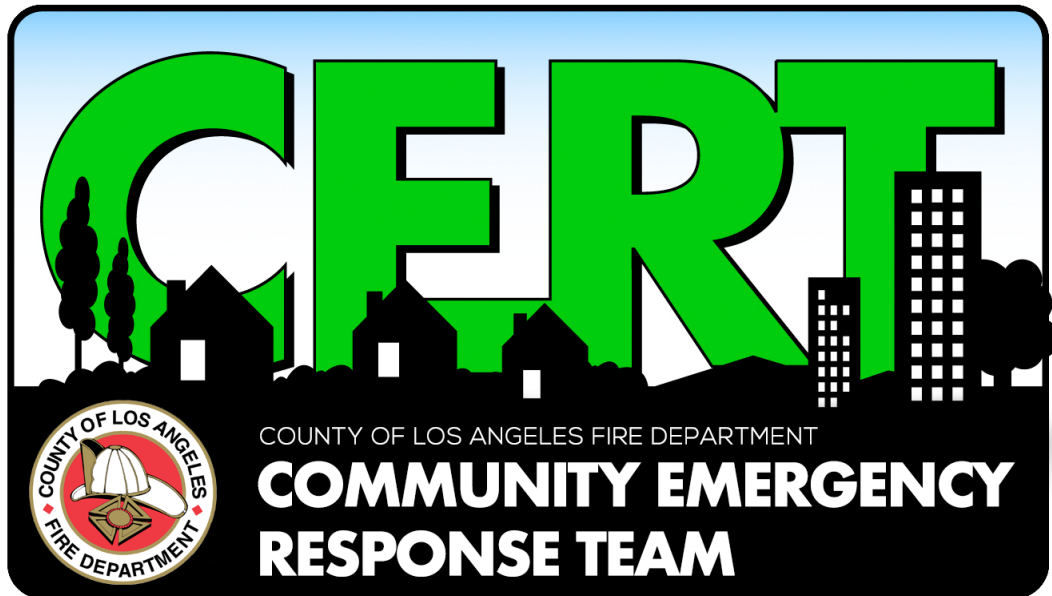
In October, the City Council [declared a local state of emergency](#) to bolster the City's response to accelerated movement in the landslide complex. The Council also put a moratorium in place prohibiting new construction that may contribute to land movement.

As the City continues to closely monitor the movement and work on immediate and long-term solutions, both the local emergency declaration and the moratorium are due to be considered for renewal in the coming weeks. At a special meeting on November 14, 2023, the City Council will consider extending the local emergency declaration to January 13, 2024, and extending the building moratorium to October 2, 2024.

Additionally, at the November 14 meeting, the City Council will receive a status update on the projects underway by the City, Abalone Cove Landslide Abatement District, Klondike Canyon Abatement District, and utility companies (Cal Water, So Cal Gas, SCE, LA County Public Works, and LA County Sanitation District).

More information about the meeting and how to participate will be shared in a future update. A staff report about this topic will be published on the City website at rpvca.gov/agendas on November 7, 2023. In the meantime, a [Public Hearing Notice \(PDF\)](#) about the proposed moratorium extension is being mailed to property owners in the landslide complex and is available on the City website.

EMERGENCY PREPAREDNESS TIPS

How to Properly Use a Fire Extinguisher

Fire extinguishers are a necessary safety item that should be in every home and business. Most fires start small. If the fire is contained in a single object, such as a trash can, you may want to try using a fire extinguisher to put out the flames.

Remember, you only have seconds — a small flame can quickly turn into a major fire in less than 30 seconds, and in just two minutes, a fire can become life-threatening.



Using a fire extinguisher can be intimidating if you have never used one before. Most of us have extinguishers in our homes and at our workplaces but may not know how to actually use one. It's important to make sure you know how and when to use a fire extinguisher and have the right type on hand to put out common household fires.

The following information is designed to help you determine when to use a fire extinguisher, the proper use, and what type you need.

Types of Fire Extinguisher Classes

Not all fire extinguishers are the same; they are classified according to the type of fire that is burning. If you use the wrong fire extinguisher on the wrong fire class, you can, in fact, make matters worse. Therefore, it is important to understand the different classifications of fire extinguishers.

All fire extinguishers are labeled to indicate which classes of fire they are designed to combat. There are four classes of fire extinguishers — A, B, C, and D — and each class can put out a different type of fire.

- **Class A extinguishers** will put out fires in ordinary combustibles such as wood and paper.
- **Class B extinguishers** are for use on flammable liquids like grease, gasoline, and oil.
- **Class C extinguishers** are suitable for use only on electrically energized fires.
- **Class D extinguishers** are designed for use on flammable metals.

Most household fire extinguishers are considered multipurpose and can be used on different types of fires and will be labeled with more than one class, like A-B, B-C, or A-B-C.

How to Use a Fire Extinguisher

There is a simple acronym to remember to operate most fire extinguishers - **PASS**. PASS stands for Pull, Aim, Squeeze and Sweep.



- **Pull** - Pull the pin at the top of the extinguisher. This unlocks the extinguisher and allows it to be discharged.
- **Aim** - Aim the extinguisher nozzle at the base of the fire.

- **Squeeze** - Squeeze the lever above the handle. This will discharge the extinguishing agent.
- **Sweep** - Sweep the extinguisher nozzle from side to side while aiming at the base of the fire.

When to Use a Fire Extinguisher

Fire extinguishers are meant to handle only small fires. Death or serious injury can occur by tackling a fire which is beyond your capabilities. Only tackle a fire in its very early stages and always ensure you put your own and other people's safety first. Before trying to control a fire with a portable extinguisher, you should know the general procedures for responding to a small, early-stage fire.

You should fight a fire with a fire extinguisher only when all the following are true:

- Everyone has left or is leaving the building.
- The fire department has been called.
- The fire is small and confined to the immediate areas where it started, such as in a wastebasket, cushion, small appliance, stove, etc.
- You can fight the fire with your back to a safe escape route.
- Your extinguisher is rated for the type of fire you are fighting and is in good working order.
- You have had training in the use of the extinguisher and are confident that you can operate it effectively.

If you cannot put out the fire or if the extinguisher becomes empty, evacuate yourself and everyone in the building immediately, closing all doors behind you as you go and ensuring the fire department has been called.

Fire Extinguisher Best Practices

Because we don't have regular opportunities to practice fighting fires, it's easy to make simple mistakes when the time comes. The following is a list of best practices for storing, maintaining, and using your fire extinguisher.

- **Ensure easy access in an emergency:** Be sure nothing is blocking or limiting your ability to reach it.
- **Read the instructions:** Thoroughly read the operating instructions with your fire extinguisher.

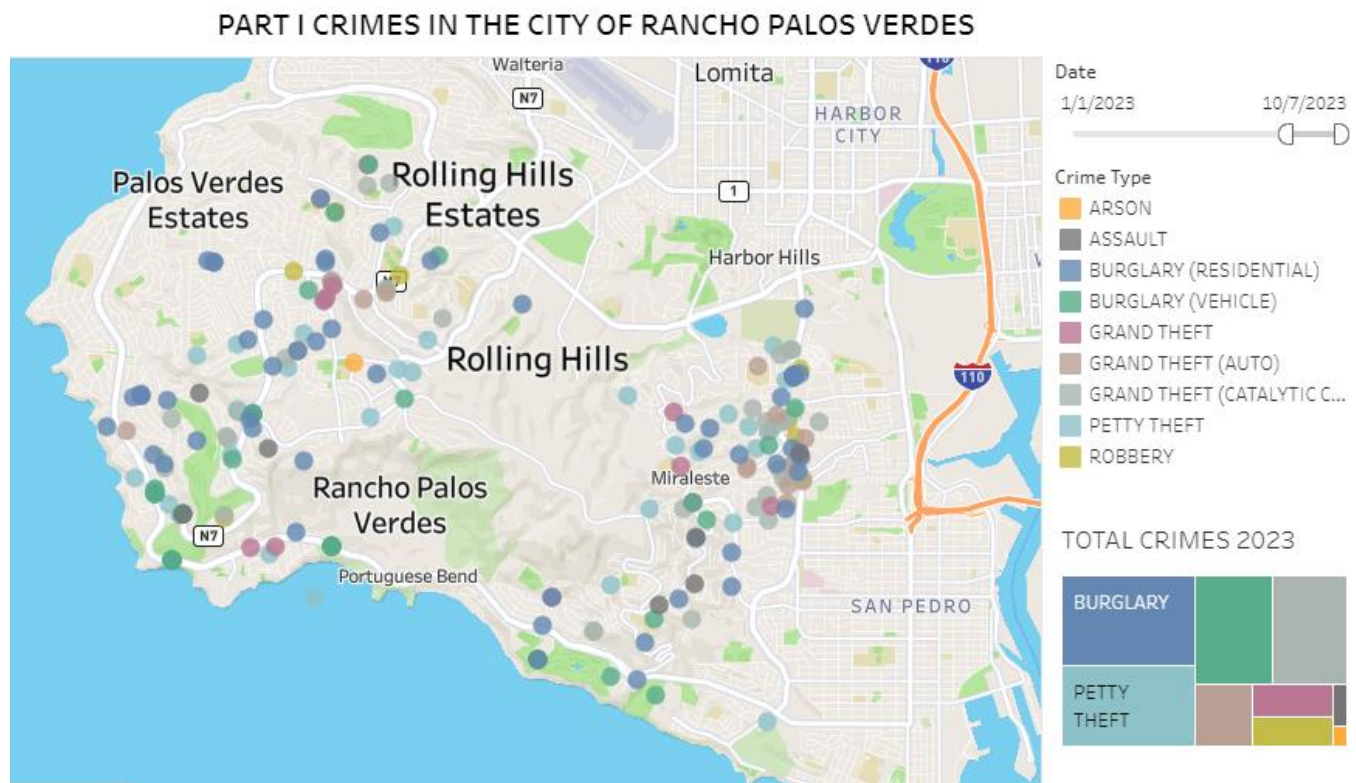
- **Don't let your extinguisher go bad:** Fire extinguishers come with an expiration date, after which the extinguishing agent is no longer effective. Know the dates on your fire extinguishers and replace them as needed.
- **Care for and maintain your extinguisher:** Ensure there are no dents, leaks, rust, chemical deposits, and other signs of abuse/wear. Wipe off any corrosive chemicals, oil, gunk, etc., that may have landed on the extinguisher.
- **Know where the exits are at all times:** When you decide where to keep your fire extinguisher, make sure it is in an easily accessible location near exterior doors. Also, consider the most common places where fires occur in a home and place your extinguishers accordingly.

1. Check Your Alarms  Don't forget to check and update your smoke alarms and carbon monoxide detectors when adjusting your clocks. Ensuring they are in working order can be a lifesaver.

2. See and Be Seen  The evenings will get darker earlier, which means reduced visibility on the roads. Be sure to check and replace the bulbs in your vehicle's headlights and taillights. When walking in the early in the morning or in the evening, remember to wear reflective clothing.

3. Home Security  Longer nights can provide cover for potential burglars. Double-check your home security measures, like locks, outdoor lighting, and security cameras, to keep your family and property safe. If you have been thinking about adding a camera to your home, now is the perfect time. The City offers public safety reimbursements for individuals or neighborhoods. 4. Outdoor Activities  If you enjoy outdoor activities like jogging or cycling, be aware that your routine may now be in the dark. Wear reflective gear and consider a headlamp or flashlight for added visibility.

5. Sleep Well 😴 Use the extra hour to catch up on sleep, as it can improve your overall health and alertness, reducing the risk of accidents and mistakes.

6. Safe Driving 🚗 Adjusting to the time change can disrupt sleep patterns. Be especially alert while driving during the days following the time change, as drowsy driving can be dangerous.

Remember, the fall back time change is not just about gaining an extra hour; it's about being proactive and ensuring your safety during the transition. Let's make this time change a step toward a safer and more secure tomorrow!

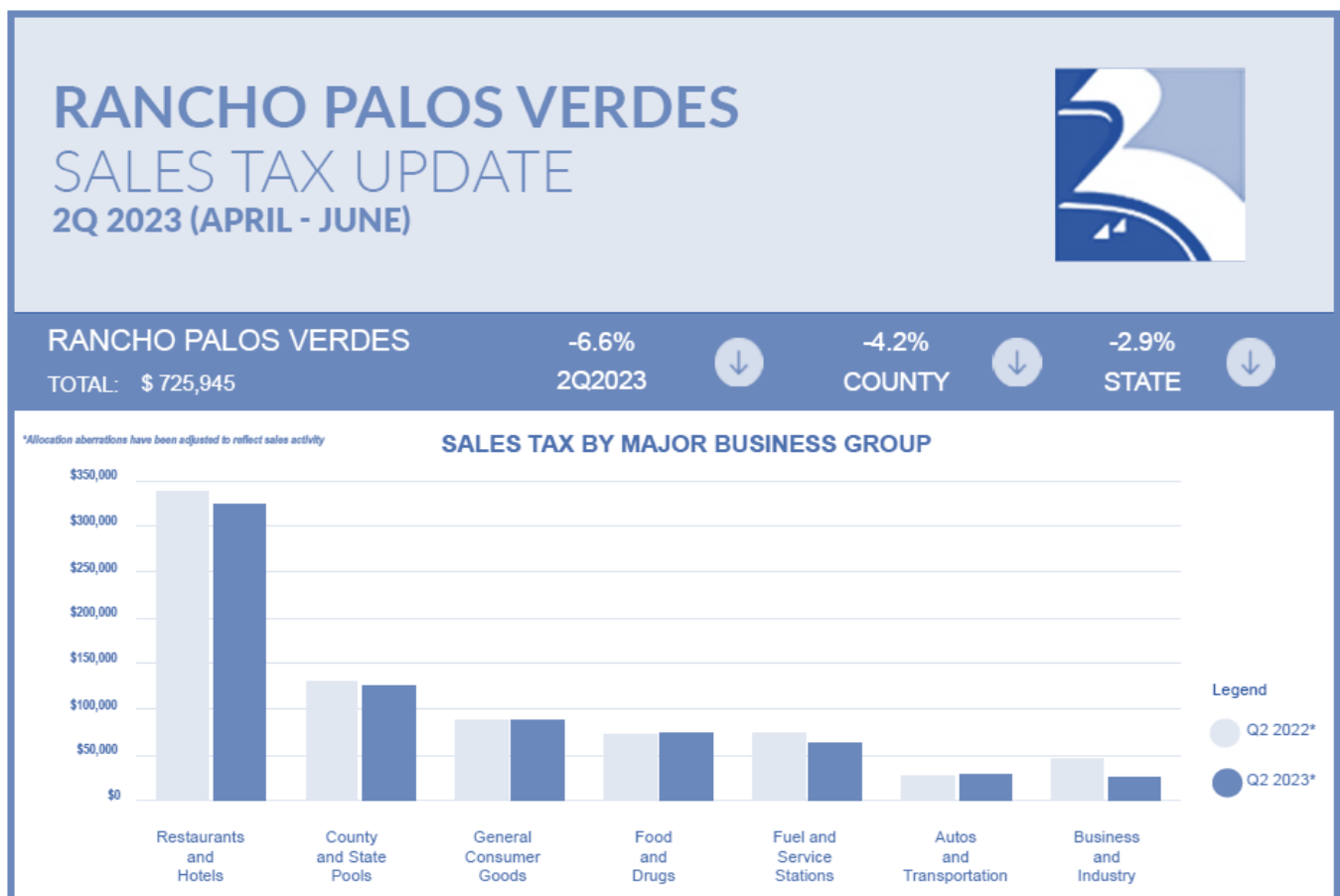
Sales Tax Update – 2nd Quarter 2023

The following information provided by HdL, the City's sales tax consultant, serves as an update on the City's sales tax revenue and performance in the second quarter of 2023.

According to the report, the City's 1% Bradley-Burns cash revenue decreased by 4.2% when compared to the same period one year ago. After adjustments, the second quarter was down by 6.6% from a year ago. The Business & Industry sector was heavily contracted due to changes in audiovisual vendors at Terranea. AV Services & Technology (Encore) was previously an onsite provider which changed in the beginning of 2023.

Additionally, lower tax receipts from service stations caused by lower prices compared to the spring of 2022 contributed to the overall slowdown.

Despite the quarterly contraction, taxable activity within the restaurant-hotels segment remained near peak levels. Revenues fell by 4.5%, however, this decline is in comparison to the same period from a year earlier that accounted for the highest level of sales tax proceeds in recent history. A portion of this decline was due to business closures as well as delayed payments. Overall, this was the first contraction from the restaurant-hotels segment since the first quarter of 2021. Additional highlights from the latest quarterly sales tax reports are provided in the image below.



Case-Shiller Home Price Index – July 2023

On October 31, data from the S&P CoreLogic Case-Shiller Home Price Indices, the leading measure of residential real estate prices, were released for the month of August. The following summary provides a brief overview of the monthly and annual changes reported in the U.S. National Index and Los Angeles Home Price Index.

Month-over-Month

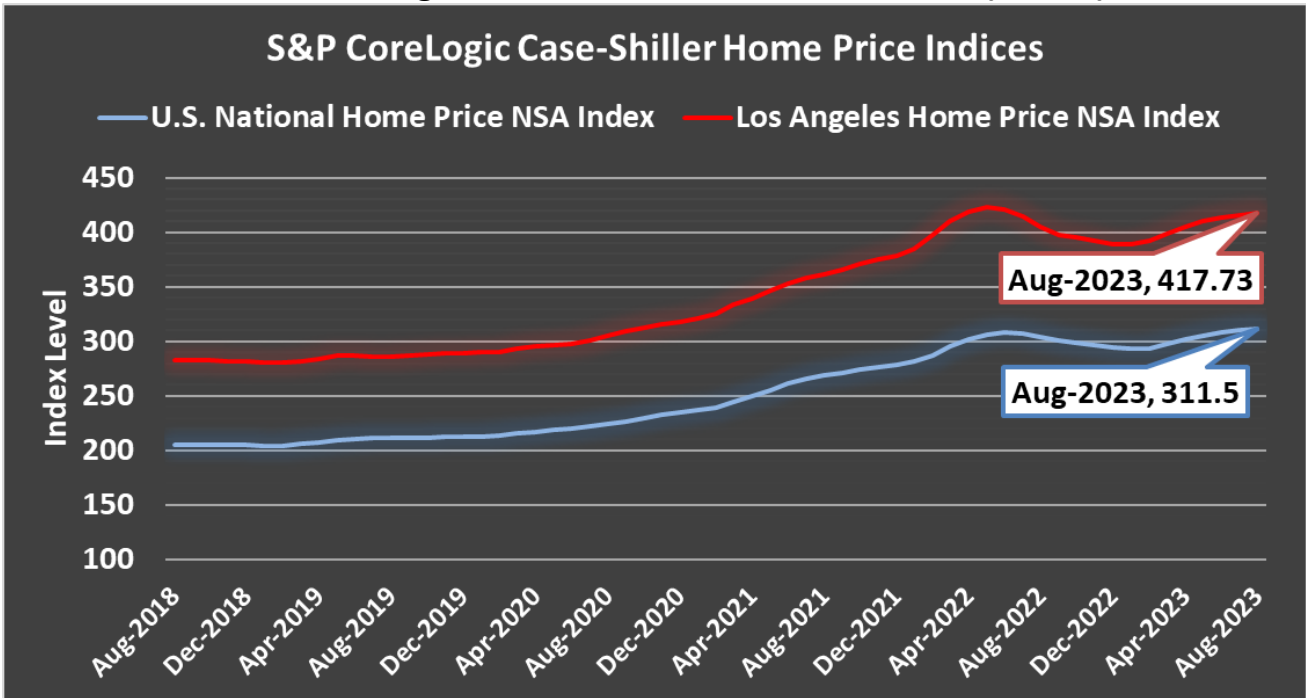
The U.S. National Index posted a 0.4% month-over-month increase in August. The rise in home prices was a continuance from previous months and marks the seventh consecutive monthly gain since prices bottomed in January 2023. Similarly, the Los Angeles Home Price Index also rose by 0.4% over the prior month.

Year-over-Year

Over the past 12 months, the National Index reported a 2.6% annual change in the month of August. According to the report, 19 of the 20 major metro markets showed a positive trend in year-over-year price acceleration as of August. In comparison, home prices reported in the Los Angeles Index increased by 3.1% over the prior year.

Chart 1 illustrates the peak in prices from May 2022 to June 2022 before falling to a low in January 2023, followed by the upward trend for both indexes that has continued month-over-month.

Ladera Linda Community Park Project Update

Last week, the construction contractor installed foundations for the playground equipment, gates for the paddle tennis courts, and cabling for the post and cable fence for the upper tier. Inside the building, crews installed finish flooring in the building and installed wall tile in the kitchenette area.

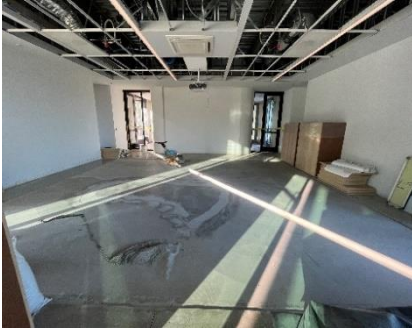
This week, the contractor will install display cases, ceiling tiles, door hardware, and building signs. Crews will also apply finish coats of paint on interior surfaces of the building and continue work on landscaping and the post and cable fence for the middle and low tiers.

Delivery of playground equipment is still being scheduled and neighboring residents will be notified once the delivery date is finalized.

Disposing of excess vegetation and tree trimming around your home is not only simple, but you are helping reduce fuel load and prevent brush fires.

Use your green carts, personal cans and/or tied bundles (no plastic bags) and leave them at the curb. Find your collection day and mark your calendars for the upcoming fall brush clearing event!

Document Shred, E-Waste, and Mulch Event – November 4

The City will be hosting the biannual document shredding, e-waste, and mulch event on November 4 at the Ken Dyda Civic Center (overflow parking lot) from 8 a.m. to 11 a.m.

Bring your sensitive and confidential documents (such as pay stubs, medical and insurance records, old income tax returns, and bank/mortgage statements) for on-site shredding to prevent or reduce the possibility of identity theft or fraud. There is a limit of three banker's boxes (approximately 10"x12"x15") or paper bags per household. Documents with staples or



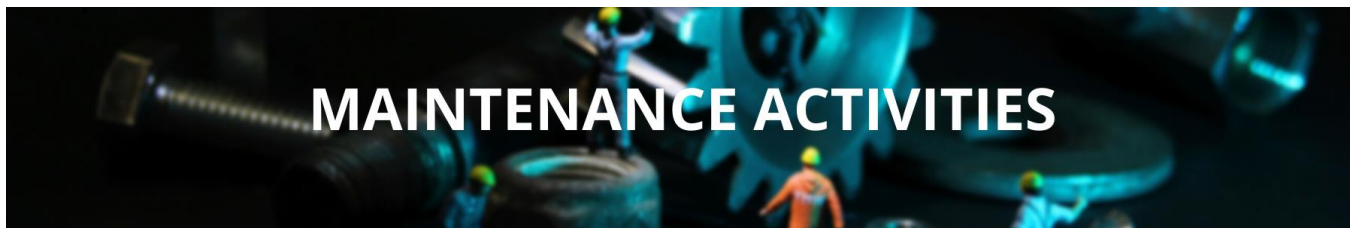
paper clips are acceptable. Remove all paper from metal three-ring binders.

Have extra electronic waste (computers, TVs, printers, etc.) around? Bring them with you to the event. This is not a household hazardous waste roundup event, so no hazardous material such as paint, expired medicine, fluorescent lights, or medical sharps will be accepted.

While you're at it, free mulch (self-serve, self-load, and self-haul) will be available. Bring your own shovel, gloves, and cans for the mulch. There is a maximum of three cans per vehicle.

This event is for RPV residents only and not offered to businesses or residents of other cities. Please bring proof of RPV residency, such as a utility bill or ID.

The Rancho Caninos Dog Park and the tennis court will be closed from 6:30 a.m. to 12 p.m. on the event day.



Maintenance Activities

In addition to regularly scheduled maintenance and repairs, Public Works performed the following:



- Weekly landscape maintenance at all City parks.
- Repaired two irrigation lines.
- Installed new locks to entrance doors at Ryan Park.

- Repaired several wood steps at Hesse Park adjacent to the Locklenna Lane park entrance.
- Removed rust, treated, and painted playground equipment at Ryan Park.
- Repaired a downed rattlesnake warning sign at Hesse Park.
- Public Works landscape team installed 144 cubic yards of fresh mulch at the Rancho Caninos Dog Park. In addition, trees and bushes were trimmed and park benches repainted.



Weed removal, brush clearance, and debris removal continued throughout the City at medians and various right-of-way locations:

- Montemalaga Drive from Silver Spur Road to Grayslake Road
- Palos Verdes Drive South from the City limits to Forrestal Drive
- 1,000 feet of storm swales were cleared of vegetation and debris in the switch

back area near Palos Verdes Drive East and Ganado Drive.

- Next week, crews will continue to work on Palos Verdes Drive South from Forrestal Drive to Terranea Way.



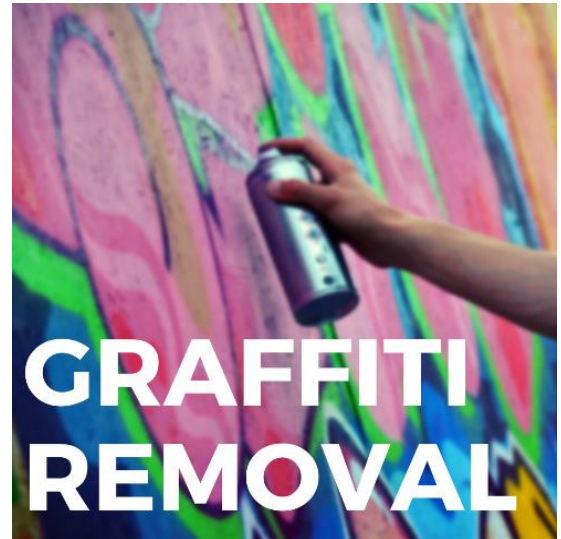
Public Right-of-Way/Roadway Repairs

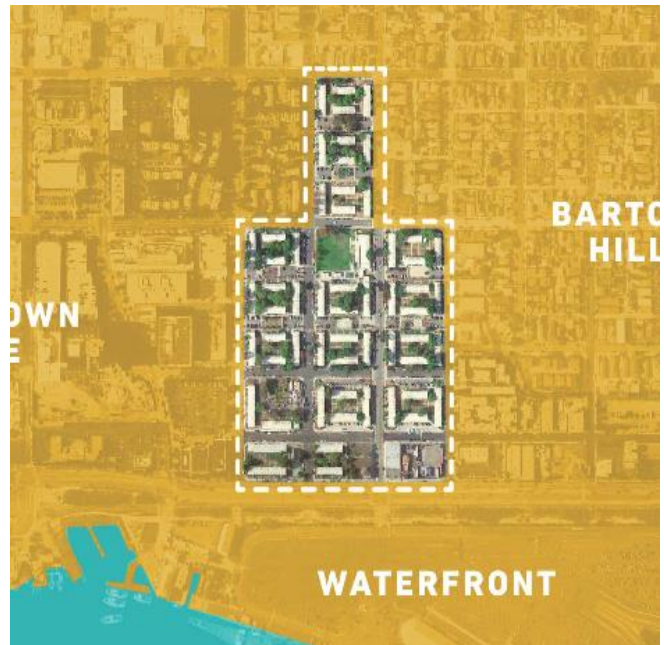

One San Pedro Specific Plan – Notice of Availability

The Housing Authority of the City of Los Angeles and the City of Los Angeles Housing Department have prepared a joint Draft Environmental Impact Report/Environmental Impact Statement (EIR/EIS) for the proposed One San Pedro (OSP) Specific Plan (project).

The proposed project involves the development and occupation of 47 residential units on the 327 Harbor Site, the adoption of the OSP Specific Plan to guide redevelopment of the OSP Specific Plan Site, the phased demolition of existing structures on the OSP Specific Plan Site, and the construction of up to 1,553 residential units on the OSP Specific Plan Site, as well as 85,000 ft² of Neighborhood Serving Uses and 45,000 ft² of commercial retail uses on the OSP Specific Plan Site.



The public review period on the Final EIS begins on **Friday, October 27, 2023** and closes at **5:00 p.m. on Monday, November 27, 2023**. Any person wishing to comment on the Final EIS may do so. Comments and related material must be submitted on or before **Monday, November 27, 2023 at 5:00 p.m.**

The REACH program serves the social and recreational needs of youths and adults with developmental disabilities and is back at Hesse Park for in-person activities.

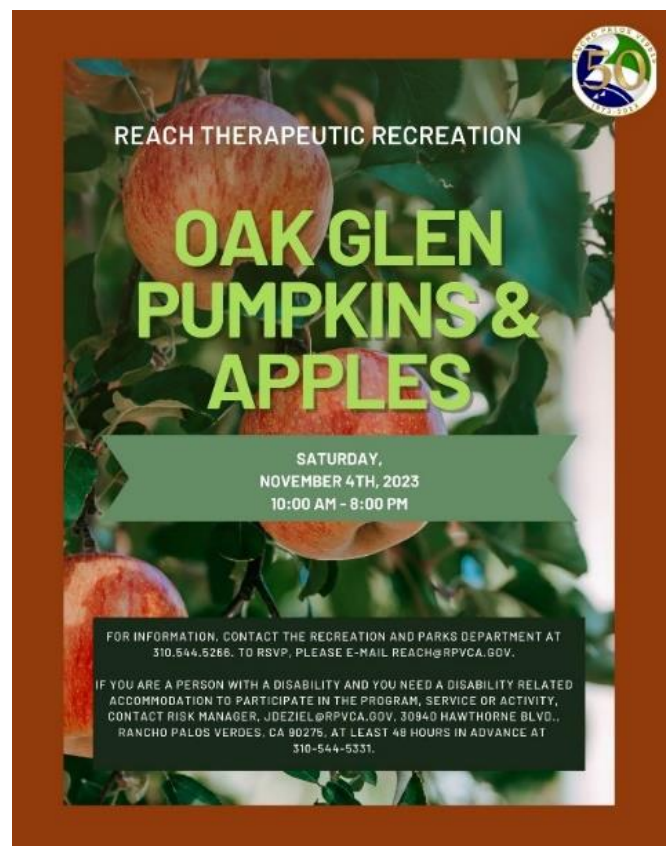
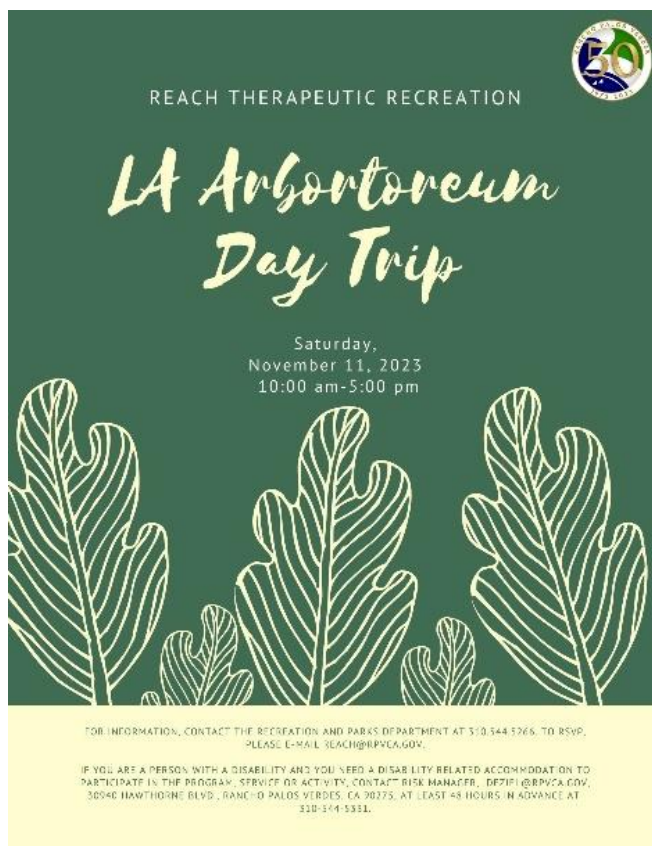

NOTICE OF PUBLIC HEARING FOR FINAL EIR: The HACLA Board of Commissioners (Board) will hold a hearing on Thursday, November 16, 2023 at 9:00 a.m. at 2600 Wilshire Boulevard, Los Angeles, California 90057. At this meeting, HACLA will give a presentation on the proposed project and the potential

environmental impacts associated with implementation of the project based on the analyses in the Final EIR/EIS. During this meeting, the Board will determine whether to certify the Final EIR, adopt environmental findings of fact and a statement of overriding considerations, adopt the mitigation monitoring and reporting program, and approve the project.

SUPPLEMENTARY INFORMATION:

Project Location: The project site is located on the Palos Verdes Peninsula, approximately 0.5 mile southeast of the southern terminus of SR-110, on the west side of Harbor Boulevard. The project site consists of two locations in the community of San Pedro in the southwestern-most portion of the city of Los Angeles: One San Pedro Specific Plan Site (OSP Specific Plan Site) and 327 Harbor Site. The approximately 20-acre OSP Specific Plan Site encompasses approximately nine city blocks bounded by Santa Cruz Street on the north, Harbor Boulevard on the east, 3rd Street on the south, and Mesa Street on the west. The OSP Specific Plan Site is currently developed with the Rancho San Pedro public housing complex (Rancho San Pedro), a 478-unit public housing community with approximately 8,000 square feet (sf) of amenities, services, and administration within 60 buildings. Rancho San Pedro is considered eligible for listing in the in the National Register of Historic Places, the California Register of Historic Place, and as a City Historic Cultural Monument. The approximately 0.6-acre 327 Harbor Site is located one block to the north of the OSP Specific Plan Site at 319-327 North Harbor Boulevard and is currently vacant and undeveloped. See **Project Site Location Map** below for the boundaries of the project site.

Project Description: The proposed project involves the development and occupation of 47 residential units on the 327 Harbor Site, the adoption of the OSP Specific Plan to guide redevelopment of the OSP Specific Plan Site, the phased demolition of existing structures on the OSP Specific Plan Site, and the construction of up to 1,553 residential units on the OSP Specific Plan Site, as well as 85,000 sf of Neighborhood Serving Uses and 45,000 sf of commercial retail uses on the OSP Specific Plan Site. The 85,000 sf of Neighborhood Serving Uses would be primarily for the benefit of the residents of the proposed project and/or residents of the immediate neighborhood and are typically required for the needs of the future residents. These uses include, but are not limited to, a property management office, community rooms, social service offices, social hall, workforce development office, health clinic, wellness center, business incubator, nonprofit offices, and municipal offices. Neighborhood Serving Uses also would include small-scale retail not exceeding 3,000 sf in size that would provide goods and services to future residents to meet typical needs, such as dry cleaners, flower shops, small convenience stores, and bakeries. The 45,000-sf commercial retail component of the proposed project would include businesses larger than 3,000 sf such as restaurants, grocery stores, and pharmacies. In addition, the proposed project would include a variety of public open space amenities, including a linear park along Palos Verdes Street, a community center, a youth sports field, a pedestrian street along 2nd Street from Palos Verdes Street to Harbor Boulevard, and several courtyards and plazas interspersed throughout the proposed buildings. In total, approximately 5.3 acres of public open space would be provided on the OSP Specific Plan Site. Parking on the site would include a mix of street parking and one- to two-level underground parking structures beneath the proposed buildings.

Construction of the OSP Specific Plan includes three Phases and four Subareas. The phasing of the proposed project is planned to minimize disturbance to current residents on the OSP Specific Plan Site. The proposed project would pursue a build-first approach. When residents must be relocated, HACLA would adhere to all requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970. Resident relocation would be guided by the One San Pedro Relocation Plan, which, once adopted by the HACLA Board of Commissioners, would set forth procedures to assure the fair, uniform, and equitable treatment of persons displaced from their homes when development occurs.

Required Approvals: The proposed project would require the following actions and approvals, in no particular order:

- Adoption of Master Development Agreement, Disposition and Development Agreements, Ground Leases, and Relocation Plan by HACLA
- NEPA Part 58 compliance necessary for Demolition/Disposition and Rental Assistance Demonstration (RAD) Conversion of the existing Rancho San Pedro development from HUD and potential federal funding for the project
- Certification of the EIR by HACLA Board of Commissioners and publication of the Record of Decision in the Federal Register by HUD
- Adoption of the OSP Specific Plan, General Plan Amendments, Amendment of the Community Plan Implementation Overlay boundaries, and Zone and Height District change by the City of Los Angeles
- Adoption of a Phased Vesting Tentative Tract Map (VTTM) by the City of Los Angeles. The Phased VTTM is consistent with applicable regulations within the OSP Specific Plan. The Phased VTTM consists of nine ground lots and a Final Map will be filed for each subsequent development phase.
- Haul Route Approval from the Los Angeles Department of Building and Safety
- Permit for removal of street trees

Other discretionary and ministerial permits and approvals that may be deemed necessary, including, but not limited to, demolition of structure and landscaping including street trees, temporary street closure permits, grading permits, Haul Route permits, excavation permits, foundation permits, building permits, and sign permits to execute and implement the project.

Anticipated Significant Environmental Impacts Pursuant to CEQA: Based on Section 4, Environmental Impact Analysis, of the Draft EIR/EIS, implementation of the proposed project would result in significant environmental impacts that cannot be mitigated to less than significant levels with respect to historical resources, construction and operational noise, and construction groundborne vibration. Cumulative impacts associated with historical resources and on-site construction and operational noise would also be significant and unavoidable. All other potential environmental impacts would be less than significant or less than significant with mitigation incorporated.

Anticipated Significant Environmental Effects Pursuant to NEPA: Based on Section 7, Environmental Impact Statement, of the Draft EIR/EIS, implementation of the proposed project would result in potentially significant and unavoidable impacts with respect to construction-related noise and vibration, operational noise, and historic resources. Cumulative impacts associated with on-site construction and operational noise, as well as transportation and circulation (specifically related to intersection queuing), would also be significant and unavoidable. All other potential environmental effects pursuant to NEPA would be less than significant or less than significant with mitigation incorporated.

Government Code 65962.5: The project site is not listed on the Hazardous Waste and Substances Sites List as set forth in Government Code Section 65962.5 (Cortese List).

Project Site Location Map

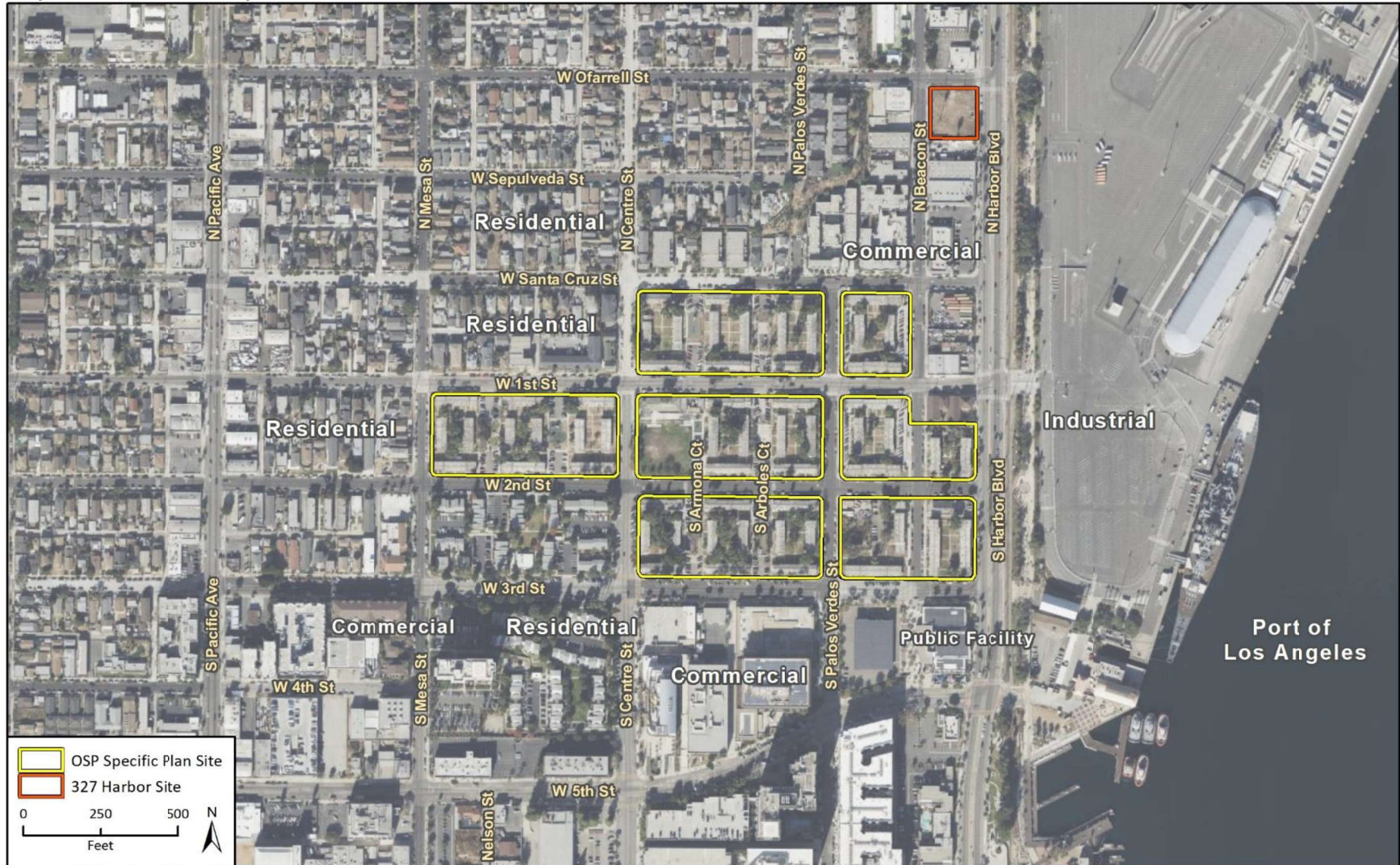


Fig 2-2 Project Location 20220624
