## City Letter Regarding Bail Schedules

Today, Staff sent a letter signed by the City Council to Lomita Sheriff's Station Capt. Kimberly Guerrero regarding 2023 Los Angeles Superior Court felony and misdemeanor/infraction bail schedules (see attached letter). The letter expressed concern that the October 1, 2023 bail schedules adopted by the Executive Committee of the Los Angeles County Superior Court may fail to adequately protect residents of our community from the potential for arrestees, who are either cited and field released or are booked in a jail and then immediately released, to reoffend while released on "zero-bail" and awaiting arraignment. Staff and the City Attorney's Office will continue to monitor this issue.

# Public Advisory

The Los Angeles County Department of Public Health has received multiple reports of dogs in L.A. County experiencing a sudden respiratory illness of unknown origin, similar to case reports in other states. This illness is currently known as:

## Atypical Canine Infectious Respiratory Disease (aCIRD)

**Symptoms of aCIRD include:** cough, nasal discharge, sneezing, and lethargy

**If your dog is experiencing these symptoms:**

1. Contact your pet's veterinarian so the pet may be evaluated, and, if indicated, the appropriate tests and medications may be provided.
2. Isolate sick dogs at home for a minimum of 28 days past the first day of the onset of illness. Dogs exposed to the sick dog should quarantine at home and away from other dogs for 14 days to monitor them for signs and symptoms of illness.
3. Clean regularly and disinfect surfaces, doorknobs, keyboards, and animal equipment. To disinfect, use an EPA-registered disinfecting product or a stronger bleach solution.
4. Keep the dog home and away from day care, boarding kennels, grooming facilities, and dog parks.
5. If a dog becomes ill after being boarded or being in a facility, owners should take it to a veterinarian for evaluation and they should also notify the facility about the illness.

## L.A. County Department of Public Health Investigating Respiratory Disease in L.A. County Dogs

The L.A. County Department of Public Health is investigating a respiratory illness currently known as Atypical Canine Infectious Respiratory Disease (aCIRD) in L.A. County. Dog owners should look out for symptoms such as a cough, sneezing, nasal discharge, and lack of energy in their dogs. If a dog is experiencing these symptoms, owners should take the following steps:

1. Contact their pet's veterinarian so the pet may be evaluated, and, if indicated, the appropriate tests and medications may be provided.
2. Isolate sick dogs at home for a minimum of 28 days past the first day of the onset of illness. Dogs exposed to the sick dog should quarantine at home and away from other dogs for 14 days to monitor them for signs and symptoms of illness.
3. Clean regularly and disinfect surfaces, doorknobs, keyboards, and animal equipment. To disinfect, use an EPA-registered disinfecting product or a stronger bleach solution.

4. Keep the dog home and away from day care, boarding kennels, grooming facilities, and dog parks.
5. If a dog becomes ill after being boarded or being in a facility, owners should take it to a veterinarian for evaluation and they should also notify the facility about the illness.

### Utility Pole Repair Work

On the afternoon of November 27, a Frontier communication pole was reported to have snapped on Exultant Drive near Dauntless Drive in the Seaview neighborhood. SCE confirmed that the pole did not have power and a Frontier crew was dispatched. The broken pole was removed and replaced that evening and additional work is being performed to support the new pole.



## **Residential Fire Insurance Advocacy Letter Now Available on the City Website**

Need help finding fire insurance for your home? The increasing frequency and severity of wildfires in California have heightened the risk to homes and communities, leading to significant challenges in the residential fire insurance market. Homeowners across the state, particularly in areas prone to wildfires, are confronting rising premiums, coverage reductions, and even policy cancellations.

In RPV, the City has received numerous reports of residents facing increased premiums or losing their fire insurance coverage, reflecting the broader, statewide insurance market challenges have prompted concerns among residents regarding the availability and affordability of their fire insurance.

Recognizing the issues of rising premiums, coverage reductions, and policy cancellations, particularly in wildfire-prone areas, the City's Emergency Preparedness Committee (EPC) collaborated with City Staff to create a [comprehensive insurance resource letter \(PDF\)](#) (see attached letter).

This advocacy tool is designed to facilitate effective communication between RPV residents, businesses, and their respective insurance providers. It underscores the comprehensive and ongoing fire risk reduction efforts undertaken by both the City of Rancho Palos Verdes and the Los Angeles County Fire Department. These detailed measures demonstrate a strong commitment to minimizing fire hazards and enhancing community safety. The information in the letter provides a solid foundation for homeowners and businesses to advocate for the maintenance of their existing insurance policies and to potentially negotiate reduced premium rates.

Residents and business owners can access this valuable advocacy tool on the City's dedicated Home Fire Insurance Information and Resources webpage at [rpvca.gov/fireinsurance](http://rpvca.gov/fireinsurance). To maximize reach and awareness, the City plans to leverage various communication platforms. These include announcements at City Council meetings, information shared in City newsletters, social media posts, and making printed copies available at key locations ensuring the community is well-informed about the availability of this resource.

### Pet Preparedness Tips

Are you a pet owner? Pets are an essential part of our society; for many, they are an extension of their household and family members. In an emergency, your pets will be even more dependent on you for their safety and well-being.



Have you thought about how to prepare so that your pet is safe in case of a disaster? Check out the easy-to-follow tips from [Ready.gov](http://Ready.gov)

### MAKE A PLAN:

- **Have an evacuation plan for your pet:** Many public shelters and hotels do not allow pets inside. Identify a safe place to take your pets before disasters and emergencies happen.

- **Develop a buddy system:** Before an emergency, be sure to plan with your neighbors, friends, or relatives to make sure that someone is available to care for or evacuate your pets if you are unable to do so.
- **Have your pet microchipped:** Keep your address and phone number up-to-date and include contact information for an emergency contact outside your immediate area.

### BUILD A KIT:

Ensure your pet is prepared for an emergency by assembling a pet disaster kit before a disaster. Be sure to discuss the types of things you should include in your pet's emergency first aid kit with your veterinarian. Below are basic items you should include in your pets' disaster kits.

#### Your kit should include:

- **Food.** Keep several days' supply of food in an airtight, waterproof container.
- **Water.** Store a water bowl and several days' supply of water.
- **Medicine.** Keep an extra supply of the medicine your pet takes on a regular basis in a waterproof container.
- **First aid kit.** Talk to your veterinarian about what is most appropriate for your pet's emergency medical needs.
- **Collar with ID tag and a harness or leash.** Include a backup leash, collar, and ID tag. Have copies of your pet's registration information and other relevant documents in a waterproof container and available electronically.
- **Traveling bag, crate, or sturdy carrier,** ideally one for each pet.
- **Sanitation needs.** Include pet litter and litter box (if appropriate), newspapers, paper towels, plastic trash bags, and household chlorine bleach to provide for your pet's sanitation needs.
- **A picture of you and your pet together.** If you become separated from your pet during an emergency, a picture of you and your pet together will help you document ownership and allow others to assist you in identifying your pet.
- **Familiar items.** Put your favorite toys, treats or bedding in your kit. Familiar items can help reduce stress for your pet.

#### Tips For Large Animals:

Emergency preparedness is important for all animals, but it is especially important for horses and larger animals because of their size and special transportation needs. Consider these tips as you prepare your evacuation plan:

- Before an emergency, make arrangements to shelter your animals at two different locations far apart from each other.
- If you have large animals, evacuate when you hear the evacuation warning.
- Train horses to lead a trailer so that they become comfortable with the process.
- Keep your truck and trailer in safe, working condition (gas tank full). If you don't have a truck and trailer, make arrangements in advance to have someone evacuate your animals.
- Know who is evacuating your animals. Be sure to exchange phone numbers, California Driver's License numbers, and other relevant information with the person evacuating your horse. Know where your animals will be taken.
- Network with your neighbors prior to an emergency. Work together to help horse/large pet owners on your street who do not have horse trailers or who are not home during an emergency.

- Alarm systems:  If you have an alarm system, ensure it's in working order. Activate it when leaving, even if it's just for a short period.

## FINANCE DEPARTMENT

### Gross Domestic Product (Second Estimate) - Third Quarter 2023

Real gross domestic product (GDP) increased at an annual rate of 5.2% in the third quarter of 2023 according to the "second" estimate released by the Bureau of Economic Analysis. The GDP estimate released today is based on more complete data when compared to the "advance" estimate of 4.9% issued last month. Third quarter results follow a 2.1% increase in real GDP in the second quarter.



The increase in real GDP reflected increases in consumer spending, private inventory investment, exports, state and local government spending, federal government spending, residential fixed investment, and nonresidential fixed investment. Compared to the second quarter, the growth in real GDP is primarily attributed to acceleration in consumer spending and private inventory investment, and an upturn in exports.

### Case-Shiller Home Price Index – September 2023

On November 28, data from the S&P CoreLogic Case-Shiller Home Price Indices, the leading measure of residential real estate prices, were released for September. The following summary provides a brief overview of the monthly and annual changes reported in the U.S. National Index and Los Angeles Home Price Index.

#### Month-over-Month

The U.S. National Index posted a 0.3% month-over-month increase in September, continuing the upward trend. The rise in home prices marks the eighth consecutive monthly gain since prices bottomed out in January 2023. Similarly, the Los Angeles Home Price Index rose by 0.19% over the previous month.

#### Year-over-Year

Over the past 12 months, the National Index reported a 3.9% annual change as of September. According to the report, only three of the 20 cities measured in the major metro markets reported lower prices in September versus a year ago. In comparison, home prices reported in the Los Angeles Index increased by 5.2% over the prior year.



On November 15, the LAX Community Noise Roundtable held its regularly scheduled meeting to discuss a wide range of agenda items (attachments) including noise concerns caused by passenger jets arriving and departing from LAX (Los Angeles International Airport). Los Angeles World Airports (LAWA) staff distributed routine passenger jet data for those aircraft that overflew the Peninsula during September-October 2023 (see attachments). ### UCLA South Bay Update

On November 20, 2023, UCLA South Bay Staff provided the first official announcement about the UCLA South Bay campus since the acquisition of the site from Marymount California University in September 2022. This announcement stated that a Joint Task Force on the Academic Mission of the UCLA Campus Expansion selected an academic focus of sustainability, climate change and environmental justice for the UCLA South Bay campus. This was in part due to the location of the campus in proximity to the Pacific Ocean and the largest port complexes in the world. An Implementation Committee, chaired by Steve Yu, Chief Operating and Financial Officer for UCLA South Bay, has been charged with designing the academic programs and ensuring physical spaces are ready for use, with the goal of having programs operating by Fall 2024. UCLA South Bay is also in the process of exploring strategic community partnerships with area groups including AltaSea (a public-private





## Beacon Award Results

The City received the results for its participation in the Institute for Local Government's Beacon Award for Leadership and Innovation in Climate Resilience and Adaptation. While the City did not receive an award, the City was thanked for its submission and for its ongoing leadership on climate issues.







Captain Guerrero:

Like many cities in the county, the City Council is concerned that the October 1, 2023 “bail” schedules adopted by the Executive Committee of the Los Angeles County Superior Court may fail to adequately protect residents of our community from the potential for arrestees, who are either cited and field released or are booked in a jail and then immediately released, to reoffend while released on “zero-bail” and awaiting arraignment.

To that end, City staff and the City Attorney have been closely monitoring both the *Urquidi* and the *Whittier* litigations regarding the bail protocols adopted by the Court. The City has appreciated the expanded process of detaining in jail pending magistrate review (“MR”), which utilizes an on-call magistrate to determine whether offenders should remain in custody or be subject to some conditions upon pre-arrangement release.

This “MR” process, which involves an *individualized* review by a magistrate of facts and circumstances of a particular crime and/or individual, needs to be fully utilized by your station particularly with respect to arrestees from the City of Rancho Palos Verdes. We write, on behalf of a unanimous City Council to ***urge your station to elevate all of your arrests made in the City to the status of Magistrate Review.***

We would further recommend that the Los Angeles County Sheriff urge the Executive Committee of the Los Angeles County Superior Court to enhance the magistrate review process to include expanded review of arrestee prior offense history, arrestee repeat offense history,

arrestee out-of-state offense history, and such other historical factors as may be provided to a magistrate during the review process.

We are concerned, however, the Court's 2023 bail schedules may have "tipped the scales" in a direction that negatively impacts the deterrent value of pre-trial detention, may actually reduce fear of incarceration by those who are released on zero-bail from re-offending prior to arraignment, hamper law enforcement's ability to investigate crimes, and exacerbate our residents' concerns over public safety. Your attention to our request will be appreciated.

**RE: City of Rancho Palos Verdes Efforts to Help Reduce Wildfire Risks**

Dear Insurance Agent,

The City of Rancho Palos Verdes is committed to reducing wildfire risks in our community using prevention and early detection tools, along with home hardening techniques, aimed to protect property and lives. You are receiving this letter to learn more about the tools the City utilizes to achieve its commitment to reducing wildfire risk which should translate to secured and reduced premium rates.

Rancho Palos Verdes, along with the neighboring Peninsula Cities, is protected by the Los Angeles County Fire Department (LACoFD), [a Class II department recognized by the Insurance Services Office \(ISO\)](#). LACoFD covers approximately 26.3 square miles and serves an estimated population of 65,008. Our protection includes six strategically located fire stations, two of which are in Rancho Palos Verdes, each staffed 24/7 by dedicated full-time professionals.

Our partnership with LACoFD is a key component of our comprehensive strategy to reduce wildfire risks. This includes maintaining city-owned landscaped and open spaces near residential areas through year-round fuel modification. An important aspect of this strategy is our robust [annual weed abatement program](#) from April through July, aimed at creating defensible spaces between open areas and combustible structures, significantly reducing fire fuel load. Regular inspections ensure adherence to [LACoFD's Defensible Space requirements](#). In Rancho Palos Verdes, these regulations necessitate fuel modification within a 200-foot radius around structures.

Notably, the City has been [pioneering the use of goat grazing for fuel modification](#) since 2008. This initiative, applied to city-owned lands including public rights-of-way, emphasizes the role of goats as a key element in our fuel modification strategy. Their ability to navigate and manage difficult terrains makes them exceptionally effective, not only in reducing fire risks but also in fostering the resurgence of native vegetation. This eco-friendly approach underscores our commitment to sustainable and innovative wildfire risk management.

In collaboration with neighboring Palos Verdes Peninsula cities and the County of Los Angeles Office of Emergency Management, an evacuation management tool known as [Zone Haven](#) was launched in May of 2023. This critical emergency preparedness tool assists local public safety agencies and Peninsula cities in managing evacuations efficiently during emergencies including wildfires. Residents can access this tool at [PVReady.gov](#), which helps in quickly determining evacuation zones and necessary actions during wildfires or other emergencies. This tool provides residents with real-time information if and when an emergency occurs and how the community should respond based on geographic zones.

The [RPV City Council has approved a five-year agreement](#) with [Pano AI](#) to install a network of high-mounted cameras for early wildfire smoke detection utilizing artificial intelligence (AI). This AI-enabled wildfire camera detection system, covering a 15-mile-plus radius, enhances our fire ignition response and readiness capabilities. The cameras provide up-to-date time-lapse imagery and vital information about a fire's location and movement, improving our ability to respond promptly and accurately to wildfire threats. This system has already demonstrated its effectiveness in delivering prompt and precise alerts for fire ignitions, greatly enhancing the readiness and response capabilities of the Peninsula cities and public safety agencies.

Moreover, in a continued effort to enhance wildfire risk management, LACoFD, in partnership with California Water Service (Cal Water) and the [City of Rancho Palos Verdes, proudly unveiled a cutting-edge HeliPod firefighting dip source on June 20, 2023](#). This state-of-the-art installation, strategically positioned at the RPV Civic Center, represents a proactive step in strengthening our readiness and timely response to wildfires. A [HeliPod](#) allows a firefighting helicopter to automatically fill up four times faster while hovering than by replenishing its tank by landing. When every second counts, this time-saving measure can help save and protect lives and homes. The 7,000-gallon capacity HeliPod is installed and housed at the City of Rancho Palos Verdes's Civic Center and will benefit and protect communities throughout Southern California including all four Peninsula cities.

The City has further initiated the following measures to enhance community safety against wildfires:

- Coordination with Southern California Edison on proactively hardening utility lines and pursuing grants to underground utility lines in open space areas
- City Council adopted [Multi-Jurisdictional Hazard Mitigation Plan](#), detailing our current and future wildfire mitigation activities. Pages 151-158 of the Mitigation Plan offer detailed insights into these initiatives.






