## CITY MANAGER'S OFFICE

### January 16, 2024 City Council Meeting Highlights

Highlights from the January 16 City Council meeting:

- In response to safety concerns, the Council approved left-turn signal arrows for Hawthorne Boulevard at the intersection of Eddinghill Drive/Seamount Drive. Accounting for time for budgeting, design, bidding, obtaining materials, and construction, the project is expected to be completed in one to one-and-a-half years.
- Short-term traffic calming measures were approved for Miraleste Drive and Palos Verdes Drive East, including narrower lanes, high-visibility crosswalks, advisory signs, a rapid flashing beacon on Palos Verdes Drive East south of Marion Drive, and continued traffic enforcement. Longer-term measures could be considered in the future, if needed.
- At the request of public interest advocacy group CALPIRG, the Council opposed an income-based fixed charge on utility bills being proposed by investor-owned utilities, including SCE, which would result in a high fixed charge for higher-income households.
- Representatives from each of the City's advisory boards — which advise the City Council on matters related to Civic Center planning, emergency preparedness, finance, infrastructure, land use, and traffic safety — gave updates on their recent activities and plans for 2024.

## RPV Goes to Sacramento for Annual Legislative Tour

Earlier this week, Mayor John Cruikshank, Councilmember Dave Bradley, and City Manager Ara Mhrianian attended the California Contract Cities Association (CCCA) Sacramento Legislative Tour. The annual tour gives CCCA members the opportunity to directly interface with legislators to share issues impacting cities and directly hear from legislative leadership and various state constitutional officers regarding their priorities for the year.



Mayor Cruikshank, Councilmember Bradley, and City Manager Mhrianian had the opportunity to meet face-to-face with Senator Ben Allen and Assemblymember Al Muratsuchi to discuss the Portuguese Bend Landslide, the City's Landslide Remediation Project, and other City priorities including the Abalone Cove and Klondike Canyon Landslide Abatement Districts. City Manager Mhrianian also met with the State Geologist, Jeremy Lancaster, to update him on the Landslide.



## RPV Welcomes Sakura City Exchange Students

Earlier this week, Mayor Cruikshank and City Manager Mihranian attended a welcome reception hosted by RPV's sister city, Sakura City, Japan, for exchange students in its homestay program with Miraleste Intermediate School. RPV officials welcomed the Japanese students at a ceremony held at the DoubleTree Hotel in Torrance, which included



performances by students from Miraleste Intermediate, Ujise Junior High School, and Kitsuregawa Junior High School. Established in 2001, the exchange program has enabled students from both cities to attain a robust cultural understanding and appreciation of each other's countries. 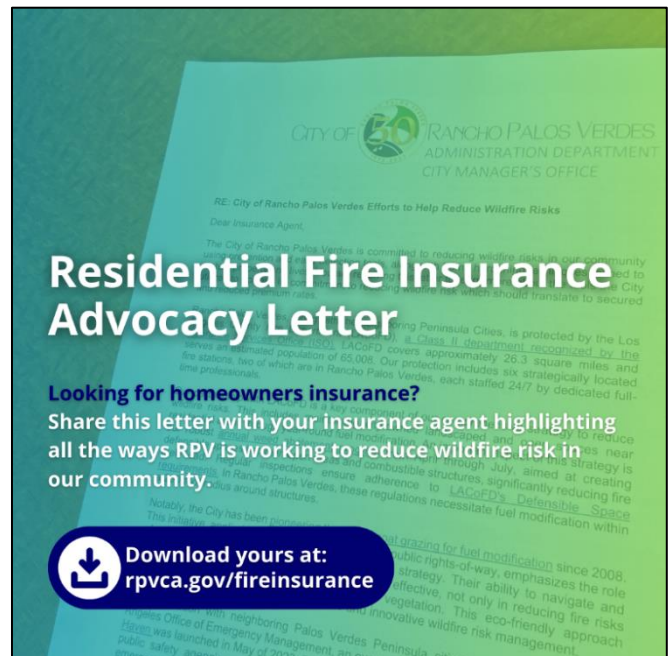


## Residential Fire Insurance Advocacy Letter - Now Available on the City Website

Are you struggling to find adequate fire insurance for your home? In California, the increasing frequency and severity of wildfires have significantly impacted the residential fire insurance market. This has resulted in higher premiums, reduced coverage options, and, in some cases, policy cancellations.

In RPV, these statewide challenges are evident, with many residents reporting increased premiums and difficulty in maintaining their fire insurance coverage. In response to these concerns, the City's Emergency Preparedness Committee (EPC), in collaboration with City Staff, has developed a [comprehensive insurance resource letter \(PDF\)](#) (see attached letter).

This advocacy tool is tailored to help you, our residents and businesses, communicate effectively with your insurance providers to advocate for maintaining your current insurance policies and potentially negotiating lower premiums. We encourage you to utilize this resource to its full extent.

## Northridge Earthquake 30<sup>th</sup> Anniversary – Are you Ready?

At 4:31 a.m. on January 17, 1994, a 6.7-magnitude earthquake centered in Northridge hit the Los Angeles area, collapsing several buildings, destroying stretches of freeways, and sparking several fires. It lasted only 30 seconds but claimed at least 57 lives, injured thousands, and caused billions of dollars in property damage.

January 17, 2024 marks the 30<sup>th</sup> anniversary of the devastating 1994 Northridge earthquake that shook Southern California.



The Northridge quake, named after the San Fernando Valley community near its epicenter, was the costliest in U.S. history, with damages estimated at more than \$20 billion. The damage was widespread, as buildings, shopping centers, parking lots, and portions of major freeways all collapsed. The fact that the quake occurred on a federal holiday (Martin Luther King Jr. Day) and in the early morning hours when most people were home in bed was critical in reducing the number of casualties.

Images of collapsed apartments, freeways, bridges, and buildings associated with the 1994 Northridge earthquake remind us of the need to prepare ourselves and our families for the possibility of another major earthquake striking Los Angeles.

The next "big one" is not a matter of if, but when!

We can all do our part to stay prepared by taking simple steps such as [assembling an emergency kit](#), [developing a family emergency plan](#), learning the proper way to [shut off](#)



[utilities](#), and practicing taking the proper actions, such as "[Drop, Cover, and Hold On](#)," to ensure you and your family stay safe in the event of a devastating earthquake.

Residents are also encouraged to learn more about [Earthquake Warning California](#), the country's first publicly available statewide earthquake warning system that could give California residents crucial seconds to take cover before they feel shaking. To receive earthquake warnings, individuals and family members can download the [MyShake App](#). The app can be downloaded for mobile devices at no cost from Google Play and the Apple App Store. App location services must be set to "always on" so that ground sensors can alert those nearby when shaking is detected.

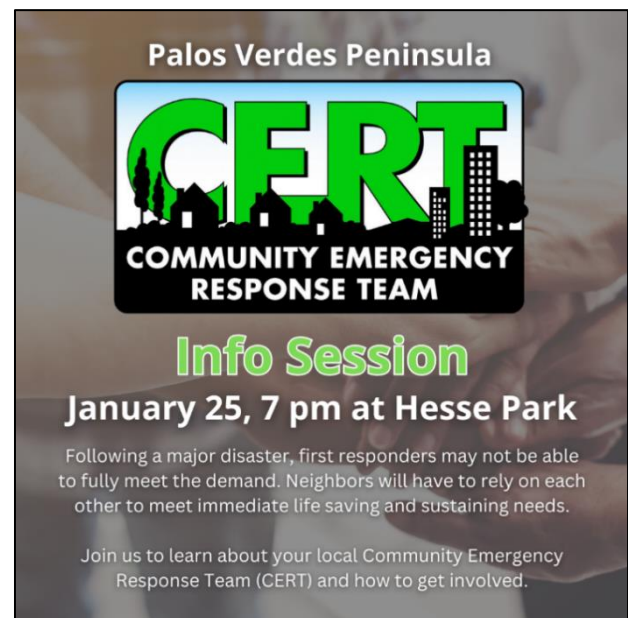

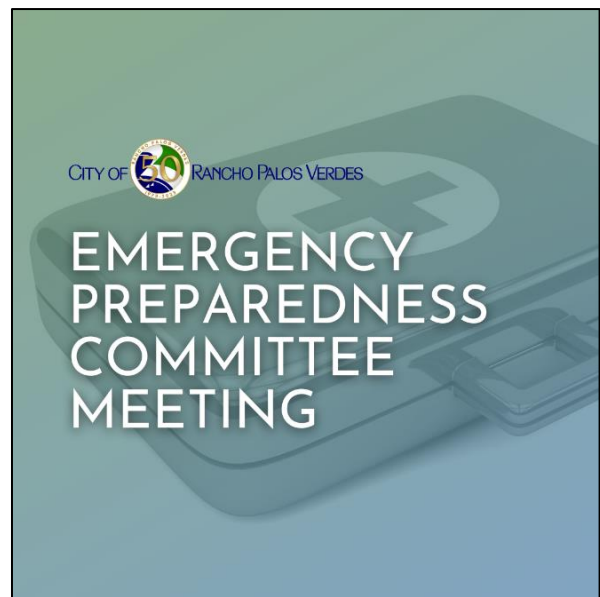

For courses sponsored by the Palos Verdes Amateur Radio Club, students thru grade 12 who pass their examination at a PVARC VE test session will, upon application to the Club, be eligible for reimbursement up to a maximum of \$50 to cover the cost of materials and the examination fee.

Everyone who obtains their first ham radio license through a PVARC VE test session, regardless of age, will receive a free membership in the Palos Verdes Amateur Radio Club for the remainder of the current calendar year.



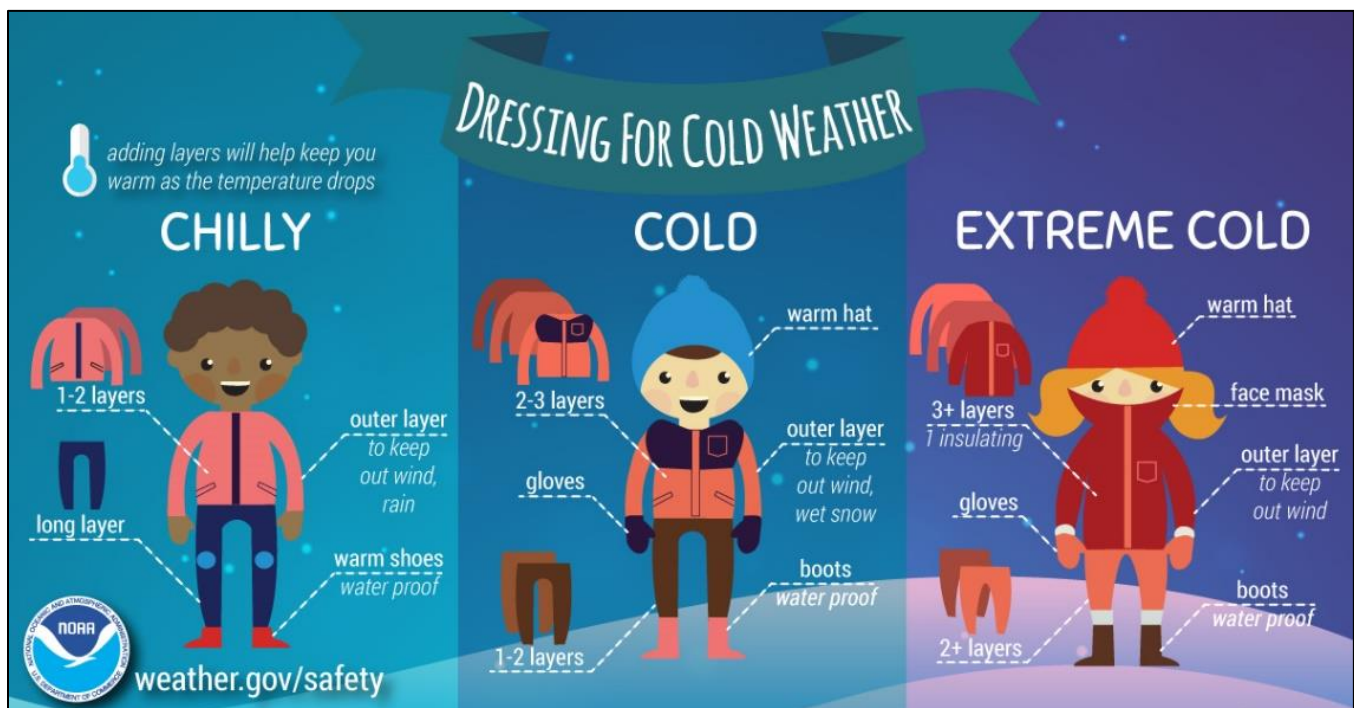

## Winter Weather Safety Tips

Before a storm strikes, make sure your home, office, and vehicles are stocked with the supplies you might need. Make sure farm animals and pets also have the essentials they will need during a winter storm. [Know how to dress for varying degrees of cold weather.](#)



## At Home and Work

Your primary concerns at home or work during a winter storm are loss of heat, power, and telephone service and a shortage of supplies if storm conditions continue for more than a day. **In either place, you should have available:**

- Flashlight and extra batteries
- Battery-powered National Oceanic and Atmospheric Administration (NOAA) weather radio and portable radio to receive emergency information
- Extra food and water such as dried fruit, nuts, granola bars and other food requiring no cooking or refrigeration.
- Extra prescription medicine
- Baby items such as diapers and formula
- First-aid supplies
- Heating fuel: refuel before you are empty; fuel carriers may not reach you for days after a winter storm
- Emergency heat source: fireplace, wood stove, or space heater properly ventilated to prevent a fire
- Fire extinguisher and smoke alarm; test smoke alarms monthly to ensure they work properly
- Extra pet food and warm shelter for pets
- [Review generator safety](#): Never run a generator in an enclosed space.
- Ensure your carbon monoxide detector is working correctly and the outside vent is clear of leaves and debris. During or after the storm, make sure it is cleared of snow.
- [Home fires](#) are common each winter when trying to stay warm. Review ways to keep your home and loved ones safe.



## In Vehicles

Before you leave the house, especially before a long winter trip, ensure all fluid levels are full and that the lights, heater, and windshield wipers are in proper condition. Keep your gas tank near full to avoid ice in the tank and fuel lines. Avoid traveling alone. Let someone know your timetable and primary and alternate routes. Then call 511 for the latest traffic and road incidents, including construction and weather conditions and restrictions. Every state offers this Department of Transportation service. Call before you leave; it might change your plans!

Fully check and winterize your vehicle before the winter season begins. Carry a winter storm survival kit that includes the following:

- Mobile phone, charger, batteries
- Blankets/sleeping bags
- Flashlight with extra batteries
- First-aid kit
- Knife
- High-calorie, non-perishable food
- Extra clothing to keep dry
- Large empty can to use as an emergency toilet, tissues, toilet paper, and paper towels



- Small can and waterproof matches to melt snow for drinking water
- Sack of sand or cat litter for traction
- Shovel
- Windshield scraper and brush
- Tool kit
- Tow rope
- Battery booster cables

### Staying Safe During Winter Weather

Stay off the roads if at all possible. If trapped in your car, stay inside. Limit your time outside. If you need to go outside, then wear layers of warm clothing. Watch for signs of frostbite and hypothermia.

#### Learn the signs of, and basic treatments for, frostbite and hypothermia:

- **Frostbite** causes loss of feeling and color around the face, fingers, and toes.
  - **Signs:** Numbness, white or grayish-yellow skin, firm or waxy skin.
  - **Actions:** Go to a warm room. Soak in warm water. Use body heat to warm. Do not massage or use a heating pad.
- **Hypothermia** is an unusually low body temperature. A temperature below 95 degrees is an emergency.
  - **Signs:** Shivering, exhaustion, confusion, fumbling hands, memory loss, slurred speech, or drowsiness.
  - **Actions:** Go to a warm room. Warm the center of the body first—chest, neck, head, and groin. Keep dry and wrapped in warm blankets, including the head and neck.

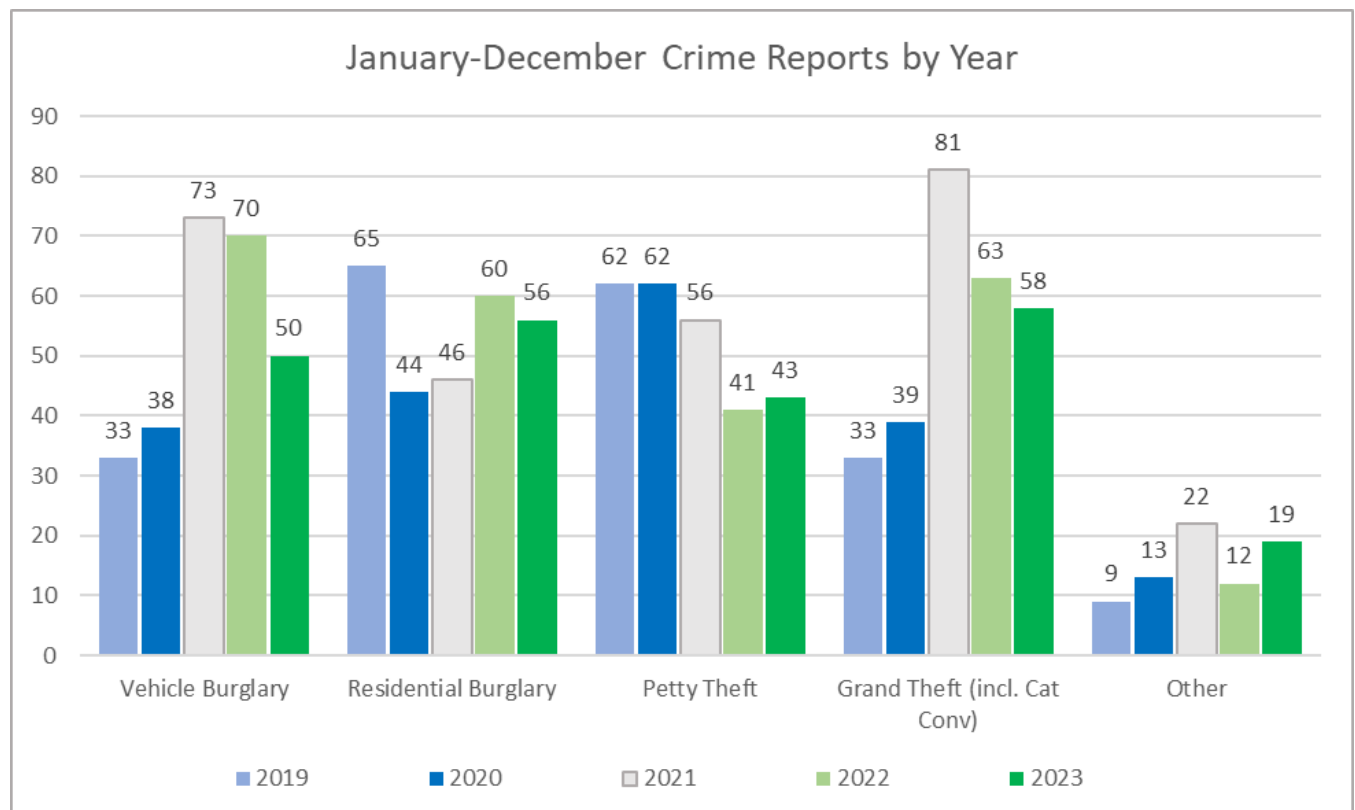

## Public Safety Reminder: Lock Up for a Safer Neighborhood

Securing your home is a simple yet effective way to deter potential intruders and enhance the overall safety of your neighborhood. Here are a few key tips to keep in mind:

- 1. Lock all doors and windows:** Before leaving your home or heading to bed, make sure all doors and windows are securely locked. This includes both front and back doors, as well as any windows that may serve as entry points.
- 2. Invest in quality locks:** Consider upgrading your locks to more robust and secure options. Deadbolt locks, for example, provide an extra layer of protection and are an excellent investment in home security.
- 3. Secure sliding doors:** If you have sliding glass doors, install a bar or rod in the track to prevent them from being forced open. This simple measure can significantly enhance the security of your home.



4. **Don't forget the garage:** Keep your garage doors locked, and if you have an attached garage, ensure the door leading into your home is equally secure.

## **PVPUSD School Resource Officer**

Last night, the City Council approved a Memorandum of Understanding (MOU) between the four Peninsula cities and the Palos Verdes Peninsula Unified School District to fund the School Resource Officer program for an additional three years. The MOU stipulates that the school district will pay 50% of the cost of the agreement with Allied Universal for two School Safety Officers up to \$150,000 annually while the four Peninsula cities will split the other 50% up to \$150,000 annually according to a formula based on enrollment and population, as follows:

- City of Rancho Palos Verdes: 65% or \$97,500
- City of Palos Verdes Estates: 20% or \$30,000
- City of Rolling Hills Estates: 13% or \$19,500
- City of Rolling Hills: 2% or \$3,000

### Consumer Price Index – December 2023

#### Consumer Price Index (U.S.)

The Consumer Price Index (CPI) increased by 0.3% in December, rising on a seasonally adjusted basis for the second month in a row. Measured annually, the CPI index for all items was up by 3.4% compared to December 2022. The CPI for all items less food and energy (core inflation) also rose by 0.3% in December, matching the same increase as in

November. Core inflation increased by 3.9% over the past 12 months, down slightly after rising by 4% over the 12 months ending November.

Charts 1 and 2 below illustrate the monthly and yearly percent changes in CPI based on the two key measures of inflation.

Chart 1. U.S. One-month Percent Change in CPI (seasonally adjusted)

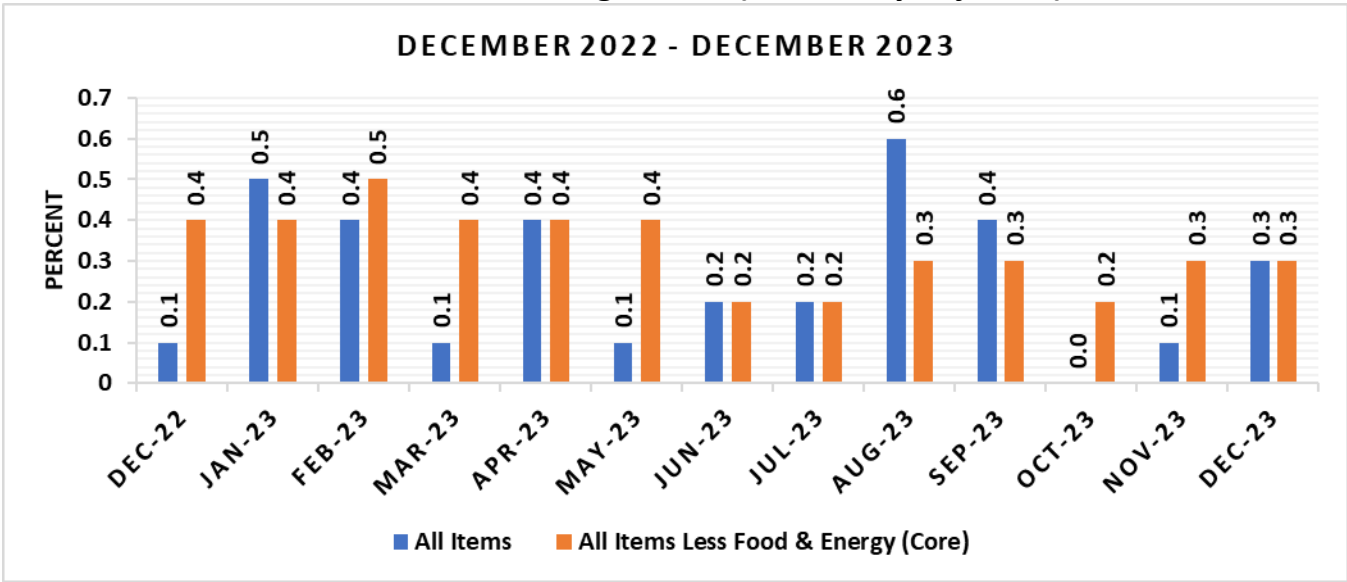
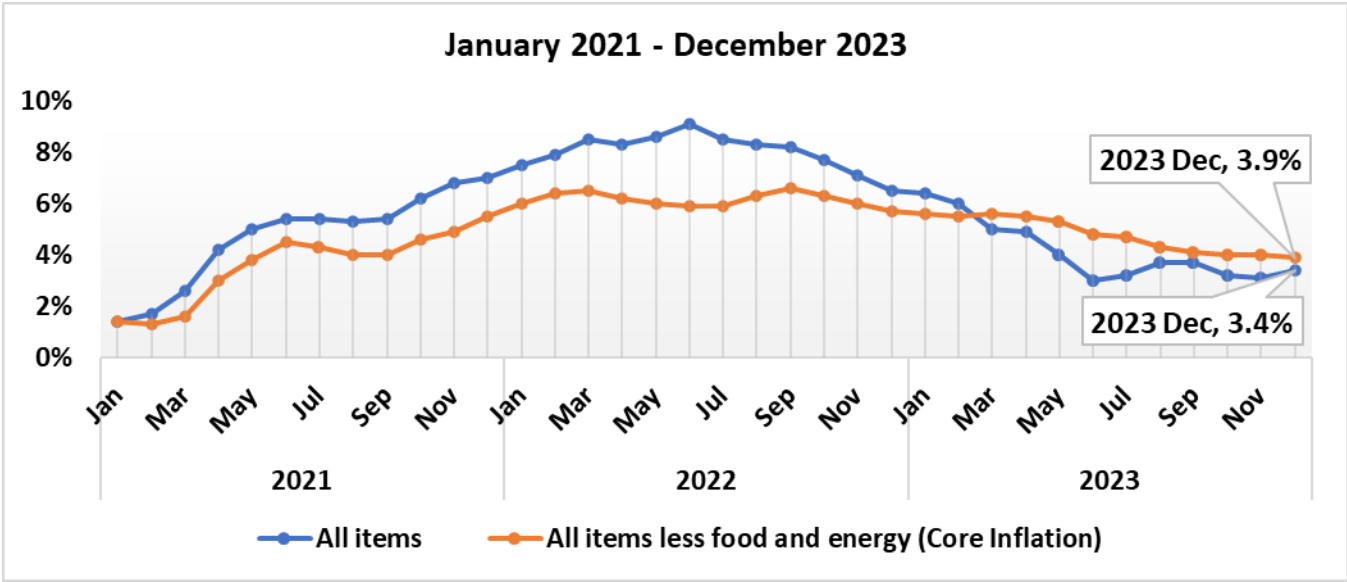


Chart 2. U.S. 12-month Percent Change in CPI (not seasonally adjusted)

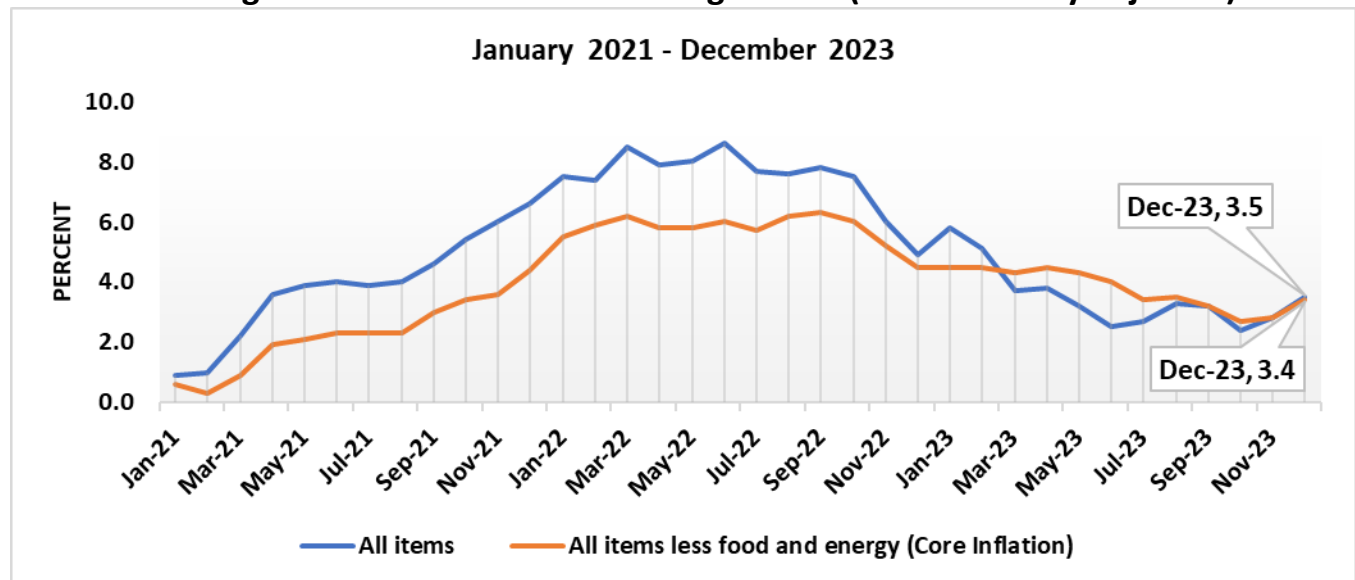


In summary, the index for shelter continued to rise in December, contributing to over half of the monthly all items increase. The shelter and food indexes remain elevated on an annual basis, resulting in sustained higher prices in these categories. The energy index has decreased compared to a year ago due to the lower cost of natural gas.

### Consumer Price Index (Los Angeles)

Prices in the Los Angeles area were unchanged from November to December. Measured annually, CPI rose by 3.5% over the past 12 months. Core inflation grew by 0.3% over the month and by 3.4% over the year. As reported, the higher prices for shelter were offset by lower prices for gasoline, leaving prices unchanged over the month. Over the last 12 months, however, energy prices increased by 3.1% due to increases in the price of electricity, contributing to the higher annual rate of inflation in December. The annual percentage changes in CPI for both indexes are illustrated in Chart 3 below.

### Ladera Linda Community Park Project Update

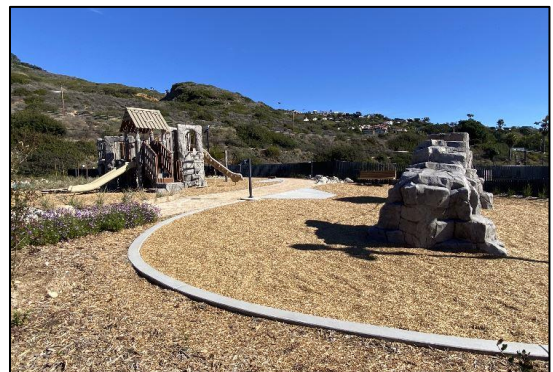

## Repairs to Palos Verdes Drive South in the Landslide Area

Work on Palos Verdes Drive South to repair the roadway surface in the landslide area is underway this week. This work will address needed repairs at various locations. Roadway inspection will continue on a regular basis to identify any additional repairs that may become necessary.

Traffic control will be in place. Therefore, expect delays when driving in this area. Please slow down, drive cautiously, and obey all signs and instructions when driving through the work zones.



## Hawthorne Boulevard Traffic Impacts

Beginning on January 18, traffic on Hawthorne Boulevard in the vicinity of Country Lane/Ocean Crest Drive will be impacted by work in the City of Rolling Hills Estates on the Peartree Lane Landslide Remediation Project.

Traffic impacts will occur intermittently for approximately 5-6 days during a 30-day period. During those days, Hawthorne Boulevard will be impacted from 9 a.m. to 3 p.m. Lanes will be reduced to one lane in each direction and the speed limit will be reduced from 45 mph to 35 mph.

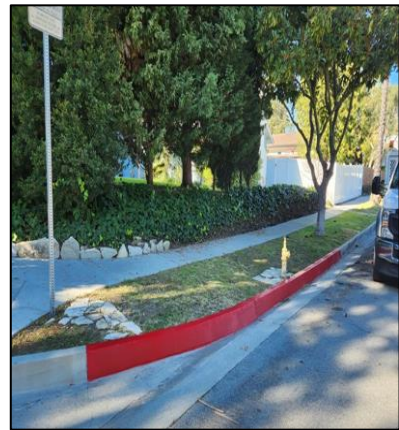
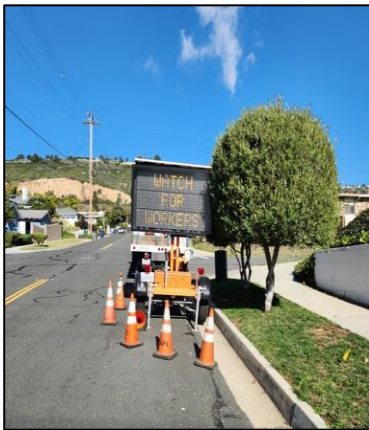

- Repaired wood post and signage on Forrestal Drive.

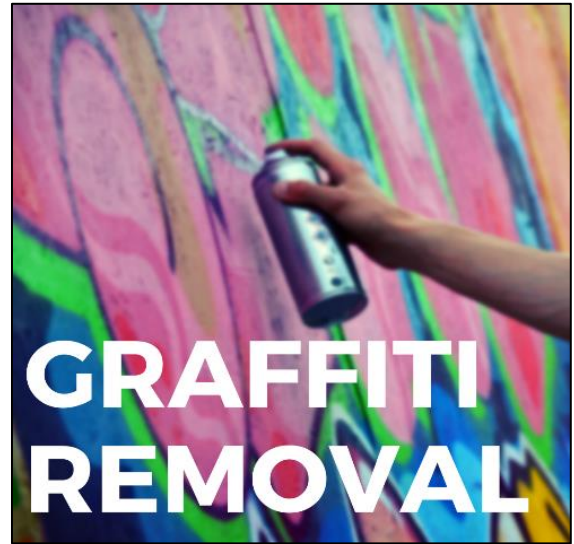






## Graffiti Removal

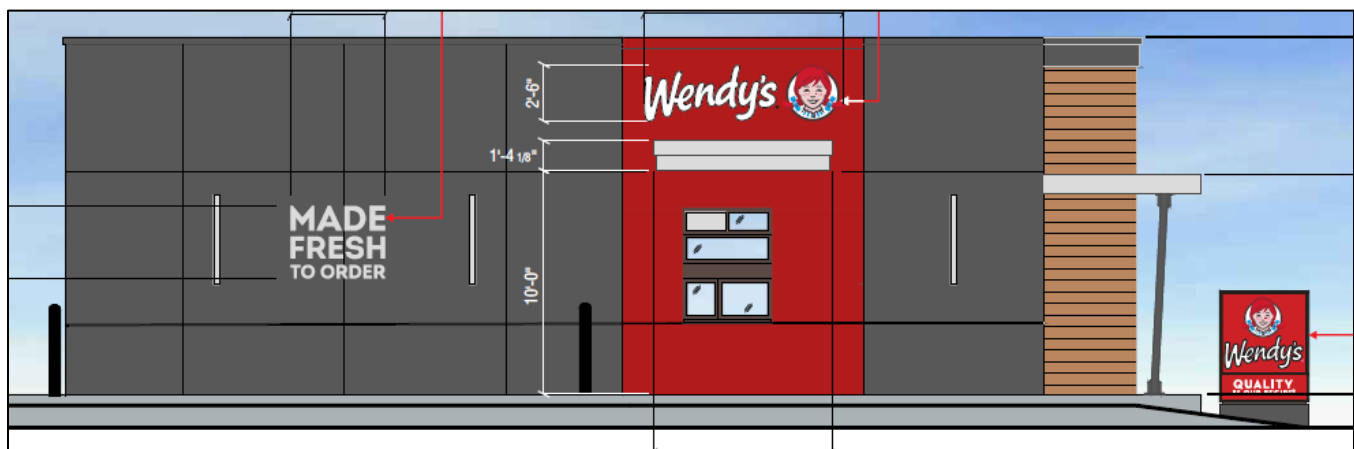

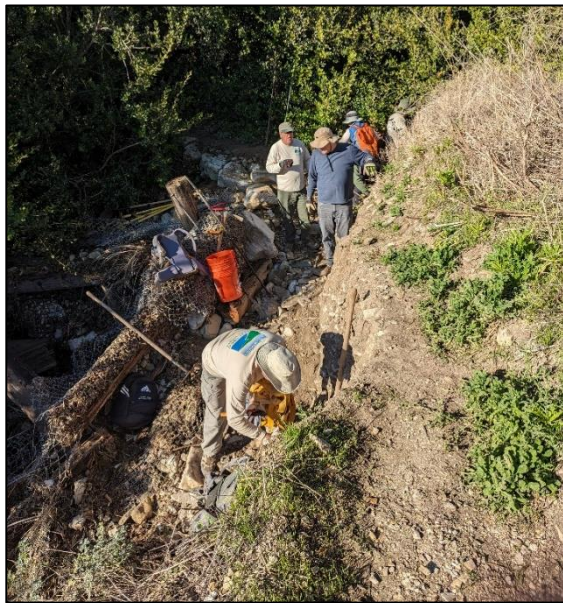




## Filiorum Reserve

**RE: City of Rancho Palos Verdes Efforts to Help Reduce Wildfire Risks**

Dear Insurance Agent,

The City of Rancho Palos Verdes (RPV) is dedicated to minimizing wildfire risks through prevention, early detection, and home hardening techniques aimed at safeguarding both property and lives. On behalf of the policy owner, this letter is being provided to you and your adjuster outlining the City's strategies and measures to reduce wildfire risk intended to contribute to more favorable insurance premium rates and policy availability for our residents and businesses.

RPV collaborates closely with the Los Angeles County Fire Department (LACoFD), [a Class II department recognized by the Insurance Services Office \(ISO\)](#). Covering approximately 26.3 square miles and serving an estimated 65,000 Palos Verdes Peninsula (PVP) residents, LACoFD operates six strategically located fire stations, including two within RPV.

Notably, RPV enhances its wildfire management capabilities with the following measures to significantly improving our emergency response and preparedness:

- Maintaining City-owned landscaped and open spaces near residential areas through year-round fuel modification. RPV's robust [ANNUAL WEED ABATEMENT PROGRAM](#) aims to create defensible spaces between open areas and combustible structures, significantly reducing fire fuel load. Regular inspections ensure adherence to [LACoFD's Defensible Space requirements](#).
- [GOAT GRAZING FOR FUEL MODIFICATION](#): On city-owned lands including public rights-of-way. Goats effectively remove brush and grass from hard to access terrain thereby significantly reducing fire loads and risks.
- [GENASYS PROTECT \(ZONE HAVEN\)](#): Implemented in May 2023, this critical emergency preparedness tool is available to residents at [PVPready.gov](#), as an Evacuation Management Platform in identifying evacuation zones and guiding residents on necessary actions during emergencies.
- [PANO AI'S WILDFIRE CAMERAS](#): This network of AI cameras provide early detection of wildfire smoke across the Palos Verdes Peninsula and has proven effective in delivering timely and accurate early alerts for fire ignitions.
- [HELOPOD FIREFIGHTING DIP SOURCE](#): The City installed a [HeloPod](#) at its Civic Center that is in close proximity to open space and canyons areas enabling rapid water refilling for firefighting helicopters.

The City has further initiated the following measures to enhance community safety against wildfires:

- [Firescaping training workshops.](#)
- [Home hardening videos.](#)
- [Monthly emergency preparedness safety tips.](#)
- Collaborative efforts with Southern California Edison (SCE) for utility line hardening and undergrounding.
- A comprehensive [Multi-Jurisdictional Hazard Mitigation Plan](#), offering in-depth insights into RPV's wildfire mitigation strategies on pages 151-158 of the plan.

(2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.
