Two Charged in July 2023 Double Homicide in RPV

On January 23, local media reported that two suspects already in custody for allegedly committing robberies along Angeles Crest Highway where a man was fatally shot last summer were charged with the killings of two people found days later on the morning of July 24, 2023 inside a parked car in the Pelican Cove parking lot in Rancho Palos Verdes.



According to City News Service, Wendy Sarai Cerritos, 20, and Rossel Jose Hernandez, 22, both of Los Angeles, were both charged with two counts of murder in the shooting deaths of Jorge Ramos, 36, and TaylorRaven Whittaker, 26. Cerritos was also charged with two counts of attempted second-degree robbery, while Hernandez was charged with one count of attempted second-degree robbery. The charges against both defendants include various firearm allegations.

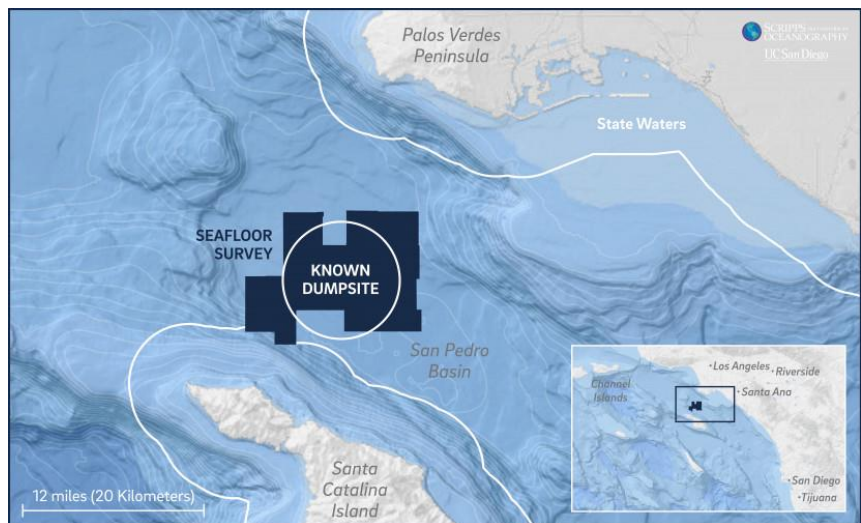


Traveling in groups of four, volunteers tally the number of unsheltered individuals, tents, vehicles, and make-shift shelters they see in their assigned census tract.

California Deep Ocean DDT Community Meeting Today, January 24

DDT, a legacy pesticide, is known to have devastating and long-lasting impacts on wildlife, ecosystems, and human health. DDT was banned in 1972 but contamination persists and the coast off Southern California is home to one of the largest known sites of DDT contamination. While the impacts of near-shore DDT on



the Palos Verdes Shelf have been well-studied, little is known about the status and impacts of DDT dumped in Southern California deep-ocean. The National Oceanic and Atmospheric Administration (NOAA) and the California State Water Resources Control Board are funding over \$15 million of research to provide a greater understanding of the human health and ecological risks due to deep-ocean DDT deposits in Southern California.

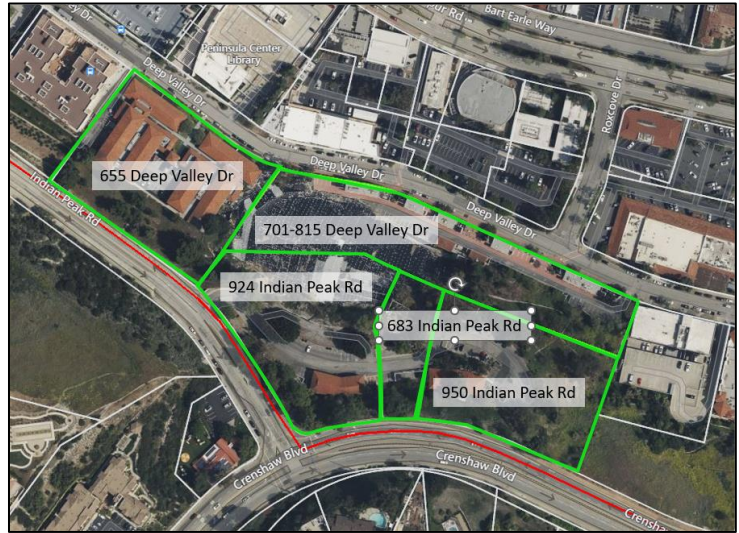

407-Unit Mixed-Use Development Proposed in Rolling Hills Estates

Last night, the Rolling Hills Estates City Council held a special meeting to receive a presentation regarding a 407-unit mixed-use development proposed for Indian Peak Road and Deep Valley Drive near Crenshaw Boulevard on the city's border with Rancho Palos Verdes. City Staff became aware of this project last week and was unable to attend the presentation, which was not live-streamed.

Proposed by property owner Rolling Hills Capital, LLC, the project calls for the demolition of existing buildings and the construction of 407 residential units (including 29 very low-income units, qualifying for a 30% density bonus) in three eight-story buildings and one six-story building on a 10.42-acre site located at 655-815 Deep Valley Drive and 924-950 Indian Peak Road, where a landslide occurred in 1997. Additionally, 3,249 square feet of retail and 503 parking spaces are proposed. An 8-acre portion of the site is identified as an Opportunity Area in the land use element of the city's 2040 General Plan, which considers infill and redevelopment potential in five areas in the city's Commercial District.



The proposed residential development is called the Brickwalk Residences and all units would be for rent. This includes 245 one-bedroom/one-bathroom units, 83 two-bedroom/two-bathroom units, and 79 three-bedroom/three-bathroom units. Access and improvements at the Indian Peak Road site will require coordination with the City of Rancho Palos Verdes as Indian Peak Road and Crenshaw Boulevard are within our City's jurisdiction. To accommodate the density bonus and proposed height maximum of 96.5 feet, the developer is requesting a waiver for the site's 44-foot height limit.

A [staff report \(PDF\)](#) with more information, project plans, and renderings is available on the City of Rolling Hills Estates' website. The Rolling Hills Estates City Council is expected to consider a professional services agreement for environmental review-related work for this project at a future meeting.

Community Development Department Staff will be communicating with Rolling Hills Estates regarding the project, including its potential impacts to RPV residents. Additionally, Staff will monitor this project as part of the biannual Border Issues Status Report.

The City's new Youth Advisory Committee will hold its first meeting on January 29 at 4 p.m. in the Community Room at City Hall and via Zoom.

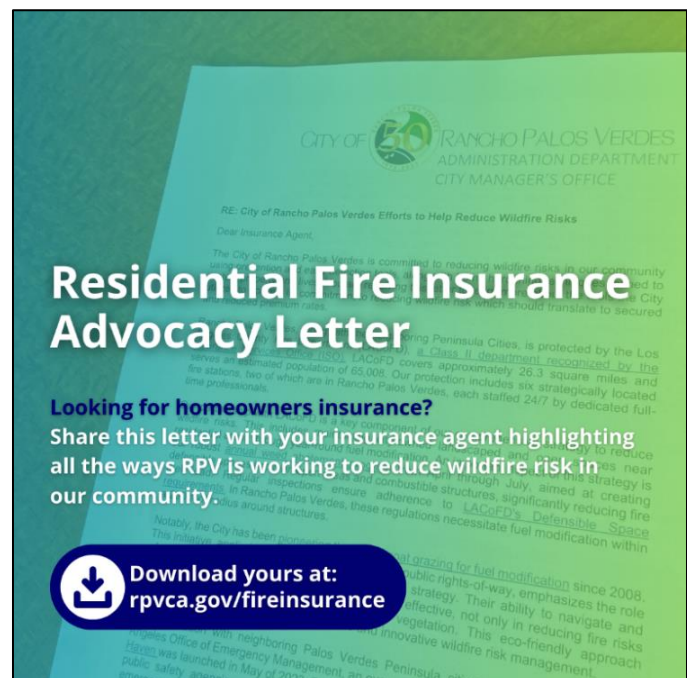

Are you struggling to find adequate fire insurance for your home? In California, the increasing frequency and severity of wildfires have significantly impacted the residential fire insurance market. This has resulted in higher premiums, reduced coverage options, and, in some cases, policy cancellations.

In RPV, these statewide challenges are evident, with many residents reporting increased premiums and difficulty in maintaining their fire insurance coverage. In response to these concerns, the City's Emergency Preparedness Committee (EPC), in collaboration with City Staff, has developed a [comprehensive insurance resource letter \(PDF\)](#) (see attached letter).

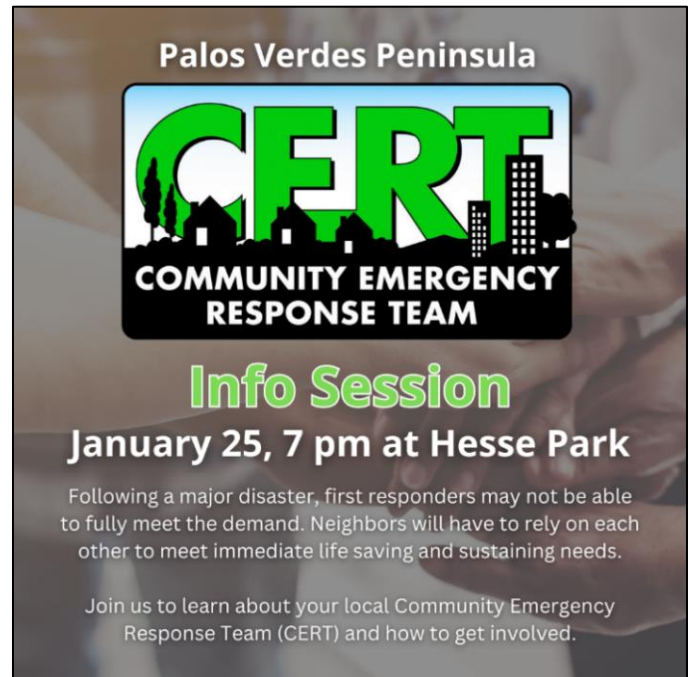
PVP CERT Info Session January 25

Common Fire Hazards in the Home

In just two minutes, a fire can become life-threatening. In five minutes, a residence can be engulfed in flames. The causes of these fires can range from candles left burning, to unattended food in the kitchen. Knowing where and when fires are most likely to ignite can help you protect yourself, your family, and your home from tragedy.

Kitchen fires: Most home fires start in the kitchen during cooking — usually on stovetops — not in the oven. Specifically, unattended cooking is the leading cause of kitchen fires and fire-related injuries.

These home fires are also easily preventable: Keep an eye on the stove, oven, and other appliances like toaster ovens, and move combustible items away from the stove. Stay in the kitchen when you are frying, grilling, or broiling food. If you leave the kitchen for even a short period of time, turn off the stove.

Portable space heaters: With the following safety tips and precautions, you can prevent most heating fires from happening.

- Make sure to always keep anything that gives off heat at least 3 feet away from flammable materials or items.
- Never plug more than one heating appliance into an outlet.
- Buy only heaters evaluated by a nationally recognized laboratory, such as Underwriters Laboratories (UL).
- Check to make the portable heater has a thermostat control mechanism and will switch off automatically if the heater falls over.
- Keep portable gas generators outside and away from windows to avoid carbon monoxide poisoning.
- If you have a fireplace, make sure your chimney is checked and cleaned by a professional once a year. Use a metal or glass screen that is large enough to prevent escaping embers.

Electrical safety: Electrical fires can be caused by an equipment malfunction, an overloaded circuit, or from an overheated appliance such as a washer, dryer or space heater.

Safety Tips

- Frayed wires can cause fires. Replace all worn, old or damaged appliance cords immediately, and do not run cords under rugs or furniture.
- If an appliance has a three-prong plug, use it only in a three-slot outlet. Never force it to fit into a two-slot outlet or extension cord.
- Immediately shut off, then professionally replace light switches that are hot to the touch and lights that flicker.
- Don't overload circuits or outlets.
- Consider having additional circuits or outlets added by a qualified electrician so you don't have to use extension cords.
- Consider hiring an electrician to perform an annual checkup of your home's wiring.

Candles: The National Fire Protection Association estimates that candles cause an average of 8,200 house fires each year in the U.S. The matches and lighters used to light candles are equally dangerous if left in a place where children can reach them.

Candle Safety Tips

- Blow out all candles when you leave the room or go to bed.
- Avoid the use of candles in the bedroom and other areas where people may fall asleep.
- Keep candles out of the reach of children and pets.
 - Do not place lighted candles where children, pets or anyone else can knock them over.
- Never burn a candle on or near anything that can catch fire.
 - Keep burning candles away from furniture, drapes, bedding, carpets, books, paper, flammable decorations, etc.
- Put candle holders on a sturdy, uncluttered surface.
- Light candles carefully. Keep your hair and any loose clothing away from the flame.
- Don't burn a candle all the way down — put it out before it gets too close to the holder or container.
- Have flashlights and battery-powered lighting ready to use during a power outage. Never use candles.

Laundry rooms: Dryers are responsible for about 9 out of 10 appliance fires.

Fortunately, preventing laundry fires is simple for the most part:

- Don't overload your washer or dryer or pack items down. Instead, leave room for laundry to tumble. Follow your machine manufacturer's recommendations for capacity.
- Clean the lint screen and drum between loads to prevent buildup.
- About once a year, clean the dryer exhaust vent and ducts.
- Replace plastic venting material with flexible metal venting material.
- Ensure that your appliances are plugged into outlets with the proper voltage.

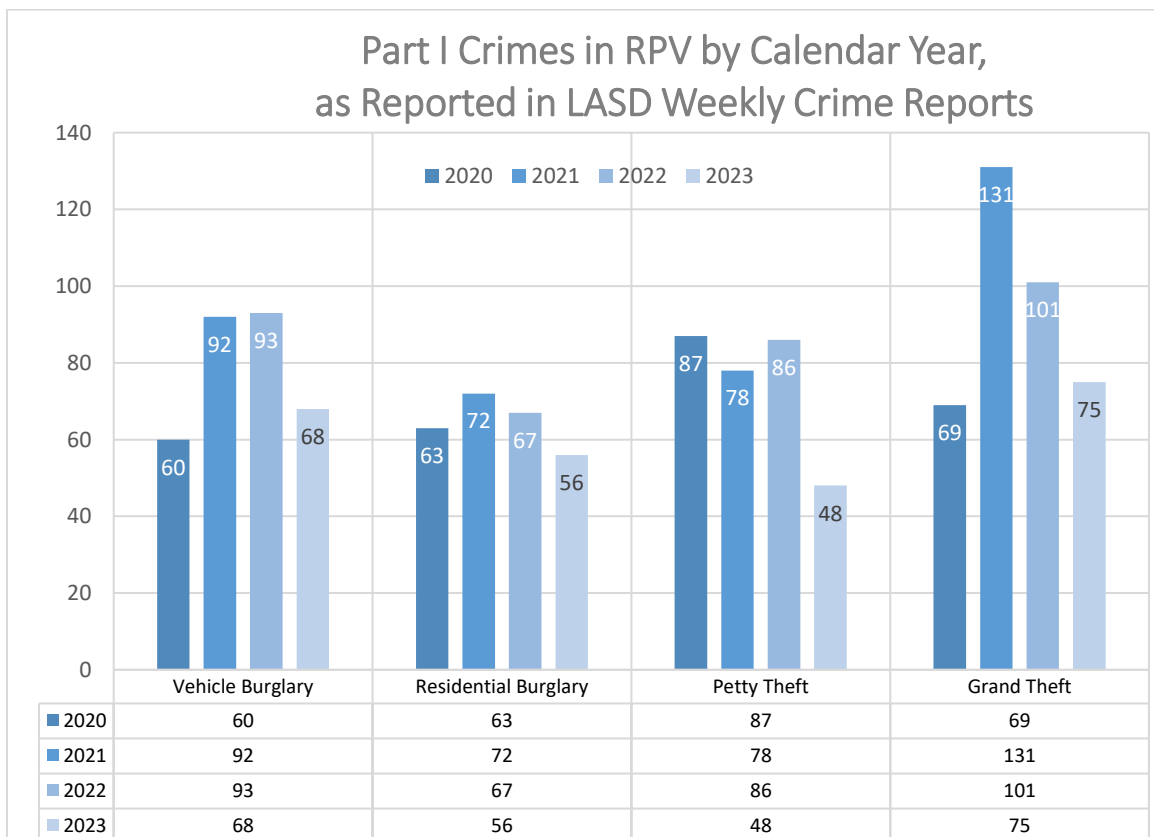




Weekly Crime Report Summaries

Quarterly Home Sales History – 4th Quarter 2023

Overall, the shortage of homes for sale and high interest rates continued to negatively impact housing supply and demand through the end of calendar year 2023. In addition to the declining sales volume, December's statewide median home price in Los Angeles County was \$817,740, down by 0.3% from November, but up by 6.4% from a year ago. Mortgage rates are projected to decline over the next year, which suggests that home sales are likely to rebound due to a more favorable housing market. Home prices may also see a moderate increase in 2024 as a result.

Throughout various regions in the state, year-over-year price growth persisted and ended positive in 2023. Additional details are provided in Chart 1 below.

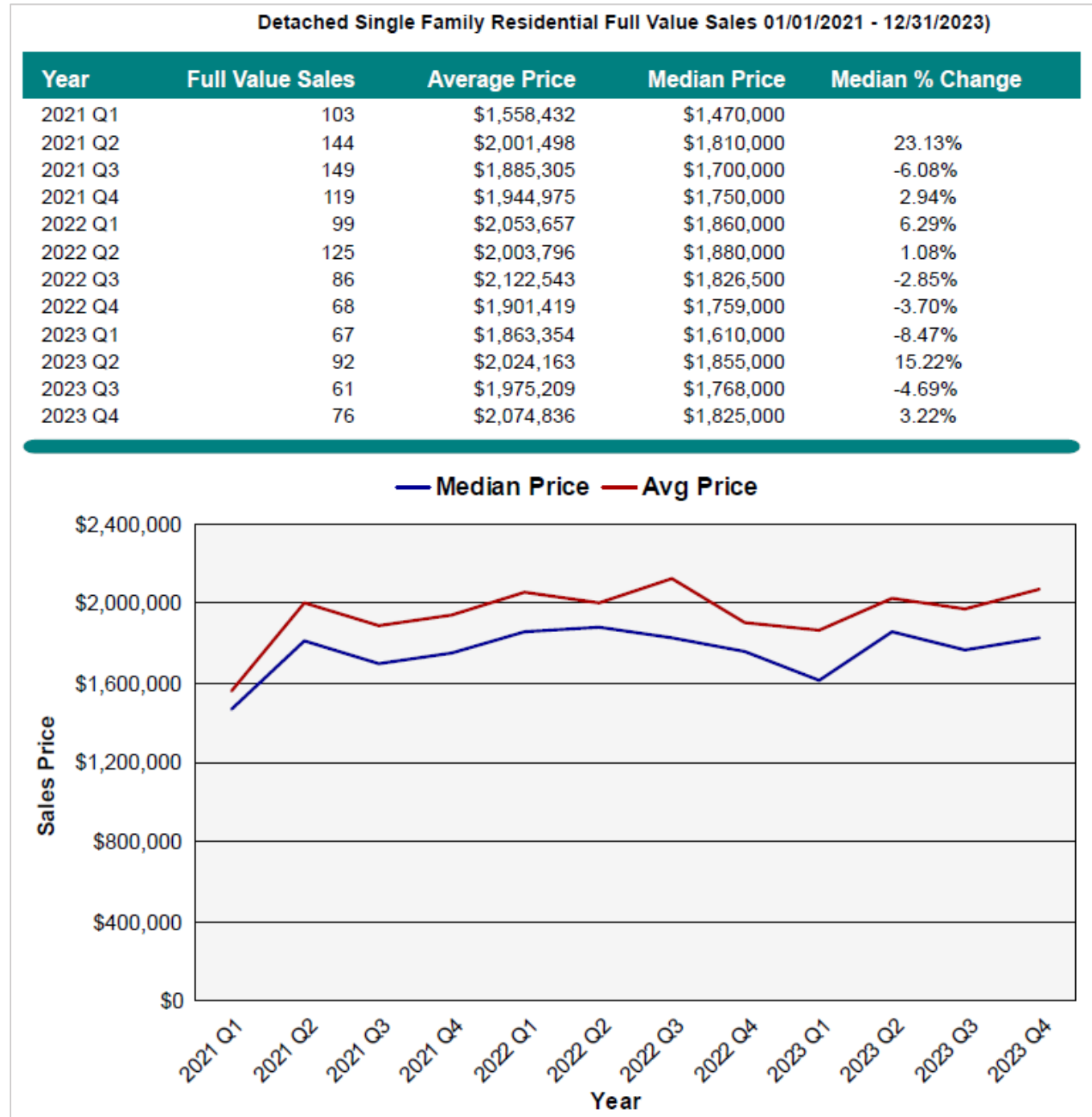

In the City of Rancho Palos Verdes, the median sales price for detached single family homes rose to \$1.8 million in December, up by \$57,000, or 3.2%, from the third quarter. This rise in value comes following a decrease of -4.7% from the previous quarterly report. Compared to the same period a year ago, the median price is up by 3.8%.

The average home price in the City also increased as of December and ended the year at \$2.1 million. This price change reflects growth of about \$100,000, or 5%, compared to the third quarter. Additionally, sales volume in the area rose by 24.6% after previously declining by -33.7%. Despite the recent rise, 2023 finished the year with 81 less full value sales than in calendar year 2022, a decrease of roughly 22%.

Ladera Linda Community Park Project Update

Last week, the construction contractor installed power to the audio/video racks, reinstalled glass panels for the display cases in the Discovery Room, and installed the remaining components for the WiFi system. The contractor held the first four training sessions for Staff which covered door hardware, the skywall partition in the Multipurpose Room, the heating, ventilation and air conditioning (HVAC) system, and floor maintenance.



This week, the contractor is scheduled to make an adjustment to the gate at the main driveways, relocated the drinking fountain by the paddle tennis courts, add some vegetation and fencing by the switchback ramp, and make alterations to some areas of the decomposed granite (DG) pathways by benches and picnic tables to be compliant with the ADA (Americans with Disabilities Act). The Fire Marshal is scheduled to conduct their final inspection and the contractor will host a training for Staff on the fire alarm system.

Various final inspections continue to be performed, and construction crews continue to make the required corrections.

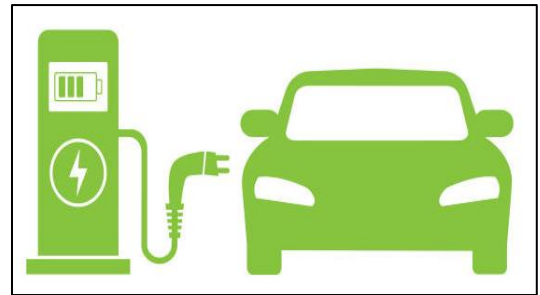

EV Charging Stations Coming to Ladera Linda Community Park

The City was recently awarded \$76,730 in grant monies by the U.S. Department of Energy through the Energy Efficiency Conservation Block Grant for the purchase and installation of three electric vehicle (EV) charging stations. These charging stations will be installed at the new Ladera Linda Community Park and are expected to be operational this summer.



Staff is developing a fee structure plan which will be presented to the City Council for approval in the coming months.

We are excited and looking forward to the first EV charging stations at a City facility!

UCLA South Bay

Last week, the permanent illuminated street name signs for UCLA South Bay were installed at the campus entrance on Palos Verdes Drive East. In August 2023, temporary reflective-only signs were installed in time for a UCLA ceremonial event, as the illuminated signs had a long lead time. UCLA purchased the campus that was previously the site of Marymount California University.



Civic Center Project Update

The new Civic Center will implement significant phased improvements to meet organizational needs, as well as provide various features for public use. The Civic Center Master Plan has entered the second stage of development, Master Plan Design, which includes obtaining project management support to implement a design competition, select a project delivery method, and ultimately progress the project to Stage 3,

Planning Entitlement and Environmental Review. The Stage 2 request for qualifications (RFQ) for project management support was released on January 10. A site walk of the civic center campus with prospective proposers was held on January 22. Responses to the RFQ are due on February 9.

Hawthorne Boulevard Traffic Impacts

On January 18, work began impacting traffic on Hawthorne Boulevard in the vicinity of Country Lane/Ocean Crest Drive. The work is in the City of Rolling Hills Estates related to the Peartree Lane Landslide Remediation Project.

Traffic impacts will occur intermittently for approximately 5-6 days during a 30-day period. During those days, Hawthorne Boulevard will be impacted from 9 a.m. to 3 p.m. Lanes will be reduced to one lane in each direction and the speed limit will be reduced from 45 mph to 35 mph.



Infrastructure Management Advisory Committee (IMAC) Meeting

The regularly scheduled meeting for February 19 meeting will be canceled and instead, a special meeting will be scheduled for February 12 at 6 p.m. The public is invited and encouraged to participate. The agenda will be available on the City's website at rpvca.gov/agendas by February 5 at 5:30 p.m.

LAX Community Noise Roundtable Meeting Summary

On January 17, the LAX Community Noise Roundtable held its regularly scheduled meeting. The Roundtable discussion included a presentation by the Federal Aviation Administration (FAA) on the FAA's decision concerning new LAX departure procedures. As a reminder, on February 7, 2023, Staff alerted the City Council that the FAA was to imminently implement new aircraft flight procedures titled STHBY and KYLOW for early morning departures from LAX. In response, the City Council expressed concerns to the FAA that the proposed flight procedures may cause noisy aircraft to fly closer to the Palos Verdes Peninsula. The FAA delayed the publication of the proposed flight paths to allow additional time for the FAA to consider changes requested by both the City Council and Los Angeles World Airports (LAWA).



With consideration to the recommendations made by the City Council and LAWA, the FAA has now reported that it has modified its originally proposed STHBY and KYLOW departure procedures (see attached STHBY SID Design map), so that the flight route off the western Peninsula coastline remains relatively unchanged. The changes that are occurring relate to the departure route waypoints that start from LAX to the waypoint off the southwestern Peninsula coastline named PEVEE. The FAA intends to remove and replace these waypoints with new route waypoints deemed safer by the FAA. The waypoint STHBY will replace PEVEE, but waypoints HOLTZ and OSHNN located above the San Pedro Channel, south of RPV, will remain unchanged. These three waypoints — PEVEE (soon to be STHBY), HOLTZ, and OSHNN — are key waypoints that keep commercial jet aircraft from overflying the Palos Verdes Peninsula. RPV Staff will monitor passenger jet Peninsula overflights after the July implementation of the new departure procedures and provide an update in the City Manager's Weekly Administrative Report after collecting one year of data.

A letter from the City Manager was sent to FAA representatives thanking them for their continued cooperation in working with the Peninsula cities (see attached).

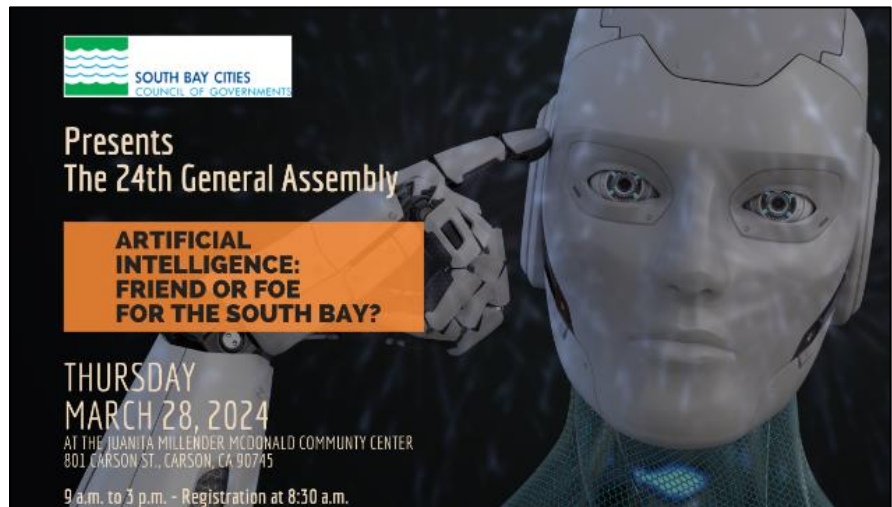

On January 19, Staff added additional signage to the areas in the Lay Reserve where public access is not permitted.



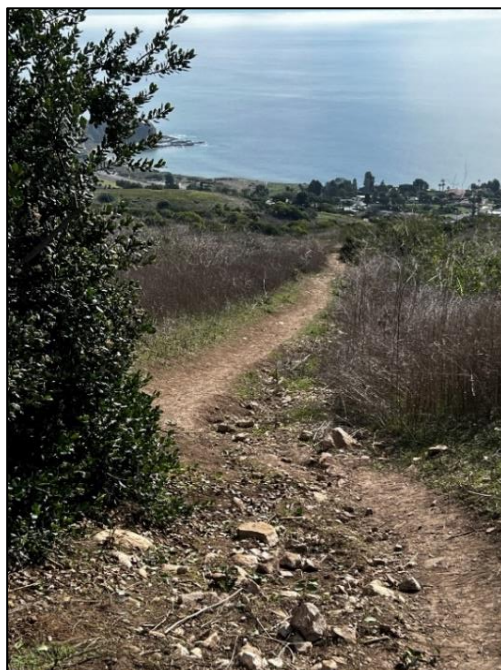

RE: City of Rancho Palos Verdes Efforts to Help Reduce Wildfire Risks

Dear Insurance Agent,

The City of Rancho Palos Verdes (RPV) is dedicated to minimizing wildfire risks through prevention, early detection, and home hardening techniques aimed at safeguarding both property and lives. On behalf of the policy owner, this letter is being provided to you and your adjuster outlining the City's strategies and measures to reduce wildfire risk intended to contribute to more favorable insurance premium rates and policy availability for our residents and businesses.

RPV collaborates closely with the Los Angeles County Fire Department (LACoFD), [a Class II department recognized by the Insurance Services Office \(ISO\)](#). Covering approximately 26.3 square miles and serving an estimated 65,000 Palos Verdes Peninsula (PVP) residents, LACoFD operates six strategically located fire stations, including two within RPV.

Notably, RPV enhances its wildfire management capabilities with the following measures to significantly improving our emergency response and preparedness:

- Maintaining City-owned landscaped and open spaces near residential areas through year-round fuel modification. RPV's robust [ANNUAL WEED ABATEMENT PROGRAM](#) aims to create defensible spaces between open areas and combustible structures, significantly reducing fire fuel load. Regular inspections ensure adherence to [LACoFD's Defensible Space requirements](#).
- [GOAT GRAZING FOR FUEL MODIFICATION](#): On city-owned lands including public rights-of-way. Goats effectively remove brush and grass from hard to access terrain thereby significantly reducing fire loads and risks.
- [GENASYS PROTECT \(ZONE HAVEN\)](#): Implemented in May 2023, this critical emergency preparedness tool is available to residents at [PVPready.gov](#), as an Evacuation Management Platform in identifying evacuation zones and guiding residents on necessary actions during emergencies.
- [PANO AI'S WILDFIRE CAMERAS](#): This network of AI cameras provide early detection of wildfire smoke across the Palos Verdes Peninsula and has proven effective in delivering timely and accurate early alerts for fire ignitions.
- [HELOPOD FIREFIGHTING DIP SOURCE](#): The City installed a [HeloPod](#) at its Civic Center that is in close proximity to open space and canyons areas enabling rapid water refilling for firefighting helicopters.

The City has further initiated the following measures to enhance community safety against wildfires:

- [Firescaping training workshops.](#)
- [Home hardening videos.](#)
- [Monthly emergency preparedness safety tips.](#)
- Collaborative efforts with Southern California Edison (SCE) for utility line hardening and undergrounding.
- A comprehensive [Multi-Jurisdictional Hazard Mitigation Plan](#), offering in-depth insights into RPV's wildfire mitigation strategies on pages 151-158 of the plan.

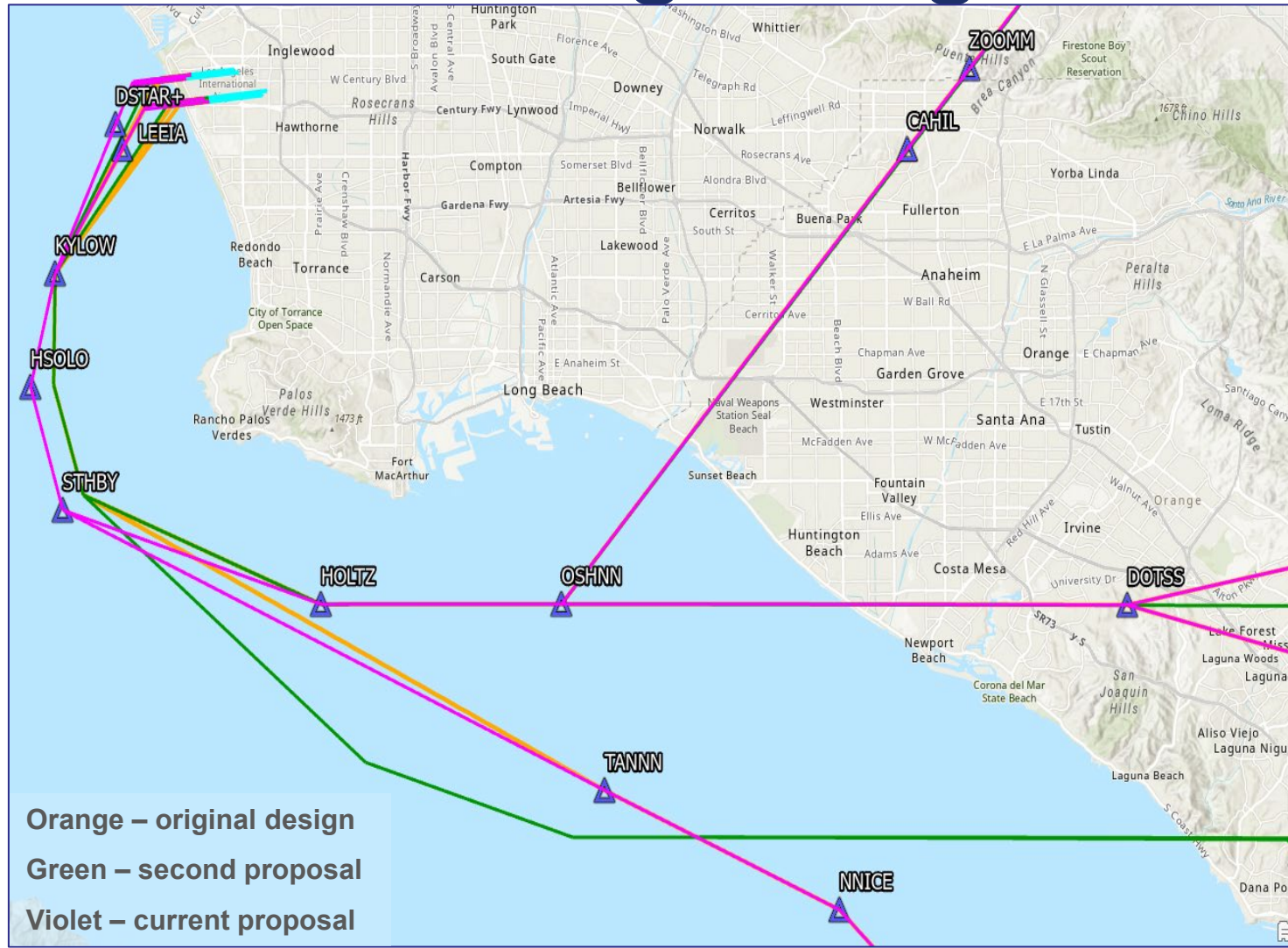

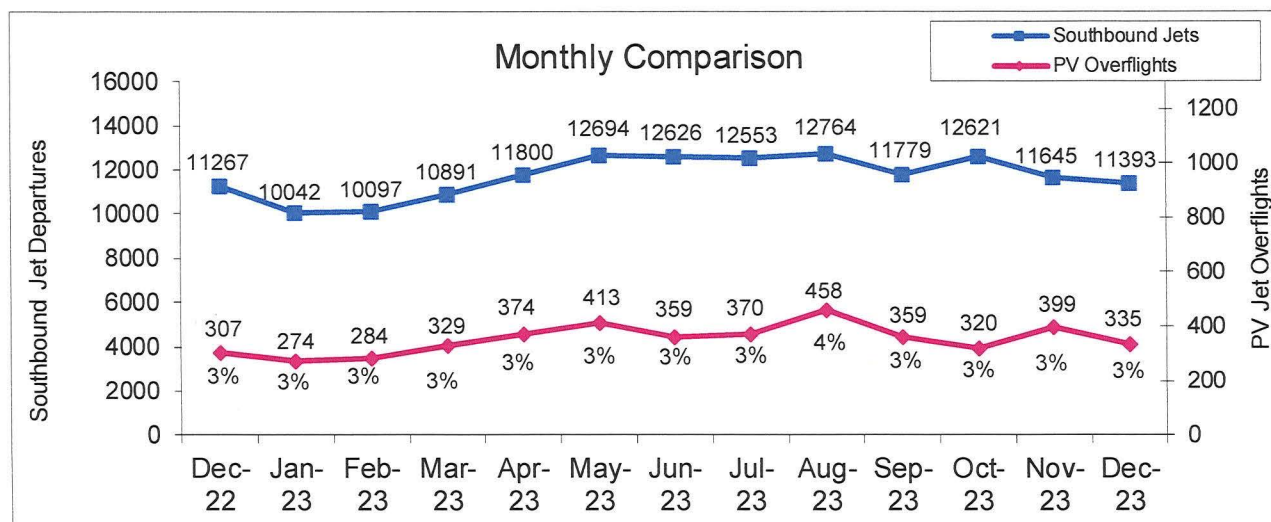
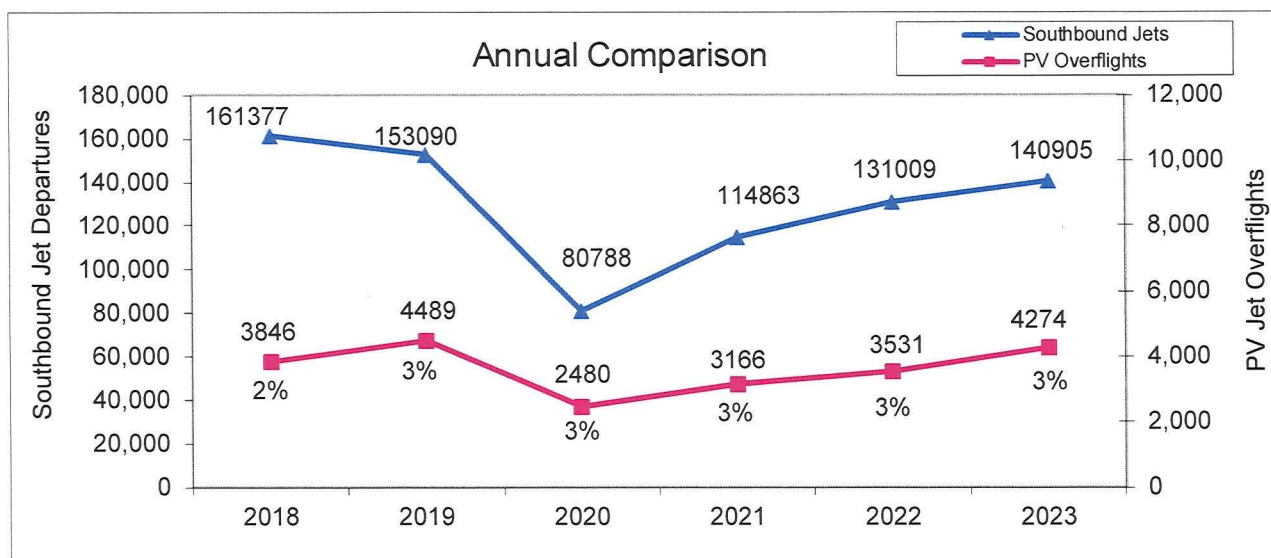
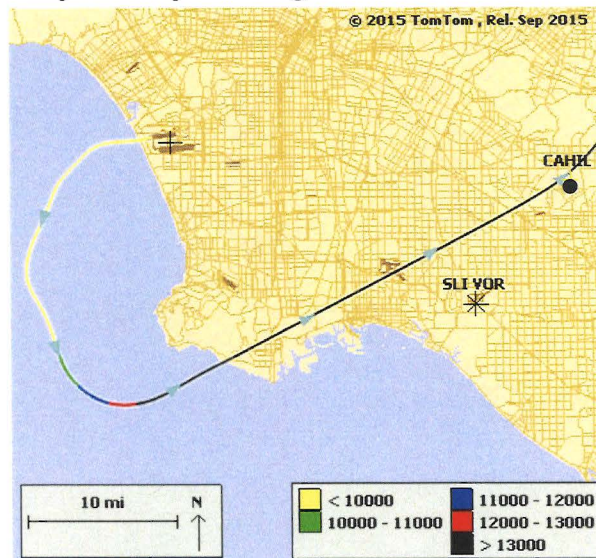
STHBY SID Design Progression



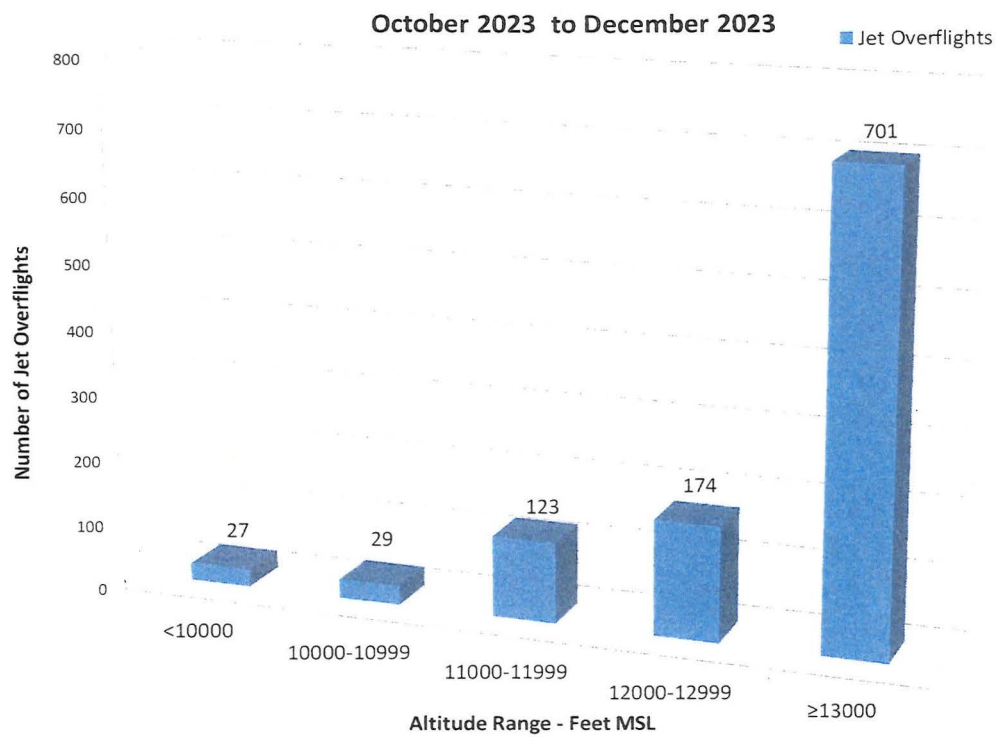
Palos Verdes Peninsula – Jet Overflights

In response to a letter to your office that expressed LAWA's and our community's concerns relating to FAA proposed STHBY and KYLOW departure procedures from Los Angeles International Airport (LAX), the City of Rancho Palos Verdes received your letter in April 2023 announcing the postponement of the procedure publication to allow the FAA time to consider stakeholders' input.

On January 17, 2024, the FAA presented to the LAX/Community Noise Roundtable an update on the departure procedures illustrating how the new flight paths underwent modifications that are aligned with those recommendations made by LAWA and our City Council.

On the behalf of the City Council and residents of Rancho Palos Verdes, thank you for considering our community's aircraft noise concerns and ensuring that the forthcoming departure procedure continues to be routed no less than 5 miles from the Palos Verdes Peninsula coastline. This community will take comfort knowing that the FAA continues to listen to our concerns and is willing to implement measures that keep departing jet aircraft a reasonable distance from the Peninsula.

The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force. (2) “True threat of force” means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

Continuation of Meeting:

Code § 54963(c).)
