### **February 6, 2024, City Council Meeting Highlights**

Highlights from the February 6 City Council meeting:

- The Council voted to extend the City's local emergency declaration in the Portuguese Bend landslide complex through April 6, 2024, and to explore asking Governor Newsom to declare a state of emergency to help the City leverage additional resources.
- The City's geologist gave an update on landslide activity, expressing concerns about how recent storms will further accelerate movement and impact infrastructure. Given the landslide complex's large size and long history of slow-



moving behavior, he does not believe there is risk of a sudden catastrophic landslide.

- Recognizing the urgency of the situation, the Council requested a report at the next meeting on February 20 about what can be done to expedite progress toward implementing the long-term Portuguese Bend Landslide Remediation Project, which remains in the environmental review stage while modifications are being explored.
- City staff gave an update on efforts to plan a Peninsula-wide emergency drill slated for April that will simulate a large earthquake and subsequent evacuation.
- The Council decided to move forward with making a patriotic drone light show a regular part of the annual Fourth of July celebration at the Ken Dyda Civic Center. A three-year contract for shows using 150 drones will be considered at a future meeting.
- SCE gave an update on its efforts address recurring power outages in the Grandview Estates neighborhood, including a long-term project to resolve customer reliability and voltage concerns. More information is expected to be presented at a meeting in June.

# Portuguese Bend Landslide Local Emergency Update

## February 7, 2024 Community Update

With this week's historic atmospheric river now passed, the City would like to thank our residents, fire and law enforcement agencies, fellow Peninsula cities, homeowners associations, Neighborhood Watch, and other community partners for helping us get the word out about storm preparedness. We also thank residents for alerting our Public Works team to clogged storm drains, flooding, mudslides, and fallen trees. In all, 100 cubic yards of sand and 2,500 loose sandbags were distributed to residents, and 3,700 prefilled bags were deployed to slide/flooded areas.

### Storm Roundup

- 68 emergency calls
- 5 trees down
- 5 branches down
- 2 signs down
- 3 flooded facilities
- Multiple flooded roads and mudslides
- 100 cubic yards of loose sand provided residents
- 2,500 loose sandbags distributed to residents
- 3,700 prefilled bags deployed to slide/flooded areas

As was discussed during last night's City Council meeting (more on that below), the City's geologist believes the impacts of the heavy amount of rain the Peninsula received this past week will be experienced in the landslide complex within days to weeks, and likely extend for months after the rainy season ends, as was the case last year.

**It's important to stay prepared.** Have an [emergency plan](#) for your family, keep [supplies for a go-bag](#), Know Your Zone on the zone map at [PVPready.gov](#), and sign up for [Alert SouthBay](#) emergency alerts.

## February 6 City Council Meeting Recap

At last night's City Council meeting, RPV's local emergency declaration in the landslide complex — which goes up for renewal every 60 days — was extended through April 6, 2024. The Council also moved to explore asking Governor Newsom to declare a state of emergency to help the City leverage additional resources.

The City's geologist, Mike Phipps of Cotton, Shires and Associates, presented an update on landslide activity, cautioning that the situation "is going to get worse before it gets better." He expressed concerns about how the recent record rainfall will further accelerate movement in the landslide complex and impact infrastructure, especially roads, sewer lines, and water lines.

Mr. Phipps shared the [most recent GPS monitoring data](#) showing that average land movement velocities since October 2023 have accelerated by a factor of three to four times compared to the previous 12-month monitoring period. In other words, we have seen as much movement (and in some cases, more movement) in the landslide complex

in the past three months as we did from October 2022 to October 2023. City staff is developing heat maps to better visualize the City's land movement data.

Given the landslide complex's large size and long history of slow-moving behavior, Mr. Phipps does not believe there is risk for a sudden catastrophic landslide.

Recognizing the urgency of the situation, the Council requested a report at the next meeting on February 20 about what can be done to expedite progress toward implementing the long-term [Portuguese Bend Landslide Remediation Project](#), which remains in the environmental review stage while modifications are being explored. Stay tuned for details on meeting info.

The City is also working with the state on additional potential short-term measures that can proceed before the project's Environmental Impact Report (EIR) is released later this year.


### **Sandbags Update: Limited Supply Now Available**

A limited amount of sandbags are back in stock at RPV City Hall on a first-come, first served basis.

Unfilled sandbags are located at the City Hall info desk and are available to RPV residents during regular business hours (7:30 a.m.-5:30 p.m. Monday-Thursday, and 7:30 a.m.-4:30 p.m. Friday). There is a limit of 10 sandbags per household with valid ID or proof of residency. Fill sand is located at City Hall in a designated area for residents to use. Please bring your shovels and tools as they are not provided. If you need additional bags, they can be purchased at local hardware stores.

# MISFORTUNE & CALAMITY TAX RELIEF

TO QUALIFY, YOU MUST FILE AN APPLICATION FOR REASSESSMENT: PROPERTY DAMAGED OR DESTROYED BY MISFORTUNE OR CALAMITY (ADS-820) WITH THE ASSESSOR'S OFFICE WITHIN 12 MONTHS FROM THE DATE THE PROPERTY WAS DAMAGED OR DESTROYED. THE LOSS MUST EXCEED \$10,000 OF CURRENT MARKET VALUE.

## Storm Damage Relief for Property Owners Now Available

In the aftermath of recent storms, the Los Angeles County Assessor's Office is providing critical financial relief to property owners who have experienced damage due to natural disasters through the Misfortune and Calamity Tax Relief program. This initiative aims to mitigate the financial impact on affected homeowners by offering a reassessment of their property's value, reflecting the damage incurred and potentially lowering their tax obligations.

To be eligible for this relief, property owners must submit an [Application for Reassessment: Property Damaged or Destroyed by Misfortune or Calamity](#) (Form ADS-820) (PDF) within 12 months of the damage occurrence. The program stipulates that the property loss must amount to more than \$10,000 in current market value to qualify.

### Key Aspects of the Relief Program

- **Filing Requirements:** Eligibility hinges on filing the reassessment application within the 12-month window following the damage, ensuring that losses meet the minimum financial threshold.
- **Tax Bill Adjustment:** Qualifying properties will see a reduction in tax liability for the portion of the property that was damaged or destroyed, effective from the damage date and maintained until the property is repaired or rebuilt.
- **Reconstruction Considerations:** Rebuilding efforts that closely resemble the original structure will not result in an increased property tax rate, maintaining the

pre-disaster tax base value. However, any enhancements or expansions will be assessed at their full market value.

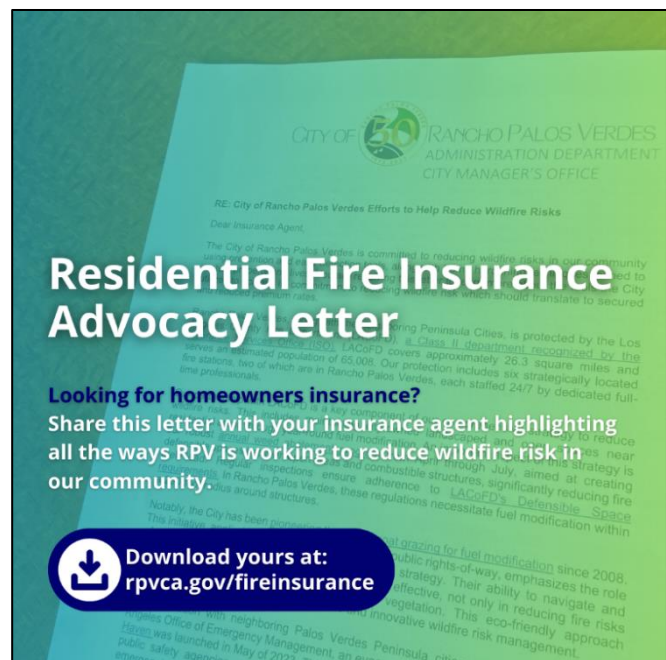


## Residential Fire Insurance Advocacy Letter - Now Available on the City Website

Are you struggling to find adequate fire insurance for your home? In California, the increasing frequency and severity of wildfires have significantly impacted the residential fire insurance market. This has resulted in higher premiums, reduced coverage options, and, in some cases, policy cancellations.

In RPV, these statewide challenges are evident, with many residents reporting increased premiums and difficulty in maintaining their fire insurance coverage. In response to these concerns, the City's Emergency Preparedness Committee (EPC), in collaboration with City Staff, has developed a [comprehensive insurance resource letter \(PDF\)](#) (see attached letter).

This advocacy tool is tailored to help you, our residents and businesses, communicate effectively with your insurance providers to advocate for maintaining your current insurance policies and potentially negotiating lower premiums. We encourage you to utilize this resource to its full extent.

For courses sponsored by the Palos Verdes Amateur Radio Club, students thru grade 12 who pass their examination at a PVARC VE test session will, upon application to the Club, be eligible for reimbursement up to a maximum of \$50 to cover the cost of materials and the examination fee.

Everyone who obtains their first ham radio license through a PVARC VE test session, regardless of age, will receive a free membership in the Palos Verdes Amateur Radio Club for the remainder of the current calendar year.

## Know the Difference: What Evacuation Warnings and Orders Mean

Residents are reminded of the importance of being prepared as a significant storm continues to impact portions of the state. In addition, extreme weather conditions, such as heavy precipitation and snowfall, contribute to hazardous conditions. To keep people safe, law enforcement may issue evacuation warnings or orders before major



emergencies, such as severe weather, so it is crucial that all residents understand what it means and how to respond to law enforcement guidance.

### **Evacuation Warning vs. Evacuation Order**

- An **EVACUATION WARNING** means there's an impending danger to your life or property. If a warning is given, assume an evacuation order will follow. Start gathering important items for your family and pets. Individuals needing extra time to evacuate, or anyone with large animals, should pack up and leave when a warning is issued.
- An **EVACUATION ORDER** means an immediate threat to your life, and you must leave now! It's critical to follow all directions from law enforcement to ensure you and your family evacuate safely.

### **When to Evacuate**

- Leave as soon as evacuation is recommended to avoid being caught in flood waters or road congestion. In some emergencies, officials may not have time to knock on every door. If you are advised to leave, don't hesitate!
- Officials will determine the evacuation areas and escape routes based on the danger's location, behavior, terrain, etc.
- You will be advised of potential evacuations as early as possible. So take the initiative to stay informed and aware.
- Do not return to your home until officials determine it's safe. Notifications will be given as soon as possible and will consider safety and accessibility.

### **Know What to Do in Case of Evacuation**

- [Know Your Evacuation Zone](#): Familiarize yourself with your designated zone on [PVPready.gov](#). It's crucial to Know Your Zone before a crisis arises. Save your zone number on your smartphone, jot it down, and put it somewhere easily accessible - perhaps on your fridge or next to your entryway. In an emergency, check the zone map to see if your zone is under an advisory or evacuation order.
- [Assemble a go bag](#): Prepare an emergency go bag with essential items and important documents. For a comprehensive packing list, go to [ready.lacounty.gov](#) or see the [Los Angeles County Fire Department's Evacuation Packing List \(PDF\)](#).

## Public Safety and Regional Contract Law Committee Meeting Recap

The Quarterly Peninsula Public Safety and Regional Contract Law committee met February 1.

Key topics discussed included:

- The Palos Verdes Peninsula Unified School District (PVPUSD) discussed school safety measures,



including addressing vaping and vandalism issues.

- A review of the number of school resource officers and drug policies in schools on the Peninsula
- RPV's Emergency Preparedness Coordinator provided updates on emergency preparedness and wildfire detection cameras and discussed installing additional security cameras for fire prevention. He also discussed a Peninsula-wide safety drill tentatively planned for April 2024.
- L.A. County Assistant Fire Chief Brian Bennett reviewed weather, fire safety, and community outreach programs and discussed emergency response times in the cities of RPV, Rolling Hills, Rolling Hills Estates, and Palos Verdes Estates.
- Rolling Hills updated the committee on its siren alert system and regional emergency alerts.
- The committee reviewed a proposal for upgrading automated license plate recognition (ALPR) cameras on the Peninsula.
- LASD provided a regional update on Part 1 and Part 2 crimes, traffic incidents, and tactics utilized to reduce crime on the Peninsula.

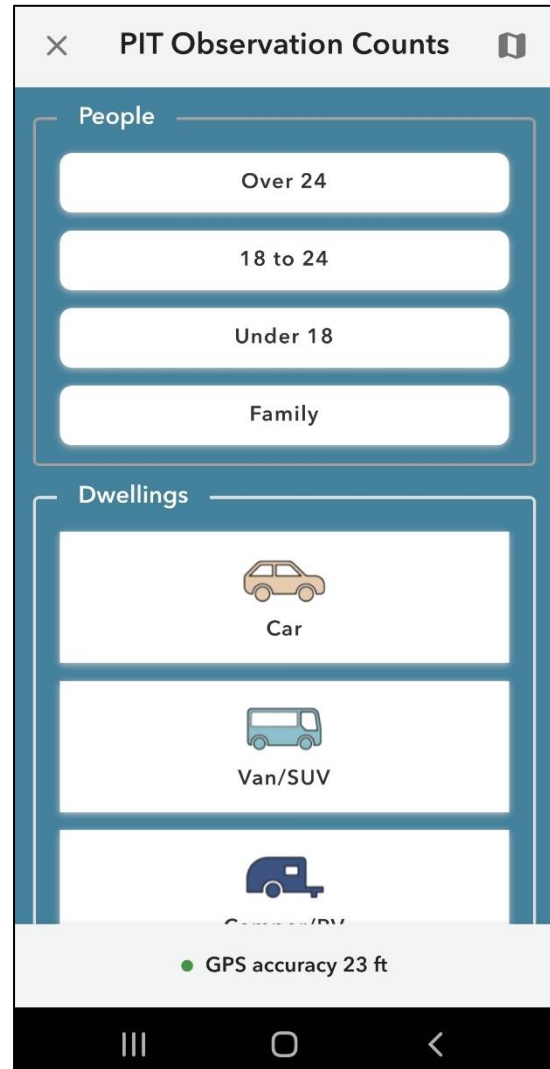

RPV takes great pride in the involvement of our staff members in communities across Los Angeles County. Two of our staff participated in the annual Greater Los Angeles Homeless Count on January 24. Mary Hirsch canvassed the community of Inglewood, while Shauna Hunter surveyed the east side of Rancho Palos Verdes along the Western Avenue corridor and the hills above Palos Verdes Drive North. Each team, consisting of two to three individuals, canvassed their assigned census tract and documented the number of unsheltered individuals, tents, vehicles, and makeshift shelters observed using an app provided by Esri (screenshot of app pictured above).

### The Employment Situation – January 2024

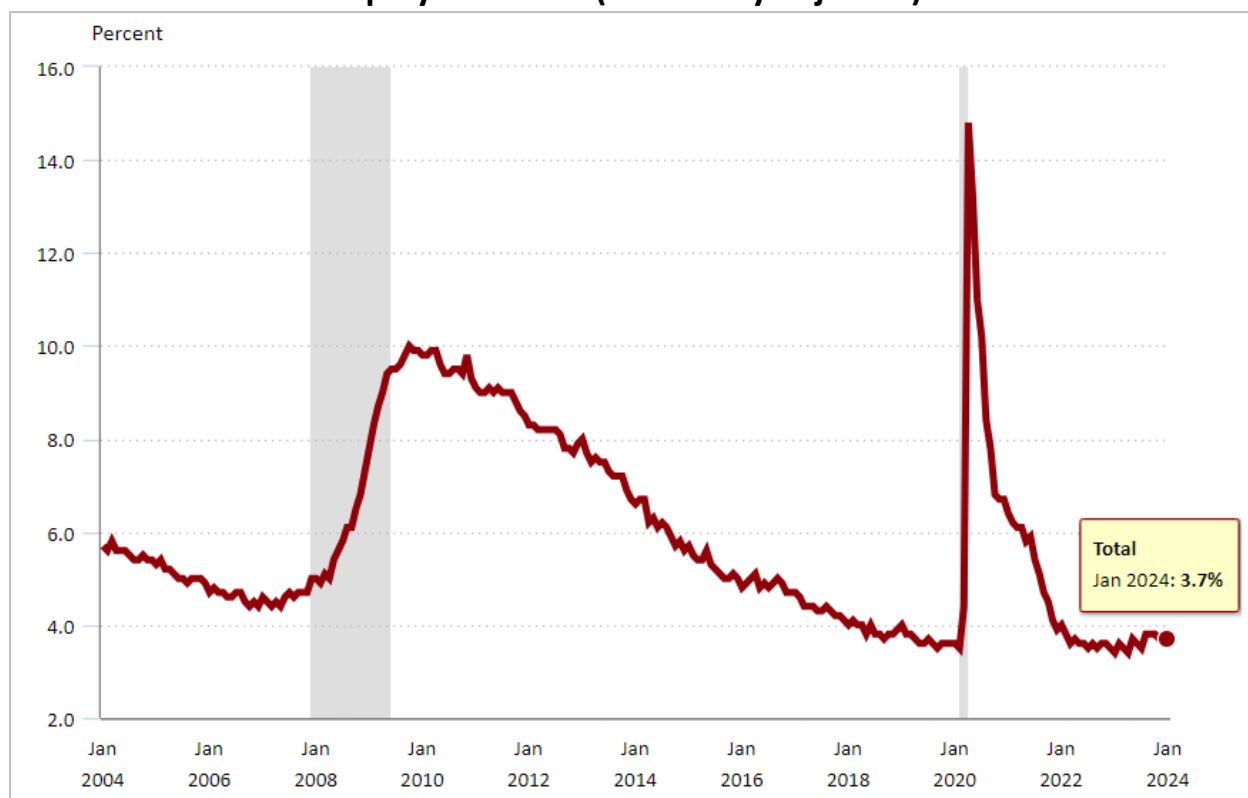
Last week, the U.S. Bureau of Labor Statistics reported that total nonfarm payroll employment rose by 353,000 in January, similar to the monthly gain of 333,000 in December. The job growth in January exceeded the average increase of 255,000 per month recorded in calendar year 2023. This latest report also indicated that the national unemployment rate remained at 3.7% for the third consecutive month.

In January, notable job gains occurred in industries such as professional and business services, health care, retail trade, and social assistance. On the other hand, employment

numbers have declined in the mining, quarrying, and oil and gas extraction industry based on this latest report.

Total government employment continued to trend upward in January and began the year with an increase of roughly 36,000 jobs. However, this figure fell below the average monthly gain of 57,000 jobs recorded in 2023. Within the government sector, job gains of 11,000 occurred in the federal government, while employment continued to trend up in local government with an increase of 19,000 in January. For a broader view, Chart 1 below illustrates the trend and current unemployment rate through January 2024.

- Removed wooden fence debris at Palos Verdes Drive East near the Eastfield gate

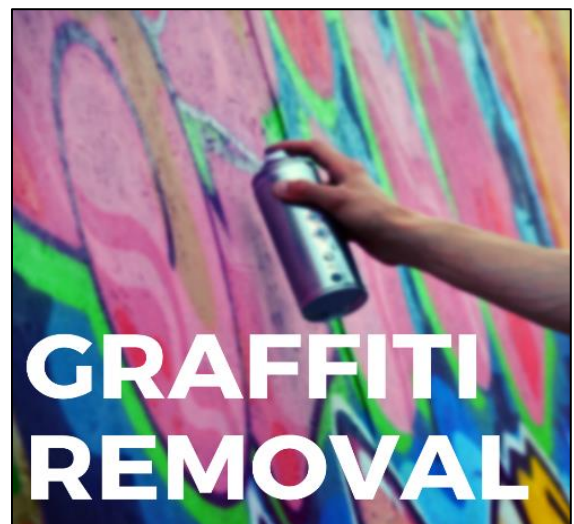

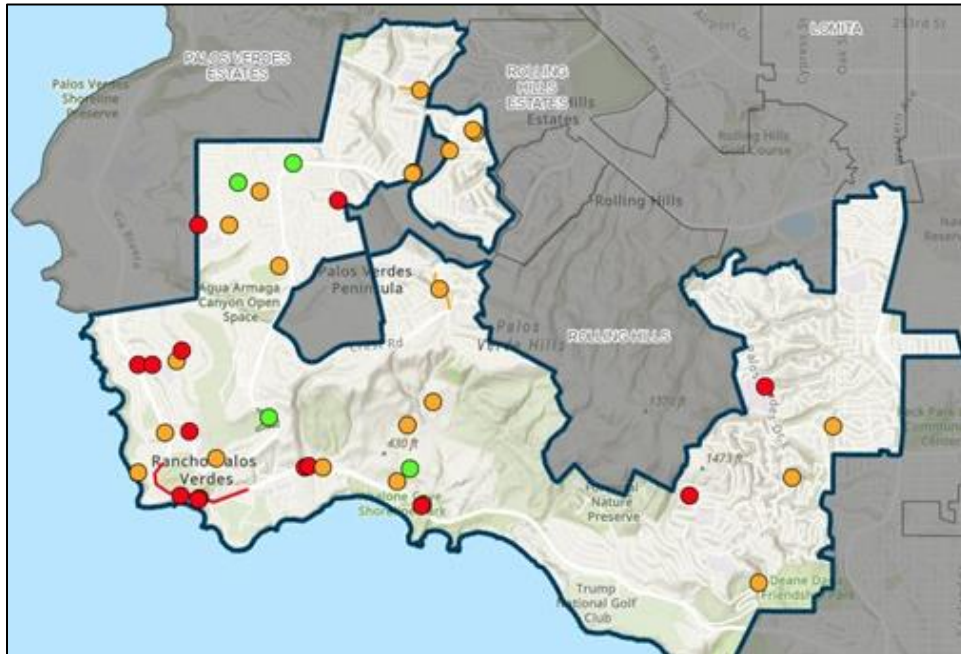


## **Emergency Response**

## **WHAT ARE THE FILING PROCEDURES FOR DISASTER RELIEF?**

To qualify for property tax relief under California Revenue and Taxation Code section 170, you must file an Application for Reassessment Property Damaged or Destroyed by Misfortune or Calamity form (ADS-820) with the Los Angeles County Assessor's office within 12 months from the date the property was damaged or destroyed.





# **HOW DOES THE DISASTER RELIEF AFFECT MY PROPERTY TAX BILL?**

The current property taxes will be reduced for that portion of the property damaged or destroyed. This reduction will be from the date of the damage, and will remain in effect until the property is rebuilt or repaired.





## **WHEN MY PROPERTY IS REBUILT OR REPAIRED FOLLOWING THE DAMAGE, WILL MY PROPERTY TAXES BE INCREASED OVER WHAT THEY WERE BEFORE?**

No. Property owners will retain their previous factored base year value if the house is rebuilt in a like or similar manner, regardless of the actual cost of construction. However, any new square footage or extras, such as additional baths, will be added to the base year value at its full market value.

Dear Insurance Agent,

The City of Rancho Palos Verdes (RPV) is dedicated to minimizing wildfire risks through prevention, early detection, and home hardening techniques aimed at safeguarding both property and lives. On behalf of the policy owner, this letter is being provided to you and your adjuster outlining the City's strategies and measures to reduce wildfire risk intended to contribute to more favorable insurance premium rates and policy availability for our residents and businesses.

RPV collaborates closely with the Los Angeles County Fire Department (LACoFD), [a Class II department recognized by the Insurance Services Office \(ISO\)](#). Covering approximately 26.3 square miles and serving an estimated 65,000 Palos Verdes Peninsula (PVP) residents, LACoFD operates six strategically located fire stations, including two within RPV.

Notably, RPV enhances its wildfire management capabilities with the following measures to significantly improving our emergency response and preparedness:

- Maintaining City-owned landscaped and open spaces near residential areas through year-round fuel modification. RPV's robust [ANNUAL WEED ABATEMENT PROGRAM](#) aims to create defensible spaces between open areas and combustible structures, significantly reducing fire fuel load. Regular inspections ensure adherence to [LACoFD's Defensible Space requirements](#).
- [GOAT GRAZING FOR FUEL MODIFICATION](#): On city-owned lands including public rights-of-way. Goats effectively remove brush and grass from hard to access terrain thereby significantly reducing fire loads and risks.
- [GENASYS PROTECT \(ZONE HAVEN\)](#): Implemented in May 2023, this critical emergency preparedness tool is available to residents at [PVPready.gov](#), as an Evacuation Management Platform in identifying evacuation zones and guiding residents on necessary actions during emergencies.
- [PANO AI'S WILDFIRE CAMERAS](#): This network of AI cameras provide early detection of wildfire smoke across the Palos Verdes Peninsula and has proven effective in delivering timely and accurate early alerts for fire ignitions.
- [HELOPOD FIREFIGHTING DIP SOURCE](#): The City installed a [HeloPod](#) at its Civic Center that is in close proximity to open space and canyons areas enabling rapid water refilling for firefighting helicopters.



The City has further initiated the following measures to enhance community safety against wildfires:

- [Firescaping training workshops.](#)
- [Home hardening videos.](#)
- [Monthly emergency preparedness safety tips.](#)
- Collaborative efforts with Southern California Edison (SCE) for utility line hardening and undergrounding.
- A comprehensive [Multi-Jurisdictional Hazard Mitigation Plan](#), offering in-depth insights into RPV's wildfire mitigation strategies on pages 151-158 of the plan.

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may

remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force. (2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

**Time Estimates:**

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.
