RPV Talks “Lions, Tigers, and Landslides, Oh My!”

At last week’s Cal Cities City Managers Conference, City Manager Ara Mihanian joined Rolling Hills Estates City Manager Greg Grammer, Assistant City Manager Alexa Davis, and Jon Barilone, Principal at government communications firm Tripepi Smith, for a panel discussion on crisis communications titled, “Lions, Tigers, and Landslides, Oh My!” The session touched on recent situations experienced in both cities that dealt with catastrophic land movement, a high-profile incident featuring a prominent sports figure, and a fabricated story that created a panic on social media. Focusing on the importance of providing accurate and consistent information relevant to all parties, leveraging resources and agency partners, and utilizing risk management strategies to reduce risk in a crisis, the session provided an excellent opportunity to gather valuable insights on some best practices and lessons learned from two cities that have been on the front lines of crisis management.

How SCE Can Help

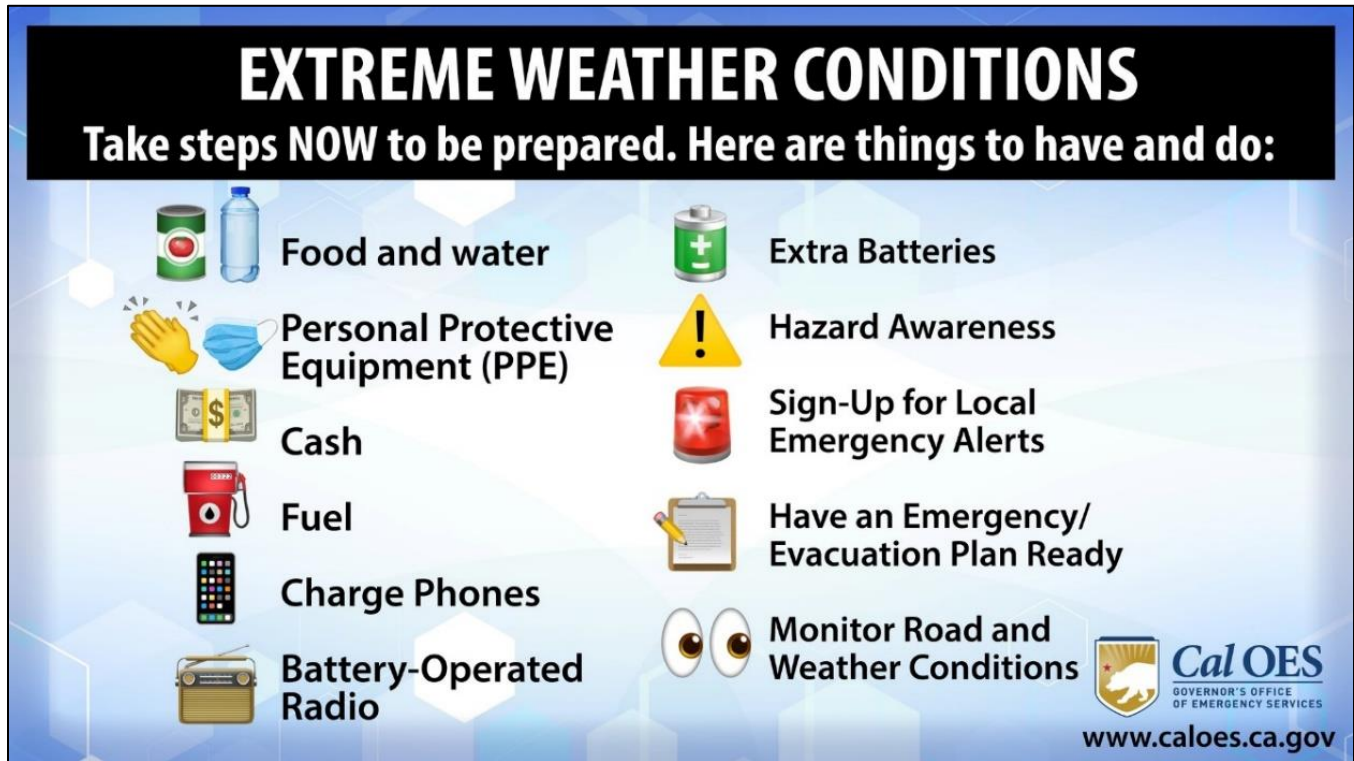
- Waive deposit requirements for affected small business customers seeking to reestablish service to a new location. SCE does not collect re-establishment deposits from residential customers.
- Discontinue billing for homes that have been destroyed, are deemed uninhabitable or have evacuation periods.
- Offer reasonable payment plans to help ease the financial impacts resulting from the disaster event.
- Suspend disconnection for non-payment.

Programs Available to SCE Customers

- **California Alternate Rates for Energy (CARE)**
 - This program offers income-eligible customers an approximate 30% discount on their monthly utility costs.

- **Medical Baseline**
 - This program is for customers who are reliant on electrically operated medical equipment. This program provides customers with additional electricity per day at discounted rate, helping to reduce monthly utility costs.

- 🌧️ Gather food and water as well as personal protective equipment.
- 🌧️ Have cash, fuel, and charge your phone.
- 🌧️ Gather a battery-operated radio and extra batteries.
- 🌧️ Prepare a [family emergency communication plan](#)
- 🌧️ **Sign up for emergency alerts:** Sign up for Alert SouthBay emergency notifications by texting “alertsb” to 888-777 or visiting [alertsouthbay.com](#). Download the free [MyRPV app](#) to your devices from your app store.
- 🌧️ **Know Your Zone.** Go to [PVPready.gov](#). Click “Find Your Zone” and search your address. Save your zone number in your phone or write it down and keep it somewhere that’s easy to find in an emergency. In an emergency, check the zone map at [PVPready.gov](#) to see if your zone is under a shelter-in-place or evacuation order.

 **Sandbag Availability:** The City of RPV offers residents empty sandbags and sand. Pick up unfilled sandbags at the City Hall info desk during regular hours. 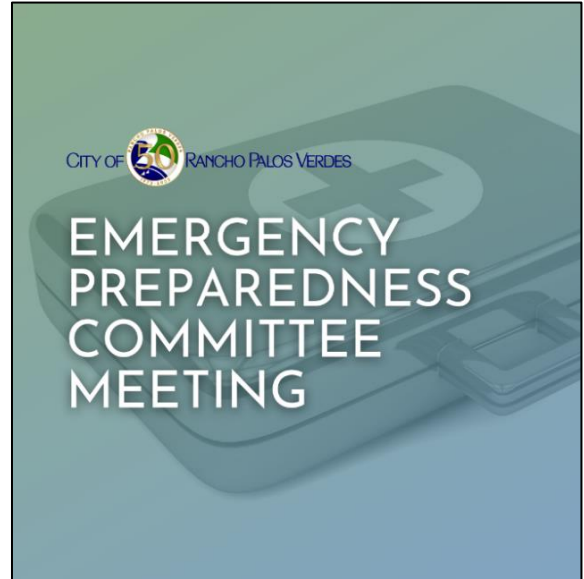

EMERGENCY PREPAREDNESS TIPS

Thunderstorms and Lightning Safety

Thunderstorms last an average of 30 minutes and can cause dangerous lightning, large hail, flash flooding, and strong winds. They often develop quickly and with little warning, so it is important to learn the danger signs and plan ahead. Lightning is a leading cause of injury and death from weather-related hazards. Although most lightning victims survive, people struck by lightning often report a variety of long-term, debilitating symptoms.

Understanding Severe Weather Alerts:

Do you know the difference between a National Weather Service Severe Thunderstorm Watch and a Severe Thunderstorm Warning? Check your knowledge below:

- **Severe Thunderstorm Watch:** Be prepared! Severe thunderstorms are possible in and near the watch area. Stay informed and be ready to act if a severe thunderstorm warning is issued. The watch area is typically large, covering numerous counties or even states.
- **Severe Thunderstorm Warning:** Take action! Severe weather has been reported by spotters or indicated by radar. Warnings indicate imminent danger to life and property. Take shelter in a substantial building. Get out of mobile homes that can blow over in high winds. Warnings typically encompass a much smaller area (around the size of a city or small county) that may be impacted by a large hail or damaging wind identified by an NWS forecaster on radar or by a trained spotter/law enforcement who is watching the storm.



Be Prepared Before a Thunderstorm Threatens

- **Be Weather-Ready:** Check the forecast regularly to see if you're at risk for severe weather. Listen to local news or a [National Oceanic and Atmospheric Administration \(NOAA\) weather radio](#) to stay informed about severe thunderstorm watches and warnings. Check [Weather-Ready Nation](#) for tips.
- **Subscribe for Emergency Alerts:** Sign up for Alert SouthBay emergency notifications by texting “alerts” to 888-777 or visiting [alertsouthbay.com](#). Download the free [MyRPV app](#) to your devices from your app store.
- **Create a Communications Plan:** Have a family plan with an emergency meeting place and related information. Pick a safe room in your home, such as a basement, storm cellar, or an interior room on the lowest floor with no windows. Get more ideas for a plan at: [ready.gov/make-a-plan](#)
- **Practice Your Plan:** Conduct a family severe thunderstorm drill regularly, so everyone knows what to do if a damaging wind or large hail is approaching. Ensure all family members know to go there when severe thunderstorm warnings are issued. Don't forget pets if time allows.
- **Prepare Your Home:** Keep trees and branches trimmed near your house. If you have time before severe weather hits, secure loose objects, close windows, and doors, and move any valuable objects inside or under a sturdy structure.
- **Help Your Neighbor:** Encourage your loved ones to prepare for severe thunderstorms. Take CPR training so you can help if someone is hurt during severe weather.

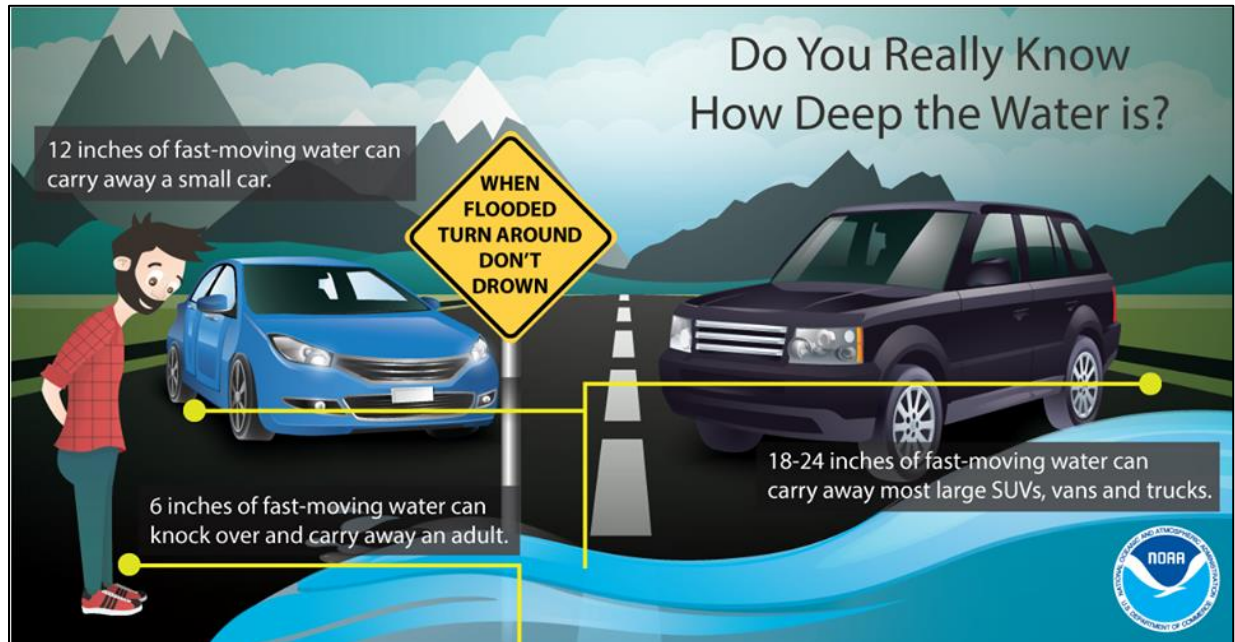
Staying Safe During a Thunderstorm

- **Stay Weather Ready:** Continue to listen to local news or a NOAA weather radio to stay updated about severe thunderstorm watches and warnings.
- **At Your House:** Go to your secure location if you hear a severe thunderstorm warning. Damaging wind or large hail may be approaching. Take your pets with you if time allows.

- **At Your Workplace or School:** Stay away from windows if you are in a severe thunderstorm warning and damaging wind or large hail is approaching. Do not go to large open rooms such as cafeterias, gymnasiums, or auditoriums.
- **Outside:** Go inside a sturdy building immediately if severe thunderstorms are approaching. Sheds and storage facilities are not safe. Taking shelter under a tree can be deadly. The tree may fall on you. Standing under a tree also puts you at a greater risk of getting struck by lightning.
- **In a Vehicle:** Being in a vehicle during severe thunderstorms is safer than being outside. However, drive to the closest secure shelter if there is sufficient time.

Staying Safe After a Thunderstorm

- **Stay Informed:** Continue listening to local news or a NOAA weather radio to stay updated about severe thunderstorm watches and warnings. More severe thunderstorms could be headed your way.
- **Contact Your Family and Loved Ones:** Let your family and close friends know that you're okay, so they can help spread the word. Text messages or social media are more reliable forms of communication than phone calls.
- **Assess the Damage:** After you are sure the severe weather threat has ended, check your property for damages. When walking through storm damage, wear long pants, a long-sleeved shirt, and sturdy shoes. Contact local authorities if you see power lines down. Stay out of damaged buildings. Be aware of insurance scammers if your property has been damaged.
- **Help Your Neighbor:** If you come across people that are injured and you are properly trained, if needed, provide first aid to victims until emergency response team members arrive.

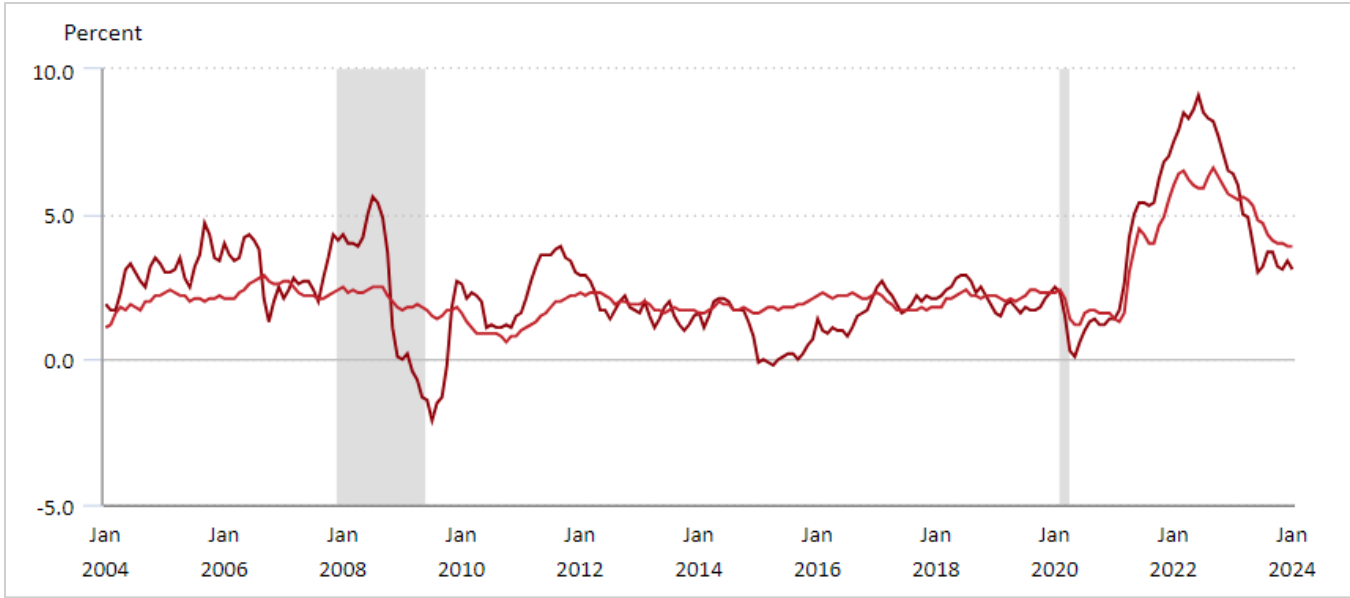

Consumer Price Index – January 2024

In January, prices increased 3.1% over the same period last year, and by 0.3% over the previous month according to the U.S. Bureau of Labor Statistics. Inflation rose more than anticipated in January primarily due to increases in housing and grocery expenses, which underscores the difficulty of taming price pressures within the economy. Core prices, which exclude food and energy, grew by 0.4% over the month and marked the largest monthly gain since April 2023. Core inflation increased annually by 3.9% and was reported slightly above expectations.

All things considered, the data shows that although inflation has significantly decreased from a peak of 9.1%, it is still higher than the 2% target set by the Federal Reserve.

Chart 1. 12-month percent change in CPI (U.S)



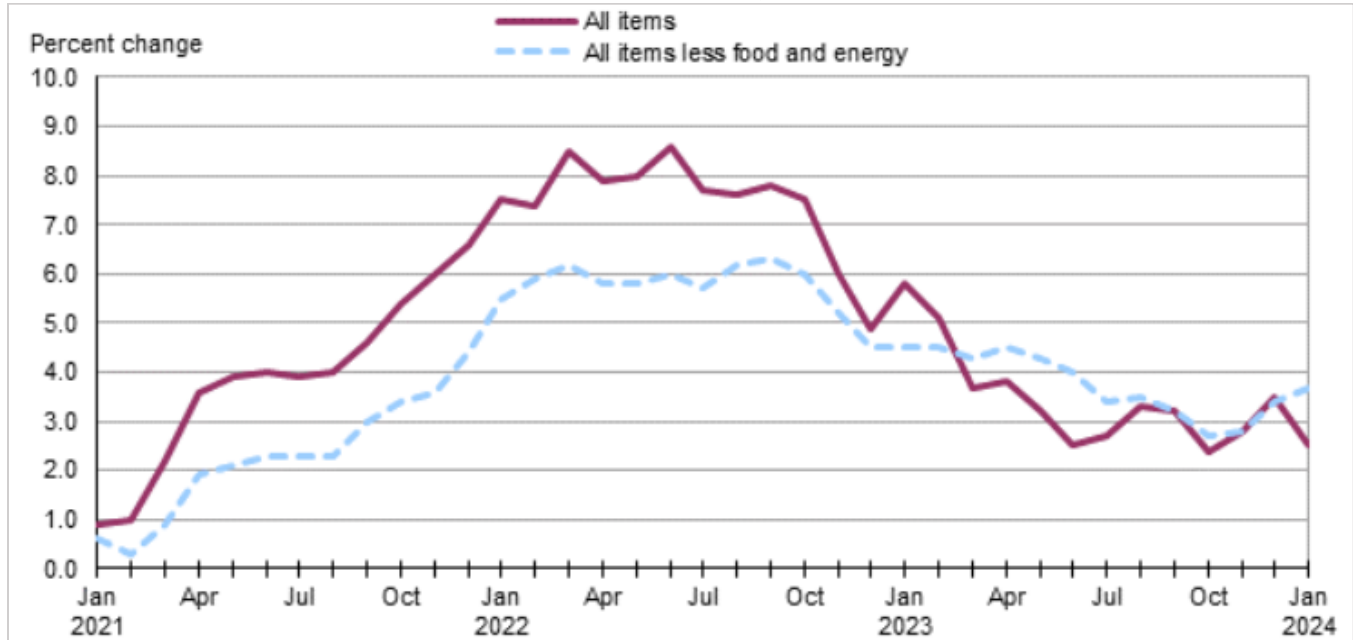
CPI – Los Angeles Area

According to the latest report, prices in the Los Angeles region increased by 1% in January. The month over month increase in January was largely brought on by rising housing and apparel costs. Core prices, less food and energy, advanced by 1.3% over the previous month.

Over the 12 months ending January, CPI rose by 2.5%. Compared annually, food prices

rose by 3.4%, while energy prices decreased 12.4% due to a drop in the cost of natural gas service. The index for all items less food and energy increased 3.7% over the year.

FAC Meeting Recap

A summary of the Finance Advisory Committee (FAC) meeting held on February 8 is provided below.

- Staff presented the legal requirements associated with the City’s investment policy, the overall performance of the City’s investment portfolio, and reiterated the policy objectives for safety, liquidity, and yield.
- This presentation highlighted additional information regarding public fund investments and the individual investment instruments that may be acquired by the City as authorized by law.
- Following a brief discussion, the committee’s overall sentiment was that interest earnings generated by the City’s investment portfolio were on par with the cities surveyed from the surrounding area.
- Given the intricacies of investments and to explore potential revenue opportunities, the FAC moved to form an ad hoc subcommittee and will carefully review the investment policy and portfolio allocations.
- The subcommittee’s recommendations, if any, will be presented to the FAC for future consideration.

This week, final inspections for various portions of the project continue to be performed, and construction crews will continue to make the required corrections.

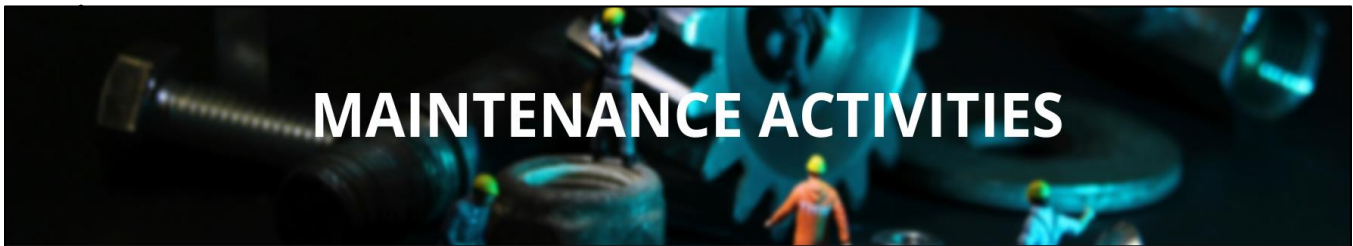

- Installed a new exhaust fan in the men's restroom at Hesse Park.



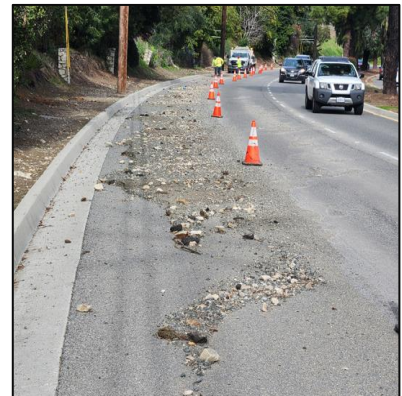
- Weed removal, brush clearance, and debris removal continued throughout the City at medians and various right-of-way locations:

Public Right-of-Way/Roadway Repairs

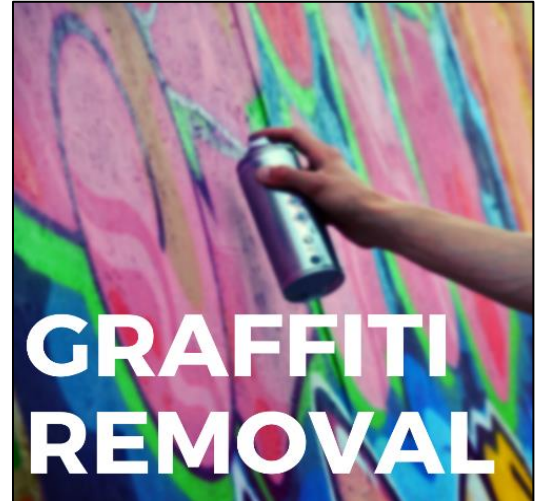
- Repaired right-of-way deviations and cracks at the following locations:

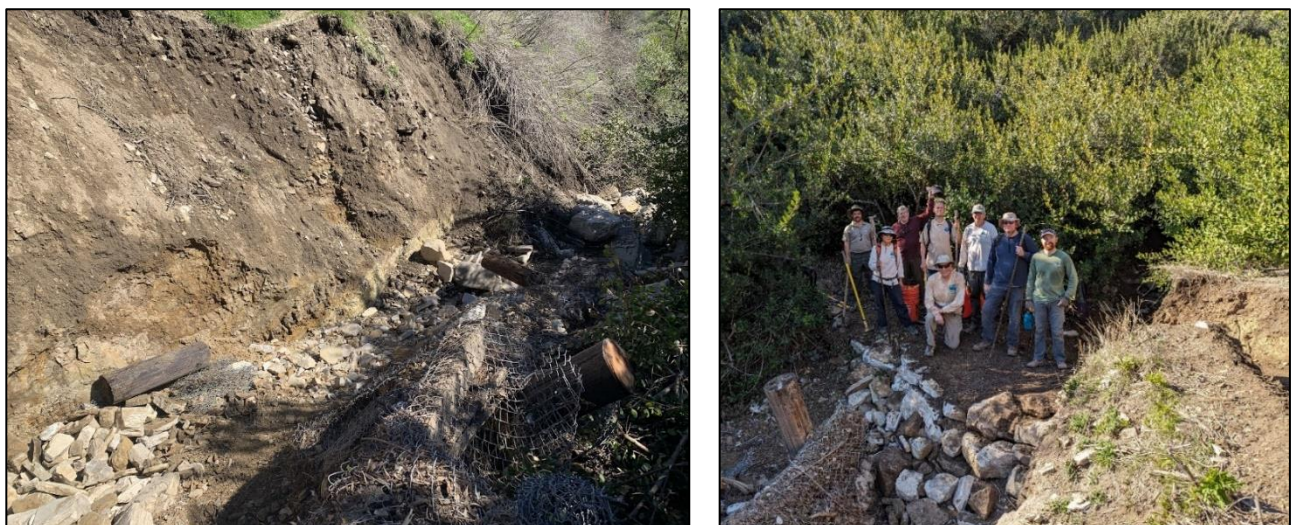
Abalone Cove

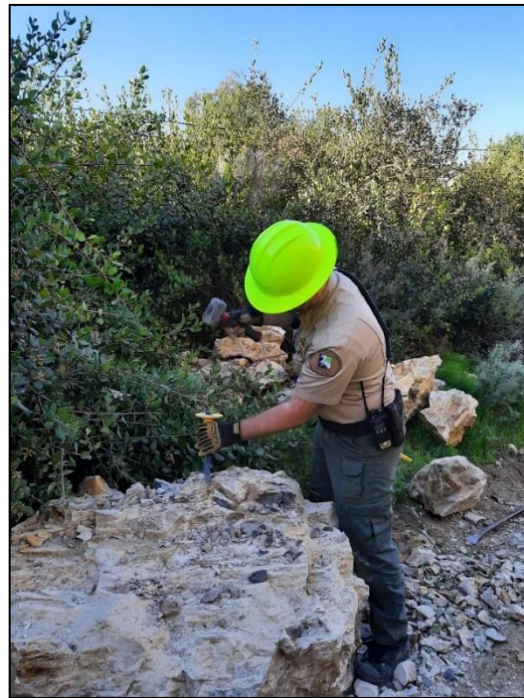
Filiorum Reserve
