Ladera Linda Community Park Grand Opening This Friday

After years of planning and construction, the long-awaited opening of the Ladera Linda Community Park is set for February 23. The event begins at 3:30 p.m. and the ribbon cutting ceremony is scheduled for 5 p.m. with a reception to follow. The park features a new community building, walking paths, basketball courts, paddle tennis courts, lawn areas and much more. Along with a chance to see this beautiful brand-new park firsthand, there will be guest speakers, interactive stations for kids and activities led by City Staff and Docents. February 20, 2024 City Council Meeting Highlights

Highlights from the February 20 City Council meeting:

- The Council voted to urge Gov. Newsom to declare a state of emergency to expedite critical landslide remediation efforts and to request President Biden declare a federal disaster to potentially make federal funding and assistance available.
- The Council also directed City staff to complete the Final Environmental Impact Report (EIR) and final engineering for the

proposed long-term Portuguese Bend Landslide Remediation Project based on its original concept design, and to return with an update at the March 19 meeting.

With this approach, the City expects to move up the project's Final EIR release date to May 2024 instead of September 2024. This alternative approach could still allow the City to make changes to the project based on a concurrent analysis of options to reduce environmental impacts.

- The Council agreed to join the other Peninsula cities in making necessary upgrades to the region's shared automated license plate recognition (ALPR) camera system, including replacing 29 cameras. RPV's share of the cost is 60% or \$284,850.
- City staff gave an update on the pilot program creating the City's new Public Safety Division using in-house staff to enhance public safety services. Next steps include hiring staff and procuring equipment to support the new division.

City Council Honors Former Mayor Ann Shaw, Receives \$35K Check from First Annual Run for Myles

At last night's meeting, the Council also honored RPV legend Ann Shaw, who is moving to Massachusetts. The Council recognized her tremendous legacy of service to the City, including her time on the Council from 1977-1983 and term as Mayor in 1979-80. Thank you, Former Mayor Shaw, for all your contributions to RPV, and we will miss you! The Council also received a \$35,000 check from the family of the late RPV resident Myles Helm. These funds were raised during the first annual Run for Myles 5k/10k held in his memory in September 2023 and will directly benefit the preservation and enhancement

of parks and trails in Rancho Palos Verdes. Stay tuned for details on the next Run for Myles on September 28!

Portuguese Bend Landslide Local Emergency Update

Amid unprecedented land movement impacting local residences, landmarks and public infrastructure, the Rancho Palos Verdes City Council voted unanimously on February 20 to [submit a letter](#) urging Gov. Gavin Newsom to declare a state of emergency in the City to waive and/or suspend state permitting requirements for critical landslide remediation efforts. An emergency declaration by the state would allow the City to significantly expedite the landslide mitigation measures identified in the Portuguese Bend Landslide Remediation Project.

City Council Urges Gov. Newsom to Declare State of Emergency to Expedite Critical Landslide Remediation Efforts



When declaring a state of emergency, the governor has the ability to waive and/or suspend certain state permitting requirements in order to protect against immediate threats to life and property. In this case, a suspension of certain state permitting requirements would allow the City and local Geologic Hazard Abatement Districts to immediately proceed with critical measures needed to stabilize the landslide, without the costs and time delays typically experienced with obtaining permits.


City Statement on Wayfarers Chapel

The City of Rancho Palos Verdes is saddened by the announcement of the temporary closure of Wayfarers Chapel, a national landmark and iconic cultural treasure of the City and the Palos Verdes Peninsula. Over the past several months, the City has been in communication with Wayfarers Chapel regarding impacts of accelerated movement in the landslide complex and efforts to remediate them. Last week, chapel officials requested an inspection by the City's Building Official. While damage and signs of movement were observed, no structures were yellow- or red-tagged. The City was informed on February 14 that the Wayfarers Chapel Board of Directors made the voluntary decision to close the chapel and grounds to the public while repairs can be made. The City stands ready to support Wayfarers Chapel in any way possible to safely reopen this sacred space to the community.



Residential Fire Insurance Advocacy Letter - Now Available on the City Website

Are you struggling to find adequate fire insurance for your home? In California, the increasing frequency and severity of wildfires have significantly impacted the residential fire insurance market. This has resulted in higher premiums, reduced coverage options, and, in some cases, policy cancellations.

In RPV, these statewide challenges are evident, with many residents reporting increased premiums and difficulty in maintaining their fire insurance coverage. In response to these concerns, the City's Emergency Preparedness Committee (EPC), in collaboration with City Staff, has developed a [comprehensive insurance resource letter \(PDF\)](#) (see attached letter).



This advocacy tool is tailored to help you, our residents and businesses, communicate effectively with your insurance providers to advocate for maintaining your current insurance policies and potentially negotiating lower premiums. We encourage you to utilize this resource to its full extent.

Don't Let Earthquakes Catch You Off Guard – Download the Free MyShake App Now

With recent earthquakes in our region, it's a good reminder to download the free "MyShake" app. The MyShake app sends a audible and text warning to cell phone users that shaking is about to occur. The system uses ground-motion sensors to detect earthquakes that have already started and estimates their size, location, and impact. When it detects a significant magnitude quake of 4.5 or more, the system issues a ShakeAlert message, providing a warning so people can take cover. Severe Weather Preparedness Tips

Severe weather can happen anytime in any part of the country. Severe weather can include hazardous conditions produced by thunderstorms, including damaging winds, large hail, flooding, and flash flooding. Severe weather events can cause downed trees and power lines and flying debris, leading to power outages, transportation disruptions, damage to buildings and vehicles, and injury or death. Proper planning and understanding the risks may help save your family from injury and inconvenience when severe weather strikes.

Here are some crucial steps to take in order to be prepared.

Preparing for Severe Weather Events

- **Be Weather-Ready:**
 - Check the forecast regularly to see if you're at risk for severe weather. Listen to local news or a [NOAA Weather Radio](#) to stay informed about severe thunderstorm watches and warnings.
- **Prepare Your Home:**
 - Keep trees and branches trimmed near your house.

- If you have time before severe weather hits, secure loose objects, close windows, and doors, and move any valuable objects inside or under a sturdy structure.
- **Help Your Neighbor:**
 - Encourage your loved ones to prepare for severe thunderstorms.
 - Take CPR training so you can help if someone is hurt during severe weather.

Staying Safe During Severe Weather

- **Monitor Weather Conditions:**
 - Listen to the local news or NOAA Weather Radio to keep abreast of approaching storms, their severity, and reported severe weather.
 - A NOAA Weather Radio will alert you if any watches or warnings are in effect or issued for your area.
 - If a WATCH is issued, pay special attention to changing weather conditions and be ready to take action
 - if a WARNING is issued or severe weather strikes.
- **If Caught Outside or Driving:**
 - Immediately go inside a sturdy building during a high wind warning or severe thunderstorm warning and move to an interior room or basement.
 - Listen to the local news or NOAA Weather Radio for updates.
 - Take shelter in your car if you are not near a sturdy building. If possible, drive to a nearby sturdy building. Otherwise, move your car to a location where it is less likely to be hit by falling trees or power lines.
 - If no shelter is available, avoid trees, power lines, and the side of the road. Keep in mind that power lines that are lying on the ground may be live.

Staying Safe After Severe Weather

- Continue listening to local news or NOAA Weather Radio for updated information and instructions. Access to some parts of the community may be limited, or roads may be blocked.
- Do not go near downed power lines. Report downed lines to your local utility emergency center and the police. Do not try to free lines or remove debris yourself.
- Help people who require special assistance—infants, the elderly, those without transportation, large families who may need additional help in an emergency, people with disabilities, and those who care for them.

- Avoid driving and other travel until conditions have improved. If you are using a portable generator, take precautions against carbon monoxide poisoning, electrocution, and fire.
- Exercise caution when handling debris that may have blown into your yard.

Emergency Preparedness Planning for an Evacuation

The Los Angeles County Fire Department has provided the following invaluable guidance for residents on preparing for potential emergency evacuations. Here's what you need to know:

PRE-PLANNING:

- Organize critical documents for emergency evacuation.
- Organize original documents in a special binder.
- Scan documents, into a password protected encrypted flash drive.

CRITICAL DOCUMENTS TO INCLUDE IN YOUR EMERGENCY BINDER:

- PERSONAL DOCUMENTATION**-Degrees, professional licenses, driver's license, marriage certificate, social security card, concealed carry permit, military documents, naturalization/immigration documents.
- MEDICAL INFORMATION**-Advance Care Directives, immunization records, critical medical records, list of current medications and pharmacy, copies of both front and back insurance cards.

- INSURANCE POLICIES**-Life, health, auto, and homeowners policies including contact information and policy numbers.
- PROPERTY DOCUMENTS** - Property deeds, loan documents, automobile titles.
- LEGAL DOCUMENTS** - Contracts, adoption records, custody records, divorce papers, last will and testament, living trust, or family trust documents, power of attorney, rent or lease agreement, contact information for attorney.
- FINANCIAL** - Savings bonds, stocks, and bonds, statements from investment firms, banking information, credit card numbers, (website, account information and passwords) retirement and pension.
- CONTACT INFORMATION** - Written contact information for each member of your family, close relatives, and friends.
- PET INFORMATION** -Pet license information along with vaccination records, and veterinary contact numbers.
- RECENT PHOTOS** - Include a recent photo of each family member and pets. In the event you get separated from your loved one, a recent photo, may help locating him/her. They are also helping in identifying the deceased.
- LIST OF FIREARMS** -Include a list of all firearms and be sure to include the serial numbers.
- PASSWORD LIST** - You will need a list of all of your passwords to gain access to your online life. You need to decide exactly how you want to handle storing passwords to prevent passwords from being compromised.
- FAMILY KEEPSAKES** - Make a digital copy of meaningful family photos (wedding photos, baby pictures, special events) and other family memories that would be impossible to replace. Store them in a good quality flash drive with your documents.
- VIDEO INSURANCE INVENTORY** - Create a video inventory of all your possessions for insurance purposes. Do a video walkthrough of your home, garage, and entire property. Be sure to capture brand names and serial numbers. Describe possessions while you are making the recording. Include anything of value such as art, jewelry, collections, firearms, etc. Remember to document cupboards, closets, and drawers. If you are unable to prove what you have, the insurance

company may not pay. Store this video on a labeled flash drive. Update it annually or when you purchase an expensive item.

- EXTERNAL HARD DRIVE** - It is easy to store an amazing amount of information on one external hard drive. Make it a habit to make a special back up of your computer every 6 months.



During an evacuation

- Call or email the out-of-state contact in your family communications plan.
- Secure your home by closing and locking doors and windows.
- Unplug electrical equipment such as radios, televisions, and small appliances.
- Leave a note telling others when you left and where you are going.**
- Check on neighbors who may need a ride.
- Follow recommended evacuation routes. Do not take shortcuts, they may be blocked.



Evacuation WARNING vs. Evacuation ORDER - What's the difference?

EVACUATION WARNING: If you receive an evacuation warning, this means you need to start preparing to leave. If you have animals, children, or need additional time evacuating, this is the time to leave.

EVACUATION ORDER: If you receive an evacuation order, this means you need to leave immediately. Emergency responders have determined there is an imminent life safety risk and you need to evacuate.

ALWAYS REMEMBER, YOU DON'T HAVE TO WAIT TO EVACUATE. IF YOU FEEL UNSAFE, LEAVE.

What does "SHELTER IN PLACE" mean?

SHELTER IN PLACE: If authorities tell you to shelter in place, it means you need to go indoors. Shut and lock doors and windows. Prepare to self-sustain until further notice and/or contacted by emergency personnel for additional direction.

As your dedicated law enforcement team at the Los Angeles County Sheriff's Department (LASD) Lomita Station, we are committed to keeping our community safe and informed. Here are some updates and initiatives we've been working on:

Community Engagement and Crime Prevention:

Last year, our Detective Bureau Sergeant and Crime Analyst actively engaged with our community through neighborhood watch meetings, fostering dialogue and sharing valuable crime prevention strategies. We also organized a special gathering at the Peninsula Center, bringing together local businesses and owners to discuss proactive measures to enhance safety.



Holiday Season Surveillance:

During the busy holiday season, we implemented surveillance operations in the Peninsula Center to deter commercial burglaries, ensuring a secure environment for businesses and shoppers alike.

Crime Trends Analysis:

We've been closely analyzing crime data, and we're pleased to report decreases in Aggravated Assaults, Commercial and Other Burglaries, and Other Larceny/Thefts compared to the previous year. However, there has been a slight increase in residential burglaries and Grand Theft Auto (GTAs).

Targeted Initiatives:

In response to the rise in residential burglaries, we launched targeted suppression initiatives during the summer, focusing on certain neighborhoods in RPV. These efforts aim to proactively address emerging crime trends and keep our neighborhoods safe.

Collaborative Efforts:

Collaborating with our department's Taskforce Regional Auto Theft Prevention (TRAP) team, we've conducted operations to support patrol efforts in recovering stolen vehicles, bolstering community safety.

Continued Vigilance:

Moving forward, we remain committed to proactive education on crime prevention for residents and businesses alike. Our patrol efforts will continue to be vigilant, especially in areas susceptible to residential burglaries. We will also continue working closely with departmental resources and neighboring cities to address community concerns.

Enhanced Security Measures:

You may have noticed our Mounted Enforcement Detail and utility vehicles patrolling along trails. These measures are part of our ongoing efforts to enhance security and maintain a visible presence in the community especially open space areas.

Thank you for your continued partnership in keeping our community safe. Remember, your safety is our priority, and we're here for you.

Public Safety Division Update



At last night's meeting, Staff presented an update on the Public Safety pilot program to the City Council. This two-year initiative was approved during the May 2, 2023 City Council meeting. Palos Verdes Peninsula ALPR Camera System Upgrades

Also last night, the Council ratified an amendment to the Memorandum of Understanding (MOU) among the four Peninsula cities for the Peninsula-wide Automatic License Plate Recognition (ALPR) system. The original MOU, enacted in 2016, marked the implementation of ALPR system strategically covering key areas, entry points, and major corridors across the Palos Verdes Peninsula. The unanimously approved amendment updates cooperation terms for system replacement and ongoing maintenance.



The camera upgrades represent a collaborative effort involving the cities of Rancho Palos Verdes, Rolling Hills, Rolling Hills Estates, and Palos Verdes Estates. With Vigilant Solutions, the total project cost amounts to \$474,750, divided among the four cities. After seven years, the existing Peninsula-wide system is no longer under warranty, with certain locations currently non-functional. A report was presented to the Peninsula Public Safety Committee on February 1, receiving approval to advance the amendment to individual city councils. The agreement was already approved by the city councils of Rolling Hills Estates and Palos Verdes Estates and is scheduled for review at the Rolling Hills City Council on February 26.

ALPR technology plays a pivotal role in law enforcement by facilitating the apprehension of stolen vehicles and the identification of wanted individuals. Thus, the replacement of the regional ALPR system is crucial for maintaining effective crime prevention and law enforcement within our community. 

Public Safety Reimbursement Program

The City of Rancho Palos Verdes offers public safety reimbursements for the purchase of doorbell or neighborhood camera systems. Please see the graphic to the right to learn more about the application process.

The City will provide a one-time reimbursement for half of the cost of a new public safety purchase, up to \$2,000 for neighborhoods, and up to \$100 for individuals.



The City will additionally waive permit fees directly related to the installation of the approved purchase. The neighborhood, individual, or vendor will be responsible for completing any necessary permits prior to installation.

Retail Headlines – February 2024

Retail news this month includes stories about Target's membership program, bigger Walmart stores, a shift in consumer confidence, and more.

How Retail is Shaping Up in 2024

While some pandemic problems in retail have subsided, such as the leveling off of inventories and a return to buying in stores and online, 2024 is not free from challenges. Inflation is still influencing consumers, and industry turnover remains on the top of mind for retail executives. Additionally, retailers used layoffs as a cost-cutting measure last year, and this year has seen more of the same as companies prioritize profits in a challenging macroeconomic climate. Theft continues to be reported as a problem with some stores closing their doors as a result. However, important data regarding what has been labeled as "organized retail crime" has come under recent scrutiny.

Target Weighs Paid Membership Program Similar to Amazon Prime

Target Corp. is considering launching a new paid membership service similar to Amazon Prime or Walmart+ as it searches for strategies to boost growth and take on more established competitors. The new program, internally known as Project Trident, could begin operations as soon as this year. This new program would go beyond current offerings in Target's free loyalty program and offer other benefits and require a fee.

Walmart Plans to Add More Than 150 Large-Format Stores

Despite having a massive presence in the United States already, Walmart sees room to grow. Over the next five years, the company intends to construct or renovate more than 150 large-format stores according to a recent announcement. The bulk of the locations will be brand new, but some will be converted from smaller locations into Supercenters offering a wide selection of goods and groceries.


Retailers are Finding More of What They Want Off Mall

Certain retailers are redefining their relationship with malls after decades together. Macy's, Dillard's, Belk, and J.C. Penney are just a few of the stores that have long been regarded as the cornerstones of stability for America's indoor malls. However, the pandemic has accelerated the trend of those retailers looking more and more off-mall in recent years. Additionally, a large number of well-known specialty shops that usually occupy American mall concourses have announced plans to reduce their mall footprint.

Americans are Feeling Optimistic about the Economy Again

It has been years since American consumers have felt this optimistic about the state of the economy. The University of Michigan's monthly survey of consumer sentiment in the U.S. saw a 13% increase in January, marking the highest level since July 2021. Moreover, the New York Federal Reserve's survey of consumer finances for December showed that perceptions of households' current financial situations also improved. To some, this may signal an end to the past sentiment that something in the economy still felt a bit off despite the low unemployment rates and the slowing pace of inflation.





Coastal Officer Hearing for Proposed Project on Packet Road

As the subject property is located within the Appealable Area of the City's Coastal Specific Plan District, the project requires consideration of a Coastal Development Permit by the City's Coastal Hearings Officer (Director of Community Development). 



Rancho Palos Verdes City Council Urges Gov. Newsom to Declare State of Emergency to Expedite Critical Landslide Remediation Efforts

Feb. 20, 2024 (Rancho Palos Verdes, Calif.) — Amid unprecedented land movement impacting local residences, landmarks and public infrastructure, the Rancho Palos Verdes City Council voted unanimously on Feb. 20 to submit a letter urging Gov. Gavin Newsom to declare a state of emergency in the City to waive and/or suspend state permitting requirements for critical landslide remediation efforts. An emergency declaration by the state would allow the City to significantly expedite the landslide mitigation measures identified in the Portuguese Bend Landslide Remediation Project.

“While we know we cannot completely stop the landslide in our community, we have spent years identifying peer-reviewed engineering strategies to greatly slow its movement. Now, we need the state’s help in making their implementation a reality,” said Rancho Palos Verdes Mayor John Cruikshank. “An emergency declaration by Gov. Newsom could help the City expedite remediation efforts to slow the movement as quickly as possible.”

When declaring a state of emergency, the governor has the ability to waive and/or suspend certain state permitting requirements in order to protect against immediate threats to life and property. In this case, a suspension of certain state permitting requirements would allow the City and local Geologic Hazard Abatement Districts to immediately proceed with critical measures needed to stabilize the landslide, without the costs and time delays typically experienced with obtaining permits.

“The City has a landslide mitigation plan that needs to be started now, but we are restrained by following the all-too-lengthy CEQA process that does not account for the immediate safety needs of our residents and entire community within the landslide complex,” added Cruikshank. “We are calling on the state to help us address this urgent problem that will only get worse as we feel the impacts of recent record rainfall in the weeks and months ahead.”

An emergency declaration would allow the City to streamline or bypass permitting for measures, such as:

- Filling fissures to prevent surface water from directly recharging the water table and further lubricating the slip plane
- Constructing drainage swales, lining certain canyons with non-penetrable membrane, and/or installing flexible drainage pipes to properly convey surface water to the ocean and/or sanitary lines to prevent recharging the water table
- Installing dewatering wells in the form of horizontal hydraugers and/or vertical dewatering wells to extract groundwater from the slip plane and reducing the local water table.

The City Council also voted on Feb. 20 to ask Gov. Newsom to request President Biden declare a federal disaster, which could potentially make federal assistance and funding available. In addition to submitting the letter to Gov. Newsom, the Council voted to expedite the Portuguese Bend Landslide Remediation Project by directing City staff to complete the Final Environmental Impact Report (EIR) and final engineering for the project based on its original concept design. With this approach, the City expects to move up the project's Final EIR release date to May 2024 instead of September 2024. This alternative approach could still allow the City to make changes to the project based on a concurrent analysis of options to reduce environmental impacts.

Over the past year, the City of Rancho Palos Verdes has contacted state and federal representatives to convey the urgent nature of the accelerating land movement in the greater Portuguese Bend Landslide Complex. In those discussions, City staff emphasized the need to immediately respond to the unprecedented rate of land movement and its severe damage to Palos Verdes Drive South, utility lines (water, sewer, gas line and electricity), eight miles of trails in the Palos Verdes Nature Preserve, the closure of residential streets, the temporary closure of a federal and state designated historic landmark, Wayfarers Chapel, and the red-tagging of homes.

The City of Rancho Palos Verdes (RPV) is dedicated to minimizing wildfire risks through prevention, early detection, and home hardening techniques aimed at safeguarding both property and lives. On behalf of the policy owner, this letter is being provided to you and your adjuster outlining the City's strategies and measures to reduce wildfire risk intended to contribute to more favorable insurance premium rates and policy availability for our residents and businesses.

RPV collaborates closely with the Los Angeles County Fire Department (LACoFD), [a Class II department recognized by the Insurance Services Office \(ISO\)](#). Covering approximately 26.3 square miles and serving an estimated 65,000 Palos Verdes Peninsula (PVP) residents, LACoFD operates six strategically located fire stations, including two within RPV.

Notably, RPV enhances its wildfire management capabilities with the following measures to significantly improving our emergency response and preparedness:

- Maintaining City-owned landscaped and open spaces near residential areas through year-round fuel modification. RPV's robust [ANNUAL WEED ABATEMENT PROGRAM](#) aims to create defensible spaces between open areas and combustible structures, significantly reducing fire fuel load. Regular inspections ensure adherence to [LACoFD's Defensible Space requirements](#).
- [GOAT GRAZING FOR FUEL MODIFICATION](#): On city-owned lands including public rights-of-way. Goats effectively remove brush and grass from hard to access terrain thereby significantly reducing fire loads and risks.
- [GENASYS PROTECT \(ZONE HAVEN\)](#): Implemented in May 2023, this critical emergency preparedness tool is available to residents at [PVPready.gov](#), as an Evacuation Management Platform in identifying evacuation zones and guiding residents on necessary actions during emergencies.
- [PANO AI'S WILDFIRE CAMERAS](#): This network of AI cameras provide early detection of wildfire smoke across the Palos Verdes Peninsula and has proven effective in delivering timely and accurate early alerts for fire ignitions.
- [HELOPOD FIREFIGHTING DIP SOURCE](#): The City installed a [HeloPod](#) at its Civic Center that is in close proximity to open space and canyons areas enabling rapid water refilling for firefighting helicopters.

The City has further initiated the following measures to enhance community safety against wildfires:

- [Firescaping training workshops](#).
- [Home hardening videos](#).
- [Monthly emergency preparedness safety tips](#).
- Collaborative efforts with Southern California Edison (SCE) for utility line hardening and undergrounding.
- A comprehensive [Multi-Jurisdictional Hazard Mitigation Plan](#), offering in-depth insights into RPV's wildfire mitigation strategies on pages 151-158 of the plan.

City of Rancho Palos Verdes to Celebrate Grand Opening of Revitalized Ladera Linda Community Park

Feb. 20, 2024 (Rancho Palos Verdes, Calif.) — The City of Rancho Palos Verdes this week will celebrate the long-awaited grand opening of the revitalized Ladera Linda Community Park, which recently underwent a major makeover.

City officials and community leaders will gather Feb. 23 at 3:30 p.m. at the 11-acre site overlooking the ocean at 32201 Forrestal Drive to celebrate, followed by a 5 p.m. ribbon-cutting ceremony at sunset. This free event is open to the public and will mark the culmination of more than a decade of planning and community engagement as part of one of the most significant recreation projects in the City's history.

"The grand opening of the Ladera Linda Community Center is finally here after years of planning and hard work by our residents, City staff, and contractors," said Rancho Palos Verdes Mayor John Cruikshank. "This new center has much needed facilities for our entire community. I look forward to cutting the ribbon and presenting this beautiful facility to our residents."

Along with a chance to see the brand-new park, the grand opening will include guest speakers, interactive stations for kids, and activities led by City staff and Los Serenos de Point Vicente docents. Refreshments and appetizers will be provided.

The new Ladera Linda Community Park features a 6,790-square-foot community center designed by Culver City-based architecture firm Johnson Favaro. The building includes a dividable multi-purpose room, classrooms, a staff office, a warming kitchen, and a meeting room that also serves as a "discovery room" displaying exhibits of local flora, fauna, and historic information. The site also includes patio areas, one and a half basketball courts, two paddle tennis courts, a children's playground, tiered outdoor seating, a lawn area, walking paths that traverse through restored native landscaping, and 57 parking spaces. Electric vehicle charging stations for seven parking spaces are expected to be installed this summer thanks to a \$76,730 grant from the U.S. Department of Energy's Energy Efficiency Conservation Block Grant Program.

City Manager Ara Mihranian called the grand opening of Ladera Linda Community Park "a long-time dream come true."

"Beginning this weekend, residents, especially those residing on the east side of the City, will have a new place to recreate and congregate with two playgrounds, sports courts, walking paths, picnic tables, a

discovery room showcasing the Palos Verdes Peninsula, and classrooms for community meetings and recreation programs for all ages,” he said.

Originally home to an elementary school that opened in 1967, following a decline in student enrollment, the site was repurposed as a park and community center in 1982. Ladera Linda Community Park is located next to the Forrestal Reserve, which is part of the Palos Verdes Nature Preserve, and features a variety of recreational facilities, including soccer fields owned by the Palos Verdes Peninsula Unified School District that are used by American Youth Soccer Organization leagues. With the park’s five aging buildings in serious disrepair, the City began a planning process in 2014 to revitalize the park and community center, involving input from a variety of stakeholders such as community members, neighboring residents, and local youth and sports groups. A master plan for the park was approved by the City Council in 2019 and the project was granted entitlements in 2021. Financing and construction agreements were approved in March 2022, followed shortly thereafter by demolition and the start of construction.

“It’s not too often that we get to rebuild a public facility,” said Director of Recreation and Parks Cory Linder. “While this project involved many years of public meetings, planning, and design, it is well worth the wait to ensure the community will have this beautiful new park and community center for future generations.”

After the grand opening ceremony on Feb. 23, Ladera Linda Community Park will be open daily from one hour before sunrise to one hour after sunset. If you are interested in renting the facility for a meeting or private event, please contact the Recreation and Parks Department at 310-544-5260.

Incorporated in 1973, the City is home to 42,000 residents, 7 1/2 miles of coastline, a 1,500-acre nature preserve, and hundreds more acres of open space. Residents and visitors enjoy expansive ocean views and ample opportunities for recreation, including golfing, hiking, beach access, and whale watching. Notable landmarks and points of interest include the Wayfarers Chapel designed by Lloyd Wright, the Point Vicente Lighthouse, the Point Vicente Interpretive Center, Terranea Resort, the Palos Verdes Nature Preserve, and Trump National Golf Club.
