RPV Celebrates Long-Awaited Grand Opening of Revitalized Ladera Linda Community Park

After years of planning and construction, Ladera Linda Community Park had its grand opening on February 23. Approximately 300 people attended the event, which began at 3:30 p.m. with informal touring of the building and park grounds. Staff and Los Serenos de Point Vicente Docents were on hand to answer questions about the facility. Scout Troop 955 led a flag ceremony followed by opening remarks by City Manager Ara Mihanian, Mayor John Cruikshank, Mayor Pro Tem Eric Alegria, and Councilmembers David Bradley and Barbara Ferraro. Former RPV Mayors Jim Knight, Susan Brooks, Jerry Duhovic and many other dignitaries were in attendance. Speeches were followed by a ceremonial ribbon cutting and champagne toast. Attendees enjoyed beautiful weather and sunset views while



exploring the many features of the new site including a new community building, walking paths, basketball courts, paddle tennis courts, and lawn areas.





Portuguese Bend Landslide Local Emergency Update

City of Rancho Palos Verdes Continues to Work with County and State Partners on Recovery Efforts

On February 20, 2024, the Rancho Palos Verdes City Council requested the Governor consider proclaiming a State of Emergency to suspend and waive state permitting requirements to allow the City to immediately begin work on landslide stabilization measures. The City Council's request included requesting the President declare a federal disaster to deploy FEMA resources.

The recent storms in Los Angeles County have brought widespread impacts countywide, in particular to the land movement occurring in Rancho Palos Verdes. The City, County and State have been maintaining a close watch with safety being the top priority. Ensuring coordination and collaboration at all levels of government is vital to the response and recovery efforts after any disaster and all community members across L.A. County should have the confidence that all levels of government and non-governmental partners are working together collectively.

Identifying the necessary response and recovery activities is a critical step in setting a solid roadmap for how our community members, jurisdictions and County get back to normal after any disaster. On February 4, 2024, prior to the start of the February rainstorms, the Governor proclaimed a State of Emergency, and the County proclaimed a local emergency. These proclamations are applicable to portions of the County that may have experienced loss or damage from mudslides, flooding, land movement or debris flows.

For weeks, the Los Angeles County Office of Emergency Management (OEM) has been working closely with partners from all levels of government to collect critical data to support the need for state and federal assistance to local jurisdictions. These efforts will continue as we work through the established processes that apply to all disasters.

While both the City of Rancho Palos Verdes and County work through response and recovery processes, the California Office of Emergency Services (Cal OES) has determined that the City is able to utilize the current February 4 State of Emergency to implement immediate emergency measures to help reduce further damage to the landslide area, including:

- The installation of additional drainage systems and wells to extract groundwater and
- Other measures that would prevent surface water from adding to the saturation.

The road to recovery is not always fast or easy. However, impacted community members should feel secure in knowing all agencies are continually working together to advocate for the necessary assistance communities need to get the critical support and resources available.

What does this mean for the City and the Portuguese Bend Landslide Remediation Project?

Now that the City has received clarity from the state, Staff is determining what immediate emergency measures can be implemented, with the goal of starting work by the end of March or early April. This involves meeting with government agencies such as L.A. County OEM, Cal OES, the California Coastal Commission, and the California Department of Fish and Wildlife, to name a few, regarding next steps, including how permitting and environmental review requirements can be bypassed under the existing state of emergency. Those conversations are ongoing, and updates will be provided in the coming weeks. If the Governor requests a federal disaster be declared in response to February's storms, federal assistance and funding could become available as part of the City's response and recovery, including stabilizing the landslide.

City staff continues to work toward completion of the long-term Portuguese Bend Landslide Remediation Project's Final Environmental Impact Report (EIR), which is expected to go before the City Council this spring. Staff will provide an update on the Final EIR at the next regular City Council meeting on March 19, when the City's local emergency declaration will be considered for extension. Stay tuned for meeting information.

Los Angeles County February 2024 Winter Storm Recovery – Homeowner Damage Cost Estimates

On February 4, 2024, the County of Los Angeles proclaimed a local emergency due to the early February 2024 Winter Storm. This powerful, slow moving atmospheric river storm system struck a large portion of the State of California including Los Angeles County. Impacts are expected to be seen for the next several days, even weeks. The County is in the process of assessing damage to infrastructure and private properties countywide, as well as supporting residents with their individual recovery efforts.

Homeowners who experienced damage as a result of the recent winter storms, the Damage Collection Survey link below will assist the County of Los Angeles in collecting damage information and estimated costs that are a direct result of the February 2024 Winter Storm. This information will be used to determine if the estimated dollar amount of disaster damages within Los Angeles County meets the established thresholds to qualify for various disaster assistance programs. Completion of this survey does not guarantee a disaster declaration will be received and it does not guarantee the County or its residents will be eligible to receive disaster assistance. This document is intended for information gathering purposes and will be used to determine eligibility based on the total amount of damages countywide. 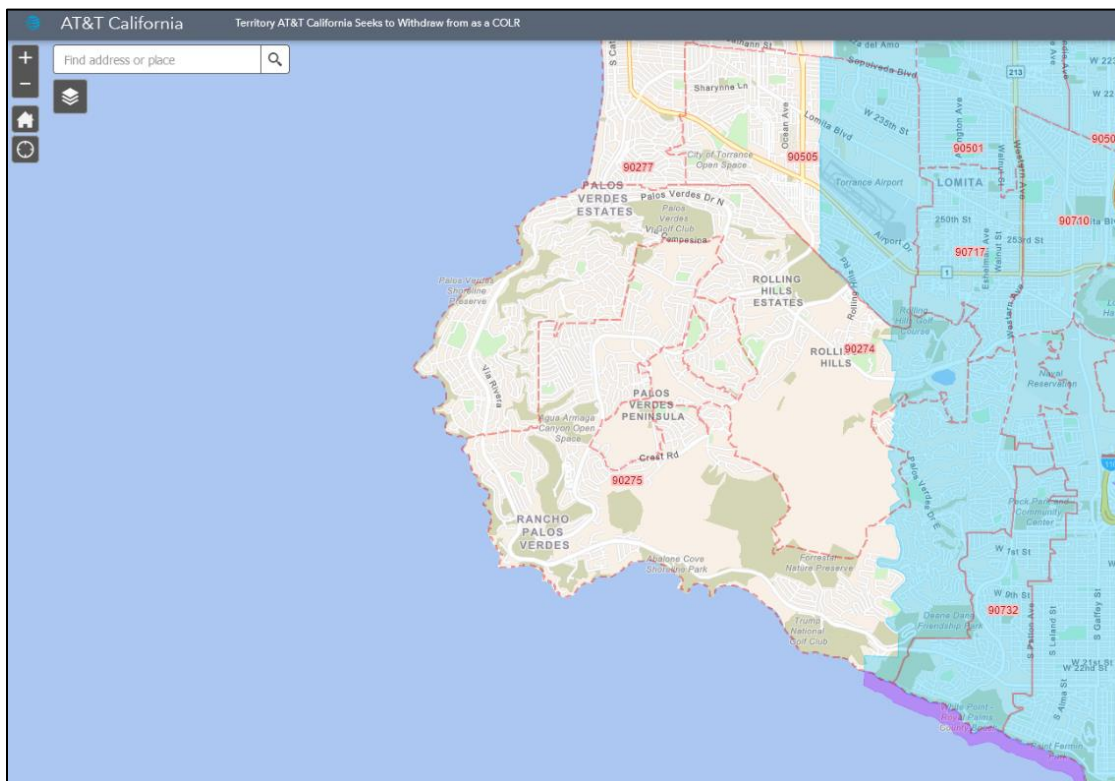
AT&T's Application for Landline Relief

The City of Rancho Palos Verdes has been closely monitoring the proceedings of the California Public Utilities Commission (CPUC) in response to an application submitted by the telecommunications company AT&T seeking relief from Carrier of Last Resort (COLR) obligations on landlines.

Attached to this report is an AT&T fact sheet detailing its plans for modernizing its networks in California, along with information on how to participate in one of the upcoming public hearings. These hearings are scheduled for March and can be accessed either in person or virtually.

Details are as follows:

- In-person hearing: March 13 at the Indio City Hall Council Chambers, located at 100 Civic Center Mall, Indio, CA 92201, at 2 p.m. and 6 p.m.
- Virtual hearings: March 19 at 2 p.m. and 6 p.m. ([info available](#) on the CPUC website)



AT&T has provided a map highlighting the service areas in Rancho Palos Verdes that may be affected by its COLR application, marked in blue. Only AT&T landline customers serviced by traditional copper lines in these areas may be impacted.

AT&T has also offered tips and assurances for affected customers:

- If customers do not have alternatives, AT&T will continue to provide copper-based traditional landline services.
- Residents in AT&T's service territory can choose from several comparable or lower-priced wireline and wireless alternatives for voice services. These alternatives include digital home phones (VoIP), fixed wireless, and mobile wireless services. Providers such as Comcast, Charter, Cox, T-Mobile, and Verizon Wireless may offer alternatives to AT&T's services.

attend a Brush Clearance Referee Hearing hosted by the Los Angeles County Fire Department scheduled on the following date and location:

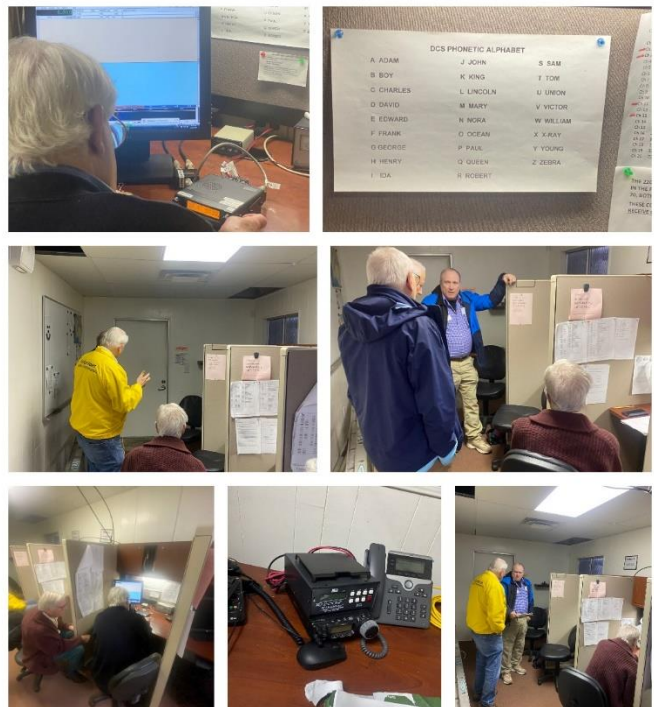

You may be aware that Assembly Bill No. 3074 introduced “Zone 0” as a 5-foot ember-resistant zone. When officially adopted by the State Fire Marshal, this law will require a 5-foot ember resistant zone around all structures in a Fire Hazard Severity Zone. Please note that this requirement is currently not in effect. Enforcement will occur when the State Fire Marshal approves vegetation clearance requirements, which is anticipated in 2025.

EPC Members and Palos Verdes Alert Network (PVAN) – Emergency Communications

Recently, the City's Emergency Preparedness Committee (EPC) and members of the Palos Verdes Alert Network (PVAN) convened to discuss the strategic role of amateur radio in emergency communications. During this meeting, EPC members had the opportunity to tour the City's Emergency Communications Center (ECC) trailer, where they observed ham radio net control operations firsthand. The meeting focused on bolstering cooperation among crucial stakeholders and how best to use amateur radio to improve the emergency communication system, ensuring a more robust response in times of disasters.



PVAN is a dedicated group of volunteers who step up with emergency communications at the neighborhood level when conventional channels like phones and electricity

faulter during major incidents. Leveraging their personal two-way ham radios, PVAN volunteers bridge the communication gap by transmitting essential information to the City's Emergency Communications Center. This data is then forwarded to the City's Emergency Operations Center (EOC). After a disaster, volunteer amateur radio operators with PVAN check on their homes and families before conducting a neighborhood-wide survey to gather vital information. The local PVAN amateur radio operator will then relay the neighborhood's status and other vital information necessary to the City's EOC or other local PVAN operators.

PVAN members participate in a weekly radio net or check-ins with the City's ECC every Monday night. In addition, periodic training exercises are conducted to familiarize all personnel with the most recent radio operating procedures and policies.

Interested in supporting your community during emergencies and deepening your knowledge about ham radio communications?

Consider joining the Peninsula Volunteer Alert Network (PVAN).

To become a volunteer amateur radio operator for PVAN, you must be at least 18 years old, possess a valid amateur radio license, have access to an appropriate amateur radio transceiver, and complete a two-hour training seminar conducted by the Palos Verdes Amateur Radio Club. Don't Let Earthquakes Catch You Off Guard – Download the Free MyShake App Now

With recent earthquakes in our region, it's a good reminder to download the free "MyShake" app. The MyShake app sends a warning to cell phone users that shaking is about to occur. The system uses ground-motion sensors to detect earthquakes that have already started and estimates their size,

location, and impact. When it detects a significant magnitude quake of 4.5 or more, the system issues a ShakeAlert message, providing a warning so people can take cover.

Emergency Preparedness Planning for an Evacuation

The Los Angeles County Fire Department has provided the following invaluable guidance for residents on preparing for potential emergency evacuations. Here's what you need to know:

PRE-PLANNING:

- ☐ Organize critical documents for emergency evacuation.
- ☐ Organize original documents in a special binder.
- ☐ Scan documents, into a password protected encrypted flash drive.

CRITICAL DOCUMENTS TO INCLUDE IN YOUR EMERGENCY BINDER:

- ☐ **PERSONAL DOCUMENTATION** - Degrees, professional licenses, driver's license, marriage certificate, social security card, concealed carry permit, military documents, naturalization/immigration documents.
- ☐ **MEDICAL INFORMATION** - Advance Care Directives, immunization records, critical medical records, list of current medications and pharmacy, copies of both front and back insurance cards.
- ☐ **INSURANCE POLICIES** - Life, health, auto, and homeowners policies including contact information and policy numbers.
- ☐ **PROPERTY DOCUMENTS** - Property deeds, loan documents, automobile titles.
- ☐ **LEGAL DOCUMENTS** - Contracts, adoption records, custody records, divorce papers, last will and testament, living trust, or family trust documents, power of attorney, rent or lease agreement, contact information for attorney.
- ☐ **FINANCIAL** - Savings bonds, stocks, and bonds, statements from investment firms, banking information, credit card numbers, (website, account information and passwords) retirement and pension.

- ☐ **CONTACT INFORMATION** - Written contact information for each member of your family, close relatives, and friends.
- ☐ **PET INFORMATION** - Pet license information along with vaccination records, and veterinary contact numbers.
- ☐ **RECENT PHOTOS** - Include a recent photo of each family member and pets. In the event you get separated from your loved one, a recent photo, may help locating him/her. They are also helping in identifying the deceased.
- ☐ **LIST OF FIREARMS** - Include a list of all firearms and be sure to include the serial numbers.
- ☐ **PASSWORD LIST** - You will need a list of all of your passwords to gain access to your online life. You need to decide exactly how you want to handle storing passwords to prevent passwords from being compromised.
- ☐ **FAMILY KEEPSAKES** - Make a digital copy of meaningful family photos (wedding photos, baby pictures, special events) and other family memories that would be impossible to replace. Store them in a good quality flash drive with your documents.
- ☐ **VIDEO INSURANCE INVENTORY** - Create a video inventory of all your possessions for insurance purposes. Do a video walkthrough of your home, garage, and entire property. Be sure to capture brand names and serial numbers. Describe possessions while you are making the recording. Include anything of value such as art, jewelry, collections, firearms, etc. Remember to document cupboards, closets, and drawers. If you are unable to prove what you have, the insurance company may not pay. Store this video on a labeled flash drive. Update it annually or when you purchase an expensive item.
- ☐ **EXTERNAL HARD DRIVE** - It is easy to store an amazing amount of information on one external hard drive. Make it a habit to make a special back up of your computer every 6 months.

- ☐ Check on neighbors who may need a ride.
- ☐ Follow recommended evacuation routes. Do not take shortcuts, they may be blocked.

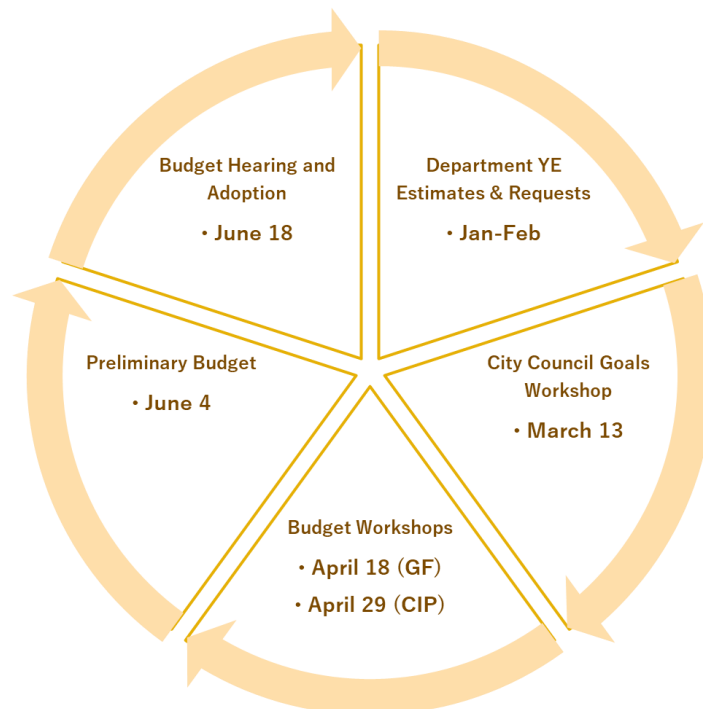

Fiscal Year 2024-25 Budget Process

The annual budget process for Fiscal Year 2024-25 is underway. Led by the Finance Department, the budgeting cycle spans several months and involves many people within the organization — from department-level staff, to elected officials. Each phase provides sufficient opportunities for collaboration and stakeholder participation to ensure that the resulting budget reflects priorities of the community. The approved budget will be structurally balanced and maintain financial sustainability for several years into the future to safeguard the City's valuable resources.



The FY 2024-25 Budget Calendar was approved by the City Council at the meeting on January 16. The image below illustrates each phase and the public meeting dates.

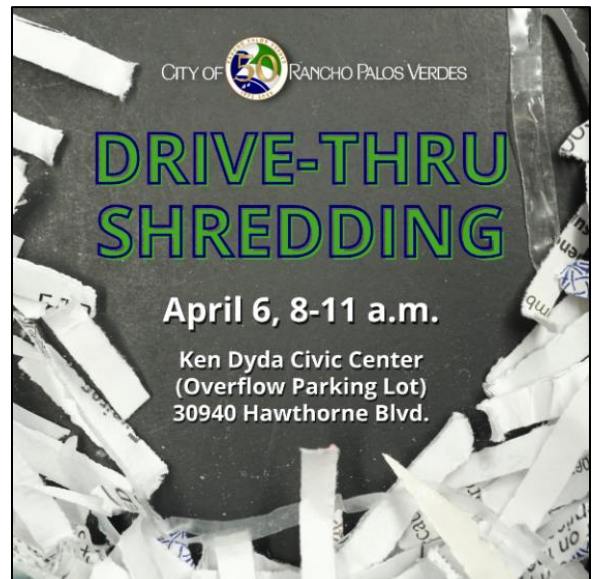

Prepare for the Citywide Brush Clearing

The spring season brush-clearing event begins on Saturday, April 6, and will continue for four consecutive Saturdays. Each week a different area of RPV is serviced. Public Right-of-Way/Roadway Repairs

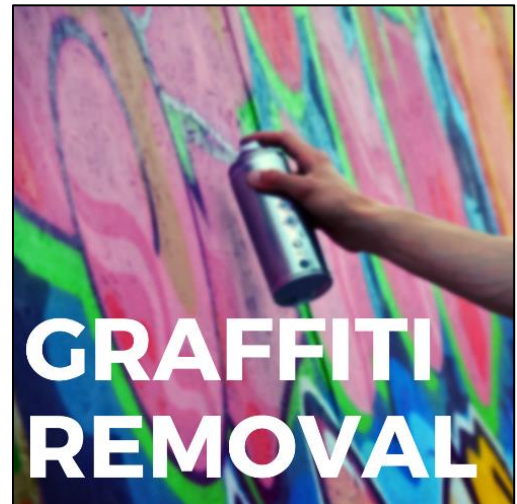
- In preparation for regular rain events, maintenance crews have been routinely performing the following:

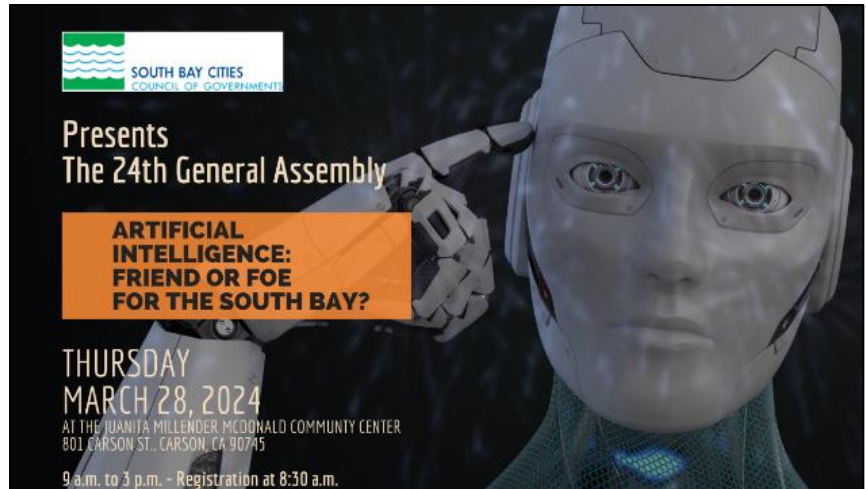

When Do I Need to Get a Building Permit?

As a public service reminder, building permits are required for all buildings or structures that are to be altered, repaired, enlarged, remodeled or converted, any change in the size of a room takes place and when any mechanical, electrical or plumbing work is involved. Some examples of projects requiring permits include, but are not limited to:

- Room additions
- Interior remodels
- Foundation Repair
- Roof Replacement
- Retaining walls

In some cases, certain improvements also require approval from the City's Planning Division prior to any permit issuance. Revised FEMA Civic Center Application Submitted

The City has submitted an application to the Federal Emergency Management Agency (FEMA) regarding consideration of a revised conceptual plan for the Rancho Palos Verdes Civic Center Campus Master Plan. Applications regarding the revised conceptual plans were previously sent in 2023 to FEMA and the Department of Justice (DOJ). FEMA and DOJ have had federal oversight of the public safety portion of the property, with administration by General Services Administration (GSA), since 2019 when oversight was shifted from the National Park Service. The 2023 applications were submitted to reflect changes to a previously submitted 2019 conceptual plan that included sheriff and fire stations, both significant public safety components that were removed in 2022 due to logistical and financial concerns.

The 2023 FEMA application focused on public safety/emergency components including the existing helopod and helipad and a proposed Emergency Operations Center (EOC), maintenance yard/emergency supply storage and emergency staging area, while the DOJ application focused on two law enforcement components: A sheriff drop-in office and offices/storage for Park Rangers. FEMA approved the 2023 application, but DOJ rejected it, stating that the law enforcement elements did not match its criteria. The revised application to FEMA added the sheriff drop-in office and Park Ranger offices as public safety/emergency components. The revised conceptual plan, which was approved by the Civic Center Advisory Committee and presented to the City Council last October, would increase the City's ability to respond quickly and effectively to a wide range of emergency situations including fires, earthquakes, and land movement. Staff will keep the City Council apprised of the status of this application.

Whale of a Day Planning Underway

It's been a whale of a while, but Whale of a Day is well on its way. The City of RPV and Los Serenos de Point Vicente are busy preparing for the 39th annual Whale of a Day, set for April 13, from 10 a.m. to 4 p.m.

The Point Vicente Lighthouse grounds will be open again for tours. The event will have plenty of fun for everyone including live music, children's activities, a silent auction, a raffle, beer and wine, food trucks and more.

California Network Modernization: FAQ

Will California customers lose service?

- No California AT&T customer will be left without service.
- We are simply seeking an approved process to help consumers transition from outdated services to modern services.

Does this mean that customers won't have a home landline?

- No. We are not cancelling landline service in California, and none of our California traditional copper-based customers will lose access to voice service.
- We are focused on enhancing our network with more advanced, higher speed technologies like fiber and wireless, which consumers are demanding.

Will California consumers have access to 911 services?

- No customers are being disconnected.
- Our customers will continue to have access to 911, and newer digital voice services have access to 911 and use technology that makes it quicker and easier for customers to reach first responders.

Will Californians access to affordable services?

- Today, Californians have access to mobile wireless and VoIP alternatives that are at least as affordable as copper-based landline service.
- AT&T also offers Access from AT&T, which provides low-cost internet service for eligible households with plans up to \$30/mo. and speeds up to 100Mbps where available.

How will California's rural residents be impacted?

- No AT&T California customer is being left behind.
- We're working to transition our remaining consumers who use traditional copper-based phone service to upgrade to newer technologies from us or other providers.
- We are focused on enhancing our network with more advanced, higher speed technologies like fiber and wireless, which consumers are demanding.

What about location accuracy of 911 calls for wireless and VoIP phones?

- Today, 911 operators can locate you nearly anywhere—from the side of a highway to inside your home—all thanks to decades of innovation in wireless location accuracy technologies.¹
- The Federal Communications Commission (FCC) requires that providers of interconnected VoIP telephone services using the Public Switched Telephone Network (PSTN) to meet Enhanced 911 (E911) obligations. E911 systems automatically provide emergency service personnel with a 911 caller's call-back number and, in most cases, location information.²

What are the benefits for California's seniors using wireless services?

- According to the Pew Research Center, 94% of seniors (65 and older) in America own a cellphone of some kind, and 76% of seniors own a smartphone (Pew Research) including 94% of those 65 and older.³
- The benefits to senior of using modern technology include for telehealth services, staying connected with loved ones, keeping mentally fit, having access to emergency alerts and the ability to track and manage health conditions.
- It's imperative that California's seniors have access to and continue to adopt high-speed internet and newer technologies, to increase access to much needed services, connect with loved ones and to improve quality of life.

What will happen to residents in areas where cell service may not be as strong?

- Our analysis based on data from the CPUC and FCC showed that 99.7 percent of consumers within our service territory have at least three viable alternative options for voice service.
- These include services other than wireless, such as VoIP services provided by cable companies.
- For customers who do not have alternatives available, we will continue to provide service until such time as an alternative is available.

What about backup power for VoIP phones. What is the cost? How long does the backup battery power last?

- AT&T offers a 24-hour battery backup option for AT&T Digital Phone (VoIP). Customers can also buy a backup option that lasts for less time.⁴
- For VoIP phones, consumers can buy reliable external backup power systems online, at local electronics stores, or directly from the phone providers from anywhere from 8 to 48 hours. Costs vary for backup batteries for VoIP, but options can be found for around \$40.

Are prices for broadband and phone service increasing faster than inflation?

- The current price of AT&T residential copper-based landline service in California is \$37.50 per month. There are both bundled and non-bundled VoIP and wireless alternatives costing a similar amount or less than the current \$37.50 per month price.
- Mobile wireless providers offer prepaid and postpaid wireless plans at price points below or comparable to those for AT&T's copper-based service. Managed VoIP services that broadband providers offer over their cable, fiber and fixed wireless networks are generally less expensive than copper-based landline voice services.
- According to a 2023 study, prices for broadband experienced a 18% drop year-over-year in the price of providers' most popular broadband speed tier and a 6.5% drop year-over-year in the price of providers' fastest speed tier.⁵

Is Access from AT&T available for new and existing customers?

- Yes. AT&T has no plans to discontinue Access from AT&T program.
- We continue to offer the Access program, which provides low-cost internet service for eligible households with plans up to \$30/month and speeds up to 100Mbps where available. To learn more, visit <https://att.com/access>.

What are the eligibility criteria for Access from AT&T?

- The following programs will continue to be used to determine eligibility for Access from AT&T: Supplemental Nutrition Assistance Program (SNAP), and Supplemental Security Income (SSI) for California residents, National School Lunch, or with a household income below 200% of federal poverty guidelines.
- New Access from AT&T customers can go through an application process where they submit documentation for review.

Why is AT&T exiting programs such as Lifeline that provide service to low-income customers?

- Californians can continue to choose from among a number of providers if they want to participate the federally supported Lifeline program.
- A CPUC report found that about 85% of Lifeline customers in California already obtain the Lifeline benefit for wireless services.⁶
- We also offer the Access program, which provides low-cost internet service for eligible households with plans up to \$30/month and speeds up to 100Mbps where available

What is a COLR?

- One of the applications that AT&T submitted, if approved, would remove AT&T's obligation under California law to provide traditional landline phone service in a large portion of our service territory in California – known as Carrier of Last Resort (COLR).
- AT&T's COLR obligation means that we must provide traditional landline phone service to any potential customer in our service territory.
- However, the COLR obligation no longer makes sense given that almost everyone in our service territory can choose among several comparable or lower-priced wireline and wireless alternatives to traditional telephone landlines for voice service.

Why did AT&T file for COLR relief in California?

- We've seen a precipitous decline in demand for telephone services provided over our copper networks.
- This application seeks targeted COLR relief for areas in our California service territory where facilities-based alternative options for voice service already exist.
- Our commitment is that consumers currently in our California service territory will retain access to a service connection, whether from us or another service provider.

Doesn't California need a COLR provider?

- We believe that the COLR obligation is outdated and no longer necessary given that nearly everyone in our California service territory already has or can choose among several comparable or lower-priced wireline and wireless alternatives to copper-based landlines for voice service.

Why doesn't AT&T just maintain the copper-based network?

- Our copper network is incapable of meeting these modern, data demands, and as such, it is now vastly underutilized.
- We cannot continue to support two networks, and the time has come for us to switch to a modern network.

What happens to households who do not have access to alternative services?

- Our commitment is that customers currently in our California service territory will retain access to a service connection, whether from us or another service provider.
- For customers who do not have alternatives available, we will continue to provide service until such a time as an alternative phone service or provider is available.
- We are participating in eight in-person and virtual public forums for stakeholders and customers to provide input into our proposal.

Is AT&T just profiting off discontinuing landline?

- We are not cancelling landline service in California, and none of our California customers will lose access to voice service if the CPUC approves our application.
- We spend more than a billion dollars a year in California maintaining our legacy network and set of services that are used by a small and rapidly declining number of customers. Those dollars would be better spent on more advanced, higher speed technologies like fiber and wireless, which consumers are increasingly demanding over outdated copper-based services.
- In California, we invested nearly \$8.6 billion in our wireless and wireline network infrastructure from 2020-2022.

Would we sell portions of business to another service provider?

- None of our traditional copper-based landline customers in California will be left without service.
- We are simply seeking an approved process to help consumers transition from an antiquated copper network to modern services. Our goal is for customers currently in our California service territory to retain access to a service connection, whether from us or another provider.
- We are focused on investing in services that will meet our rural customers' needs today and in the future. Resources we spend on maintaining an antiquated copper network are resources we can't invest in our networks to help close the digital divide.

CPUC Public Participation Hearings

Background

In March 2023, AT&T submitted two applications to the California Public Utilities Commission (CPUC) to start the process for an orderly transition to IP-enabled wireless and fiber networks.

One of AT&T's CPUC applications, if approved, would remove AT&T's obligation under California law to provide traditional phone service in a large portion of our service territory in California – known as Carrier of Last Resort (COLR). AT&T's COLR obligation means that we must provide traditional landline phone service to any potential customer in our service territory. However, the COLR obligation no longer makes sense given that almost everyone in AT&T California's service territory can choose among several comparable or lower-priced wireline and wireless alternatives to traditional telephone landlines for voice service.

Why this is Important

AT&T believes that it's imperative all California consumers have access to modern communications services and technologies, and our ongoing, significant investments complemented by those of other providers are establishing a modern communications infrastructure across the state. By transitioning away from the underutilized landline telephone network, we can invest more resources in high-speed fiber-based infrastructure to expand broadband access and adoption.

If the CPUC approves AT&T's applications as proposed:

- AT&T would continue providing traditional landline phone service to existing customers until all federal and state regulatory processes are completed. AT&T has also committed to providing service to existing traditional landline phone customers for at least six months after the CPUC approves the application for COLR relief.
- AT&T would still be required to provide telephone service in areas where no alternative voice services are yet available and continue to provide traditional landline phone service to our customers until proven alternatives become available.

Upcoming Public Participation Process

As part of the process, the CPUC is hosting in-person and virtual public forums to receive public comments, concerns and opinions regarding AT&T's filings. During the hearings, stakeholders can provide public comments and speak with a CPUC Administrative Law Judge regarding this proceeding. By participating and sharing your perspective, you can assist the CPUC in making a well-informed decision.
