March 19, 2024 City Council Meeting Highlights

Highlights from the March 19 City Council meeting:

- The Council approved moving forward with emergency measures to slow accelerated movement in the Portuguese Bend landslide complex, including installing two dewatering wells to remove water that is trapped underground and contributing to sliding. Due to the urgency of the situation, this \$8 million work will proceed ahead of the rest of the larger Portuguese Bend



Landslide Remediation Project, which remains in the environmental review stage.

- Critical regrading work is being planned for Palos Verdes Drive South, which may require a temporary closure in the landslide area. The City will share details on the construction timeline at the April 2 City Council meeting.
- The Council voted to explore ways the City can provide assistance to two independent geological hazard abatement districts (GHADs) in RPV for their landslide mitigation projects, such as no-interest loans, grants, and/or in-kind services.
- The local emergency declaration that was put in place in October 2023 to bolster the City's response to the land movement was extended through May 18.
- Staff will also coordinate an upcoming town hall meeting regarding the City's and GHADs' plans to slow the landslide movement.
- The Council approved making several changes to the ParkMobile parking system near Del Cerro Park that will be rolled out in the coming months:
 - Eight parking spaces directly adjacent to the park on Park Place will be converted to general public parking requiring ParkMobile reservations.
 - Six spaces on Park Place will be reserved for Park Place Homeowners Association visitors, City staff and contractors, and Palos Verdes Peninsula Land Conservancy volunteers.
 - Two spaces on Park Place will remain designated as ADA spaces.
- Zone C, which is the closest ParkMobile zone to Del Cerro Park on Crenshaw Boulevard, will be converted to Residential Recreational Parking Permit parking.
- Staff will also install a sign at the park acknowledging the transfer of the land, a former Nike missile radar station, to the City by the federal government in 1976.
- Finally, the Council authorized the Mayor to submit an opposition letter to the California Public Utilities Commission on AT&T's plans to discontinue its landslide service in California, citing concerns about the reliability of cellphone service on the Peninsula, especially during an emergency, as well as the region's significant senior population.

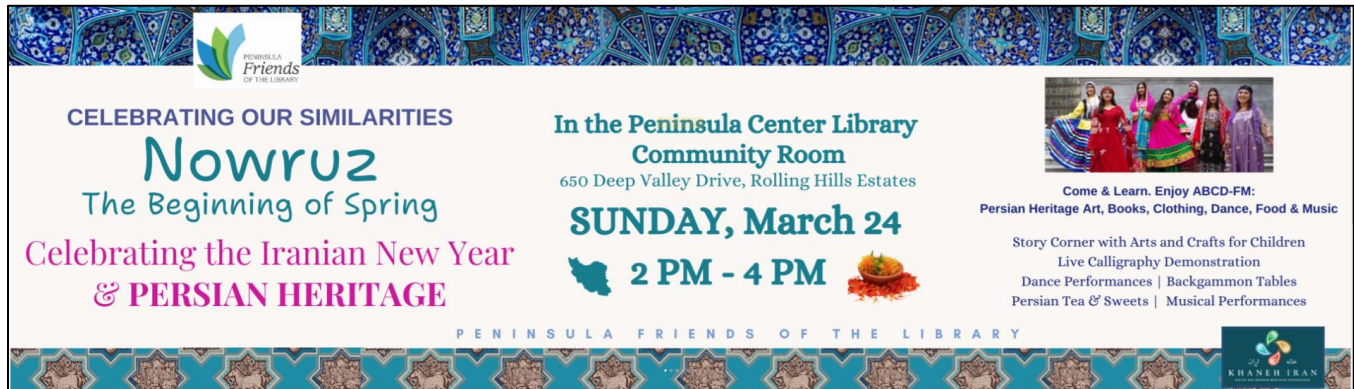

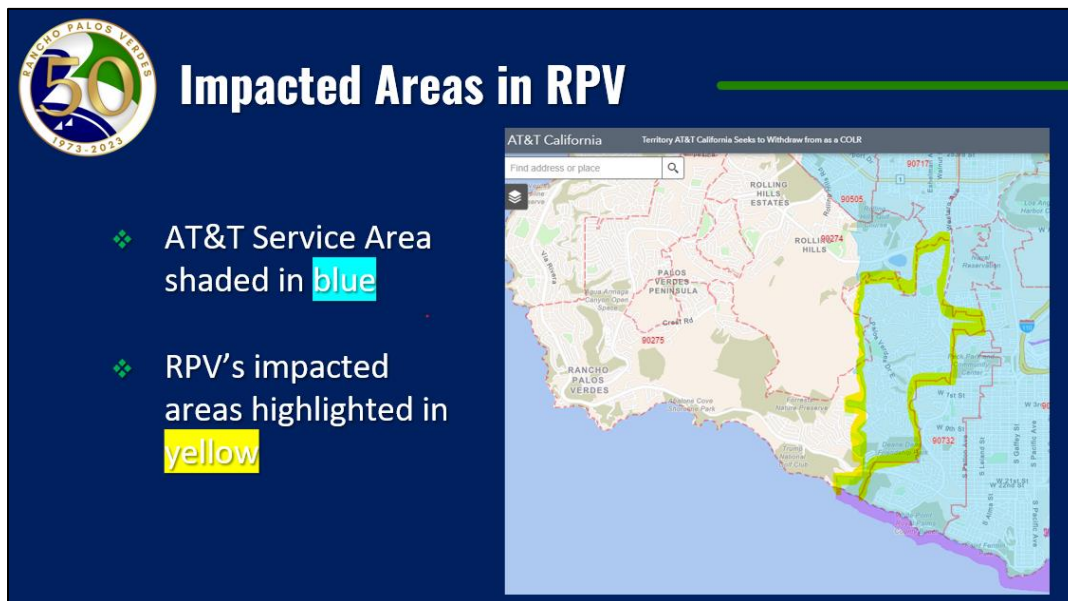

AT&T Application for Landline Relief

At last night's meeting, the City Council authorized Mayor Cruikshank to sign a letter of opposition in response to AT&T's application to the California Public Utilities Commission (CPUC) to be relieved of its Carrier of Last Resort (COLR) obligations in parts of California and to remove its designation as an Eligible Telecommunications Carrier (ETC), including the east side of Rancho Palos Verdes.



The CPUC held a series of public hearings to get input from impacted individuals. Staff attended a virtual meeting held March 19, where over 250 individuals provided

comments on AT&T's application. The predominant concern voiced by callers was reliable access to communication in the event of an emergency. Given that there are areas where wireless coverage is intermittent, landlines are a lifeline to many residents in RPV. 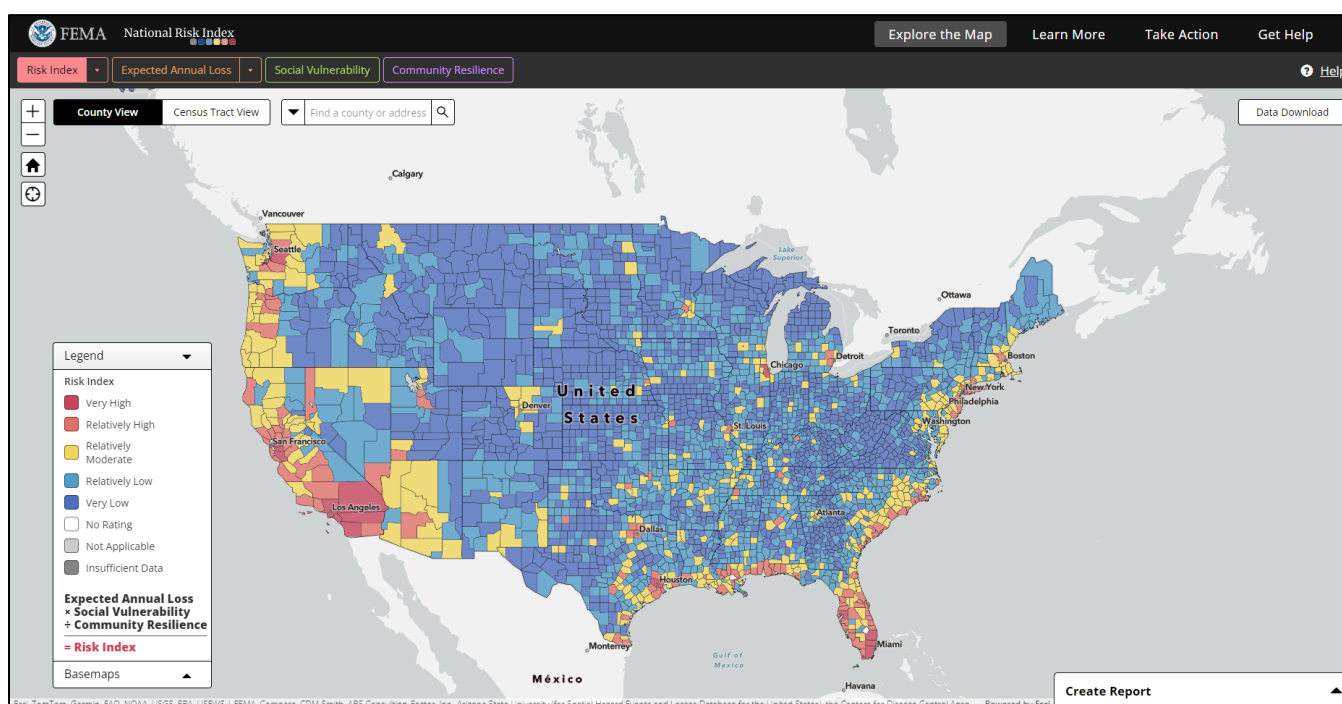
Legislation Corner

At last night's meeting, the City Council extended the City's contract for lobbying services with Rene Public Policy Group (RPPG) into its third year. In addition to approving extending the agreement, City Council members directed Staff initiate a request for proposals (RFP) process to onboard a federal lobbying firm. This firm would be tasked with representing the City's interests, aiding in securing funding, and advocating for our priorities at the federal level including the Portuguese Bend Landslide Complex.

FEMA's National Risk Index Supports Community Hazard Mitigation Planning



The Federal Emergency Management Agency (FEMA) has developed the [National Risk Index](#), an online mapping application that provides a comprehensive view of a community's risk from 18 natural hazards. The tool visualizes data on expected annual losses, social vulnerability, and community resilience, enabling communities to identify areas most at risk.

The National Risk Index is designed for planners, emergency managers, and other decision-makers at local, regional, state, and federal levels. It is also publicly accessible for any interested members of the general public seeking to better understand their community's natural hazard risk.

One key aspect of the National Risk Index is its ability to support communities in the hazard mitigation planning process. By illustrating which hazards pose risks and the

community's current level of resilience, the tool aids in the initial stages of planning and serves as a valuable resource for community outreach. While the Risk Index does not generate a complete risk assessment, it provides high-quality, comprehensive data that can help meet specific hazard mitigation planning requirements.

The Risk Index leverages best available nationwide datasets, which may not be as precise as local data in some cases. Communities with access to more accurate local data for any risk factor should consider using that data for a more refined risk assessment. It's also important to note that the Risk Index has some limitations and does not account for factors such as climate change impacts, dependencies between hazard types, manmade hazards, or impacts to critical infrastructure and transportation.

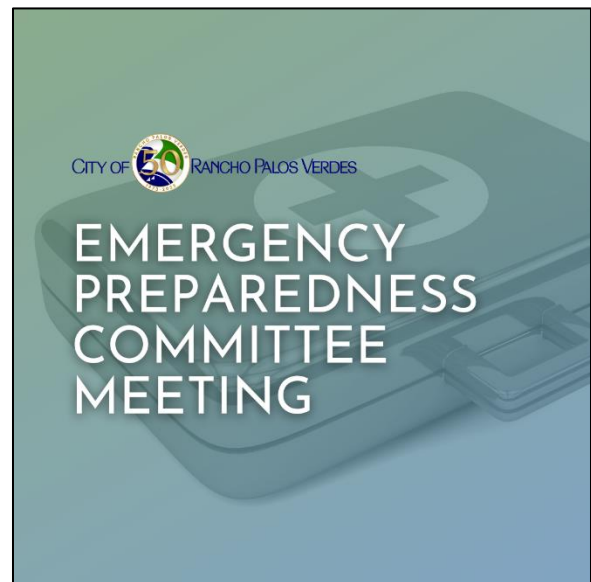
Despite these limitations, the National Risk Index remains a valuable tool for understanding and reducing community risk. It can inform risk-based decision making and increase risk awareness, serving as one important input alongside other information and analyses like benefit-cost studies and local knowledge.

Making a Family Emergency Plan is a good place to start when preparing for an emergency. Because your family may not be together when a disaster strikes, it is critical to plan communication strategies with your friends and family before, during, and after a disaster. Your plan should include every member of your household, including pets, and should take into account the specific needs of your household. Fill out a [family emergency plan](#) or use it as a guide to create your own plan today.

Create a plan by discussing the following questions with your family, friends, or household to kick-start your emergency preparedness:

- What is my shelter plan?
- What is my evacuation route?
- What is my family/household communication plan?
- Do I need to update my emergency preparedness Disaster Supply Kit?

Everyone who obtains their first ham radio license through a PVARC VE test session, regardless of age, will receive a free membership in the Palos Verdes Amateur Radio Club for the remainder of the current calendar year.

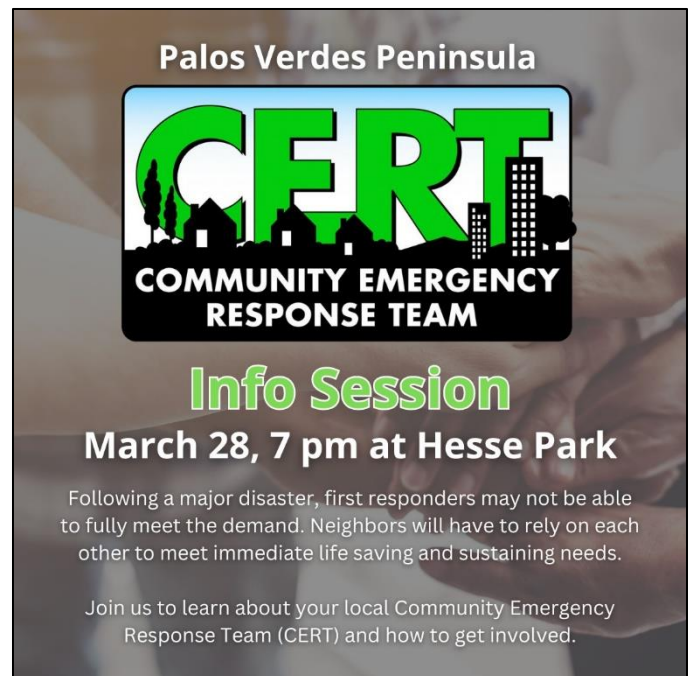

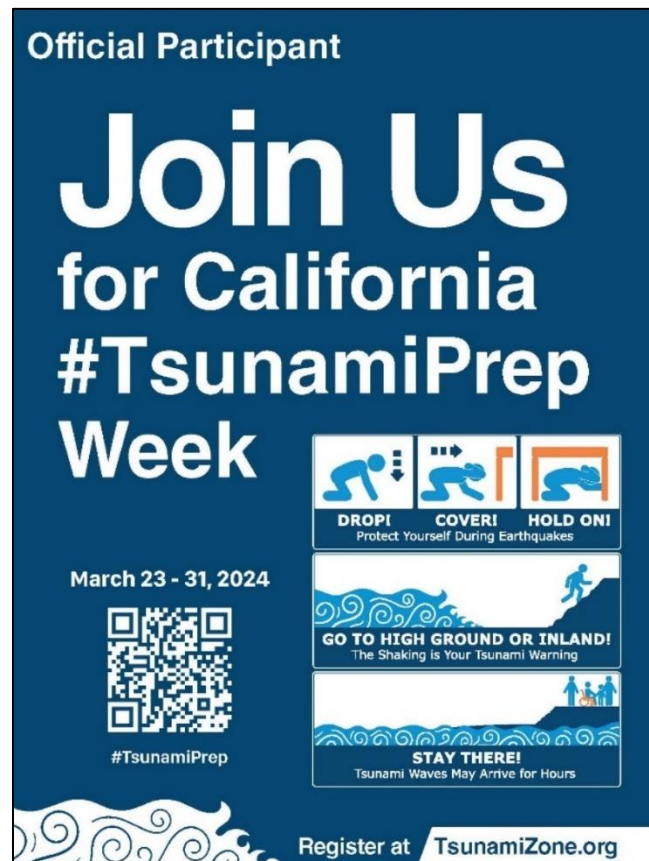

California Tsunami Preparedness Week

March 23-31 is 2024 California Tsunami Preparedness Week. The City encourages beachgoers, visitors, and residents who live near the City's coastline to practice tsunami awareness by accessing life-saving preparedness information to support California's Tsunami Preparedness Week — a statewide campaign.

Everyone who lives, works, or plays near the coastline should know how to protect themselves from a tsunami. Tsunamis are large ocean waves generated by major local or distant earthquakes or major landslides in the ocean. Ocean waves, ranging from several feet or much larger, can strike the coast with devastating force. Tsunamis can occur here in Southern California and impact the Peninsula and surrounding cities.



Tsunami Hazard Area maps available on the [state's tsunami website](#) illustrate how a tsunami could impact our coastline using new data and modeling developed over the past ten years, using lessons learned from the 2011 Tōhoku region event coupled with new tsunami hazard information and mapping tools. Easy-to-use [interactive web applications](#) now reflect that some areas of our coastline may have a higher tsunami hazard than previously represented in prior hazard maps.

Tsunamis can be catastrophic in the short and long term, affecting millions of people over wide geographical areas up to thousands of miles away from the source. Any member of the public can take these immediate preparedness steps to keep themselves, their families, and loved ones safe in the event of a tsunami:

- Take a “tsunami walk” with your family, friends, and loved ones; [get to know your zone](#) and be alert when at work, home or playing near the ocean.

- Create a personal tsunami evacuation plan. For more information on individual tsunami hazards and preparations, review the [California Tsunami Preparedness Guide](#), which explains how you can be tsunami ready.
- Next time you visit a local beach area for fun, work, or exercise, be on the lookout for local tsunami preparedness signage and identify a safe evacuation area and evacuation routes to get to higher ground quickly.
- Network with your neighbors prior to an emergency. Work together to help horse/large pet owners on your street who do not have horse trailers or who are not home during an emergency.

How to Properly Use a Fire Extinguisher

Fire extinguishers are a necessary safety item that should be in every home and business. Most fires start small. If the fire is contained to a single object, such as a trash can, you may want to try using a fire extinguisher to put out the flames.

Remember, you only have seconds — a small flame can quickly turn into a major fire in less than 30



seconds and in just two minutes, a fire can become life-threatening.

Using a fire extinguisher can be intimidating if you have never used one before. Most of us have extinguishers in our homes and at our workplaces but may not know how to actually use one. It's important to make sure you know how and when to use a fire extinguisher and have the right type on hand to put out common household fires.

The following information is designed to help you determine when to use a fire extinguisher, the proper use and what type you need.

Types of Fire Extinguisher Classes

Not all fire extinguishers are the same, they are classified according to the type of fire that is burning. If you use the wrong type of fire extinguisher on the wrong class of fire, you can, in fact, make matters worse. It is therefore important to understand the different classifications of fire extinguishers.

All fire extinguishers are labeled to indicate which classes of fire they are designed to combat. There are four classes of fire extinguishers – A, B, C and D – and each class can put out a different type of fire.

- **Class A extinguishers** will put out fires in ordinary combustibles, such as wood and paper.
- **Class B extinguishers** are for use on flammable liquids like grease, gasoline, and oil.
- **Class C extinguishers** are suitable for use only on electrically energized fires.
- **Class D extinguishers** are designed for use on flammable metals.

Most household fire extinguishers are considered multipurpose and can be used on different types of fires and will be labeled with more than one class, like A-B, B-C or A-B-C.

How to Use a Fire Extinguisher

There is a simple acronym to remember to operate most fire extinguishers: **PASS**. PASS stands for Pull, Aim, Squeeze and Sweep.



- **Pull** - Pull the pin at the top of the extinguisher. This unlocks the extinguisher and allows it to be discharged.
- **Aim** - Aim the extinguisher nozzle at the base of the fire.
- **Squeeze** - Squeeze the lever above the handle. This will discharge the extinguishing agent.
- **Sweep** - Sweep the extinguisher nozzle from side to side while aiming at the base of the fire.

When to Use a Fire Extinguisher

Fire extinguishers are meant to handle only small fires. Death or serious injury can occur by tackling a fire which is beyond your capabilities. Only tackle a fire in its very early stages and always ensure you put your own and other people's safety first. Before trying to control a fire with a portable extinguisher, you should know the general procedures for responding to a small, early-stage fire.

You should fight a fire with a fire extinguisher only when all the following are true:

- Everyone has left or is leaving the building.
- The fire department has been called.

- The fire is small and confined to the immediate areas where it started such as in a wastebasket, cushion, small appliance, stove, etc.
- You can fight the fire with your back to a safe escape route.
- Your extinguisher is rated for the type of fire you are fighting and is in good working order.
- You have had training in use of the extinguisher and are confident that you can operate it effectively.

If you cannot put out the fire or if the extinguisher becomes empty, evacuate yourself and everyone in the building immediately, closing all doors behind you as you go and ensure the fire department has been called.

Fire Extinguisher Best Practices

Because we don't have regular opportunities to practice fighting fires, it's easy to make simple mistakes when the time comes. The following is a list of best practices for storing, maintaining and using your fire extinguisher.

- **Ensure easy access in an emergency:** Be sure nothing is blocking or limiting your ability to reach it.
- **Read the instructions:** Thoroughly read the operating instructions that came with your fire extinguisher.
- **Don't let your extinguisher go bad:** Fire extinguishers come with an expiration date, after which the extinguishing agent is no longer effective. Know the dates on your fire extinguishers and replace them as needed.
- **Care and maintenance of your extinguisher:** Ensure there are no dents, leaks, rust, chemical deposits and other signs of abuse/wear. Wipe off any corrosive chemicals, oil, gunk etc. that may have landed on the extinguisher.
- **Know where the exits are at all times:** When you decide where to keep your fire extinguisher, make sure it is in an easily accessible location near exterior doors. Also, consider the most common places where fires occur in a home and place your extinguishers accordingly.

In partnership with Ring, residents now can rent a Ring Spotlight Camera along with select accessories for use at home, all at no cost* for up to 30 days.

Here is how you can participate:



- 1. Program requirements:** Before renting, residents are required to review and sign the Acknowledgment of Program Terms and Release of Liability, as well as complete the [Checkout Form](#).
- 2. Schedule pickup:** Email PublicSafety@rpvca.gov to schedule a convenient pick-up time at RPV City Hall. Please ensure you download the Ring app and set up your account prior to arriving at City Hall for a seamless experience.
- 3. Placement and return:** Cameras must be placed in the home and must be returned to City Hall within 30 days. If you need an extension, simply contact PublicSafety@rpvca.gov before the end of the 30-day period.

HdL Legislative Update 2024

The March update from HdL, the City's revenue consultant, explores the status of 2024 legislation concerning business licenses, lodging tax, property tax, sales and use tax, and utility users tax that are being closely monitored.

Overview

In January, California's financial outlook turned negative for fiscal year 2024-2025, prompting the Governor and Legislature to address a multibillion-dollar budget shortfall amid various legislative priorities. The deadline to introduce new legislation for 2024 was February 16, resulting in over 2,000 bills, many of which were placeholders. The information below provides status updates on key legislation, particularly regarding sales and use tax, property taxation, and tax/fee administration.

Legislation to Watch

The California Two-Thirds Legislative Vote and Voter Approval for Fee and Charge Increases Initiative

As amended, initiative No. 21-0042A1, limits the ability of voters and state and local governments to raise revenues for government services. New or increased taxes must be passed by a two-thirds legislative vote in each state chamber and approved by a simple majority of voters. Moreover, local taxes proposed by local government or citizens would require a two-thirds vote of the local electorate. Any tax adopted after January 1, 2022, not complying with these rules would be void after 12 months, unless reenacted in compliance.

Status: Approved for the November 2024 statewide general election.

ACA 13 (Ward) Voting Thresholds

ACA 13 establishes voting thresholds for constitutional amendments and statewide initiatives. It ensures that an initiative measure with provisions to increase voter approval requirements would only pass if it garnered a proportion of votes equal to or greater than the highest requirement it imposes. Additionally, it allows local governing bodies to conduct advisory votes on governance issues.

Status: Approved for the November 2024 statewide general election.

ACA 1 (Aquiar-Curry) Exemption And Changes To Voter Approval Rate For Ad Valorem Tax Rate on Real Property

ACA 1 introduces changes to voter approval rates for ad valorem taxes on real property. It permits cities, counties, and special districts to levy such taxes to service bonded indebtedness incurred to fund public infrastructure and housing with a 55% voter approval, instead of the usual two-thirds requirement.

Status: Approved for the November 2024 statewide general election.

Business License Legislation

AB 2791 (Wilson) Additional Restrictions for Sidewalk Vendors

Existing law authorizes a local authority to prohibit sidewalk vendors in areas located within the immediate vicinity of a permitted certified farmers' market or swap meet. This bill also extends current law to authorize local authorities to restrict sidewalk vendors near annual fairs organized by a district or county.

Status: Referred to Committee on Local Government on March 4, 2024.

Property Tax Legislation

SB 1164 (Newman) New Construction Exclusion for Accessory Dwelling Units

This bill proposes an amendment to the California Constitution regarding ad valorem taxes on real property. It entails excluding accessory dwelling units from being classified as "newly constructed" or "new construction" until 15 years after completion or change in ownership. This change would necessitate property owner affidavits and require additional work from county assessors, thus imposing a state-mandated local program.

Status: Referred Committee on Revenue and Taxation on February 21, 2024.

Sales And Use Tax Legislation

Ab 2274 (Dixon) Back to School Sales and Use Tax Holiday

This bill proposes a sales tax exemption for tangible personal property purchased on the first weekend of August starting in 2025. While current law mandates reimbursement for revenue losses to local agencies due to tax exemptions, this bill suggests no reimbursement for losses incurred from this specific exemption.

Status: Amended and re-referred to Committee on Revenue and Taxation on March 4, 2024.

Sb 1494 (Glazer) Local Agency Sales and Use Tax Agreements With Retailers

This bill, effective January 1, 2024, prohibits local agencies from making agreements to give Bradley-Burns local tax revenues to retailers in exchange for their business location. Existing agreements before January 1, 2024, would become void by January 1, 2030. Agencies must post these agreements on their website until they expire or become void.

Status: Referred to Committees on Local Government and Revenue and Taxation on February 29, 2024.

Utility Users Tax Legislation

Ab 1826 (Holden) Digital Equity in Video Franchising Act of 2024

The bill renames the Digital Infrastructure and Video Competition Act of 2006 to the Digital Equity in Video Franchising Act of 2024. It mandates the Public Utilities Commission to hold a public hearing for each state franchise renewal application. The commission must issue or reject state franchise applications within 90 days after the hearing or once the application is complete. Franchise applicants must provide details on unserved households in the proposed service area, and the bill extends deadlines for the Commission's review of state franchise applications.

Status: Referred Committee on Communications and Conveyance on January 29, 2024.

- Sanded and repainted the railings at Hesse Park.

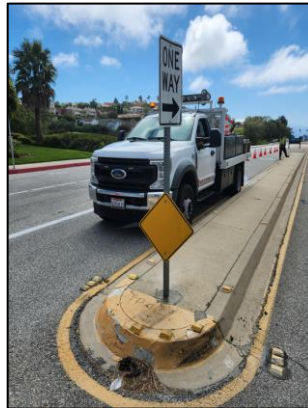

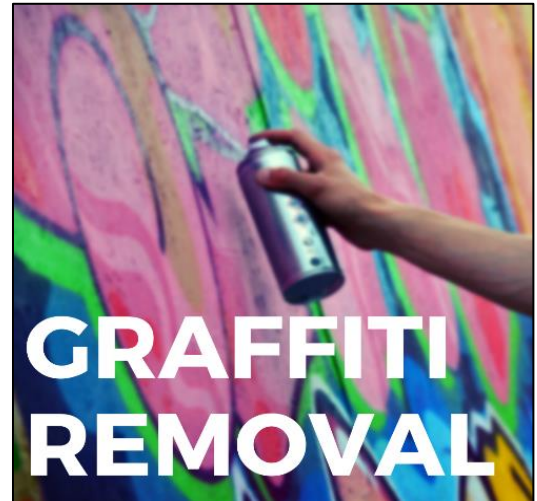
Public Right-of-Way/Roadway Repairs

- Placed sandbags at Basswood Avenue.



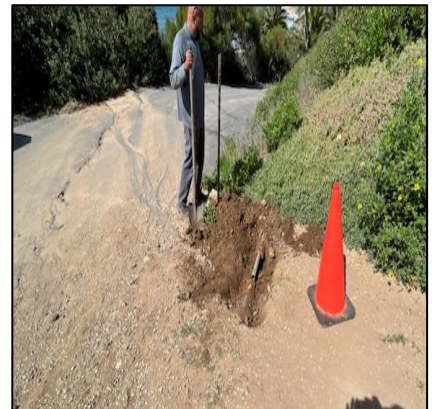
Graffiti Removal

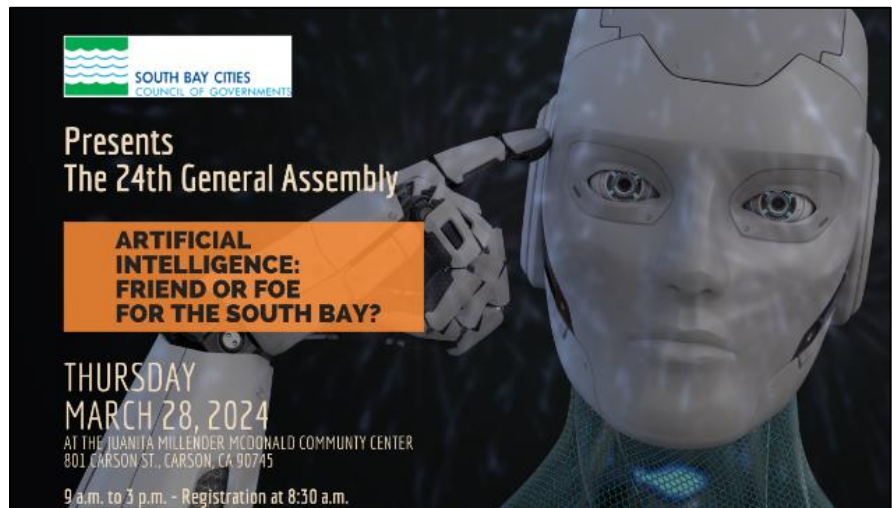
Reminder - Coastal Officer Hearing for Proposed Project on Packet Road

On March 25, the City of Rancho Palos Verdes' Coastal Hearings Officer will conduct a public hearing for a Site Plan Review with Neighborhood Compatibility Review and a Coastal Development Permit (Case No. PLSR2023-0237), for the property located at 25 Packet Road. The request is for the conversion of a 420-square-foot existing carport to a two-car enclosed garage on a 1,962-square-foot single-family residence for a new total structure size of 2,382 square feet (garage included). As the subject property is located within the Appealable Area of the City's Coastal Specific Plan District, the project requires consideration of a Coastal Development Permit by the City's Coastal Hearing's Officer (Director of Community Development). Wildlife Attractants and Deterrents

There is an abundance of spectacular native and urban wildlife throughout the Peninsula's rural and semi-rural neighborhoods, with hundreds of different species of life. The City of Rancho Palos Verdes is home to many of these wonderful creatures, from adorable bouncing bunnies and gorgeous peacocks, to finicky foxes and cunning coyotes. Although some urban wildlife is more favorable than others, the protection of urban wildlife and their habitats is especially important. Education and coexistence are the foundation of the City's general wildlife management programs. The City adopted

two wildlife programs: the [Coyote Management Plan](#), and the [Peafowl Management Plan](#).

Although the City of Rancho Palos Verdes places a high value on its wildlife, some species that have adapted to urban environments have the potential to cause health or safety issues for residents, such as venomous rattlesnakes and aggressive coyotes. In addressing these issues, residents as well as the City must implement preventative measures by reducing wildlife attractants.

What are wildlife attractants?

Wildlife attractants are three main elements: food, water, and/or shelter. Any combination will attract wildlife to frequent your property. Examples of these main elements include, but are not limited to, pools, ponds, fountains, birdbaths, and standing water sources, pet food/water dishes, bird feeders, trash and/or compost bins, fruit/vegetables gardens, BBQ grills, accessible crawl spaces, sheds, large piles of debris, and overgrown brush/shrubs. Other attractants include pet defecation, deceased wildlife, and scent marking from other animals. Although these attractants may not directly draw in coyotes directly, they will draw in wildlife that are typical prey to coyotes.

What if I do nothing to reduce attractants?

Coyotes are seen throughout the City of Rancho Palos Verdes and are considered scavengers and predators of small animals. Although they are not likely to knock over a few trashcans for scraps of food, or drink from your pools, ponds, or fountains, they are more inclined to attack the wildlife that does. Coyotes primarily hunt for small mammals such as rabbits and rodents but are also known for attacking small household pets and may even shift to larger prey at times. Coyotes are not finicky hunters; they have been known to eat fish from ponds, frogs, snakes, certain fruits, and grass from time to time. Reducing attractants will likely reduce wildlife from frequenting your yard and thus reduce coyote activity.

What can I do to reduce attractants?

Look around your yard for things that wildlife needs the most to survive, such as food, water, and/or shelter. If you have pets, clean up their waste daily and feed them indoors, if possible. When feeding pets outdoors, don't leave pet

treats, food, and water dishes out. Where there is access to food, water, and/or shelter, wildlife will keep returning to these resources. To minimize sheltering unwanted wildlife, keep your hedges and shrubs trimmed at least six inches off the ground. Make sure your crawl spaces and sheds are secured. Secure trash

and/or compost bins to prevent tipping over or lids from being removed. The odors from trash and/or compost bins and BBQ grills attract several species of wildlife. The image provided here is an example of securing your trashcan. However, there are several other methods, including homemade methods, you may use to secure your trash and/or compost bins. The REACH program serves the social and recreational needs of youths and adults with developmental disabilities and is back at Hesse Park for in-person activities.

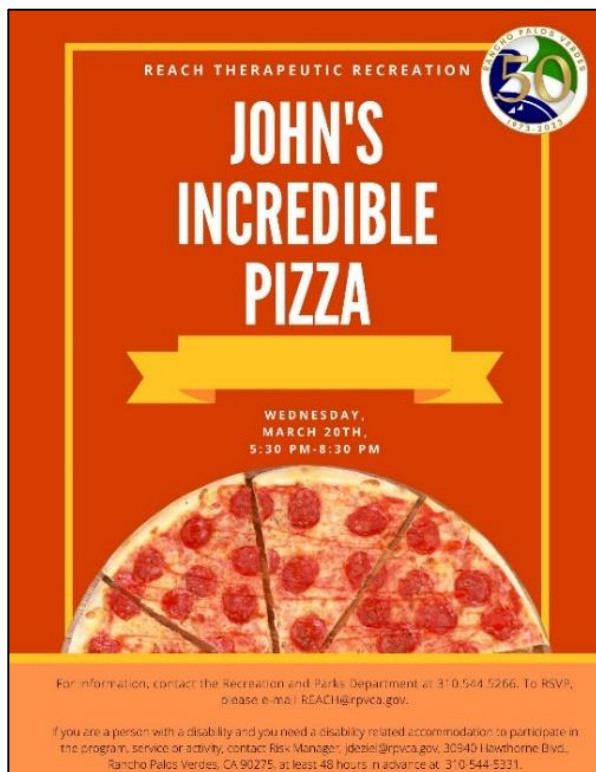

Abalone Cove

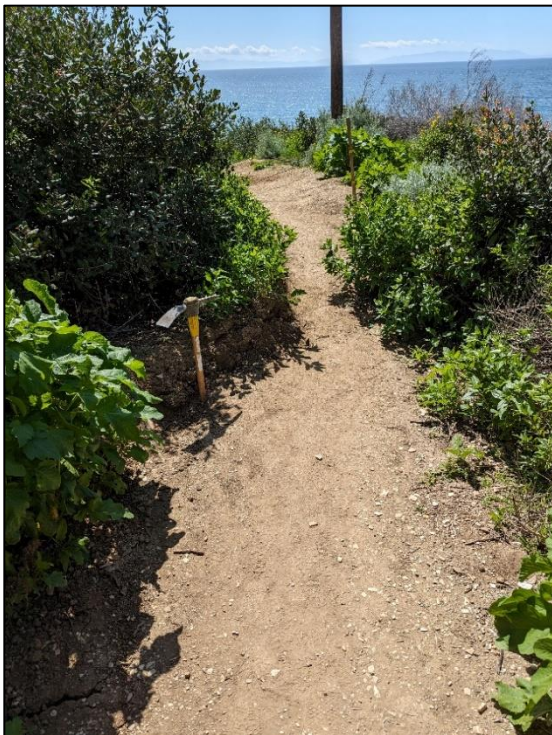
On March 12, Staff reported a water leak on Abalone Cove Trail to Public Works, which then made necessary repairs.

Ocean Trails Reserve

On March 17, Park Rangers were notified by Trump National Golf Club of an injured pinniped along Ocean Trails Reserve. The Marine Mammal Care Center was contacted and Trump National Golf Club staff assisted with access.

That same day, Rangers received a report of a transient camp on Shoreline Trail. Rangers contacted the individual and educated him on Reserve rules. He left the area shortly after.

On March 19, Rangers received a report of a beached seal pup on Rancho Palos Verdes Beach. The reporting individual indicated that the pup did not appear to be injured but was concerned that it may not be able to return to the ocean on its own. The Marine Mammal Care Center was contacted, and the individual thanked for their report, as well as informed to maintain distance.

That same day, Rangers received a report of an individual setting up a tent near East Boundary Trail. Park Rangers patrolled the area and were unable to identify a tent or possible encampment in the area.

Portuguese Bend Reserve

On March 17, Rangers were notified by the Los Angeles County Fire Department of a water leak along Burma Road Trail. It was later confirmed the leak was on Vanderlip Trail. Cal Water made repairs.



On March 19, Rangers inspected and reopened Portuguese Bend Reserve. The Reserve had been temporarily closed since March 11 due to a high-priority project to remove Southern California Edison distribution equipment from utility poles. Dear President Reynolds,

I am writing on behalf of the City of Rancho Palos Verdes to express our concerns regarding AT&T's application for relief from its Carrier of Last Resort (COLR) obligations in our community. We respectfully urge the California Public Utilities Commission (CPUC) to reject this application.

AT&T currently serves as the designated COLR in Rancho Palos Verdes, providing essential landline telephone services to our residents. Despite advancements in telecommunications technology, there are still many areas within our community with inadequate cellular coverage. Consequently, the discontinuation of AT&T's landline service could potentially leave our residents without access to critical emergency services such as 9-1-1 or 2-1-1, placing them in grave danger during emergencies especially as a designated Very High Fire Hazard Severity Zone.

Of particular concern are our elderly residents, who often rely on landline services due to their reliability and familiarity. These individuals may have limited options for accessing affordable telecommunications services that meet their specific needs. Therefore, it is imperative that any decision regarding COLR relief ensures the availability of alternative communication solutions that can adequately meet the basic needs of our community.

The City of Rancho Palos Verdes is committed to promoting equitable access to high-quality telecommunications services for all residents, especially those who are most vulnerable. We believe that access to reliable, secure, and open networks is essential for fostering community safety and well-being.
