Portuguese Bend Landslide Local Emergency Update

RPV Meets with County, State, and Federal Officials to Discuss Landslide Emergency Response

Earlier this week, Councilmember Dave Bradley, City Manager Ara Mihranian, and Public Works Director Ramzi Awwad had a collaborative and productive meeting with officials

from the county, state and federal levels of government regarding the City's response to the ongoing emergency in the Portuguese Bend Landslide complex.

The representatives included Rep. Ted Lieu, Senator Ben Allen, Assemblymember Al Muratsuchi, L.A. County Supervisor Janice Hahn, Nancy Ward, Director of the California Governor's Office of Emergency Services (Cal OES), Katie Lipiecki and Stephanie Stephens of the Federal Emergency Management Agency (FEMA), and Kevin McGowan, Director of the L.A. County Office of Emergency Management.

During the meeting, FEMA representatives reiterated their support for the City's landslide remediation efforts, including the selection of the Portuguese Bend Landslide Remediation Project for a \$23.3 million Building Resilient Infrastructure and Communities (BRIC) grant. They stated that the City can move forward with installing two emergency hydraugers in the landslide complex without jeopardizing grant eligibility, but that Staff must submit a revised project scope (including boundary limits that remove the two hydraugers) and an updated benefit-cost analysis. The BRIC grant will not fund the two emergency hydraugers and the City will have to find alternative funding sources.

Cal OES clarified that Governor Newsom's recent request to President Biden for a federal disaster in response to February's storms, if granted, could make federal assistance available to public agencies, but not individuals.

Senator Allen discussed his proposed legislation, Senate Bill No. 1461, which would add "landslide" as a condition constituting a state of emergency or local emergency in the Emergency Services Act. This may help bring financial assistance to the City. (The City Council will consider supporting the bill at next week's meeting on April 16. A [staff report \(PDF\)](#) with more information is available on the City website.)

The message was clear that all levels of government support efforts to assist the City and the geological hazard abatement district on the Portuguese Bend Landslide crisis. The City expresses its gratitude to these officials and agencies for their attention and support as we navigate this emergency.

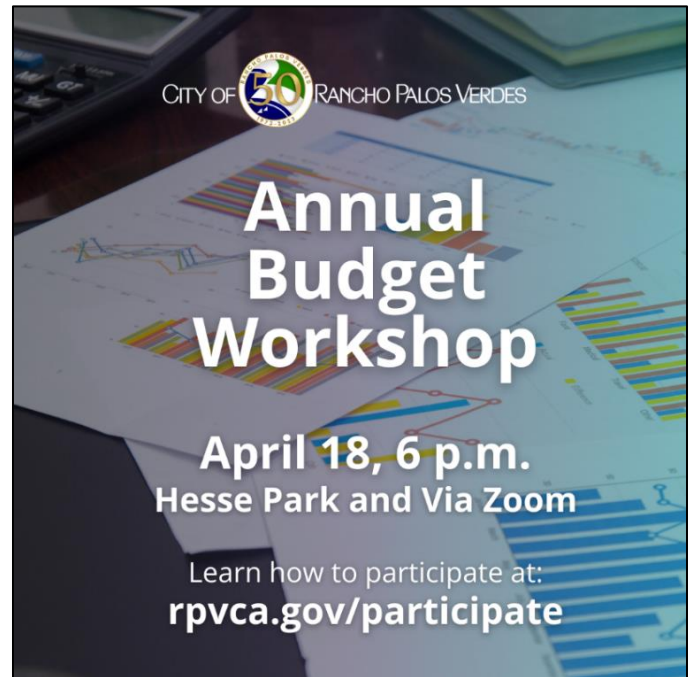

On April 18, the City Council will host its annual budget workshop for the General Fund (the City's chief operating fund).

The hybrid in-person/virtual meeting will take place at 6 p.m. in McTaggart Hall at Hesse Park and via Zoom. Please note that the meeting will not be livestreamed or televised, but a recording will be available at rpvca.gov/agendas.

City staff will present the Fiscal Year 2023-24 year-end estimate of revenues and expenditures, the assumptions used to prepare the FY 2024-25 proposed budget, and fund balance. The preliminary FY 2024-25 budget, all funds, and the 5-year Capital Improvement Plan will be presented at the June 4 City Council meeting. Legislation Corner

On April 16, the City Council will review two pieces of pending legislation, SB 1461 and AB 2560, and consider taking a support or opposition position.

[SB 1461 \(Allen\): State of Emergency and local emergency: Landslide](#)

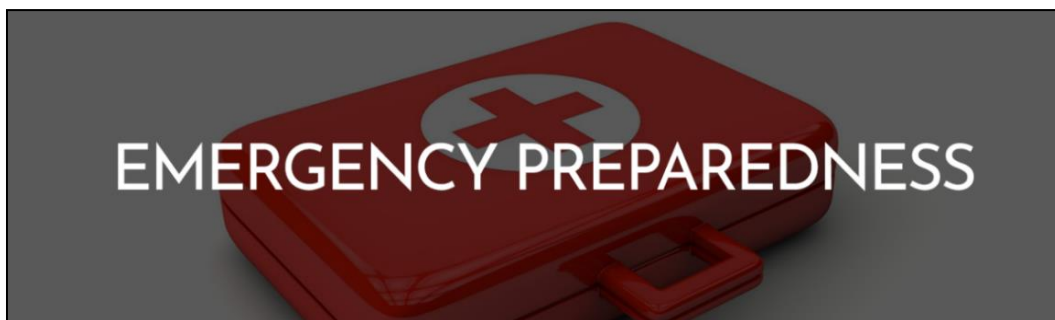
SB 1461, authored by Senator Allen, proposes amending the Emergency Services Act (ESA), which gives authority to the Governor to declare a local emergency in the case of extreme peril or threat to public safety of property and persons living within a designated area. SB 1461's proposed changes will expand the conditions under which the Governor can exercise this authority, specifically adding "landslide" as a condition constituting a state of emergency or local emergency.

[AB 2560 \(Alvarez\): Density Bonus Law: California Coastal Act of 1976](#)

AB 2560, introduced by Assemblymember Alvarez, aims to extend the Density Bonus Law (DBL) to the California Coastal Act of 1976 without limitations. This bill seeks to tackle the housing crisis in California's coastal areas by allowing DBL provisions to apply unrestricted within the Coastal Zone. If passed, AB 2560 would remove provisions that currently prevent DBL from superseding or altering the Coastal Act, thereby enabling density bonuses, concessions, incentives, and waivers of development standards within Coastal Act governed areas.

Proponents of the bill argue that it will promote equity and affordability in the Coastal Zone by incentivizing the construction of affordable housing. However, opponents express concerns that it could weaken environmental protections provided by the Coastal Act and potentially exacerbate issues like sea-level rise.

Join PVAN Today

Interested in supporting your community during emergencies and deepening your knowledge about ham radio communications? Consider joining the Peninsula Volunteer Alert Network (PVAN). PVAN is a dedicated group of volunteers who step up with emergency communications at the neighborhood level when conventional channels like phones and electricity falter during major incidents. Leveraging their personal two-way ham radios, PVAN volunteers bridge the communication gap by transmitting essential information to the City's Emergency Communications Center. This data is then forwarded to the City's Emergency Operations Center (EOC).

After a disaster, volunteer amateur radio operators with PVAN check on their homes and families before conducting a neighborhood-wide survey to gather vital information. The local PVAN amateur radio operator will then relay the neighborhood's status and other vital information necessary to the City's EOC or other local PVAN operators. PVAN members participate in a weekly radio net or check-ins with the City's ECC every Monday at 7 p.m. In addition, periodic training exercises are conducted to familiarize all personnel with the most recent radio operating procedures and policies.

To become a volunteer amateur radio operator for PVAN, you must be at least 18 years old, possess a valid amateur radio license, have access to an appropriate amateur radio transceiver, and complete a two-hour training seminar conducted by the Palos Verdes Amateur Radio Club. For courses sponsored by the Palos Verdes Amateur Radio Club, students thru grade 12 who pass their examination at a PVARC VE test session will, upon application to the Club, be eligible for reimbursement up to a maximum of \$85 to cover the cost of materials and the examination fee.

Everyone who obtains their first ham radio license through a PVARC VE test session, regardless of age, will receive a free membership in the Palos Verdes Amateur Radio Club for the remainder of the current calendar year.

Disaster can happen at any time, often with little to no warning. After an emergency, you may need to survive on your own for several days. Being prepared includes having food, water, and other supplies on hand to last for several days. Make a New Year's Resolution that matters: Resolve to become prepared for emergencies – this could save your life.

The RPV Emergency Preparedness Committee offers the following preparedness tips to help you and your family Kick-off 2022 the right way by preparing for all types of emergencies

MAKE A PLAN **BUILD A KIT** **BE INFORMED**

MAKE A PLAN:

Making a Family Emergency Plan is a good place to start when preparing for an emergency. Because your family may not be together when a disaster strikes, it is critical to plan communication strategies with your friends and family before, during, and after a disaster. Your plan should include every member of your household, including pets, and should take into account the specific needs of your household. 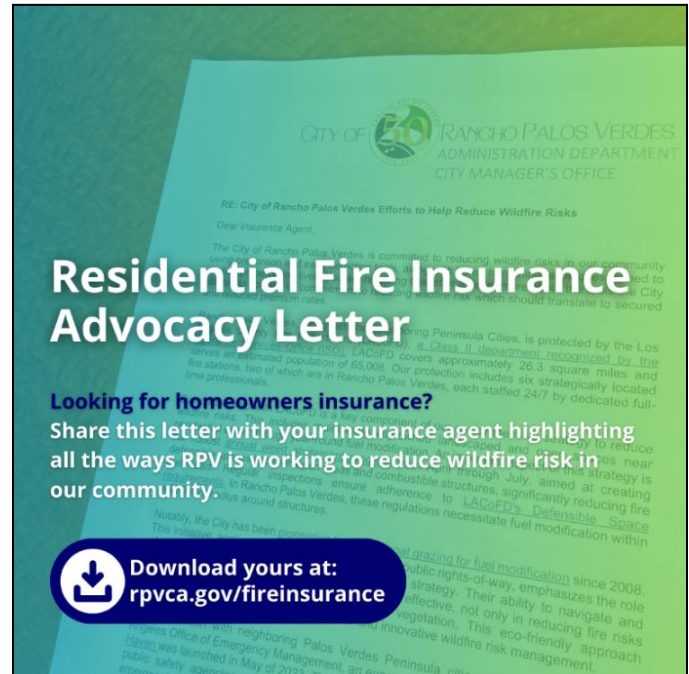
Create a plan by discussing the following questions with your family, friends, or household to kick-start your emergency preparedness:

- What is my shelter plan?
- What is my evacuation route?
- What is my family/household communication plan?
- Do I need to update my emergency preparedness Disaster Supply Kit?

Residential Fire Insurance Advocacy Letter Available on the City Website

Are you struggling to find adequate fire insurance for your home? In California, the increasing frequency and severity of wildfires have significantly impacted the residential fire insurance market. This has resulted in higher premiums, reduced coverage options, and, in some cases, policy cancellations.

In RPV, these statewide challenges are evident, with many residents reporting increased premiums and difficulty in maintaining their fire insurance coverage. In response to these concerns, the City's Emergency Preparedness Committee (EPC), in collaboration with City Staff, has developed a [comprehensive insurance resource letter \(PDF\)](#) (see attached letter).



This advocacy tool is tailored to help you, our residents and businesses, communicate effectively with your insurance providers to advocate for maintaining your current insurance policies and potentially negotiating lower premiums. We encourage you to utilize this resource to its full extent.

Earthquake Safety - What to do During and After an Earthquake

An earthquake is a sudden, rapid shaking of the earth caused by the shifting of underground rock. Deaths and injuries occur when people fall trying to walk or run during shaking or when they are hit by falling debris. Smaller earthquakes, called aftershocks, always follow the mainshock. Earthquakes can cause tsunamis, landslides, fires, and damage to utilities. Earthquakes can happen anywhere, and there is no way to predict them. But we can take action to prepare. Prepare now to protect yourself, your loved ones, and your home.



When Shaking Starts, DROP, COVER, and HOLD ON to Protect Yourself

- If you are in bed, STAY there and COVER your head and neck with a pillow. Lie face down.
- If you are outdoors, drop, then crawl towards an open space if you can. Stay away from buildings, power lines, and trees
- If you are driving, stop and stay in your vehicle. Avoid stopping near buildings, trees, overpasses, and utility wires. Proceed cautiously once the earthquake has stopped. Avoid bridges or ramps.
- If you are in a wheelchair or use a walker, lock your wheels and remain seated until the shaking stops.

- Protect your head and neck with your arms, a pillow, a book, or whatever is available. If you are unable to drop, brace yourself and protect your head and neck.

After an Earthquake

- Wait a minute before getting up. Check for any immediate dangers around you and protect yourself.
- Anticipate broken glass and debris on the ground, so put on sturdy shoes as soon as possible.
- If it is safe, exit the building. Go outside to a clear area. Check to make sure nothing will fall on you, such as bricks from a building, power lines, and trees.
- If you do not have a safe area outside, it may be better to remain inside.
- If you are near the coast, a tsunami could follow the earthquake. As soon as the shaking stops, climb to safety. Walk quickly to higher ground or inland away from the coast. Don't wait for officials to issue a warning.
- Expect aftershocks. Drop, Cover, and Hold On whenever you feel shaking.
- If you are trapped, protect your mouth, nose, and eyes from airborne debris. You can use a cloth, clothing, or a dust mask to cover your mouth and nose. Signal for help. Use a whistle or knock loudly on a solid piece of the building three times every few minutes. Rescue personnel listens for such sounds.
- Care for any injuries you may have and assist others.
- If your home has been damaged and is no longer safe, leave and go to a safer place. If you can, take your go kit of supplies.
- Use flashlights, not candles, due to fire risk.
- Do not use matches, lighters, appliances, or light switches until there are no gas leaks. Sparks from electrical switches could ignite the gas, causing an explosion.

Stay Connected

- Listen to local radio, TV, or other news sources for emergency information.
- Let friends and family know you are safe when you can.
- Check your home for safety.
- Follow guidance from local officials.
- Inspect the outside of your home for damage before re-entering. If safe to do so, check the inside of your home.
- Check for damage to gas, water, electrical, and sewage systems. If there is damage, turn the utility off. If you suspect a gas leak, leave your home, and call 911. Once you are safe, report the issue to your utility company.

- If needed, have your home inspected by a professional for damage and safety issues.

Take Care of Yourself

- It's normal to have a lot of bad feelings, stress, or anxiety.
- Eat healthy food and get enough sleep to help you deal with stress.

Be Prepared

Learn Emergency Skills

- Learn [first aid](#) and [CPR](#) to help others. People may be injured, and emergency services may not be
- available.
- Learn how to turn off the utilities in your home.
- Get a fire extinguisher and learn how to use it safely. Be ready to live without power, gas, and water.



Gather Emergency Supplies

- [Gather food, water, and medicine.](#) Stores and pharmacies might be closed. Organize supplies into a go kit, stay-at-home kit, and bed kit:
 - Go kit: at least three days of supplies that you can carry with you. Include batteries and chargers for your devices (cell phone, CPAP, wheelchair, etc.)
 - Stay-at-home kit: at least two weeks of supplies.
 - Bed kit: a bag of supplies attached to your bed. Include items you will need if an earthquake happens while you are sleeping. Store sturdy shoes to protect your feet from glass, one of the most common earthquake injuries. Also include a flashlight, glasses, a dust mask, and a whistle.
- Have a one-month supply of medication in a child-proof container and other needed medical supplies or equipment.
- Keep personal, financial, and medical records safe and easy to access (hard copies or securely backed-up). Consider keeping a list of your medications and dosages on a small card to carry with you.

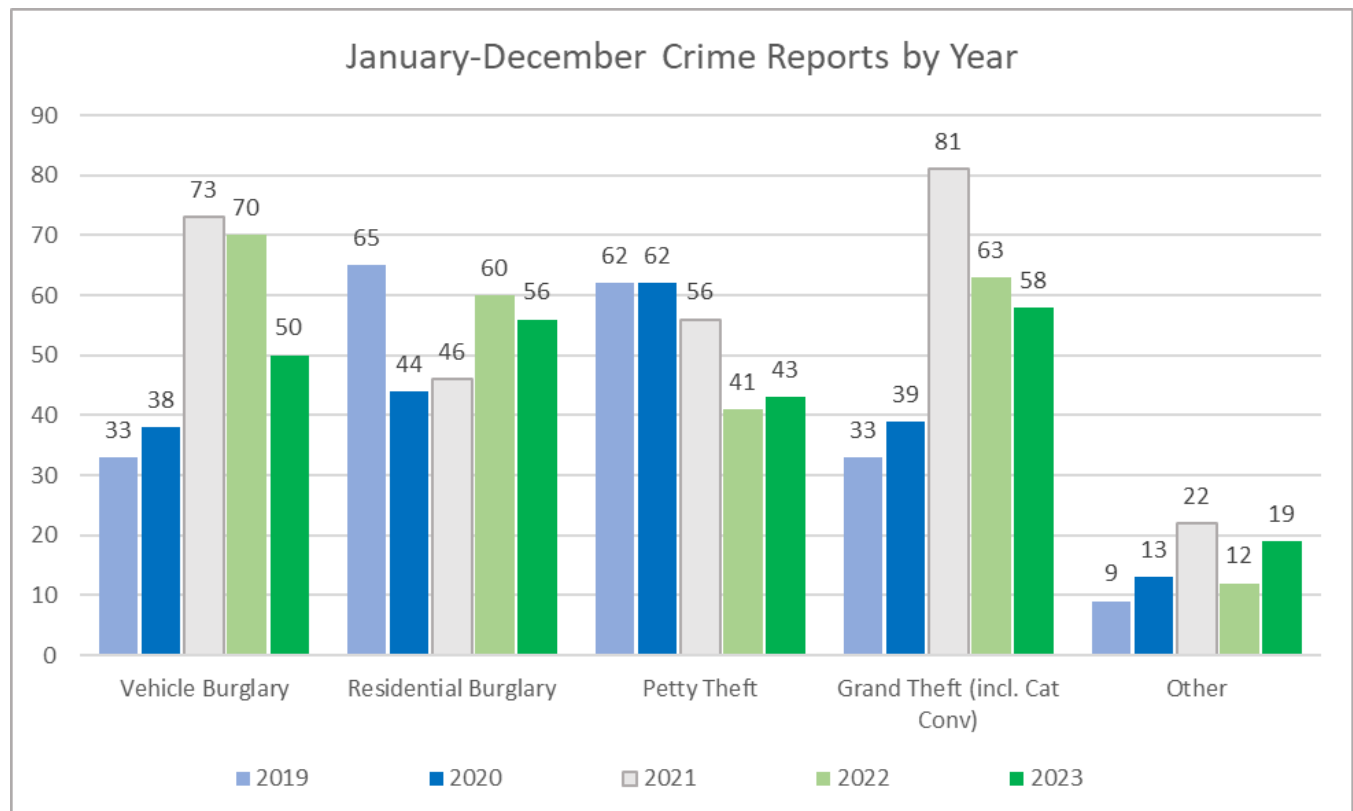

Public Safety Reminder: Lock Up for a Safer Neighborhood

Securing your home is a simple yet effective way to deter potential intruders and enhance the overall safety of your neighborhood. Here are a few key tips to keep in mind:

- 1. Lock all doors and windows:** Before leaving your home or heading to bed, make sure all doors and windows are securely locked. This includes both front and back doors, as well as any windows that may serve as entry points.
- 2. Invest in quality locks:** Consider upgrading your locks to more robust and secure options. Deadbolt locks, for example, provide an extra layer of protection and are an excellent investment in home security.
- 3. Secure sliding doors:** If you have sliding glass doors, install a bar or rod in the track to prevent them from being forced open. This simple measure can significantly enhance the security of your home.



4. **Don't forget the garage:** Keep your garage doors locked, and if you have an attached garage, ensure the door leading into your home is equally secure.
5. **Car security:** Always lock your car doors, even if you're only stepping away for a moment. Avoid leaving valuables in plain sight, and park in well-lit areas when possible.

PVPUSD School Resource Officer

On January 16, 2024, the City Council approved a Memorandum of Understanding (MOU) between the four Peninsula cities and the Palos Verdes Peninsula Unified School District to fund the School Resource Officer program for an additional three years. The MOU stipulates that the school district will pay 50% of the cost of the agreement with Allied Universal for two school safety officers up to \$150,000 annually while the four Peninsula cities will split the other 50% up to \$150,000 annually according to a formula based on enrollment and population:

- City of Rancho Palos Verdes: 65% or \$97,500
- City of Palos Verdes Estates: 20% or \$30,000
- City of Rolling Hills Estates: 13% or \$19,500
- City of Rolling Hills: 2% or \$3,000

Consumer Price Index – March 2024

In March, the Consumer Price Index (CPI) rose by 0.4%, matching February’s monthly increase. The rise in March was mainly driven by increases in shelter and gasoline prices, which together accounted for over half of the overall increase. Over the past year, the all items index rose by 3.5%.

Excluding food and energy (core inflation), the index rose by 0.4% in March. Items such as shelter, motor vehicle insurance, medical care, apparel, and personal care faced price increases, while used cars and trucks, recreation, and new vehicles saw decreases. Over the past 12 months, the all items less food and energy index rose by 3.8%, with both the energy and food indexes rising by just over 2%.

Chart 1. One-month percent change in CPI (U.S) – Mar. 2023 – Mar. 2024

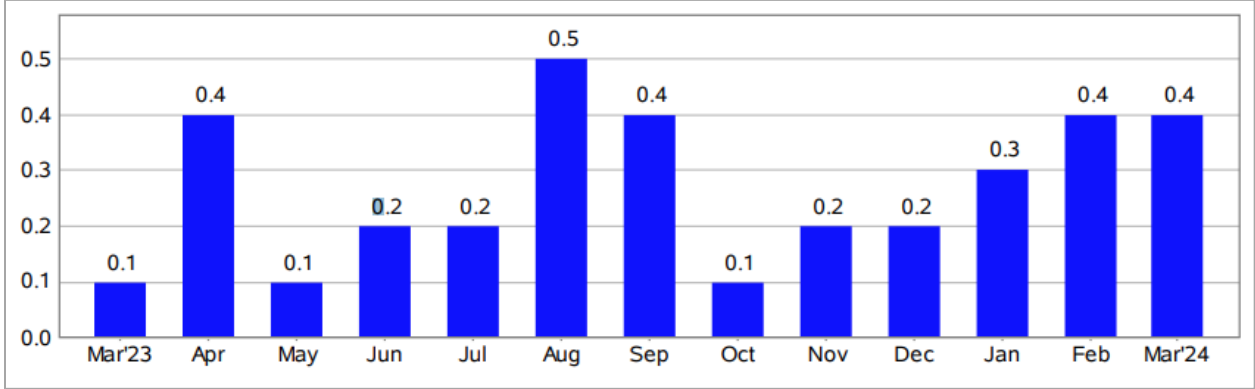
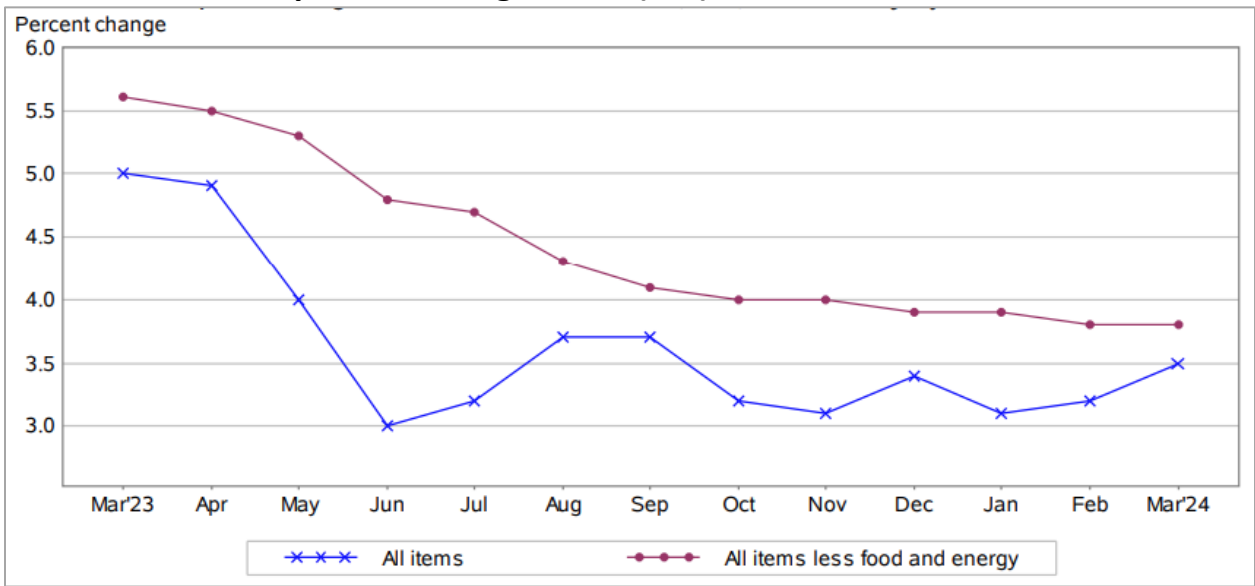


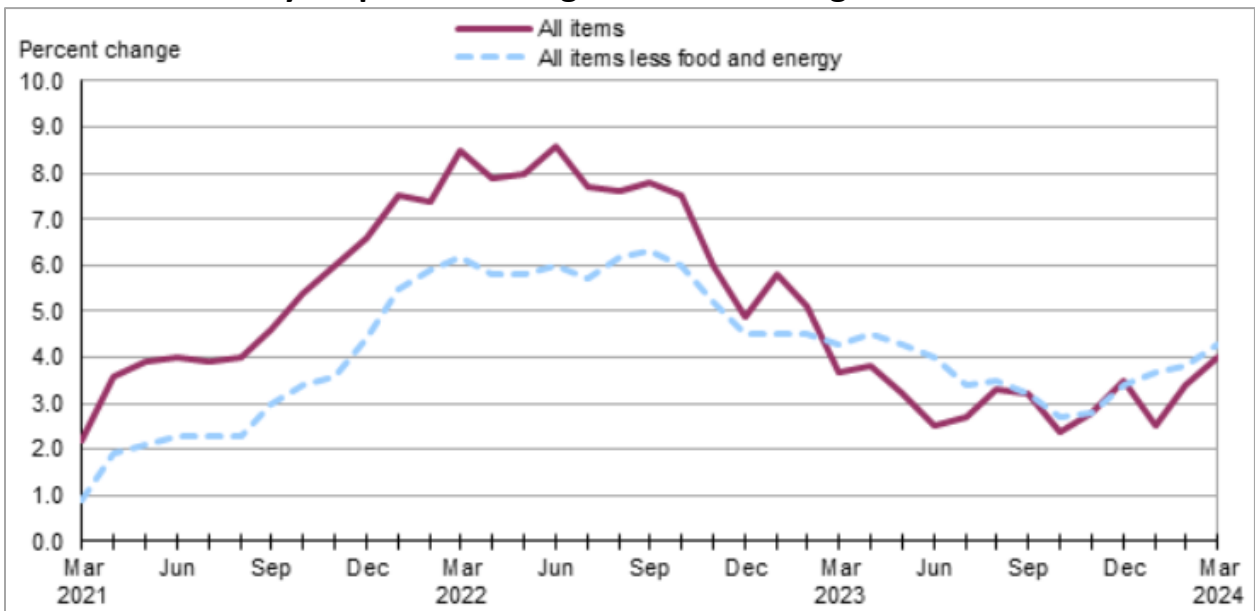
Chart 2. 12-month percent change in CPI (U.S)



Consumer Price Index – Los Angeles Area

In March, prices in the Los Angeles area increased by 0.7% over the month, driven primarily by higher shelter prices. Over the past 12 months, the CPI rose by 4%, with food prices up by 2.9% and energy prices by 3.3%, mainly due to increased electricity costs. Excluding food and energy, the index rose by 4.3% over the year.

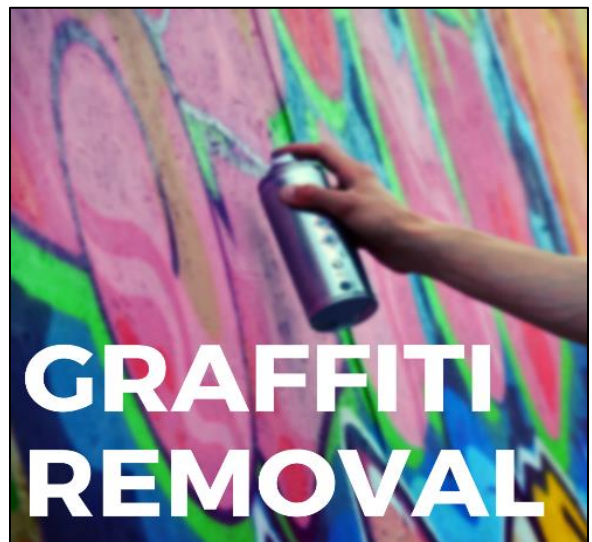
- In preparation for regular rain events, maintenance crews have been routinely performing the following:

Reminder: Planning Commission to Consider Antenna Code Update

On April 23, the Planning Commission will consider a proposed code update to the City's Antenna Code, which includes a proposal to repeal Section 17.76.020 (Antennas) of Chapter 17.76 (Miscellaneous Permits and Standards) of Title 17 (Zoning) of the Rancho Palos Verdes Municipal Code and replace it with Chapter 17.85 (Wireless Telecommunications Facilities on Private Property) and Chapter 17.87 (Amateur Radio Facilities and Over-the-Air Reception Devices). This update is being proposed to bring the City's Antenna Code into compliance with federal telecommunications law. RE: City of Rancho Palos Verdes Efforts to Help Reduce Wildfire Risks

Dear Insurance Agent,

The City of Rancho Palos Verdes (RPV) is dedicated to minimizing wildfire risks through prevention, early detection, and home hardening techniques aimed at safeguarding both property and lives. On behalf of the policy owner, this letter is being provided to you and your adjuster outlining the City's strategies and measures to reduce wildfire risk intended to contribute to more favorable insurance premium rates and policy availability for our residents and businesses.

RPV collaborates closely with the Los Angeles County Fire Department (LACoFD), [a Class II department recognized by the Insurance Services Office \(ISO\)](#). Covering approximately 26.3 square miles and serving an estimated 65,000 Palos Verdes Peninsula (PVP) residents, LACoFD operates six strategically located fire stations, including two within RPV.

Notably, RPV enhances its wildfire management capabilities with the following measures to significantly improving our emergency response and preparedness:

- Maintaining City-owned landscaped and open spaces near residential areas through year-round fuel modification. RPV's robust [ANNUAL WEED ABATEMENT PROGRAM](#) aims to create defensible spaces between open areas and combustible structures, significantly reducing fire fuel load. Regular inspections ensure adherence to [LACoFD's Defensible Space requirements](#).
- [GOAT GRAZING FOR FUEL MODIFICATION](#): On city-owned lands including public rights-of-way. Goats effectively remove brush and grass from hard to access terrain thereby significantly reducing fire loads and risks.
- [GENASYS PROTECT \(ZONE HAVEN\)](#): Implemented in May 2023, this critical emergency preparedness tool is available to residents at [PVPready.gov](#), as an Evacuation Management Platform in identifying evacuation zones and guiding residents on necessary actions during emergencies.
- [PANO AI'S WILDFIRE CAMERAS](#): This network of AI cameras provide early detection of wildfire smoke across the Palos Verdes Peninsula and has proven effective in delivering timely and accurate early alerts for fire ignitions.
- [HELOPOD FIREFIGHTING DIP SOURCE](#): The City installed a [HeloPod](#) at its Civic Center that is in close proximity to open space and canyons areas enabling rapid water refilling for firefighting helicopters.

The City has further initiated the following measures to enhance community safety against wildfires:

- [Firescaping training workshops.](#)
- [Home hardening videos.](#)
- [Monthly emergency preparedness safety tips.](#)
- Collaborative efforts with Southern California Edison (SCE) for utility line hardening and undergrounding.
- A comprehensive [Multi-Jurisdictional Hazard Mitigation Plan](#), offering in-depth insights into RPV's wildfire mitigation strategies on pages 151-158 of the plan.
