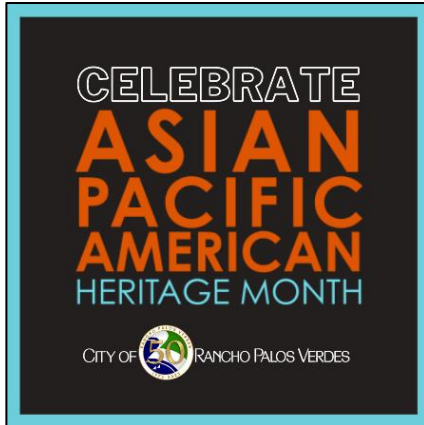

Portuguese Bend Landslide Local Emergency Update

Rainy season may be coming to an end, but as we know, the impacts of rainfall on the City's ancient landslides are felt weeks and months after the fact. According to the latest surveying data, since March, average land movement velocity across the landslide complex has accelerated an additional 76% — or 1.76 times — above velocity from January-March. Recent land movement rates are approximately 6-9 inches per week in the Abalone Cove Landslide, 5-9 inches per week in the Portuguese Bend Landslide, and 1-4 inches per week in the Klondike Canyon Landslide. The middle of the landslide complex is moving the fastest, at over 9 inches per week.

The City continues to closely monitor the movement and work on an expedited timeline to implement emergency measures to slow the sliding and address its impacts, while working toward making progress on the long-term Portuguese Bend Landslide Remediation Project.

May 7 City Council Meeting

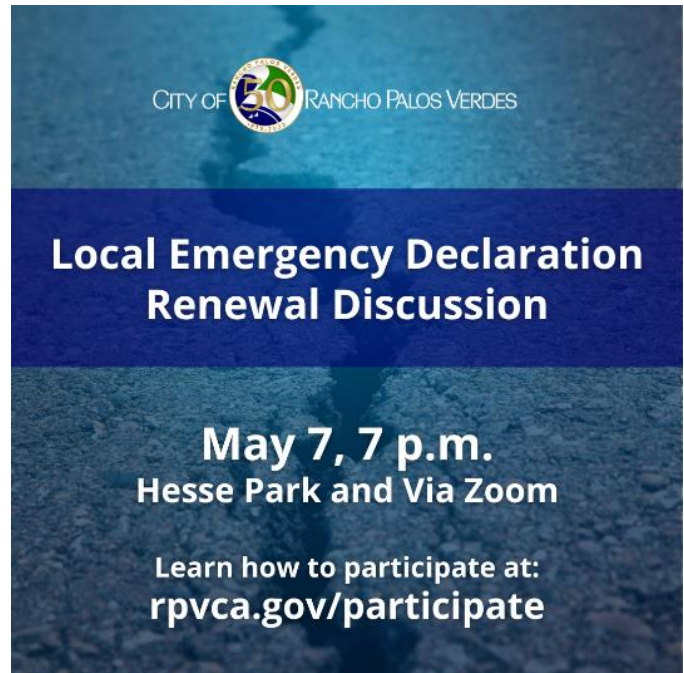
On May 7, the City Council will consider extending the City's local emergency declaration in the landslide complex through July 6, 2024. The Council will also hear the City geologist's latest findings and consider construction contracts for two emergency dewatering wells in the landslide complex that will remove water that is trapped underground and contributing to movement.

One well will be installed near Burma Road at the north end of the landslide complex, and the other will be installed on the south end at one of two potential locations: in the Portuguese Bend Beach Club (PBC) near Yacht Harbor Drive and Seawall Road, or in the turnout area along Palos Verdes Drive South formerly known as "Gateway Park." The PBC location was identified as a preferred option for the south end because it is most likely to yield the greatest benefit. However, the City will need to secure authorization from PBC to access the site.

Installing these dewatering wells — also called hydraugers — is expected to cost about \$9.6 million in total. If approved by the City Council, the work will be funded by the Capital Infrastructure Program Fund while City staff seeks reimbursement under the federal disaster declaration related to February's storms to help offset costs, as well as other funding opportunities. Construction could begin as early as June.

During the meeting, City staff will also give an update on trail conditions, plans to regrade the "ski jump" on Palos Verdes Drive South, and request the City Council provide an additional \$875,000 in funding needed for repairs along Palos Verdes South and roads in the Seaview neighborhood, as the City has gone over budget for this fiscal year due to the unprecedented land movement requiring frequent repaving.

Staff will also give an update on discussions with the Abalone Cove and Klondike Canyon Landslide Abatement Districts regarding potentially providing them with financial and in-kind assistance to help them complete landslide stabilization work.



Finally, the Council will consider a request from the Portuguese Bend Community Association — which maintains roads in the private community — for a nearly \$500,000 loan to fund unforeseen road repairs due to land movement.

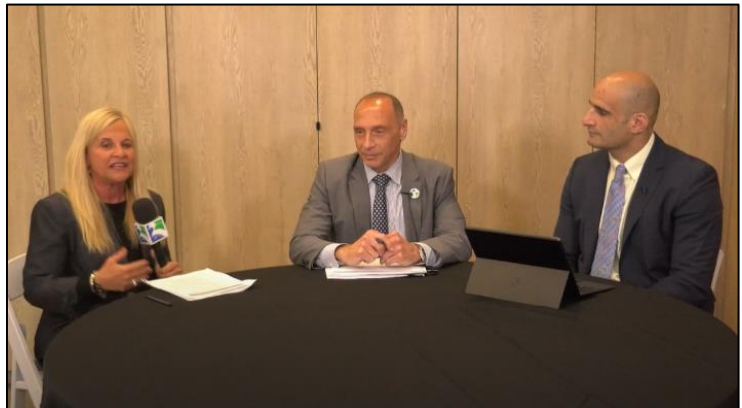

Legislation Corner

On May 7, the City Council will consider taking positions on important pending legislation. The bills under consideration are Assembly Bill No. (AB) 2583, AB 2715, AB 1886, AB 1893, AB 1820, and Senate Bill No. (SB) 1037. In addition, the City Council will consider adopting a resolution in support of a bipartisan ballot measure, the Homelessness, Drug Addiction, and Theft Reduction Act.

Court Declares Senate Bill 9 Unconstitutional For Charter Cities

On April 22, L.A. County Superior Court Judge Curtis A. Kin issued a ruling granting a Petition for Writ of Mandate challenging the constitutionality of Senate Bill No. 9 (SB 9), as applied to charter cities. SB 9 requires all California cities to ministerially approve an application for a lot split, and up to four total housing units, on a single family residential lot that meets certain specified criteria.

Five charter cities — Carson, Redondo Beach, Torrance, Del Mar, and Whitter — initiated a lawsuit in early 2022 against the State of California claiming that SB 9 is unconstitutional and invalid against charter cities. Cal Cities and the City of Cerritos filed respective amicus briefs in the Trial Court in support of the charter cities' position. After extensive briefing and two hearings, the Court ruled in favor of the five charter cities. The ruling does not apply to general law cities, including Rancho Palos Verdes, which filed a "sister" challenge to SB 9 with the cities of Lakewood, Paramount, and Simi Valley.

In this litigation, the charter cities are represented by Managing Partner Sunny Soltani, Equity Partner Pam Lee, Partner Michelle Villarreal, and Associate Shukan Patel of Aleshire & Wynder, LLP along with Michael Webb from the Redondo Beach City Attorney's office. 

Alert SouthBay Plans Regional Emergency Alert Test for May 7

Alert SouthBay, in coordination with the Federal Communications Commission (FCC), will conduct a regional Wireless Emergency Alerts (WEA) test on May 7, 2024.

The regional test will consist of two portions: testing WEA and registering subscribers in the Alert SouthBay Regional Program. Both tests are scheduled to begin at approximately 11:30 a.m. PST on Tuesday, May 7, 2024. These tests are vital to ensuring the deliverability of critical public emergency alerts.

The message will read as follows:

"THIS IS A TEST of the Regional Wireless Emergency Alert System. No action is needed."

Who: The Alert SouthBay Regional Alert and Warning Program will send this test alert.

What: The Regional Public Alert Test to all active cell phones. One alert will be sent to devices during a 30-minute timeframe.

When: Tuesday, May 7, 2024 at 11:30 a.m. PST

Why: To ensure alert systems in the U.S. continue to be effective in communicating to the public critical information regarding emergencies, especially on a regional level. While national and state emergency agencies can access the alerting tools utilized by local agencies, national and state agencies will not be issuing this regional alert; it will be issued by the local agency of Alert SouthBay.

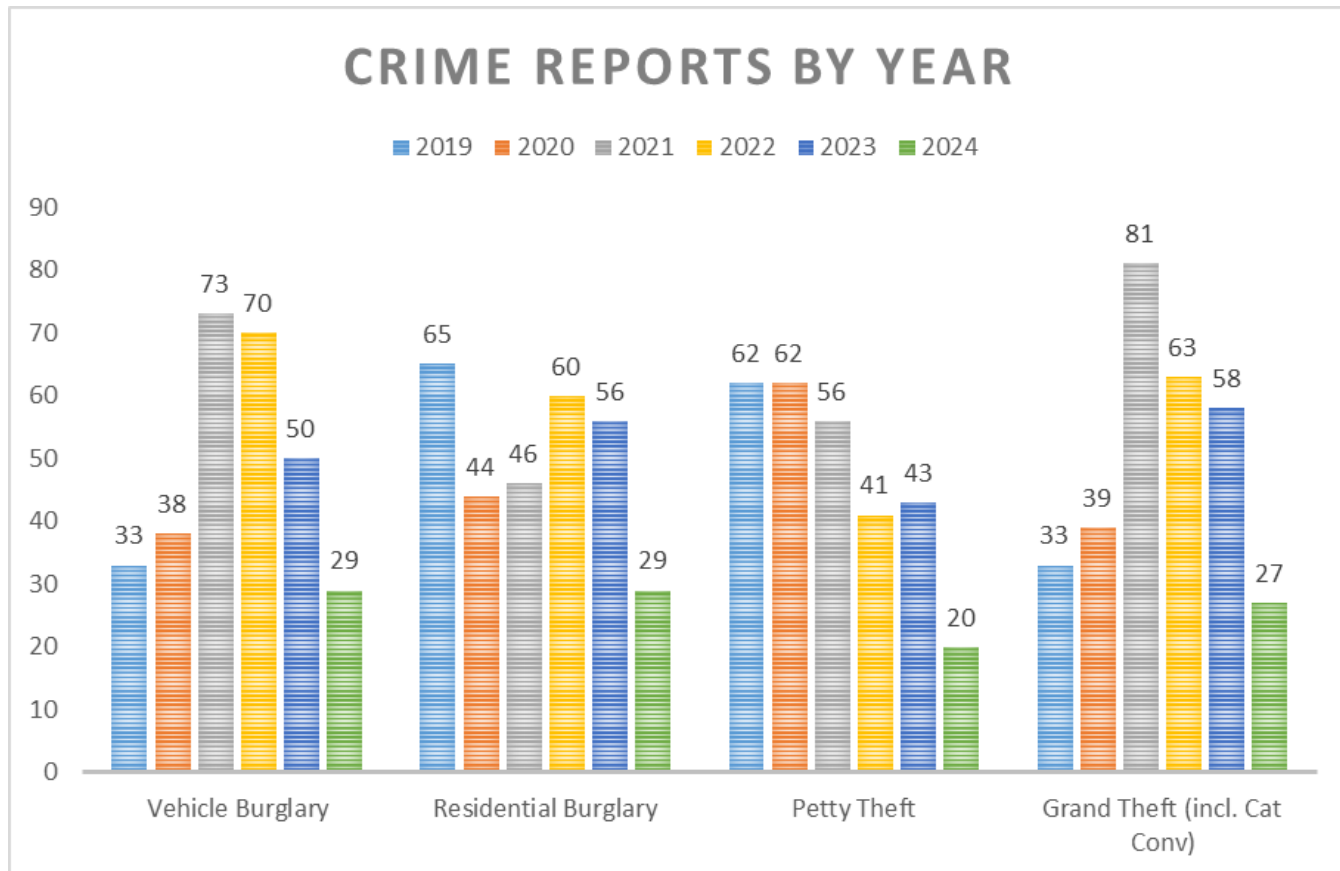

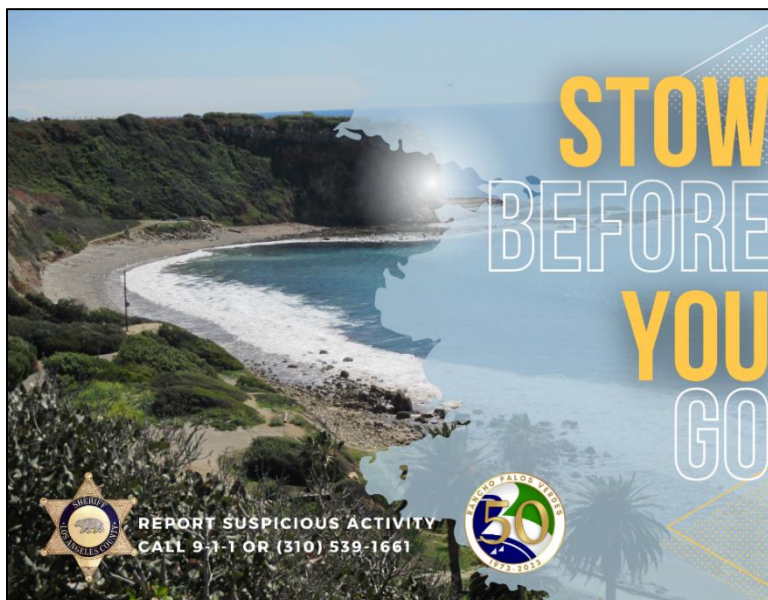

Attention All: Stow Before You Go!

"Stow before you go" isn't just a catchy phrase; it's a crucial reminder for ensuring public safety. Whether you're at home, work, or in public spaces, taking a moment to secure your belongings before leaving can prevent accidents, injuries, and even tragedies.

Before you rush out the door, take a second to secure your surroundings.



Home Safety: Before leaving, ensure stoves, ovens, and any electrical appliances are turned off. Secure windows and doors to deter burglars and prevent accidents every time.

Trail Safety: Embarking on a trail adventure? Remember, safety begins before you hit the path! Take a moment to stow away essentials properly for a safer and more enjoyable journey.

Public Safety Reimbursement Program

The City of Rancho Palos Verdes offers Public Safety Reimbursements for the purchase of doorbell or neighborhood camera systems. The City will provide a one-time reimbursement for half of the cost of a new public safety purchase, up to \$2,000 for neighborhoods, and up to \$100 for individuals.

In addition, the City will waive permit fees directly related to the installation of the approved purchase. The neighborhood, individual, or vendor will be responsible for completing any necessary permits prior to installation.

Case-Shiller Home Price Indices – February 2024

This week, data from the S&P CoreLogic Case-Shiller Home Price Indices, the leading measure of residential real estate prices, were released for February. This information provides insight into the housing market by highlighting monthly and annual changes reported in the National and Los Angeles Home Price Indices.

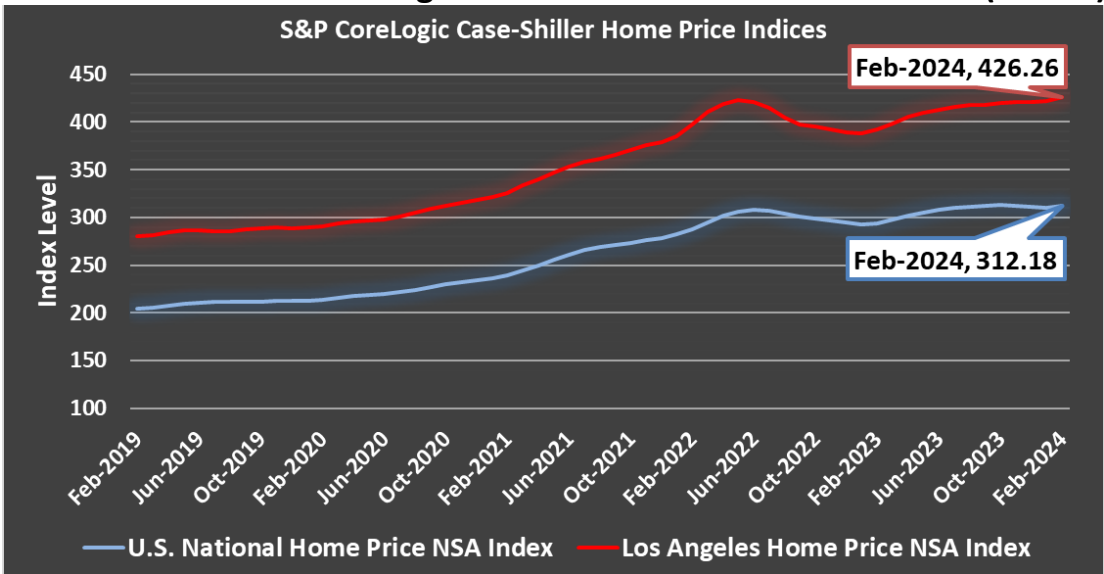
Month-over-Month

While high mortgage rates continue to impact sales activity, the U.S. National Index posted a month-over-month increase of 0.6% in February, before seasonal adjustments. As the primary gauge of U.S. home prices, February’s data revealed that 18 out of the 20 major metropolitan markets experienced month-over-month price gains. This included home prices in the Los Angeles area, which posted a monthly increase of 1%.

Year-over-Year

The National Index reported a 6.4% annual gain for February, the fastest annual rate since November 2022, and up from 6% in January. For the third straight month, all cities saw yearly price increases, with San Diego, Los Angeles, Washington, D.C., and New York hitting all-time highs. Los Angeles had a year-over-year increase of 8.7% in February, helping Southern California outperform its surrounding neighbors.

In addition to the goats, you may see Stay Green crews performing brush clearance in various areas of the City as part of the City's 2024 fuel modification program.



Maintenance Activities

 - Clearing and cleaning out storm drains.

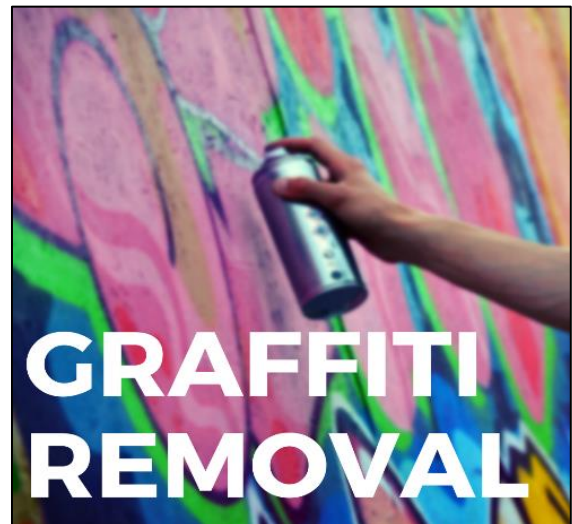


- Placing sandbags in various locations to prevent and reduce the likelihood of flooding and water damage.

Graffiti Removal

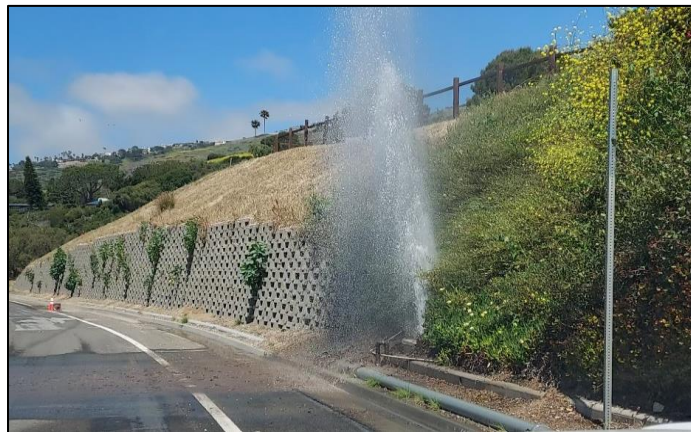
- **Twenty** graffiti incidents were reported and removed this week.

Greenbook Training, April 22-26

Public Works engineers Jeremiah Sunwoo, Brandon Mesker, and Deputy Director David Copp recently attended an American Public Works Association (APWA) webinar on the latest revisions to the Greenbook. The Greenbook is a key resource for ensuring safety and accessibility in public infrastructure design and construction and is widely used by various stakeholders including local governments, transportation agencies, and construction professionals. The webinar highlighted the importance of understanding

general provisions, such as their relationship to the Public Contract Code and their application during contract administration. This knowledge is crucial for ensuring compliance with relevant laws, identifying potential risks, and managing liabilities associated with infrastructure projects. Understanding these provisions empowers engineers to navigate legal and regulatory requirements, promote ethical conduct, and effectively manage projects from conception to completion.

Stop Illegal Dumping

The Community Development Department's Code Enforcement Division has received a recent increase in complaints regarding illegal dumping throughout the City. Rancho Palos Verdes Municipal Code (RPVMC) § 8.20.130 (Illegal Dumping) prohibits dumping onto any public or private lot, alley, street, land, or in any water or waterway.



The City's website includes resources related to city-wide disposal services including bulky item pickup. Please visit rpvrecycles.com for more information on residential or commercial services available through EDCO.

REMINDER: Planning Commission to Consider Mixed Use and Residential Overlay District Code Amendments

On April 16, the City Council unanimously adopted [Urgency Ordinance No. 678U \(PDF\)](#) approving zoning amendments inclusive of Zoning Map amendments and development standards for accessory dwelling units (ADUs) and junior ADUs (JADUs), to immediately effectuate the Housing Element, including rezoning sufficient sites to accommodate the City's regional housing needs allocation by adopting the implementation actions to effectuate the City's Revised Final 2021-2029 Housing Element.

As part of this action, City Council initiated code amendment proceedings related to amendments to Chapter 17.40 (Overlay Control Districts), Chapter 17.96 (Definitions), Chapter 17.76 (Miscellaneous Permits and Standards, Chapter 17.10 (Accessory Dwelling Unit and Junior Accessory Dwelling Unit Development Standards) and other code sections as applicable of Title 17 of the Rancho Palos Verdes Municipal Code to adopt

the zoning and code amendments that were adopted in Urgency Ordinance 678U by regular ordinance.

On May 7, the Planning Commission will consider a recommendation to the City Council to adopt by regular ordinance those code amendments that were adopted by City Council in Urgency Ordinance No. 678U on April 16. The REACH program serves the social and recreational needs of youths and adults with developmental disabilities and is back at Hesse Park for in-person activities.

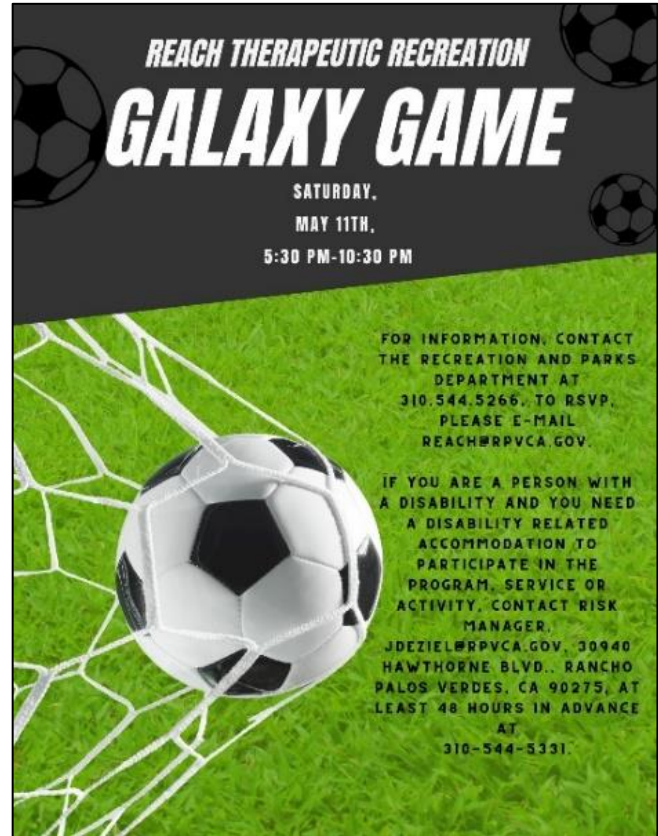

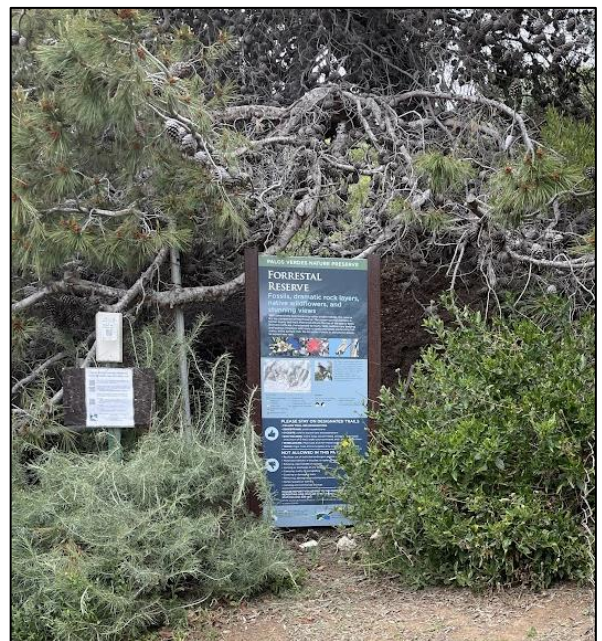

WILDFIRE PREPAREDNESS TIPS

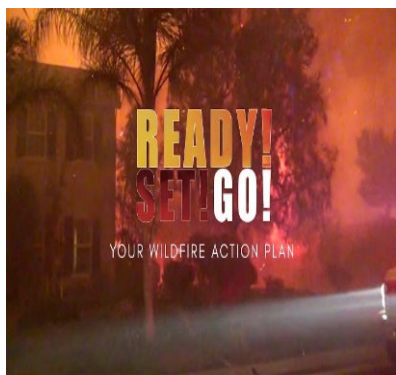
With an uptick in recent brush fires across the State and Los Angeles County region, Peninsula residents are reminded to be on heightened alert and to be prepared for wildfire. **Download the Ready! Set! Go! Wildfire Action Plan** (Fire.lacounty.gov/rsg/) for tips on how to protect your family and safeguard your home in case of a wildfire.



READY

Create and maintain defensible space and harden your home against flying embers.

- Trees touching/overhanging structure: Remove limbs within five feet of any structure, and within 10' from any chimney outlet.
- Vines and climbing plants: Remove from all structures.
- Hedges and screens between homes: Reduce and maintain to height of no greater than 8'.
- Large shrubs under windows: Maintain 12" separation under windows.
- Ground cover: Maintain at 18" maximum height.
- Dead vegetation: Remove all dead material within 100' of structures.



SET

Now that you have done everything you can to protect your home, it's time to prepare your family. Your Wildfire Action Plan must be prepared with all members of your household well in advance of a wildfire. Once you finish your plan, practice it regularly with your family, and post it in a safe and accessible place for quick implementation.
