Disaster Assistance Now Available

On May 17, the U.S. Small Business Administration announced that disaster assistance is now available to California businesses and residents affected by recent severe winter storms, tornadoes, flooding, landslides and mudslides (see attached press release). **A Virtual Disaster Loan Outreach Center is now open.** The deadline to apply for property damage is July 16, 2024. The deadline to apply for economic injury is Feb. 18, 2025.

SBA Offers Disaster Assistance to California Businesses and Residents Affected by the Severe Winter Storms, Tornadoes, Flooding, Landslides and Mudslides

SACRAMENTO, Calif. – Low-interest federal disaster loans are available to California businesses and residents affected by the severe winter storms, tornadoes, flooding, landslides and mudslides that occurred Jan. 31 – Feb. 9, announced [Administrator Isabella Casillas Guzman](#) of the U.S. Small Business Administration. SBA acted under its own authority to declare a disaster in response to a request SBA received from Gov. Gavin Newsom’s authorized representative, Director Nancy Ward of the California Office of Emergency Services, on May 16.

The SBA Rural disaster declaration makes SBA assistance available to both rural and non-rural areas of Butte, Los Angeles and Santa Cruz counties.

“SBA’s mission-driven team stands ready to help California’s small businesses and residents impacted by the severe winter storms, tornadoes, flooding, landslides and mudslides,” said Administrator Guzman. “We’re committed to providing federal disaster loans swiftly and efficiently, with a customer-centric approach to help businesses and communities recover and rebuild.”

“Low-interest federal disaster loans are available to businesses of all sizes, most private nonprofit organizations, homeowners and renters whose property was damaged or destroyed by this disaster,” said [Francisco Sánchez Jr.](#), associate administrator for the Office of Disaster Recovery and Resilience at the Small Business Administration.

“Beginning Monday, May 20, SBA customer service representatives will be available at the Virtual Disaster Loan Outreach Center to answer questions about SBA’s disaster loan program, explain the application process and help each business owner complete their application,” Sánchez continued. The virtual center will be open on the days and times indicated below. No appointment is necessary.

Businesses of all sizes and private nonprofit organizations may borrow up to \$2 million to repair or replace damaged or destroyed real estate, machinery and equipment, inventory and other business assets. SBA can also lend additional funds to businesses

and homeowners to help with the cost of improvements to protect, prevent or minimize damage from occurring in the future.

For small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations of any size, SBA offers Economic Injury Disaster Loans to help meet working capital needs caused by the disaster. Economic injury assistance is available regardless of whether the business suffered any property damage.

Disaster loans up to \$500,000 are available to homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for up to \$100,000 to repair or replace damaged or destroyed personal property, including personal vehicles.

Interest rates can be as low as 4 percent for businesses, 3.25 percent for private nonprofit organizations and 2.688 percent for homeowners and renters with terms up to 30 years. Loan amounts and terms are set by SBA and are based on each applicant's financial condition.

Interest does not begin to accrue until 12 months from the date of the first disaster loan disbursement. SBA disaster loan repayment begins 12 months from the date of the first disbursement.

Hatano Farm Approved as California Point of Historical Interest

Last week, Staff received a letter notifying the City that California Department of Parks and Recreation Director Armando Quintero has approved Hatano Farm as a California Point of Historical Interest (see attached letter).

Established in 1953 on a hillside located at what is today the Ken Dyda Civic Center, Hatano Farm is the last vestige of the tradition of Japanese American truck farming that once dominated the Palos Verdes Peninsula. In January 2023, the State Historical Resources Commission (SHRC) voted unanimously to designate Hatano Farm as a California Point of Historical Interest and for listing on the California Register of Historical Resources.


Now that the California Department of Parks and Recreation has signed off on the designation, Staff will reach out to the state about the next steps in the process, including the installation of a plaque.

DMV to No Longer Process Simple Transactions in Offices

The Department of Motor Vehicles is making it so easy for Californians to take care of business as part of its customer-focused digital transformation that the DMV will no longer process simple transactions in offices that can easily be completed online or through other convenient options.

Starting June 3, the DMV will only process the following transactions through alternative, out-of-office options:

- Simple vehicle registration renewals that are not past the due date.
- Driver's license renewals that do not require an in-person visit.
- Requests for copies of vehicle registration records, which show a vehicle's ownership history.



- Requests for copies of driver's license records, which show a driver's history.
- Replacing a lost or stolen driver's license/identification card.

Customers accustomed to completing these tasks in person need not fret because the DMV has spent the last few years digitizing services, improving efficiency and making more than 90% of transactions available on a phone, tablet, laptop or computer. These transactions are available online or by mail, and in some cases at kiosks, over the phone or through DMV business partners, making it easier than ever to skip the trip to an office. As more customers go online and use other service channels, DMV offices can better accommodate Californians who need a REAL ID or otherwise must visit an office.



In all, this could potentially reduce DMV office visits by 200,000 customers a month – 2.4 million trips in a year.

There are some transactions that require an in-office visit, like finalizing a REAL ID application. The DMV encourages customers to start their application online to limit the amount of time it takes to complete the process in an office.



Regional Contract Law and Peninsula Public Safety Committee Meeting Recap

At the May 24 Regional Contract Law Meeting, Lomita Sheriff's Station Captain Kimberly Guerrero provided information on response times, crime statistics, and updates on crime suppression activities that LASD Lomita Station deputies are involved in within Rancho Palos Verdes and the rest of the Peninsula. Past agendas and minutes are available to view on the [City website](#).

On the chart below, LASD reported that during the first quarter of 2024 (January-March), response times to calls for service in Rancho Palos Verdes were 6 minutes, 12 minutes, and 30 minutes for Emergency, Priority, and Routine calls, respectively. These response times are well below LASD targets and demonstrate Lomita Station deputies' commitment to providing exceptional service to the residents of Rancho Palos Verdes. Case-Shiller Home Price Indices – March 2024

This week, data from the S&P CoreLogic Case-Shiller Home Price Indices, the leading measure of residential real estate prices, were released for March. This information provides insight into the housing market by highlighting monthly and annual changes reported in the National and Los Angeles Home Price Indices.


Month-over-Month

The U.S. National Index continued its upward trend from last month, posting a month-over-month increase of 1.3% in March, before seasonal adjustments. Moreover, the leading measure of U.S. home prices shows that all the major metro markets reported month-over-month price increases. As such, home prices in the Los Angeles area rose by 1.7% in March, increasing by 0.7% compared to February’s monthly gain.

Year-over-Year

The National Index reported a 6.5% annual gain for March, the same increase as the previous month. The National Index has reached new highs in six of the last 12 months. San Diego stands out with an impressive 11.1% annual gain, followed closely by New York at 9.2%, and Cleveland and Los Angeles at 8.8%, indicating a strong demand for urban markets.




Portuguese Bend Landslide Emergency Hydraulics Project Update

This project is an emergency stabilization measure for the Portuguese Bend Landslide. Since the City Council's approval of continuing the emergency project at the May 21 meeting, the need for emergency work is ongoing. The status of the project is as follows:

- The general contractor secured bonds and insurance as required before work can commence on site.
- Borehole locations have been finalized and associated instrumentation ordered.
- Mobilization, staging, and drilling of the boreholes has been scheduled.

Equipment for drilling the first set of boreholes is expected to arrive onsite the week of May 27. The following week, the contractor will perform earthwork operations for access to the boreholes. Drilling of the first borehole is scheduled to begin by June 10. The boreholes will be used to determine the exact launch point and alignment of the horizontally and directionally drilled hydraulics. The hydraulics will be used to capture and extract groundwater from the landslide area.



The Goats are Here for Fuel Modification Season

Goats are back to perform the important job of helping reduce fire loads and protecting homes. Although we understand many people enjoy seeing the goats, please refrain from going to see them out of respect for residents living near where the goats work.

A temporary electrified fence is used to contain the goats while they are working, and attempting to approach them puts you as well as the goats at risk. Please avoid attempting to take selfies/pictures or touch the goats, especially if you have dogs or other pets with you. This will prevent stress and/or injury to you and the goats.



In addition to the goats, you may see crews from Stay Green performing brush clearance in various areas of the City as part of the City's 2024 fuel modification program.



Maintenance Activities

In addition to regularly scheduled maintenance and repairs, Public Works performed the following:



- Weekly landscape maintenance at all City parks.
- All City irrigation systems have resumed regular watering as of this week.
- Repaired irrigation systems at Eastview Park.
- Cleared overgrown weeds at the main staircase to lower Hesse Park.






- Weed removal, brush clearance, and debris removal continued throughout the City at medians and various right-of-way sections at the following locations:


Public Right-of-Way/Roadway Repairs

Emergency Response


- Over the Memorial Day holiday weekend, the Public Works Department responded to a sewer lift station grinder pump outage in the Portuguese Bend area. Crews arrived on site and were able to perform temporary repairs to make the lift station operational until the pump could be replaced. As of May 28, the lift station was back online with no service interruptions.

Update for Remodeling Project at 29105-29229 S. Western Avenue Shopping Center (Western Plaza)

On May 17, the Building and Safety Division of the Community Development Department approved a commercial tenant improvement permit (Permit No. COM2024-00006) to renovate an existing shopping center known as “Western Plaza” at the south-west corner of Western Avenue and Trudie Drive located at 29105-29229 S. Western Avenue.

The project proposes replacing some existing professional office space with an outdoor seating area, updates to the existing building facades, along with new building and site signage. The design revisions will maintain existing building height configurations throughout the project site. The project also involves grading and recontouring the existing parking lot, which is currently under review by the City’s Planning Division. If approved, the Applicant will be working with the City’s Building and Safety Division on grading plan check and permitting. Consideration of Mixed Use and Residential Overlay District Code Amendments

On April 16, the City Council unanimously adopted [Urgency Ordinance 678U \(PDF\)](#) approving zoning amendments inclusive of Zoning Map amendments and development standards for accessory dwelling units (ADUs) and junior ADUS (JADUs), to immediately effectuate the Housing Element, including rezoning sufficient sites to accommodate the City’s regional housing needs allocation by adopting the implementation actions to effectuate the City’s Revised Final 2021-2029 Housing Element.

As part of this action, City Council initiated code amendment proceedings related to amendments to Chapter 17.40 (Overlay Control Districts), Chapter 17.96 (Definitions), Chapter 17.76 (Miscellaneous Permits and Standards, Chapter 17.10 (Accessory Dwelling Unit and Junior Accessory Dwelling Unit Development Standards) and other code sections as applicable of Title 17 of the Rancho Palos Verdes Municipal Code to adopt the zoning and code amendments that were adopted in Urgency Ordinance 678U by regular ordinance.

On May 14, the Planning Commission approved recommendations to the City Council to adopt by regular ordinance those code amendments that were adopted by City Council in Urgency Ordinance 678U on April 16. The City Council will consider the Planning Commission's recommendations on the code amendments as part of a public hearing on June 4. City Council to Consider Antenna Code Update

On June 4, the City Council will consider a proposed code update to the City's Antenna Code, which includes a proposal to repeal Section 17.76.020 (Antennas) of Chapter 17.76 (Miscellaneous Permits and Standards) of Title 17 (Zoning) of the Rancho Palos Verdes Municipal Code and replace it with Chapter 17.85 (Wireless Telecommunications Facilities on Private Property) and Chapter 17.87 (Amateur Radio Facilities and Over-the-Air Reception Devices). This update is being proposed to bring the City's Antenna Code into compliance with federal telecommunications law. A copy of the [public notice \(PDF\)](#) is available for review. 
Scoops and Sprinkles Soiree

SBA Offers Disaster Assistance to California Businesses and Residents Affected by the Severe Winter Storms, Tornadoes, Flooding, Landslides and Mudslides

SACRAMENTO, Calif. – Low-interest federal disaster loans are available to California businesses and residents affected by the severe winter storms, tornadoes, flooding, landslides and mudslides that occurred Jan. 31 – Feb. 9, announced [Administrator Isabella Casillas Guzman](#) of the U.S. Small Business Administration. SBA acted under its own authority to declare a disaster in response to a request SBA received from Gov. Gavin Newsom’s authorized representative, Director Nancy Ward of the California Office of Emergency Services, on May 16.

The SBA Rural disaster declaration makes SBA assistance available to both rural and non-rural areas of Butte, Los Angeles and Santa Cruz counties.

“SBA’s mission-driven team stands ready to help California’s small businesses and residents impacted by the severe winter storms, tornadoes, flooding, landslides and mudslides,” said Administrator Guzman. “We’re committed to providing federal disaster loans swiftly and efficiently, with a customer-centric approach to help businesses and communities recover and rebuild.”

“Low-interest federal disaster loans are available to businesses of all sizes, most private nonprofit organizations, homeowners and renters whose property was damaged or destroyed by this disaster,” said [Francisco Sánchez Jr.](#), associate administrator for the Office of Disaster Recovery and Resilience at the Small Business Administration. “Beginning Monday, May 20, SBA customer service representatives will be available at the Virtual Disaster Loan Outreach Center to answer questions about SBA’s disaster loan program, explain the application process and help each business owner complete their application,” Sánchez continued. The virtual center will be open on the days and times indicated below. No appointment is necessary.

Businesses of all sizes and private nonprofit organizations may borrow up to \$2 million to repair or replace damaged or destroyed real estate, machinery and equipment, inventory and other business

assets. SBA can also lend additional funds to businesses and homeowners to help with the cost of improvements to protect, prevent or minimize damage from occurring in the future.

For small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations of any size, SBA offers Economic Injury Disaster Loans to help meet working capital needs caused by the disaster. Economic injury assistance is available regardless of whether the business suffered any property damage.

Disaster loans up to \$500,000 are available to homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for up to \$100,000 to repair or replace damaged or destroyed personal property, including personal vehicles.

Interest rates can be as low as 4 percent for businesses, 3.25 percent for private nonprofit organizations and 2.688 percent for homeowners and renters with terms up to 30 years. Loan amounts and terms are set by SBA and are based on each applicant's financial condition.

Interest does not begin to accrue until 12 months from the date of the first disaster loan disbursement. SBA disaster loan repayment begins 12 months from the date of the first disbursement.

Applicants may also call SBA's Customer Service Center at (800) 659-2955 or email disastercustomerservice@sba.gov for more information on SBA disaster assistance. The deadline to apply for property damage is July 16, 2024. The deadline to apply for economic injury is Feb. 18, 2025.
