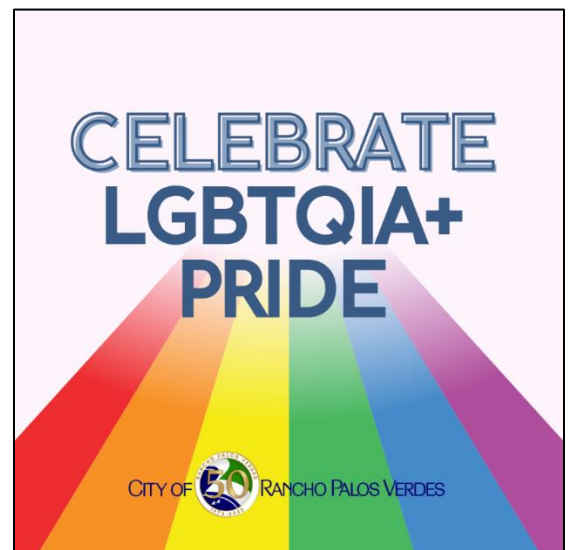

## June 4, 2024 City Council Meeting Highlights

Highlights from the June 4 City Council meeting:

- The Council approved the terms and conditions of financial assistance packages the City is offering to RPV's two geological hazard abatement districts to help complete their landslide mitigation projects. The proposed \$1.5 million loan to the Abalone Cove Landslide Abatement District (ACLAD) and \$1.9 million loan to the Klondike Canyon Landslide Abatement District (KCLAD) each include a 2.5% interest rate over a 12-year period.
- Now, both districts' board of directors must accept, by resolution, the loan terms before the agreements can be brought back to the Council for approval to be signed.
- As the City is the largest property owner in each district, the Council discussed proposed assessment increases, opting not to challenge them, since they are needed for the critical landslide mitigation work. The Council allocated approximately \$488,000 total to cover both districts' assessment increases.
- The Council introduced an ordinance making necessary updates to the City's wireless telecommunications ordinance for private properties.
- City staff presented the preliminary City budget for 2024-25, which includes \$39.4 million in revenues. The Council will consider adopting the final spending plan on June 18.
- Finally, the Council set its goals for 2024-25 across multiple policy areas, including a new goal of creating a storefront improvement matching grant program for businesses along Western Avenue.

## Portuguese Bend Landslide Local Emergency Update

### Virtual Disaster Loan Outreach Center Available

The federal government has made low-interest loans from the U.S. Small Business Administration (SBA) available to California businesses and residents affected by recent severe winter storms. Disaster loans up to \$500,000 are available to

homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for up to \$100,000 to repair or replace damaged or destroyed personal property, including personal vehicles.

Businesses of all sizes and private nonprofit organizations may borrow up to \$2 million to repair or replace damaged or destroyed real estate, machinery and equipment, inventory and other business assets. SBA can also lend additional funds to businesses and homeowners to help with the cost of improvements to protect, prevent or minimize damage from occurring in the future.

A Virtual Disaster Loan Outreach Center is available with SBA customer service representatives who can answer questions about SBA's disaster loan program, explain the application process and help complete applications. No appointment is necessary.

## Legislation Corner

Last night, the City Council approved letters in opposition to pending legislation in line with the 2024 Legislative Platform. To review bill summaries, letters, and links to proposed legislation, access the [staff report \(PDF\)](#) for the June 4, 2024 City Council meeting.

**Senate Bill No. 1116 (Portantino and Durazo) Unemployment Insurance.** This bill would enable striking employees to be eligible for unemployment benefits after two weeks of striking. Current law provides for the payment of unemployment compensation benefits and extended benefits to eligible individuals who meet specified requirements. Under current law, unemployment benefits are paid from the Unemployment Fund, which is continuously appropriated for these purposes. Current law makes an employee ineligible for benefits if the employee left work because of a trade dispute and specifies that the employee remains ineligible for the duration of the trade dispute. Existing case law holds that employees who left work due to a lockout by the employer, even if it was in anticipation of a trade dispute, are eligible for benefits. This bill would restore eligibility after the first two weeks for an employee who left work because of a trade dispute.

**Assembly Bill No. 2561 (McKinnor) Vacant Positions.** This bill requires local governments to meet and confer with labor unions if the vacancy rate in the membership exceeds 10% for more than 90 days and develop, publish, and implement a

plan to address the vacancy rate within the next 180 days. The plan would need to be presented at a public hearing.

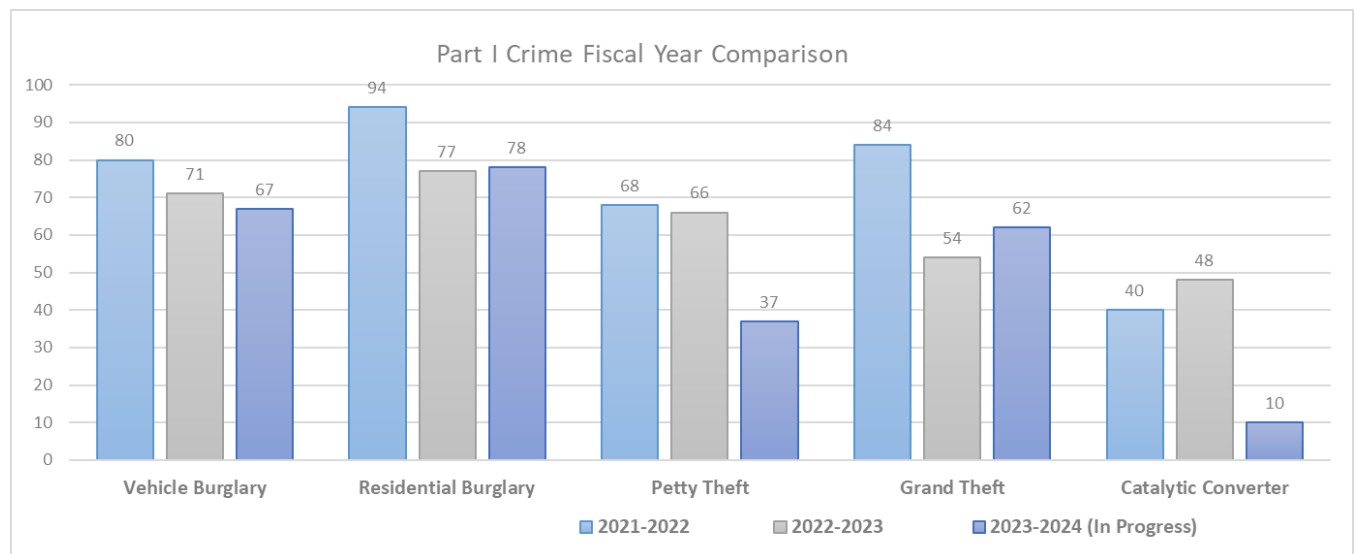

## Summer Public Safety Tips for Parents and Kids

As summer break begins, it's important to ensure that kids stay safe while enjoying their time off school. With more children out and about, everyone in the community should stay vigilant. Here are some key safety tips for parents, kids, and community members to keep in mind:



### *Outdoor Safety*

- **Supervision:** Always supervise young children during outdoor play. Older children should play in safe, designated areas.
- **Stranger danger:** Teach kids not to talk to strangers and to report any suspicious behavior to an adult immediately.
- **Buddy system:** Encourage kids to use the buddy system when playing outside or going to the park.
- **Road safety:** Remind children to look both ways before crossing the street and to use crosswalks.

### *Water Safety*



- **Supervised swimming:** Ensure that swimming activities are supervised by an adult or lifeguard.

#### *Travel Safety*

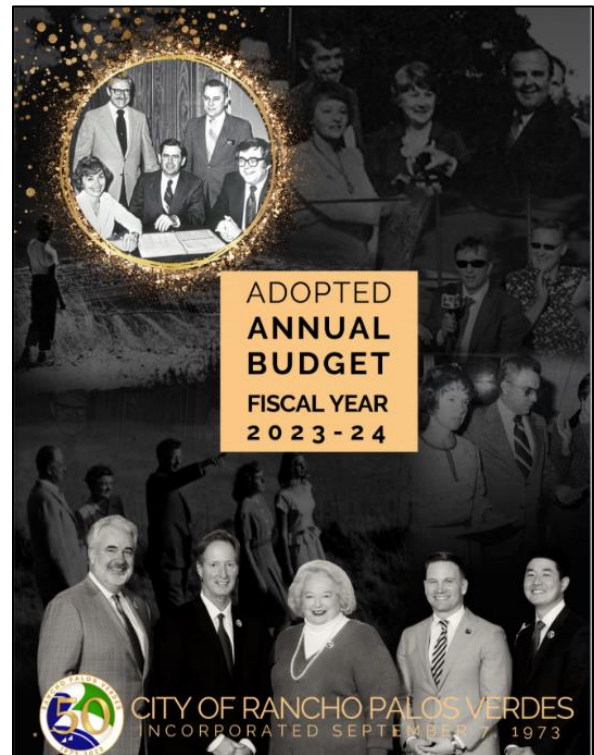

### Fiscal Year 2024-25 Budget Hearing and Adoption

The City Council will hold a public hearing on June 18 at 7 p.m. for consideration and possible action to adopt the Fiscal Year 2024-25 Budget. This hearing follows the City Council's review of the Preliminary Budget presented on June 4 and culminates the annual budget process that began at the start of the year.

The budget report for the public hearing will provide a comprehensive overview of the following:

- FY 2023-24 Year-End Estimates
- FY 2024-25 Draft Budget and fund balance summary for the General Fund
- FY 2024-25 Draft Budget and fund balance summary for the Capital Infrastructure Program (CIP) Fund and all other funds.



The required Public Notice was published in the Palos Verdes Peninsula News on May 30 and June 6.

## PUBLIC WORKS DEPARTMENT



### **Update on FEMA BRIC Grant for the Portuguese Bend Landslide Remediation**

In January 2023, the City applied for a Federal Emergency Management Agency (FEMA) Building Resilient Infrastructure and Communities (BRIC) FY22 cycle grant for the Portuguese Bend Landslide Remediation Project (PBL Remediation Project). The City applied for funding for 70% of the cost of the project with a requirement that the balance of the cost be funded through non-federal matching funds.

On August 28, 2023, FEMA announced the PBL Remediation Project was selected, with funding allocated, not obligated, for the City's project. The project met the basic eligibility requirements and entered the next phase of the awards review process, which includes a programmatic, environmental, and historic preservation review before a final funding decision is made.

Staff continues to work with the California Governor's Office of Emergency Services (CalOES) and the FEMA project team to expedite the review process as much as possible.

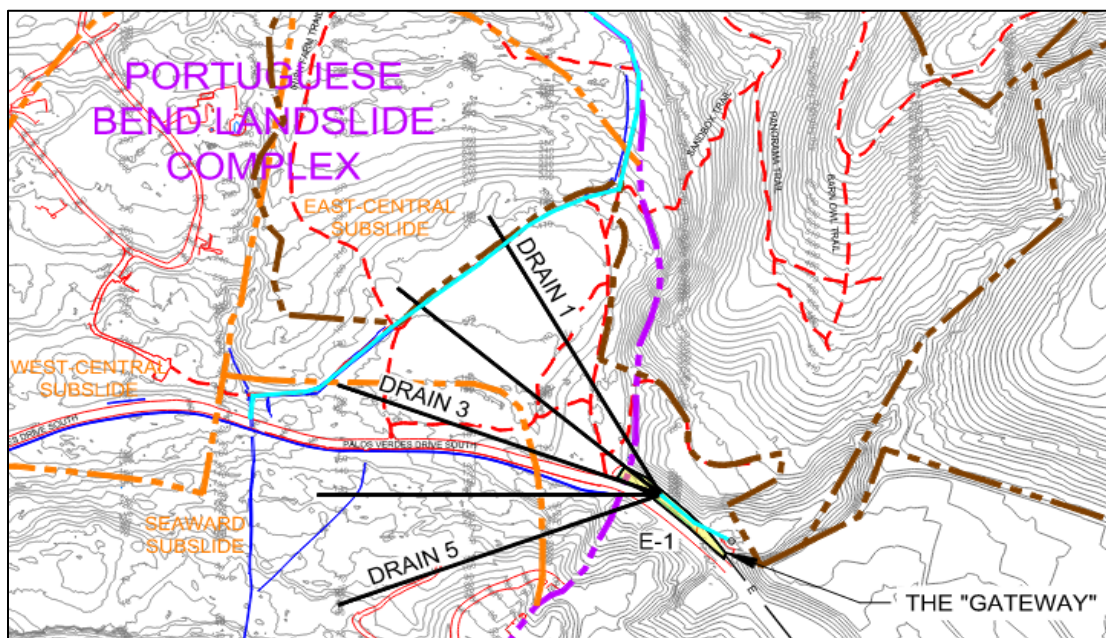
Most recently, Staff has been working with CalOES to respond to a series of FEMA requests for additional information on the grant application. The response package is planned to be finalized and submitted next week. FEMA is expected to review the responses and continue processing the application expeditiously.

## Portuguese Bend Landslide Remediation Emergency Hydraulaugers Project Update

On May 21, the City Council approved the Portuguese Bend Landslide Remediation Emergency Hydraulaugers Project, which consists of the installation of two hydraulaugers with five drain arrays each. The hydraulaugers will be used to extract and/or intercept groundwater from the landslide area as an emergency stabilization measure to reduce movement in the Portuguese Bend Landslide. Following are the updates since the City Council approved the project:

- Mobilization and staging of equipment and materials is underway at the “Gateway” location off Palos Verdes Drive South. This work is expected to continue through this week.
- Earthwork to provide safe and adequate access to the borehole locations and the hydraulauger launching locations has started and will be ongoing for the next several weeks.
- Drilling of the first three test boreholes is scheduled to start on or around June 10. Subsurface data obtained from boreholes will be analyzed to determine the exact launch points and alignments of the horizontal and directional drilled hydraulauger drains.

Minor traffic delays are to be expected over the course of the next 2-3 weeks as the contractor delivers construction materials and major equipment to the Gateway location. If you must drive through this area during this time, please proceed slowly, yield to workers and obey traffic control at the site. Thank you for your patience. 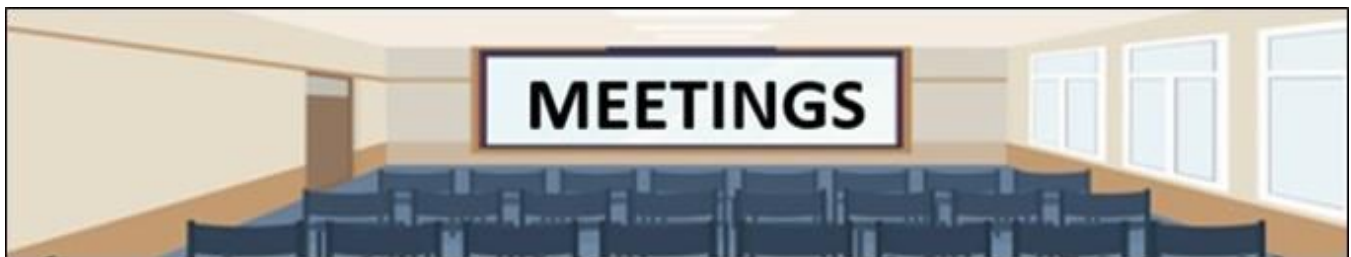
## **The Goats are Here for Fuel Modification Season**

Goats are back to perform the important job of helping reduce fire loads and protecting homes. Although we understand many people enjoy seeing the goats, please refrain from going to see them out of respect for residents living near where the goats work.



A temporary electrified fence is used to contain the goats while they are working, and attempting to approach them puts you as well as the goats at risk. Please avoid attempting to take selfies/pictures or touch the goats, especially if you have dogs or other pets with you. This will prevent stress and/or injury to you and the goats.

In addition to the goats, you may see crews from Stay Green performing brush clearance in various areas of the City as part of the City's 2024 fuel modification program.

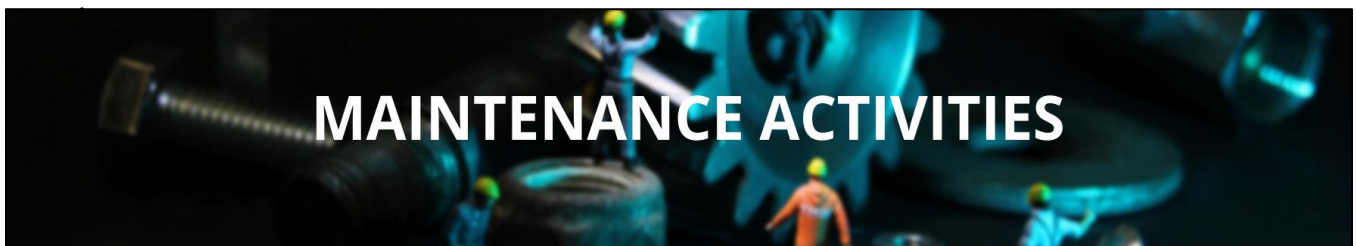
## **Infrastructure Management Advisory Committee (IMAC)**

The Infrastructure Management Advisory Committee (IMAC) held its regularly scheduled meeting on May 20. The committee formally adopted a list of accomplishments over



the past six months that will be presented to the City Council on June 18, adopted a work plan for the upcoming fiscal year, and proposed a project for limited improvements near the lower portion of Fred Hesse Jr. Community Park to be considered during next year's Capital Improvement Program discussions. In addition, it was also the last meeting for Don Swanson, who has served on the committee for the past 10 years, including serving as chairman from February 2020 through June 2022.

In addition to regularly scheduled maintenance and repairs, Public Works performed the following:

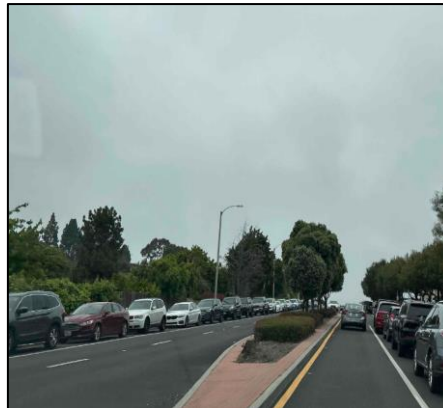


- Weekly landscape maintenance at all City parks.

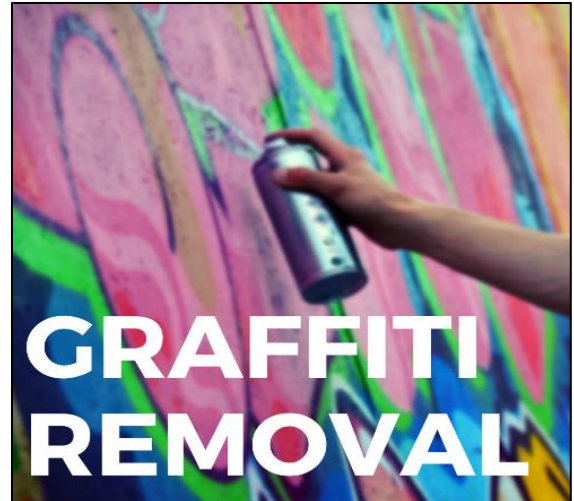


- Sidewalk deviations were repaired at the following locations:

- All catch basins throughout the were cleaned out to ensure proper drainage and prevent flooding.



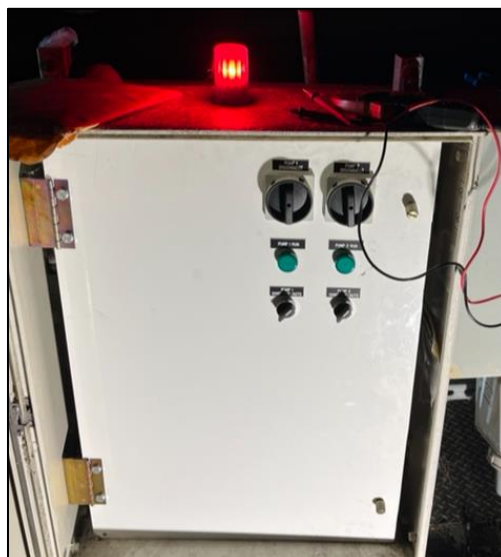
## Graffiti Removal

## Emergency Response

- The Public Works Department continues to respond to landslide related issues in the Abalone Cove Sanitary Sewer System. The land movement has caused breaks and separation in the sewer system. On June 1, crews responded to Narcissa Drive and made repairs to bring the system back online within hours.

### **Street Vendor Permit Approved**

On June 4, the City's Community Development Department approved a Street Vendor Permit filed by Brown Enterprises for the sale of merchandise, apparel and souvenirs at the southwest corner of Palos Verdes Drive West and Hawthorne Boulevard. State regulations are very specific regarding municipalities permitting street vendors and this application met these requirements. The REACH program serves the social and recreational needs of youths and adults with developmental disabilities and is back at Hesse Park for in-person activities.

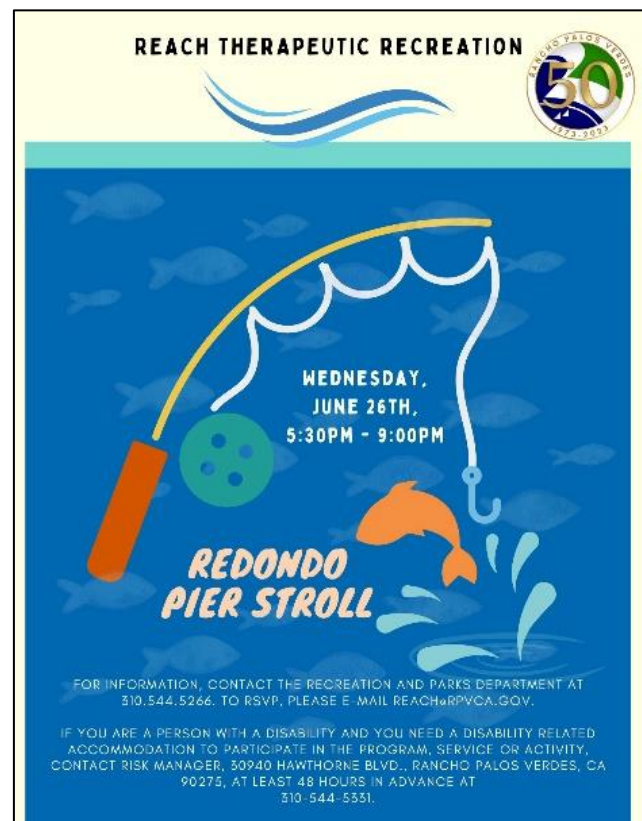

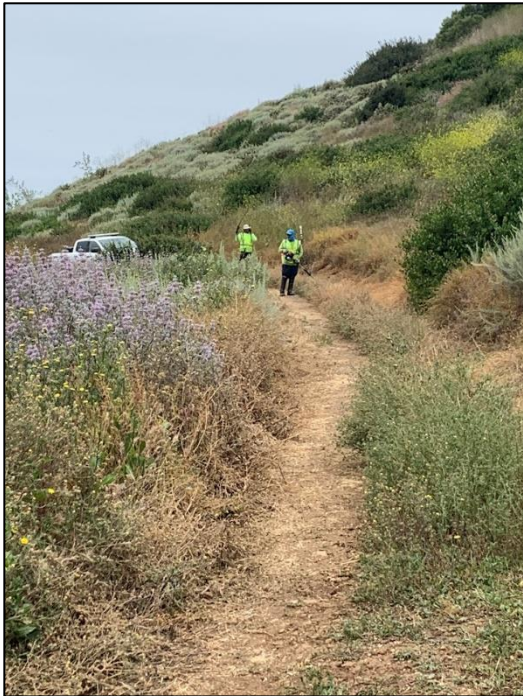

## Alta Vicente Reserve

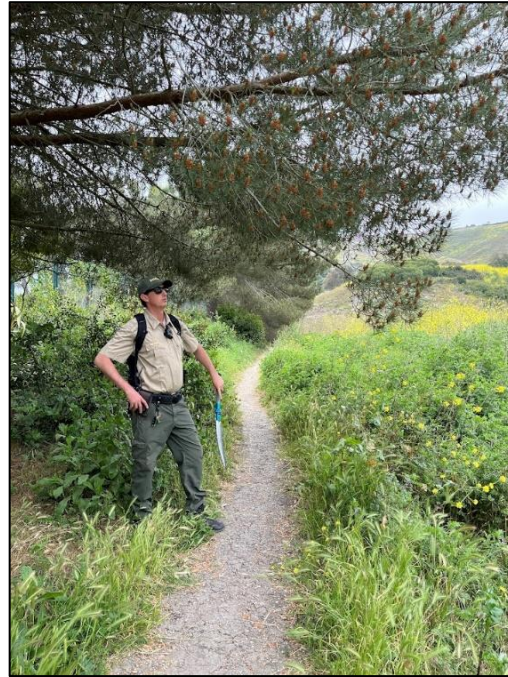

On May 27, Park Rangers removed an overhanging branch from a pine tree along Zote's Cutacross Trail.

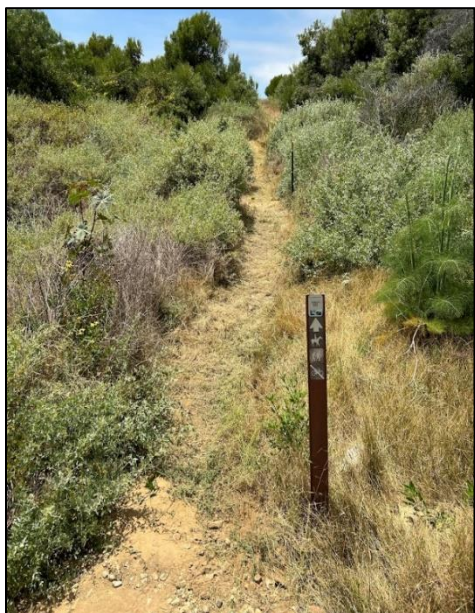


## Portuguese Bend Reserve

On May 29, Park Rangers coordinated with the City land surveyor and Public Works Department to clear several survey markers.



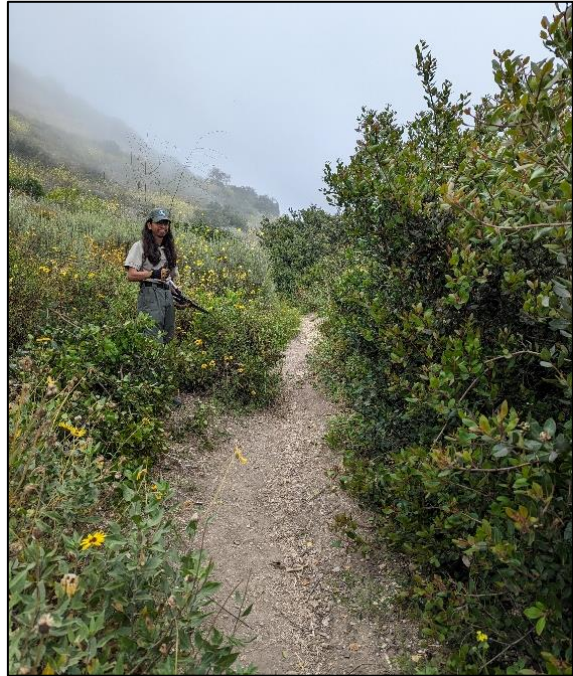




On May 30, Staff trimmed overgrown lemonade berry with hand tools. This ensures careful removal of select branches while minimizing impacts to nearby nesting activities.





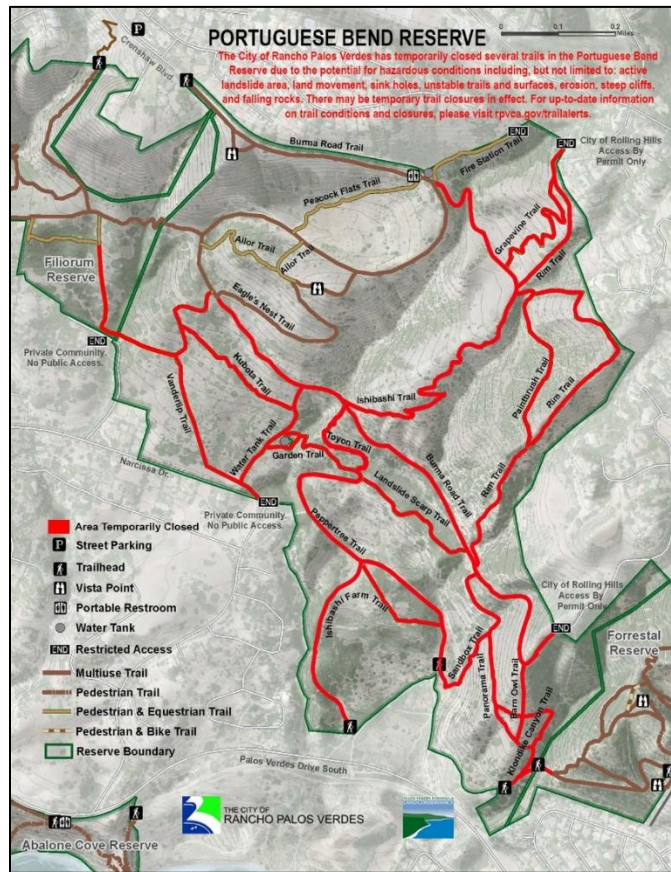


On June 4, Park Rangers removed graffiti from a “Hazard Trail Closed” sign at Ishibashi Trail.

**SUBJECT: Notice of Opposition for SB 1116**

Dear Honorable Senators Portantino and Durazo,

I am writing on behalf of the City of Rancho Palos Verdes to express our strong opposition to SB 1116 (Portantino). This bill proposes to provide Unemployment Insurance (UI) benefits to employees who remain on strike for more than two weeks. We believe this would unfairly burden employers by requiring them to fund ongoing labor disputes through the UI system.

Local government revenues are already incredibly restrictive, with limited funding sources. As cost pressures continue to increase, it is crucial for local agencies to maintain a fiscally solvent UI system to continue delivering public services and providing competitive benefits to both active and retired employees.

Under current law, UI payments are designed to assist employees who, through no fault of their own, are forced to leave their employment. Participating local agencies fund these payments through an Unemployment Insurance Reserve Account (UI Account) managed by the Employment Development Department (EDD). SB 1116 would significantly alter this system by extending UI benefits to workers who are still employed but have chosen to go on strike as a labor negotiating tactic. In the event of a strike lasting over two weeks, SB 1116 would allow all striking workers to claim UI benefits for up to 26 weeks, leading to simultaneous claims that would drastically increase UI costs for local government agencies.

Moreover, the financial implications of SB 1116 extend beyond individual employers. The bill would likely exacerbate the already dire state of California's UI fund, which was exhausted during the COVID-19 pandemic and is projected to owe \$21 billion to the federal government by the end of 2025. This debt is nearly double the amount borrowed during the 2008 recession, which took a decade to repay. California's UI insolvency led to significant federal tax increases, ranging from hundreds of millions to over \$2 billion per year between 2012 and 2018. With the UI fund becoming insolvent less than two years after repaying the federal UI debt from the Great Recession, further leveraging an already burdened system is unsustainable.



Similar legislation has been proposed in 2023 (SB 799, Portantino; SB 227, Durazo, pending) and in 2022 (AB 2847, Garcia), which was vetoed by the Governor. Given the current budget deficit, no additional burden should be placed on taxpayers or businesses, including local governments, at this time.

Additionally, SB 1116 could undermine good faith negotiations in the bargaining process. Public employers strive to engage in fair and productive bargaining with employee representatives. If SB 1116 were enacted, we anticipate it would result in longer periods of impasse, increased costs associated with extended Public Employee Relations Board proceedings, and a decline in the quality of public services.

For these reasons, we must oppose SB 1116 (Portantino) and urge you to consider the substantial negative impacts this bill would have on local governments, the UI fund, and the broader community.

**SUBJECT: Notice of Opposition for AB 2561 (Employee Vacancy Rates)**

Honorable Chair McKinnor,

I am writing to express opposition to Assembly Bill (AB) 2561, which requires local agencies with vacancy rates over 10% for more than 180 days to create and implement a plan to reduce these rates to 0% within another 180 days. This plan must also be presented publicly and posted online for at least a year.

As a contract city, Rancho Palos Verdes uses various tactics to fill vacant positions, including contracting technical workers, hiring interns, and employing short-term workers while we recruit talented permanent employees. Recently, we participated in a Class and Compensation study to evaluate our departments, positions, and titles to aid in recruitment and retention. These adjustments take time to implement effectively. AB 2561 detracts from our efforts to build an engaged and effective workforce for the benefit of our residents.

Public sector vacancies are a significant issue statewide. The State of California has had a vacancy rate above 10% for over 20 years, currently around 20%. Counties, especially in behavioral health, corrections, and social services, face similar challenges.

Despite ongoing efforts to recruit and retain employees, several factors contribute to persistent vacancies. Post-COVID demand for remote work, shifting workforce priorities, and burnout from pandemic-related workloads have made public sector roles less attractive. Additionally, mandated service delivery overhauls without adequate support have further strained resources.

AB 2561's requirement for additional reporting and planning diverts critical staff from their primary duties and adds an unfunded mandate, exacerbating the problem. Local agencies are already modernizing hiring processes and offering competitive compensation. Effective solutions require investment from educational institutions, all government levels, and the private sector.

Instead of imposing additional reporting burdens, we should focus on practical, collaborative approaches to address workforce shortages. Local governments, through their personnel divisions and in partnership with bargaining units, can develop and implement hiring and retention strategies without the mandates proposed in AB 2561.

I urge you to oppose AB 2561 and support more effective and collaborative solutions.

## EQUINE EMERGENCY PREPAREDNESS

Wildfires, mudslides, floods—you name it, there are many different types of emergency situations that require disaster planning and could require you to evacuate your horses. Horses require extra consideration in disaster planning. A good disaster plan is vital to keeping yourself and your animal companion safe. But horses require extra consideration because of their size and specific transportation needs. Since you won't have much time to think or act during an emergency, take time now to create an effective emergency plan.

A basic emergency plan could include the following recommendations:

### Before a Disaster

#### Connect

- Subscribe to Alert South Bay (text AlertSB to 888-777) or visit [alertsouthbay.com](http://alertsouthbay.com).
- Download the MYRPV app to all your devices.
- Equestrians are encouraged to sign for the City of Rolling Hills equestrian notification system by texting "RHEhorse" to 888-777.



#### Plan Ahead

Determine the best place for animal confinement in case of a disaster. Decide where you want to take your horses. Contact fairgrounds, equestrian centers, private farms/stables about their policies and abilities to take horses temporarily. Find alternate water sources in case power is lost and/or pumps are not working. You should have a minimum of three days of feed and water on hand.

#### Evacuation

With minimum egress/ingress of Peninsula main outlets, consider if evacuation is not an option and have to shelter-in-place. Have several sites and contact information in mind. Familiarize yourself with several evacuation routes and mileage to your destination.

#### Identification

This is critical! Photograph, identify, and inventory your horses. Permanent identification, such as tattoos, brands, etches hooves, or microchips are best. Temporary identification, such as tags on halters, neck bands, and duct tape with permanent writing can work. Practice braiding dog tags in mane. Include your name and phone number. Keep identification information with you to verify ownership.

#### Landscape

Clear fire breaks around house, barns, and property lines. Keep firefighting tools and extinguishers in one location.

#### Medical Records & Vaccinations

Keep medical histories and record special dosing instructions, allergies, and dietary requirements. Include your vet's contact information.

#### Vehicles

Keep trailers and vans well-maintained, full of gas, and ready to move at all times. Be sure your animals are trained to load. Teach and practice with your horses how to trailer both day and night times. Spend time loading and unloading, so they are safe and willing to load. Blindfold horses only if absolutely necessary. Many horses will balk at a blindfold, making evacuation more difficult and time consuming. Practice blindfolding, if possible. Blindfolding horses is commonly believed to be a beneficial practice in emergency situations; however, understanding how blindfolding impacts stress and ease of handling can improve the odds of successful emergency handling and thereby safeguard the well-being of both horse and handler.



## During a Disaster

Evacuate your horses early, if possible. Do you have sufficient trailers for all your horses? Take all vaccination and medical records, the emergency disaster kit(s), and enough feed, hay, and water for three days. Call your destination to ensure site is still available.

### Fire

Lock animals **OUT OF THE BARN**. Their instinct is to run into their stall when fearful, and barns are highly flammable.



## After a Disaster

- Check fences for any repairs.
- Be aware of downed power lines, fallen trees, debris and local wildlife that may have entered the area and could pose a threat.
- If you find someone else's animal, isolate it from your animals until it is returned to its owner or examined by a veterinarian.
- Check with your veterinarian and the California Department of Food & Agriculture, Animal Health Branch for information about possible disease outbreaks.

## Disaster Preparedness Sample Kit

- Portable radio and extra batteries • Plastic trash barrel with a lid • Water buckets • Stored feeds • Non-nylon leads and halters • Leg wraps • Horse blanket or sheet • Portable generators • First aid items • Tarps • Flashlights • Shovel • Lime or bleach • Fly spray • Wire cutters • Sharp knife • Hoof pick

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force. (2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

**Time Estimates:**

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.
